materials she needs to organize the yearly event. The flags, thankfully, are kept in storage at the VFW and it is a good thing, too, because this year there will be 1,956 of them to place.

groups Volunteer and individuals have increased over the years. There are some consistent groups, like the Northeast Baptist Church. In fact, she recalled Chad Nepple (church member and current Captain at the Clinton Police Department) being there her first year during the rainstorm. Nepple has volunteered for many years and takes his family with him to help. The number of volunteer groups and individuals fluctuates from year to year. Social media (mainly Facebook) helps get the word out. Northeast Baptist Church, Drakes Chapel, Good Shepard Hospice, the local Boy Scout Troops, and a 4-H group are all helping this year. A lot of individuals help too. Umland recalled last year having a Gold Star family volunteer to take care of the plot that their loved one was in (recall that a Gold Star family is the family of a soldier who lost their life in service). Gary Michael's family, the Clinton Police officer that lost his life a few years ago in town, volunteered to take care of the plot in which he rests; Officer Michael was a Veteran. spends Umland about six months of the year preparing for the Memorial Day flag placements. She begins by going through the books, identifying the new graves which will need flags, and updating her laminated sheets (placed in three-ring binders) and doing some research. Of course, there is the wrap-up work following Memorial Day itself: the flags are left up for two weeks following Memorial Day before being taken down which also presented a problem that had to be overcome: whose flag was it? Did the family put that one there or did a volunteer group? In order to not take down a flag that a family had placed on their own, Umland started painting the flags stems red on the ones the volunteers placed: problem solved. It is, indeed, improved upon every year. Damaged flags have to be properly disposed of, new flags ordered, and everything updated. It is a momentous undertaking, and she is always identifying new graves of soldiers who should be getting a flag. "Every Veteran deserves a flag for Memorial Day," said Umland. These days, the volunteer groups put

flags out on Friday and Saturday; it used to only be on Saturdays, but because of COVID last year (in order to keep groups separated) she added Fridays; the change, because it worked, stuck. Another improvement. Umland is a Veteran herself – and lost four soldiers from her unit in 1988 -part of the reason she continues to take this seriously. But she also remembered how as a youth her family would travel to Versailles (Mo.) and take care of her grandfather's grave he had been killed in World War II. "They have a memorial wall there," she said. "It has always tugged at my heart-strings."

Umland has become interested in the individual lives of the veterans buried in Englewood as well; her aspiration is to someday collect the life information of those veterans and put it in book form. She talked about some of her favorite graves: there is the Indian Interpreter and Scout who was with General Sheriden: Cephas "Dick" Parr (1843 – 1911); Umland likes the history and the variety of graves – for instance, there is the interesting grave of Ephraim Allison, a Captain in the 16th Missouri Infantry for the Confederate States (1835 – 1905); or the grave site of Clem Dickinson who was killed at the Battle of Argonne in World War I. In many ways, a history of the county can be constructed through the veterans of the county (even going back to the Revolutionary War - one of the first settlers to this area and the only veteran from that war buried here, although not at Englewood). "I like to get the stories, too," said Umland. She said that some of the more interesting stories she gets are from the families that visit the cemetery and talk about their veteran. She writes the stories down when she can and keeps them; if she can do it, those stories will be included in the book she'd like to put together. The Englewood Cemetery staff are really good, too: Umland said they are used to seeing her tromp around the cemetery while they are moving and the Sexton, John Wilson, has been really helpful as well. In fact, when she first started trying to find graves for Memorial Day, her antiquated system was on full display. Wilson finally told Jennifer one day: "You know we have a searchable website, right?" Well, no, she didn't know that, but once she did know it was not long before she was able to incorporate that tool into her prepping and

planning. For those who don't know, the Englewood Cemetery has a very nice website with a searchable data base and a map that shows the locations of the grave sites – it will even give you GPS coordinates.

What started as 1,716 veterans has now grown to 1,956 and more are added every year. To volunteer with the Memorial Day flag placements, check out the Englewood Memorial Day Flag Placement event on Facebook.

volunteers recently installed the display and there are plans to put a few of the museum's World War I collection items with the display as well. One item already in the exhibit room is a mechanical knitting machine (developed because of the soldiers' lack of socks resulting in trench foot) which was used during the war. The panel exhibit is on loan from the Missouri Humanities Council and the Springfield-Greene County Library District.

Over There! The rally cry for World War I was a call to arms. America, late entering the Great War, mobilized its men and industry to help defeat the German Alliance in Europe. Later, the war was dubbed as "the war to end all wars." Of course, many wars have been fought since, but the magnitude of World War I on modern life is enormous. US entry into the global conflict was the tipping point and the catalyst for victory for the Allied powers. Before the Americans entered the war, deadly trench warfare and new technologies had drawn the European contestants to a bloody stalemate. New machine guns, new submarines, aviation, and, most sinisterly, the use of chemical agents in war, were all new facets of warfare. Artillery had advanced significantly, and tanks were used for the first time on a battlefield. It was a strange mix of old and new: cavalry charged into artillery barrages, against tanks and into machine gun nests. The death toll was high. It is estimated that about 9 million combatants and about 13 million civilians lost their lives in World War I. To make matters worse, the Spanish Flu pandemic took another 100 million lives worldwide. America entered the war in 1917 about three years after it had already started in Europe. President Woodrow Wilson had tried to keep the US neutral, but the targeting and sinking of American merchant ships became so frequent in Atlantic waters, the US was forced to concede to the inevitable. On the rodeo either June April 2, 1917, America officially entered the war.

Missouri sent 156,232 soldiers off to fight – many soldiers were from Henry County; for those interested, there is a Military Section at the Henry County Museum with more information and displays concerning World War I and Henry County. Clem P. Dickinson was the first casualty from Henry County. Of the 156,000 soldiers from Missouri sent off to fight, 11,000 became casualties; there were five recipients of the Medal of Honor from Missouri. Famous Missourians in World War I include General John J. Pershing, Enoch Crowder, President Harry Truman, and Walt Disney. Frank Buckles, the last surviving veteran of World War I, was also a native Missourian.

The world after The Great War forever changed: literature, art, culture, technology, governments, philosophy, art, food, and even the world map. In many ways, it is the beginning of the modern era.

Robert Moore of Clinton, Mo. successfully completed four years of challenging academic, physical and professional military training, graduating from the U.S. Naval Academy with a Bachelor of Science degree in History and a commission as a U.S. Marine Corps 2 nd Lt. He is a graduate of Clinton High School.

At the academy Moore was a member of the Varsity Offshore Sailing Team and Semper Fi Society.

Founded in 1845, the U.S. Naval Academy today is a prestigious four-year service academy that prepares midshipmen morally, mentally and physically to be professional officers in the naval service. More than 4,400 men and women representing every state in the U.S. and several foreign countries make up the student body, known as the Brigade of Midshipmen. U.S. News and World Reports has recognized the Naval Academy as a top five undergraduate engineering school and a top 20 best liberal arts college. Midshipmen learn from military and civilian instructors and participate in intercollegiate varsity sports and extracurricular activities. They also study subjects such as leadership, ethics, small arms, drill, seamanship and navigation, tactics, naval engineering and weapons, and military law. ### **Trinity Lutheran Church**

The 5th New York Volunteer Infantry, "Duryée's Zouaves," was one of the most renowned fighting regiments of the American Civil War. Their colorful Zouave uniform, precision maneuvers, effectiveness in combat, and steadiness under fire gained universal respect and recognition. "I doubt whether it had an equal." General George Sykes said of the 5th New York.

On the afternoon of August 30, 1862, the third day of the Second Battle of Manassas, the famed "Texas Brigade" launched a massive attack. There were few Union troops there to meet the onslaught. Among those who engaged in the battle were two Zouave regiments: the 5th and 10th New York. In less than 10 minutes, 85 lives of 525 men of the 5th New York were lost.

Brigadier General Hiram Duryee, a former commander of the 5th New York, would later comment on that fateful day in a Memorial Day tribute at Manassas in 1907. General Duryee had purchased the land for the erection of a monument to his beloved Zouaves. He said:

"We stand on holy ground! For this field was the altar of God. The Master said, 'Greater love hath no man than this, that a man lay down his life for his friends.' Here, our comrades laid down their lives for the love of country, for human rights, the love, and the service of man. We sorrow at their loss, but we rejoice at their glorious death and achievements. age points lower than Fund. the April 2020 rate. Attorney, The rate had reached a low of 3.1 percent starting in July 2018, before gradually edging up to 3.5 percent by the end of 2019, and then to 3.7 percent in March 2020. The COVID-19 effect hit in April 2020, spiking the rate to 12.5 percent for that month. The rate decreased monthly for the rest of 2020, reaching 4.4 percent in December, and has continued gradually downward through the first four months of 2021. Missouri's unemployment rate has been below the national rate for every month since February 2020. The national unemployment rate increased from 6.0 percent in March 2021 to 6.1 percent in April 2021.

The estimated number of unemployed Missourians was 126,758 in April 2021, down by 1,303 from March's 128,061.

Improved weather and the gradual return to a post-COVID economy helped to push the state's not-seasonally-adjusted rate down to 4.0 percent in April 2021, four-tenths of a percentage point lower than the March 2021 not-seasonally-adjusted rate of 4.4 percent. The corresponding not-seasonally-adjusted national rate for April 2021 was 5.7 percent.

A year ago, the state's seasonally adjusted rate was 12.5 percent, and the not-adjusted rate was 12.3 percent.

Missouri non-farm payroll employment showed little overall change from March 2021 to April 2021, and the seasonally adjusted unemployment rate decreased by a tenth of a percentage point. ### Animals that Blow Bubbles

I have been in love with astronomy ever since I got my first telescope many years ago. There is something about gazing off into the abyss and seeing something no human can touch. There is a sort of mysticism surrounding the science when you are young. Learning to decipher the night sky is part of the wonder of youth as far as I am concerned. The history of astronomy is just as fascinating. It is an accurate measuring stick of the epochs of human reason and the changes we have undergone over time. From the interpretations first to the most recent. the record of what we thought about those distant points of light can tell a lot about what we believed and just how far we would go to protect what we believed: Galileo is a perfect example of this. He was branded a heretic for basically stating his observations to the Holy Roman Catholic Church. What Galileo saw, and measured, was that the Earth was not the center of the Universe at all - but that we were really just a part of a larger system. Copernicus was so afraid of stating his findings mathematically (he showed that the sun was the center of our solar system) that he wished his works to be published posthumously. And they were. When the blinders were off, however, the world - or universe in this case, opened up. Isaac Newton, one of the chief architects of the Scientific Revolution. searched the stars (and planets) for answers. His attempts to make the prediction of planetary movement accurate even led to the invention of calculus (well, he and Leibniz independently came up with calculus). Many of the inventions related to astronomy in the 15th and 16th centuries were put to use elsewhere - all because we wanted to explain what was beyond our Earth. much Not has changed in that regard technologies today: developed by NASA have also trickled into mainstream use, like LED's, artificial limbs, and anti-icing systems - not to mention better tires and freeze-dry technologies (tires got better when Goodyear developed a rubber to help soft-land the Viking Landers on Mars).

get a telescope for almost nothing (like \$20). Or, you can pop off several hundred and get software and motorized mounts which will keep a kid from ever really learning about celestial navigation and mapping, but - for those interested - the ability to do so is still there.

Learning about astronomy really has only one grand purpose: it shows us continually how insignificant and small we are. I know that most astronomers would argue that learning about astronomy is chiefly a utilitarian act (we need to be able to measure the days. seasons, etc. and to explain the universe). I argue that learning it keeps us humans in our place and our egos in check. Astronomy reminds us that there are distances we cannot fathom, forces so large we cannot really measure, and a time scale so vast we struggle to conceptualize it. In short, learning about astronomy is a way to keep a little mystery in our lives.

Besides, there is something gratifying about pointing a telescope into the night sky and finding an object you set out to look for - like Saturn and her rings, or a distant galaxy, such as the M31, our closest galactic neighbor (the M31 Galaxy is better known as the Andromeda galaxy). With a little luck, you might even catch a glimpse of the Orion Nebula, the rings of Saturn - or just gaze at the craters on our moon. All of it is fascinating. A significant increase in sky gazing satisfaction can be had by just getting out a pair of binoculars. With the naked eye, we can see some 10,000 stars - with standard binoculars, we can see some 200,000. Even a small telescope puts that figure to over 5 million. I am not sure if kids these days are more into astronomy - or activities like it (that take you outdoors) or not. I know that the video game industry has capitalized on making couch-potatoes out of our youth for quite some time now. It runs counter to what I grew up doing. Sure, there were video games when I was young specifically, Nintendo. Yet I still recall having to be dragged indoors for anything. Taking up astronomy as a hobby does something else that is really important: it increases

your individual freedom.

Not long ago I ran into a friend I went to high school with, and we got to talking about kids. He explained that he only lived a block away from the school but that his kids still insisted on getting a ride. I saw the pained look on his face, and shared it: mine, too, seemed to have an aversion to walking to school at one time. It is an attitude I did not understand because when I was their age riding a bike to school was 100% pure freedom: no adults, the ability to choose one's own direction, and, if possible, stop and get gum at a convenience store.

I did not want to ride the bus, even though I had to a few times. I did not want to be taken to school (because what kid wants to be seen getting dropped off by their folks or, in

my case, my older sister). My brother and I even walked or rode a bike to swim practice most days during the summer. I remember the walks: somehow, my parents trusted us to our own devices. and it was great. I don't know if kids think like that much anymore.

The appeal, then, with astronomy must have been two-fold for me: not only was I doing something that had a slight mysterious edge to it, and "exploring," but I was also gaining freedom - how else could you get out late at night without American Legion and an adult?

The world changed. But now I follow NASA news updates with a little thrill because I am, in some small way, a part of what they are doing. They are just able to use better "toys" and gaze at things further off and - as I had in my mind's eve manv years ago - actually get up close to the things I knew were out there. By the way, a small telescope is a great gift to give to a kid. It may give them that sense of freedom they need.

# Stock Market Insights By Dr. Richard L. Baker, AIF

The vaccine rollout and the reopening of more businesses led both the U.S. and global economy to grow considerably in April. The U.S. economy continues to ride the huge wave of stimulus money that was pumped into it during the height of the pandemic to the detriment of higher consumer prices. These higher prices/inflation around the world make investors fear that the Fed and other central bankers will need to tighten monetary policy to combat the global inflation which could shock the equity markets. As of May 21st, the S&P 500 has been down since setting a new all-time high on May 7thof this year. The current volatility signals investors are concerned about the weaker-than-expected April employment report and the inflation fears.

Though the equity markets are high in regards to their earnings, we don't see the latest sell-off as the beginning of a major decline. We also don't see investors deploying the "sell in May and go away" strategy ed week! where investors sell their equity holdings in late Spring and invest again in the Fall because there isn't a high percentage of companies trading 65804 below their 50-day or

200-day moving averages. Equity declines are being led by smallcaps, growth, consumer discretionary, and technology sectors. Though technology, a leading sector out of a recession, is generally weak during times of inflation.

Strong earnings reports from the major retail companies show the U.S. consumer remains healthy and has the cash to spend. The increasingly tight housing market is causing some analysts to grow concerned this could negatively affect the markets if it continues very long.

One positive note is that investors reacted favorably on May 13 when the CDC ruled that vaccinated people could stop wearing masks in most places signaling there may be more gas in the tank for the market to benefit from pandemic-related businesses reopening.

Overall, the markets seem to be wrestling with the enthusiasm of global economic recoveries as vaccines continue to roll out and increasing inflation fears. A major question yet to be answered is if the equities benefit from the recovery has already been priced into the markets. Have a blessed week!
