On July 2 the Clinton Fire Department held a "Push In Ceremony" for the new pumper truck. It is an ages old tradition, one that is still honored at Clinton FD.

Willings addressed those gathered: "For the past 18 months we've been faced with a pandemic," said Willings. "These guys didn't get to work from home," he said gesturing to the Clinton Fire Department personnel lined up in front of the

Assistant Chief Matt department headquarters. A large gathering of people had come to see the push in ceremony, too.

"This new pumper truck replaces the old rescue truck which is 24 years old," said Willings. In terms of fire equipment/ apparatus, that is a

"very old truck." Willings continued to talk about how the previous Fire Chief Leo Huff and City Administrator Christy Maggi had developed a plan to replace the old trucks and equipment; it involved the approval of a ¼ cent fire tax which Clintonians

passed in April 2017. Since that time the city has also purchased a new ladder truck with those funds, bought a new brush truck and a new vehicle for the Fire Chief. It also pays for the Assistant Chief position which had been vacant since 1993. The tax will ex-

pire in 2038, and the funds should generate two more trucks, more equipment, and maybe a new staff car.

The new pumper truck was ordered in 2019. Assistant Chief Willings pointed out that it was not a simple as "going to the dealer-

on the building has been taken off and replaced with a filler. Some stones have been replaced, as well as border joints and guttering."

Watson said that inside of the courthouse has three stories and a basement, and all county offices are in the finishing stage of being remodeled. He said that there is now a new courtroom in the basement, and the Juvenile Office that used to be housed across the street has been moved into the basement too.

"There are a total of three courtrooms in the courthouse," said Watson. "The one in the basement is used for Workmen's Compensation as well as other cases. The courtroom on the third floor of the building is for felony, juvenile and jury cases; and the second floor courtroom is used for everything."

Watson said that plans are in place to rehabilitate the hallways in the courthouse and to put in a new HVAC system that will allow each office to regulate its own temperature. He said this new system will also open up more room in the office spaces.

"We have a lot of plans for the next few years for making the courthouse a suitable, enjoyable space that will be useful for many years to come," said Watson.

According to the website for the Henry County Courthouse, the County Clerk's office is the "nerve center" of the county government, ranging from the daily administration of the county's business, conducting elections, personnel administration, risk management, economic development and a host of other administrative functions. Traditionally throughout the State of Missouri, the County Clerk is considered the Chief Administrative Officer of the county.

ship and picking out a new car." Fire trucks are built to accommodate and serve the communities they will be in so are custom ordered. There was a delay in the construction of the new truck because of COVID.

Mayor Greg Lowe said he was proud of the fire department and told those gathered that a new truck has already been ordered (the quick turn around on ordering the next fire truck is to combat the rising costs of things). "These guys are the best," said Mayor Lowe. He said that by the end of next year everything promised to be bought for the department should be fulfilled. "I'm proud of you guys," said Mayor Lowe.

Fire Chief Mark Man-

uel was the last to address the crowd. "I'd just like to say thank you," said Chief Manuel. "Without you guys and your support, our job is not possible." Chief Manuel went on to introduce a new tradition (in addition to the push in ceremony), that of the bell ringing. Mounted on the new fire truck's front bumper was the bell that came on the city's first new fire truck – a 1965 LeFrance. In days gone by, before horns were used, the fire bell would ring three times after the department had been dispatched to a fire and returned: there would be a pause and it would be rung three more times to let the citizens know that everything was all right. "The fire department is rich in traditions," said Chief Manuel. He took a moment to recognize the fire fighters standing at the ceremony: "Without you this is nothing more than a truck," said Manuel. "I want to thank you for all your hard work, dedication, and sacrifices," he told them.

The push in ceremony is also quite old: it dates back to the time when the pumper and tank carrying water was horse-drawn. When the firemen came back from a call, they would unhitch the horse and push the water-tank back into the station by hand.

As if on cue, the fire fighters of the Clinton Fire Department surrounded the front of the new pumper truck and assisted pushing it into the stall where it will be housed. Following the truck's placement, a radio call came across the intercom formally calling the new truck into action.

son Center on Sunday evening, featuring The Mark Trammell Quartet, Mark Bishop, The Browders and Tony Bullock."

Lee said there were four concerts, two on Friday and two on Saturday. Bands playing included David Graham and the Eskimo Brothers, Dawson Hollow, Cate Brothers and TLC Dulcimers. The Grand Parade on Saturday had 75 entries and the carnival was huge with bigger, newer and shinier equipment than before. He said that there was a huge ferris wheel that must have taken a lot of planning and effort to transport. He said that the carnival has been part of Olde Glory Days since its start in 1994.

Some of the other events enjoyed this year during the celebration were Quilt Displays, Kayak Races, FireQuacker 500 race, "Recollections of Hometown Veterans," Golf Ball Drop, Home Decorating Contest, OGD Patriotic 5K Run/

Walk, Pancake Breakfast, Cruise Night Car Show, Clinton Elk's Lodge Cornhole Tournament, Pet Show, Clinton Rotary Club 50/50 Give Away, and an Ice Cream Social by Clinton Christian Church. There were also three side shows with performances three times a day on Friday and Saturday. They were The Fishin' Magicians, James Wedgwood Pratt (Ventriloquist & Com), and the Kansas City Aerial Show. There was even a Toddler Tent available a couple of afternoons.

"We had a lot of tourists as well as residents," said Lee. "There were fans from Memphis who attended the Eskimo Brothers show on Saturday night. Hotels were full, and there were no incidents that I heard of. We sold 500 armband tickets from Monday through Thursday (June 30 to July 3), and people were buying armbands on Friday and Saturday for the carnival rides. People were happy to be out. We consulted with a representative from Golden Valley Hospital about the safety of getting so many people together again, and were given the go ahead. However, we will wait and see if COVID results later on as a result of the celebrations.

keys.

Since that fateful day, efforts of family and volunteers have been rampant, but unsuccessful, nonetheless. They've used flyers, signs, t-shirts, local and social media. They've walked the woods and they've knocked on doors, but they've had no luck. However, they continue to look forward to and yearn for the day that their questions are replaced with answers.

"... I really need people to be asking, 'Where is she? Where is the evidence? What's going on here?'", Smith told KCTV 5's Emily Rittman in an interview on May 10, 2021, the 1-year anniversary of her mother's disappearance.

"We definitely need people to understand that she's still missing and she's important," Smith also told Tia Johnson with Kansas City's Fox 4 News in an article two months ago.

Local law enforcement has been cooperative as possible, yet with no real leads in the case, their job is justifiably difficult. The same goes for the Missouri State Highway Patrol's Missing Persons Clearinghouse, who has since had the case turned over to them.

"This is a personal case for our office and we are exerting every effort to work any leads and cooperate with every other agency to try to get Echo home," Benton County Sheriff Eric Knox stat-

Throughout their search, the message has been clear: If you know something, say something. Family and friends of Lloyd believe that someone does know what happened to her and they're begging for them to speak out.

"In all reality, we know that when we bring her home, it'll give us justice and she'll be home where she belongs," Smith also relayed to Johnson.

There is a \$9,000 reward for anyone with a tip that can lead to Lloyd's whereabouts. Anyone with any information about Lloyd's disappearance call the Missouri State Highway Patrol Missing Person's Clearinghouse at (573) 526-6178 or email them at missingpersons@ mshp.dps.mo.gov. Anyone with information can also anonymously call (816) 474-TIPS.

#### Parson Signs Bills Into Law

Today, Governor Mike Parson signed Fiscal Year 2022 (FY22) state operating budget bills that invest in critical infrastructure projects, support stronger communities, fund workforce development priorities, and increase pre-pandemic K-12 and higher education spending levels.

"When the 2021 legislative session began, Missouri was still experiencing some of the hardest days of the global COVID-19 pandemic, which affected every state agency and Missourian," Governor Parson said. "Yet, the Missouri General Assembly stayed the course and delivered balanced budget that responsibly allocates taxpayers' hardearned money."

The Missouri FY22 state budget is approximately \$35.6 billion, including \$10.5 billion in general revenue. Additionally, Governor Parson issued 26 line-item vetoes, totaling nearly \$115 million. To view the complete list of budget vetoes, click here.

"Missouri's financial situation is vastly different from what we faced in 2020, and we applaud the General Assembly for recognizing this historic opportunity to make critical investments in the future of our state," Governor Parson said.

Key investments in infrastructure projects keep the state moving forward and have helped establish Missouri as a top destination for business expansion. Improving Missouri's infrastructure will continue to

remain a top priority for Governor Parson and his administration. The FY22 budget bills include:

\$154.4 million for State Road Fund construction projects.

\$60.2 million in bonding authority for state park improvement projects.

\$21 million for maintenance and repair projects at State Highway Patrol facilities.

\$15 million for low-volume road maintenance and repair.

\$10 million to increase broadband access in underserved areas.

\$6.3 million for port capital improvement projects.

Governor Parson understands that education and workforce development initiatives must work hand-inhand to prepare Missouri's next generations for the demands of the future. The FY22 budget will provide more Missourians with the education and training necessary to develop a skilled workforce by investing: \$252.7 million and

121 staff from various state agencies to support the newly created Office of Childhood.

\$20.2 million over FY22 spending levels to four-year institutions of higher education. \$13.2 million to sup-

port the A+ Schools Scholarship Program. \$10 million for community colleges.

\$8.5 million to fully fund the foundation formula.

\$8.4 million for early childhood special education programs.

\$3.9 million to support the Bright Flight program.

\$2.7 million to support the Fast-Track Workforce Incentive Grant Program.

\$2 million for State Technical College.

\$2 million to grow Missouri's new and emerging high-tech industry.

\$750,000 for 12,000 additional students to take the ACT Work Keys and Career Readiness Assessment.

\$200,000 for the Main Street Program. During the 2021 State of the State Address, Governor Parson called on lawmakers to fund projects that strengthen the health and safety of communities all across the state. The FY22 budget will make real progress in strengthening communities by allocating:

\$166.3 million to increase development disability service provider rates.

\$15 million to establish six new crisis stabilization centers and further support existing ones.

\$8.3 million to expand the Behavioral Healthcare Home Program.

\$5.3 million for 50 additional Communi-

ty Mental Health and Substance Use Disorder Liaisons.

\$3.6 million and 53 staff members to address waitlists in Missouri's Public Defender system.

\$1 million in grants for violent crime prevention, community engagement, and law enforcement mental health support. \$21.5 million to re-

cruit and retain quality Department of Corrections employees.

\$6 million for county jail reimbursements.

\$2.5 million to further support recidivism reduction programs.
\$2.6 million and 11

State Highway Patrol Troopers to assist in violent crime investigations across the state.

\$1.1 million for the Operation Legend Grant Program.

\$1 million for the state's witness protection fund.

\$575,000 to provide grant funding for law enforcement officer safety equipment.

"We applaud the work of the General Assembly for not only a balanced budget but for renewing the Federal Reimbursement Allowances program," Governor Parson said. "With billions of dollars in jeopardy and millions of livelihoods at stake, the majority of legislators put narrow political interests aside and passed an FRA renewal bill that protects Missouri's most vulnerable populations and builds on our pro-life principles. Without their efforts, we would be announce unprecedented budget restrictions rather than these historic investments. To all those who helped get FRA across the finish line: we appreciate your work."





Besides Lisa Jones and Jo Ann Lane, other START HERE counselors celebrating the entrepreneurs they hand a hand in helping are Michele Smith, Credit Building Coordinator/ Revolving Loan Fund Director; Kelly Asbury, Director of the Missouri Small Business Development Center at State Fair Community College; and Amie Breshears of University of Missouri Extension in Benton County.

CC's Butcher Shop plans on serving Cole Camp and Benton County with fresh meat and nothing pre-wrapped, and "no boxed meats" from national processors. Mrs. Casteel said, "[Rod] is one of the best meat cutters in the state of Missouri." 

#### **Emery** Weighs In On Spending

"A \$1.2 trillion government spending bill is not what our country needs," argues former State Senator Ed Emery, candidate for U.S. Congress in Missouri's 4th Congressional District. #### All SFCC Local Nursing Students Pass NCLEX Exam

On the first attempt, 100 percent of State Fair Community College's May 2021 Registered Nurse graduates from the Clinton and Sedalia campuses passed the NCLEX-RN exam. This graduating class in Clinton included the first paramedics who entered the program in fall 2020 with the goal of transitioning into registered nurses. The total number of graduates were

The National Council Licensure Examination for Registered Nurses (NCLEX-RN) determines if students are prepared to begin practicing as an entry-level nurse. This exam measures students' abilities to apply and analyze nursing knowledge learned in school and their abilities to use critical thinking skills to make correct nursing decisions.

"We are very proud of our Clinton and Sedalia nursing students for passing the rigorous NCLEX exam on their first attempt," said Allison Brosch, SFCC Associate Degree in Nursing program director. "This 100 percent pass rate is simply the result of our students' and faculty's persistence and determination along with our clinical partners who allow students to apply what they are learning to the care of patients."

SFCC's Registered Nursing and Licensed Practical Nursing programs have been recognized as the #1 rated program in Missouri for several years by RegisteredNursing.org and PracticalNursing.org, nursing advocacy organizations. One of the factors for this high ranking is how well a program supports students toward licensure and beyond.

SFCC's competency-based bi-level program, which is approved by the Missouri State Board of Nursing, prepares students to meet the requirements to become a licensed practical nurse (Year One), then transition seamlessly to associate degree nursing (Year Two) if the goal is to become a registered nurse. Those who are already certified LPNs or paramedics can apply to the Year Two program. Completion of these programs does not guarantee eligibility to take the licensure exams. In addition to Clinton and Sedalia, the program is offered in Eldon.

Starting in the fall, the Year Two nursing classes in Clinton will be available in hybrid format, and nursing students will have the option to choose web conference or on-ground classes. ### Senate Ag Committee Holds **Hearing on MCA Priority**

The United States Senate Committee on Agriculture, Nutrition and Forestry recently conducted a hearing, "Examining Markets, Transparency, and Prices from Cattle Producer to Consumer," with the intent to examine challenges facing the beef cattle market, one of Missouri Cattlemen's Association's top policy priorities.

"There is a widening gap between those giant players and the small and medium-sized processors that many local farmers and ranchers rely on," said Sen. Debbie Stabenow, D-Mich., chairwoman of the Senate Agriculture Committee.

Justin Tupper, a South Dakota cow-calf producer and manager of the St Onge Livestock Auction, testified, arguing that packers have too much control over each aspect of the supply chain, leaving the producers to fend

"The only way you can have true price discovery is to have a second bidder," Tupper said. "If we had more competition out there and they could not hold captive supply, then when we have high boxed beef prices, we would see the direct benefit of that.'

Mary Hendrickson, a sociology professor at the University of Missouri, said that recent events showed the true volatility of our food supply chain and that we must be better equipped.

"Everybody keeps saying these are black swan events, but they happened, and we weren't really prepared for them," Hendrickson said.

Producers and industry leaders know there is a long road ahead but are cautiously optimistic by the conversations surrounding the issue.

"We are encouraged to see this issue finally coming to the forefront as we are ready to push forward meaningful, long-term structural changes in the beef cattle markets. The goal is robust price discovery and market transparency that will afford all segments of this industry the opportunity for profitability, and many of this hearing's testimonies called for the same," MCA President-Elect Bruce Mershon said. "We appreciate the participation of committee members and the continued efforts of our own Sen. Josh Hawley."



State Sen. Rick Brat-R-Harrisonville, took to the floor of the Missouri Senate last week (6/25) to press for pro-life protections in legislation reauthorizing the Federal Reimbursement Allowance (FRA) program and voted for an amendment to defund Planned Parenthood and cut off all taxpayer funding of abortion and any organizations that perform abortions.

"We should use every opportunity we have to protect unborn children and push forward pro-life policy," Sen. Brattin said. "The people of Missouri don't want their tax dollars going to pay for abortions or for any groups or facilities that have anything to do with abortions. Let's stop hemming and hawing and do what we were sent here to do."

The proposed pro-life language is similar to language the General Assembly passed in the 2020 and 2021 state budgets. Last summer, a court struck down that provision citing the General Assembly couldn't legislate in an life."

## Stock Market Insights By Dr. Richard L. Baker, AIF

No, they didn't line up all the presidents of America's largest banks to walk on a treadmill with a bunch of wires taped to them. Although that probably would have been more fun to watch.

Each year since 2010 the Federal Reserve conducts a stress test on America's largest banks in accordance with the Dodd-Frank Wall Street Reform and Consumer Protection Act. This is where they run the banks through a hypothetical doomsday scenario to see how they would fare if the economy was in shambles. The Fed reported this year's results on June 24, 2021.

The Federal Reserve tested the largest 23 banks in America (they had to have at least \$100 billion in total assets to qualify) to evaluate how well they would hold up in a dire situation. The stressors for the hypothetical doomsday scenario for the 2021 stress tests were: U.S. unemployment of 10.75%, real Gross domestic product (GDP) falling 4%, consumer price inflation falling to an annual rate of 1%, three-month Treasury bills falling to zero, ten-year Treasury yields falling to 0.25%, equity/stock prices dropping 55%, the U.S. market volatility (VIX index) going to 70, residential real estate prices declining 24%, and commercial real estate prices declining 40%. (Thankfully, this is hypothetical and not actually happening.)

In this worst-case scenario, though all 23 large banks had losses, none of them failed. All of them were able to continue meeting their obligations to their account holders and creditors and were able to continue making loans.

America's large banks are in great shape. This is especially impressive since they just went through an actual crazy scenario during the pandemic's difficult financial times.

Your money is in good hands and that's one less thing to worry about. However, now I've got that image of those bank presidents looking like Boss Hog from Dukes of Hazard walking on a bunch of treadmills.



My wife stood on the dock, hands on her hips, and stared at me from a distance. Since the sun was at her back I couldn't quite read the expression on her face: Amusement? Disappointment? Embarrassment? It was probably a mixture of all of them. But, that's what happens when you get a new boat – there is a learning curve with it and I was making a mess of things early on.

It actually started weeks before. Not wanting to part with the amount of cash it takes to buy a brand new boat, we opted to look around for folks selling their older boats; often they upgraded and wanted to part with their previously favorite fishing vessel. We didn't need anything

special, so we started there. The Facebook Marketplace is a brutal environment for anyone trying to buy or sell something. At one point we had driven clear to Lebanon to buy a boat only to get a message that the guy had just sold the boat we were coming to look at. It wouldn't have been so bad but we had messaged him that we were on our way and about an hour and forty minutes or so from his location. He had responded "that's ok" and I even sent him a message telling him when we were thirty minutes away from him. We got a "thumbs up" emoji back. When we pulled in to where we were supposed to meet him we saw the message he had just sold it: "sorry for the inconvenience" it said. It was a little more than an inconvenience. After that experience, I thought my wife had lost her mind when a week later she told me she found another boat on marketplace and that we should check it out. Reluctantly, I agreed. At least this one was not so far away (Osceola). Long story short, it worked out: the guy who sold us our "new" boat was very nice, didn't sell it out from under us before we got there, and was honest about the boat's failings. We bought it, got everything licensed, registered, and legal, and took it to the lake to give a proper outing. Of course, all didn't go as planned. He had told me he wasn't mechanically inclined and that he never could get it to stay idling for very long. I didn't mind that so long as it started and moved and thought I could adjust whatever it was that was hampering the boat from running smoothly. It started off a little rough, but I did finally get the boat off the dock and we took it for a drive.

Nothing really embarrasses me too much these days, but I have to admit that when my boat started drifting sideways and blocking all the other water traffic I started to feel a little crumby. My wife was particularly amused that I had taken my shirt off and the description "fish belly white" was used more than once in my presence.\* At that time I figured it was just helping the other boaters identify the obstacle at a distance since I'm sure the glare from me was visible from space.

Everything seemed to go pretty well until we got

After what seemed like an eternity, the boat finally started up again and we got it loaded. In my haste I left the prop down and it dragged once on the ramp going up. I ignored it because at that point I was glad to just be out of the wa-

Believe it or not, the story has a happy ending. Once home, and after going through the motor and not being able to do much to it, I finally involved help: my dad. He adjusted the carburetor and now the thing runs right as rain. I have to admit, the sunburn I got was spectacular, but we finally have some fish in the freezer to show for it. I guess all is well that ends well and we are now enjoying our boat.

\*Note to anyone and protection from the sun: I swam a lot as a kid - swim team and all. And I cannot specifically recall getting burned so bad I couldn't manage it and ran around with a tan most of my youth. In fact, the recent sunburn I got, didn't really hurt me much. That is, except my knees. I recommend covering your knees and protecting them with all the vigor a mother lion would her cub from sunlight. For some reason, they were the sunshine's first target and that night in bed I could have sworn someone was holding a small torch to my knees while I tried to sleep. It was uncomfortable to an amazing degree. It didn't help that I had hunched over in the boat for a long time and that there were red stripes across my abdomen, either. They didn't hurt, but when my wife said I looked like a candy cane, I thought about the fact that I was getting old. Use sunscreen, folks. It protects you from more than just the sun's harmful effects on your body: it can protect your dignity also.


