Joicie Appell, 93, of Calhoun, is celebrating 77 years in professional show business. She started her career with a commercial at a Kansas City, Missouri radio station when she was 16, and has since performed in 90 plus stage pro-

ductions, appeared in 10 feature films, in more than 100 radio and TV Commercials, and in numerous print ads. She also wrote and narrated a weekly 15-minute radio show, aired over WHB Kansas City, Missouri, for 11 years. Still, she found time to start the Heartland Community Theatre of Clinton, Missouri (HCT), in

1996, where she has voluntarily directed and written skits and plays for the community for the past 25 years. In celebration of her 25th year of involvement in the local theater group, she will star in A. R. Gurey's "Love Letters," the first play that was performed by the theater group in 1996. An ac-

Local Woman Falls, Survives Harrowing Waterfall Accident



At the beginning of September, Kim Hembree, a 36-year-old woman and mother of six, from Appleton City, Missouri was on

vacation in Tennessee. She was enjoying a wonderful bike ride with her husband on the trail known as the Fiery Gizzard, which consists of a few waterfalls throughout a 12-mile trail and is overall beautiful. As

many others do Mrs. Hembree was trying to capture the beauty that surrounded her and wanted to take a picture from the top of the waterfall that they were on, Mrs. Hembree had said that the waterfall was well dry

at this time, so she walked out towards the edge and began snapping pictures. Mrs. Hembree told me that her husband was wary of her doing it and had told her to "get back and turn around" as she was doing so, she slipped off the edge and fell 35-40 feet down. Her husband immediately began calling for help and was making his way down the waterfall embankment down to her, she said that "my husband looked down and said that I wasn't moving at all but by time he had made it down to me I was beginning to moan." A few people had heard her husband's cries for help and began helping anyway they

Celebrating 234 Years Of American Freedom



About a dozen members of the Daughters of the Revolution (the Udolpho Miller Chapter, Clinton) gathered at the Henry County Museum about 4 p.m. Friday, September 17,

to ring the bell and recognize Constitution Day. September 17th marked the 234th anniversary of the signing of the document which lays the foundation for American government. The ceremony lasted about 15 minutes, although a few mem-

bers hung around afterwards to chat. A Proclamation was read by Gene Henry (City Councilman and S.A.R. member of the Martin Warren Chapter) in lieu of Mayor Greg Lowe's absence. The proclamation declared the week beginning with September

17th as "Constitution Week." Following the reading of the proclamation, the bell in the museum courtyard was rung by D.A.R. Regent Angie Voelmeck. Constitution Day does not quite get the recognition or notoriety it probably deserves: it is, after all, the reason

Americans are able to enjoy our liberties and rights. The document was signed in Independence Hall (Philadelphia), the same place that the Declaration of Independence was signed; six men who signed the Declaration of Independence also signed the

Constitution – two of the signers would go on to become President (Washington and Madison). The first state to ratify the Constitution was Delaware and the last was Rhode Island (of the original 13 colonies). The oldest

Stock Market Insights

Thinking about those hills on Highway 65 from Branson to Springfield, are you really breaking the law if you’re speeding downhill just to gain momentum to climb the next hill? Likewise, maybe this market is speeding downhill in early September just to gather momentum for a steady rise over the next twelve months.

The first part of September hasn’t been great for the market so far. As a matter of fact, the first two weeks of this month have been the worst of the year. There have been a few negative reports, but nothing major enough to justify investors’ fears. Whether justified or not investors are definitely acting nervous.

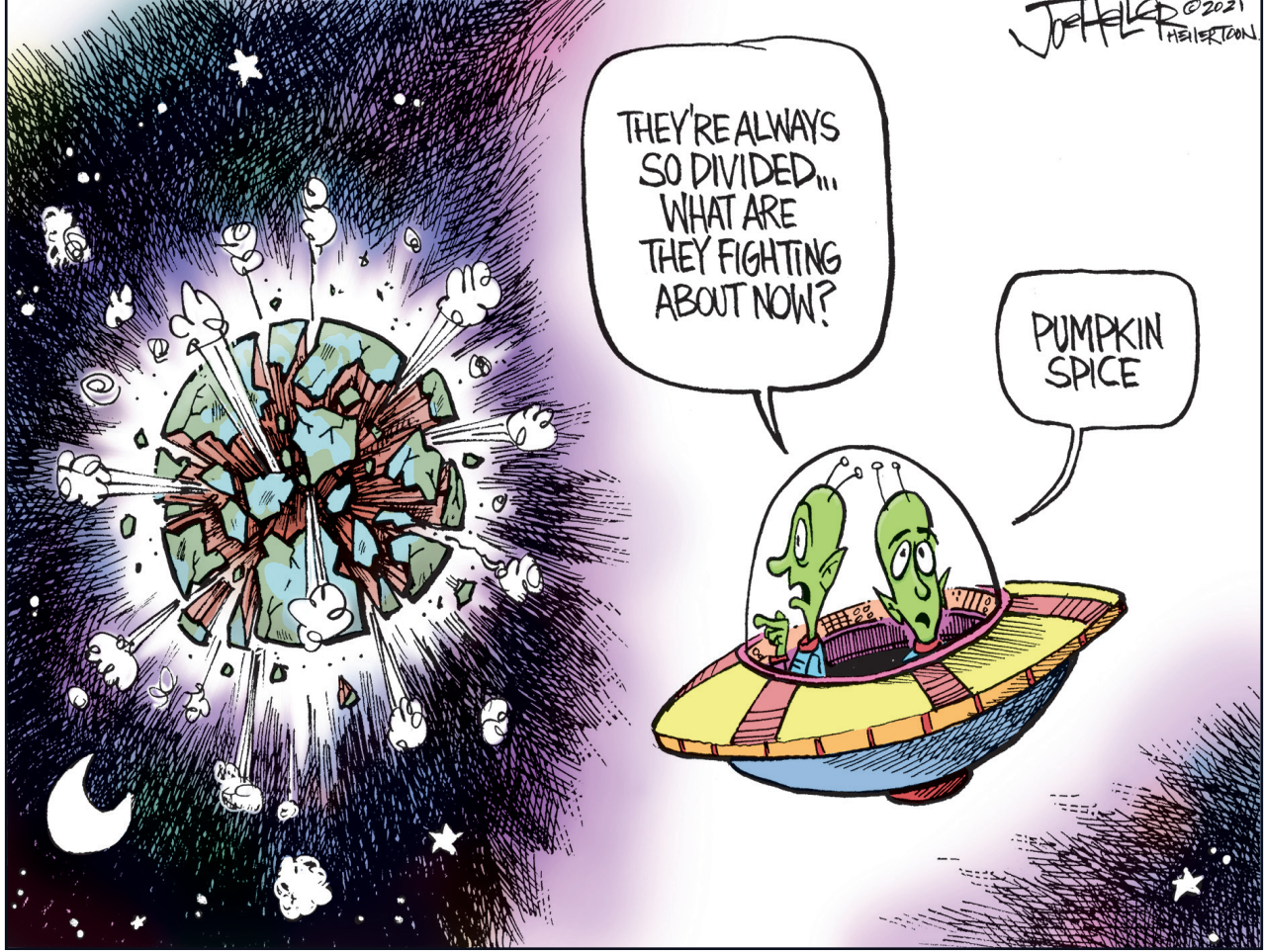
This may be because the Federal Reserve is expected to announce at their November meeting that they are going to start tapering their quantitative easing in December of this year. They should do that, but it could be viewed as negative and soften the market. On top of that, there has been some discussion in Washington this week about raising corporate taxes which would hurt profits. Lastly, U.S. manufacturing output data was weaker than expected, half of what Reuters projected, making some analysts feel like the economy is slowing.

All these things contributed to Action Economics, a market analysis firm, to reduce its third-quarter GDP projected growth forecast down to 5.6% from 7.0% because of “growth softening.” On the positive side, CFRA, one of the largest market research companies said though they expect some negative days short term, they project the S&P 500 to gain 7.7% over the next twelve months from 09/01/21 to 08/31/22.

Several years ago, as a teenager I was driving those hills on Highway 65 north of Branson on my way back to college. The old 1976 Monte Carlo I was driving was going way too fast down one of those big hills and a state trooper stopped me. I tried to tell him I was speeding up so I would have momentum on the next hill, but he wasn’t buying it and gave me a ticket. I probably deserved it.

We can’t get a good read on the market going forward until September is over and the normally positive fourth-quarter shows us a trend. Hopefully, the market is using this negative downturn to get momentum for the next market high.

tor who performed in the play the first time it was presented will join Appell as a co-star. The drama will begin on September 30, and run until sometime in October.

“This is the first time that I have acted in a play with the HCT,” said Appell. “I have always directed and written plays. This is also the last time that I will perform, write or direct with the group. I am going to leave it to the board and others to carry on the performances and they will do a great job! I will be slowing down, but not retiring. My plans are to continue to do a one-woman show in churches entitled “A Woman of Galilee.”

Appell said that her volunteer work with the Clinton Area Arts Council began in the early 1990s when the Council asked her to put on a play for the members. Then, after the HCT was organized, the production of “Love Letters” was performed at Clinton’s Christian Church. Soon after, a board was formed and a 501c-3 designation obtained. The group rented the Delozier Building on the Clinton Square, and Appell put on two plays a year in April and October. When Clinton’s Crest Movie Theater across the street came up for sale, HCT purchased it, gutted the interior and installed a set construction area in the rear. A few years later the adjoining building south of the Crest had a roof cave-in and HCT bought it, painted it, made roof repairs, built a portable stage, installed lights and sound and called the new space the Pavilion. More plays were written by Appell for Clinton’s Olde Glory Days, and HCT skits continued.

Appell’s greatest supporter during her career was Alan Appell whom she was married to from 1948 to 2019, when he died. She said that he worked a lot on the Katy Trail and has his name on one of its benches.

“He was always supportive of my professional career and my work with HCT,” said Appell. “We had a summer house in Calhoun after we were married and our daughter was still in diapers. It was a small house on 100 acres, with an out-house. Alan eventually increased our property to 352 acres, did some improvements and did some tree farming. I still live there today.”

Appell said that out-of-town celebrities joined in to help with some of the performances at HCT including a professional comic from New York City, a TV newsman and his wife from Kansas City, and a guest director from State

Fair Community College. HCT also took their productions by truck and car to State Fair CC, to Whiteman AFB, Warrensburg, the Liberty Theatre in Sedalia, and the Truman Lake Opry.

As of 2021, HCT’s 25th year, it has put on many skits, 50 plus full-length classic script productions, 15 one-act Readers Theatre productions, plus four full productions written by Appell. Volunteers tackling building repairs, lights, sound and set construction and decoration, props, costumes, stage management, advertising, ticket sales and refreshments have all been a part of Appell’s life during this time. But, she has said that it never interfered with her “legitimate professional career” in show business.

Appell said that until she did the radio commercial at age 16, she had plans to be an English teacher. However, after the commercial, she headed into the business and never looked back.

Appell has wonderful memories of people she worked with in her show business career. She said that she acted with Don Knotts in “Arsenic and Old Lace,” and that he came down to her farm for a picnic.

“He was a very nice person, and quiet,” she said. “During the play that we were in, he would sit on a chair offstage so he wouldn’t miss his cue. I also played the wife of Dick Wilson in a production. He had been in Vaudville and was a fine actor. Even though he was in 38 movies, and appeared in TV shows like Bewitched, he was most known for his role as Mr. Whipple in the Charmin Commercials.”

Appell said that she also enjoyed working with Al Lewis, who played Granpa Munster on TV. She said that he too had been on Vaudville and was a marvelous actor. She said people loved him because he was loud, boisterious and funny. She also worked with Marion Ross (“Happy Days” Mom), and Ray Walston, known for being on “My Favorite Martian.”

When asked what she thought was special about working in the community theater, she replied that it was seeing actors losing themselves in a role. She said her reward was seeing HCT actors come to appreciate classic comedies, mysteries and dramas; savoring the words, learning them, then offering them with actor ego held firmly in check.

Appell said that she is in good health, and enjoys mowing the lawn on her farm. She

used to keep an apartment in Kansas City as a springboard to various professional jobs around the country. However, a few years ago she gave it up, enjoying life in Calhoun.

the felony hearings of Associate Judge Harold Dump, to say that a situation had occurred outside the courthouse and that they needed to speak with the judge.

During that brief meeting in chambers, Dump immediately revoked Masterson’s bond.

Outside, Clinton Police Officers drew a taser and threatened to subdue the suspect if he did not comply with law enforcement commands.

According to a video of the confrontation, Masterson immediately got on his knees and held up his hands.

“The suspect complied right away,” said Police Officer Joseph Hartwick. “We used our training and employed the minimum amount of force necessary.”

Police officers then took Masterson to the Henry County Sheriff’s Department, for processing into the county jail.

Masterson, though late to court, was supposed to appear at a case review on two counts of 4th degree assault charges.

According to law enforcement’s probable cause statement, the defendant allegedly tried to pick a fight with a police detec-

tive on August 3 of this year, threatened a neighbor with a shovel on July 8, on April 25 threatened a female employee at the Sonic Drive In, resulting in the use of a taser by law enforcement.

At press time, Masterson’s next court date has not been set. He remains in the custody of Henry County Sheriff J. Kent Oberkrom, at the county jail in Clinton.

signer was Benjamin Franklin (81) and the youngest was Jonathan Dayton (26). James Madison was the last person to die who signed – he died June 28, 1836. Believe it or not, the reason Rhode Island held out was because they thought the document would give the federal government too much power – and did not ratify the Constitution until that now familiar portion of it was included: the Bill of Rights. Several states, actually, only agreed to ratify the Constitution on the condition it be included later. Hence, the first ten amendments to the Constitution. Well, actually James Madison submitted 19 amendments which was wheedled down to 12 by September of 1789. Of those two amendments that did not make it in the final cut of 10 (one was about representation in the House and the other about Congress voting pay raises to themselves), the latter was, a few hundred years later, added as

the 27th Amendment: “No law varying the compensation for services of the Senators and Representatives shall take effect, until an election of Representatives shall have intervened.”

The U.S. Constitution is something to be proud of: the 4,400 word document is the oldest and shortest written constitution in the world. Washington referred to its development as “little short of a miracle” and John Adams said it was the greatest single effort of national deliberation ever seen. Although it can be changed, it takes a lot to do that and that is on purpose: many of the original framers of the Constitution did not want the government usurping individual rights. In fact, the first three amendments made to the Constitution following a 60 year period (from 1804 to 1865 there were no amendments) seem to indicate that, if anything, states only tended to ratify those amendments which ensure freedoms and rights are guaranteed to be more inclusive (13th, 14th, 15th and by 1920 also the 19th amendment). Of the some 11,000 proposed amendments, only 33 have went to the states to be ratified – and only 27 have survived that process.

could. Mrs. Hembree’s husband immediately took his shirt off to try and stop the bleeding from a gash in her

face and bystanders helped carry her out of the water because she couldn’t support her own weight. After getting to the hospital, she was informed that her right ankle and right leg were both shattered and that the bone that holds the Achilles’ tendon in place was in pieces, on her right ankle. She had fractured her L5 vertebrae in the process as well. To fix her leg, she had to have bone grafts taken from the top of her leg to reconstruct the bone in her ankle, and her leg needed 2 plates and 15 screws put in. Her nose had been smashed into her skull due to her hitting a fallen tree at the bottom of the waterfall, doctors said that the tree is probably the only reason she didn’t die because it’s a lot softer than rocks. The swelling was so bad in her face that they waited a week to perform surgery on her and they feared that if infection took hold it would go to her brain. Currently she is back home, she is covered completely with bruises and scratches, she can’t use her right wrist and for the next 12 weeks she is in a permanent cast. Mrs. Hembree said, “I wouldn’t wish this on anyone at all, I can’t do anything by myself, I can’t even use the bathroom by myself, it’s awful.” After the accident occurred Mrs. Hembree done a bit of research on that trail and she found out that a total of 5 people

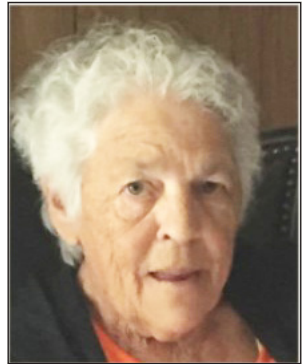

If we lose self-control of our speech, our religious beliefs are worthless. James urges us to read and study the word of God. If we do not obey God’s teaching, we are not Christians. James also points out to help the widows and the orphans. This may sound odd to single out those two categories, but during that time period, life was totally male-oriented, with absolutely no help for a woman when her husband was gone, and the same was true for orphans. As a woman could not own property, the widow could not even own her home. One of a Christian’s duties is to love and care for those in need.

Hezekiah prayed earnestly, crying out to God for mercy while citing his reputation for justice, mercy and righteousness. God heard his prayers, saw his tears and felt the depth of his pain. So, because of Hezekiah’s prayer and tears, God changed his mind and decided to heal him. He goes from a terminal situation to a 15-year reprieve in a matter of moments.

God’s essential nature cannot change, but God can change his action. With earnest prayer and a righteous reputation God may change his mind. But this isn’t just for the sake of us—it is for the greater good. When God gives us a reprieve from a terminal situation of any kind, He is giving us the opportunity to serve him and do something great with our new lease on life. Hezekiah was told that God changed his mind because of his love for the king and to deliver Israel from the Assyrians. God had a purpose for this decision.

When God gives you a new opportunity, he wants you to be a blessing, not just be blessed. When you want God to get involved with you, you must get involved with God—this means reaping a harvest of righteousness in all areas of your life. Take time to build a relationship with God. Love God. Pray to God. Spend time with God. Serve God. Love God’s children and get involved with God. Because, when you think that your life is falling apart, that there is no more hope, God can change everything—reverse course, fix the situation—in the blink of an eye.

So, take time to be with your Creator, to serve your God, to give in the light of his Grace and care for his children. Be the change God wants and reap a harvest of righteousness. Amen!

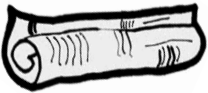

Jay Ashcroft Visits HC Library



MISSOURI SECRETARY of State Jay Ashcroft visited the Henry County Library on Thursday, September 16. Ashcroft is an enthusiastic supporter of creating life-long learners and also making sure libraries are well funded. Henry County Museum Director Stephanie Rogers was happy to show Secretary Ashcroft around and highlight the positive changes which have been made over the last year.

On Thursday, September 16, Missouri Secretary of State Jay Ashcroft visited the Henry County Library. The library has undergone some significant upgrades and revisions over the last two years, and Ashcroft, having heard about that, decided he needed a tour. Library Director Stephanie Rogers was glad to oblige.

Ashcroft spoke to Director Rogers about the importance of libraries and also shared some of his ideas concerning a budgeting plan to include long term state aid for libraries. Discussions included how it could be possible to share public library resources with other entities such as schools; some school libraries have literally shut down due to a lack of funding.

The idea behind libraries, of course, is to create life-long learners, but also provide community spaces. It could be that someday the public library might be a place to provide access to things such as DNR (Department of Natural Resources), Telehealth, or even a place to connect for the VA (Veterans Administration) for those who could not travel.

Both Director Rogers and Secretary Ashcroft have fond memories of libraries they visited in their youth and they shared with each other how those libraries have affected them as adults in positive ways. Rogers, rightly so, is proud of the progress at the Henry County Library (including the Windsor branch). "He seemed impressed by the new interactive spaces as well as the addition of Launchpads and how they provide education to children to help close the digital divide," said Rogers. There have been changes to almost every part of the library's collection: the staff moved well over 50,000 books to create space for patrons and provide easier access. Also, the Henry County Library recently joined a sharing consortium (Missouri Evergreen) and created a Youth Department complete with kid-sized furniture. They even have a new digital sign.

"My staff and I are excited to continue to raise the bar for library services within Henry County. We plan to set and achieve new goals annually to make certain patron needs continue to be met," said Rogers. And she also wanted to make sure Ashcroft knew that his visit was appreciated: "The Henry County Library staff and I would like to thank Secretary of State, Jay Ashcroft for expressing his interest in our library and dedicating his time to ensure that libraries across the state are receiving the necessary funding to support the needs of their communities."

85th Birthday Skydiving!

Rayona Harris, who lives in Tightwad with her daughter, Karen Reimal, is an unusual woman in many good ways. She has always dropped everything in her personal life when family or community needed her help, and now she has displayed some bravado by skydiving in celebration of her 85th birthday.

“Mom has said for the last few years that she wanted to go skydiving when she turned 85,” said daughter Karen Reimal. “I have no idea why she wanted to skydive, but a lot of our family was onboard with her. My youngest son, Daniel Reimal and his girlfriend, Chrisdena Bastura, were caught up in the plan right away, but it took me and my sisters a while to agree to skydive with her. None of us had ever skydived before. We booked the event at Glidersports in Clinton for September 11, a day after Mom’s birthday. We were told by the staff at Glidersports that there had been someone who was frail and in the 90s age bracket who had skydived and was fine because jumpers who share the parachute gently move a person’s legs up while the jumper lands on his or her bottom. My sisters, Jan Boring, and Deb Alexander, traveled from Alabama and St. Louis, Missouri to join us for the celebration. I baked a birthday cake and took it with us to share with the skydiver team after the jump. We also had shirts made for the jump.”

“The skydiving was awesome,” said Reimal. “Mom wasn’t afraid and thought it was amazing. We arrived at Glidersports about 11 AM and finished about 1:30, so we didn’t have long wait times. We had to take a class on safety, and then three of us went up in the plane at a time. My sisters went with Mom, and I went with my son and his girlfriend. My son was ‘Over the moon!’

Reimal said that her Mom is an amazing woman. Rayona Harris, and a twin sister, were born in Ohio, MO, in 1936. Harris was puny and was sent home from the hospital while her sister was kept for treatment. Her twin died after three months, and Harris was discovered to be allergic to cow’s milk, and eventually regained her health. She graduated from Osceola High School in 1954. While in high school she played basketball, and was a cheerleader and drum major. In 1952 she was named Miss St. Clair County. Reimal said that in school her mom was called “Butch,” but now everybody calls her “Gran. Her mom was married for 32 years before getting a divorce.”

“Mom has always had a great faith in God and family,” said Reimal. “Any time someone in the family was in need of care, there were no questions asked. She just moved in with the family and cared for the one who needed her while working at her job. When my mom’s mother was diagnosed with Alzheimer’s she quit her job in the city and moved to Osceola to care for her. Again, she was working a job and caring for two households and her mother. Later, when her son-in-law (Reimal’s husband) was diagnosed, at age 52, with the same awful disease, Mom sold her house and moved in with our family to help take care of him until his passing. When my uncle had emphysema, (when Reimal was in elementary school), he moved in with us so he could get care at the VA hospital nearby. Mom took him there every day. She also helped her dad and sister when they were ill. ”

Reimal said that to this day if there is a craft sale or bake sale at Reimal’s work, to raise money for a worthy cause, her mom is in the kitchen baking up a storm or fixing a couple of boxes full of crafts to donate. She also said that her mom takes care of her sister’s kids when she takes mission trips to Haiti.

“Her heart is huge and golden,” said Reimal. “She is my best friend, my rock, my heart! Happy 85th Birthday!”

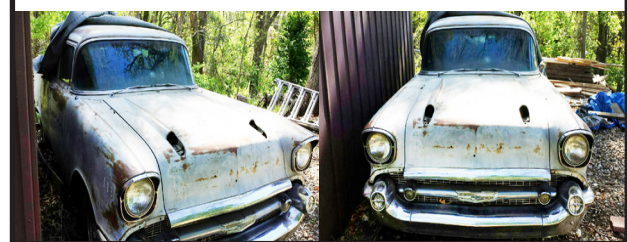

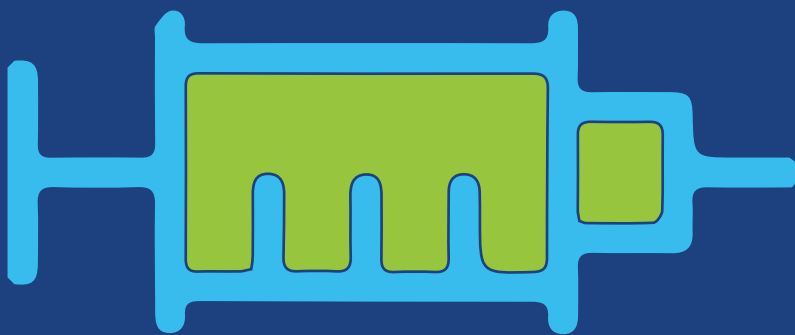

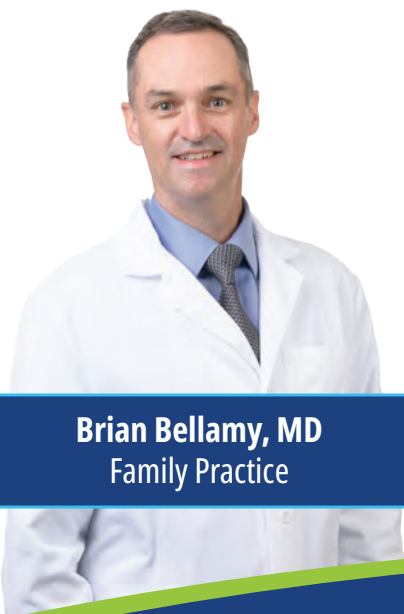
