"Thank A Soldier" Encourages Youth Appreciation For Troops

A "Thank a Soldier" program for kids was held at the two branches of the Henry County Library on Monday, September 27. This first-time event was planned after a member of an Army National Guard unit from Minnesota, SSGT An-

thony Patton-Nacey, worked with the director of the library, Stephanie Rogers, to get a care package for his unit that was just pulled out of Afghanistan and sent to Kuwait. The program was to show appreciation for soldiers who are serving our country and sacrificing time without their families. "The Unit is part

of the 1st Combined Arms Battalion, 194th Armor Regiment, and was pulled out of Afghanistan when the airport at Kabul was in chaos," said Sheila Jensen, Henry County Library Youth Services Director. "The original unit was divided when they left Afghanistan and the other half sent to Syria. Its Team

Volunteers Kick Into Gear For Project Christmas Cheer

Bringing food and Christmas to those who need a little help,

brought Clinton area church groups together almost 40 years ago, in what is now called Project Christmas Cheer. Susie Wetzel and Mary Jo Cable

with the United Methodist Church, Fathers Tom Hermès and previous priests with Holy Rosary Parish and many others found a way to pool their fund raising, food donation and building requirements.

"We work with the schools too," said Wetzel, the gift card coordinator for Christmas Cheer. "They help us with identifying the children's needs."

Beginning on September 16, families who want their names added to the donation receiving list can contact the Samaritan Center. "We will take sign-ups through November 16, said food coordinator Kim Daugherty.

Age is not a consideration for qualification.

"We help seniors and families without children too," Daugherty said.

Blankets and bicycles are items people can receive. "The firemen donate the bicycles," Wetzel said. "We do the blankets."

Each child can get their own blanket. "We give one for the family and one per child," Wetzel said.

Contributors include civic clubs, chamber of commerce members, individuals and the schools. "I spoke at the Rotary Club about business contributions," Daugherty said. "We couldn't do this without their tremendous support, and that of the entire community."

decided he needed a tour. Library Director Stephanie Rogers was glad to oblige.

Ashcroft spoke to Director Rogers about the importance of libraries and also shared some of his ideas concerning a budgeting plan to include long term state aid for libraries. Discussions included how it could

Commission Listens To "Fall Festival" Pitch

The Clinton Daily Democrat stopped by the Henry County Commission September 21. The commission updated the press on some things happening with the coun-

ty. The commission will be investigating a water concern regarding 1200 Rd bridge. It was reported that there is a standing water issue at that location. Also, it was reported that the new monitoring system (for heat/electric) that was installed at

the Henry County Detention Center is projected to save the county about \$42,000 over the course of the year. Surveillance cameras are due to be installed at the courthouse (for the inside and outside of the building) in the next few weeks. A new air conditioning

system is scheduled to be installed at the court house as well as they have been having problems with the old system's compressors for several years now.

Henry County Clerk Rick Watson said that absentee voting on the Clinton question started. The commission

updated the press as to the tuck point project at the courthouse as well – it appears the renovation work will continue (hopefully) through cold weather.

County Treasurer Ann Julian stopped by the commission for a few moments. She reported that the recent

back-tax sale had the smallest number of parcels in it: of the five parcels in the sale, one was sold.


The commission heard (and approved) a request from Clinton Main Street (Kaitlyn Wallen represented Main Street in the

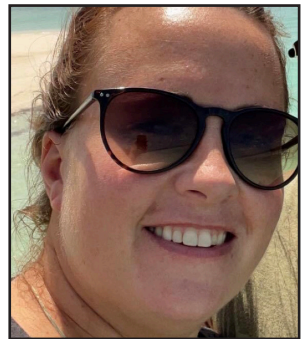

- In the event you know someone who is struggling with alcohol addiction, you should

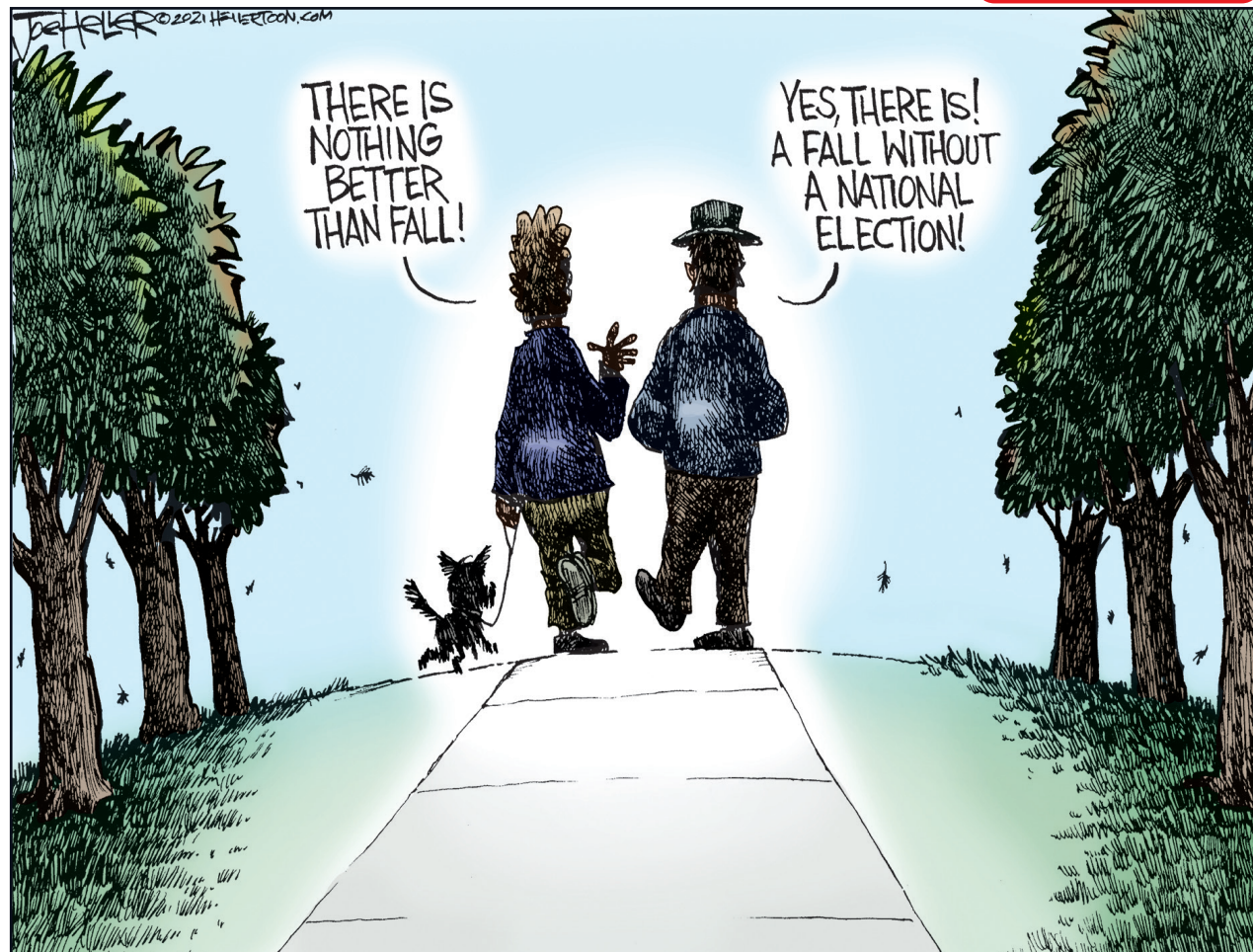
quickly get them into treatment.

with non-perishable staples.

"They really collect the canned goods for us," Wetzel said. "Harvesters donates a lot as well."

"Meat items come in closer to Christmas.

"We give away a lot of hams & turkeys," said Samaritan Center Director Sheila Barkwell.

The donations are all coordinated out of the Samaritan Center in Clinton.

"This building has a warehouse area as well as a thrift shop," Barkwell said.

"This center is much better than the various buildings we had in the past," said Wetzel. "We have enough space for everything now."

Storage is a necessity, as almost 800 families benefited from the project in 2020.

"We gave out almost 40 tons last year," 20-year volunteer David Graham said.

Long time project co-chair Mary Jo Cable was very influential. She passed away tragically last year, and her husband Kent still volunteers.

"I so wish I could ask her things," Daugherty said. "She was someone that cannot be replaced."

Families wanting to sign up can come to the Samaritan Center before November 16. Project Christmas Cheer sign up hours are daytime 9-12, Monday, Tuesday, Thursday, Friday, but not on Wednesday's.

"That's the day we get our deliveries," Daugherty said.

Leader is SGT Zachary Peterson. Soldiers from both units are lacking a lot of basic items that they need, and we are collecting donations to send to them.

Children attending the "Thank a Soldier" program learned about the units that consist of about a total of 75 soldiers, and they helped write a letter to the soldiers as well as decorate cookies that are to be sent in two separate care packages to the units. Kids also worked on coloring sheets of soldiers to send to unit members."

Jensen said that donations received so far include crafts, envelopes and paper, little pots, potting soil and grass seeds, since they have no grass where they are stationed. Other things include boxed snacks such as candy, crackers, coffee, little cereal boxes, ramen noodles, peanut butter, fruit cups, Rice-A-Roni, notebooks, fans that spray water, lip balm, card games, puzzle books, toothpaste, sanitizer, and gum. There is also a large box filled with all kinds of food including powdered potatoes.

"We learned that the unit that was divided up when the soldiers were pulled out of Afghanistan will eventually be brought back together in an unnamed place in Kuwait," said Jensen.

Two programs were held on Monday – one at 10:30 AM at the Lenora Blackmore branch in Windsor, and the other at 3:45 at the Administrative Headquarters in Clinton. A total of 14 children attended. The library offers many services for children including story hour on Tuesdays and Thursdays in Clinton, and on Fridays in Windsor. A Non-Fiction Story Time began September 20 and will be held on the fourth Monday of each month through May. Crafts will be included. Pre-registration is required for this story hour, by calling 660-885-2612 in Clinton, or 60-647-2298 in Windsor.

Look for the Spider-making craft time at the library coming up October 4, in Windsor, at 10:30 AM, and October 7 at 3:45 PM in Clinton.

be possible to share public library resources with other entities such as schools; some school libraries have literally shut down due to a lack of funding.

The idea behind libraries, of course, is to create life-long learners, but also provide community spaces. It could be that someday the public library might be a place to provide access to things such as DNR (Department of Natural Resources), Telehealth, or even a place to connect for the VA (Veterans Administration) for those who could not travel.

Both Director Rogers and Secretary Ashcroft have fond memories of libraries they visited in their youth and they shared with each other how those libraries have affected them as adults in positive ways. Rogers, rightly so, is proud of the progress at the Henry County Library (including the Windsor branch). "He seemed impressed by the new interactive spaces as well as the addition of Launchpads and how they provide education to children to help close the digital divide," said Rogers. There have been changes to almost every part of the library's collection: the staff moved well over 50,000 book to create space for patrons and provide easier access. Also, the Henry County Library recently joined a sharing consortium (Missouri Evergreen) and created a Youth Department complete with kid-sized furniture. They even have a new digital sign.

"My staff and I are excited to continue to raise the bar for library

services within Henry County. We plan to set and achieve new goals annually to make certain patron needs continue to be met," said Rogers. And she also wanted to make sure Ashcroft knew that his visit was appreciated: "The Henry County Library staff and I would like to thank Secretary of State, Jay Ashcroft for expressing his interest in our library and dedicating his time to ensure that libraries across the state are receiving the necessary funding to support the needs of their communities."

request) regarding a Fall Festival on the downtown square. The small festival will be presented by Circle By Hope and hopefully be on the same day as the Clinton Wine Stroll. Tentative scheduling would be from 11 a.m. to 3 p.m. and include activities such as a hay ride, bounce house, hay bale bowling, and a kettle corn truck – as well as some other vendors. There could be a pumpkin painting contest as well. She told the commission that Circle By Hope would be responsible for the set up (and clean up) and that there would be no alcohol for their event. "It is just an idea of bringing the community together," she told the commission. She told the commission that she has not yet sought the city's approval but thought that she would be doing that in the near fu-

ture.

Press coverage of the commission ended about 10:30 a.m.

City Council Talks Budget, Playground, Parade

The Clinton City Council met in open session on Tuesday (September 21). Councilwoman Debbie Smith was absent. Following roll call and the saying of the Pledge of Allegiance, the previous meeting's minutes were approved without correction. There were no personal appearances or reports.

Second readings of bills included: the establishment of fees for city services (Bill No. 2021-14); the approval of pay plans for the city (Bill No. 2021-15); the adoption of the city budget (Bill No. 2021-16); the adoption of the Title VI policy (for ATS, Bill No. 2021-17); and the ordinance for the supplemental agreement concerning railroad crossing improvements in town (Bill No. 2021-18) – all bills were adopted with unanimous council (one absent) approval.

Councilman Cameron Jackson gave the Public Works committee report: the council approved the request to close various roads for the October 1 Homecoming Parade. The inclusive playground (Kids' World) is open, and a grand opening will be held October 16th at 10 a.m. "If you have not yet driven by, I recommend you do so after school some time," said Councilman Jackson hoping that folks might go by the new playground to see kids enjoying it. Parking at the new playground may be the discussion of a future council, however, and it was recommended that situation be monitored in the meantime. There was no further information regarding the grant extensions with the Department of Natural Resources or the National Park Service, however, all have been submitted in regard to the playground project.

At the Waste Water Treatment Plant, the first lower level pump is due to be in by late September with pumps number two and four (and the Calvird Station pump) due to arrive in November sometime. The number six rotor has been repaired and is back online. Councilman Jackson reported that the manhole at Orchard and Ohio has been replaced "with a more modern update."

An update was provided on the Coal Creek/Franklin Street Bridge project: a meeting was held with project engineers CJW and HDR, in conjunction with Waste Water and the Henry County Water Company which was to discuss the water line at the bridge crossing. The focus at this time is how to get the lines that run under the bridge relocated. It is hoped that the project will be put out to bid by February. "Getting the line out from under the bridge will be challenging,"

Tighwad Woman Spends 85th Birthday In Freefall



Rayona Harris, who lives in Tighwad with her daughter, Karen Reimal, is an unusual woman in many good ways. She has always dropped everything in her personal life when family or community needed her help, and now she has displayed some bravado by skydiving in celebration of her 85th birthday.

"Mom has said for the last few years that she wanted to go skydiving when she turned 85," said daughter Karen Reimal. "I have no idea why she wanted to skydive, but a lot of our family was onboard with her. My youngest son, Daniel Reimal and his girlfriend, Chrisdena Bastura, were caught up in the plan right away, but it took me and my sisters a while to agree to skydive with her. None of us had ever skydived before. We booked the event at Glidersports in Clinton for September 11, a day after Mom's birthday. We were told by the staff at Glidersports that there had been someone who was frail and in the 90s age bracket who had skydived and was fine because jumpers who share the parachute gently move a person's legs up while the jumper lands on his or her bottom. My sisters, Jan Boring, and Deb Alexander, traveled from Alabama and St. Louis, Missouri to join us for the celebration. I baked a birthday cake and took it with us to share with the skydiver team after the jump. We also had shirts made for the jump."

"The skydiving was awesome," said Reimal. "Mom wasn't afraid and thought it was amazing. We arrived at Glidersports about 11 AM and finished about 1:30, so we didn't have long wait times. We had to take a class on safety, and then three of us went up in the plane at a time. My sisters went with Mom, and I went with my son and his girlfriend. My son was 'Over the moon!' Reimal said that her Mom is an amazing woman. Rayona Harris, and a twin sister, were born in Ohio, MO, in 1936. Harris was puny and was sent home from the hospital while her sister was kept for treatment. Her twin died after three months, and Harris was discovered to be allergic to cow's milk, and eventually regained her health. She graduated from Osceola High School in 1954. While in high school she played basketball, and was a cheerleader and drum major. In 1952 she was named Miss St. Clair County. Reimal said that in school her mom was called "Butch," but now everybody calls her "Gran. Her mom was married for 32 years before getting a divorce."

"Mom has always had a great faith in God and family," said Reimal. "Any time someone in the family was in need of care, there were no questions asked. She just moved in with the family and cared for the one who needed her while working at her job. When my mom's mother was diagnosed with Alzheimer's she quit her job in the city and moved to Osceola to care for her. Again, she was working a job and caring for two households and her mother. Later, when her son-in-law (Reimal's husband)

was diagnosed, at age 52, with the same awful disease, Mom sold her house and moved in with our family to help take care of him until his passing. When my uncle had emphysema, (when Reimal was in elementary school), he moved in with us so he could get care at the VA hospital nearby. Mom took him there every day. She also helped her dad and sister when they were ill." Reimal said that to this day if there is a craft sale or bake sale at Reimal's work, to raise money for a worthy cause, her mom is in the kitchen baking up a storm or fixing a couple of boxes full of crafts to donate. She also said that her mom takes care of her sister's kids when she takes mission trips to Haiti.

"Her heart is huge and golden," said Reimal. "She is my best friend, my rock, my heart! Happy 85th Birthday!"

Midway is one of the United States' territories. It is a distant part of the Hawaiian chain of islands. Midway is an atoll, which is a narrow ring of coral reef, circling a body of water. During World War II, Midway became famous because of a major Naval battle between the Japanese and American fleets. The American military had built an airfield, later called Henderson Field, and a communication center on this tiny plot of land. After the attack at Pearl Harbor, where the American Navy was nearly decimated, the Japanese Navy gained superiority. When the Japanese decided to capture the Midway Atoll, the American Navy was prepared for the attack, destroying or crippling four of the Japanese aircraft carriers, a cruiser, and hundreds of airplanes, plus nearly three thousand Japanese lives, taking back the superiority of the Naval warfare. This was the "Battle of Midway," and was depicted in a Hollywood film by the same name. It was also the turning point in the war with Japan. Today, approximately forty people live on this atoll, and it is designated as a wildlife refuge, mostly for birds. The turning point for the Israelites was the entrance into the promised land, as told in Joshua 1:1-9; 3:14-17.

Zacchaeus was not in need of physical or monetary support, but God had a plan for him, just as God has a plan for us. Zacchaeus was excited to see Jesus so, being a man of small stature, he climbed up a tree just to get a look at this holy man. When Jesus called out to him by name and invited himself to his house, he was elated. Zacchaeus was convinced and Christ's message hit home with him. He saw the plan of God unfolding right before his eyes and he immediately gave half of his possessions to the poor.

What is more, he then offered to repay—four times over—anyone he had ever cheated. Let not the magnitude of this act be lost upon you. There was no more "lip service", but an acting upon the convictions of the heart. This is what being a Christian is all about. These actions demonstrate how we, as Christians, should live our lives. There was a recognition of God's plan and Zacchaeus seized the moment when he saw it. He acted and didn't just think about it.

Now, while this wonderful account of Zacchaeus illustrates the true nature of our faith, there is one character in the story that is sometimes drastically overlooked—the tree. Zacchaeus is definitely the "star" of the show, but Jesus may never have seen this short man without the assistance of the tree. We are all called to be saints, but sometimes we fall short. We may not always be the Zacchaeus of the world, but perhaps we can lead others to God. The tree raised Zacchaeus up allowing him to encounter Jesus. This is exactly what we must do—be the "tree", lifting others up to see the light of Christ. When we are playing a key supporting role in God's plan, we just have to do what God asks. That is, to make disciples of Jesus Christ for the transformation of the world. We simply, like the tree in the story, have to lift others up to see Christ.

So, encourage those around you in the ways of God. Be a foundation—a tree that allows others to be lifted up and exposed to Christ. Raise up those around you to see God's light and experience God's love. You are part of God's plan because God has ideas and hopes for your journey. Amen!

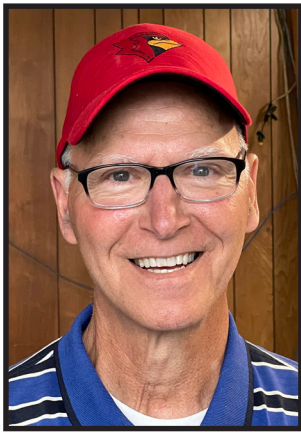

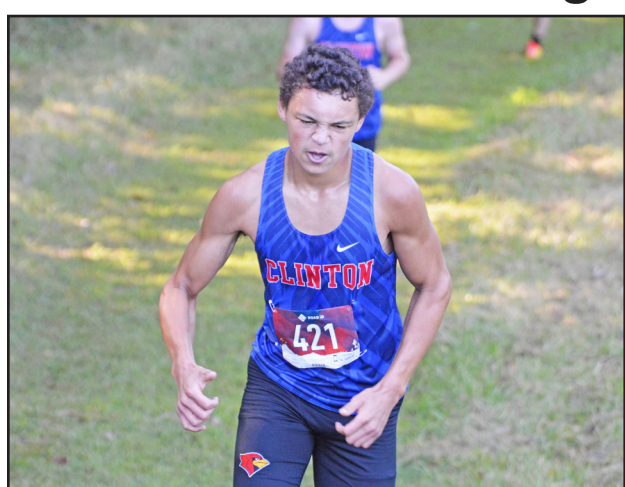



said Councilman Jackson. He also wanted to reassure the public that the bridge is not at a critical juncture where it would need to be closed: "If that were the case," he said, "it would be closed."

The SERC request about ADA parking had no action taken on it at this time.

The Finance Committee Report was given by Councilwoman Carla Moberly. The agreement for the auto renewal arrangement between the City of Clinton and Clinton Main Street will take place; an issue pertaining to boarding fees at the Henry County Jail is to be sent to the City Attorney for review.

Unfinished business for the council included the matter of the personnel policy revision to remove the personnel board's involvement in the hiring of employees other than in the matter of department heads and in grievance processes. Revisions also include the changing of the number of personnel board members from six to five members. Other changes include shift changes at the Clinton Police Department schedule (officers will rotate on a 14-day cycle and change from four, ten-hour shifts, to a 12-hour shift schedule), and modifications to the leave requirements and regulations to include domestic violence instances for employees. Both readings for the bill (No. 2021-20) were held and the council approved the changes.

The council also held the first and second readings regarding amendments to the annual budget – it was unanimously approved.

The Clinton City Council entered executive session at about 6:20 p.m. and did not return to open session.

GVMH Offers COVID-19 Vaccine Booster Clinic

Golden Valley Memorial Healthcare (GVMH) will be offering a Pfizer COVID-19 booster vaccine clinic at its Outpatient Treatment Center on October 12 from 4:30-6:30 p.m.

The Federal Drug Administration (FDA) recommends that individuals who initially received the Pfizer vaccine that are 65 years of age and older, as well as residents in long-term care settings and individuals 50-64 years of age with underlying medical conditions receive a booster shot of the Pfizer COVID-19 vaccine. In addition, individuals 18-64 years of age that face high risk of exposure to COVID-19 due to their occupation are also eligible.

To schedule an appointment for the COVID-19 vaccine, call 660.890.8660. Please bring your vaccine card to the appointment.

To get the vaccine, you must have completed your second Pfizer shot at least six months ago.

"A lot of people have been asking about the difference between a booster dose and an additional dose," said Christine Faulconer, Director of Risk and Quality. "Sometimes people who are moderately to severely immunocompromised do not build up enough protection when they first get a vaccination. When this happens, getting another dose of the vaccine can help them build more protection against the virus. The booster dose refers to another dose of a vaccine that is given to someone who built enough protection after vaccination, but that protection has decreased over time."

Recommendations of next steps for individuals that received the Moderna and J&J COVID-19 vaccines should be coming soon.

Rolling Back The Levies

The Clinton Daily Democrat was able to stop in and visit Henry County Assessor Scott Largent Thursday (September 16). The reason for the visit? Levies.

As most folks know, the real estate market took a wild turn upward for a time which significantly affected the assessed values for properties in the county. Of note, however, is that while some of those assessed values went up, levies should have rolled back. The reason for this is the Hancock Amendment: part of that amendment states that there is a cap on how much any tax can rise relative to the previous levy rates. The rate of rise (or fall, for that matter) is tied to the Consumer Price Index (CPI) and will vary for the individual taxing entities in the county.

As many of the surrounding counties around Henry went through a virtual "reset" because of the market, Henry County Assessor Largent sought to be proactive and made sure that each of the taxing entities in Henry County (schools, townships, etc.) were aware of what they would need to do according to Missouri law. The numbers are in for the levies for Henry County,

and here's how they rolled back:

*Note: the 2020 levy is contrasted with the 2021 levy which is in bold followed by the amount of reduction in parentheses. Every other township/entity is in bold as well simply to assist the reader keep track. The lowest levy in the county is the Leesville (R-9), and the highest is Bogard (Blairstown). They have both been underlined for reference.

MSHP Urges Drivers To Watch For Deer

The Missouri State Highway Patrol reminds drivers that deer are more active and create hazards for Missouri motorists this time of year. Deer behavior changes due to mating season, which may cause an increase in sightings and roadway crossings. Hunting and crop harvesting may result in these animals being in places they aren't usually seen. Drivers are urged to remain alert. If you strike a deer, move your vehicle to a safe location and call 9-1-1 or *55 on a cell phone and report it.

Last year, drivers in Missouri experienced 3,639 traffic crashes where deer-vehicle strikes occurred. One deer strike occurred every 2.4 hours in the state. In these crashes, there were five fatalities and 348 people were injured. The majority of deer strike crashes occur in October and November each year, with the largest number taking place in November. Although deer strikes can occur at any time, most occur during the 6-6:59 a.m. and 6-6:59 p.m. timeframe.

Remember: Rural areas are not the only place where deer/vehicle strikes occur. Drivers in urban areas of the state should watch for deer as well. When you see a deer, slow down and proceed with caution. Deer often travel in groups--stay on guard after a close call or when you see a single deer. Natural features also affect deer movement. In areas where there are streams or wooded corridors surrounded by farmland, look for more deer to cross roadways. At night, watch for deer eyes to reflect your headlights, which could give you more time to react to their presence.

Drivers are reminded that an attempt to avoid striking a deer could result in a more serious crash involving oncoming traffic. Try to remain calm. Overreacting usually leads to more serious traffic crashes. As soon as you see a deer, the best course of action is to reduce your speed gradually while watching other traffic around you. Other drivers may be doing the same, so be sure to pay attention and always wear your seat belt.

Too many people die in traffic crashes each year in Missouri. The choices you make when you're behind the wheel matter. Make good choices, so you'll never have to say, "If I could just go back ..."

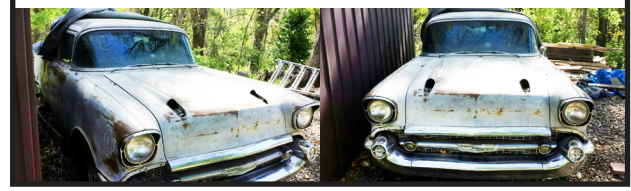

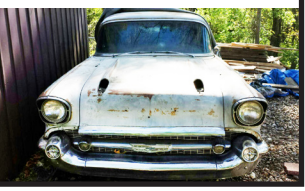
