# Wrong Way Crash Costs Clinton Woman Her Life

A Clinton woman died in a head-on vehicle collision early in the afternoon of February 7 near the I-49 and 291 exit at Harrisonville. Janna L. Dillon, 73, of Clinton was pronounced deceased at the scene by Harrisonville EMT Zachariah Sierks.

Also passing away in the accident, was 77-year-old Sandra C. Hammond of Belton.

According to Missouri Highway Patrol accident reports, Hammond was allegedly from the collision. driving the wrong way

north in the southbound lanes of I-49 when her maroon Toyota struck Dillon's 2002 Chevrolet SUV head-on.

A third involved vehicle, driven by Trevor Halfman of Lee's Summit was also struck by the two vehicles. Halfman survived the accident with no injuries. His 2006 Volkswagen was totaled in the crash.

Witnesses to the accident described the initial crash sound as being like an explosion. They further described two of the crash vehicles emitting smoke

personnel, nearby people rushed to the scene to help.

Further information from the crash report, shows that both victims were using their safety device (seatbelt). Both victims were transported from the accident scene to Frontier Forensics Midwest Laboratory in Kansas City.

The Missouri State Highway Patrol Troop A Major Crash Investigation Team was summoned to the scene.

The southbound lanes of I-49 were completely closed until 5 p.m.,

### **LETTER** TO THE **EDITOR**

When it comes time for the reader of the Democrat to consider the many blessings of living in Henry County, Missouri, one would probably include great places for outdoor recreation at or near the top of one's list. Such a list might include hunting, fishing, playing golf, riding bikes, horses or 4-wheelers, or hiking. These activities are generally available to all ages and contribute to good mental and physical health in many ways.

It has been this reader's privilege to live in Henry County for the most part of the last 25 years. Now in retirement, I often eniov hiking alone (or when with my wife, she prefers the term "walking"). Residents in Clinton are blessed further by our physical location near a trailhead for the Katy Trail. I have hiked or biked most of the trail from Clinton to near Green Ridge. Hiking the trail has the easy familiarity, much like a favorite sweater or quiet with an old friend.

But, good readers, my old friend the Katy Trail is sick, neglected the bag is full. I then

in many places, and abused. For example, lately when I hike on my "old friend" it is hard not to see trash in abundance, especially plastic debris, within a few feet of the trail. Bags, hard and soft drink cups, lids, bottles, shredded clear or colored strips in abundance. A rainbow of colors. None of it contributing anything of value to our quality of outdoor enjoyment.

What can be done?

In a perfect world one might suggest a good start would be to ban all single use plastics and plastic bags county-wide. This would require two important factors: bold political leadership at all levels, especially the County Commissioners, and secondly, enthusiastic acceptance of such a ban by the general population. At present one must recognize the likelihood of either of these two suggestions going anywhere as near zero.

What is now being done? What I do is pretty simple. When I begin from the Clinton trailhead, I look around for a discarded empty plastic bag as I walk along. Good ones with intact handles are not hard to find. conversation Once I have a bag in hand, I wander along wherever the plastic trash trail leads until

tie off the full bag and stash it near the trail and continue my hike.

On my return trip, I repeat the steps described above that I took on the outbound leg of my hike: find a good bag, fill with plastic debris, tie it up and head back to my starting point.

On this hike back, I pick up my first bag.

Now with 2 full bags of plastic debris, I return to the trailhead parking lot. From there it is a short, 2-minute drive to the recycling location near the Benson Cen-

The Katy Trail is just one example of a location where plastic trash could be collected for recycling. Our city streets, roadways and retail areas are full of opportunities to collect and recycle. And the larger problem remains; our beautiful land is drowning in a sea of plastic which is largely the result of oil company lobbying, continuing governmental foot-dragging, and widespread consumer indifference. Can the United States overcome our plastic dependence? Or can we even simply pick up after ourselves, recycle, or properly dispose of unwanted items?



# Albin, Wells Family Shares Their Storied History With CHS

Robin Wells, of Clinton, is currently Administrative Assistant at Henry Elementary School. But her familial connection with the Clinton School District goes back to the 1950s. As a senior at Clinton High School in 1957, her dad, Bill Albin, was voted Mr. CHS. Well's uncle, Bob Albin, was Mr. CHS in 1958, and her aunt, Rose Ann Albin Musser, was Best Dancer in 1962. Wells was voted Best Dancer in 1982, and her sister, Sherri Albin, was voted Most Athletic in 1984. More recently, Wells'

"When I attended Clinton High School, seniors voted for other students in their grade level to be honored as Most Likely to Succeed, Best Dressed and more. The seniors with the highest votes were announced at the winter formal. High school days were a happy time and I would go back

Wells related some other Missouri family history going as far back as the 1930s. She said that her dad's father, Lyle Albin, grew up in Blairstown in the north part of Henry County and as a young man he went to California to work as a water carrier. While there, he met and married his wife, 15-year-old Cleo, whose parents had to accompany her to the wedding so they could give permission for the event. Lyle Albin was nine years older than his wife. The couple's first child was Well's dad, who was born in California in 1939. Soon afterward the family moved to

Clinton where more siblings were born and raised.

Well's mom, Eileen, was from Calhoun and worked at Walker Motor Company. Her dad met

Eileen when he walked into the dealership in December 1962 to make a payment on his 1962

Ford convertible. They became engaged in February 1963 and married in April 1963. They have been married nearly 59 years.

Well's husband Richard was from Popular Bluff, and the two of them were at the University of

Central Missouri (UMC) in Warrensburg at the same time, but didn't know each other. He graduated in 1984 and started teaching at the Clinton Technical School, Wells left UMC in 1984 and returned to Clinton in 1986. She met Richard in December 1986, and they married in May 1987. Richard later became director at the Clinton Technical School, then took the position as Superintendent of the Montrose School District.

The Wells have three sons. The oldest, Andrew, is a college professor in Iowa. Middle







The Lady Cards, led by Coach Stacie Womack, owe a lot to the ladies in the article below. The NGWSD is celebrating it's 35th year.

On February 4, 1987, President Ronald Reagan declared the first National Women in Sports Day in recognition of the history of women's athletics. It also recognized the progress made by the Title IX amendment passed in 1972. 2022 is also the 50th anniversary of Title IX, the landmark 1972 legislation. We know Billie Jean Kings, Florence Griffith Joyner, Althea Gibson, Danica Patrick, Wilma Rudolph, Didrikson, Babe Shannon Eastin, etc. But there are others we should know:

Florence May Chadwick: August 8, 1950, at the age 32, Chadwick swam across the English Channel in record-breaking time. She broke many records. She was inducted into the International Swimming HOF.

2. Ora Washington:

she dominated in basketball and tennis.

3. Alice Greenough Orr: As a child, Alice Greenough was immersed in ranch life. She helped promote the Rodeo circuit especially for women athletes. In 2002, Alice Greenough Orr was one of the first honorees inducted into the Cowgirl Hall of Fame.

4. Effa Manley: Effa was not an athlete. However, she had a great mind for the business of athletes. A bi-racial women she later became a part owner of a Negro League team and was very instrumental in getting better deals for the Negro league players moving to the Major Leagues. In 1946 her team won the Negro League World Series.

5. Margaret Wade: She loved basketball and played college ball in the 1920s She played in the days but the program was Foundation/NCAA.)

1959, Wade returned to her alma mater as the Director of Women's Physical Education. Delta State relaunched the women's basketball program in 1973. With Coach Wade at the helm, the team earned three consecutive Women National Championships.

6. Dorothy Sears Ainsworth: Throughout her career she was known for her dedication to women's and girls' physical education. At Smith College, she advanced physical education as an educator, serving as its Director of Physical Education for more than three decades. She helped establish the International Association of Physical Education and Sport for Girls and Women in 1949.





# Farmland Prices Make Young **Farming Difficult**

Increasing farmland prices are forcing hard choices upon rural youth making career decisions. And older Ag producers would prefer to have their descendents be able to farm.

Members of the Future Farmers of America at Clinton High School, and seniors from the Henry County Cattlemens Association, spoke about their feelings on February 1 and January 26.

"I remember when the price of land was \$325 an acre," said Gene Reid. "The price of land now is ridiculous." Amounts of \$4,000 - \$5,000 per acre are asking prices currently online for row-crop land in Henry County. Ranch land shows prices of \$2,200 up to \$5,000 for asking prices. Reid told of land nearby that was listed a lot higher.

"They started out at \$17,500 an acre," he said. "I've heard that

they are now down in the \$8,000 range asking price."

Clinton High School juniors wanting to farm, are hoping that prices don't keep them from being able to choose Ag careers. "I plan to farm with my dad," said Garrett Doll, son of Eric and zanne Bush supports. Meredith Doll.

row crop operation near Montrose." Being able to purchase additional land, is something Doll is concerned about. "We have to be able to live comfortably (on what we earn)," Doll said. "It is better to own the land you farm."




