

# Amid Labor Shortages And Inflation, Some Area Seniors Get Back To Work

There's a lot going on in America these days, especially with the economy. Gas is high, interest is up, and inflation continues to rear its ugly head, continually shrinking the value of the once almighty dollar.

Perhaps it makes sense then, that more people than ever are returning to work post-retirement. But for those formally retired employees or what would be on-the-cusp retiree hopefuls out there, is their return to the workforce really out of simple financial necessity, or for some, is it something else entirely?

This week, the Daily Democrat took to the Clinton community to find out.

Interviewing several employees from several different businesses around town, a couple things quickly became clear. First, the economy, for the most part played the biggest factor. Specifically, inflation and gas prices which have, according to several formally retired employees, "made it impossible" to live off of social security post retirement without some sort of income supplement. These same employees expressed their frustration too, that even

with the supplemental income from their job, making ends meet was still a struggle, and would continue to be a struggle barring drastic changes within the economy.

The second thing that became clear in these interviews is that the majority of employees interviewed preferred to remain anonymous. One employee, however, Alison Gordon was kind enough to share her thoughts, as well as a picture. Alison, not yet retired but on-the-cusp, actually works two jobs within the community, both at Bucksaw and Old Crowe Winery. When asked about potential retirement, and what factors played a role in her decision to remain in the workforce, Alison indicated that while "yes" money did in fact play a factor, "staying

Truman Lake is normally at 706 feet above sea level. The lake was brought down in June for safety reasons so that a gate in the dam could be worked on by the Corps of Engineers. Although the Corps wanted the 706 elevation, the heat has probably contributed to the current elevation of 704.3. This level is considered to be within the normal range necessary to manage flood control, hydroelectric power genera-

# "Painted Ladies" Bring A Pop Of Color & Pizzazz To Clinton

"Painted Lady" is a term applied to a house built in the late Victorian era, dressed in paint-box colors with contrasting trim. It can also be the name of a butterfly with orange and brown wings and dark markings resembling stained-glass windows.

Painted ladies — the houses — are iconic in San Francisco, but the style is now migrating to the Clinton area.

The largest is a three-story apartment house on the corner of Ohio and Third Street that is being renovated by Bryan and Beth Goodson of Blue Springs, Mo. The Goodsons are examples of people who are taking advantage of Clinton's affordable real estate market by investing their time and money to bring older houses back to life.

They bought the apartment house earlier this year, sight unseen, Bryan said, along the house next door, for a total of \$60,000. Their plan: to resell, or flip, them.

They also bought the for-

mer Bloomers Flower Shop one block down, on the corner of Ohio and Second. That house is already a gem, with two stained-glass windows imported from Bolivia in 1892, Bryan said, and a wrought-iron fence imported from England the same year.

"The Bloomers house is number 20 on the list of historic buildings in Clinton," he said.

Over on the 900 block of South Main, Pastor Thomas Waller picked up a Victorian-era painted lady at an estate auction for \$50,000. Since he bought it as a hedge against retirement last September, he's put in

a lot of elbow grease, repainting everything on the outside. In the "before" photo he took, the exterior is a light brown. He painted it a cheerful yellow, and refreshed the red and green decorative trim and orange panels on the woodwork around the bay window to





its original brightness. Fish-scale and triangular shakes above the window add to the look.  
“It was built around 1900,” he said of the house.  
When he asked the sellers what was under the decades-old carpeting in the central room, which probably was the dining room, they didn’t know, he said. When he pulled it up, he found planks of white oak flooring, which was not in good shape, but refinished to a golden glow. The front room with the bay window also had white oak flooring

under the carpet, he discovered. It was glued down, so he had to scrape it off.  
In the kitchen, he removed 3 layers of linoleum to reveal pine flooring, which he refinished to match the flooring in the other rooms. He painted the walls and kitchen cabinets a dark blue-gray and glazed the faux tin-tile ceiling, which now resembles real tin.  
“I want it to look period,” he said.  
He also removed the dry-wall nailed over the transoms and is replacing it with glass. The house already had ceiling fans and new

glass in the sash windows, he said, along with its original wide baseboards.  
Thomas has lived in Clinton for 20 years and considers Missouri home, he said, although his father was in the military so the family moved numerous times. Until he retires, the restored house will be a home for his daughter, who is doing the landscaping, and his granddaughter, 12. Canine pets Squeaky and Truman guard the shady yard from behind a fence next to the garage, also painted yellow.  
Thomas is pastor of Clinton Church of the Nazarene next to the elementary school, and now lives in the parsonage.

Another ‘Painted Lady’ in Clinton is the historic cottage on the corner of Washington and Allen, across from the Allen Street Baptist Church. It’s the home of James Beasley, whose grandfather told him cottages of the type date from the same era as the courthouse, 130 years old.  
“It has a hand-dug basement, and stone benches on three sides,” he said of the rock slabs serving as the foundation. “The brick sidewalk also shows how old it is.”  
James said his grandfather knew all about the history of cottages of that era built in Clinton. James kept his eye out for one to go on the market, and bought it to live in, doing the work himself.  
The decorative woodwork around the windows and the porch was already there, he said, but he added the bright coat of red paint, contrasting it with white trim and the charcoal-gray exterior.  
Last week, the apartment house on Third was revived

by a new coat of paint.  
“It’s called cobalt blue,” Beth said. “It’s a nice color that really pops.”  
So far, the five-plex, which was white with black shutters, has been rewired and re-roofed, and new windows installed. Inside, the drywall has been replaced or repaired, Bryan said, and each apartment is receiving new flooring and kitchen appliances.  
“It was rough when we got it,” Beth said. “People have told us it looks a lot better.”  
The renovation of the house they bought next door was within two weeks of being finished, Bryan said, when a fire destroyed their work and sent them back to square one.  
The couple has bought houses to flip in Kansas, Arkansas and across the Kansas City area, Beth said, and are looking for more houses to renovate in Clinton. They generally find projects from people who bring houses to their attention, she said.  
“Nothing scares us,” she said. “We’ve taken on hoarder houses, houses with raccoons living in them, and houses with cats.”  
Renovating old houses takes vision and perseverance — plus paying for one of those big trash bins, called a roller, and having to fill and empty it six or seven times, Beth said, even for a small house.  
But the return, both to the renovator and the community, is rewarding.

The Clinton community it seems, has spoken. Perhaps for some these results are surprising, for others perhaps not. # Blue Ribbon Bakery Changes Hands: Long-time Business Raises Game for Couple

The new co-owner of Blue Ribbon Bakery has a ready answer to why she and her fiancée leapt at the chance to buy the bakery. "Becky wanted to sell, and we wanted to expand," said Jesse Gann.

Jesse and Casey Mothersbaugh had a catering business in their home. Becky is Becky Church, who bought the bakery in 2008 and ran it for 14 and half years. She is now ready to retire.

"I'm very blessed and lucky to find a nice family to take care of my bakery," she said.

The Blue Ribbon Bakery has been a Clinton institution for 41 years, she said. It has been at the same location, the shopping center on Ohio Street, since it opened in 1981. The owner then was a man who spent the first year assembling the equipment, Becky said. They still have the 1981 mixer that he bought, and a work table originally in a World War II ship, she said.

The next owner had a monument company in town, and bought the bakery sight unseen, she said. Esther Cauthen owned it

after that, then her sister, Katie, took it over, then her, Becky said.

Jesse grew up in Windsor, and has been baking her whole life, she said, starting in her grandmother's kitchen. Jesse is a 2009 graduate of Windsor High School.

Casey, from Clinton, is a 2009 graduate of Clinton High School. Together, Jesse and Casey have taken to operating the Blue Ribbon likes "ducks to water," Miss Becky said.

The Blue Ribbon serves as a meeting place for coffee groups, including farmers and couples, who come in every morning at 7 a.m. and sometimes stay for hours. Coffee is 81 cents, and includes free refills. The in-house deal is coffee and a cookie for \$1.89. The bakery also offers cinnamon rolls, turnovers, fritters, snails and breakfast quiche by the slice.

"The line is out the door in the morning," Jesse said.

There is a variety of sandwiches for lunch to eat in or take out. The new owners plan to expand the lunch menu, Jesse said, to include sub sandwiches on different types of bread. They already sell bread and

rolls to order. Folding their catering business into the bakery was a natural. They cater weddings, events and bridal showers, and make casseroles for family reunions, Jesse said. Personalized birthday cakes and wedding cakes have always been a key part of the mix of the bakery, which also caters the weekly Rotary meeting, Becky said. Last week, they baked 12 pies for the Boy Scouts to present as thank-you gifts to their leaders, she said. Wacky Cookie Wednesday, a Blue Ribbon tradition, continues, with colorful iced cookies in fun shapes for children or for a holiday party. Miss Becky has been helping Jesse and Casey in the transition period for the first month. Starting in August, she plans to enjoy her retirement and travel. She is already getting used to later hours. "I used to get up early in the morning," she said. "Now I sleep in 'til 9." The Blue Ribbon Bakery is located at 702 E. Ohio Street, #6, Clinton, Mo. 64735. Hours are 7 a.m. to 4 p.m Monday through Friday, and Saturday by appointment.

This means to follow the new law—the New Covenant—established between Jesus and those followers who bear his name—Christians.

We serve a merciful God. A God who would have saved the morally lost town of Sodom for the sake of 10 righteous people. So, let us constantly be righteous exemplars in a sinful world, loving our neighbor because of the great love Christ our Lord has for us. Amen!

## Trinity Lutheran

Johann Sebastian Bach (1685-1750) composed and conducted hundreds of Cantatas and other pieces of sacred and classical music during his lifetime. Unfortunately, only 209 of these have survived.

Cantatas are musical selections performed during regular and special church services each week. Bach, who was a committed, lifelong Lutheran and had an unshakeable faith in Jesus Christ, typically signed all of his compositions "Soli Deo Gloria," which translates "To the Glory of God alone."

As the director of music for Saint Thomas Lutheran Church in Leipzig, Germany for nearly 30 years, it was one of Bach's responsibilities to write a new cantata each week! The cantatas were based on the liturgy readings for a particular Sunday, and were performed prior to the reading of the Gospel. For those who think church services are too long today, keep in mind that many of Bach's Cantatas were over 30 minutes long!

In addition to church cantatas, Bach also composed, wrote and performed many, many other sacred cantatas and other orchestral musical pieces for weddings and funerals, congratulatory cantatas for secular events such as town council meetings, academic functions at the University of Leipzig, and for anniversaries and entertainment for nobility and society occasions.

It should not be overlooked that in his spare time, Bach was responsible for teaching Latin and music to students throughout the city of Leipzig each day. In addition, he somehow found time to become the premiere musician and organist in Europe. In fact, during his lifetime, Bach was much more famous as a harpsichord player and organist than as a composer. And, as has been mentioned before in this space, Bach was the father of 20 children!

There is no doubt that Johann Sebastian Bach was a very busy and productive man who loved God, had a deep and abiding faith in Jesus Christ, and was dedicated to the Lutheran Church. Praise God!

## Windsor Teacher Receives Grant from WGU Missouri

The \$500 grant that was awarded to AshLea Forrest will be used to purchase three Dash Robots for her computer lab.

AshLea Forrest, a K-6 computer teacher at Windsor Elementary School in the Henry County R-1 School District, has received a \$500 grant through WGU Missouri's "Fund My Classroom" initiative. The grant will be used to purchase Dash robots, providing Forrest's students with a hands-on opportunity to learn block coding in a fun and innovative way. Forrest learned she was selected for the grant in May.

Forrest has been incorporating block coding into her computer class curriculum and currently has three Dash robots, which enables up to nine students to participate in an activity at a time. With the grant she received from WGU Missouri, she'll be able to obtain three additional robots, allowing every child in a class to participate in the same activity simultaneously. The Dash robots respond to voice commands and can perform a number of movements and traits. The platform provides students with an easy way to understand coding and allows them to explore loops, events, conditions and programming sequences.

The innovative classroom project is one of 50 across Missouri chosen by WGU Missouri to receive funding. The nonprofit, fully online university issued a call in March for K-12 teachers across the state to nominate proposed classroom projects by April 17 for the opportunity

For 30+ years the 27th and 28th Judicial Circuits and Children's Division have been offering children in foster care the opportunity to take part in a typical summer camp experience, with the exception of 2020 due to being in a pandemic that many children in foster care don't usually get. For many years now Kozy Kamp near the Kansas state line has been reserving the first weekend of August for this event, this year it is August 1st-3rd, the camp is three days long and the children have the opportunity to participate in many

summer camp activities, including swimming. Many community partners such as the Conservation Department, Missouri Highway Patrol, Sheriff Departments as well as Police Departments give presentations that are not only informative and educational but inspirational as well, throughout the three day camp. The community partner demonstrations differ each year. The number of children that attend the camp each year changes drastically due to some children being a part of school activities, such as volleyball camps etc. and due to the amount of children being placed within the local circuits. Deborah Powell is the chief juvenile officer of the 27th judicial court and stated " this year we made the move to send out letters as a plea with local businesses to help keep this opportunity alive, we typically get the same businesses that donate each year and we are incredibly grateful for every cent that is donated to help the children experience something like this, but I feel it was time that it became public knowledge, that this opportunity is something we do annually and have for as long as I've had a job here, the only purpose of sending these children to camp is for them to have fun and they get the chance to be themselves and be around other kids that share similar backgrounds." Powell also stated that the camp counselors are all social workers and juvenile officers from the 27th and 28th circuit and this has helped build communication skills as well as trust between the children and the adults who help make decisions regarding their livelihoods. Powell shared that this camp, when the idea was brought forth to the state the state agreed it was a good idea however it could not help with funding and it would have to rely only on donations in order for the camp to run annually. The cost is approximately \$10,000 a

year, the average cost per child is \$175, this year the camp is expecting a high number of participants which is why they have resorted to asking other businesses for the first time for donations. Powell shared that she is incredibly grateful to get to be a part of a community that cares and gives back whenever and however it can and is appreciative of any donations given for the summer camp.

## LOOKING BACK

The AFL and the NFL merged (officially on June 8, 1966). But it was a long process. The full merger was not complete until 1970. Why did they merge? It was money, of course. The NFL still felt they played better football, but their profit margins were shrinking because they had to compete financially with the AFL for players. Lamar Hunt was in the middle of the merge but before the merge could be finalized, the NFL had to go to the US Congress to get permission due to antitrust laws. The NFL had to promise to expand, and was required to have 50,000 seat stadiums. The owners, of course, wanted a common draft and a championship game. The owners generally agreed on things, but Al Davis the AFL Commissioner was outspoken against it. He thought the AFL was getting the short end of the stick. The original AFL teams were New York Titans/Jets, Boston Patriots, Buffalo Bills, Houston Oilers, Los Angeles Chargers, Denver Broncos, Oakland Raiders, and Dallas Texans/Chiefs. The AFL teams had to pay \$50 million to play with the 'big boys'. The NFL required that Pete Rozelle remain the commissioner. The hardest part of the merger was the "Alignment" of the teams in each conference, the AFC and the NFC. Different combinations were written down and put in a hat. The alignment they

used came from a blind draw. Part of the alignment difficulties was the thinking that the old NFL teams were still considered better, in spite of Super Bowls III (Jets- Nameth) and IV (KC- Dawson) going to old AFL teams. The playoff formats were soon changed into divisions, etc.

Note: There have been many other pro football leagues, the USFL, XFL, etc. Of course, the CFL (Canadian Football League) has been in business since the 1880s and even tried to have some CFL teams in the US, (2009 -Baltimore). They did not last.

Other sports have had similar "growing pains". Baseball expanded fast and change formats. The NBA had a similar merger in 1976 with the ABA and the NBA. In soccer, the MLS was established with a 10 team league in 1996, which included the KC Wiz/ Sporting KC. The soccer league quickly grew to 28 teams. Lamar Hunt was one of the MLS founding fathers. Not to leave hockey out; the NHA (Association) started in 1909. It morphed into the NHL in 1917. They played with six teams until 1967 when they went to 12. The World Hockey League (WHL) operated from 1972-1979. They did not force a merger, but when they folded the NHL expanded. The NHL now has 32 teams. I do not see another league, in any sport, forcing another merger any time soon.

tion (for Southwestern Power Administration – SWPA), fish and wildlife management and recreation at Truman Lake. However, a couple of local marinas are seeing some potential hazards to boats due to low water and

boaters are encouraged to navigate with care.

Sterett Creek Marina recently emailed a letter to its slip owners advising them of the ongoing repairs to the dam gates. Boaters were told that large concrete blocks acting as anchors for docks were seriously close to the surface of the water, since the water is currently at about 9 feet. Marina personnel have placed small buoys on the anchors to alert the boaters but still encouraged caution when entering and exiting the marina from the wave break to the docks.

At Bucksaw Resort and Marina, a staff member reported that docks are halfway on the ramps, and that business has slowed down because of low water and visibility of stumps. She said that the restaurant was closed Monday through Wednesday due to lack of patrons, and reported that the Corps of Engineers had contacted her to see if the marina would suffer any damages.

A representative of Osage Bluff Marina said the water has been this low before, and bracing for the dock is still underwater. However, he said that if the water went lower things might be different.

Truman State Park Marina staff reported that everything was fine at its location and that business was good. However, Lynette Stokes, Director of Benton County Tourism and Recreation, says high gas and food prices as well as the low lake level is having an overall negative impact on tourism.

Jim Sandberg, Operations Project Manager for the Truman Project, said that everything is in the normal range for the power pool (which uses two feet of the lake water to generate electricity through SWPA.) He doesn't expect there to be requests for releases to take place, but it may depend on the rest of the summer, and whether or not there are no other sources for hydropower.

"People are just concerned," said Sandberg."We are not looking at any generation that will pull us below the 704 feet above sea level, unless something like evaporation causes a drop in elevation. We are at 704.3 feet now, but at 704.0 SWPA will not be able to generate. The record low for the lake was 703.4 feet in 1981. The rain that the area had on Sunday night was good, but probably didn't do much to raise the lake elevation. However, more rain is probable later in the week.

The Corps project will take about five months, ending in the fall. Sandberg said that there is a lot involved in this project including the continued closure of the Dam Access Road.




