

Deepwater Family Dives Into Business

Kris Miller came by his passion for scuba diving naturally — he inherited it from his father, Kenny Miller. Kenny started taking scuba diving lessons when he got out of the military, Kris said. Kris started scuba diving when he was young.

"It's a fun thing to pass down, and a fun way to see the world," Kris said.

Kris passed the love of scuba diving to his daughter, Emilee Taylor, and in 2019, started Ozarks Scuba Diving with three generations of the family — Kenny, Kris and spouse Mikayla Miller and Taylor.

Most of the family lives in Deepwater, Kris said, but Ozarks Scuba Diving is a mobile company, meeting people where they want to dive. They have taken people scuba diving in area lakes to explore wrecks or treasure hunt.

"We can point them to good locations,"Mikayla said.

Next fall, Ozarks Scuba

Diving will offer scuba diving lessons at the Clinton Aquatic Center, Mikayla said. Certification will probably take place at Stockton Lake, she said, which has clear water.

They offer guided diving trips to Stockton and lakes in Arkansas and Illinois. They especially like to go to Beaver Lake near Eureka Springs, Ark., Kris said, where there is a sunken ghost town called Monte Ne, which was flooded when the Beaver Lake dam was built.

"There's an old jailhouse there," Kris said. "You used to be able to dive down to it and put yourself behind bars."

This time of year, they are mostly involved in the recovery side of things, Mikayla said. They work with the state highway patrol and the Henry County Sheriff's Department to recover cars and boats from the lake, she said, and re-

The church is less than 25 years old, but when you enter the red door, you'll discover a sanctuary with traditional features — an ornamental screen called a reredo, behind the altar, a stained-glass rose window, tapestry paraments, and a carved wood pulpit and baptistry.

The pulpit, the baptistry, and the reredos, which have Celtic crosses with central floral motifs, were made by a church member Bob Crossley.

"Bob worked on the designs until everyone was happy," Kate French said. "He would bring the pieces to church on Sunday. He wanted to make sure everyone loved them."

Kate is the Bishop's Warden at St. Paul's, representing the bishop of the West Missouri diocese, the Rt. Rev. Diane Jardine Bruce. You'd never know that in the last few years, the church has survived a plague, when the church was shut up during the pandemic, followed by a flood, which ruined the **BUILDING BACK BETTER**, St. Paul's Bishop's Warden Kate French is proud of the communion box made by her nephew after the former container was damaged in the 2021 flood.

flooring and damaged the walls.

Luckily the reredos, along with the pews, was not damaged. With all the work done on the interior, the sanctuary doesn't show any sign of the backto-back disasters that have assailed it.

"It was really a test of faith to get this done," Kate said. "It's not just back the way it was, but it's better because all the little things that needed fixing were repaired."

It was when they had to close up the church during the pandemic in 2020 that the first disaster occurred — because there was no air circulating, mold grew on the hymnals and other surfaces, she said. The hymnals had to be thrown out, she said, but were replaced by the diocese. After a thorough cleaning, church members installed an ion filter, and felt confident the church was free of mold.

Then, just when St. Paul's was planning to reopen, came the flood.

It was March of 2021 when a cold snap hit, Kate said. They had turned up the heat and opened cabinet doors under the sinks. But a pipe broke, flooding the sanctuary.

They didn't discover the damage until four days later, when they went to the church to get ready for the bishop's visit.

"There was water covering the carpet," she said.

The church visit was delayed, and when the bishop visited the next week, the walls were ripped out. Everything was piled behind the altar and covered with sheets, Kate said.

They still had services during the next year, but **St. Paul's 3**



Continued from page 1 cently found a site with seven cars plus a dump truck that they are going to recover.

"Ozarks Scuba Diving is the only independent rescue, recovery and salvage diving business in the area," Kris said.

To raise cars or boats from the bottom of the lake, divers attach tow ropes that pull the vehicle up, he said. Under certain circumstances, however, they can attach flotation bags, which are inflated using a spare tank.

Salvaging vehicles takes concentration on a lot of details, Kris said

"Safety being paramount," he said.

Ozarks Scuba Diving also recovers keys and cell Makayla said. phones, Treasure hunts of Truman Lake have turned up cell phones, lighters, Apple watches, fishing rods and lures, Kris said, as well as snorkel masks, towels, shoes and swimsuits. Ozarks Scuba Diving has short, lightweight metal detectors that attach to vour arm and work underwater, he said, and vibrate when they detect metal.

Ozarks Scuba Diving also owns an underwater drone, which is tethered and has a camera and a robotic arm.

"It's part of the team," Mikavla said.

The robotic arm is useful in picking up trash and pop cans, when the Deepwater divers help with environmental clean-ups, Kris said. They will be at Bennett Springs State Park at the end of February to clean up the springs, Kris said, to help save the environment of the hellbender, an aquatic salamander, that lives there.

To keep warm in the winter. divers wear thermal drv suits with layers of clothing, called diving thermals, under them, Kris said.

They also do cave diving in warmer climes, including Mexico's Cenote Zapote caves in the Mayan jungle of Mexico. A cenote is a cave that has collapsed, creating a depression that is filled with water. The dive

said.

"Work went on for eight months," Kate said. "We were back together by Advent."

But it took even longer to get the floor of the sanctuary replaced because they couldn't get anyone to do it. Eventually they hired ServPro, whose staff brought in more than 30 fans to dry out the sanctuary. As well as replacing the flooring, the company dealt with the church's insurance company, so the church was compensated for the cost.

"It wasn't finished until April of last year," Kate said of the job.

Clinton's original Episcopal church, called St. Mark's, stood on the corner of Second and Grandview, holding its first service in November of 1869. The name was changed to St. Paul's in 1886. The church was closed in 1925 after the building developed structural problems. The site is now a playground, Kate said.

The Episcopal congregation then met in a house church at 315 S. Third St., north of Ohio. There used to be a cross up under the eaves of the house, Kate said.

About 25 years ago, the congregation decided to build a new church. When they couldn't find land in town, they bought 9.2 acres beyond the east edge of Clinton, and built the white church. There are only two stained glass windows in the back of the sanctuary, plus the rose window over the altar. The arched windows on both sides of the sanctuary are clear glass.

"We like the view of the open field," Kate said.

Bob Crossley was a hobby woodworker who made the interior what it is today, she said. The material for the reredos, made of red oak, cost \$2,500 and was paid for by contributions from church members.

"After Bob cut out the wood, his spouse, Barbara, stained and varathaned the larger pieces in their garage, and the smaller pieces in her kitchen," Kate said

up the altar for communion. Church members also serve as lay readers or Lay Eucharistic Ministers to help with communion, Kate said. The Lay Eucharistic Visitor takes communion to shut-ins.

The flood damaged the sacristy and the communion box, used to transport the elements, which was stored in the sacristy. Kate's nephew, Robb Gallogos, volunteered to make the church a new one, she said, choosing symbolic wood for the box.

"He made the box out of African mahogany, and used ash wood for the interior dividers," she said. "The cross on top is apple wood."

Robb lives in Denver and didn't want to mail his handiwork, so Kate and her husband picked the communion box up when they visited Colorado last December. It is now in a drawer in the Sacristy.

"It was another step in getting the church back," Kate said. "It was like when we got the baptistry up. It did my heart good."

churches Episcopalian trace their heritage back through the centuries, Kate said. The word "episcopal" means that the church is headed by bishops, who according to tradition, have been ordained in an unbroken succession from the time of the apostles. In addition to the House of Bishops, there is a House of Deputies, made up of priests, deacons and lay members.

Kate's father was an Episcopal priest who served in Valparaiso, Indiana, where she grew up. Kate and her spouse, Sam French, moved to Clinton 20 years ago, where Kate taught English for 13 years at Clinton High School.

Sam is head of the Henry County Ministerial Alliance, which plans the World Day of Prayer in May and the city's ecumenical Thanksgiving service, and has an office at First Baptist

Church where people can apply for aid.

As Bishop's Warden, Kate attends diocesan council meetings, where representatives from Episcopal churches are discussing how to serve as the hands and feet of Christ in the world. The Episcopal Church partners with other denominations to serve others, she said, and is inclusive, with women serving as bishops, priests and deacons.

"St. Paul's is a church with an open atmosphere, where all are accepted as children of God," she said. "It's all about love."

The red doors of Episcopal churches are a tradition that goes back to ancient England, signifying the building is a place of sanctuary. It still signifies a place of refuge, Kate said, where people can find peace, comfort and healing. Red is also the color of the Holy Spirit.

"I would love everybody in the community to come and share a Sunday morning at St. Paul's," she said. "Everybody's friendly. You will be spoken to."

Services are Sundays at 10 a.m., with communion, which is open to all, every other Sunday. Morning praver is on alternate Sundays. Coffee and fellowship time is held in the back part of the sanctuary after the service.

Lent starts next week on Ash Wednesday, Feb. 22, making this a good time to find a church home, and have a church family to celebrate with on Palm Sunday, April 2, and Easter, April 9.

The church with the red door was only a year old when she and her husband moved to Clinton, she said, but it is her favorite church, not only for the beauty of the sanctuary, but because of the people who created and care for it.

"It's a very loving church," she said. "This is so much a family."



they do at Cenote Zapote has a narrow access, and is a dive for advanced divers. It is known as Hell's Bells because of underwater stalactites shaped like large bells.

There is a vast difference in scuba diving today and when his father was learning, Kris said. Back then, the equipment was rudimentary, he said – divers had a weight belt, an air tank and an emergency flotation device.

Now, they have breathing regulators and floatation devices that are much more intricate, and can be fine tuned, plus electronics and computers that tell divers the depth and water temperature, and have built-in compasses.

"It's much safer," Kris said. The sport of scuba diving is becoming more popular, Kris said. With him, the hobby progressed to an obsession, then to a business.

For Kris, diving and being under water, where he can view a part of the world that few people see, is his natural habitat. Or as Mikala puts it:

"He has to get his gills wet," she said.

it took that long to get the sanctuary completely repaired, she said. Water had damaged the walls halfway up, so those sections had to be removed and replaced, along with the insulation. Then they had to replace the drywall, paint it, and move the furniture back.

They also had to stain all the wood needed to reinstall the baseboards, she

The Crossleys were also the official grandparents of St. Paul's, she said, greeting everyone with a hug. After Bob passed away, Barbara moved from Clinton to be closer to family.

A photograph on the wall in the back section of the sanctuary, next to the door to the kitchen, is of Cliff Campbell, another church benefactor. Cliff, a welder for the Peabody Coal Company at the Tebo mine, paid off the mortgage on the church, Kate said.

"He truly loved the church and the people here," Kate said.

Other figures that have passed through St. Paul's history are Father Larry Lewis and Father Rolf Leed. Fr. Leed, who worked parttime as a counselor at Pathways, was the priest at St. Paul's for 20 years, serving at both the house church and the new church, she said.

St Paul's morning service is as traditional as its sanctuary. It begins with a processional to the altar, led by a person holding high the cross, followed by the priest, lay readers and acolytes. Candles glow in brass candlesticks on the altar and below the rose window. There's a hymn board on the wall behind the pulpit where hymn numbers are posted. The Book of Common Prayer, first printed in 1549, contains liturgies and daily prayers, is in the pews.

Off the side of the chancel is the sacristy, where Father Mike Kyle, the supply priest who serves St. Paul's, gets ready for the service. Framed pieces of old vestments decorate a wall in the sacristy.





It was a nice warm February day to worship the Lord. Clint Keeney rang the church bell. Mrs. Julia Klinefelter led in the congregational singing with Mrs. Dixie Collins playing piano. We rejoiced with Eva Richardson on her 10th birthday. Randy Vogt and Clint Keeney collected the offering.

The scripture passage from Pastor Chad Pollett's sermon was from John 6:1-15. In this passage Jesus and His disciples had crossed over to the far shore of the Sea of Galilee. They were tired and wanted to rest, but a large crowd had followed them. It was getting late and they knew the crowd would be hungry. Jesus knew just what to do. A young boy had 5 small barley loaves and 2 small fish. The disciples told the people to sit down and Jesus blessed the bread and the fish. There was enough bread and fish to feed the 5,000 men, as well as all the women and children of nearly 20,000. The people realized that Jesus was the promised Messiah. Jesus is the Bread of Life - who gave us eternal life through His death and resurrection.

Dallas Spurgeon, the Garmin sales manager, took the audience through the Garmin chartplotters, covering everything from standard sonar and how to get the best out of the settings to down scan, side scan and finally ending with Live-Scope.

Understandably, the new LiveScope system was a maior feature in the seminar. LiveScope is Garmin's system that lets the user scan around the boat in all directions, looking for fish. Not only does it show structure and fish and the distance to them, but it also can show the angler's lure and how the fish respond to it when it is set up correctly. Spurgeon explained how to adjust the system so that the angler gets the best the LiveScope has to offer, noting that the best settings vary with water conditions. This technology has had a major impact in fishing tournament results.

"The newest advances really give fishermen a new way to approach fishing," says Mike Toigo of Angler's Port Marine. "You can drive in to an area, cruise around looking for structure with your big motor and establish waypoints to visit later. If you have a Garmin trolling motor, you tell it, through the chartplotter, to follow a route to the waypoints that you've marked, and it will go from waypoint to waypoint without you having to do a thing."

Another feature that is worth noting is that the Garmin units will let the angler create a track that he wants to fish, say a specific depth for instance, and he then can direct the electric trolling motor to follow that trail by using the chartplotter. It also has a function that directs the trolling motor to keep the boat in one position, effectively becoming an electronic anchor.

As the informercial says, "But wait; there's more!". The latest units have a wide range of functions that can be manipulated to adjust the sonar returns to provide the best viewing options, depending upon what the viewer wants or needs.

Spurgeon also explained about the mapping function in the latest Garmin chartplotters that cover all of the United States in freshwater (and saltwater) in increments of one foot. The mapping function is integral to the new units. He also stressed the ActiveCaptain function, a Garmin exclusive, and its features. He also talked about Garmin's customer service center that helps customers with their problems as well as updating of software, which can be done online through a computer

or by smart phone.

A few years ago, she returned to the Hinton Family farm, where with her parents, Chuck and Carol Hinton, they turned a former soybean field into four acres of sunflowers. With the encouragement of Jennifer's daughter, Sarah Smidt, the Hintons opened the field to the public last summer.

Now, Jennifer and Sarah, a designer and photographer, are turning their talents to an urban makeover.

Jennifer refers to Sarah as her partner in crime. Sarah jokes back that her mother needed a project. But their reasons to tackle the makeover on Main go deeper than that.

"We are interested in the historic district," Sarah said, "and bringing more businesses to the downtown area."

Their plan: to turn the street level into retail shop space, and the second story into a bed and breakfast. The second story will have four windows across the front looking down on Clinton's historic train depot.

They chose the building on South Main because of the view from its location opposite the depot, which houses the Clinton Chamber of Commerce.

"Bicyclists using the Katy Trail come to the Chamber of Commerce, looking for information on places to eat and shop," Sarah said.

Sarah and Jennifer think the ground floor of their building would be a good spot for a bakery, cafe or bike shop, or a combination of the three, like the Bike Stop Cafe in St. Charles, which offers coffee, pastry and light fare along with bicycle services, rentals and accessories.

"It's already listed with Mark Dawson," Sarah said of the retail space, referring to Clinton's director of economic development, who said there is a demand for retail space. "There are tons of potential on the Square."

Their first step was assessing the building, which dates from the early 1900s and housed a succession of furniture stores. The business there the longest was Peck's Furniture Exchange, which occupied the space from 1919 to 1957.

"My grandfather remembers when it was Peck's," Sarah said, referring to Chuck Hinton, who grew up on the family farm east of town.

To find the older history of the building, Sarah started at the Henry County Museum's Genealogy Library, where she found a listing in a telephone directory for Sims and Hurt Furniture and Undertaking. She was surprised, at first, to find out that furniture companies were also the undertakers, but learned that back then, it was common.

"The same people who built or sold furniture would also build or sell coffins," Sarah said. "It was a way for them to expand their business."

Sims and Hurt was owned by William and Naomi Sanders Sims in partnership with Benjamin Hurt. Sarah made another interesting discovery about Naomi.

"She was the first licensed female mortician in the state of Missouri," Sarah said. "In her free time, she enjoyed quilting and would throw quilting parties for the ladies in town."

Armed with names and the addresses, Sarah searched the Missouri Historical Society's digital online files. Combining information from newspaper ads and death certificates with information on Ancestry.com, she compiled family trees of the businesses owners, and located William and Naomi's great-grandson, David Jackson, who lives in Liberty. David has sent her photographs, including one of Naomi.

"We've always been interested in history," Sarah said. "Our family has been in Clinton for more than 100 years. This is a labor of love."

In 1919, the building was sold to Harold Peck and his son, Grover Peck, who was newly returned from serving in WWI. They operated Peck's Furniture Exchange in the building for decades. An ad from the "Clinton Eye" in 1934 announced the formation of Consalus and Peck Furniture and Undertakers with partner Gene Consalus. Consalus is still a name of a mortuary in Clinton. Sims and Hurt moved to the square, Sarah said, then to a yellow house on North Main. According to an old ad in the Clinton Eye, Naomi Sims, along with Mae Jackson and Harry W. Jackson, sold their funeral home on North Main to Fred Wilkinson in 1936.

After 38 years in business, the Pecks sold the building on South Main to Harold Hoey in 1957. In 1962, it became Jim Bernard's Bargain Spot, the fourth business to offer new and used furniture in the building.

The South Main building, which had a newer roof, looked good from the outside, Jennifer said, but when they gutted the inside, they found rotten floor joists in the front part of the building. Upstairs, the newer roof was layered over roof joints that were rotten, with no underlayment. Used pieces of metal were the only thing separating the upstairs facade from "the great outdoors," Jennifer said.

The floor joists were removed, and a crew from Roman Herschberger of Herschberger Construction poured a concrete foundation that is tied into the piers, so that the entire ground level has a solid concrete foundation, Jennifer said. The crew also installed a new underlayment and a metal roof, Jennifer said. A steel skeleton is being constructed to frame the street-level retail space.

"We want this to be done right, and once," Sarah said. Hans Nettelblad, a former classmate of Jennifer's at CHS, is the architect for the makeover. Dane Smidt of Dane Smidt Flooring is refinishing the upstairs floors and installing custom tile work. David Barabas is doing the custom woodwork and Eddie Phillips of Norton and Schmidt is the structural engineer, Jennifer said.

Jennifer has already started collecting furniture and art to furnish the bed and breakfast on the second floor's 1,000 square foot space. Planning an art deco look, she purchased furniture at two estate auctions in the county, plus invested in primitive paintings by Reggie Cornell, landscapes by Woody Roddy, Jennifer's art teacher at CHS, and paintings by Ike Parker. Parker did scenes of homes, barns and mills of the area, and rural life. The Henry County Museum has several of his works in its exhibit and art gallery, and there are also several in the Truman Lake Dam Visitor's Center in Warsaw.

Sarah and Jennifer said their mission can be summed up in the words of Parker, whose work records local landmarks that are now gone, along with older methods of farming.

"Some of the scenes don't have glamor or significance to the rest of the world, but to the people who live here, they have a lot of worth and sentimental value," Parker wrote.

Jennifer and Sarah see preserving historic buildings on the Square in a similar light. The remodel has been slower than they expected, Jennifer said, but they are taking their time.

"We want to ensure that this building is standing tall for generations to come," Jennifer said. "We hope others will see the value of our historic district and invest and patronize the businesses on the Square."

For now, the building is encased in a protective shell, like a nut or a sunflower seed. As soon as the steel support frame is installed, Jennifer said, new brick will go in, the wood windows will be installed, and the building will start to open up and turn its face to the sun.

"We've got our plans," Jennifer said.

"We're ready to roll," Sarah said.

Jennifer said if anyone has old photographs of the building or its proprietors that they are willing to share, she and Sarah would be interested in seeing them and adding to their store of information of the building's history.

Jennifer said the Hinton family plans to plant sunflowers on the farm next spring, which Sarah says will be an early one, based on folk wisdom handed down to her from her great-grandfather, Earl Hinton, who chose his spring-planting dates based on signs from nature







A LESSON ON RACISM

My first lesson on racism came when I was only five or six. We lived in Jackson, Mississippi. A city work crew was repairing a water line in the street in front of our house. I looked down into what seemed to me to be a big hole in the ground. At the bottom of that pit, there was a large, strong, black man. In an innocent effort to be friendly and talk, I said "Hi, n_____."

"Boy," he answered, "I'll eat you alive." Frightened enormously, I ran as fast as I could back to our house. The other men in the work party roared with laughter. In the safety of our house, I put it all together. I had called this man a bad name. I never told my parents about the incident; but I bided my time. When the opportunity came, I asked my mother "Why do we call black people n ?"

She explained it like this. Black people come from a race called Negroes. Ignorant and illiterate people say "n_____." I understood ignorant but didn't know what illiterate was. Still, I knew she was telling me our family does not approve of that word, and we will not use it here. She continued, "They are people just like us. They should be treated with the same kindness and respect we give other people. Jesus taught us to treat everybody just like we want to be treated." I'm not sure she was right about the origin of the name, but she was right with the rest of her lecture. We were not to use that word; and if someone did use it in our house, they got a "talking to" about the value and equality of all human beings, "God made them just like He made you and me."

Growing up in the deep south, I cannot say there was never prejudice in our house. But I can say, when it did appear, it was solemnly frowned on. This one example before I conclude. Since my mother and father both worked, they hired a black lady to do some housework each week. While discussing housework at church, my mother told a friend what she paid this black helper. "Why?" the lady asked astonished. "Why do you pay so much? I pay my help only half that. "

Bluntly, my mother could be blunt, she answered "Because it is right!" There is the answer to our racism.
