with allocations also to the Drug Enforcement Administration and Department of Justice for law enforcement. However, no funds are designated for law enforcement efforts in Benton County.

"Benton County has trouble with Marijuana and Meth," said Sheriff Eric Knox. "But, the biggest problem is with prescription drugs. The \$4 billion

aimed at fighting these kind of drug issues is going to health agencies and federal law enforcement agencies. Some funds are being used to issue grants for high intensity drug trafficking areas such as the Hwy 44 corridor. But, Hwy 65 is also a drug trafficking corridor that Benton County is having to address."

Hawthorn Bank Gets New Interactive Teller Machine

If you use the drive-up windows at Hawthorn Bank's Northtown facility today, you'll find those windows closed before 8 AM and after 5:00 PM. But that's changing. Chuck Allcorn, Hawthorn's local Market President, introduced me Tuesday to what some call a "virtual ATM," which

he referred to as an "Interactive Teller Machine" and, with an actual human teller in a building in Jefferson City, can stay open during other hours. The machine was installed at Hawthorn last week and is presently located in the 3rd drive-through lane.

To demonstrate the ITM's capabilities, Allcorn made both a cash withdrawal and a cash deposit; and we were greeted during the transactions by Macaya Deal, the Jeffer-

RUBBER BOOTS
NOW ARE RATION
FREE

Rationing of industrial rubber footwear has ended according to an OPA announcement.

Rubber boots and rubber work shoes have been placed on ration free list.

Other commodities previously released, were gasoline, fuel oil, oil stoves and processed foods. "Only meats, fats and oils, butter, sugar, shoes, automobiles and tires are still rationed, and each of these will go off the list the minute that supplies will stand up under the pressure of consumer buying," says J.G. Callaway, OPA District Director.

The following six types of rubber footwear now ration free are: hip height boots, above knee height boots, below knee height light boots, mine pacs, booties and other footwear in this class 10 inches or more in height, and pacs, booties and work shoes below 10 inches in height.

Production schedules for 1945 call for approximately 3,000,000 pairs of these six types of rubber footwear, a million and a quarter more pairs than were turned out last year.

BUYS WARSAW CAFE

FARMERS BANK IN FEDERAL SYSTEM

The Farmers Bank of Lincoln which recently

became a member of the Federal Reserve System, was chartered January 11, 1890.

It has a capital of \$25,000, surplus of \$25,000 and total resources of \$920,071.06. Its officers are : J.A. Autrieth, president; John W. Guthrie, vice president; S.O. Brill, cashier; A.D. Hunt, assistant cashier and Addie Love, assistant cashier.

The addition of the Farmers Bank of Lincoln brings the total membership of the Federal Reserve Bank of St. Louis to 490. These member banks hold over 70 percent of the net deposits of all banking institutions in the Eighth district.

This is the fourteenth state bank in this district to join the system in 1945. Twenty joined during 1944.

THE BENTON COUNTY, MO COMMUNITY EMERGENCY RESPONSE TEAM (CERT) classes have been scheduled for Benton County in Warsaw, MO. All classes will be held at the Warsaw/Lincoln Ambulance conference room at 1206 Medic Dr. Warsaw. The C.E.R.T. classes will educate individuals about disaster preparedness, about hazards that can impact the immediate areas involved in the disaster and provide training in proper basic disaster response skills. These skills will involve fire safety techniques, light search and rescue techniques, team organization, disaster medical operations, life saving skills with an emphasis on decision making processes, rescuer safety, what to expect in terms of immediate services and how to do the greatest good for the greatest number of people. All classes will be held in the evenings at 5:30 PM to 8:30 PM to enable those citizens who cannot attend day classes an opportunity to be a part of this vital community service team. There will be no charge for the classes.

The C.E.R.T. Classes will be held on three consecutive Mondays and three consecutive Thursdays. September 10th - Disaster Preparedness, Personal Protective Equipment & C.E.R.T. Organization; Sept. 13th - Fire Safety and Search & Rescue; Sept. 17th - Medical Part I & 2; Sept. 20th - Disaster Psychology & Terrorism; Sept. 24th - Hands on Demonstrations and Practice; Sept. 27th Communications Training & Course Review. Oct. 2nd - Final Testing & Full Disaster Simulation. Since different phases of the program are covered in each session, it is necessary to attend all the classes for a total of 20 hours. However, things do happen, so a Make-Up class will be held on Saturday, Sept. 29th from 9:00 am to 12:00 noon.

The classes will be taught by the Samantha Henley, Deputy Director, Benton County, MO Emergency Management with the assistance of Marie Payne- Bowman, C.E.R.T. Coordinator; Christy Barber, Martha Foster, Sal Rios, Jude Kelly, Deputy Sheriff Storm Walker and numerous professional members of the various EMS and medical services in Benton County.

The C.E.R.T. program trains citizens to be better prepared to respond to emergencies (tornadoes, floods, earthquakes, terrorism) in their communities when they happen, as well as assisting with non-emergency projects that help improve community safety. 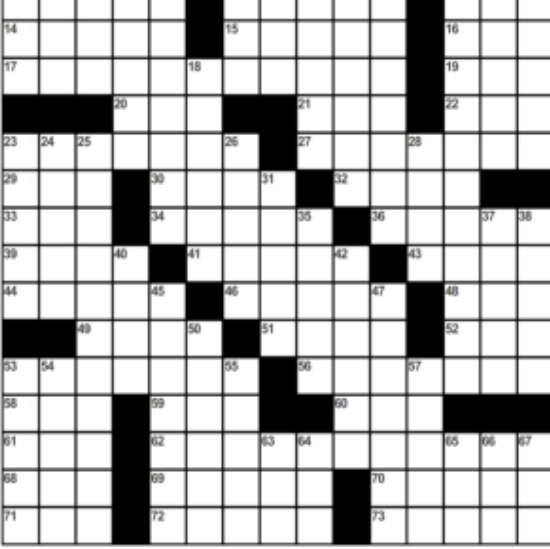

KCP&L Expands Payment Options For Customers

As a result of high customer bills due to one of the hottest summers on record, KCP&L is temporarily expanding its customer payment options and delaying residential disconnections.

Effective immediately and through the month of September, KCP&L will not disconnect residential customers. Further, customers will be offered a four-month period to pay their balances. “We understand that our customers are feeling the stress of higher bills due to one of the hottest summers on record,” said Chuck Caisley, Chief Customer Officer. “We are providing extra time and additional payment options to help customers manage this expense.”

To participate in the extended pay period being offered, customers should call the KCP&L customer care center after the Labor Day holiday at (816) 471-5275 or (888) 471-5275. KCP&L customer service representatives will be available beginning Sept. 4 to assist customers with questions about these options. Given the number of expected calls, wait times may be longer than normal.

“To ensure service isn’t interrupted in October, it’s important that customers call us in September to make payment arrangements,” Caisley said.

boost of traffic benefits these stores without a doubt.

The Truman Dam Visitors Center, a premier tourist spot for those visiting Truman Lake and Warsaw, was once again a favorite stop for this Labor Day weekend.

Although last year they had 1,630 visitors over the weekend, the Visitors Center welcomed in 1,374 people between Friday, August 31 and Monday, September 3.

Even though this number dropped, it's still an impressive amount considering that the auditorium, which holds the mastodon bones found here in Warsaw, was having ceiling construction done throughout this time. The building should be finished by Sunday, September 7.

Beth's Osage Mini Mart is arguably one of the best places to fill your gas tank in Truman Lake. Those visiting the area for the weekend were able to experience the friendly employees and excellent service provided by this locally owned gas station.

In 2017, over 36,000 minnows were sold over Labor Day weekend, but with high temperatures, this number dropped. People attempted to beat the heat by staying on the lake, resulting in 22,000 minnows sold over the weekend this year, according to Beth Drake, owner of the Mini Mart.

Friday business was steady, and the traffic grew from there. "We sold a lot more gas this year than last, thanks to the lower prices. Overall, this weekend went smooth and as well as it could've," said Drake.

Sterett Creek Marina, home to the Drunken Minnow Bar and Grill, was overflowing with business over the holiday. Ken Beyer, owner, and operator of both the Marina and the Drunken Minnow stated, "The weather this weekend helped business tremendously. It was nicer out than the forecast had predicted, so we had plenty of people come by. The business we had this year was close to, if not more than the business we had during the Fourth of July weekend."

The Drunken Minnow is relatively new to the Warsaw area, only in its second year of business, but according to Beyer, "This was the best weekend we've ever had for it. The seating is under our shaded dock, so it provided a nice place for visitors to get out of the sun and relax for a while."

Not only was the Drunken Minnow busy, but the marina was also packed as well. Boat rentals were abundant, the campground provided on the mainland was full, and there were barely any docking slips left. "The new dock we put in this year helped us host more people without a doubt, this weekend is a great way for us to end the season," said Beyer.

Cosmic Café, owned and operated by Shannon Noland since February of 2006, is a favorite business here in Warsaw.

The perfect place for a morning coffee, freshly cooked breakfast, or relief of a sweet tooth, Cosmic Café was flooded with visitors over the holiday. "This year was the record for any Labor Day weekend business we've had. We're normally not open on Labor Day itself, but this year we decided to change that. We were as busy during breakfast on Monday as we were on Saturday, which is saying something. Although we had all the extra business, things went as smooth as possible, and we were glad to get to host such friendly tourists and locals alike" explained Noland.

With all this business, traffic was expected to be as bad as ever this holiday. Last year during Labor Day weekend, Missouri State Highway Patrol recorded 941 crashes statewide, resulting in 11 deaths and 265

injuries. These numbers add up to one death or injury ever 12.4 minutes. The statistics for this year should be posted soon, providing information from 6 PM on Friday, August 31 through 11:59 PM on Monday, September 3.

City teller. Of course, receipts were furnished for both transactions. The list of capabilities of the ATM is long: cash withdrawals and deposits, credit and debit card transactions, loan payments, other business matters ... but with a live teller on the other end, perhaps to help you complete a transaction.

Allcorn added that, at present, that the ATM is open for business from 8 AM to 5:30 PM. After 5:30 PM it will revert to a standard ATM machine. As business builds, Hawthorn expects its hours of operation to be 7 AM -7 PM. But the demand for it may well dictate its eventual hours of operation. "It's more economical to house a teller in a remote site, and from there to service multiple locations such as the Warsaw, than to have a number of tellers at the bank window," he said, "But this new feature is really like actually walking into a bank."

Sheriff Knox said that Benton County needs a pill-sniffing dog for schools to help with the prescription drug issue, and a drone would greatly increase efforts to locate lost children and drowning victims. He said that infrared capabilities of a law enforcement drone could detect heat sources (of humans) and also help locate criminal suspects in hiding places.

"Warsaw Police Chief Jason Wenberg was shot during an altercation that took place last May," said Sheriff Knox. "If we had had air support like a drone could supply, during that incident, Chief Wenberg's injuries would not have happened."

Sheriff Knox said that a drone would cost \$20,000 and a pill-sniffing dog \$7,000. Of course, there is no money in the budget

to cover those costs. However, there is a campaign to raise needed funds and Lucas Oil is being contacted as a potential contributor. The Friends of the Benton County Sheriff's Office are also working on grant applications and a fundraising drive.

Linda Viebrock, Administrator of the Benton County Health Department, said recently that she has not heard of any health organization in the county that is expecting to get funding from the \$4 billion earmarked for the opioid epidemic. However, she said that the county has a fairly new prescription drug ordinance that is in effect and is operating in conjunction with the St. Louis Health Department. Under this Prescription Drug Monitoring Program (PDMP), the prescribing and dispensing of schedule II-IV controlled substances is carried out to assist in the identification and prevention of prescription drug misuse and abuse.

"Under PDMP, pharmacies have to report any prescription given out," said Viebrock. "Physicians can go online to see if a patient is receiving the prescription somewhere else. It will take some time for input to be put in the system. Another thing this program allows is for trained first responders to administer Narcan (Naloxone) for opioid overdose."

According to www.ncbi.nlm.nih.gov, paramedics have been carrying and administering naloxone for decades, but the first emergency personnel to arrive at the scene of an overdose are often not paramedics but rather emergency medical technicians (EMTs), emergency medical providers with a lower level of training than paramedics, or law enforcement officers (LEOs). Nationwide, EMTs outnumber paramedics approximately 3 to 1, and LEOs are approximately 10 times more numerous. These disparities are typically more pronounced in rural areas and other underserved locations such as tribal lands.

Equipping EMTs and LEOs with naloxone may therefore reduce the amount of time between the onset of respiratory depression and

the administration of naloxone. Because damage to the brain and other organs generally increases the longer the victim remains hypoxic, the quicker normal respiration is restored, the better outcomes are likely to be.

"I've asked for and will receive 22 doses of Narcan for my staff to carry on board," said Sheriff Knox. "That will be coming from the State Health Department. We're waiting on our training date before we receive the injectable Style pins. Narcan is used for opioid overdoses in the field."

Residents of Benton County can help local law enforcement get a bite of the \$4 billion allocated for the opioid epidemic by contacting their state and national representatives. Our government representatives include the following.

Warsaw Loses Nailbitter To Knob Noster On Friday

Even though the Warsaw Wildcats lost 44 - 40 Friday night. Coach Ryan Boyer was happy with his team. He could be heard saying across the field "Now that was a football game"! Later he commented, that although we lost, I was happy with the effort we gave tonight. We had ten times of heart than we had last week. I told the kids last week "We instead of Me" "and I guess they got it".

Warsaw had 10 penalties for 45 yards, with numerous conferences among the referees. Zach Chapman, who had an interception in the first quarter last week, recovered a short kick-off from the side lines to give Warsaw good field position. A few plays later quarterback Matt Couzens scored on 15 yard keeper at the 10:09 mark. Couzens in only his second game as quarterback has already put his name in the Warsaw record book. He had a 12 for 22 performance with 312

yards, breaking a 25 year old record by Brandon Morrow of 257 yards.

Knob Nobster would come right back in almost a minute as quarterback Stevie Elwell, who is a state wrestling champion, would pitch the ball to Iverson Sirom, who ran 74 yards for a touchdown after a successful PAT the Panthers led 8 - 6.

After each team had a score called back, the Wildcats would pull one of the greatest fakes in recent Warsaw history. After a called time out with Knob Noster with twelve men on the field. Warsaw would fake a punt, with Couzens hitting Clayton Simons for 44 yards to take them down to the five yard line. Then Eli Hawkins would score on a three yard pass. After they failed the two point conversion, the Wildcats lead 12 - 8. Then Knob Noster would score on a short rushing touchdown to give the Panthers a 14 - 12 lead.

On the first play of the second half, Eli Hawkins

would catch an 11 yard pass and scramble 63 yards for a 74 yard passing touchdown. The failed PAT made the score 18 - 14. Then Knobs quarterback would pass to Lane Elwell to score to put Knob ahead 22 - 18. With a successful PAT at the end of the 3rd quarter Knob now lead 28 - 18.

In the 4th quarter, Kieon Davis would take off for a 12 yard touchdown. He then converted the PAT to pull his team within 26 - 28. Warsaw would then recover their 2nd kick-off fumble of the night at the Panthers 35 yard line. Then on 4th and 6, Davis would score again. Couzens would make the PAT making it 34 - 28 with seven minutes to go in the game.

Knob Noster responded with another touchdown to make the score 36 - 34. Then Couzens would show the magic in his arm and hit Simons with a 48 yard passing-run play down to the one yard play. Davis then scored and the score would then be 40 - 36. With a 1:14 left on the clock,

Knob Noster would drive down the field and score a touchdown with 10 seconds on the clock, to make the score 44 - 40 Knob Noster. The game would end with Couzens throwing a 40 yard pass down field that would bounce off Clayton Simons. Simons was charged with offensive pass interference. After a delayed conference with the referees, the game would end with the Warsaw Wildcats falling short to Knob Noster 44 - 40.

Warsaw had good blocking all night from Tristen Reynolds, Jake Luebbert, Lane Bates, among others. Davis ended the night with 20 - 124 rushing yards. Eli Hawkins had 3 catches for 93 yards. Clayton Simons was 6 for 80 yards.

Warsaw dropped to 0 - 2 and will play Cole Camp 2 - 0 this Friday at 7:00 PM. As always, You can watch the game on BCE TV with Barry Edwards.

Torch shot from the length of the court, approximately 55 ft. He was probably one of the few in the entire country who could make such a tough shot but he practiced on this court everyday and

knew the angles. Well, the ball hit the front of the rim and bounced straight back. Phillips grabbed it at center court but Torch followed his shot and slapped the ball loose. He then nailed one from half court to make it 34 all.

Thorhagen grabbed the tip and hit Phillips for a layup and it was 36-34 Phillips stuck his hand high into the air in order to rattle the crowd.

Tatum stole the ball from Masher and headed down court for the layup. Masher caught him and drove Tatum into the wall head first. The game was stopped and the crowd was in total silence as little Ricky Tatum laid on the floor. Local Doctor, T.R. Mercer was in the crowd and rushed out onto the court. Tatum got up slow and was okay but Coach Morgan had seen enough. If Viper wanted to play rough then he had the guy for them. Doyle stepped on the court and pointed to both Masher and Phillips.

Doyle made the free throw and it was 36-35. The next couple of minutes on the court were some of the roughest ever saw around Torre. Starks, Doyle and Gotch picked up fouls as well as Masher, Phillips and Lloyd for Viper.

Referee McKenzie warned both coaches and the players on both sides to calm things down some. Both teams went 2-3 from the line and it was 39-38 with just two minutes to play.

Thorhagen hit two in a row for the 43-38 lead and things looked grim for Torre. Starks missed a layup and Lloyd gathered in the rebound. Torch would steal

the pass and feed Gotch for the bucket.

Dribbling the ball was not an art form in those days as dribbling with one hand was just put into play the year before.

Phillips was fouled with just 27 seconds left. He made a point to walk by the Torre fans and grinned with his hands held high. It was 43-40 and he knew a free throw might seal the deal. He took aim and put the ball into the air and missed the shot. The ball was slapped out. Tobias went into the crowd to slap the ball back into bounds. He hit his head on the concrete steps. Gotch fought Phillips for the ball and won out. Lloyd picked off his pass intended for Torch. Tobias slowly walked back onto the court rubbing a knot on his head. However, nobody was coming out of the game at this point and Torre had nobody eligible. Timmerman had an ice pack on his ankle and Tatum had already re-entered the game so he couldn't return.

Again, there was no time outs in 1927, so the players had to play with their instincts and with their knowledge of the game.

Lloyd was content to run out the clock but was doubled teamed and threw the ball into the crowd. With 11 seconds left, Tobias in-bounded a sweet pass to Gotch. Torch was doubled teamed and was knocked to the floor. So Gotch drove to the basket and hit Doyle wide opened underneath the basket. With the double team on Torch, Tobias had told Doyle, who was left

will respect me" which resulted in very special bonds between Don, his players and his students. Don will always be remembered as a fierce competitor and took his "Dixon's Dollies" to the state championship where they came in second, losing by just one point, in the final game of the Missouri 2A championship in 1994. He has been the only coach in the school's history to have this accomplishment in girls' basketball.

WHS graduate and now Clinton attorney Audara Stadler Lutjen fondly remembered her coach. "When I entered high school and tried out for the girls' basketball team. The coach was the legendary Don Dixon. And he wasn't nice. He wasn't nice at all. He demanded excellence from his players and wasn't satisfied unless we were succeeding both on and off the courts.

The first few days of freshman practice he instilled in his players the knowledge that he didn't care if we liked him. He wasn't going to lose a minute of sleep if we walked out of that gymnasium every night cursing the ground he walked on. (And during preseason practices we did!). Like him or not, however, there wasn't a girl who played for him who didn't respect him and come to love him.

Throughout that first year, Dixon told us over and over that our class would see the state championships before we graduated. Over the next few years that became ingrained in us: we WERE going to play for the ultimate trophy.

Winning became the norm playing for Dixon.

There were just certain unwritten rules that became a way of life when you played WHS Lady Cats basketball: you were going to win 20 games a season, you dressed nicely walking into away games, the bus rides there were fairly quiet. And if we lost the game that night our bus ride home was beyond silent. Not a word was spoken on those nights as we all replayed the game and dreaded the next night's practice.

When you played basketball for Dixon and took one of his courses, it was just understood you were going to work harder than you would for any other teacher. I distinctly remember being nervous about having to cut into the fetal pig dissection in his biology class. The classmate next to me received praise and encouragement to make the first cut. I was told, 'Stadler you are welcome to go run laps until you can handle tearing into that pig!' I did so (with a little help from a classmate who now has Dr. in front of her name). And when it came time to dissect in college biology, it was one of the easiest courses I ever took thanks to how hard Dixon pushed me in high school.

Coach Dixon had promised my class he would see us to the end. We knew we were his last team and that he was retiring from coaching basketball after the State Championship games. That, combined with the knowledge we had two games waiting for us to play at the Hearnes Center took us—an unranked, unknown team—to the Final Four.

In the locker room at the Hearnes Center after that devastating loss, we were all in tears. When Coach Dixon entered the locker room it became worse. There wasn't anything anyone of us would have not done for that man, but we had fallen short of the championship by one point at the buzzer. The coach that never accepted—or let us accept—defeat in tears alongside us. But not because of the loss.

He told us we had given him the most amazing gift that season and that we had nothing to feel down about. He reminded us that we had went from an unranked team to a team that made all the other ranked 2A teams sit up and take notice. He taught us a life lesson about sportsmanship, pride and dignity that night in that Mizzou locker room.

Coach Dixon, your reward for a life well lived to the fullest, mentoring young women for decades, being a wonderful teacher and mentor to many isn't waiting for you at Hearn's Center. It's waiting for you in heaven. Godspeed Coach!"

Another WHS basketball standout Leanne Thixton Donaldson also had fond memories of Mr. Dixon, "Warsaw Girls' High School Basketball provided some of the most memorable experiences in my high school career. And I scored in the top 5 of 500 in my college biology class because of this coach who was also my high school biology teacher. I have many memories with Coach Dixon, one of which was visiting in his living room about something other than basketball or carp. Sad that the Legend is gone. Thankful I got to be a part of the journey. 'Run to victory!'"

Warsaw physician Dr. Amber Campbell said that Mr. Dixon helped prepare her for the rigors of medical school. "I didn't realize that not every high school science teacher required his students to memorize the name of every bone in the body," said Campbell. "I am thankful for Mr. Dixon's guidance."

Dr. Wendy Bybee Austin echoed Dr. Campbell's sentiments. "I am so fortunate to have had Mr. Dixon in my life. He pushed me athletically and academically. I will be forever grateful."

Family and friends who were touched by the life of Donald Dixon are invited to the Reser Funeral Home in Warsaw, Missouri for a visitation on Wednesday, September 5 from 3:30pm - 5:00 pm followed by a memorial service at 5:00 pm, officiated by Rev. Barry Edwards with a eulogy given by Dr. John Boise.

Donald L. Dixon



Don Dixon, age 76, son of Donald Sr. and Doris Pitman Dixon, passed away at his home on Saturday, September 1st, 2018. He was born on February 5th 1942 in Maryville, Missouri. He grew up in Fairfax, Missouri and graduated from Fairfax High School in 1960.

Don attended college at Northwest Missouri State University in Maryville until sustaining a back injury while playing football in 1961. He worked at Fairfax Manufacturing Company as a sectional foreman from 1961 until 1966. He then worked with his father at Dixon's Boats and Motors as a salesman and mechanic. He returned to Northwest Missouri State University where he graduated with honors in 1974 with a Bachelor of Science Degree in Secondary Education and a double major in Biology.

He was a member of the TriBeta Biological Society. Don moved to Warsaw in 1978 where he became a science teacher and coached football, track, softball and girls basketball for 17 years in addition to being a color commentator for WHS Football. His true passion however, was coaching the girls High School basketball team. He always told his students and players "you may not like me but you will respect me," which resulted in very special bonds between Don, his players and his students. Don's love of teaching and influence on the young lives of children was evident. Many pursued and achieved success in medical and science fields. He was always so proud of each one.

Don will always be remembered as a fierce competitor and took his "Dixon's Dollies" to the state championship where they came in second, losing by just one point in the final game of the Missouri 2A championship in 1994. He has been the only coach in the school's history to have this accomplishment in girls' basketball.

Due to his love of the lake and the outdoors, he spent his summers managing the Warsaw swimming pool, working for the US Army Corps of Engineers as a Youth Group Labor Leader and then later becoming a Federal Park Ranger from 1986 until 1999. After Don retired he worked part-time under Myrna Schroder for the Harry S Truman Visitor Center where he was able to share his knowledge and love of the Lake with tourists.

In my previous life as a caterer, cooking teacher and culinary event planner in San Francisco, I created some fabulous events. I also had a couple of not so fabulous events. One was planning a cooking demo for an East Coast cooking celebrity to be held in Macy's Cellar. However, the special events staff forgot to inform me they were having a celebration of Vanna White, major game show TV star, at the same time. Well, after setting up the demo kitchen with 100 chairs for guests, we had NO guests. Vanna drew hundreds! My cooking compadre was understanding about the whole thing and we went out to lunch. Point being is that even the best plans can go wrong; you just have to get on with it. (A good

lunch always helps me get on with it.)

So in thinking about a good lunch, chicken salad and the many variations always come to mind. Using a store bought rotisserie chicken or poaching some chicken breasts, the following is a favorite.

- Cooked chicken
- Dressing: Mix together 1/3 cup plain yogurt 1/3 cup mayonnaise 1 Tablespoon Dijon mustard
- 1 cup seedless grapes, halved crosswise
- 1 cup coarsely chopped walnuts (I usually toast them first)
- Toss all together and eat!
- Sometimes I add 3 tablespoons of drained chopped capers; the salty addition gives a new zing to the salad.

Fake Meat Labeling Law Takes Effect

MCA supported bill now enforceable law.

The Missouri General Assembly passed Senate Bill 627, sponsored by Senator Brian Munzlinger (R-18), with bipartisan support during the 2018 legislative session. The legislation was later signed by then Governor Eric Greitens. The bill, which went into effect on August 28, 2018, prohibits misrepresenting a product as meat that wasn't derived from harvested livestock or poultry.

The Missouri Cattlemen's Association (MCA) was a driving force behind the legislation. MCA Executive Vice President Mike Deering said the current definition of meat in Missouri Statutes is: "any edible portion of livestock or poultry carcass or part thereof." He said this definition certainly excludes plant-based or even laboratory grown food products from being considered meat. Now, legislation prevents product marketing from contradicting this definition.

"This legislation didn't change the definition of meat. It simply requires marketing with integrity," said MCA Executive Vice President Mike Deering. "You can't sell a Subaru as a Corvette. You shouldn't be able to sell a product manufactured in a laboratory as something grown by farm and ranch families."

This law is currently facing a legal challenge from The Tofurky Company and The Good Food Institute.

MJCA Members Tour Southeast Missouri For Jr. Beef Tour

Missouri Junior Cattlemen's Association (MJCA) hosted the Show-Me Beef Tour in southeast Missouri August 24-26, 2018. MJCA members from throughout the state attended the tour to visit multiple forms of agricultural businesses in the southeast region and gain knowledge about agricultural operations. The tour is designed to give junior members exposure to different sectors of the agricultural industry in Missouri and provide them a greater understanding of the many things that go into producing agricultural commodities.

The first stop on the tour was to Tribute Farms, a dairy operation. Participants later visited Byrd Creek Farms, a purebred Berkshire hog operation.

On the second day of the tour, junior members visited Flickerwood Farms and Steinbecker Livestock to tour a stocker cattle operation. Participants later toured Jackson Egg Company to learn about egg production. The day concluded at Butch's Angus, owned by Missouri Cattlemen's Association (MCA) Immediate Past President Butch Meier and his wife, Eileen.

On the final day, the tour stopped at South East Missouri University's beef farm.

The Show-Me Beef Tour was the largest it has ever been, with 33 MJCA members in attendance. Supporting and educating the next generation of cattle producers is a goal of MCA.

"The Show-Me Beef Tour is a fantastic chance to educate our junior members on the many options they have when the entering the industry," said MCA Manager of Membership Maria Washburn. "It is the hope that young people will find something that they love in agriculture and return to the industry to contribute their unique skills in the future."

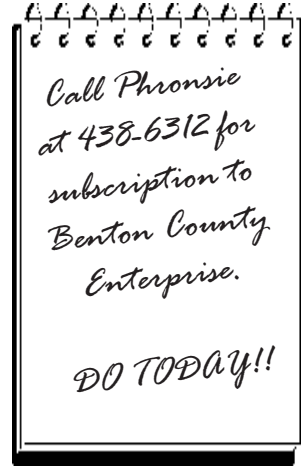
It seems when our society changes it is not the better.

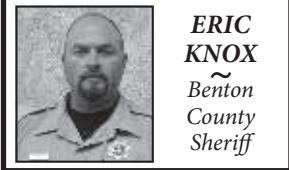

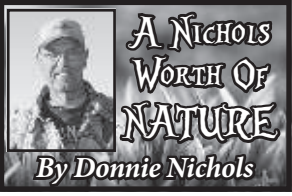

Maclura pomifera, member of the mulberry family, is a tree whose native range was limited to a small triangle in western Arkansas, southern Oklahoma, and parts of eastern Texas and yet was named after a Missouri Indian tribe. It is remarkable that this tree that produces no pulpwood, saw timber or utility poles, has been planted more than any other tree species in North America. You may know this tree as bois d'arc, hedge, hedge apple or Osage orange.

Early French explorers like Marquette and Joliet found these trees growing near almost all Missouri Osage Indian villages. From branch wood of these trees the Osage made their highly prized bows and also made a light orange dye from the roots, thus the name Osage orange. Bow blanks and finished bows were prime items for barter among native tribes. In the early 1800s, the price of a good Osage orange bow was a horse and blanket. So sought after by the other tribes like the Shawnee and Wyandotte in Ohio and the Blackfoot in Montana, that the wood was traded over a distance of 2,000 miles. Tribal wars were fought for possession of lands generously supplied with Osage orange.

Early French explorers come to associate these strong powerful bows with the Osage Indians and called the trees "bois d'arc" (pronounced bodark) which means "wood of the bow."

In addition to bows and dye, Native Americans also used the stout wood for war clubs and tomahawk handles. The rigid scaly bark of the trunk provided both fiber for rope and a tannin for making leather. A tea

was made from the roots which was used to wash sore eyes.

Early pioneers used a dye from the roots and inner bark to color their homespun cloth, later used by the Armed Forces for their olive drab uniforms in WWI, Osage orange's hardness and low shrinkage made it a valuable wood for wagon wheels and rims. Cattle yokes were fashioned from its many angled limbs.

In 1804 Meriwether Lewis obtained Osage orange cuttings and seedlings in St. Louis, Missouri from Pierre Chouteau, a trade and Indian agent in Osage territory. Lewis forwarded them to Thomas Jefferson, who in turn gave some to George Washington who planted them at his River Farm in Virginia. Seven of those Osage orange trees still grow today.

In 1806 in a message to Congress, Thomas Jefferson referred to Osage orange as a potential hedge plant. By the 1800s on the expansive prairies of a fertile new continent, before the invention of barbed wire, settlers needed fence and Osage orange makes a great fence. The use of the Osage orange was so common throughout most of its introduced range that "hedge" became the tree's common name. A single row of hedge trees planted a foot apart would yield a fence that was "horse high, bull strong and hog tight" within four years. Some farmers would weave the already twisted and intertwined limbs of the young trees tightly together, a technique known as "plashing" for a more impenetrable barrier.

Hedge nurseries sprang up to meet the needs for seed and seedlings. Fruit commonly called hedge apples were covered with dirt and straw in the fall. By spring, seed was easily separated from the rotten flesh of the fruit. One apple produced about 3,000

seeds. A bushel (about 80) would yield 24,000 seeds. These were placed in a prepared seedbed and then sold as seedlings. A hedge row could be established for 37.5 cents per rod (\$120 a mile). In the 1860s, the Osage orange market went wild. Prices jumped for \$8 to \$50 a bushel.

Few records exist about the extent of Osage orange hedge planted in Missouri. Earliest records show hedge first planted in Greene County in 1844. In nearby Kansas, records show that between 1865-1939 nearly 40,000 miles of Osage orange was planted. Other states were also planting thousands of miles of hedge at this time.

In September 1874, the Clinton Missouri Daily Democrat advertised Osage orange hedge plants at \$1 to \$2 per thousand. By 1879 Monroe County in northeast Missouri and Nodaway County in northwest Missouri, each had over 2,000 miles of hedge rows...more than any other county in Kansas, Nebraska or Iowa.

In 1874, Osage orange met its match. A new invention, barbed wire, was now cheaper to use for fencing. Although the Osage orange planting storm had passed, the tree had been planted in all 48 contiguous states. By the early 1900s, Osage orange was generally disliked by farmers. The plants needed annual trimming, sapped water from adjacent crop land, and spread to adjacent fields.

Many of the Osage orange hedges at the 1800s were unmaintained and allowed to grow into tall trees with spreading crowns. These shelterbelts provided habitat for many wildlife species. Nesting sites, roosting cover, travel lanes and food from the plants that grew up under the trees. However, not all species benefitted from these tall rows of trees. Many prairie species require open land-

scapes without trees. Their daily lives were adapted to a world of tall grass and forbs. Where the Osage orange rows dissected what used to be open prairie, the wildlife suffered.

As barbed wire fences crisscrossed the continent, farmers needed posts. When hedges were available, it became the preferred material. Osage orange, one of the heaviest woods in North America, with heart wood that contains anti-fungal and anti-oxidant compounds that protect the wood from decay and weathering, make it the best wood for fence posts.

It seems ironic that the trees that once served as thousands of miles of living fence continue to yield fence posts as their main commercial product.

Five Life Insurance Myths Busted

Life insurance. It's something that most people need but a topic that no one wants to discuss, leading to many misconceptions.

1. I'm single; I don't need life insurance. Most people think life insurance is more necessary for married people than for singles, according to the 2017 Insurance Barometer Study by Life Happens and LIMRA. But even if you're single and don't have children, you may still leave behind loved ones who would have to pay your debts. peace of mind by potentially paying off any remaining debt. Or, if you want to leave money to a charity, life insurance can help ensure your wishes are carried out.

2. It's too expensive. Cost is one of the top reasons people don't purchase life insurance. Sixty-six percent of participants in the Insurance Barometer Study said it's too expensive. The same consumers overestimated the price by more than three times the actual cost. It can cost as little as \$14.24 per month for a \$250,000 policy at Erie Insurance, for example. That's less than 50 cents a day. Millennials can get an even bigger break by purchasing while they're still young. Premiums are typically less expensive since they're generally healthier and have fewer assets.

3. My employer provides life insurance; I don't need my own. While it's great to have coverage through an employer, it often isn't enough. "A typical group life benefit is two times your annual salary, but you may need more like six to eight times your salary just to break even," says Louis Colazzo, senior vice president for Life at Erie Insurance.

What's more, if you take another job, your policy may not be transferable.

4. I'm a stay-at-home

parent. If you're not the breadwinner in your household, you may think your family doesn't depend on your income. However, think about the value of all the unpaid services that would need to be replaced, such as childcare, household cleaning, transportation and cooking. A stay-at-home parent in 2018 contributes a salary of \$162,581 annually, according to research by Salary.com.

5. I don't have the time to research this or sign up. An insurance agent can quickly walk you through the process to identify what you need and your options, as well as explain the terms. Think of your agent as a trusted partner who will keep an eye on how your policy is keeping up with your life. Plus, the application at such providers as Erie Insurance only takes about 15 minutes, doesn't include complicated forms and may not require doctor's visits.

Bottom line: most people could benefit from life insurance, but it's not a one-size-fits-all scenario. The amount needed really depends on individual circumstances. To protect those who matter most, check with your insurance agent to make sure you get the right coverage.

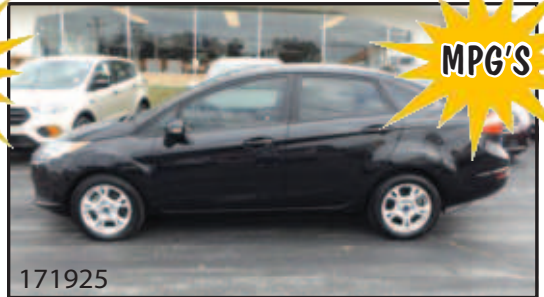
