Roger L. Reedy, Benton County Assessor, will mail approximately 12,000 personal property lists to Benton County residents who own taxable personal property, as of January 1, 2018, who must furnish the assessor a list by March 1, 2018, to avoid late penalties. Taxable personal property includes vehicles, boats, boat motors, airplanes, travel trailers, mobile homes, livestock, farm machinery, and all licensed trailers. If you have lifetime plates on your vehicle or trailer, you still need to list this.

If you do not receive a list in the mail by January 22, 2018 please call the assessor’s office at 438-5473 so that one will be sent to you. Office hours are 8:00 to 12:00 and 1:00 to 4:30.

In addition, the assessor will be at the Cole Camp City office to take lists on the following mornings from 8:30 AM until noon: Fridays, January 5, 12, and 19, 2018.

## 4 Day School Week- R-IX District Could Take Dynamic Shift

Warsaw Superintendent Shawn Poyser presented a four day school week proposal to his staff at their January Professional Development meeting on January 2.

Poyser began the meeting by pointing out that the Warsaw R-9 District has several old buildings in need of repairs and remodeling.

“In a perfect world we would have all the schools

on the same campus but instead we have four different locations to maintain,” Poyser said. “Going to a four day school week could save the district close to \$100,000.”

One of the benefits of a four day school week would be lowering transportation costs. The busses would only run four days a week instead of five.

Another important benefit would be an increase in attendance for students and staff. Warsaw had an 88.7 percent attendance rate for the 2016-17 school year. As of the end of first

semester, not one building in the R-9 District had 90 percent attendance. North Elementary had 87.56% attendance; South Elementary had 87.40% attendance; John Boise Middle School had 84.36% attendance; Ruth Mercer Elementary had 83.72% attendance and WHS had 76.44% attendance.

Poyser commented that the district receives funds from the state based on student attendance, so in order to increase the amount of funding, students need to be in class.

“We can’t teach if the

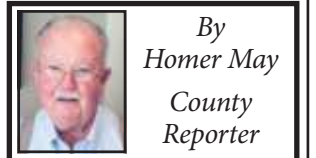
students aren’t in class so we are looking at as many different ways to get them into class that we can,” Poyser said.

Transportation expense is another reason for the four day week.

“We would save approximately \$30,000 in transportation costs with a four day week,” said Poyser. “The R-9 District covers 320 square miles which makes it one of the largest in the state.”

Poyser pointed out that a four day school week would

## Warsaw Board Approves New Tourism Contracts

In an unusually short session, Monday eve Jan. 8, Warsaw’s Board of Alderpersons approved three tourism-related ordinances which complement the City’s long term efforts to attract tourists to the area and promote long term economic benefits here. They were: (1) an ordinance authorizing the mayor to execute a \$9,000 contract with the Warsaw Area Chamber of Commerce for tourism-related services, which includes \$5,000 for a July 4 fireworks display on Truman Lake; (2) an ordinance authorizing the mayor to execute a \$2,500 contract with the Benton County Historical Society for historic preservation related services. The Historical Society’s contributions to this areas tourism may be a bit difficult to quantify, but there’s no doubt its unique presentation of local history attracts wide-ranging interest. (3) an ordinance authorizing a \$15,000 contract with the Benton County Tourism Commission for economic and community development related services. Mayor Eddie Simons reported there was a 17% growth from 2010 to 2016 in tourism-related employment, and a 16% growth in annual guest tax collection from 2014-2017. He added that the official population census numbers show Benton County grew by 12% during the past decade, the fastest of any of the sur-

For sports enthusiasts, there is the Warsaw Wrestling Invitational at Warsaw High School on Saturday, January 13. It will take

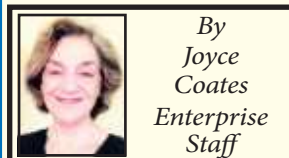

## Public Administrator Responds To Criticism



**PUBLIC ADMINISTRATOR** Lori Dunkin recently received a barrage of e-mails from a disgruntled Warsaw resident over her handling of the office and the emergency guardian conservatorship of well known resident Rodney Mercer.

Lori Dunkin, public administrator, subject to the same scrutiny and criticism as any other public official, has come under both in the past several months.

In April last year, based on a complaint by a relative of a person under her conservatorship, the State Auditor came to investigate. The Enterprise published the audit report’s findings as part of an interview with Dunkin on the subject.

She spent the next several months working to make the recommended corrections.

On November 22, 2017, former local mail carrier Rodney Mercer was arrested by the Warsaw Police on an outstanding warrant and remains incarcerated. Criminal charges are pending on matters which are scheduled in court this month.

Dunkin was called to court on Thanksgiving Eve to be appointed as guardian for Mercer, who was made a ward of the court at that time; with guardian ad

litem also appointed.

Friends of Mercer, pointing to the 2017 audit report, claim that Dunkin is mishandling his case. Talking about the experience of being audited, she said "It was a learning experience that opened my eyes, and at first made me feel like noth-

ing is ever good enough. But in the end, it worked out for the better."

As a matter of fact, on November 21, 2017, the day before his arrest and the day Dunkin was appointed as Mercer's guardian, the State Auditor published the Follow-Up Report on Audit Findings - Benton County Public Administrator's Office that showed eight corrective recommendations had been implemented and two were in progress (<https://app.auditor.mo.gov>).

Thus, anyone concerned about findings of the original report who have not read the follow up report can do so and know that the issues have been resolved. To understand more about the public administrator's role and the regulations that govern how she carries out her responsibilities may also be helpful.

Elizabeth L. ("Lori") Dunkin was first appointed in January 2011 to complete the term that began in 2008. She ran unopposed and was elected to a four-year term in 2012, and again in 2016.

Qualifications for the position, per RSMO Section 473.730.1-3, are:

- at least twenty-one years of age and a resident of the state of Missouri and the county in which he or she is a candidate for at least one year prior to the date of the general election
- a registered voter and
- current in the payment of all personal and business taxes; and
- shall take the oath required by the constitution, and post bond to the state of Missouri in a sum not less than ten thousand dollars, with two or more securities.

Responsibilities, summarized at <http://www.benton-como.com>, conform to the statute above:

- to serve as guardian or conservator for Benton County residents proven to need such help;
- to report to the court annually about the care and administration of each estate;
- to be appointed personal representative of a decedent's estate where no will was made, including such duties as cleaning out a home or holding an auction; and
- to work with the Benton County Division of Senior Services, Social Security, and Division of Family Services to locate resources for the people for whom she has been appointed.

Guardianship is the legal process that determines a person's ability to make decisions regarding personal affairs. Conservatorship is similar but involves the ability to handle personal finances ([www.moaging.com](http://www.moaging.com)).

As set out in Section 473.730.2, "The county shall defend and indemnify the public administrator against any alleged breach of duty, provided that any such alleged breach of duty arose out of an act or omission occurring within the

scope of duty or employment."

The public administrator receives a salary, per RSMo. Section 473.730.3, paid from the county budget, and receives no other fees or compensation for services. County public administrators must be on call 24 hours a day, seven days a week to respond to any issues that may arise with a client. She keeps in contact with hospitals, health-care facilities, hospices, law offices and other agencies on behalf of clients.

As public administrator Dunkin does not, in fact she cannot by law, solicit for clients. Dunkin's caseload consists of cases assigned to her by the court. An attorney files a petition with the court; a judge, on advice of the department of mental health, or senior services, or a doctor, as set out in the petition, determines that a guardian or conservator is required.

The court notifies Dunkin to appear in circuit court, where she is appointed as guardian or conservator. At the same time, the court appoints an attorney to serve as guardian ad litem when minor children, or impaired or incapacitated adults are involved.

Once assigned, Dunkin has 30 days within which to complete an inventory of the individual's property, including cash, stocks, bonds, certificates of deposit, personal and real property, and all other assets and income. The ease or complexity in locating assets depends on the circumstances, yet every effort must be made to locate property that could be situated anywhere in or out of the county or state.

Dunkin makes lists all property located and submits it to the attorney who prepares a document for signature and presentation to the court.

She was notified of three new cases to be assigned to her this week that will bring her caseload to about 80 files. Officially, her clients are "wards of the court,"

but Dunkin refers to them as "my people" who she cares about personally.

Some of her cases are more complicated than others, especially in matters where a ward's mental health is at issue.

"The mental health system is seriously broken," Dunkin said, in that people who need help often figure out how to get around the system; they know what to say or not say. Also, when the court orders evaluations and procedures, the best interests of individuals under guardianship are not met when health care workers overlook them, or do not completely carry them out.

When mental health placements are made, it is by recommendation of health-care officials, Dunkin has no part in those decisions.

All the correspondence she receives about guardianship or conservatorship cases is by law part of the public record, and reviewed by the attorney for the public administrator.

Members of the public can rightfully file complaints against any public official for alleged ethics violations based on fact or law, which are investigated by the Missouri Ethics Commission (RSMO 105.957). Claims must be submitted on a signed and notarized document. However, frivolous complaints that falsely put a public official in bad light will be dismissed, and may result in assessment of actual and compensatory damages to the complainant.

rounding counties.

The meeting opened at 6 PM, with Alderpersons Eric Masoner, Terry Marshall Sr., Eric Flores, Lou Breshears, Dave Williams attending. Alderman Adam Howe was absent. Mayor Simons presided; City Clerk Jessica Kendall recorded. First actions by this group were to approve the evening's agenda and bills presented.

In late session, the group heard City Administrator Randy Pogue discuss an upcoming transportation summit in Jefferson City with participants expected to form coalitions across the state, on matters of mutual interest such as transportation issues. Pogue will attend.

The open session closed at about 6:15 PM, to go into executive session. Next meeting is scheduled for Jan. 22; visitors are welcome.

also allow for more family time.

"Students and staff would be able to set up doctor and dentist appointments for Mondays and therefore not have to miss school," Poyser said.

Substitute teachers would be in lower demand with a four day week, contributing to the district's cost savings. The four day school week leaves Mondays available for teacher training sessions or in service, allowing teachers to manage professional development without missing school.

If the Warsaw R-9 School District were to implement the four day week, school would begin at approximately 8 AM and continue until 3:31 Tuesday through Friday. That would break down to 5 to 6 minutes more in each class for the middle school and high school.

Missouri law allows four day school weeks and gives districts the choice to structure their school calendar as they see fit. It is up to the school board rather than the district administrators to make that call. A majority of the board must vote in favor of the altered school schedule.

Even if children are only in school four days of the week, the law requires that they still attend school for at least 1,044 hours per school year.

"Warsaw students will be in class 1,079 hours with the four day week," said Poyser

Missouri districts began adopting four day weeks in 2011 when the Legislature changed the minimum school requirement from 174 days to 1,044 hours. Adding the extra time to each school day would meet the 1,044 threshold.

Schools in Missouri currently using the four day week plan include: Community R-VI, Miami R-1, Harrisburg R-VIII, East Lynne 40, Orearville R-IV, Miller R-II, Pierce City R-VI, Stockton R-I, East Newton, Montgomery County R-11, Lathrop R-11, Everton R-III, Albany R-111, Maries County R-11, Walnut Grove, Crane, Wellsville Middletown R-1, Laclède County C-5 and Wellington-Napoleon.

The Lexington School District in Lafayette County, east of Kansas City, is the only Missouri district to revert back to a five day school week after a two year trial of the four day week.

The superintendent of the North Callaway School District says the district will implement a four-day school week for the 2017-18 school year.

Superintendent Bryan Thomsen says the change is in response to a cut in state funds for schools.

Thomsen said the change could save the mid-Missouri district about \$100,000, or 1 percent of its \$10 million annual budget. The district about 20 miles east of Columbia has about 1,200

students.

The decision comes after district officials sought reaction from parents, with 65.7 percent in support, 13 percent opposed and 21.3 percent undecided.

The district is planning a future election to ask residents for an operating levy increase.

Twenty one states currently have school districts operating on a four day week. These states include: Arizona, California, Colorado, Georgia, Idaho, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Missouri, Montana, Nebraska, New Mexico, Nevada, Oklahoma, Oregon, South Dakota, Utah, Wisconsin and Wyoming. There are more than 120 school districts that host four day school week program.

According to the Missouri Department of Elementary and Secondary Education (DESE) Supervisor no school district has gone back to a Four-Day Week to due to APR scores. 171.029. Four-day school week authorized — calendar to be filed with department.

1. The school board of any school district in the state, upon adoption of a resolution by the vote of a majority of all its members to authorize such action, may establish a four-day school week or other calendar consisting of less than one hundred seventy-four days in lieu of a five-day school week. Upon adoption of a four-day school week or other calendar consisting of less than one hundred seventy-four days, the school shall file a calendar with the department of elementary and secondary education in accordance with section 171.031. Such calendar shall include, but not be limited to, a minimum term of one hundred forty-two days and one thousand forty-four hours of actual pupil attendance.

2. If a school district that attends less than one hundred seventy-four days meets at least two fewer performance standards on two successive annual performance reports than it met on its last annual performance report received prior to implementing a calendar year of less than one hundred seventy-four days, it shall be required to revert to a one hundred seventy-four day school year in the school year following the report of the drop in the number of performance standards

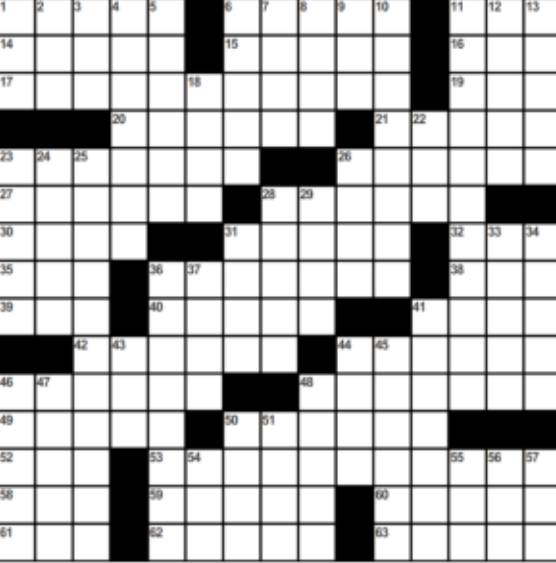

met. When the number of performance standards met reaches the earlier number, the district may return to the four-day week or other calendar consisting of less than one hundred seventy-four days in the next school year.

Usually these programs are in small, rural districts. Poyser said he intends to survey the R-9 staff and parents about the four day program to get their reactions.

"We will have several community meetings in February to get the reactions to the four day week," said Poyser.

The Board of Education could possibly vote on a four day week proposal at the March meeting. "Four day weeks, according to research shared with staff, and my interviews with area four day schools, has shown teacher attendance and student attendance goes up. Coupled with more in depth instruction can lead to increased student achievement. Also, the ability to attract and retain teachers to our district would be huge. It is nice to save money and I try to wherever I can without hurting the district, but the other benefits are much more important."

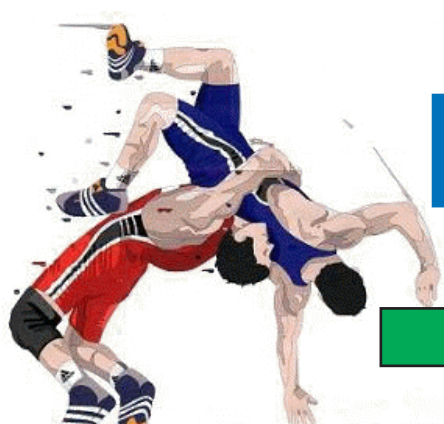

My team only won one game outright. We won 50-40 over the Rejects when our best player had 30 points and was 18-21 from the free throw line. The Rejects were an outcast group of kids who allegedly lived only for wild parties.

Our team didn't have a coach and we needed one badly. We had no game plan and played a 2-1-2 when we should have played either a 1-3-1 or a box and one. We did play a floating zone on David Norton, an outstanding junior high star who didn't make his freshman team. I told you Springfield was tough. Norton was the starting quarterback though and I believe he went on to play college ball. We held Norton to eight points but made stars of two other kids and lost.

We had a team made up of Jehovah Witnesses, also a yellow shirt team called the Ziggers, a pretty good team called the Purple Aces and a few others.

We would walk to most of the games and have a pop and a hamburger at the Platter across the street before our game. It was a fun time in some ways but losing was bad to say the least. So to Joe Gettle, Steve Irwin, Jeff Moyle, Rick Willis, Mike Purdue, Gary Plaster, Chris Meyers and Allen Burks, I remember you and I acknowledge you. I wish I had a team picture but it never happened.

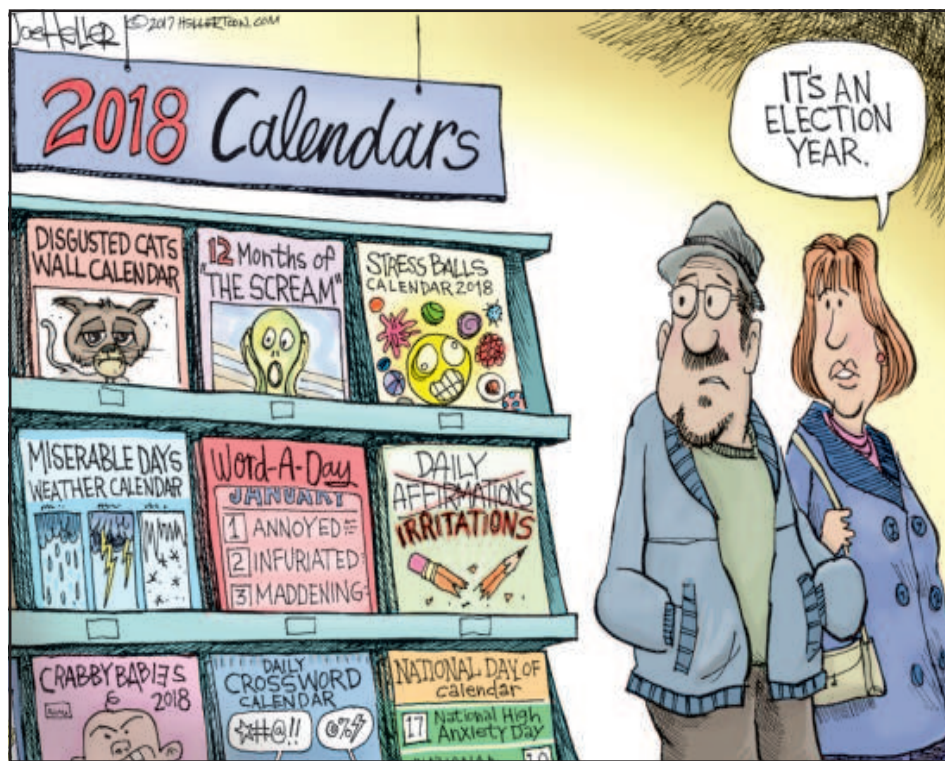

**Berry Pudding Cake**

It took me years to realize that there is no fairy tale life. It sometimes seems that way, looking at someone else's life. But everyone has something to cope with on a personal level.

Many years ago I was working on a benefit for the San Francisco Opera and the guest star was Beverly Sills; one of the great operatic voices of the time. She was a beautiful and gracious lady and assisting her was a delight. We were doing a (what else) cooking demonstration as a fund raiser, so she was preparing some favorites she made for her beloved daughter Muffie. As we were chopping and chatting about our families, she mentioned that her daughter had been born completely deaf.

My eyes filled with tears realizing that her daughter had never heard her mothers world famous extraordinary voice. Always a good crier, (the old Kodak commercials had me in 5 seconds) Beverly stopped chopping to comfort me. I learned a lot from her; acceptance of what is and courage to deal with it. I have always believed that cooking for someone can be an act of love. It was certainly love that inspired some of the following Sills' family favorites.

**Berry Pudding Cake**

- Preheat oven to 350 degrees
- 2 cups blueberries
- 2 cups raspberries
- 1-1/4 cups granulated sugar
- 4 large eggs
- 1 tablespoon olive oil
- 1 tablespoon grated orange peel
- 1 teaspoon vanilla
- 1 cup all purpose flour
- 1 teaspoon baking powder
- Pinch of salt
- Powdered sugar

In 9x13 inch baking dish mix blueberries and raspberries with 1/4 cup granulated sugar. Spread level.

In a bowl whisk eggs, olive oil, orange peel, vanilla and remaining 1 cup granulated sugar. Then stir in flour, baking powder, and salt until just combined. Pour batter evenly over berry mixture and gently spread to cover berries.

Bake for about 30 to 35 minutes until the top springs back slightly when gently pressed in the middle. Let cool at least 10 minutes, serve warm or cool. Sprinkle with powdered sugar just before serving.

**Sweet Corn And Onion Salad**

You can make this salad up to one day ahead. Sprinkle with chopped chives and very thin slivers of lemon peel for garnish if desired.

- 1 cup finely chopped onion
- 3 tablespoons vegetable oil

- 6 cups corn kernels (fresh or frozen)
- 1/2 cup chicken broth
- 1/4 cup lemon juice
- Salt and pepper

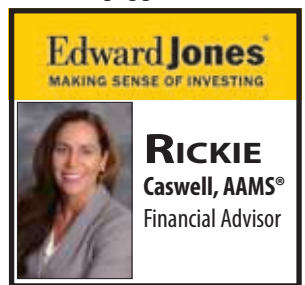
In 10-12 inch frying pan over medium high heat, stir chopped onion in oil until lightly browned, 3 to 5 minutes.

Add corn and broth, stir until liquid is evaporated, about 8-10 minutes. Pour into a bowl and add lemon juice, sugar, salt and pepper. Serve warm or cool.

**Petite Peas with Greens**

- 1/4 cup sour cream
- 2 tablespoons mayonnaise
- 1 tablespoon white wine vinegar
- 2 cups frozen petite peas, thawed
- 2 cups finely slivered romaine lettuce leaves
- Salt and pepper

In a small bowl, mix sour cream, mayonnaise, and vinegar. In another bowl mix peas and lettuce. Stir dressing into vegetables, add salt, pepper to taste.

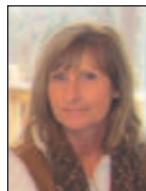

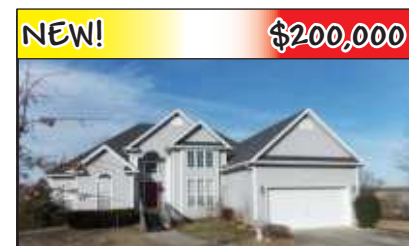

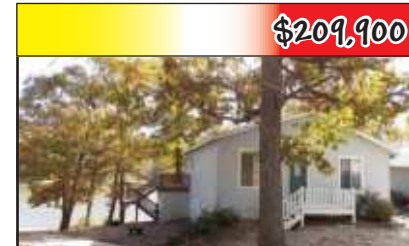

First actions by the group were to approve the evening's agenda and minutes of a previous meeting, then agree to pay bills presented.

Visitor Rick Renno then spoke in favor of a proposal that the City contribute funds to the Benton County Tourism Commission for related activities. Under old business, the group voted to award \$1,874 to BCTC for its mission.

Police Chief Mickey Mit-

tlestadt reported that Departmental activities in 2017 had been about the same as in 2016. He added that an oil sensor in his police car had failed and was replaced; also that a sign at Oakline and Main Sts. had been knocked down and needed to be replaced. 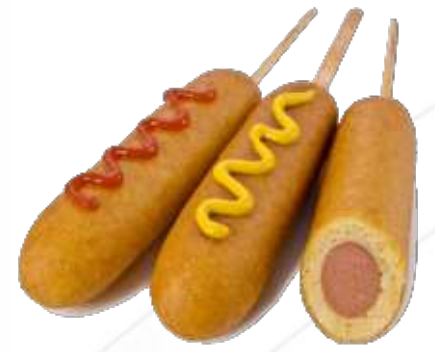
