## Simons And Dockery Set To Square Off In Mayoral Race

He was elected mayor for the first time in April 2012, and is now serving his third term.

Simons said he is running for a fourth term "because I believe in Warsaw's bright future; there are things I want to see happen."

"The city is unique." Besides its residents within the city limits, Warsaw serves a growing number of tourists. Also, many people living just outside the city limits come to Warsaw regularly on business, to shop, or to enjoy recreational amenities like the swimming pool.

The mayor's role is an important one, Simons said, one that he takes seriously.

He is honored to be addressed as "Mr. Mayor," but considers himself no better than any other person in the community. He does not sit and wait for matters to be brought to him, but rather he wants to be visible, to let people know him as a person who listens and gives each person his full attention.

Simons believes in returning emails and phone calls as quickly as possible and remaining accessible to the public. He works with a great city staff, he said, to serve the best interests of the city.

For example, communication between the city and

the school district administration is great; in fact, they have an excellent relationship that leads to working together effectively to solve problems like traffic safety issues which concerns parents dropping off their kids at the North School. In another context, the Parks and Recreation staff work with the school to open part-time summer jobs for high school students as lifeguards, sports-event umpires and in maintenance positions.

His vision for the future, Simons said, is to direct resources after completion of projects to upgrade the

## Fire Destroys House, Spreads To Neighbor

Chief Rob Lane, Warsaw brought two tankers and a fire engine to the scene with 10 volunteers fighting the blaze. The Lincoln Fire Department responded to the call as well bringing a fire engine, a tanker and five volunteers as well. The combined fire departments fought the blaze until 8 PM.

"We had a red flag warning on Saturday as well as 17 MPH wind," said Lane. "While we were fighting the fire we had another call from

a 50 acre fire on Dwyer Road so I had to send five of our volunteers to fight that fire."

Osage Valley Volunteer Fire Department also responded to the Dwyer Road fire. Lane reported that the Warsaw Fire Department had a total of five fires which they responded to on Saturday. "It was not a good day to burn trash," Lane said.

## Hank Saved-- Owners Delighted With Dogs Return



A THRILLING MOMENT took place when Texas residents Caleb and Savannah Owen were reunited with their dog Hank after he went missing during their visit to Warsaw.

Caleb and Savannah Owen from San Antonio, Texas, were visiting relatives for Thanksgiving at Cedar Gate Estates community when Hank, their two-year-old 40 lb micro chipped heeler mix, slipped out of his collar and couldn't be found. The couple had to return to jobs in Texas without Hank, but were able to connect with local resident, Janet Perry. Perry has spent her life

helping owners find lost dogs and helping dogs that aren't lost find homes. Perry and many spotters helped in the search for Hank following his travels from Cedar Gate to an area near the Lost Valley Fish Hatchery. He eventually made it to Lincoln where he camped out at the home of Kurt and Jeanene Bagley and their 8-year-old son Reed.

"The dog (Hank) stayed at our house for two or three weeks," said Reed See HANK on Page 3

harbor, trails, and the swinging bridge, improve roads and build sidewalks.

Besides being a good thing for citizens, it will also raise property values.

Dockery, elected the first time in 2003, served three terms as alderman until 2009. He decided not to run again after he became a single parent with three sons to raise. But in 2013 he was appointed to serve out the remainder of the late Alderman Fitzpatrick's term, and was then elected to another two-year term in 2014.

His youngest son will graduate from high school in 2018. Dockery believes the time is now right for him to pursue his long-held desire to run for mayor, which he said would be another way to continue in community service.

An Eagle Scout himself, Dockery has been active in Boy Scouts for 18 years. He has served as Scout Master for 13 years; a Cub Master for 4-1/2 years, and a Den Leader for one year before that. He has given notice that he will step down from formal Scout positions in August 2018.

The mayor, Dockery said, "should be the biggest promoter and must be the person most excited about the city!" In partnership with city administration, in collaboration with key personnel in the city and county, and with community organizations like the Lions Club, the American Legion, Shriners, etc., he would work to encourage local business growth through city means.

Like Simons, Dockery described Warsaw as "unique." Although its size and population are small, the city is part of a larger community with resorts dependent on tourism. It is important to encourage cooperation with neighbors outside the city limits. They are affected by the quality of the city's utilities and amenities, and they in turn affect the city. Therefore, everyone in the broader community has an interest in the city's success.

Dockery has stayed current on city news. He attended a council meeting about two months ago. He will attend this week's meeting, and will attend regularly going forward. "I encourage everyone to take interest, and in whatever way you can to be a part of making the community better."

Simons and Dockery are looking forward to spending time with their families over the holidays before getting into "campaign mode." And, who knows that some one or more hopefuls may join the race for mayor before the January 16 deadline?

group's December 4 meeting, then agree to pay bills presented. There was no old business.

The group then adopted three ordinances: (1) amending the 2017 estimated operating budget to actual adjusted ending balance for all funds within the City; (2) amending charges for permit fees to require a \$25. minimum fee for new signs, to cover increased costs; (3) appointing a five member Board of Appeals, to hear parties adversely affected by City action. Appointed to that Board were Tom Hill, Brad Spencer, Phil Slavens, Ag Slavens, Joe Morrison.

City Administrator Randy Pogue then briefly discussed planned extension of Commercial St. in North Town, promising more information in a January meeting. He also said employee health insurance in 2018 will not go up, overall, "First time recently it hasn't spiked." People Service Manager Mark Breshears reported water has been hooked up at the new Casey's General Store building in North Town; everything else operating okay. City Clerk Kendall reported that an employee luncheon will be held in the Community Building, Friday December 22 at 11 AM. Police Chief Jones presented a report summarizing 2016 and 2017 activities of his Department. It showed there were 410 offense/incident reports filed in 2016, vs. 469 in 2017; 82 motor vehicle accident reports filed in 2016, vs. 87 in 2017; 265 summons issued in 2016 vs. 220 in 2017. Other department reports were received without comment. In late session, Mayor Simons presented a plaque describing the City's appreciation for Chief Jones' 40 years of law enforcement service. The Chief's last day will be December 22.

The group went into executive session at 6:20 PM. Meeting dates for Warsaw Alderpersons, in January, have been moved to the 8th and 22nd, due to the holidays. Visitors are welcome.

Representatives from the MU Extension Office met with Commissioners to present their 2018 budget request. Those in attendance were Livestock Specialist Gene Schmitz, Nutrition Specialist Tammy Culpepper and Extension Council Chairman Rod Brethower.

Sheriff Knox reported to the Commissioners that the previously awarded Local Law Enforcement Block Grant (LLEBG) has been delayed, pending litigation and at this time, it is unclear when funds will be available. This grant funding was to be used for the purchase of bullet-proof vests for deputies. Review of budget expenditures will be conducted to determine payment of this expense.

County Treasurer Rick Renno gave his weekly financial report, noting that sales tax revenues are up. County Clerk Susan Porterfield submitted bills for

approval and payment.

on Tuesday. "Then one day a flyer was handed out at school with the dog's picture and I told my teacher that he was at our house. After that, a lady brought a bag with a bunch of goodies (to eat) for me and a bag of dog treats for my dogs. I am sharing the goodies with my classmates."

"Through Face Book sites such as Angels For Paws Lost and Found, the many volunteers who joined in the month-long search for Hank, and the Lincoln residents who helped take care of him, this story had a happy ending," said Perry, Administrator of Angels For Paws Lost and Found.

Many spotters reported sightings of Hank, and Janet Perry and others set traps and tried to find out his routine. He was first spotted near Lost Valley Fish Hatchery where he avoided capture. He then made his way seven miles from Cedar Gate, on Hwy 65 south of Warsaw to Hwy C, west of Lincoln. Early in December, he apparently met up with a couple of other dogs from the Bagley home in that area and went through the doggie door where the dogs lived, sleeping and eating with them. During the day, he ran free and supplemented his diet with deer carcasses.

"I began posting signs in the Lincoln area when an older gentleman came up and asked me what I was doing," said Perry. "I gave him a flyer with the lost dog information, and he called me later, on a Saturday, telling me that Hank was in his yard. We were able to trap the dog in a kennel, but he got out. Then, the Bagley's and their son, neighbors of the older gentleman, said that the dog had been hanging out at their house and entering through a dog gate. We were finally able to get him in a trap kennel again and contacted the Owens."

Perry said that she and Jim Chambers, a resident of Cedar Gate Estates who had been helping look for the dog, met the Texas owners in Oklahoma, the halfway point between San Antonio and Warsaw. Perry had driven about a total of 3500 miles during her hours devoted to finding and returning Hank to his home. She was also questioned by a Sheriff's Deputy when someone saw her searching and putting up flyers, and made a call about a suspicious person lurking about.

"When Hank was first spotted, you could see his ribs," said Perry. "He had spent about four days getting from Thibault Point on Hwy T to the Lincoln area. Other animals had probably been chasing him and he was scared. I am very thankful for the many volunteers and spotters working to find Hank."

Angels For Paws Lost and Found is a Facebook page for Benton County and surrounding areas. It tries to bring awareness of missing, stolen and dumped pets in the local area, but people can post from anywhere in Missouri. The site is quoted as saying "We have to be their voice and help them.

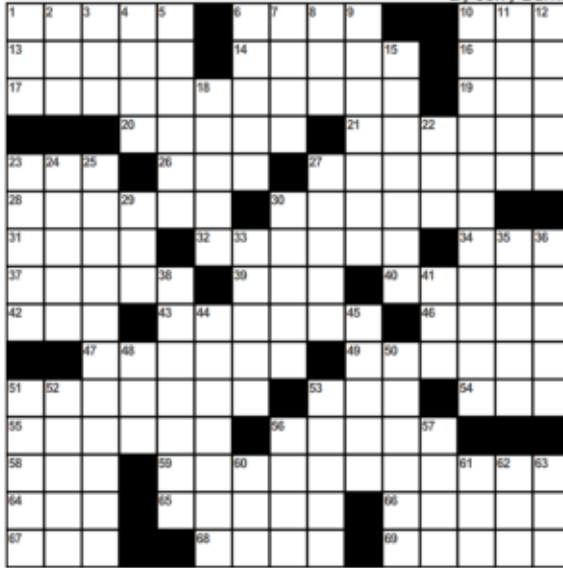

Perry said that if a dog is found and no one claims it right away, then the law requires that the animal be held for seven days before allowing it to be adopted. If the dog turns out to be lost, and the owners are found, they have to reimburse whatever a rescue organization spends on the animal for such things as vaccinations.

**Are You A Snowbird? Protect Your Finances While You're Gone**

Winter is (just about) officially here - but you may soon be leaving it behind if you're a snowbird. When you go, though, you'll want to keep your financial situation from getting caught out in the cold.

These are a few suggestions you may want to consider:

- Protect your home. If you're like many people, your home is your biggest investment, so you'll want to protect it while you're away. You're probably already familiar with the steps you should take, such as informing your neighbors that you'll be gone, stopping your newspapers, forwarding your mail, using a timer to run lights on and off, and so on. And these days, with smart phones and advanced security systems, you can look in on your home whenever you like.

Even if you're only gone a couple of months, you may need to make some investment moves, such as "maxing out" on your IRA, so stay on top of your accounts and contact your investment

professional, as needed. As always, though, don't overreact to sudden market swings - ideally, you've got long-term strategies in place that can serve your needs in most investment environments. In any case, it also wouldn't hurt to notify your financial professional that you'll be away for a while, even if you typically only see him or her a couple of times a year.

ONE GREAT BIG CHOCOLATE CAKE  
This is my go to recipe when I want to feed a lot of people chocolate cake. It's an easy cake; you can make the cake ahead of time and freeze the two layers, or make it the day before. Everybody likes it and it is easy to transport. So on holidays this is the chocolate cake that gets to travel.

For the cake:  
• 1½ cups unsweetened cocoa powder (not Dutch process), plus more for dusting the pans  
• ¾ cup whole milk  
• 1½ teaspoons vanilla  
• 3 cups flour  
• 2 teaspoons baking soda  
• Salt  
• 1½ cups (3 sticks) unsalted butter, softened

• 1½ cups dark brown sugar  
• 1½ cups granulated sugar  
• 6 eggs  
For the frosting:  
• 5 ounces unsweetened chocolate  
• ¾ cups (1 1/2 sticks) unsalted butter  
• 1 cup whipped cream cheese  
• 1 teaspoon vanilla  
• 2½ cups confectioners' sugar

Preparation  
1. Heat the oven to 350 degrees. Butter two large rectangular baking pans (13 by 9 by 2 inches) and line them with waxed or parchment paper. Butter the paper and dust the pans with cocoa (you could use flour, but cocoa adds color and flavor).

2. Measure the cocoa powder into a bowl, and whisk in 1 1/2 cups of boiling water until it is smooth, dark and so glossy it reminds you of chocolate pudding. Whisk in the milk and vanilla. In another bowl, whisk the flour with the baking soda and 3/4 teaspoon salt.

3. Put the butter into the bowl of a stand mixer and beat in the sugars until it is light, fluffy and the color of coffee with cream (about 5 minutes). One at a time, add the eggs, beating for about 20 seconds after each before adding the next. On low speed, beat in the flour mixture in 3 batches and the cocoa mixture in 2, alternating flour-cocoa-flour-cocoa-flour.

4. Pour half of the batter into each pan and smooth the tops. Bake in the middle of the oven until a tester comes out clean, 25 to 35 minutes. Let the pans rest on cooling racks for 2 minutes, and then turn the cakes onto racks to cool completely before frosting.

5. Make the frosting: Chop the chocolate and melt it in a double boiler. Let it cool so that you can comfortably put your finger in it. While it's cooling, mix the butter with the whipped cream cheese. Add the chocolate, the vanilla and a dash of salt, and mix in the confectioners' sugar until it looks like frosting, at least 5 minutes. Assemble the cake, spreading about a third of the frosting on one of the cooled layers, then putting the second layer on top and frosting the assembled cake.

Hart Company representatives Larry Hart and Courtney Wegman, Jail Committee representatives Mark Richerson, Kathy Bruner, Bob Berkhoff, Rod Brethower, Jason Shackles, Sheriff Eric Knox and Captain Jeff Canfield.

Representatives from the MU Extension Office met with Commissioners to present their 2018 budget request. Those in attendance were Livestock Specialist Gene Schmitz, Nutrition Specialist Tammy Culpepper and Extension Council Chairman Rod Brethower.

Sheriff Knox reported to the Commissioners that the previously awarded Local Law Enforcement Block Grant (LLEBG) has been delayed, pending litigation and at this time, it is unclear when funds will be available. This grant funding was to be used for the purchase of bullet-proof vests for deputies. Review of budget expenditures will be conducted to determine payment of this expense.

County Treasurer Rick Renno gave his weekly financial report, noting that sales tax revenues are up. County Clerk Susan Porterfield submitted bills for approval and payment.

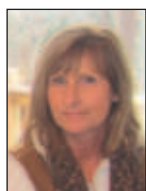

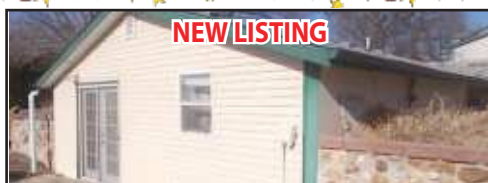

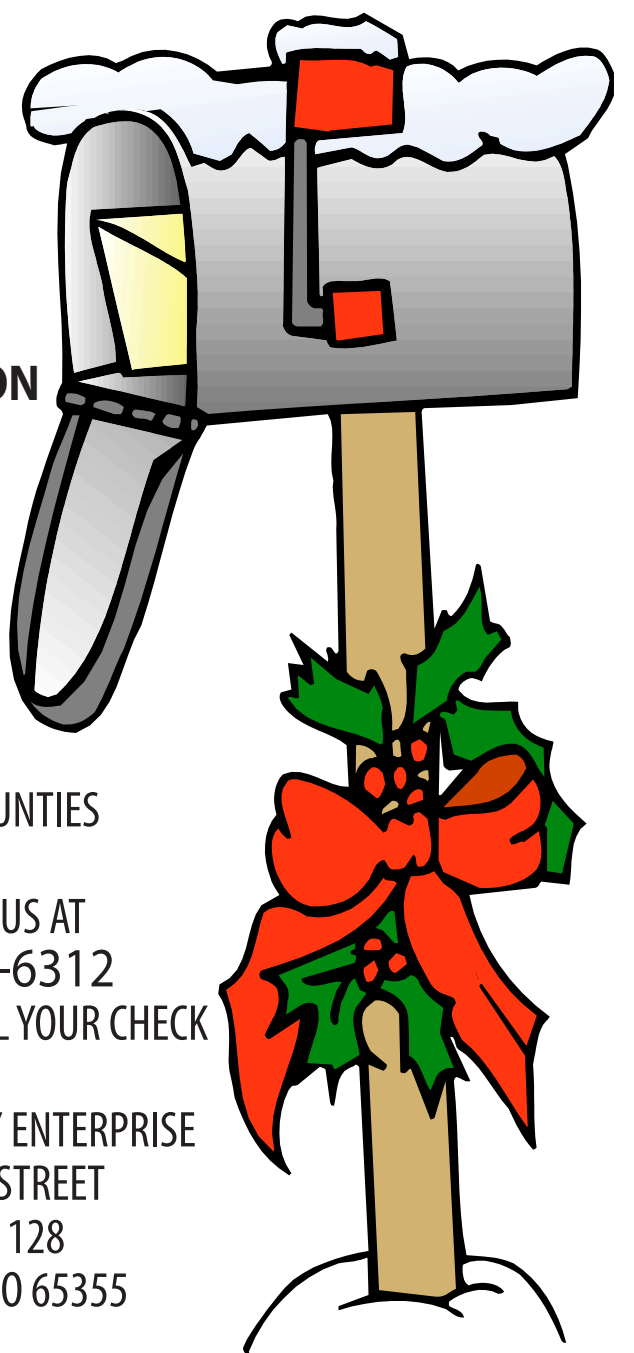
