Doing The Math: Pharmacies Fill Gap In Rural Communities

On April 1, 2023, Ryan and Julie Summers drove out to Primitive Old Crow and Winery. There, they were surprised to find family and employees gathered for a party to mark the 10th anniversary of the opening of their first pharmacy in Clinton.

That first pharmacy was a 3,300 square foot building they built on Pawnee, where they employed six people, Ryan said. Now, they own pharmacies in 13 locations, with 140 employees.

Having his own pharmacy was a long-time goal, but Rvan still remembers how he felt back at the opening for the first pharmacy.

"Excited, nervous, pretty much everything," he said. Like the first one, their stores fill a gap left by pharmacy owners who started their businesses back in the '70s and '80s, and closed them when they decided to retire, Ryan said. They include the owners of Kreisler Drug in Clinton, where Ryan worked as a delivery driver and stocker in high school. He graduated from Clinton High

School in 1997 and entered the six-year doctor of pharmacy program at the University of Missouri School of Pharmacy in Kansas City.

There were 40 or 50 people in the graduating class of 2004, Ryan said, including Julie, from Charleston in southeast Missouri. They married in Charleston in 2006, and moved to Clinton. Ryan worked at J and D Pharmacy in Warsaw, he said, and at Walmart. Julie worked at a pharmacy in Pawnee location. Harrisonville.

Last Tuesday, Ryan and Julie were both working at the counter of the Pawnee pharmacy. They opened their second pharmacy in the Golden Valley Medical Clinic in 2013, a few months after the Pawnee store, they said. Pharmacies in Butler and Bolivar followed in 2015, then in Nevada in 2016, also the year they expanded the

In 2019, they opened pharmacies in Marshall,

Warrensburg and Slater, and in 2020, Boonville and Appleton City. Last year, they opened a compounding pharmacy in Blue Springs, where they compound medicines that are prescribed by doctors but not available from manu-

facturers. Julie usually stays in town Summers 3

Community development Director Chuck Bailey spoke to the dangerous buildings commission. He reported that there is a meeting between the attorney and the property owner about the remaining demolition that needs to be done on the building that collapsed on the Square. The meeting was short and the commission went recessed until the May Council meeting. when they will reconvene.

Mayor Carla Moberly called the regular council meeting to order. All members of the council were present. Following the saying of the Pledge of Allegiance (led by Boy Scout Troop 430), the previous meeting's, minutes were approved. There were no personal appearances.

terminal in the amount of \$1.4 million. "We're fortunate to receive the funding," said Manager White. At present Garver Engineering is working with an architectural firm and they have a possible meeting next week in order to get bids ready by July 1. Mr. White said that he was excited about it.

Also big news from the Clinton Regional Airport is that Wallace White will be retiring. His last day is May 31 and in the council audience was his replacement, Joe Long. "I appreciate being able to work alongside the city, and grow the airport," Said Wallace White. He also said that he plans to be back and volunteer at the airport after a short reprieve.

Reporting next to the council was Economic Development Director Mark Dawson. He reported that there were three new projects this month one was an expansion project. He said that project "queen" was still out there and that project neon, which we all know now is Shermans Plumbing and Heating, are pretty close to closing on their real estate deals. "It has been a fairly busy month," said Director Dawson. Of interest to the council were the results of the business industrial surveys that were sent out. He reported that 51 businesses responded, which is about 13% of the area businesses. Some of the highlights of that included : many businesses reported increases in staff levels, most reported an average starting wage of \$17 an hour, 45% of the Council 3

Kreisler Drug closed two weeks after Ryan and Julie opened their first pharmacy. Besides the baby-boomer generation of pharmacy owners retiring, what other changes has he seen in the industry in the last 10 years?

"Everybody is getting bigger, "Ryan said. "There are more chain pharmacies."

The Summers pharmacies are an independent chain, he said, with an actual owner. Overseeing 13 stores is definitely challenging, he said, but has its prerogatives.

"The advantage of being the owner is you can take time to be away when you want," he said, "but you have to take care of everybody, too."

Ryan said he continues to hire high-school students to work for him. And for those aiming at a career in pharmacy, he has these words of advice: Study science.

"And math,"Julie adds.

responding businesses reported they were currently hiring, 85% of the employees of those businesses that responded live in Henry County, and that most reported that the labor pool was too small. On a positive note as well was that most of the responding businesses reported that they were planning on growing or expanding their businesses within the next three years.

Services related to the community were rated as a part of the surveys, too. The fire department, Animal Shelter, and Clinton Police Department were all rated rather high. Also rated as "high" in the service categories were the water and sewer services, and the mayor and city council. Economic Director Mark Dawson concluded his report by reminding the council that there is a Clinton Tech Center job fair next week that will involve about 100 students. "They'll need jobs," said Mark Dawson. Two second readings of previously read bills were approved by the council. Bill number 2023–07 and Bill number 2023–08, both pertaining to conditional use permits at 114 South Main and 116 S. Main, we're held. Councilman Cameron Jackson gave the public works committee report. The council approved the sale of the old motor grader. The property was declared surplus and permission was given to the street department to purchase a new 72 inch bobcat soil conditioner. The purchase price is \$11,653 and the purpose of the equipment is to allow the grading of alleys and other uses for the city streets (such as for chip and seal projects). Councilman Jackson re-

ported that the Artesian pool house is coming along nicely. Construction of the interior walls are near complete and the metal roof panels should be installed within a week. At the Benson Center Aquatic Center, the city has obtained quotes for the construction of a new building to house the boiler controls. The concrete pad for that project should be poured soon. Resolution number 2-2023 was passed by the city Council. Also resolution number 3-2023 passed concerning phase 1 and 2 of the project for the property, that was essentially donated to the city, regarding conservation grants for Antioch Park. The local match money for each grant combined total is \$70,000. Also, Council work at Hurt Park has be-

gun. A discussion about repairs for the exterior walls at the Benson center was held. The base proposal was only to treat the north and west side for \$38,000. However, the council ultimately approved, for an additional \$15,000, the inclusion of the south and east portions (which will include the waiver of some small fees if done in tandem); Councilman Gene Henry questioned the logic of not treating/repairing the whole structure while the opportunity is there as he believes it would just lead to problems down the road. Both Councilmen Jackson and Wilson opposed his motion, but the motion carried anyway.

Councilman Jackson reported that final revisions for the waste water treatment plant improvement project are being made. Also, more problems were encountered at the Calvird Pump Station (a new leak developed and more parts will need to be ordered). Monitoring devices for three pump stations have been ordered. The Waste Water Treatment Plant permit renewal is still in the public comment phase and Alliance Water Resource is still working on a long-term solution for staffing issues at the plant. It was reported an offer had been made to fill the plant manager position, however. The Public Safety report was given by Councilman Gene Henry. A motion to declare the 1998 Freightline Pumper truck at the fire department as surplus property and sell it thru "Purple Wave" was made; the motion carried. In addition to that, Councilman Henry reported that the sound barriers for the Animal Shelter project have been ordered. Councilman Daniel Wilson gave the Finance Committee report. Both items on the committee report pertained to bids for the Clinton Regional Airport runway project. Both low bids for the project were approved by the council. The City Administrator's report included a report about some light storm damage from the recent wind weather events. She also reported that the Waste Water Plant would be keeping some extra hours to accommodate cleanup from those events. The compost site will now be open all Saturdays and Sundays from 8am - 2pm. The Clinton City Council adjourned to executive session at 6:49 pm.

souri and Larry from the grocery business. Larry didn't have weekends off, Beth said, so when they retired, they were careful to plan how to spend their time together.

The first step: selling their house in Warrensburg, and buying 20 acres near Osceola. While living in a camper for seven months, they oversaw a house and barn being built, she said, with the goal of creating a place they could live independently as long as possible. They named it the Homestead.

After doing the finish work on the house, they decided to tackle a new interest: brewing beer. Now Larry puts out a batch of home brew five times a year, Beth said, which is popular with family and friends who stop by, especially in the summer. Then the Halseys took up beekeeping, joining a beekeeping group in Hermitage before installing their own hives. They harvested honey to share with family and friends, and in 2022, had enough to sell.

Deciding that a dog would be a good addition to the Homestead, they found a Beagle on Facebook that needed a new home, but it was spoken for by the time they contacted the person who had it.

Thirty minutes later, a post appeared on Facebook from an elderly couple who had rescued a Beagle mix frantically running around a parking lot of the Casey's in Hermitage, Mo., during a rainstorm. The couple spent three months trying to find its owner, but were moving, so couldn't take the dog with them. Beth responded, and she and Larry went to meet the dog, who took one look at them and ran straight to Larry.

"I could tell he was thinking: 'She's easy, but he'll be harder to win over," Beth said.

Beth posted a "meet our new dog" photo on Facebook, who they named Otis, because he reminded them of the laid-back character on The Andy Griffith Show. Every few weeks, Beth posted

news about Otis and how he was adapting to his new life. They had never had an indoor dog before, Beth said, and after a while, realized that Otis knew exactly what his role as dog of the house was.

"It wasn't us training him, it was him training us," Beth said. So Beth started prefacing Facebook posts with "Otis says."

People loved the posts so much, they became worried if they hadn't heard from Otis. Beth even got phone calls and emails, asking if he was okay. Then a neighbor suggested she print up Otis' thoughts, and another person said she should write a book.

She thought "That's never going to happen. I'm not an author. I wouldn't know where to start."

Then Beth met a former classmate, Janet Adams, in a beauty salon in Osceola. They hadn't seen each other in 50 years, Beth said, since they had graduated from Warsaw High School in 1970. Janet, a retired teacher, was an author and artist. They made plans to meet for lunch, and when Beth asked her friend for advice about writing a book, Janet told her to "just write it."

Beth did, starting with how Otis came to live with them, then chapters about what he enjoys, using the "Otis says" format. When she finished the first draft, she submitted copies to her two sons, with a note "Your crazy mother wrote this book." Their response was positive. In the process, Beth said, she gave up her preconceptions about what a book should be.

"I realized there is room in the world for all kinds of books," Beth said. "I wanted it to have pictures. Adults like picture books as well as kids. It could be a book that grandparents would want to read to their grandchildren, a feel-good book, a book that would make you smile."

It was on the advice of Janet that Beth contacted Dr. Rebecca Spencer of Warsaw, who has a faith-based publishing company. Dr. Spencer edited and formatted the book for her, Beth said, but the cost to publish was pro-

hibitive. So Spencer suggested that Beth take it to Amazon, which doesn't charge to print and promote books. Beth did and on Dec. 11, Otis' story,"My Forever Homestead Home," went live on Amazon.com.

On Dec. 22, Beth felt comfortable announcing that the book was available, telling friends and family "You said Nana should write a book, and I did."

Beth and Larry are Nana and Papa in the book, the names their grandchildren call them and how they imagine Otis thinks of them. By opening up their home to Otis, and herself to a new challenge, the book has opened up opportunities for Beth to speak at senior centers around mid-Missouri. and to raise money for senior centers and animal rescue shelters. In May, she's speaking to a retired teacher's organization in Warrensburg.

The best moment, however, was the response she got from a student whose teacher in Warsaw used her book as the focus of a threemonth reading and writing bloc. When Beth visited the class, and told the students that she was glad they liked her book, one of them responded "We didn't just like it, Mrs. Halsey. We loved it." The sequel, "My Forever Homestead Friend," is coming out in May, also voiced by Otis, describing how he adjusted to life with Smokey, a six-week-old kitten. Smokev showed up at the Halsey's back door and started out as a barn cat, Beth said, then moved onto the deck before moving into the house.

Going from an "only pet" to sharing the homestead

has been an adjustment for Otis, Beth said. But being a celebrity author has not changed him from his down-to-earth self, she said, although he would prefer to have bacon more often. Beth is surprised, however, when strangers come up to her at the grocery store, and say "You're Otis' Nana, aren't you?" because they had friends who shared Otis' story with them.

Otis, who doesn't travel well, was home with Larry on morning patrol, Beth said, but the presentation last week at the Senior Center was attended by Wyatt, a Clinton Animal Shelter resident accompanied by Laura Himes, the treasurer of CARE, Clinton Animal Rescue Endeavor.


The Halseys are always looking for new challenges, Beth said — the best part is meeting new people who share a common interest. Next on their list: greenhouse gardening and photography.

Her advice: if you see something you're interested in, go for it, and don't let how old you are or the fear it won't work out stop you.

"Even if it doesn't," she said, "you'll have learned something."

Beth also said the small things are just as important as the big things, and in being grateful for every day.

And as Otis says, take the opportunity to help somebody. trophies received at the National Collegiate Shooting Sports Athletic Association (NCSSAA) National Championships held in March at the Clark County Shooting Complex in Las Vegas, Nevada. SFCC is the only community college in Missouri that offers shooting sports as an athletic program.

SFCC had 12 student-athletes qualify for nationals. They were NJ McKenzie of Boonville, Connor Hess of California, Missouri, Anthony Walls of Ashland, Braiden McEachern of Slater, Hunter Snow of Columbia. Will VanVactor of Marshall, Matthew Richardson of Hughesville, Ben Engemann of Herman, Daniel Younger-Losing of Hughesville, Arthur Sims of Sedalia, Aidan Meyer of Boonville, and Philip Crawford of Jefferson City.

NJ McKenzie earned NCS-SAA All-American honors in American Skeet. All-Americans are determined by the shooters regular season averages and their national score. The honors were given to the top five student-athletes in each discipline.

The Roadrunners took second place as a squad in American Skeet. Squad members were McKenzie with a score of 98; Younger-Losing with a score of 95; Engemann with a score of 93; Walls with a score of 93, and Hess with a score of 92. McKenzie tied for first place as an individual but ended up finishing fourth overall after shoot-offs to break the ties in American Skeet.

SFCC placed second in Double Skeet. McKenzie scored a 93, Hess scored a 90, McEachern scored an 89, Walls scored an 89, and Sims scored an 83.

"Braiden McEachern was our top shooter with a total of 265 birds out of 300 overall," said SFCC Head Coach Sarah Manuel. "Daniel Younger-Losing really stepped up for us at na-

tionals. Daniel took eighth overall in Doubles Trap and then multiple other top five finishes for our squad.

"Arthur Sims had never shot competitively when the season began. He just joined the team to see how he would do. He ended up finishing second high overall in our squad with 264 out of 300 birds. NJ McKenzie scored a 261, Connor Hess scored a 260, and Anthony Walls had a 259 out of 300.

"I'm just very proud of these students and what they did and how they showed up to the competition," said Manuel. "We were starting in a new league this year, and I was kind of nervous going into it. Our kids really stepped up to the plate and allowed us to be successful. I'm very proud of the way the overall trip went, and I can't wait to get back to work for next season."

Coach Manuel, who is in her second season at SFCC, was recognized as the NCS-SAA 2022-2023 Division V Coach of the Year at the event. This prestigious honor is determined by votes from all the NCSSAA division coaches, of which there are five.





The Clinton School District is dedicated to EDUCATING and EMPOWERING students with the skills they need to be successful and ENGAGED adults after high school.

One of the ways the district accomplishes this goal is by providing cutting-edge, rigorous, and relevant Career and Technical Education (CTE) programs that prepare students for a wide range of high-wage, highskill, and high-demand careers. Below are highlights of the Clinton School District's CTE programs and the unique ways they are preparing students for their next steps in life.

Machine Tool Technology Clinton Technical School (CTS) students in Mr. Noble's Machine Tool Technology class are introduced to automated manufacturing, the branch of technology that uses stationary power-driven machines to shape or form parts made of metal and other materials.

In this class students learn how to use both lathes and mills. Students are also fortunate to be able to learn how to use Computer Numerical Controlled (CNC) machines. The CTS Machine Tool Technology program currently has 3 CNC mills and 2 CNC lathes, with another CNC milling machine arriving soon. This is the most CNC equipment the Machine Tool Technology program has ever had.

"The machining industry has become more and more automated and the addition of the CNC equipment to our shop is helping our students gain a knowledge of CNC that will place them well ahead of others when continuing on in their schooling or going straight into the workforce", says Dalyn Noble, program instructor.

Marketing

For more than three decades, high school marketing students have had the opportunity to manage and operate a school store. Now known as "The Nest", this store first took flight in the late 1980's.

Students in the Retail Operations class operate The experience at Jim Raysik, Gregg Smith, and Matteson Auto. The district is thankful for the strong partnerships we have with our community, and are always looking for more.

The district's programs are not as "narrow" as their names suggest, and there are eligible students in all of the career and technical education programs. This is an opportunity for you to invest in future graduates and hopefully attract qualified individuals that will help your business grow. If you have a need, it is likely that we have a qualified student in one of the following areas: Accounting, Automotive, Building Trades, Computer Networking & Repair, Health Occupations, Graphic Design, Machine & Tool Technology, Marketing, Multimedia, and Welding. Health Occupations

One of the most popular CTE programs in the Clinton School District has always been the district's Health Occupations program. Through this course, students spend time in the classroom, laboratory, and local clinical sites where they gain a solid foundation before entering the healthcare field. One of the many great things about Health Occupations is that students have the opportunity to earn a CNA (Certified Nursing Assistant) while they are in high school. This allows them to immediately enter the workforce, or to further their education after high school graduation. Recently, students have been attending clinicals at Golden Valley Memorial Healthcare and Adair Village. Students are participating in patient care to perfect the skills of a CNA while also exploring many healthcare careers. These opportunities allow students to experience how a CNA would be utilized in different departments, while also getting to see the inner workings of a potential career interest. To become a CNA, students must have a minimum of 75 classroom hours and 100 clinicals hours as well as pass written exams with a score of 80% or greater. Prior to clinicals, students must learn and demonstrate in a lab setting that they understand how to perform a procedure while also gaining patient perspective. Once students have met all of the classroom and clinical requirements as set by the Missouri Department of Health and Senior Services, they are then allowed to sit for the CNA certification exam. The proctored exam consists of a written portion, as well as a hands-on skills portion in which they must perform 3-4 skills. In order to prepare, students are given multiple, timed practice tests as well as many lab hours to study and prepare for all 19 skills because they do not know which 3-4 skills have been selected for them until they enter the exam room. Both portions of the exam must be passed with a minimum score of 80% in order for a student to receive their CNA certification.

ulator trains students on how to work from heights with proper fall protection in uncomfortable positions. It simulates the unsteadiness of being in a man lift, common mobility restrictions, working in confined spaces, and how to set up and use proper fume extraction techniques for air quality control. The idea behind this simulator is to take students out of the perfectly controlled environment of their welding booths and put their skills to work in real situations that they might encounter in the welding industry. The use of this trainer is boosting the skills of students and providing them with handson knowledge of the safety precautions that go along with a career in the field of welding.

Agriculture Science

The Agriculture Science program is one of three CTE (Career and Technical Education) programs housed at Clinton High School. Students who are enrolled in Ag Science classes also have the opportunity to join the national student organization, FFA. The Clinton FFA Chapter is going strong with 63 members, 26 new members just this year.

This year during National FFA Week, the Clinton FFA chapter had fun celebrating, but also took time to give back and thank those in the community who support their efforts and program throughout the year. To kick-off the week-long celebration, members attended church at United Methodist Church. On Monday morning, several members volunteered their time to participate in highway clean-up. Members were up bright and early on Tuesday for the annual Businessperson Breakfast at the Clinton Rotary Building. On Wednesday, first-year FFA members had their hand dyed green to signify that they are "Greenhands". And to celebrate George Washington's birthday, students delivered cherry pies to local businesses as a way to say "thank you". On Thursday, students enjoyed a meal together courtesy of Powell Meats and FFA officer, Allie Goucher. And on Friday, students traveled to Kansas City for the Western Farm Show.

Computer Networking and Repair

The ultimate goal of the district's CTE programs is for students to have the skills to be gainfully employed, or to continue their education, upon high school graduation. The district has many success stories of how programs are doing just that. One story in particular that the district is proud of comes from the Computer Networking and Repair program.

This program, taught by Mr. Michael Bowman, introduces students to computer networking, computer hardware/operating systems, troubleshooting, cybersecurity, and so much more. Students in this class, and all of the CTE classes at Clinton Technical School, have the opportunity to earn industry-recognized credentials allowing them to be more marketable in the workforce.

Gage Sidfrid, a 2022 Clinton High School graduate, was a 2-year student in this class. Upon completion of this program, Gage earned Testout Networking Pro and **Testout PC Pro certifications** as well as the skills and experience to enter directly into the workforce. Two months after graduation, Gage had a job here in the Clinton School District as an Information Technology (IT) Technician using the skills he acquired here as a student.

"The Computer Networking and Repair class familiarized me with common issues that occur as well as gave me the opportunity to get hands-on experience with computers," says Gage. "I enjoy working in the Clinton School District and getting the chance to encounter new problems and issues." Gage is also a student at State Fair Community College where he is studying

Looking Back: A Lucky Miracle?

I wrote the following article after reading a book about hockey and after Irene and I saw a minor league hockey game in Indianapolis (the Fuel) while visiting our daughter. I know we are in the Chiefs Kingdom, but for many the NHL is big, and we do have the KC Mavericks, an NHL affiliate. (Also the 2023 NHL playoffs begin April 17.)

(Three inches to the left.): His life would have been so very different if that puck would have been three inches to the left. But luckily it wasn't. Mike Eruzione made the winning goal in the 1980 Olympic hockey game when the USA beat the Soviet Union. Mike explained in his book "The Making of the Miracle" how Sports history and his life changed amazingly. This was the 'Miracle on Ice' game that many remember because this game was far more than a hockey game; It was the Cold War on ice, it was East vs West, it was our values vs theirs. Even if it was just a hockey game it was a shocker. The Russian team had won four straight Olympics, and had recently beaten an NHL All-Star team. So, this very young college team had no chance unless you do believe in miracles, the value of hard work, and how sometimes "Destiny trumps talent." Mike explained he believes in talent, and hard work, but he also believes that luck, at times, plays a role. Mike, a North Boston kid, grew up in a three-story home with 30 members of his extended Italian family. His family was everything to him. He was lucky to have so many built-in playmates. Hockey was big, but he also loved baseball and later football. In high school, he excelled in hockey and thought he could get a big college scholarship, but he didn't. After graduation, trying to get over the disappointment, he was playing in a local league

and had a great game. Lucky for Mike, one of the officials was a scout for Boston University (BU). Luckily this scout (Jack Parker) had two big recruits who surprisingly rejected his offer. Parker quickly recruited Mike. Mike went on to have a great college career, but was never the top dog. He was a low pick in the NHL draft, and went to a low minor-league team. He played nine games, but had doubts about his hockey future. Also, at times, he was homesick for his girlfriend and family back home.

Now on to the Miracle: A Minnesota coach, named Herb Brooks, was asked to put together the 1980 Olympic team. Brooks was famous for saying, "I am your coach, but I won't be your friend." He called 68 of the most talented college players, but he only needed 22. Luckily Brooks was given Mike's name when he called the BU coach. To be an amateur you could not have played more than nine pro games. Luckily Mike was one day away from being labeled a pro. The tryouts with Coach Brooks were brutal. Mike made the first cut, second cut and luckily made the team. Mike thought he had enough talent, but with Brooks being from Minnesota, a big rival of BU, most of the players were from the Minnesota area. The team played many "prep" games. Mike thought it was lucky that the US team played the Russian team in a 'friendly' right before the Olympics. The US lost 10-3. How was this lucky? The US players got a good look at how the Soviets played and knew they would need a better strategy next time. The very tough, very smart coach, Herb Brooks, scheduled that game so his young college players could get over their fear of the older Russian players. Mike, looking back on the whole experience, knew they were lucky to have such an intense smart coach, even though they often hated him and his 'mind games'. The US college kids won five games in order to get to the Russians in the Olympic semi-finals. They now had the 'impossible' task of beating the unbeatable Soviets. (The Soviets had not lost a game in forever.) There was no live TV coverage, because the networks thought it was going to LOOKING Page 12



Collison Looks To Guide Cardinals Golf To Take Next Step

An interview with Coach Collison, Cardinals Golf: 1) Tell us about yourself.

TC-I was born in Staples MN. but grew up in Benton City Washington. It was a very small town of about 1500. My graduating class of 1987 was only 36 students, so Clinton HS is a big school to me. After high school I tried my hand at college and realized that it was not right for me at that point in my life and joined the workforce working at a fertilizer company. I quickly realized that I did not want to be working 100 hours a week. Having a wife and two small boys I was missing out on the impressionable times of their lives. On my way home from work one day I stopped off at the Army Recruiting office and the next thing I know I am on my way to Spokane Wa. to enlist in the Army. That was on a Wednesday night. I enlisted the next day, came home, went back to work for the day, told everyone that I had joined the army and I fly out Saturday for Fort McClellan AL.

I joined the Army in June of 91 as a Military Policeman. My first assignment was to Schweinfurt GE. It was a great place for my first assignment. I think my wife and I rode our bikes all over Germany while we were there. After Germany I was assigned to Fort Campbell Ky, home of the 101st Airborne Div. While there I deployed to Panama S.A as part of a force protection for the Panama Canal. When I returned from Panama, I convinced my wife that we needed to get stationed there. It was probably one of the best places I have ever been. I worked as a Protective Service Agent for the Command Generals. This is really where I picked up my love of coaching. Our three boys were very competitive and involved in all the sports and I wanted to be part of that. I wanted to teach them about leadership, sportsmanship and camaraderie. An interview with Coach Ross, Cardinals Baseball: 1) Tell us about yourself.

TR-My name is Tayler Ross, I am 29 years old and have been married to my beautiful wife of 8 years, Bethany. We have 2 daughters, Vandy (5) and Molina (2).

I graduated from CHS in 2012. In my 4 years playing for the Clinton Cardinals I was a 3x all-conference, 3x all-district, and a first team all-state award winner as a senior utility (pitching & 3rd base) player. Clinton won 1 conference championship, 2 sectional crowns, and 3 district titles while I played for the Cardinals. I was 7-0 with a 0.60 ERA with 80 strikeouts in just 46 innings pitched as a senior, also hit .453 with a pair of homers, 30 RBI and 25 runs scored.

I started my collegiate baseball career at Missouri State University in Springfield. After a torn labrum surgery and 2 baseball seasons, I transferred to the University of Central Missouri in Warrensburg.

In my final 2 seasons at UCM, I was 3-0 with 2 saves in 35 appearances. In 2016, with the Mules, we took home 5th place in the D2 College World Series. After 51.1 innings pitched, my ERA was a 1.58. I earned All-MIAA Conference Honors as a Relief Pitcher my senior year.

I graduated from UCM in 2017 with a Bachelor's in Design and Drafting and shortly after graduation I started my career with Kiewit. I have been working remotely at Kiewit as a Designer II for almost 6 years now.


