# **Clinton's Shop Small Crawl** Is A BIG Shopping Success!

Clinton shops on and off the Square were busy Saturday morning, with shoppers drawn to town for the second annual Shop Small Crawl. By visiting each shop on the Crawl, shoppers got a stamp on their passports, which when filled, were entered in a raffle for cash prizes totaling \$1,000.

Among the family groups negotiating the Square Saturday morning were Whitney Doody with daughter Blake, 3, and son Bennett, 1. Accompanying Whitney were Cheryl Goucher, the children's grandmother, and their aunt, Crystal Roskup. All are from Clinton.

"We did this last year," Goucher said. "We're going to all the stores."

Blue skies and spring sunshine added to the festive atmosphere, along with music by a guitarist playing under the striped awning of the Clinton Daily Democrat and T-Shirt Factory, 104 S. Main, and refreshments at many of the stores.

"Last year, I won a sign from Simple Pleasures," she said. "I have it in my living room. It says 'Family Gathers Here.""


OakStar Bank sponsored the event again this year.

Most residents know that Clinton was once the Baby Chick Capital of the World.

But people may not know that the town's claim to fame was inspired by a school assembly attended by a Clinton boy in 1911, when he was a junior in high school.

The farm where Royal Booth lived with his family will be open to visitors as one of the seven stops on the 2023 Henry County Garden Tour on June 17.

The farm is at 607 Booth Rd., where Booth launched his enterprise in the barn. It is now the home of Tom and Sandra Spooner, who had the barn converted into a residence. The were Spooners. who looking for a new place to live, remember the rainy day four years ago they saw the possibilities.

"We drove up to the gate and thought 'We could make this place a home," Sandra said.

Their gaze was drawn past the farmhouse to the barn on the farm, which had

been in her family for 53 years, Sandra said. When her parents, W.D. and Hazel Scott, had bought it, there were a lot of brood houses on the 40 acres, she said, where Royal Booth housed his laying hens.

The Spooners, who are both pilots, had previously lived on a farm near Calhoun, where they had

an airplane hangar and runway. But after her parents died, a niece, Halley Bridges, and husband Matt were looking for a home in the country to raise their family, Sandra said.

"They needed a place to live, and we needed a new place and a new project," she said. Deciding on the barn

conversion, the Spooners drew a floor plan on a piece of graph paper, and gave it to carpenter Tom Williams. With the help of two Amish craftsmen, he turned the barn into their home in six months.

"We moved in on April 4, which was Mom's birthday," Sandra said.



**Continued from page 1** "She was born in 1922, and lived to be 97."

Sandra's father, known as Scotty, worked at P.A. Cowen Lumber Company for 46 years, she said. Sandra inherited her woodworking skills and interest in making things from him, she said. A 1964 graduate of CHS, Sandra studied student personnel and business administration at Central Missouri State University, then had her own woodworking business, The Wood Pile.

She also worked at Southwest Baptist University in Bolivar and then at Twin Lakes Hospice, where she met Tom, who was the hospice medical director. Born in Wisconsin, Tom grew up in Oklahoma and went to medical school in Kansas City. He started working in Clinton at Wetzel Clinic in 1974, then was at Golden Valley Memorial Healthcare. Dr. Spooner retired after 37 years in family practice, and said wherever he goes, he still meets people he delivered. He has taken over the woodworking, Sandra said, and turns out wooden bowls. "Now when I have the idea, Tom makes it," she said. The hatchery barn had been used by her family for storage — the chickens were long gone — so the Spooners held a family auction to clear it out as the first step to its conversion. The interior now has an English country ambiance, with a stone-surround wood-burning fireplace in the living room, and a

propane wall fireplace in the dining room/kitchen. A lot of the house is "original recipe," as Tom puts it, especially in the loft, which has original wood floors, walls and rafters.

They joke that they live in a former chicken coop, but the 3,800 square-foot house is neither small, nor haunted by the former residents - there is no ghostly clucking, Sandra said, or rustling of feathers. There are other farm sounds, however. The windows of the sunroom look out over the fields, where the Spooners pasture their two mules, Bess and Bonnie. They also raise Black Angus cattle and have a Texas Longhorn named Bella, who just had a calf, Oki. They also have a screened porch on the main floor, and two decks off of the loft bedrooms upstairs offer views east and west of the countryside. When their house was a barn, it had three or four rooms, they said, including a cold room where the eggs were kept before going into the incubators. That's where they found egg racks with wooden dowels, which they recycled into towel holders for their master bathroom. The racks have non-sequential numbers, but the Spooners haven't found out what they signify. "We have yet to crack the code," Tom said. Royal Booth was a junior in high school when a school assembly gave him the idea to apply modern production methods to chick production. He bred laying hens that would produce eggs year 'round, making a start after he graduated, then was drafted and served in World War I. Returning to Clinton, he ramped up his business into the first commercial chick hatchery west of the Mississippi, hatching and shipping a million chicks a year.

Booth eventually opened a hatchery in town, and shipped chicks all over the world. He also became a distributor for incubators — the largest could hatch 15,000 eggs — inspired other hatcheries to start in Clinton. The industry flourished in the 1920s and '30s. shipping 3 million chicks a year, before dying out in the 1960s.

The Spooners do have chickens — three— which provide fresh eggs every morning, Sandra said. They also grow corn, beans, tomatoes and peppers in their vegetable garden, next to the pole barn.

The pole barn also connects them to Clinton history— Sandra's father and brother used galvanized tin from the Cowan Lumber Co. to build it, she said. The lumber yard was on Franklin, across from the Henry County Museum, where the dog-trot house is, on land that Ned Cowan, the son of P.A.Cowan, donated to the museum.

The old wagon now in their front yard was once used for transportation. When the Spooners lived near Calhoun, they had Haflinger horses, a breed of small, chestnut horses with flaxen (blond) manes. One year, Sandra said, they hitched the horses to the wagon and drove on back roads to her brother's farm for Thanksgiving, a trip of 45 minutes.

In a corner of the back yard is Herb the Herb Wagon, where Sandra grows oregano, rosemary, basil and chives. Trellised rose bushes and clematis, hosta, coneflowers and daisies add bright dots of color in the beds surrounding the house. Flowers in pots bloom on the patio by the front door. Junior and Joseph, the Amish craftsmen. made the split-rail fence enclosing the yard in front of the house. On the other side of the driveway, between the chicken yard and the vegetable garden, an old mulberry tree leans to the ground. A wooden ladder placed against the trunk to make it easier for Sandra and Tom's five grandchildren to climb.

Sandra, looking out over the pastoral landscape, calls the move "Godorchestrated," and knows her father and mother would be on Cloud Nine, because the farm is still in the family.

Also still in the family is the Spooners' former farm, off of Hwy. 52 E. between Clinton and Calhoun. Sandra's niece, Halley, and Matt Bridges, a.k.a. Rustic Bridges, hold an open-air craft market there twice a year.

Coming up on June 10 is the summer "On the Farm" Day, featuring the Bridges' handmade wood furniture, Tom's turned bowls and artist friends' crafts. It's held in the hangar with the doors open, and spills out onto the lawn and gardens of the farm house. Free to visitors, "On the Farm" is oriented to all ages, with crafts, food, music and children's activities. Check the Rustic Bridges Facebook for more information.

The Henry County Garden Tour is Saturday, June 17, from 10 to 4 p.m. Tickets are \$10, and are available at any of the seven gardens the day of the tour, or from members of the Twilight Garden Club, the Designing Gardeners, or from tour coordinator Brenda Roberts, 660-351-5139. Ticket price is \$10 per person, on the day of the tour or in advance.

Addresses of the tour gardens, three in town, three in the country and the Booth Road farm on the edge of town, will appear in next week's Clinton Daily Democrat.

He said there were five new projects opened last month - a mix of industrial and retail interests. Project Queen is still moving forward, albeit somewhat slowly and he reported working with a property owner about a potential mixed-use project. 

nesses would like to see an increase in youth work ethics. To that end Dawson said he would be working with the school next year to perhaps implement some sort of education about this. Dawson spoke briefly about a housing rehab pilot program to which Councilman Jackson seemed supportive of. The goal is to remediate residential areas with older, neglected homes in them. The goal is still to gain more workforce housing. Director Dawson also talked about some statistics concerning the lack of business activity last month (nationwide). He pointed out the fact that supply for new products was down 9% last month and may be related to the business activity.

Director Main Street Amanda Johnson spoke to the council next. She said she attended the Main Street Conference (in Boston) earlier this month. Johnson said there was a lot of useful information she gleaned from attending and that she was able to make it to six breakout sessions. She also spoke about April downtown events to help increase store traffic and that a promenade event on May 6 was held on the square where graduating seniors from CHS were able to "walk the red carpet" and get photos taken. She reported it was well-received and hopes it will become a tradition. Also involving students was a May 10 4th grader CIS Historical Walking Tour. Johnson said the kids toured historical places on the square which included the Bandstand. Fountain, and 9/11 Memorial. Clinton's Main Street was awarded a \$5,000 grant to help increase their cultural tourism presence in the downtown area and QR codes are being placed at various historic locations so folks that are curious can find out historical information about some of the buildings or structures they might see. Johnson concluded her report by informing the council of a new promotion event for the downtown stores on June 15 – again, to help support the local businesses on the square. Councilman Cameron Jackson gave the Public Works report. He said that 81 tons of garbage were collected from the Citywide Cleanup event. There are some issues with the roll-off truck used at the transfer station, but City Administrator Christy Maggi said that the issue should be resolved by the end of the week (May 20 or so). Because of the mechanical issues only household trash will be accepted at the transfer station until such time as the issue is resolved. There was another issue during city-wide cleanup which involved out of town people using the local transfer station of which a solution will be explored in the coming weeks. Councilman Jackson reported that the roof on the outdoor pool was done and that interior painting has begun. The Aquatic Center is now open. He reported that the Park Board met May 8 and received multiple updates on current projects and programs. Also, the west Central Community Action Agency agreed to donate a tract of land to meet a requirement for the Antioch Hill Park Urban Conservation Project. Conditions for the grant for the project state that the land needs to be in the City of Clinton's name.

The Benson Center's exterior rehab is nearing completion and the Aquatic Center boiler building work should begin in July.

Pump station repairs are ongoing: the Calvird Station pump has been installed; one snag in the pump rehas placements/repairs occurred in that the incorrect pump for one of the upper-level pumps was shipped. Although no action was taken, Lexipol appears to be the front runner for this service. Resolution 06-2023 was approved by the council. 06-2023 regards the agreement with rural fire protection. There were minor changes to the agreement, mainly in charges for use of on-board equipment and to the structure of the arrangement regarding a phone line.

The recommendation for firework sales to begin June 20 through July 4, from 9 am to 10 pm daily, and for the discharge of fireworks beginning June 30 through July 4th from 9 am to 11 pm daily were approved by the council. Councilman Henry concluded his report by noting that Fire Chief Mark Manuel and Assistant Chief Matt Willings will be traveling to inspect the new fire truck Thursday (May 18) and the potential delivery date of the new truck is mid-June. The Finance Committee report was given by Councilwoman Martha Nichols. The council approved the recommendation for the retirement benefit program. Budget work-session dates are being proposed, and she also wanted to make sure the council (and citizens) were aware that two tax rates will be expiring next year (transportation and local parks taxes). The Mayor's Report: Mayor Carla Moberly appointed Tony Smith to replace Dennis Seiger to the Kaysinger Basin Regional Planning Commission. The council approved Resolution 05-2023 supporting her appointment. The council also approved the reappointment of Tim Komer and Brady Brown to the Park Board. Approved as a slate were the recommendations for appointments and liaisons: Austin Jones (Planning Commission), Debbie Smith (Cemetery Board liaison), Shelley Nelson (Park Board), Martha Nichols (Historic Preservation Commission liaison), Cameron Jackson (CARE liaison), Danial Wilson (MU Extension Henry County Council Member and Clinton Housing Authority board member), Roger House (Tourism Commission), Gene Henry (Airport Board liaison), and Roger House (Greater Clinton Area of Commerce Board Member). The council adjourned at 6:35 p.m.

Harry S. Truman **Rural Water District #2 New** Water Tower Project



If you have driven between Montrose and Appleton City over the past few weeks you might have noticed the skyline is changing. Harry S. Truman Water District #2 is in the middle of a construction project which includes the building of a 600,000 gallon water tower which will replace a 38 year old water storage tank. The new tower is being constructed on land which was donated to the water district by the Dugan Family, in honor of Wilfred Dugan, who was one of the original founders of the water district and served as Chairman of the Board for many years.

The district has been working towards the improvement of the water distribution of the system for many years with the engineering firm, Lamp Rynerson. The engineering firm has estimated the newly designed tower and upgrades will not only enhance the water supply to all areas of the district but will also help with water quality and aid with water pressure to various areas of the district.

Financing for this large project has been approved and made available from the Department of Natural Resoures thru the Drinking Water State Revolving Fund loan program. The project is expected to cost the district approximately \$2.5 million. The 20-year loan terms along with ARPA funding provided from the St. Clair County Commission has so far made the project affordable to the district with no additional fee charges to its customers. Even with increasing cost, the water district board and employees have worked very hard to keep water charges at the same levels since the district was first established in 1986.

Harry S. Truman Water District #2 includes areas of southern Henry and Northern St. Clair Counties. The district provides water not only to the area rural population but to the communities of Appleton City, Montrose, Deepwater and Rockville. Adjoining districts in eastern Bates County and north central Henry County also use water provided from the district. The water supply for the district is pumped from two wells at an underground rock quarry which is recharged by Truman Lake. This intake area, along with the treatment plant, is located near the Sparrowfoot Public Use Area just south of Clinton.



For road condition reports, travelers can visit the Patrol's website at www.statepatrol.dps. mo.gov. Click on the Road Condition icon to view road construction areas as well as road conditions throughout the state or call 1-888-275-6636.

Motorists are encouraged to do their part to make Missouri's roadways safer. Speed, inattention, and impaired driving are leading causes of traffic crashes. Please obey all traffic laws and make sure everyone in the vehicle is properly restrained in a seat belt or child restraint.

When you're on the water, please be courteous to others enjoying Missouri's lakes and rivers, wear a life jacket, and obey the law regarding safe operation of a vessel and no wake zones. Causing harm to another person or their property with an excessive boat wake may subject you to enforcement action or civil liability.

When you're traveling up Missouri's rivers in a jet boat turn off the motor for a second and listen before navigating around that bend. River bends create blind spots. Listening for boats coming down the river allows you time to give way. Also, jet boats should stay closer to the center of the river to give floaters room. When operating a power-driven vessel, it's important to understand the rules of navigation. Power-driven vessels must give way to anchored or disabled vessels, vessels restricted in their ability to maneuver, and commercial fishing vessels. Power-driven vessels also yield to a sailboat under sail unless it is overtaking, and canoes or other vessels powered by paddles or oars alone. Observing right-of-way rules makes our waterways safer for everyone. Always treat other boaters and property owners as you want to be treated. 



Holy Rosary's seventh and eighth grade trip to Washington D.C. was a success! The students were able to see and experience many historical places as well as be active participants in daily ceremonies and traditions in and around Washington D.C.

Over a year ago the seventh and eighth grade classes began making plans to take their educational experiences outside the walls of their classrooms and school. The students, parents, school community and parish worked together to help raise funds to make this opportunity happen for all.

On April 18, 2023 all seventh and eighth grade students, parent chaperones, teacher Mrs. Jamie Larsen, and principal Mrs. Tara Engelhart departed from Kansas City International Airport to begin their Education First adventure. This trip was a five day immersion into our nation's history, civics, science, and the arts.

The tour began at the Arlington National Cemetery where the students learned about the burial criteria and procedures. While there the students witnessed the changing of the guards at the Tomb of the Unknown Soldier. Immediately following this ceremony our tour director, Larry Fischer, took us into the Arlington Memorial Amphitheater to discuss the changing of the guards and discuss the Tomb of the Unknown Soldier. During this discussion we were surprised that two of the soldiers that have the honor of guarding the tomb joined our group's discussion. They answered our students' questions and shared additional information of what qualifies a soldier for this prestigious duty. We were also excited to find that one of the soldiers was from Lebanon, MO.

Following their tour at Arlington National Cemetery they went to visit the Marine Corps War Memorial. Their next stop was the White House. After hearing the history behind the White House our students participated in a couple of line dances with a local favorite street performer. This is where the travelers began experiencing the people that live in Washington D.C. From there they moved onto the Smithsonian Museum of Natural History. Finally ending the day by visiting the Vietnam Veterans Memorial, and the Lincoln Memorial. The students enjoyed this last stop and many would say this stop was their favorite. They enjoyed seeing where Martin Luther King Jr gave his "I Have a Dream" speech as well as the opportunity to sit by the reflection pool to talk about what they had already learned and experienced on day one in Washington D.C. The students continued their travels the next day visiting the Jefferson Memorial, United States Holocaust Memorial Museum, and Mount Vernon. These stops also made a lasting impression on the students. While in the U.S. Holocaust Memorial Museum the students participated in a memorial ceremony and helped light candles to honor those that died during the Holocaust. That evening the students enjoyed listening to a storyteller that shared historical and spooky stories. This was a candlelit evening tour that took them through the historic streets and alleyways of Alexandria, Virginia. The third day of tours began at the Martin Luther King Jr Memorial and the Franklin Delano Roosevelt Memorial. Then, our group was prepared for our visit in the United States Capitol and the United States Supreme Court building. The students continued to be thoroughly engaged

in learning about how our government works. This is where their civics lessons began to become real and pertinent to their lives.

After finishing at the Capitol the students were excited to find we were making our way to the Smithsonian Museum for Air and Space. This stop highlighted science in the real world whether historical or current. The students loved trying to figure out how things worked. They enjoyed not only seeing the exhibits but loved trying out the varied simulators that were available.

That day wasn't done yet! We then went to Ford's Theater where the students helped reenact the assassination of President Lincoln. From the reenactment the tour took the group to the World War II Memorial, Korean War Memorial and finally the students had an opportunity to participate in some statue climbing with a visit to the Einstein statue.

The Holy Rosary student's last day began at the Pentagon specifically at the Pentagon Memorial. Each student had the opportunity to pay tribute to the 184 people whose lives were lost at the Pentagon on September 11, 2001.

Then, our tour took a cultural twist with a visit to the Kennedy Center. While there the students got to see different styles of art exhibits and a beautiful 360 degree view of Washington D.C.

Finally, our last stop was the Smithsonian Museum of American History. There are more than 1.8 million objects of archival collections to see in this museum! The exhibits are a range of topics that offer first hand experiences and treasures from American history. These collections range from the original Star-Spangled Banner to gowns from the first ladies, Abraham Lincoln's top hat, part of the Berlin Wall, Dorothy's ruby slippers from The Wizard of Oz and this list could go on! The artifacts found here are the greatest single collection of American history in the world. This was a great





"We will still have auto-





### **CHRISTIANS IN BETWEEN**

It was my first pastorate and the first revival for the new pastor. One night a man I had never seen answered the invitation. With tears in his eyes, he confessed he was an inactive member. He was rededicating his life and wanted to support the new pastor and the church. I was thrilled. Later, another church member warned me. "Pastor, don't be too excited; he does this at every revival. In a few Sundays, you will not see him again until the next Revival." Unfortunately, the church member was right. When the Pew Research Organization began their work, they asked the question, "Do you consider yourself a faithful Christian?" They evaluated the answer by how often a person went to church. By this standard, a faithful Christian went to church every Sunday. One who attended twice a month was rated as semi-faithful. Today, I am told they regard attendance once every few months as faithful. When asked how the organization explained this change, they replied, "Times have changed." Regarding this rule for evaluating faithful Christianity, many reply they go to church, "Whenever the spirit moves me." While working on my project for a seminary degree, I interviewed the inactive members of our church personally. I was guite shocked to learn that some of them regarded themselves as faithful members, yet they had never attended church in all my tenure. No doubt, the Pew research evaluation is flawed. So, let's talk about what you do between your times at church. I took my car to the shop for repair. A mechanic was giving someone a tongue lashing. Thankfully, the person he was demeaning was not present. The mechanic's rant was filled with verbiage that was far from Christian. A few weeks later, a local pastor asked me to supply for him. Imagine my surprise when that mechanic came to the altar to lead the offertory prayer. It is not my intention to preach a negative sermon with this column. Such sermons are of minimal value. Neither is it my intention to tell you how often you should attend church. Jesus told us that faithful Christians follow Him. What is important is how you follow Him while you are in church as well as times in between.
