

#### **Clinton Airport Regional Director Fields Questions**

The Clinton City Council met in open session June 6 at City Hall. Councilman Austin Jones was absent. Following roll call, the Pledge of Allegiance was recited and the previous meeting's minutes were approved. There were no personal appearances.

Joel Long, the new Clinton Regional Airport Manager, reported to the council. His report was brief and more introductory in nature. Mr. Long reported that he was excited for the new projects to get started (the runway and new terminal project) and that he was available for questions at any time. "The airport is nice, well kept, well funded, and moving forward," he said. "Things are really looking up at the airport."

Councilman Cameron Jackson gave the Public Works Committee report. He reported that a storm sewer box (which had collapsed at Third and Jefferson Streets) has been repaired at a minimal cost. Waste Water is waiting for the backfill to settle before pouring concrete.

Resolution 07-2023 was approved by the council. The resolution pertains to the Clinton Square seal coating and striping project. Plans for the project include the parking for the courthouse (the City of Clinton has met with the

Henry County Commission and agreed on a price split so the project can be completed at one time). 

Stanley Brown was born on February 26, 1950, to Denver and Anna Pearl Brown in Clinton, Mo. Stanley was the second oldest of nine siblings. The Brown family was the largest African American family in the Clinton area. Denver and



Stanley attended an allblack school his 1st grade vear in Clinton. He was the pt black to attend the integrated school his 2nd grade year in Lincoln. At a young age he started working to help support his large family doing odd jobs like mowing yards and dishwashing. Children wouldn't invite him or allow him to attend classmate's birthday parties due to his color. That is until Maria. Stanley will never forget that she was the first girl to ever invite him to a birthday party.

At 11 he was the 1st and only African American to be an Eagle Scout from Clinton Missouri. He also became a member of the 2nd Baptist church of Clinton. Which later became Save Our World Ministries where his brother Pastor. Stanley graduated from Clinton High School. After high school he decided to



attend college in Warrensburg. Mo. Stanley's love for music was his motivation behind his music major. The dorm life was one big party which Stanley was not interested in. During his 2 1/2 years he was named Master of Ceremonies. Unfortunately, between the wild parties around him and the bullying and disownment from his fellow black community for "acting to white" Stanley had enough and dropped

out of college and moved back to Clinton. Stanley did attend John Casablanca's school of modeling on the Plaza of Kansas City. At a contest he took pt place in the sexiest contest. He again was the only African American in the contest and beat out ten other contestants. Stanley has accomplished many things in his 73 years including polit lessons to digging worms to modeling. He even owned an antique store. There's not much he hasn't done. He was voted Henry County Young Democrat State Administrative Vice President where he met Bob Hope and got his autograph. Stanley was also the first African American to be the director of the Henry County Fair Parade. "Children in Wonderland" was the theme. Stanley was able to get Jane Froman who was a famous actress and singer from Clinton area to make an appearance. As well as Clinton's Mayor and Missouri Governor Kit Bond, two Playboy bunnies and Miss Missouri joined the parade ceremonies.

Stanley has never married nor had any desire to have children after helping to raise his nine other

siblings. He never really knew exactly what he wanted to do so he did a little of everything. God and Jesus were his champion and he enjoyed being a Christian. Henry said that the ARPA grants for the fire extinguisher trainer and the cardiac monitor (both for the Clinton Fire Department) are still in progress. Also, the council approved that 30 SCBA air cylinders, not compatible with the Clinton Fire Department's current equipment, be declared surplus property and donated to the other county fire departments of which they are compatible with. Councilman Henry also reported that a new police officer (Wyatt Bernard) graduated from the police academy and will start immediately.

Councilman Daniel Wilson gave the Finance Committee report. The council approved the employee holiday leave policy which has been done for the last several years. Employees will be able to use 16 hours of floating leave time not otherwise scheduled as time off (for flexibility among departments). A special council session was scheduled for June 30 at noon so that the new road for the airport terminal bids could be approved with time to submit the project (to get the grant). It was also reported that a work order has been placed to repair the street lights at Second and Jefferson Streets. For now, the lights for all intersections will flash red and act as a four-way stop. Mayor Carla Moberly reported that a replacement has been found for longtime Aquatics Director Ann Drury, "We will miss her, but have happily been able to find someone to take her place." She also said she was continually amazed at how city employees and department heads are able to come up with novel ways to save the city money, City Administrator Christy Maggi had no report. A survey will be sent out to the council persons to determine the best date for the council session that is originally intended for the 4th of July. Before entering closed session, Councilman Jackson praised the Clinton Police Department for the quick capture of the vandals who recently painted obscene and offensive things on several local properties and vehicles. The adolescents were rounded up in less than 24 hours. Councilman Jackson condemned their actions but praised the community for quickly coming together especially to clean up some of the hurtful messages that would be found especially offensive to some of the residents. "This is the community I know," said Councilman Jackson, speaking about the quick actions of the residents/neighbors

who began the clean up of the vandalism. He said he found it reassuring, especially in light of the fact that grace and compassion seem a little hard to come by these days.

As a final note, Fire Chief Mark Manuel is concerned that the dead fuel moisture level might be too low to shoot fireworks off come late June through early July. "It is contingent on measurable rain," he said. "Ideally. the dead fuel moisture content should be 15% - 20%; right now it is at 6%." The situation is being moni-

#### **Warns Producers** about Hay Scams

The Missouri Department of Agriculture reminds livestock producers to be wary of potential scams involving hay sales. The Department has received reports from producers who paid for hay upfront through a wire transfer. only to have no hav delivered. Dry conditions across much of Missouri has left pastures short and hay scarce, causing many tored (pray for rain folks), but just in case fire works are too dangerous to shoot off because of a high burn hazard, there are plans to move it to a later date and the Olde Glory Days committee is aware of the situation. Of further note, Chief Mark Manuel clarified that the city does not have "burn bans" but, rather, burn restrictions. The language is in-line with state regulations.

Producers are encouraged to keep these tips in mind when looking to purchase hay:

Purchase from someone you know, if possible.

If you do not know the seller, ensure the seller is reputable.

When possible, view the hay in person before any exchange of money. Do not rely on photographs on social media.

Be cautious of any wire money exchange with someone you do not know. The Missouri Department of Agriculture and MU Extension manage online hay directories, where livestock producers can search for hay made available by other producers. The MDA directory can be filtered by county or state and is regularly maintained by Department staff. The MU Extension hay market listing can be filtered by region of Missouri, hay type and bale type. If you are the victim of a scam involving hay, contact your local authorities. The space had been a surplus store five years ago, and people still come in and look around, surprised, Trish said. Instead of dusty merchandise, they see a collection of colorful landscapes— oil, acrylic and watercolors — and other fine art.

"It's all Missouri art," Trish said. "The farthest we have is from artists who live in Smithville and St. Charles." In the summer, the gallery draws more people from out of town than locals, Trish said — the guest book holds signatures from visitors all over the Midwest, and the country. Trish opens the gallery at 11 a.m. Wednesdays through Saturdays, and the gallery participates in all the Main Quilt Walk, etc. — and makes prints of artwork to sell during sidewalk sales.

Gallery Three also holds art classes — Susan Sanders, who has a studio in Clinton, is holding a twopart class this month. Every Wednesday, people are invited to bring an art project they are working on and sit around the table in back and visit while they work.

State Sen. Sandy Crawford, R-Buffalo, announced today two of her main legislative priorities for 2023 have been signed into law by the governor. Senate Bill 13, which included my Senate Bill 12, modifies provisions relating to financial institutions.

"I would like to thank not only the governor for signing Senate Bill 13, but my colleagues for helping to get this measure across the finish line this year," Sen. Crawford said. "This new law is designed to streamline operations at the Missouri Division of Finance and assist banks who offer their own credit cards."

Senate Bill 13 gives the Division of Finance authority to issue useful guidance to the industry and increase consumer lending license fees. In addition, it repeals obsolete laws and it clarifies statutes related to the Division. It also clarifies

that financial institutions that issue their own credit cards are allowed to adapt the full terms and conditions of a contiguous states' credit card lending law.

"As someone who spent 30 years in the banking industry, I know how these regulations can affect not only the professionals, but all of us," Sen. Crawford said.

This new law will take effect on Aug. 28.
