# Wheeling Into Windsor: MO's Newest State Park Makes Debut

BY JENNIFER JACKSON Staff Reporter

Close to 30 years ago, Kim Henderson was working as an officer in a Windsor bank near Casey's. When she looked out the window, she could see bicyclists pass by on the KATY Trail.

There was the possibility of a spur line of the rails-totrail bicycle trail from Pleasant Hill that would cross the KATY Trail at Windsor.

In 2016, that spur trail, 47.5 miles connecting Pleasant Hill to Windsor, became a reality. On June 30, the Rock Island Spur, plus 144 miles from Windsor to Beaufort, became Missouri's 93rd state park.

The dedication of the Rock Island Trail State Park took place on the northeast end of Windsor, near the high school, where the KATY Trail bridge crosses over the Rock Island Trail. The ceremony and unveiling of the sign featured speeches by state park officials, DNR directors and Kim, who is vice president of the Friends of the Rock Island Trail group.

"This has only come about with the team work of many, many people," Kim said of the state park's creation.

Kim is not a cyclist, she said, but has been on board as a rails-to-trails supporter since she watched the railroad ties

being taken up to create the KATY Trail. The 240-mile long KATY Trail, also a state park, is the longest continuous rails-to-trail in the country. Windsor is its highest point.

It was nine years ago, in 2014, that Kim bought three lots on Cherry Street, east of Casey's, in anticipation of the Rock Island Trail coming to Windsor. The next year, the property and has since had three more cabins built and moved there.

"When I put the fourth cabin down, I quit my job," Kim said. "This has been my fulltime job since 2018."

Cyclists who book the cabins every year include a group that come from Texas for a week and use Windsor as a base for cycling. Her she moved a small cabin to cabins also draw people who

visit Windsor for family reunions and weddings, to go hunting, to explore Amish country or just for a getaway. Windsor has two event venues — The Moment and Evelyn Valley Ranch, Kim said, which bring visitors to town, benefiting restaurants, gas stations, and conveninence and grocery stores.

### Frank's Fish Shack Brings Big Easy Alfresco To HWY 7

The sun is over the horizon, the hawks are staking out spots on the telephone wires and the flags are flying at Frank's Fish Shack, on Highway 7 near Tightwad.

It's the first full weekend in July, and Terry and Angie Carey are debuting the latest addition to the Shack's offerings- Breakfast Al Fresco. Their weekend Caiun-style seatood business opened at the end of March, and has been such a hit, they decided to add breakfast to the eat-on-site or take-out options.

It also fills a niche, as the steady stream of cars driving down to the Fish Shacks

Multitude Of Unsolved Mysteries

But the programs could have been called "What Mysteries Did We Uncover during the Demolition of the Western Auto Building?" For example, why was there an oven in the brick wall of the basement, and what was it used for? And why was brick used for the basement walls instead of rubble stone?

There is no mystery why the Western Auto block, two adjacent buildings on the corner of Windsor's main intersection, was demolished in October of 2020. The walls were bulging out, the fire escape stairs had rusted and fallen down, and the structure was showing its age.

Because of its significance in Windsor history, the demolition was documented by Walter Joe Moser, who took hundreds of photographs. Susan Luck, curator of the Windsor Historical Museum, spent long hours scraping pieces of wallpaper, main-

ly from the upstairs floor of 103 N. Main, which was used as a boarding house.

"There were as many as 14 layers of wallpaper," she

The buildings, on the southeast corner of the Windsor's main intersection, were taken down by a contractor, who instead of bulldozing it, had his crew take the building apart by hand and salvage as much of the lumber, bricks, ceiling tiles and windows as they could.

"Every board came out the same way it went in -one piece at a time," Walter said. The corner building, at 101 N. Main, was built in 1874 by James Kelly and Emond Bass, who built the Bass Hotel where the post office is now. Once one of the oldest two-story brick buildings in town, 101 N. Main had an open upper floor that was used as a meeting room, being the only large space in town except for the church. The building next door, at 103 N. Main next to the post office, was added in 1909. John Bowen of the Bowen Coal Company bought the corner building for the First National Bank that year, and put up the second building as an investment. Both were 22 feet wide and 100 feet deep, with 10-foot ceilings. The bank lasted through the mid-1930s. In 1941, Landmark Page 9





Best's Post as MIAA CEO Council Chair Adds New Opportunity for Service to Student-Athletes

Demonstrating his commitment to strong academics and opportunities for student-athletes, University of Central Missouri President Roger Best is in a good position to share his passion for both, not only through his position at UCM, but also as the new chair of the Mid-America Intercollegiate Athletics Association (MIAA) CEO Council. Best was elected to the two-year post that began July 1, 2023, adding yet another leadership role to a career that has already had an impact on college

athletes. The election of the council chair took place during the council's summer meeting on June 14. As chair, Best provides leadership for a group of university presidents representing 14 MIAA-member institutions from Kansas, Missouri, Nebraska and Oklahoma. The CEO Council is charged with governance of the MIAA conference through budget oversight, policy setting and future planning.

Best has been a member of the MIAA CEO Council since he became UCM's president in 2018, and has previous experience as the council's vice chair, a position he held for the prior two years. He is the second-longest tenured leader of the group, and has also served on the council's membership task force, risk management task force, and currently serves as the CEO Council representative to the newly created inter-conference Division II

Football Alliance.

"I am grateful to serve as chair of the Council and fulfill the duties and responsibilities that come with this position," Best said, noting these include leading at least two major meetings of the council each year. He will also work closely with the MIAA Commissioner as needed while assisting the CFO

Council in considering the priorities established and recommendations made by other conference committees, while adhering to new constitutional provisions for the MIAA Conference that were adopted during the council's January 2023 meeting.

"One of my roles as MIAA CEO Council Chair will be to help make sure we are following our new bylaws and constitution in terms of delegated authority," he said. "The new constitution marks a major step of the conference in delegating authority to our committees. My job as chair will be to make sure that any business that comes before the CEO Council conforms to the requirements as set forth under the constitution."

This won't be the first time MIAA Commissioner Mike Racy and Best have had an opportunity to work closely together. Long before he began serving the MIAA, Racy worked at UCM in a position that included Vice President for Law, Policy and Strategy and General Counsel. Best, who was then serving as Dean of the Harmon College of Business and Professional Studies, engaged with him in many discussions related to strategic planning and risk management. As Commissioner, Racy has led and instituted numerous strategic initiatives designed to promote a positive environment for student athletes, the MIAA, and all of Division II, and he was the driving force behind the recent creation of the Division II Football Alliance.

"I look forward to working with Dr. Best in this leadership role for the conference," Racy noted. "There has never been a more challenging time for the NCAA and intercollegiate athletics, and the MIAA school presidents are fortunate to have someone with Roger's financial and strategic management backgrounds leading our organization."

Best said the MIAA conference has undergone a number of changes such as the recent update of its constitution to mirror what is happening within the NCAA.

"I appreciate the work of Steve Turner (Northeastern State), the outgoing CEO Council Chair, in leading efforts the last two years that position the MIAA conference and our member institutions to be exceptionally competitive and well-regarded. My job will be to ensure our meaningful work continues while maintaining a positive working relationship with the commissioner and the CEOs, all with the overriding goal of ensuring the MIAA remains the premier Division II conference in the country."

He pointed out one of the immediate considerations for the CEO Council is related to membership. With Lincoln University announcing its plan to leave the MIAA conference, the council formally invited the University of Arkansas at Fort Smith to join the conference effective July 1, 2024.

According to Best, "additional future expansion must be a consideration for the MIAA given the rapidly changing environment in intercollegiate athletics."

Best's MIAA post gives him an opportunity to have his finger on the pulse of a changing climate in the world of collegiate athletics. As a longtime supporter of the UCM Mules and Jennies, this is a role he believes is important to students athletes and the university, especially with UCM being one of the founding members of the MIAA in 1912.

He pointed out the changing landscape in NCAA involves some institutions moving outside their conferences, particularly in Division I. It also encompasses issues that have been created by name, image, likeness (NIL) legislation that has trickled into all divisions of collegiate athletics, in addition to issues related to the transfer portal and health and wellness initiatives.

Best has taken this changing landscape in intercollegiate athletics to heart in his leadership at UCM, as well. Challenges that face the MIAA and the NCAA played an important role in the decision to hire new Vice President for Intercollegiate Athletics Matt Howdeshell. With the passing of Jerry Hughes, who served at this post 40 years, the university was tasked with finding someone who could help navigate the university into a new era of intercollegiate athletics.

"The strong work of our search committee really made my job both easier and more difficult because I was presented with a group of finalists who were excellent," Best said. "Among that group, Dr. Howdeshell stood out as someone who could bring significant experience, with drive, passion, relationship building, ideas and initiative to move us to even greater success among Division II institutions and ensure that we adapt successfully to the rapidly evolving environment that we find ourselves in today."

Taking a rare homegrown approach to the university's top leadership position, which led to opportunities to serve the MIAA, Best came to UCM in 1995 as an assistant professor of finance, and in the years that followed was promoted to full professor and served in various administrative roles including chair, associate dean, dean and vice president. Following three months of service as inter-For All

Now, with 28 years of academic experience under his belt, Best also continues to take advantage of opportunities to ensure UCM continues to lead and influence Missouri higher education. On July 1, he began his second year of service as chair of the Council on Public Higher Education, adding to a growing and diversified portfolio of active leadership roles through which he is able to serve students both in and out of the class-

### Poised to Help Missouri Deliver on HB 417 Promise

Creating a new "Upskill Credential" workforce training program, Missouri House Bill 417 will position the state's businesses to better address obstacles that impact their growth and profitability with assistance from institutions such as the University of Central Missouri.

An opportunity for businesses to train to retain, the new program established under HB 417 creates competitive grants to reimburse employers who provide training opportunities to upskill their employees with short-term industry-recognized credentials. This initiative is directed to small- and medium-size businesses, allowing them to sponsor their best employees to take courses that expand their knowledge and skill in high-demand jobs. The bill was signed by Missouri Governor Mike Parson on July 6.

"We are extremely grateful for the support Missouri Governor Mike Parson and our legislators who have made this opportunity possible. It is a win for the businesses where skilled employees are needed, and it is a win for the employees who have a new opportunity to expand their skill set and receive a high wage," said Laurel Hogue, vice provost for online learning and engagement at UCM. She added that opportunities for employees to advance in their careers and receive a better income also mean better quality of life for Missourians who benefit from this program.

HB 417 was sponsored by Representative Mike Henderson, R-117, Bonne Terre, Missouri. Recognizing the bill as an investment in the state's workforce, it has been supported by organizations such as the Missouri Chamber of Commerce. In an annual survey, the Missouri Chamber found 50 percent of all businesses cited workforce concerns as the most significant challenge to growth. Survey respondents noted that improving the availability of qualified talent is most important to profitability.

The Upskill Credential program is modeled after the extremely successful "Tech-Cred" program that was initiated in Ohio. More than 2,100 employers in that state have utilized this program to upskill thousands of workers, an effort which Missouri hopes to replicate. HB 417 authorizes the General Assembly to appropriate up to \$6 million a year toward the "Upskill UCM Poised Page 17



### **Looking Back:** No Mercy

The powerful Georgia Tech football team played Cumberland College in 1916. No one expected Cumberland to win, but the massacre was amazing. Cumberland had only 16 players and lost three players due to travel problems. The team stopped in Nashville to grab a ringer or two. It didn't help. The score was 126 to 0 at the half. Amazingly the Georgia Tech (GT) coach warned his team at halftime to not let up. "You never know what those Cumberland players might have up their sleeves." Some of the GT football players also played baseball and they had been beaten by CC last spring. The football game's final score was 222-0, a record that still stands. Georgia Tech did this all on the ground, not one pass was thrown. To be fair, the forward pass was still not popular. It was not a legal part of football until 1906. The first legal forward pass was Saint Louis vs Carroll College on Sept. 5, 1906.

In the blow-out game, the Georgia Tech coach caught a lot of flack for running up the score, especially when the press found out about his halftime 'pep' talk. The game and the coach were often referred to using the "Ole Shut the Gates of Mercy" phrase. But the coach went on to become very well known, and was responsible for many football 'innovations' including: games being divided in four quarters, the center snap going directly to the QB (before this, the center generally rolled the ball to his QB), and the first collegiate athletic dorm for football players. The show-no-mercy GT coach also devised the T and I formations that are still

used today. In 1935 it was decided to give an annual trophy to the best college football player in the nation. It became the symbol of football excellence. The trophy was named

for John Heisman. Yes, Heisman was the coach that 'Shut the Gates of Mercy' in 1916." Clearly, there was no mercy clock at that time.

A brief history of the

Heisman Award: It started out as the DAC (Downtown Athletic Club in NY City) but was changed to the Heisman after John Heisman's death. It started out as an award for the best football player east of the Mississippi, but it became a national award. The first winner was Jay Berwanger a HB, that was drafted but chose not to play in the young NFL. Many of the Heisman winners are drafted #1, but some go late: Herschel Walker was drafted #114, and Doug Flutie #286. Archie Griffin is the only twotime winner (1974-75). Not all winners are successful NFL players, a recent example would be Johnny Manziel. Plus, most winners are seniors, but six sophomores have won. Tim Tebow was the first sophomore, winning in '07. Manziel and Jameis Winston are the only two freshmen to win the award, (they used Redshirt years). Eight of the last 10 Heisman winners have been QBs. Only occasionally does the award go to a receiver. Charles Woodson has been the only defensive player to win ('97). Lamar Jackson is the youngest winner (age 19) in '17, and Chris Weinke is the oldest (age 28) in '00.

Which colleges have the most Heisman winners?: Notre Dame, Ohio State, and Oklahoma with seven. USC had eight but one was vacated. (Reggie Bush in '05). Bush and USC were sanctioned by the NCAA, Bush had accepted 'gifts'. The '22 winner was Caleb Williams, a sophomore QB from USC. Parents may be interested to know there is a High School Heisman Scholarship. They look for excellence in the classroom, the community, and on the playing field. Note:



town used to be 17," she said. "Now it's 75."

Kim delivers what visitors want: clean cabins, each with a full kitchen, a sitting area, and bathroom with a shower and bathtub, served by a 40-gallon hot-water tank. The original cabin is smaller, but the three new cabins each have two queen beds, a queen sofa bed and a roll-way bed can be added, Kim said, so can sleep up to seven people. Prices start below \$100 for two people per night.

Each cabin also has a front porch with chairs, and a patio table and chairs in the quiet, shady yard surrounding each log structure.

"I'm in the process of adding permanent fire pits," Kim

The Rock Island Trail State Park is a work in progress — it will eventually extend across mid-Missouri for what planners call the "next 144 miles." Spanning mid-Missouri, the Rock Island Trail will connect to the KATY Trail at the Dutzow trail head to form a 450-mile loop.

Some towns along the Rock Island Trail have already received grants to build the trail to state park standards, Kim said. The Rock Island Trail will go through Ionia and near Cole Camp in Benton County, through Stover, Versailles and Barnett in Morgan County, Eldon in Miller County and five more counties to the town of Beaufort, south of Washington and the Missouri River.

The Rock Island Trail used to be a line of the Chicago, Rock Island and Pacific Railroad, known as the Rock Island Line. The corridor connects more than 20 historic railroad towns, goes through three train tunnels and crosses bridges spanning three rivers —the Osage, Gasconade and Maries —plus Soap Creek. Plans call for the trail to connect to Union and then turn north.

On the west end, the new Rock Island Trail State Park goes from Windsor to Pleasant Hill. There is one unfinished section between Pleasant Hill and Lees Summit, Kim said, called the Greenwood Gap, but from Lee's Summit, there is a paved trail put in by Jackson County that goes to the Kansas City sports stadiums.

"We've been dreaming about this for almost 20 years," Kim said of a trail connecting the St. Louis area with Kangas City

with Kansas City.
Kim is from St. Charles,

Mo. at the other end of the KATY Trail. She loves that she can tell people she grew up close to the train tracks that became the KATY Trail, and now owns property a block away from where the KATY Trail passes. Kim's cabins are less than a quarter of a mile from where the KATY Trail bridge crosses over the Rock Island Trail.

Kim, whose maiden name is Aufner, said her "lodging roots" go back to her German great-grandparents, who had a gasthaus near Frankfort. She worked at a resort in Cheyenne, Wyoming, and also lived in Europe. Kim said she has lived in Windsor for 35 years, when she and her family moved back to Missouri to be near her mother.

Her two sons live in Windsor — one is an apprentice lineman and the other just bought the liquor store in town. After working at the bank, Kim was the Windsor city administrator for four years. In addition to her main job running the cabins, Kim said she has a side job helping her long-time partner working his herd of cattle.

The cabin business keeps her tied to Windsor, but when she travels, she visits other businesses that serve people who ride the KATY and Rock Island trails. She doesn't consider them competition, she said, but part of the team that serves visitors.

This is Kim's ninth season offering hospitality in Windsor, which with the creation of Rock Island Trail State Park, is gaining prominence as the "Crossroads of the KATY and Rock Island Trails."

Western Auto moved into both buildings, which became known as the Western Auto block. Dorothy Warren, who was at the meeting, worked at Western Auto and remembered that the loft in the basement was used to store bicycles after they were assembled, but that few people wanted to venture down into the basement.

To illustrate the changes in the corner building over 15 decades, Walter downloaded Sanburn Fire Insurance

maps from 1876 onward and had them printed out. Initials on the buildings denoted the types of business located inside. Some mysteries were figured out - "DG" stood for "Dry Goods," not Dollar General as Walter joked. "Milli" denoted a millinery shop, millinery meaning where ladies' hats were sold, plus items of clothing. One shop was labeled "Novelties and B.S.," but no one ventured a guess as to what "B.S." stood for.

When Windsor got piped water, the maps noted "D.H.," which stood for a double hydrant, Walter said, with two places for hose hookups, TH for a triple hydrant, and SH for a single. Earlier maps showed a cistern, to collect water that drained off buildings, in the middle of Benton Street.

"There were cisterns in every other building on Main Street," historian Glynna Morse said.

Nobody has suggestions for what resembled a pizza oven in the bank's basement brick wall was, or what it was used for. Walter questioned why bricks were used for the basement instead of rubble stone, but someone suggested brick was easier to install than fitting large stones, which required the skills of a mason.

The two buildings housed many Windsor businesses over the decades. The lower floor of 103 N. Main housed Vincent's Shoe Repair and Billy's Barber Shop, while an annex on 101 N. Main was the home of the Pines Douglas Cafe, where Tom Colwell remembered eating hamburgers. The back part of the building was also a tin shop, a feed and grain, and a hardware, grocery and harness shop.

There was once a printing business on the upper floor in the main part of the building, Walter said, and a wooden panel in the ceiling, like a trap door, may have been where the printing press was lifted through.

What posed no mystery was the hand-hewn crook, made by a blacksmith, which Walter salvaged. It was placed over a door beam and used to hoist sections of the furnace into the basement, he said. The building was originally heated by coal, as the coal box and shovel attested, but was later fitted with a gas furnace.

The 2-by-4 foot tin tiles from the 10-foot ceilings of

A final mystery: Walter had a 1940 photo of a crowd gathered at the intersection of Main and Benton. Breakfast is served from the smaller trailer, the Frank Jr. Fish Shack, which the Careys created for Olde Glory Days. They also hired a new employee, Brenda

Taylor, to work the breakfast shift. On the menu are New Orleans-style beignets, biscuits and gravy, and breakfast sandwiches — sausage and cheese, or sausage, cheese and egg, on fresh-baked biscuits.

Fresh is by-word at Frank's.

"We get up very early, at 4 a.m.," Angie said. "The biscuits are in the oven by 5."

The biscuits are big, and the breakfast sandwiches have been getting rave reviews. The beignets are cooked when you order them, and people tell Angie the beignets are lighter and better than the ones you get in New Orleans.

"And we're a lot closer," Angie said.

Frank's Fish Shacks, senior and junior, are located next to the Carey's house, 932 SE Hwy. 7, the second driveway after SE 901 Rd. on Highway 7 west of Tightwad. If the flags are out, the Fish Shacks are open. Hours for breakfast are 6 a.m. to 11 a.m. Friday, Saturday and Sunday. Lunch and dinner are noon to 6 p.m. Friday and Saturday, or until the fish sells out. The Careys get shipments of fresh catfish from the South every week, and cook it in cornmeal when you order. They have increased their catfish order, they said, so as not to run

The Careys started the business because they like to cook, and wanted to transition into retirement. Terry is a bricklayer. Angie designed the Fish Shack logo and does the marketing, and also works from home for Children's Mercy Hospital. The business name honors Terry's father, Frank Carey, who lived in Liberty, but was an ardent Truman Lake fisherman.

The Careys created the Frank Jr. Fish Shack to Olde Glory Days this year, and the venture was a success, Angie said.

"It was a lot of work, but it provided great exposure for the business," Angie said.

Last spring, the Careys hosted a field trip for Heather Wilde's students from Cornerstone Academy, whose end-of-theyear project was to create their own food-truck business and decide what type of food they would serve. The Careys fed the students catfish and fries,

Angie said, which the students seemed to enjoy more than the tour.

At the Hwy. 7 location, you can eat at patio tables and chairs with umbrellas, or around covered picnic tables. There's new gravel on the driveway and parking areas, with plenty of room for RVs or to turn around boat trailers.

### Things To Consider As You Feed Your Way Through The Drought

"Cattle producers are dealing with varying degrees of drought and forage resources," says Patrick Davis MU Extension Livestock Field Specialist. Some cattle producers have received adequate rain and are recovering from the 2022 drought through rebuilding forage and cattle resources. Other cattle producers have received limited rain and are continuing to deal with drought conditions from 2022 with less resources in 2023. Depending on which group you are in Davis discusses some tips and strategies to help cattle producers feed their way through the drought as economically efficiently as possible.

"Use a culling plan to reduce the herd stocking rate to match feed resources," says Davis. This plan should include which cows you plan to cull and when you plan to cull them based on feed resources. Also, consider the strong cow market when making these decisions. Cows that are open, and poor performing should be at the top of the cull list. In addition, cows that are old, thin or have blemishes such as structure, udder or disposition issues should be considered for culling. Davis urges cattle producers to plan to only keep cows that breed and calve annually, maintain adequate body condition, and produce an acceptable calf as efficiently as possible.



Savannah, Missouri, Man Arrested For Possession Of Child Pornography

The Missouri State Highway Patrol's Division of Drug and Crime Control announces the arrest of Matthew G. Raya, 38, of Savannah, Missouri. Raya was arrested on June 29, 2023, for possession of child pornography, following an investigation by the Division of Drug and Crime Control's Digital Forensics Investigations Unit. The Kansas City Police Department assisted in the inves-

tigation. On Thursday, June 29, 2023, investigators executed a search warrant at Raya's residence, located in Savannah, Missouri. During the execution of the search warrant, investigators discovered evidence to support Raya possessed child pornography on his cellular telephone. Raya is currently being held in the Andrew County Jail with no bond.

The Division of Drug and Crime Control encourages internet users to promptly report to the Patrol or local law enforcement anyone who attempts to engage in unwanted, inappropriate, or sexualized communications with children.

The above charges are mere accusation and are not evidence of guilt. Evidence in support of these charges must be presented before a court of competent jurisdiction whose duty is to determine guilt or innocence.

The Missouri State Highway Patrol reports the following 2023 July Fourth holiday statistics for the counting period of 6 p.m., Friday, June 30, through 11:59 p.m., Tuesday, July 4, 2023:

2023 July Fourth Holiday **Boating Statistics** 

Troopers worked six boating crashes, which included two injuries and zero fatalities. Troopers made 10 boating while intoxicated arrests. Four people drowned over the holiday weekend. Two of the drownings occurred in the Troop F area, one drowning occurred in the Troop A area, and one drowning occurred in the Troop C area. Troopers worked all four drownings.

Two people drowned on Sunday, July 2, 2023. James D. Roy, 56, of Kansas City, MO, was last seen near a moored vessel. It is unknown how Rov entered the water. He was not wearing a life jacket and did not resurface. Camden County Medical Examiner Crystal Lloyd pronounced Roy dead at Mimosa Beach. The incident occurred at the Lake of the Ozarks near the 43-mile marker of the main channel in Bollinger Creek Cove in Camden County.

Hamsa Mohamed, 41, of St. Louis, MO, drowned after jumping from a cliff on the right side of Big River. He attempted to float and did not surface. He was not wearing a life jacket. High Ridge Fire Department personnel pronounced Mohamed dead at the scene. The incident occurred at Big River near Rockford Beach in House Springs, in Jefferson County. The Jefferson County Sheriff's Department and St. Louis County Police Department also responded to the scene.

Two people drowned on Tuesday, July 4, 2023. A six-year-old male drowned when he jumped into the water onto a lily pad, went under the water, and did not resurface. He was not wearing a life jacket. Dr. Campbell pronounced the six-year-old dead at Lake Regional Hospital. The incident occurred at the Lake of the Ozarks near the 65.9-mile marker in Lick Creek Cove in Camden County. The Camden County Sheriff's Office and Edwards, MO, Fire Department also responded.

Carlos Antonio, 22, of St. Joseph, MO, drowned when he was swimming, walked off a ledge in the water, and never resurfaced. He was not wearing a life jacket. The incident occurred at Smithville Lake near Little Platte Swim Beach in Clay County.

2023 July Fourth Holiday **Traffic Statistics** 

Troopers worked 390 traffic crashes, which included 152 injuries and seven of the eight fatalities. The Kansas City Police Department worked the remaining fatality. Troopers also made 116 DWI arrests and 21 drug arrests over the holiday weekend.

One traffic fatality occurred in each of the Troop A, Lee's Summit, MO, Troop B, Macon, MO, Troop C, Weldon Spring, and Troop E, Poplar Bluff, MO, areas. Four fatalities occurred in the Troop H. St. Joseph, MO, area.

[During the 2022 counting period, 11 people were killed and 449 injured statewide in Missouri over the holiday in 1,069 traffic crashes. Troopers arrested 146 people for driving while intoxicated last year. Over the 2022 July Fourth holiday, there were nine boating crashes, which included five injuries and no fatalities. One person drowned during last year's July Fourth holiday. Troopers made 13 BWI arrests during the 2022 counting period.]

No one died in a traffic crash within the counting period on Friday, June 30, 2023.

Three people died Saturday, July 1, 2023. Timothy S. Hall, 37, of Grubville, MO, died when he lost control of the motorcycle he was driving, began to skid, ran off the left side of the roadway, and overed. The crash occurred on Missouri Route WW at Blackhawk Lane in Jefferson County. EMS personnel pronounced Hall deceased at the scene.

Fabian C. Henderson, 34, of Lilbourn, MO, died when the vehicle he was operating ran off the left side of the roadway and overturned. Henderson was not wearing a seat belt and was ejected. The crash occurred on Missouri Route MM north of Lilbourn. New Madrid County Coroner George DeLisle pronounced Henderson deceased at the scene.

A 13-year-old male died when the vehicle in which he was a passenger traveled off the south side of the roadway, down an embankment, and struck a field entrance before becoming airborne and overturning multiple times. The vehicle came to rest on its wheels on the side of the roadway. The crash occurred on U.S. Highway 136 west of Stanberry, MO. Dr. Dela-Cruz pronounced the juvenile passenger deceased at Mosaic Medical Center in Albany, MO. The driver of the vehicle and a second passenger sustained serious injuries in the crash. All three people were wearing seat belts. Gentry County Sheriff's Office, Stanberry Fire Department, and Grand River EMS also responded to the scene.

There were no traffic fatalities reported on Monday, July 3, 2023.

Five people died in traffic crashes on Tuesday, July 4, 2023. Ricky E. Nutzman, 70, and Susan M. Nutzman, 70, both of Falls City, NE, died when the vehicle he was operating traveled from the Missouri Highway 13 ramp onto eastbound U.S. Highway 36 and cut across both lanes in front of a commercial vehicle. The commercial vehicle braked but was unable to avoid striking the vehicle's driver side. Both vehicles then traveled off the north side of the roadway into the median and came to rest. Both of the Nutzmans and the driver of the commercial vehicle were wearing seat belts at the time of the crash. Dr. Dorsch

Credential Training Fund." A qualifying employer could receive up to \$30,000 in grant funding on the basis of competitive application process.

Offering classes for entry level as well as professional development. UCM is positioned to assist in addressing workforce concerns expressed in this legislation. This includes assistance for industry who want to help their employees earn industry-recognized credentials needed to become a Certified Nurse Assistant (CNA), work in Phlebotomy, serve as a Certified Medical Assistant (CMA), and several other high-demand areas. UCM also offers Hazmat certification, and certifications in trades such as Warehouse Distribution and Project Management. In Fall 2023 and Spring 2024, the university will offer pre-apprenticeship opportunities for positions in Plumbing, HVAC, and Electrical professions. Other important certification areas in which UCM can assist are Information Technology and Cybersecurity.

In addition to "Upskill Credentialing," HB 417 also includes the Intern and Apprentice Recruitment Act. Assisting small- and medium-sized employers, this act provides an income tax credit of \$1,500 for each intern or apprentice hired at a pay rate equal to or greater than the minimum wage, provided that the number of interns and apprentices employed during the tax year exceeds the average number of interns and apprentices employed by the business for the previous three years. This act becomes effective Jan 1, 2024, and the maximum tax credit will be \$9,000 per year. Interns and apprentices also must work a certain number of hours as stipulated by the

to better match limited feed resources," says Davis. Calves have been weaned as early as 60 days, but it is more practical for beef cattle producers to early wean calves at approximately 120 days. A successful early weaning program hinges on proper calf health, management, feeding and environment. If you are new to early weaning calves Davis suggest visiting with your large animal veterinarian and local MU Extension Livestock Field Specialist to discuss a proper calf management plan to make early weaning successful on your operation.

"When buying hay make sure you buy from someone you trust and evaluate employers in the healthcare it for nutritional value,"

says Davis. Like last year there will be a lot of poor quality hay sold. Therefore, it is important to evaluate the hay for nutritional value so that a proper feeding plan can be determined. If the hay is suspected to be high in nitrate have a quantitative nitrate test done in addition to the nutritive value test. Once the nitrate concentration is determined in the hay, feeding strategies can be developed to reduce potential toxicity issues.

"Try to buy feed commod-

ities in bulk to reduce cost, but make sure you can store and feed the commodities," says Davis. When buying bulk commodities to feed, make sure you have proper bin capacity or a barn that can serve as a commodity shed that will keep the commodities dry and out of the elements to reduce spoilage and waste. In addition, if you are buying wet bulk commodities make sure those are fed in proper time to cut down on spoilage, mold, and waste. Make sure proper equipment is available to mix and feed commodities in an efficient and timely manner. Evaluate the nutritive value of these bulk commodities periodically so that a proper feeding regimen can be determined to make sure the diet is meeting cattle nutrient needs. Compare bulk commodities on a price per nutrient dry mater basis and purchase the cheapest priced commodity to fulfill cattle nutrient needs economically.

"Use rotational grazing to save forage as well as allow pastures to rest and recover" says, Davis. Using electric fence to control cow access to grass reduces pasture overgrazing and allows pasture rest and recovery. In addition, forage is more efficiently grazed by the cow which means more forage is available for the cows to graze. Davis urges rotational grazing to be a permanent strategy in cattle operations to help build a better forage base which will lead to a more profitable cattle operation.


