

## Army Veteran Becomes Bona Fide Dog Trainer

On March 7, U. S. Army veteran Rebecca Price packed her car with clothing, bedding, kitchen items and her three-month old Dalmatian puppy, Percy. Leaving their home on Ohio Street in Clinton, Rebecca drove 230 miles to the Tom Rose School for Professional Dog Trainers in High Ridge, Mo., near St. Louis. There, she and Percy spent the next six months, living in a dorm apartment on the grounds, and spending almost every waking hour in training sessions.

"I got up at 6 a.m., and classes went until sundown," Rebecca said. "I would get a quick bite to eat, and then go back to training that went into the evening."

Due to the schedule, Rebecca and Percy made only a few trips back to Clinton, but at the end of July, finished the course and returned to Clinton, where Rebecca runs Dalmatia BnB, a "home away from home" boarding option for dogs. Now she is sharing what she and Percy learned at the Tom Rose School through "Board and Train," a three- week course of basic and ad-

vanced obedience training through a combination of group classes and private lessons.

The training prepares the dog to pass the American Kennel Club's Canine Good Citizen (CGC) test, for which a dog must exhibit good manners when meeting a stranger or other dog, walk on a leash through a crowd and sit, lie down and stay on command. Rebecca also breeds Dal- or matians — Percy is one of trasix puppies born to Oreo ar and Juliet, her adult Dalmatians, last year.

In addition to Board and Train, Rebecca offers Puppy Class, four sessions of basic training for puppies, in which they learn commands, socialization and CGC prep.

"If you are struggling with your dog's bad behaviors

or want your puppy to be trained in obedience, we are here to help," Rebecca said.

She also offers private lessons for dogs, either at her home or the owner's house, teaching basic or competitive obedience, therapy dog training or whatever the owner needs. Rebecca also offers Schutlzhund/IGP Tracking, which

In 1931, the International Shoe Factory opened in Windsor. Its payroll carried the town through the Depression and four more decades, but by 1985, its days were numbered.

"I was there when the door was locked and it was closed," Dorothy Warren of Windsor said.

Dorothy will share her memories of the last days of the International Shoe Factory, along with some mementoes, on August 12 at a reunion for people who worked at the factory, or had family who did. Hosted by the Windsor Historical Society, the reunion is open to the public, and will be held at the fellowship hall of Windsor United Methodist Church, starting with lunch at 12:15 p.m. Fried chicken will be provided. Those attending are requested to bring side dishes and desserts.

The Windsor Historical Society held a 90th anniversary reunion last August, marking the day the factory produced its first

shoes. The factory was on Colt Street, five blocks north of downtown, but was the center of economic and social life in Windsor for five and half decades.

It prospered during World War II, supplying 47 percent of the combat boots and military dress shoes for Russian soldiers. Boots were shipped out by train to St. Louis, where the company was incorporated.

The International Shoe Company had factories in other towns, and after merging with other companies, it became the largest shoe manufacturer in the county.

Government contracts for military footwear kept

the Windsor factory open through the mid-1980s. But in May of 1985, word came that the factory was going to be closed. By the end of June, the last orders had been filled, the machinery had been dismantled, and most of the workforce was gone. "It was the end of an era,"



combines tracking, obedience and protection, and AKC Scent Detection. Those became her favorite part of the Tom Rose curriculum, she said, because they were fun for both the trainer and the dog. Percy learned to detect a scent in a selection of boxes, along a long wall and among 100 items, indicating the item with either a pseudo-drug scent or anise by sitting.

Police officers brought their Malinois Belgian Shepherds and German Shepherds from around the St. Louis area to the school to train alongside the civilian dogs.

"There would be 50 police cars in the parking lot on the days we did scent detection," Rebecca said.

Rebecca said living at the school was an adjustment at first — the hardest part was being around people all the time, as her dorm apartment was adjacent to a training room. But she soon realized the students spent so little time in their rooms, it didn't matter. She kept in touch with her teen-age children in Clinton by virtual reality, she said, and her grown son came to the school and visited her.

As well as cooking in their dorm apartments, students got together for pizza or barbecues, she said, and she got to have dinner with Tom Rose, an author and celebrity in the dog-training world.

"He is soft-spoken and knowledgeable," she said. The training at the Tom Rose School was so intense, she had to get another Dalmatian, Arrow, to share the load with Percy. Then her female adult Dalmatian, Juliet, developed separation anxiety, so "Jules" also went to live at the school with Rebecca.

"I had to rent another room just for the dogs," Rebecca said, "so that I had some space to study."

Rebecca supports the Clinton Animal Shelter, and is volunteering her new skills by taking and training a shelter dog in basic commands. Her first suband more," Rebecca said. "They have set me up for success."

In addition to improving your pet's behavior around other people and pets, training improves your bond with your dog, Rebecca said.

"You learn how to communicate with them and speak their language," she said.

Continued from page 1 by Councilman Cameron Jackson, include: council approval to construct a timber-framed boiler building for the Aquatic Center instead of the much delayed blockstyle building originally planned; shelter houses, ADA parking and restrooms are complete at Hurt Park - part of the restoration project there; the outdoor pool-house is open and there have been many positive comments. There are still some minor things to complete at the Artesian Pool, but it will soon be complete.

Public Safety report highlights: Councilman Gene Henry reported, with the assistance of Captain John Scott of the Clinton Police Department, the software update needs of CPD. It was explained that the procedure manual, which other departments tend to have automatic updates for, is lacking at CPD. Although the start-up cost for the implementation of these programs (one is Lexipol for policy/procedure and the other is Caliber which allows for up-to-date reporting of police reports to other agencies), not having them is costing more in man-power and time than necessary. The council approved the purchase of both - Lexipol is \$51,000 to initiate and \$15,000 annually, and Caliber is \$100,000 to start and \$19,000 per year). The Caliber purchase will bring CPD into compliance of which they have been out of for many, many years. The council also authorized the donation of the surplus car (#7) which was reported to be in very poor shape, to the UCM Drive Course which CPD uses to train officers at, too (a mutual sharing of resources). The council authorized the purchase of a mass spectrometer to help CPD identify substances (i.e., drugs) without touching them. It will also enable holds of individuals charged without having to send off to a lab for verification, at least in the onset. A mass spectrometer was used recently as part of a departmental sharing from Warrensburg's PD to help apprehend an individual selling drugs near a school here in town. There was discussion about including Henry County in the purchase of the piece of equipment, but ultimately it was decided that it could be purchased (\$30,000) using American Recovery Plan Act monies and

Bill No. 2023-22, an ordinance providing for the submission to a vote of the people the question of a local parks sales tax was read (first reading approved). Also, the first reading of a transportation sales tax question (Bill No. 2023-23) was held and approved by the council. A small discussion about the approval (by the state of Missouri) to authorize for a public safety tax was held, however, it was suggested that it not be an issue on the November ballot so as to give folks time to learn about it (the suggestion of Fire Chief Manuel). A Public Safety Tax was previously a forbidden territory for public entities.

New Business for the city: the first reading of Bill No. 2023-19 was held which addresses pertaining to a code of ethics for the ATS program (this is a requirement).

There was no closed session as expected at the beginning of the meeting (adjourn at 7:30 p.m.).

ject was Jazzy, who was uncontrollable on a leash. In three weeks, Rebecca taught Jazzy to respond to sit, down and recall, and to walk calmly on a leash. Jazzy has been adopted by a family with two small children, and Rebecca said it was heartening to learn that even the youngest girl can walk Jazzy on a leash without the dog pulling.

Rebecca is getting another shelter dog to train, she said.

On August 19, Rebecca and her family will return to the Tom Rose School for a graduation picnic, where she will receive her professional certificate. To graduate, students had to teach their dog to perform a trick. Percy learned to do an "orbit," which means the dog walks backwards in a circle around the owner, Rebecca said. Percy also learned to wipe her paws on a mat.

Arrow learned to jump over Rebecca's arm, a prerequisite to jumping through a hoop. Dogs can also be taught to give a high-five and do a "handstand," balancing on their front legs.

Tom Rose is the author of "Dog Training with the Touch," "Training the Competitive Working Dog," and "Dogs That Love and Protect." Rebecca said she was originally motivated to go to the Tom Rose School to train a protection dog for a friend who had experienced domestic violence. Attending the school changed her life, Rebecca said, and although it wasn't easy, she will be forever grateful to the instructors for the experience.

"This profession requires discipline, commitment, the ability to problem solve

pavement work is to be delayed because the projects came in about \$300,000 each over what was anticipated. Both will be put back out to bid. Council Gene Henry said he was disappointed that the drive related to the project, but which is under city purview, is not complete. He said the exit onto Business 13 (near the Everhart store) is in very poor shape and "give the city of Clinton a black eye). It was discussed that the project be completed without regard to the timeline for the other paving projects and will be on the Public Works

agenda. Other Public Works matters discussed/resolved at city council: the upper level pump repairs are complete; four hoists are needed to be inspected (as they are annually); there was an operations audit at Waste Water; all monitors have been installed at the lift stations, the most recent (and final one) was the Deer Creek one. Also, a request from the Stoneridge Home Owners Association to be annexed to the city was discussed. The request is due to pressure from the Department of Natural Resources to significantly improve their water filtration system and bring their waste water systems up-to date. It was discussed that the extra waste water would not be a problem capacity-wise for the city, but there is still discussion about whether the roads would stay private or become part of the city's responsibility. Early indications are that the city will try

shared with other agencies (like the Henry County Sheriff's Department) as warranted. The final portion of the report included sharing that the new fire truck will be officially placed into service on August 3.

Councilman Wilson reported the Finance Committee's findings: The first reading of Bill No. 2023-21 was held and approved. The bill establishes procedure if it is found that there is a conflict of interest for officials. Resolution 10-2023 regarding a lease agreement at Gerhart Industrial Park (which has been in place since 1983) was approved by the council. Mayor Carla Moberly complimented all the city department/agencies for their work after the recent severe storm. She deferred the floor to Fire Chief Mark Manuel after the nice words: Chief Manuel told the council he was worried about the lack of manpower per shift the fire department is experiencing (and has been experiencing for some time). He had tracked that only 86 of 213 days this year the department had full coverage on shifts. There were four structure fires in July alone and there were four heat related injuries to firefighters during that time as well to which the ambulance had to respond. Chief Manuel said he attributes all of those to undermanned shifts. It is a situation in which he fears something worse may happen to one of the responders if not corrected.





The agenda was approved as presented.

The minutes from the Thursday, July 27th, 2023 meeting were read; Commissioner Lawler made a motion to approve the Commissioner minutes. Fosnow seconded the motion, motion carried.

Expenditures from the following were approved to be paid: Law Enforcement Fund, 27th Circuit Treatment Court, C o u r t Administration, General County Government, Collector, Assessor, Administrative Handling Cost Fund, Prosecuting Attorney's Training Fund, Inmate Security, Road and Bridge, Law Enforcement Department, Prosecuting Attorney, County Clerk Buildings and Grounds, Victim Advocate, Employee Benefits

The Commission discussed the narcotics analyzer that the City of Clinton and the Prosecutor's Office wants to purchase. Commissioner Lawler shared of some research he had done on the machine and its capability.

Commissioner Fosnow shared of a conversation he had with the Mike Briggs of the Windsor Special Road District. The conversation was centered on CART rock contracts.

Commissioner Fosnow also shared of a conversation he had with Kenny Price in regards to tow service dispatch calls from the 911 center. Commissioner Fosnow shared that he doesn't have any control over 911 Emergency Communications. He was referred to visit with them. Clerk Rick shared a solicited proposal to repair the roof of the Emergency Operations Center on Washington St. The estimate came to \$27,119.00. No

action was taken. Commissioner Fosnow shared that he met with Gary Scott to discuss a log jam on Big Creek causing the issues on NW 1101 Rd. At 10:00, the Commission conducted a bid opening for the purchase of a Time Clock Management and Scheduling software for the Sheriff's Office. Only 1 bid was received, from Tyler Technologies. The bid totaled. \$33,760.00. After brief discussion, Commissioner Lawler made a motion to purchase the software, Commissioner Fosnow seconded the motion. The motion passed with a roll call vote of Lawler – yes, Fosnow – yes, and Stone – absent. Tina Redding, Deer Creek Township Board Member met with the Commission to discuss the county's CART contract. She provided documents that outlined the final costs for the 2023 contract for her township. She shared that rock had increased 50% over 2019's prices, and that hauling had increased 80% over 2019's prices. She requested that the Commission allow for additional funding in 2024's budget for CART rock distributions to townships. Tina also shared that the township has been busy getting fallen trees removed from the roadways, due to the Sunday storms. A return call was made to Megan Malott to discuss working with the county to remove the log jam on Big Creek, in Big Creek Township, which causes a backup and floods NW 1101 Rd in Bogard Township. She shared that she has made contact with numerous agencies in her research for assistance. Commissioner Fosnow shared that the county would be replacing the 2 bridges on NW 1101






