We're All Builders: Family Turns Property Into Camping, Music Spot

In 2002, Craig and Christy Pattison moved to a house just north of Urich, off Hwy. B. The house, built in 1908 by Urich's doctor, L.L. Smith, sits on 60-plus wooded acres, with a big field behind it that slopes down to a creek.

After they made an offer on the house, the Pattisons and daughter Tess went to look at the property again. They were sitting on the rise overlooking the field, Christy said, admiring the view, when Craig said, "This would be perfect for an amphitheater."

"Of all the times for Tess and I to do it, this was the one time we agreed with him," Christy said.

So once the deed was signed, the family started renovating the old house and creating Craig's vision. In 2004, they built a large covered stage facing the field, to make the wooded acreage into a destination for concerts and events. Called Cedar Hills Amphitheatre, the venue is 45 minutes from Kansas City, where it is probably more well known. People come to Cedar Hills for concerts, weddings, company par-

ties and special events like the recent BikeFest.

"It's a place to get out of the city and relax," Christy said.

Creating Cedar Hills has been a family project, Christy said. Craig used to build log houses, she said. Daughter Tess Pattison-Wade, who handles

the marketing and bookings, built her house near theirs on the property.

"We're all builders," Christy said.

Using recycled or donated materials, they added a 30 by 60-foot covered beer garden in 2005. They also created 28 tent campsites with lights and show-

er houses, and built two "glamping" tent platforms.

The Pattison used to hold a two-day band concert at Cedar Hills every July, Christy said. They called it the Bogart Music Festival, loosely named after the township they live in. It grew to a dozen bands, she

Contractor Is Classic Act With Inspiring Life Story

After Tim Fields graduated from college, he went to work in banking and insurance. He didn't like the job, he said, didn't like having to get dressed up every day, and especially didn't like the figure on the paycheck he took home.

So when his friend, Dustin Doll, called him and asked him to come work for his construction company, DHL, Tim quit his job that night. The next day, Tim got into a truck and drove 14 hours to Columbus, Ohio, which had been hit by a storm.

"It was life-changing," Tim said. "In six weeks, I had \$80,000 in payments in the console of my truck."

That was in October of 2006. When he quit his banking job and went to work in construction, Tim was married and had two children, 6 and 8 years old. And anyone can do it, he said.

"It was me and a truck and a will and desire to change my life," he said. "I've never looked back."

Since then, Tim has given

up storm chasing, he said, which doesn't have a good reputation. But when a city is hit by a storm, usually there aren't enough companies available to do repairs that need doing, he said. Having workers come into town means that people get their homes repaired in a timely manner, he said, and their home insurance covers the bill.

Tim formed his own company, Classic Contracting, so is now his own boss. His mission: to let other people know that they are motivated and willing to work hard, they can change their lives like he did.

"So many people are one skill away from making the jump to construction," Tim said.

The crews that work with him do roofing, siding, windows, gutters, flooring, sheetrock and electricity. But Tim is the only employee of his company, he said. There are no "sales guys," just him, who he describes as the "corporate entity" and "boots on the ground." He created the brand, does the marketing, meets the customers, likes to work alongside the crew, and

handles the billing. Classic Contracting does jobs all over Missouri, he said, and some in Kansas, and is the only company he knows of that operates this way.

"We can build a house or fix your garbage disposal," he said. "We built a truck stop, and helped build a hotel."

He is a preferred contractor with insurance companies, and is called to make repairs on roofs damaged by hail, wind and rain, and as well as by fire and flood

damage.

Tim, 43, is familiar with the vagaries of Midwest weather. Born in Northwest Arkansas, he moved to west-central Missouri when he was a child. His grandparents had a farm in Garden City. His mother Donna Fields, now lives in Urich. Tim attended Sherwood elementary and graduated from Sherwood High School in 1999, then earned several degrees at what is now the University

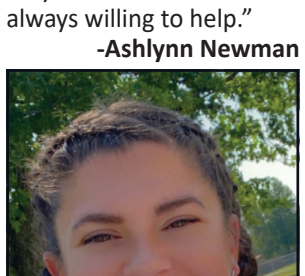

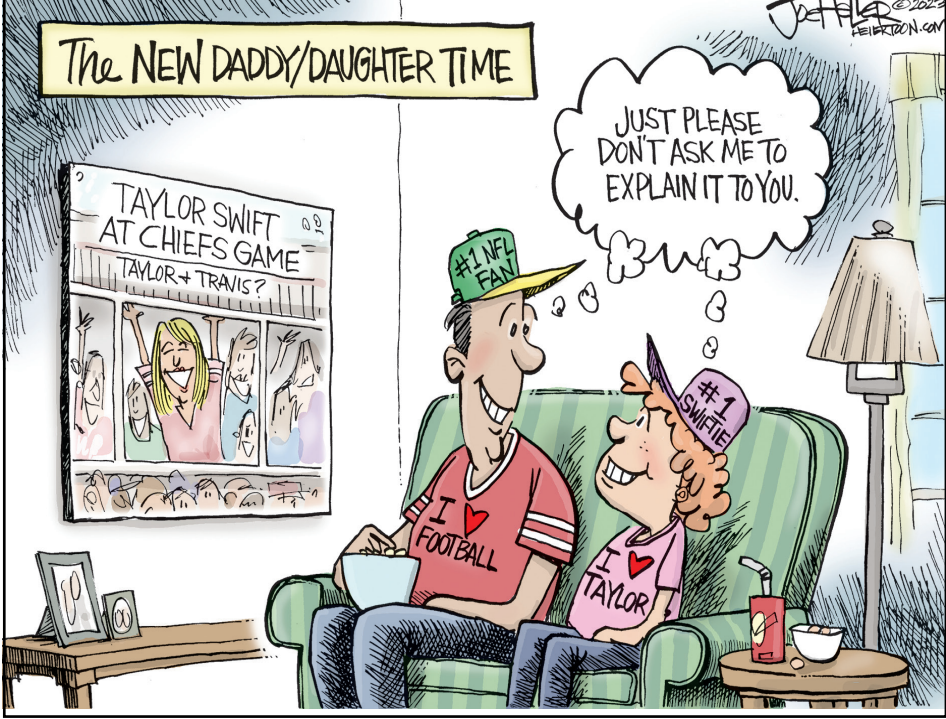

said. The event schedule took a breather during the pandemic, Christy said, but they had plenty of work to do on the property. The Pattisons built hiking trails along the tree line and bridges across the creek, she said. There's a place where you can cross the creek on a log, Christy said. Up the hill, there's a pond for fishing and swimming.

They added onto the beer garden, and built a second stage next to it, with a dance floor and firepit, where they will hold the Chili Cook-Off, coming up on October 14. Since it's near Halloween, they'll have games and treat bags for children, Christy said.

Cedar Hills starts out the season every spring in May with a fish fry and shrimp boil. It concludes in October with the Chili Cook-Off. Cooks can enter for \$5, with the winner getting the pot. Attendance for the general public is free. In addition to games and candy, there's the chance to win one of 20 bicycles the Pattisons are giving away.

"We'll have a big pile of leaves for children to play in," she said.

Barton Red of Leeton, who considers himself Cedar Hill's "house band," will play country and a mix of music. Events usually end with everyone gathered around a fire in the fire pit in the evening, Christy said, with friends playing music. "We'll have hot dogs to roast and marshmallows for s'mores," she said.

Last Sept. 15, Cedar Hills Amphitheatre was base camp for Bikefest, put on by the MOBike Federation. The ride featured 90 miles of paved and gravel roads in Henry County north of Urich, Christy said, and is on the calendar for next year.

This fall, their daughter Danielle Cooper, who lives in Oklahoma, is coming up to put on a bonus event on October 20. Called "CroboterFest," it's a cannabis-friendly educational weekend with live music, camping and speakers. Check the website, cedarhillsmusic.com, for admission and tent camping fees.

The field where the Pattisons sat 21 years ago to admire the view is now grass, but was overgrown when they bought it, Christy said. They cleared it, and plan on turning the 9-acre field into a bee and butterfly habitat.

Other plans call for adding a screened-in kitchen onto the beer garden, and

screening-in the beer garden, she said. For the Chili Cook-Off, the area next to the beer garden will be set up with three long tables and have electric plug-ins, she said. In addition to bringing entries in crock pots, chili cooks usually have crackers or some kind of snack to eat with the chili. They'll also be a dessert table, and people are welcome to bring their own drinks. She'll have plastic cups, she said, as she discourages glass in the venue.

Cedar Hills also has a fish fryer, five-foot-long barbecue smokers and barbecue grills. The Clinton Shriners used to hold pancake breakfasts at Cedar Hills, Christy said.

Future building plans include building tree houses. Christy's thinking of a large one to accommodate parents, with a ramp bridge connecting to a second smaller tree house for children. Craig ran a tree service, clearing utility right-of-ways — the logs holding up the metal roof of the beer garden were old log poles from Osage Valley Electric Co-op. The tops of the picnic tables were made from doors, the beer garden bar was made of butcher block salvaged from a K.C. school district, and the swing is made from cedar trees on the property, Christy said.

Christy grew up in Kansas City, but after she married, she and Craig lived on a ranch near Huntsville, Ark., overlooking the King's River. She had always liked the area north of Urich, however, where a cousin lived. So when the Smith property became available, Craig said "I'll go up and buy it for you."

Now the Pattisons are busy maintaining their Cedar Hills acreage. Craig mows the big field, and Christy weed-whacks and stains wood. On past birthdays, Craig bought her a stump-grinder and a red tractor, she said.

Craig is partial to his golf cart, which he rides around the property, doing a "Chisum," John Wayne's name in a movie in which he always made reconnaissance rides around the ranch. Both Christy and Craig love the peaceful feeling of their property, and want to share it with others.

"It's our staycation," Christy said.

As a family, the Pattisons plan what events they want to hold, she said.

"It takes a lot of time to put an event together,"

Christy said, "but it's so much fun."

of Central Missouri. His goal now is to be everybody's favorite contractor, he said, so that when you see his hat, you have a positive response.

"It's easy, when you do what you say you are going to do," he said.

A combination businessman and community cheerleader, Tim makes videos everywhere he goes, posting them on Facebook or Twitter. A video on the Elite Billiards Hall and Alehouse, a family recreation center that his sister, Tabettha Jamsek, and brother-in-law are creating in Clinton, got thousands of likes, he said.

"Facebook seems to be more oriented to what is happening in the community," he said. "When I post on Twitter, I get responses from all over the world."

His long-range plan: to run for governor of Missouri in 20 years, and channel his enthusiasm and energy into helping people. He figures if he keeps posting videos for the next two decades, his face will be familiar to most people.

Making a change in the way politics operate in this country is his goal. Two things he thinks are important: Sunday chicken dinners, and valuing your family.

"It just might make a difference," he said.

After changing his job in 2006, Tim said he spent the next ten years trying to get other people to see the world in the way he sees it.

"You don't have to be stuck in a job you don't like," he said.

approved.

A personal appearance was had by Rolland Peck — who stated a complaint about the "rough road" conditions of Vansant Road. "The whole road needs to be resurfaced," he told the council. It was explained to Mr. Peck that Vansant had recently been declared a major connector road (a road that connects one highway to another) and it has opened the opportunity for grants for repairs/reconditioning for it. "It's on the radar," said Carla Moberly.

Joel Long, Regional Airport Manager, reported to the council. "There is a lot going on [at the airport]," said Long. The airport received a couple of very important grants which are being used on fairly large and important projects: the runway rehab project (which will allow the runway to accommodate jets), and the airport's terminal project, which has not started but will soon. It was noticed that local contractors will be doing the project — which Mr. Long thought good for the city in general.

Councilman Roger House gave the Public Works report. The request for closing the square on October 28th for the "Scare

Fair" was approved. As mentioned above, Vansant Road was designated a major collector road — which should help the city obtain grants for that road. The council approved the city contributing \$169,000 to the OakStar Drive project (which had been discussed at a special council meeting). Also: MoDOT is starting its lane-work soon centered mainly around improvements at the north and south junctions.

Public Works reviewed a map that designated ditches and areas the city mows — following up on a request from a previous council meeting where a citizen requested a ditch be mowed by the city. The next step is to develop criteria for determining which things should and should not fall under the city's responsibility.

The Hurt Park renovations are continuing and are nearly finished. The slide that was ordered for the park should be here in six to eight weeks. Final work at the Artesian outdoor pool is being completed, too.

As mentioned at a previous council session, the city is exploring external management for its aquatic centers: a meeting was held with Midwest Pool recently to that end. The company has requested more information from the city's Park and Rec staff. The city is now looking to see what the budget might allow for outside management operations of the pools.

The bid to relocate the boilers and equipment is

being revised. Be advised: the indoor pool will have to shut down for approximately two weeks to make this happen. Tentative schedule for that to happen is late October. Also, a new water line will be installed (at no cost to the city) at the Antioch Park Urban Conservation Trail. A new ADA parking is being planned as well.

At Waste Water: issues with the SCADA system continue to occur without resolution. Work to resolve the problems is ongoing. The Waste Water Plant is also seeking a different company to perform semi-annual inspections on critical equipment. Manhole inspections are complete and the final report from those will be included in the plans for the I & I (Improvement plan for Waste Water). The council approved a stand-alone line from spectrum internet to the Waste Water Plant — mainly because of the need for reliable internet access considering the computer systems at the plant.

It was reported that the manhole access adjacent to the Henry County Jail had multiple non-flushable items in it including e-cigarettes and other materials. The jail was informed of this for corrective measures to be put in place.

The MoDOT grant reimbursements for the ATS program are now up to date (through August). Also, Community Development Director Chuck Bailey is working on declaring the structures at Fourth and

Jefferson and at Fifth and Oak Streets as dangerous structures (to get the demolition process in motion).

The Public Safety report was given by Councilman Gene Henry. He reported that the Clinton Fire Department received an opportunity to apply for a grant in the amount of \$20,000 for the purchase of new radios. Recall that the Fire Tax was for apparatus and not equipment. The council gave the go-ahead to apply for the grant.

The first and second readings for Bill No. 2023-35 were held (agreement with Westport Construction regarding the airport terminal project): the council approved the bill. It was noted there was an increase to the airport association from \$105,000 to \$150,000. The last raise to the association was in 2013. Bid openings for the Commerce Drive Extension will open October 26.

The Mayor had no report, however, City Administrator Christy Maggi reported there were two meetings held in regards to the Stoneridge Homeowners Association (about the sewer system for that subdivision). The HOA has obtained an engineering firm to compare costs of upgrades versus tying into the Clinton sewer system. She also reported that work at OakStar Drive is scheduled to start October 16th and it hoped will be done by the first week of November.

The Clinton City Council adjourned at 6:40 p.m.

Our services began with the beautiful hymn, "Joyful, Joyful, We Adore Thee".

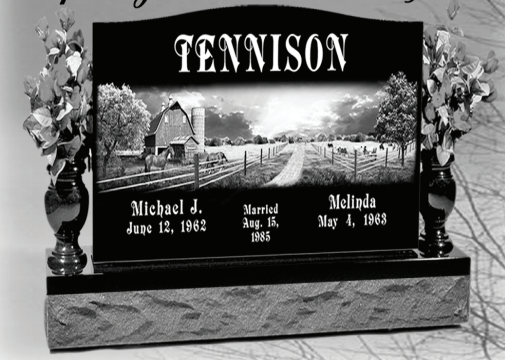

New this year is Luna Umbra, a Butler winery that originated when a group of friends were enjoying a bottle of Traminette under a full moon, according to owner Joanne Godfrey. Joanne's business partner, winemaker John Nelson, will also be at the Clinton Wine Stroll. Joanne said she hasn't chosen what wines they'll bring. "We will have slushies," she said.

John makes a Norton from Missouri's native grape, a Chambourcin, also a red wine, plus Luna Umbra's signature wines, Full Moon Red, Ruby Red and Super Pink Moon. Joanne and John will be offering samples at the Clinton Daily News and T-Shirt Factory office, 104 S. Main, on the east side of the Clinton Square.

Joanne describes the Luna Umbra tasting and sales room in Butler as "rustic urban." It's located in an historic building on the southeast corner of the Butler Square, at 1 W. Dakota Street, and is open on Fridays, noon to 8 p.m., and the third Thursday of the month from 5 p.m. to 8 p.m.

Returning for the third year to the Clinton Wine Stroll is Headquarters Winery and Mercantile in Harrisonville, which will be serving samples at Cummings Men's Wear, 111

W. Franklin. The winery is owned by Sonja Griffith-Davis and Dan Davis, a Belton police officer, who met in 2015 at a memorial for two Kansas City firefighters who died in an arson fire.

"After Dan and I met and connected over the Fallen Heroes Motorcycle Ride, we fell in love, and decided we want to create a place that would honor our first responders and military," Sonja said.

Dan and Sonja started making small batches of wine in 2017 in a wine bar in Lee's Summit, she said. They married in 2018. In 2021 they lost their lease in Lee's Summit, and the next year, moved their winery to 100 Pearl St., a 130-year-old building on the town square in Harrisonville.

The current building has 9,000 square feet of space and houses 54 vendors on the first floor, Sonja said, including cheeses from Osceola Cheese and meats from Kurzweil's. They use the underground climate of the lower level to produce 18 varieties of wine, sourcing grapes from all over the world, she said. They make everything from rieslings and zinfandels to Argentine malbec and merlot. Their current seasonal is Pomegranate Pinot Noir.

They are bringing six wines to the Clinton Wine Stroll to select from.

"We will also be bringing our Salted Caramel Sangria that is a limited release," Sonja said.

More than a dozen vintners, mostly from smaller craft wineries, are expected to showcase their wares at the Clinton Wine Stroll, which is organized by Clinton Main Street. Returning from last year are St. James and Meramec wineries in St. James, Linwedel in Branson, and Baltimore Bend Vineyards from Waverly, a town on the Missouri River near Higginsville.

Public House Brewing from Rolla and DogMaster Distillery in Columbia will add some variety of spirits to the mix. Also returning are Giggling Grapes and Summit Lake wineries from the Jefferson City area, and DeLaney Vineyards in Nevada.

Locally, Al Bottling in Clinton will be offering samples of their CRAVE ready-to-drink cocktails, and Red Fox will be pouring samples of vintages made at their winery near Urich. Primitive Old Crow and Winery will have their beer bus parked on the Square, Amanda said, and eMorBe Emporium, 102 N. Main, will have wine slushies for sale.

Primitive Olde Crow and Winery is also having an after-stroll party from 5 p.m. to 7 pm. at their property just east of Clinton, off Hwy. 7 S. at 32 SE Hwy. AA. Olde Crow has an event barn, Mercantile and brick-oven pizza house.

One of the last strolls of the season in the area, the Clinton Wine Stroll starts at 2 p.m. and goes until 5 p.m. Registration is on the

first floor hall of the Clinton Elks Lodge, 115 W. Franklin. Each participant receives a glass and a map of stores around the square hosting wineries.

All the V.I.P. tickets have been sold, according to Amanda Johnson, Main Street director, which entitle holders to start making the rounds an hour earlier.

Regular tickets are \$20 in advance, either online or in person at the Clinton Chamber of Commerce, 200 S. Main. Tickets are \$25 at the door on the day of the event.

Sonja Griffith-Davis said her team at Headquarters Winery and Mercantile go to eight to ten offsite events a year, and that Clinton is one of their favorites.

"They know how to put on a very successful event that is widely popular with the community," she said of Main Street.

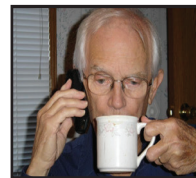

Other training at the Fire Safety Programs included information about smoke detectors and deciding upon a designated safe meeting place at home. Students were reminded that smoke detectors can smell smoke. Every house should have smoke detectors, and they should be placed high on the wall in the home because smoke rises. Firefighters also emphasized that smoke detectors should be loud enough to wake one up, the importance of changing the batteries twice a year, and checking the expiration date on the back side.

The preschool-2nd grade students were instructed by CDF Firefighters concerning what to do if they are in bed and their smoke detector goes off. Sleepy Sammy demonstrated how to check their bedroom door for heat, crawl close to the floor, or to open their window

and yell for help if the student's bedroom is on an upper level.

Older elementary students were treated to a humorous skit during which they met "Chef Fry" all the way from Oceanside, CA. Chef demonstrated how to make "hyper roasted duck." This humorous demonstration focused upon kitchen safety utilizing both the oven and stovetop! Students were instructed that if a kitchen fire occurs in their home while cooking to get out of their house, call 911 and leave the oven door closed!

Volunteer Firefighter Jack Wright (CCA graduate of 2022) concluded each session of the programs presented by demonstrating the protective gear worn by firefighters. All students received fire prevention materials to take home and share with their family.
