If these are a few of your favorite things, you'll want to be on the Clinton Square this Saturday, Nov. 11, for the 6th Annual Merry Main Street.

From 10 a.m. to 4 p.m., stores on and near the Clinton Square will be offering sugar cookies, snickerdoodles and snacks, along with cups of spiced cider or hot cocoa, to customers. Reception Marks Major Gift Giving By Truman Lake Community Foundation

The Truman Lake Community Foundation handed out its fall grants, totaling over \$30,000, to 13 area organizations during its donor appreciation event last week. The Foundation awards grants to community organizations in the spring and fall and awarded \$33,000 in grants earlier this year.

Fall grants included \$3,100 to the Clinton Fire Department for radio upgrade equipment, and \$2,000 for a technical upgrade to help the Inspector program for homes and buildings to do online reporting. The Golden Apples Senior Community Project in Appleton City received \$3,000. Henry County Library was awarded \$500 to upgrade equipment used for kids who call in to hear a story over the phone. The Clinton School District received \$1,600 to expand its interactive math program. Lowry City Community Betterment

The Sherwood Cass R-VIII School District received \$600 to help stock its closet for needy kids. \$4,500 was given to the Nancy Calvird Shoe Fund for underprivi-

leged kids. The Angel Tree, in Clinton, received \$2,500 to use for gifts for needy families. The Clinton Boy Scouts received \$4,900 to help scouts that can't afford summer camp. The Birthday Blessings program was awarded \$5,000 to help foster kids celebrate their birthdays. And, \$500 was awarded to a Clinton

school (name unknown) for a field trip.

The Foundation president, Jim Cook, said that he is committed to his organization, and that Americans in general are generous people, but it is so nice when philanthropic people donate to the local community.

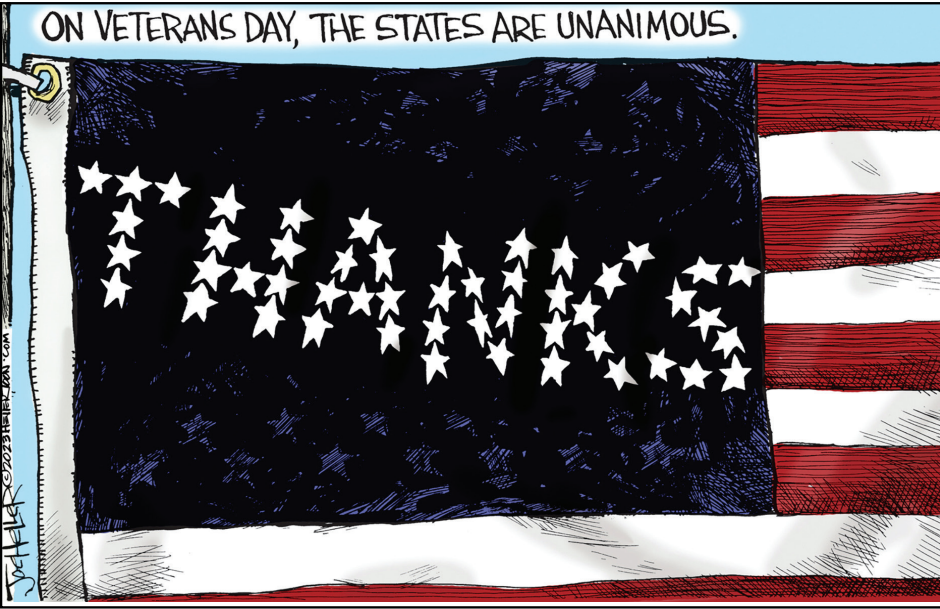

MMML, for short or long-term relationship. Must like children. What the ad, which ran for several weeks last summer, did say: Wanted to buy or rent, a male llama to breed six female llamas.

A Vietnam veteran, Lawrence has kept llamas for 30 years on his 80-plus acre farm north of Leeton. He's also had a variety of exotic species on the farm, he said, along with cattle and horses.

male cria, but also to the other livestock. "He was mean to the cattle," Lawrence said.

"I had a 2,000-pound bull he run off and he killed a blind bull calf— run him to death. And I had a cow he drove into the pond. "I sold him."

The fact that there seems to be more alpacas in the area than llamas makes his effort to find them a mate harder, he said. Llamas and alpacas are both Lamoids, so can mate, and are domesticated members of the Camelid family.

in textiles for six millennia, the coarse outer fiber for rugs and rope, and the undercoat, which has a finer texture, for garments.

Lawrence also once had large, long-necked birds —emus and ostriches — on his farm, but he thinks they became the target of neighborhood youth. His Jacob sheep, the kind with four horns, were history after they ate the bark off of one of the biggest apple trees in his orchard, killing it.

Lawrence is more philosophical about the possibility that the pond on the farm might dry up. As he says, that's Missouri. He has lived in Missouri all his life, he said, other than when he was in the military, when he was sent to Texas. He didn't like the state because the climate was the same most of the year.

"It was drab," he said. "I like Missouri because the weather is always changing. You never know what's coming."

He's already sold off some of his cattle, he said, and if the rain doesn't arrive, the rest of the livestock, including the llamas, will go. If the pond does survive, he'll continue to hope that someone out there has a male llama that he can buy, or at least rent for two or three months.

"Then they can have their male llama back," Lawrence said.

Even if the pond dries up, Lawrence may want to rethink selling the herd. National Llama Day is Dec. 9, and has been celebrated in Canada since 1932, the year a drought in Manitoba wiped out sheep and other livestock. But not the llamas.

"Application for one of our fall grants is open online during the month of August to 501(c) organizations, and is advertised in the newspaper," said Cook.

"In September a five-member committee goes over the applications and recommends grants to those organizations requesting funding for programs that best serve the communi-

ty. Then the 15-member Foundation Board votes for funding the grants. The same system is used for grant awards in the spring." Cook stated that the Foundation Board is made up of volunteers and is an umbrella for 130 or 140 groups who collect funds to help in the community. Some of these other groups are set up by organizations and families, and many offer scholarships.

for gifts and holiday parties. Santa, the Grinch and Cindy Lou Who (too!) will be at the Holiday Mart, as well as local vendors selling unique, hand-crafted gifts, and there'll be hot cocoa for the kids. Primitive Olde Crow is located just east of Clinton on Hwy. 7 S. at SE Hwy. Aa.

On Nov. 24, Santa arrives on the back of a fire engine at Clinton's 18th Annual Lighted Christmas parade on the Square. The parade starts at 6 p.m. The celebration includes the Lighting of the Square, when the colored lights outlining the buildings are turned on.

For Christians, Advent, starting on Sunday, Dec. 3, marks the beginning of the church year, and is a time of anticipation and preparation. Advent continues the next three Sundays until Christmas, which this year, falls on a Monday.

Hanukkah, the Festival of Light, starts at nightfall on Dec. 7 and lasts eight days, ending Dec. 15. During Hanukkah, families exchange gifts, play games and eat potato latkes. Hanukkah means "dedication." Lighting an additional candle on the Menorah each night commemorates the eight days the oil in the Temple Revolt recovered Jerusalem in the 2nd century BCE.

Kwanzaa, a celebration of African culture, starts the day after Christmas on Dec. 26 and goes through Jan. 1. People decorate their houses with the red, green and black candles and the Bendara flag.

And down at the Clinton post office, the clerks remind people to get their Christmas cards in the mail by Dec. 16 to ensure delivery before the holiday. Delivery deadline for packages by USPS Ground Delivery is also Dec. 16.

Clinton Main Street was founded in 1989 and is dedicated to the economic vitality and preservation of Clinton's historic downtown. The Clinton Square is the largest town square in the state of Missouri, with rows of historic buildings and double parking lanes around the grounds of the Henry County Courthouse. Vehicle traffic goes counter-clockwise on the street on the outside of the Square, next to the shops, with the inner lane between courthouse curb parking and the parking lanes for clockwise travel.

He said that the Foundation has funds that it uses for its grants in the spring and fall. But the Foundation also helps some of its umbrella organizations handle their money and taxes, while they decide who to give grants to. Sometimes an umbrella organization will also ask the Foundation to select who should benefit from its charitable grants.

"We supply an avenue for other groups and individuals to give grants without worrying about overwhelming paperwork," said Cook. "Our Foundation also gets assistance

leball courts, the driving range, the restaurant. It's all open to the public. They can do everything from renting the clubhouse to hosting a wedding." And, of course, they can play golf as well.

The Clinton Country Club started over 100 years ago with a nine-hole course. Originally, the course was established on several hundred acres of land located off Vansant Road on NE 100 road. However, the club members decided to scale back ownership to its present size of 160 acres, and the club went under expansion to its current 18 holes with a clubhouse, swimming pool, cart sheds and other buildings associated with running a golf course.

The remaining land was developed into the Dillon Creek Estates, which currently contains a dozen-and-a-half houses with two more currently under construction. A link can be found on the Country Club's website.

With that much history, a big feature is the involvement of members in the course and the club itself. "We're really a very dedicated club," says Hartner. "When problems come up, club members usually step in the resolve them."

For instance, this year during one of the torrential rains, "On this part of the creek," he said, pointing to a crossing that had a new culvert installed, "We lost our crossing area. But a club member had a backhoe, and another had a dump truck, and they jumped in with the help of some other members and put in a new culvert and spread enough gravel to make the crossing usable. It's still not finished yet, but it will be soon."

Everywhere it seems, there is evidence that club members care. The bridge is a recent example, but members also plant and maintain small flower gardens scattered over the course, and there are engraved memorials for members who have passed. And on the paved cart track, you'll see names of members scratched into

with accounting from CFO in Springfield, a huge organization that allows smaller organizations to remain volunteer."

In addition to President Cook, other Foundation Board members are Meredith Cooper, Vice President; Sandie Sorbo, Secretary; Nina Sisk, Treasurer; and Kristi Kenney, Historian. Officers normally service up to two three-year terms. The Foundation was founded on May 15, 2000, and according to its website has distributed more than \$6.2 million in grants to the community.

Tuesday through Sunday, as well as breakfast on the weekends and dinners on Friday nights. She also will cater events at the club or make arrangements for catering.

Brauer noted that there are groups that use the club house for card games and even the occasional karaoke evenings. While these activities aren't noted online, the public is encouraged to call (the phone number is 660-885-2521), or check the Ladies Association bulletin board in the club house for information on what is happening.

An upcoming event is the Passport Party, where party goers "adopt" a country and bring hors d'oeuvres and cocktails typically served in their country of choice. Mexico is already taken, so chips and margaritas are no longer an easy option. Other events may include a whisky tasting at some point, and the karaoke machine is rigged and ready. Check the club's website or call the office for more information.

The club house is closed in January and doesn't resume full functions until March.

For members of the public who want to do more than just visit the country club occasionally, there is a number of different levels and types of memberships available. Currently, there are 14 different types of memberships. For those who mainly want to use the pool, there is a pool membership for singles and for families. There also is a pickleball membership for those interested in using the courts.

Also, there are "young adult" and junior memberships and a promotional one-year membership. Golfers who belong to another club but frequently pass through and play a round or two at the Clinton club can join at a reduced rate for a dual membership. "We have people who drive down from Kansas City, play a round here and then drive back home. That takes them less time than if they got in line to play at their home course."

Also, high school golf club members can join the club at a very reduced rate.

"The young adult and junior memberships are intended to encourage younger folks to join the club," Hartner said. "As you might understand, a lot of our members are older or retired people, and we want to make it easier for younger people and families to join." He also noted that golf isn't as popular

as it once was because of the increasing number of other competing activities, and the club members are encouraging people to take up the sport.

"One thing about our club is that we have a wide variety of members; we have doctors, business men and women and people from all walks of life. We are very much a social club," in the best sense of the word.

Those members present were: Jim Stone - Presiding Commissioner, Rick Fosnow - North District Commissioner, Dale Lawler - South District Commissioner, Rick Watson - County Clerk

At 9:00 a.m. Commissioner Stone brought the meeting to order.

The agenda was approved as presented.

The minutes from the Thursday, October 12th, 2023 meeting were read; Commissioner Lawler made a motion to approve the minutes. Commissioner Fosnow seconded the motion, motion carried.

Expenditures from the following were approved to be paid: County Payroll, Capital Schools, Tri County Child Support, Road and Bridge, Sheriff's Revolving Fund, Buildings and Grounds, Circuit Clerk, Law Enforcement Fund, Law Enforcement Department, Assessor, Inmate Security, Emergency Management, General County Government

Kenny Ragland, from the Windsor Review, met with the Commission for an interview. The group shared of the proposed Solar Farm and the ballot question for Springfield Township.

At 9:18 Commissioner Lawler made a motion to go into closed session via RSMo 610.021(1) to discuss legal matters. Commissioner Fosnow seconded the motion. The motion passed with a roll call vote of Lawler - yes, Fosnow - yes, and Stone - yes.

Commissioner Fosnow made a motion to appoint Jane Marshall to serve on the Senior Citizens Service Tax Board to fulfill the unexpired term to end April 30, 2026. Commission Lawler seconded the motion. The motion passed with a roll call vote of Lawler - yes, Fosnow - yes, and Stone - yes.

Clerk Rick presented the rates for the county employees insurance policy for 2024. Rick has proposed that the county absorb the 7.5% increase in the rates over last year's premiums. The additional cost, as compared this year's enrollment, would total about \$49,000.00. Rick presented balance sheet totals to the Commission, showing increases to the cash accounts of the county. He also shared that the additional cost to the county would not be detrimental to the financial position of the county. The

Commission agreed to Rick's recommendation.

The Commission discussed the county's insurance company settling a frivolous lawsuit against their will that will increase the insurance rates for the county, Deer Creek Township, and Springfield Township.

The group discussed the assessed valuation of the land that will be leased to Ranger Power for their Solar Farm. The assessed valuation came to \$181,046.00.

The Assessor's Quarterly Reimbursement was reviewed, approved, and signed.

Dennis Bowers, Road and Bridge supervisor met with the Commission. He shared that the truck repairs may total anywhere from \$8,000.00 to \$9,000.00. He stated that he has to get the tie rod fixed now regardless of the other needed repairs. He also shared that the Brush Hog needs repair work done, but it is under warranty.

Dennis shared that he went to the MATCO Conference and learned a lot.

Clerk Rick began discussion on COLA allowances and step increases for county employees, as he beginning initial 2024 budget work. Commissioner Fosnow shared that he would support a 3.5% COLA. Commissioner Lawler agreed. They asked Rick to study how the step would impact the budget.

The Clerk told the Board that Brad Wright and Dillon Harness with Kaysinger did stop by and visit with her regarding any disaster safety concerns for the Village. Chiefs Beat Dolphins In First Germany Game

The Chiefs dominated the Miami Dolphins in Frankfurt Germany this Sunday, with a final score of 21-14, in a game considered, "a small step" in becoming the world's team. Mark Donovan said, "We think the opportunity exists today to set a foothold that we are the world's team, that people look at the Chiefs as an international representation of the NFL." The choice to play in Frankfurt was influenced by a recent study that shows that out of the 80 million people who live in Germany, 20 million are NFL fans.

The first half of the game was an exciting one. The Chiefs took an early lead when Patrick Mahomes threw an 11-yard touchdown pass to Rashee Rice. The Chief's defense dominated the first quarter, keeping the Dolphins with 0 points. That defensive dominance continued throughout the second quarter before the Chiefs could pull off a 95-yard touchdown drive, with Mahomes hitting Jerick McKinnon from 17 yards out to make it 14-0. Overall the Chiefs made their intentions for the game clear throughout the first half.

In the second half of the game, the Dolphins showed that they were not going down without a fight. The Dolphins did score when Tua Tagovailoa threw Cedric Wilson a 31-yard touchdown making the score 21-7. The Chiefs led 21-14 before the end of the third quarter. Spectators soon realized that the Chiefs were likely to win by the 4th quarter.

After the game, the Chiefs are now 7-2 in the AFC West. Not only did Kansas City show that football can be enjoyed globally, but they also made it abundantly clear that they are in it to win it this year. The football team has not disappointed loyal fans and is continuously showing signs that they intend to continue their reign of dominance on the field for the rest of the season.

The change. The northwest counties affected include Caldwell, Carroll, Clay, Clinton, Grundy, Livingston, and Ray. The CWD Management Zone is designed to limit the spread and effects of the disease over time in the state's deer herd.

The November portion of the firearms deer season is Nov. 11-21. Hunters will need to take deer harvested in those counties during the opening weekend, Nov. 11-12, to an MDC mandatory sampling station. The sampling stations can be found online at <http://short.mdc.mo.gov/ZYY> or in the 2023 Deer & Turkey Hunting Regulations and Information booklet. CWD sampling stations will be open from 7:30 a.m. to 8 p.m.

CWD is a fatal disease in deer caused by misfolded proteins called prions. The disease can be transmitted between deer. MDC implements a CWD Management Zone where the disease has occurred for increased testing and other measures. The goal is to evaluate and reduce the disease prevalence in an area. Mandatory sampling is in place Nov. 11-12 for 39 of the 52 counties in the CWD Management Zone.

While CWD continues to spread to new counties in Missouri, the overall prevalence of the disease remains low thanks to cooperation with MDC by hunters, landowners, taxidermists, and meat processors. The Centers for Disease Control says there is no evidence of transmission of the disease from deer to humans, but the

agency recommends that as a precaution meat from a positive deer not be consumed.

Throughout all of the firearms and archery deer hunting seasons, volunteer testing of deer for CWD is available at some MDC offices and at partnering taxidermy and meat processing businesses. MDC also has freezer locations where deer heads can be left for testing. However, the freezers will be locked during Nov. 11-12 and hunters must take deer to the mandatory sampling stations on those dates. Lymph nodes are removed from the deer to test for CWD. Hunters can find test results for their deer at <https://mdc.mo.gov/cwd-testresults>.

Hunters are also reminded that special regulations apply in the CWD Management Zone regarding transportation of carcasses and the prohibition of feed and minerals. For complete information on CWD regulations and voluntary testing sites, visit <http://short.mdc.mo.gov/Zxp>. Missouri Hunters Harvest 2,219 Birds During Fall Firearms Turkey Season

Preliminary data from the Missouri Department of Conservation (MDC) shows that hunters checked 2,219 turkeys during Missouri's fall firearms turkey season, Oct. 1-31. Top harvest counties were Dent with 86 birds harvested, Crawford with 82, and Washington with 72.

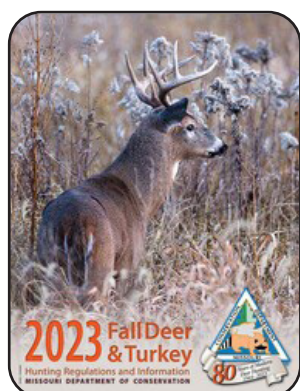
"It is great to see an uptick in fall harvest," said MDC Turkey Biologist Nick Oakley. "We saw an increased harvest during the spring season and an increase in poult production this year, so it makes sense that fall

harvest would follow suit."

Fall archery turkey hunting continues through Nov. 10 and resumes Nov. 22 through Jan. 15, 2024. Get more information about fall turkey hunting at mdc.mo.gov/hunting-trapping/species/turkey.

MDC is again asking Missouri turkey hunters to save and send feathers from the wild turkeys they harvest this fall. MDC asks hunters who harvest turkeys to mail feathers from their turkeys to MDC using a postage-paid envelope from MDC. The feathers will help MDC scientists improve research models used to monitor turkey population trends and estimate turkey numbers across the state. MDC instructs turkey hunters to save the 9th and 10th primary wing feathers and 3-5 breast feathers from harvested turkeys after Telechecking. 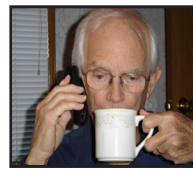

Let it be known that the Henry County Soil and Water Conservation District will hold an election for one supervisor in each of two different territories in the county from February 1-February 20. Anyone that owns a farm in Territory I, (Bogard, Big Creek, Shawnee, White Oak, or Honey Creek Townships,) or Territory III, (Clinton, Bethlehem, Leesville, Fairview, or Osage Townships,) and meets the qualifications listed below, may be considered as a candidate in the election. You may submit your name for participation in the election by completing the self-nomination form and delivering it to the district by 5:00 P.M. on November 30, 2023. The self-nomination form is available online at <https://mosoilandwater.land/henry> or in person at the district office (see contact info below). Supervisors of the district administer district policies and programs, district personnel, and cost share funding made available by the one-tenth-of-one-percent parks, soils and water sales tax.

During fiscal year 2023, the district provided \$438,230 of cost-share funds to 21 landowners to assist the landowners with installing agricultural erosion control and water quality practices. The qualifications required to be a supervisor are:

1. Being a land representative from the district (10 CSR 70-4.010 (1) (I)). A land representative is defined as the owner or representative authorized by power of attorney of any farm lying within an area proposed to be established, and subsequently established, as a soil and water conservation district under Chapter 278, RSMo. Each farm is entitled to representation by a land representative: provided, however that the land representative is a taxpayer of the county within which the soil and water district is located.
2. Residing in, or owning a farm in, the area from which he/she is nominated where there is an expiring term.
3. Being a cooperorator of the district, defined as, "a person who is actively engaged in farming and practices conservation activities related to agriculture".
4. Being a current resident and tax-paying citizen of the county for at least two years preceding the election date.
5. Be eighteen (18) years of age or older by the election date.

WHEN IN DOUBT, DO RIGHT

A church in northeast Missouri invited me to preach at their Sunday evening service. It was not an unusual request; I was their Director of Missions and had preached there often. What made this request unique was the fact that following my message they were to have a business meeting. The primary subject of that meeting was to fire the pastor.

I seized the opportunity and preached a message about forgiveness. The pastor had done nothing morally wrong, but he had made a serious misjudgment and refused to admit it. He used the pulpit to scold and ridicule those who criticized him.

The parishioner critics had tabulated the votes and knew they could succeed. Despite my "powerful" sermon on forgiveness, they voted to fire their pastor. Following the heated meeting, a member came to me and said, "I believe in forgiveness, and I could forgive him---the pastor---for anything but this. So, I voted to dismiss him." I noted he used the phrase "dismiss him" rather than "fire him." I suppose that made him feel better.

"You admit your forgiveness is selective," I responded. "Let me ask you this. Do you think you did what is right?" He walked away without answering me.

Sometimes there are no specific "commandments" to guide us. That was the case when Jesus asked John to baptize Him. John was confused; he didn't understand. "You should baptize me, not I baptize you."

Jesus responded, "Let it be so, John. It is proper for us to do this to fulfill all righteousness." In other words, this is right. (Matthew 3:16)

In response to his puzzlement, John did two things. First, he talked with Jesus about it. Second, he did what Jesus said. That is, he did what was right. When in doubt, we will do well to follow John's example.

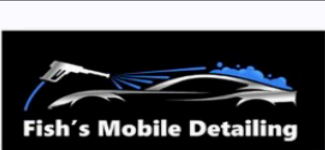
