Past Is Coming To The Present For 42nd Annual Heritage Days

Max Motors Dealerships Continue to Expand Empire

Thousands of visitors are expected in the area this weekend, October 21-22 to attend the Pioneer Heritage Days celebration on Kaysinger Bluff and the Heritage Days Craft Show on Drake Harbor. Since 1981, Warsaw Pioneer Heritage Days has drawn thousands to its Mountain Man Camp, Pioneer exhibitors and more.

Warsaw Chamber of Commerce Executive Director Pam Burnham is geared up for the annual celebration.

"We have over 300 vendors coming to the area for Heritage Day," said Burnham. "Main Street from Van Buren to Benton will be closed to traffic as we have rented spots on Main Street to vendors to expand our vendor numbers," said Burnham.

Burnham is expecting approximately 20,000 visitors to the Warsaw area during Heritage Days 2023. There will be golf carts taking visitors up and down the hill to Drake Harbor. These volunteer drivers will also be helping visitors take their purchases to their cars. Cart driver volunteer Hadley Arnett said he would be working all day on both days of Heritage Days.

"I love helping out and

meeting the people who come to Warsaw for this event," said Arnett.

One addition to Heritage Days will be food vendors on Main Street as well as food vendors on the Harbor.

"There will be lots of different food choices," said Burnham.

Another food choice is the annual Spaghetti and Meatball dinner at St. Ann Catholic Church located at 30455 West Dam Access Road just off Highway 7. The spaghetti and meatball

dinner will also feature garlic bread, tea or coffee and a piece of pie. Cost is \$12 for adults, \$6 for children ages 6 through 12 and children 5 and under eat for free. Serving will start at 11:00 AM and end at 6:00 PM.

In addition to the spaghetti and meatball dinner, the St. Ann congregation will host a car show in their parking lot as well as a cookie wheel, country store and bake sale. The car show will run from 9:00 AM

until 3:00 PM. This is the major fundraiser for the St. Ann parish for the year.

Burnham went on to say that it truly is a combined effort between the KBPHA, the City of Warsaw, the U.S. Army Corps of Engineers, and the Chamber of Commerce to prepare for the two-day event.

"We wouldn't be able to present this event without the many volunteers," said Burnham.

The KBPHA presents a living history experience

through the demonstration of the 18th through the 20th century crafts, trades and lifestyles of the early pioneers.

Throughout the wooded trails of Kaysinger Bluff, visitors will explore the Hooper House, the Concord School House, an 1850's pioneer homestead and discover which dwelling once housed Frank and Jesse James for a night. A two-day event jam packed with the sights, sounds and

Nurse Practitioner Joins Bothwell Lincoln And Cole Camp Clinics



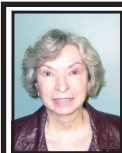

The Pleasure Of Pumpkins: The Patch Gets New Owners

Kyle and Allison Rupe became new owners of The Patch, located at 10757 Hwy 65, Cole Camp, formerly

known as Prairies End Pumpkin Patch. They closed on the site October 13, and are planning to have their first event this December when they will offer wagon rides to see "a lot of Christmas lights."

The Rupe family started their family farm in Green

Ridge in 2013 as a small garden, and with very little knowledge of how to grow veggies. They followed their dream and now have seven high tunnels (large cold-frame hoop houses or greenhouses that are usually unheated), one greenhouse, and they plant veggies on 50 of a total of 160 acres. The new Cole Camp part of the business will offer a pumpkin patch with many shapes, sizes, and colors of pumpkins from the 56 different varieties grown on their farm.

"We are open in the spring offering strawberries and flowers," said Allison Rupe. "We will also offer many different summer vegetables such as tomatoes, peppers, melons, green beans, and sweet corn. We deliver our produce in the summer through a subscription service at \$25 a box of whatever is in season."

Lovely's Story: Local Girl Coming Back From Medically Induced Coma



"HUMBLED BY THE COMMUNITY with the outpouring of prayers and concern," is how Holly Henderson describes the support received for her daughter Lovely, who has been hospitalized with seizures.

While most eight-year-olds are anxiously awaiting fall parties and trips to the pumpkin patch, little Lovely Henderson of Edwards is lying in a hospital bed at Children's

Mercy Hospital Adele Hall in downtown Kansas City. Lovely has been diagnosed with refractory frontal lobe epilepsy with generalized seizures.

According to her parents, Holly and Matthew Henderson, Lovely was a perfectly healthy eight-year-old ten weeks ago and then suddenly the

(Continued from Page 1) aromas of the way life once was. History comes alive with the sights, sounds and over 100 exhibitors and crafters demonstrating life in the 1800's.

Admission to the historical area around the Overlook is \$10 for adults and \$5 for ages 6-12. Children 5 and under are admitted free of charge. Those who pay for their admission on Saturday can use their pass on Sunday as well. Exhibits will be open from 9:00 AM until 5:00 PM on Saturday and 9:00 AM until 4:00 PM on Sunday. Buses will transport guests to Kaysinger Bluff (pioneer demonstrations and crafts) and to Drake Harbor (modern crafts).

Special attractions will include demonstrations of pioneer lifestyle such as finger weaving and tating, treadle sewing, rope making, leatherworks, antique loom weaving, broom making, knife making, spinning, weaving, dyeing yarn, soap making, stone carving and wood carving.

Warsaw resident Katie Johnson will be on the Bluff weaving baskets on Saturday and Sunday.

"We will also have baskets for visitors to purchase," said Johnson.

There will also be lots of delicious food such as kettle corn, biscuits and gravy, chuckwagon chili, homemade apple butter, bread, cookies and much more.

The Kaysinger General Store will also be open with demonstrations and many homemade items for sale. Those working and demonstrating on Kaysinger Bluff will be dressed in 19th century clothing.

Sunday on the Bluff will feature a church service as well.

Pioneer Heritage Days on Kaysinger Bluff will be accessible only by bus from the East Bledsoe parking area.

Please note that the access road across the dam will be closed! Pioneer Heritage Days can only be accessed from the east side of the dam.

Visitors can catch the bus to Downtown Warsaw to experience the quaint shops, unique restaurants and enjoy the local musicians at Drake Harbor's amphitheater.

According to Burnham there are still opportunities to volunteer.

"We always can use more volunteers," she said.

seizures started.

"We were told for several weeks that it wasn't seizures but behavioral issues but after an abnormal EEG and persistence on my part, they finally admitted her and the long EEG indeed showed 30-40 seizures in a 24-hour period," said Holly Henderson.

"For ten weeks straight, she couldn't sleep more than 20 minutes at a time without waking up having a seizure. The exhaustion caused more seizures and the seizures caused exhaustion."

Frontal lobe seizures are the hardest to diagnose and treat. The medications the doctors tried have not worked. After her third admission to the hospital, the doctors started looking at WHY she suddenly started the seizures. Some tests are still pending, but the ones that have come back are normal.

At the beginning of Lovely's illness, her parents were told it wasn't seizures, she was being treated for PANDAS (Pediatric Autoimmune Neuropsychiatric Disorders Associated with Streptococcal Infections). Most of the medical professionals will not acknowledge it as an illness. It is encephalitis caused by an illness like strep or pneumonia that lies dormant in the body and comes out causing sudden symptoms such as OCD, tics, seizures, suicidal tendencies, and behavioral issues.

According to Holly Henderson, parents need to

take illnesses such as strep very seriously and allow their child to fully recover.

The doctors started IVIG and currently Lovely is in a Pentobarbital Coma to reset her brain and give it a rest. She had so many seizures for so long that the background activity wasn't slowing down in her brain.

"My little Lovely was struggling with extreme seizures and unfortunately her brain was not responding to the final meds to help in between seizures," said Matt Henderson. "With her heart rate consistently getting very high and repeated seizures, we finally decided she had to have some rest. Lovely was put into a coma, pic line put in, intubated, and feeding tube in place. She will get rest for at least 48 hours and we are praying the good Lord will give her brain the rest she needs to heal."

"The doctors are starting to wean her down every six hours," said Matthew Henderson. "Coming out of the coma will depend on if she has break through seizures as she comes out. The doctors can only drop the coma-inducing drug a little at a time so this could take up to 12 to 24 hours."

Holly Henderson has been with her daughter continuously.

"We are humbled by the community with the outpouring of prayers and concern," said Holly Henderson. "Her friends from South School, church and sports teams have gone out of their way to reach out. She can't wait to be back at school with her friends and watch the Wildcats Basketball teams play this year"

"Thank you for all your prayers and support," said Matthew Henderson. "The community's support has meant the world to us from the volleyball girls saying a prayer before their game to the many, many messages, texts, calls and monetary help we have received. All of this support has been encouraging us."

"We are trusting in the Lord to take care of her and give her relief from the seizure activity," said Holly Henderson. "She is perfectly Lovely."

and perform annual health exams, well-woman and physicals.

Michele Laas, Bothwell's interim Clinic Operations vice president, said Kelly is a welcome addition to the Lincoln and Cole Camp clinics.

"Sam will be a great asset to both clinics," she said. "Her presence will mean more patients can have quicker access to care when they need it. I know Sam personally, and she's a terrific nurse. She lives in the area and is committed to caring for people in these communities."

Kelly said though she had a wonderful start to her nursing career at MU, she always knew she wanted to move back home.

"Coming back and working at a rural hospital, I quickly felt comforted knowing that teamwork and patient care in a rural community was just as exceptional as a larger health care system," Kelly said. "Collaboration is key in making sure patient outcomes are positive."

Kelly joins Dr. Matthew Roehrs at Bothwell Lincoln Family Medicine and Dr. Misty Todd and Nurse Practitioner Pam Eckhoff at Bothwell Cole Camp. She will see patients in Lincoln from 8:00 AM to 5:00 PM Mondays and Tuesdays and in Cole Camp from 8:00 AM to 5:00 PM Wednesdays and Fridays. On Thursdays, she will work at the clinic that

has the highest demand.

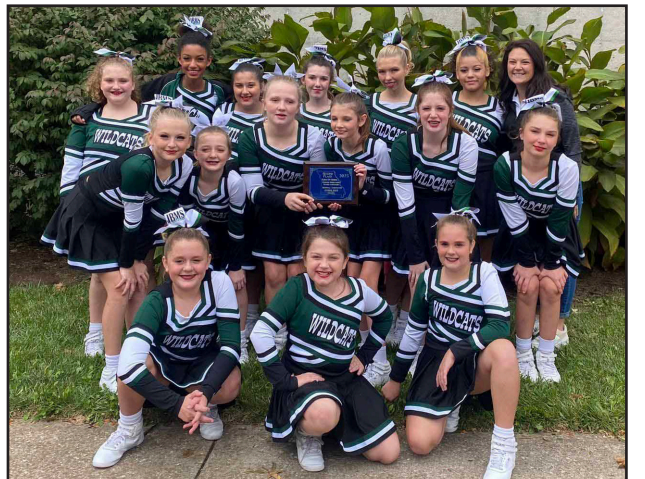

After a slow start, the Wildcats got back in the win column with a much needed victory at Skyline on Friday night, 34-6.

The opening period was a tale of two stagnant offenses, neither of which could seem to get much of anything going early on with the game scoreless after a quick first twelve minutes.

With less seconds ticking away, Ferguson scrambled and delivered a bullet to Drake Murrell who made a sliding catch in the endzone for the Wildcats with just 4.8 ticks left on the clock. Gemes came on for another PAT, he split the uprights again as Warsaw led 21-0 at the break.

With the first possession of the second half, the Wildcats capitalized again when Ferguson marched the offense down the field and capped the drive with a 6 yard touchdown pass to Murrell, his second of the night. Gemes knocked the PAT through for his fourth of the night as Warsaw stretched their lead to 28-0 after the third.

A 15 yard touchdown run by Ferguson in the fourth put the 'Cats up 34-0 after a botched snap resulted in an unsuccessful 2-point attempt and Skyline added a score in the final frame for the 34-6 final.

"I was proud of how our kids stuck to the game plan and played together," Wildcats head coach Ryan Boyer said. "We had a couple of players out, so it was great to see those other guys step up."

Riley Taylor, the starting guard on the right side sat out due to experiencing concussion systems and Josh Harvath, a starting running back, is nursing a shoulder. Both players are hopeful and expected to suit up again this Friday.

Ferguson accounted for over 70% of the Wildcats offensive output. He picked up 103 yards on the ground on 19 rushing attempts with 1 touchdown and finished 9 for 18 through the air for 134 yards with 2 passing TD's.

Depriest went for 61 yards rushing and 2 touchdowns on 12 carries and Oliver Robertson had 10 rushes for 37 yards.

Of Ferguson's 9 completions, 6 were hauled in by Murrell for 83 yards and he recorded 2 scores. Gemes was on the receiving end of 2 passes for 28 yards and Depriest had 1 catch for 23.

Gemes was a perfect 4 for 4 on PAT's and missed what would have been a new school record 38 yard field goal, his only attempt on the night.

Murrell was all over the place for the Wildcats defense, racking up 14 tackles on the night. Bagley finished with 5 tackles. Sean Reinertsen and Depriest contributed 2.5 and 2 respectively. Depriest also had the forced fumble and Bagley came up with the recovery.

The Wildcats (5-3, 3-1) will host Buffalo this Friday night for their regular season finale. The game will also be another Ozark Highlands Conference matchup. Like always, the kickoff is set for 7:00 PM and can also be viewed live on BCE TV with Matt Dove and Drew Burdick.

go out Friday night and honor our Alum with a great effort."

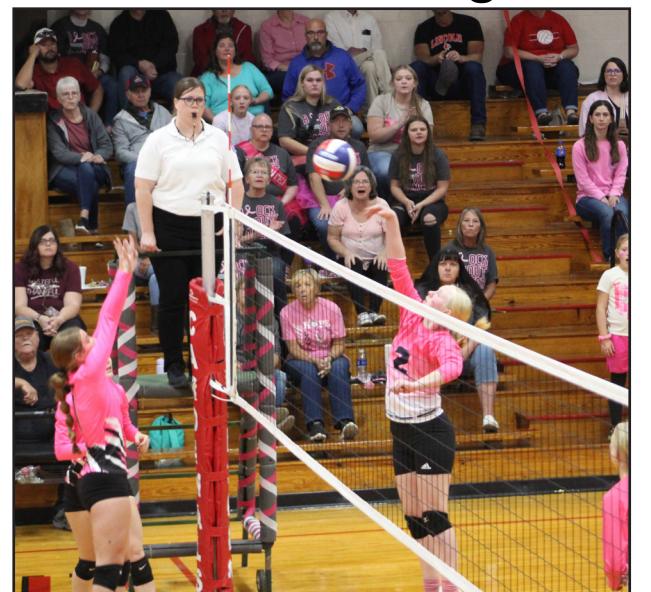
Defensively, Riley Sanders and Ben Eckhoff had 10 tackles each and Cam Everhart had nine. Dawson Parrott had a quarterback sack.

It's not as well-known as Halloween, but National Retirement Security week happens every October – the third week, to be precise – and while it doesn't involve ghosts and goblins, it does deal with something even more frightening: the risk of not being able to enjoy a comfortable retirement. Through various events, this occasion highlights ideas about building retirement security. What steps can you take?

Here are some suggestions:
• *Don't underestimate your longevity.* Consider this: 65-year-old men can expect to live another 20 years, while 65-year-old women can anticipate almost 22 more years, according to the Society of Actuaries. And these figures are just averages, meaning you could well exceed these ages, perhaps by many years. So, in thinking about how much money you'll need as a retiree, be aware that you could spend two, or even three, decades in retirement.

• *Don't underestimate health care costs.* When you retire, some of your expenses — such as transportation, wardrobe and other costs associated with your career — will drop. Others will not and may even increase. Health care is a prime example: Many people assume that Medicare or their Medicare Advantage plan will take care of virtually all their health care costs in retirement, but that's not the case. Generally speaking, you could plan on spending \$4,500 to \$6,500 per year on health care costs during retirement, excluding the large expenses connected with long-term care. Your actual costs could be higher or lower, depending on your health, prescription drugs and supplemental insurance coverage, but make sure you plan for sizable health care costs in your projected retirement budget.

• *Contribute as much as you can afford to your*



retirement plans. Try to put in as much as you can afford to your 401(k) or other employer-sponsored retirement plan and try to increase your contributions whenever your salary goes up. You may also be eligible to contribute to a traditional or Roth IRA, which offers tax benefits and a wide variety of investment options. (Contributions to a Roth IRA may be limited based on your income.)

Once you reach retirement, you can still make some moves that could help boost your financial security:

• *Maintain an appropriate investment mix.* When you retire, you might be tempted to shift most of your portfolio into highly conservative investments to "lock in" gains and avoid being over-exposed to market volatility that could cause short-term losses. Yet, even in retirement, you should still own some growth-oriented investments that can

potentially help keep you ahead of inflation. In fact, it's important to periodically rebalance your investments back to your preferred mix to avoid taking too much or too little risk, so you may want to consult with a financial advisor.

• *Identify a suitable withdrawal rate.* You don't want to take out so much from your portfolio each year that you run the risk of outliving your money. So, you'll want to determine an annual withdrawal rate that can reduce this danger.

A common withdrawal rate to start retirement is 4%, but your own rate should be based on several factors: your age, size of portfolio, other sources of income and so on.

It can be challenging to make all the moves necessary to help achieve retirement security — but it's worth the effort.

Pedestrian Safety Affects Everyone! Watch For PED's



Everyone is a Pedestrian At some point in the day, you are a pedestrian.

Whether by car, train, bus, bike, or other, we all have different preferences when it comes to getting to our destination, but we do have one thing in common — at some point, Everyone is a Pedestrian. The U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA), Region 7, which includes Arkansas, Iowa, Kansas, Missouri, and Nebraska,

wants to remind everyone that choosing safe behaviors behind the wheel could save your, or someone else's life.

There was a 12.5% increase in the number of pedestrians killed in traffic crashes when comparing 2021 with the previous year, a total of 7,388 deaths. That averages out to 20 pedestrian fatalities a day or one pedestrian fatality every 72 minutes!

First responders, including law enforcement, firefighters, paramedics, and tow truck drivers become especially vulnerable pedestrians when performing roadside job duties. Inattentive driving and speeding are two of the top causes of pedestrian collisions along the roadside and within work zones. The Move Over law, enacted in all 50 states, requires drivers to slow down and move over when approaching stopped emergency vehicles with emergency lights activated, so long as it's safe to do so. To help emphasize this life-saving law, Saturday, October 21, 2023, has been designated National Move Over Day.

Every state also has a law requiring drivers to stop when a school bus stop arm is extended. This is because the greatest risk to a child is not the school bus ride, but from walking to and from their bus. From 2012–2021, 240 school-age children (18 years old and younger) died as occupants of school buses and other motor vehicles or while walking. Of those 240 deaths, 92 were children who were walking. Among pedestrians of all ages killed in school bus-related incidents, there were 1.6 times more fatalities among pedestrians (203) than occupants of school buses (126).

"Motorists driving unsafely due to being distracted or from drugs and/or alcohol impairment has too many people paying with their lives," said Regional Administrator Susan DeCourcy. "A collision involving a pedestrian is

more likely to involve a fatality than a collision between two vehicles." That's why it's every motorist's responsibility to drive attentively and safely — especially where there is a higher chance of pedestrian traffic."

Safety is not just motorists' responsibility. It's recommended that pedestrians traveling long distances wear bright colors during the day and shine lights or wear high-visibility clothing with reflectors when it is dark to help decrease crash risks. Almost 77% of pedestrian-related accidents happen when it is dark outside, so pedestrians should do what they can to ensure they are seen by motorists. Additionally, nearly every motorist is a pedestrian at some point throughout the day, so it's always important for everyone to be aware of nearby traffic before taking their first step, and never make assumptions.

"Pedestrians can never assume that a motorist will see them, so it's imperative to exercise awareness and caution at all times when walking on and near roadways," said DeCourcy. "All of us, motorists and pedestrians, can do our part to ensure that everyone is safe both on and near the road."

Whether you're a concerned resident, a parent, or a caregiver, you can help ensure your loved ones and neighbors are safe while enjoying a walk in your community. Remember, at some point in the day, Everyone is a Pedestrian.

Cooler Nights Bring Increased Wild Animal Movement



Missouri ranks 10th in the country for potential vehicle collisions with animals

Fall has arrived, and that means more wild animals, especially deer, are on the move as cooler temperatures begin to settle in and nights become longer. The Missouri Department of Transportation reminds motorists to be prepared for the sudden appearance of wild animals on Missouri roadways throughout the fall months.

"Shorter days mean motorists are driving in the dark more often and when deer are more active," said MoDOT State Maintenance Director Natalie Roark. "This leads to a peak of vehicle collisions involving deer and other wildlife from mid-October through the end of November."

Missouri has continued to climb the ranks for deer collisions. According to State Farm Insurance, the Show-Me State now ranks 10th in the country for potential animal collisions — up from 14th last year — with a 1 in 80 chance of hitting an animal while driving. MoDOT maintains nearly 34,000 miles of highways, putting Missouri 7th nationally in state highway miles.

In 2022, Missouri drivers experienced 3,699 crashes involving a deer. One deer strike occurred approximately every 2 hours and 20 minutes in the state. In these crashes, there were 5 fatalities and 424 people were injured.

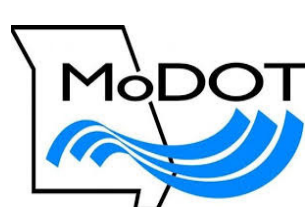
Drivers should never swerve to avoid animals in the road, as it can cause loss of control of their vehicles, resulting in serious injury or death. To avoid hitting a deer, always be cautious and regularly scan both sides of the roadway.

According to Missouri Law, an individual who has struck and killed a deer with their vehicle may claim the deer carcass if written authorization to possess the deer is granted by a Missouri Department of Conservation agent. The Wildlife Disposition Form is free, but the MDC must be contacted to obtain the permit.

If a deer is struck along a state-maintained road and is completely off the roadway, MoDOT will not pick it up unless it impedes mail delivery or is in a neighborhood, especially at or near a bus stop. If a deer is located on the shoulder, MoDOT will address the deer during normal work hours. MoDOT crews are not called out after hours to remove an item unless it is a road safety hazard in a driving lane. MoDOT does not have specialized crews assigned to remove dead animals from the roadway and does not contract out any roadkill removal.

Do not jeopardize your safety to remove an animal in a high traffic area. Notify MoDOT at 1-888-ASK-MODOT (275-6636). Crews will address any deer, animal or debris on a highway that is a safety hazard, meaning that the item is in the driving or passing lane, or partially in either lane or on the shoulder. Crews will drag the carcass to the outer portion of the roadside, outside any active drainage ditch or channel.

Statewide Winter Weather Drill Set For October 19



Winter is just around the corner, and in preparation, the Missouri Department of Transportation will hold its annual winter operations drill on Thursday, Oct. 19. Motorists may notice an increased number of MoDOT vehicles on state routes during the drill, which will begin at 8 a.m. in rural areas and 9 a.m. in urban areas. The exercise should be completed by 3 p.m. With turnover rates and many positions still open, driver training on this day is more critical than ever.

"While MoDOT has successfully hired approximately 100 new maintenance employees this summer, we're still several hundred employees below what's needed to cover more than one shift in a statewide storm," said MoDOT Chief Safety and Operations Officer Becky Allmeroth. "Nearly 27% of our snowplow operators have less than three years

of experience. Those three years did not include many significant winter storms, making this training more critical than ever."

MoDOT has more than 3,000 employees across the state involved in work to clear roads and bridges when winter weather hits. During the drill, MoDOT employees will react to a simulated forecast of significant snow for the entire state. The department's emergency operations centers will activate, and all employees involved in winter operations will be deployed to their trucks. Emergency communications systems will also be tested.

"Safety is the cornerstone of everything we do at MoDOT," said Allmeroth. "The drill ensures that proper equipment, plowing techniques and safety measures are used by every MoDOT employee." In addition, every piece of equipment—every truck, motor grader, snow blower and tractor—is inspected and calibrated to conserve materials and operate efficiently and safely.

MoDOT spent \$33 million on winter operations last year and used 63,000 tons of salt; 957,000 gallons of salt brine; and 147,000 gallons of beet juice.

For the most up-to-date information on road conditions in any winter storm, motorists are urged to use the Traveler Information Map at traveler.modot.org. The map is also available on the Apple Store and Google Play.

Conservation Commission Approves Most MDC Permit Price Increases



Missouri deer hunters will pay an extra dollar to harvest a buck starting in 2024. The price of a resident firearm deer permit will go from \$17 to \$18.

The Missouri Conservation Commission gave final approval at its Sept. 8 open meeting to adjust prices for most hunting, fishing, trapping, and commercial permits offered by the Missouri Department of Conservation (MDC). The price increases will take effect Feb. 29, 2024.

Most MDC permit prices have remained the same for the past 20 years. MDC proposed the permit price adjustments in an effort to keep up with rising costs of goods and services it uses to manage its more than 1,000 conservation areas along with nature centers, shooting ranges, fish hatcheries, and other facilities.

MDC received initial approval on its proposed permit price adjustments from the Commission at the Commission's May 19 open meeting. MDC then offered a public comment period from July 4 through Aug. 2 where it received about 250 public comments along with feedback on the proposals from numerous conservation-related groups and organizations.

Missouri is home to more than 1 million anglers, 500,000 hunters, and several thousand trappers. MDC issues nearly 2.6 million hunting, fishing, and trapping permits each year.

On average, most resident hunting and fishing permit prices would be adjusted by about \$1.

"Compared to other states, Missouri permit prices are still in the middle-to-lower end of the scale and will still be a bargain," said MDC Director Sara Parker Pauley. "The average price of a resident firearm deer permit

for surrounding states is \$54 compared to Missouri's new price starting in 2024 of \$18."

Not all permit prices will increase. Based on public comments and other feedback received, MDC will not raise permit prices for resident and nonresident Daily Fishing Permits, annual Trout Permits, and resident and nonresident Fur Dealer's Permits.

Some of the new permit prices starting in 2024 will be:

-The price of a resident hunting and fishing permit will go from \$19 to \$20.50. The average price for surrounding states is \$42.47.

-The price of a resident small game hunting permit will go from \$10 to \$10.50. The average price for surrounding states is \$26.57.

-The price of a resident trapping permit will go from \$10 to \$11. The average price for surrounding states is \$29.38.

-The price of a resident spring turkey permit will go from \$17 to \$18. The average price for surrounding states is \$47.69.

-The price of a resident firearm deer permit will go from \$17 to \$18. The average price for surrounding states is \$54.06.

-The price of a resident antlerless deer permit will go from \$7 to \$7.50. The average price for surrounding states is \$24.21.

-The price of a youth resident antlerless deer permit will go from \$3.50 to \$3.75. The average price for surrounding states is \$24.21.

-The price of the daily trout tag will go from \$4 to \$5 for adults and stay at \$3 for youth. The Commission also rescinded the '\$5 for 5 trout pilot' at Maramec Spring Park based on public input. At all trout parks the daily limit is four trout with a statewide possession limit of eight trout.

-Those under 16 and 65 years of age and older remain exempt from small-game hunting permits and annual fishing permit requirements. Daily trout tags and an annual trout permit are still required.

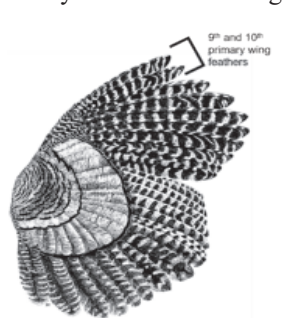
MDC Wants Feathers From Fall Turkey Hunters

Save wing feathers and breast feathers from harvested turkeys for submission to MDC.

The Missouri Department of Conservation (MDC) is again asking Missouri turkey hunters to save and share feathers from the wild turkeys they harvest this fall. Hunters who harvest a turkey during the archery season (Sept. 15 through Nov. 10 and Nov. 22 through Jan. 15, 2024) or the fall firearms season (Oct. 1-31) are asked to mail feathers from their turkeys to MDC using a postage-paid envelope from MDC.

The feathers will help MDC scientists improve research models used to monitor turkey population trends and estimate turkey numbers across the state.

MDC instructs turkey hunters to save the 9th and 10th primary wing feathers and 3-5 breast feathers (see diagram) from harvested turkeys after Telechecking.

"Once hunters have signed up for the program and Telechecked a turkey, we will mail them a feather submission packet containing additional instructions and a postage-paid envelope for the feathers to be placed inside and mailed back to MDC," explained MDC Turkey Biologist Nick Oakley. "Hunters will receive one packet for each turkey they harvest during the fall seasons, so please be sure to keep each turkey's feathers separate and labeled with the correct Telecheck ID."
