New Clinton Airport Terminal Cleared For Spectacular Takeoff

It was old home week at the Clinton Regional Airport on Wednesday, Nov. 15, as Clinton's mayor, Carla Moberly, MODOT Commissioner Gregg Smith and Clinton Airport Association's Wallace White wielded shovels to break ground for the new addition, a terminal building.

Standing in line with Smith and White, the Mayor noted that they were all graduates of Clinton High School, White in 1975 and she and Smith in 1974.

"We all stayed around," the Mayor said, "We all wanted to improve our community."

The Clinton Regional Airport has never had a terminal, but uses a small building with one main room that doubles as a pilot lounge and the office of the airport manager, Joel Long. Long took over in June from White, a pilot who served as airport operations manager for five years, and has served as a member of the Clinton Airport Association for more than 15.

The CAA is a non-profit board of volunteers who oversee the airport's operation. White credited Jim Houchen, who was hired as the airport's first paid manager in 2013, for taking the

airport to the next level. "He's one of the people who set the foundation for what we're doing here today," White said.

Christy Maggi, city administrator, welcomed guests, who gathered at the spot the terminal will be located, just east of the access road about 30 yards before the gate. Maggi thanked members of the Clinton City Council, the six mem-

bers of the Clinton Airport Association (CAA), Tom Powers at MODOT, which channels federal funds to Missouri airports, Brett Holt with Garver Engineering, Integrity Engineering and Westport Construction Co.

Don Wheeler of Westport Construction will be the site manager for the project. Of the \$2 million cost of the terminal, \$1.9

million is covered by Federal Aviation Administration grants, the mayor said, with the city's match of 7.4%.

The City of Clinton owns the airport property, the runways and the navigational aids. The ceremony drew three dozen stakeholders, including business owners, the project engineer, builders, subcontractors and city officials. **Terminal Page 3**

Climbing Your Family Tree: Ancestors Just A Link Away

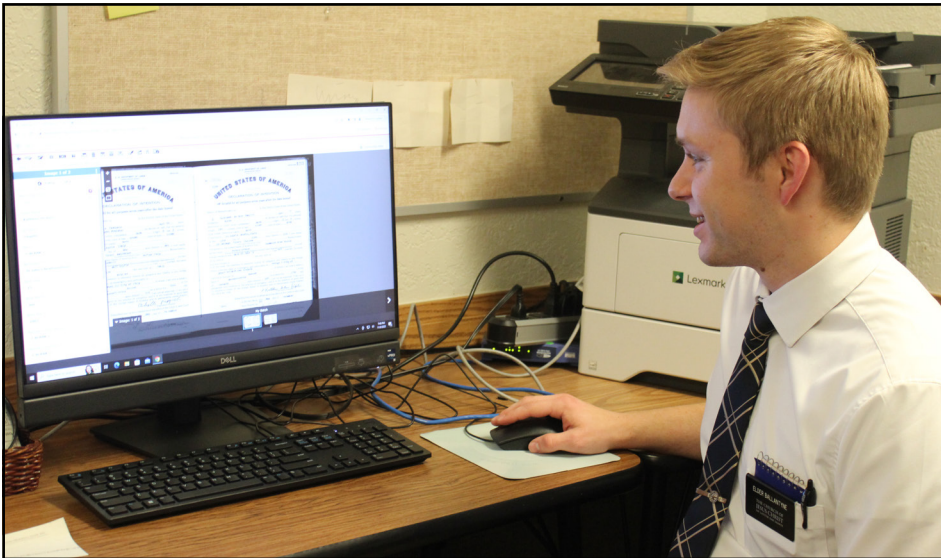
Holiday dinners are a time when grandparents, cousins, aunts and uncles gather around the table and catch up on what's new.

It's also a time to share the old — stories about great-uncles who fought in the Civil War, where the family originated, what they did and where they lived.

If older generations of your family are gone, you can recover your family's stories by researching your family tree in Clinton, even if your roots don't lie in Henry County.

The place to do it: the Family Research Center at Clinton's Church of Jesus Christ of Latter-Day Saints. The center, which has three computers, is open to the public on Thursday nights at 7:30 p.m., with no strings attached, other than the cables connected to the printer.

Use of the Family Research Center and the Fam-

ily Search program is free. Family Search is also available at the Henry County Library, but for those who need help getting started, the LDS center is staffed by two computer-savvy young men, Seth Ballantyne and Blake McCosh.

"They are very educated and are here to help us with any snags," said Jerry

Anspaugh, "and there will be snags."

Jerry, a 1971 CHS graduate, said he has traced his family tree back 17 generations on the Anspaugh side, he said, to a town in Germany called Anspach, the original spelling of the family name. The farthest back he has gone is a man named Ambrosias, 1440 -

1520.

"I keep hoping as more people add their history, I can make connections so that I can go farther back," Jerry said.

Family Search is a version of ancestry.com, and can link your search to genealogy research other people have done.

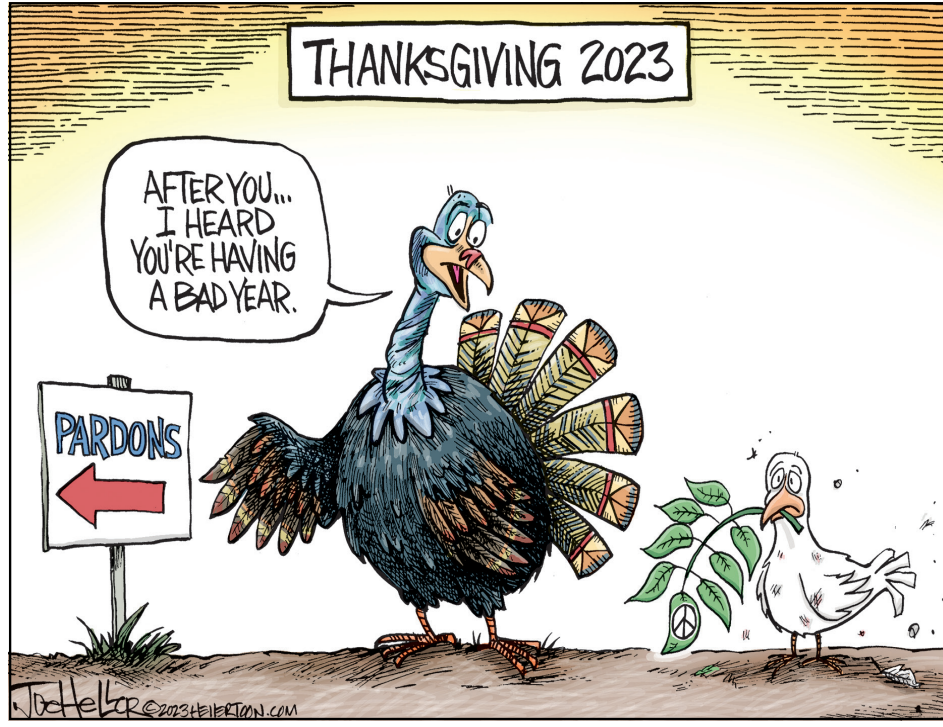

tors and the city officials who have worked for more than a decade to make the building a reality. The design is similar to the Rolla, Mo., airport terminal, with the modification of floor-to-ceiling windows to give a good view of planes landing on the runways.

"We've talked about this, we've dreamed of this, we've wished for this," said the Mayor, who was on the city council prior to her mayoral term.

The airport's operation is overseen by the CAA, a non-profit board of six citizens. The board, whose members volunteer their time, started in the early 1970s, White said. He credited Dr. Gus Wetzel with the foresight back in the early 2000s to lobby for a 5,000-foot north/south main runway, long enough for corporate jets to land.

Corporate executives no longer drive to business appointments, the Mayor said, preferring to fly in and out on the same day for meetings. Because of that, the Clinton Regional Airport actually serves national and international air traffic, she said. Providing business aircraft access to the community is the facility's primary purpose.

The airport also provides runways and refueling to agricultural businesses, medical flights, military and search and rescue operations, as well as recreation aviation and pilot training. In addition to the 5,000 foot runway, the airport has a crosswind runway that gives pilots an alternative angle to land planes no

Jerry, whose family moved to Clinton when he was 9 years old, said he had zero knowledge of his family history before discovering the computer program. At the LDS Family Research Center, he has found his family's roots with the help of Ballantyne and McCosh, Mormon missionaries who are serving their two-year assignments in Clinton. Mormon missionaries now use social media to spread the word, they said, and no longer go door to door.

"It might have worked in the past," Elder McCosh said. "but it's no longer the most efficient way to reach people."

They follow up after people respond to their Facebook posts and express an interest, they said.

"That's our knocking on doors now," Elder Ballantyne said of Facebook.

Elder McCosh said what's neat about Family Search is that there is an app you can put on your cell phone called "Find My Relatives Around Me." When Elder Ballantyne and Jerry used the link, branches of their family trees popped up, showing that they are ninth cousins once removed. The name of the relative they have in common and boxes with the names of the generations in between also appears.

There's also a "Famous People" link on Family Search. Elder Ballantyne, who grew up in Eastern Oregon, discovered he is related to John Wayne and Walt Disney. Ballantyne grew up in a farming family and plans to study agriculture at Brigham Young University, he said.

Elder McCosh is from Lew- illsville, Idaho, and plans to study data management at BYU, with the idea of supporting himself while pursuing a job in his real interest, tailoring.

Jerry found out that his ancestors were employed as soldiers as well as farmers. In the early 1700s, he found an Anspach named Johannes Balthazar ("Balt"), who wound up serving the British crown. Balthazar was rewarded by passage to the New

matter which way the wind blows. AWOS, the Automatic Weather Observing System, provides continuous, real-time information to pilots landing at the airport, in lieu of a control tower.

Gregg C. Smith, a Missouri Department of Transportation commissioner, noted that MODOT doesn't just oversee highways but all modes of transportation. Smith, who owns the Ford Lincoln dealership in Clinton, said the terminal is a great project that will play a vital part in the city's economy.

"I'm glad to be here for the ground-breaking," said Smith, referring to his term as commissioner. "I probably won't be here for the opening."

"We'll still invite you to the opening," the Mayor replied.

Making the city's economy strong is one of the most important things city officials do, the Mayor said.

For Long, the next months are comparable to waiting to open your presents on Christmas. The terminal is expected to be completed and open to the public in the latter half of 2024.

"There is no better feeling as an airport manager than knowing you have a new terminal coming," Long said.

After the ground-breaking, which was held at noon, guests were invited to the pilot's lounge, where Brett Holt of Garver Engineering provided lunch. Clinton Regional Airport is located east of Clinton, off of Hwy.7 South. To schedule a visit, call 660-885-8889.

World, Jerry said, where he accepted an indenture working in the tar and pitch industry, crucial to ship-building.

Balthazar was recruited to fight against the French in the New York area, Jerry learned, and although he was told his family would be taken care of, found them in poor shape when he returned. So Balthazar packed them up and migrated to the Midwest.

Founded in 1830 in New York, the LDS church has packed up and moved across the country due to persecution, ending up in Salt Lake City, Utah. The church is at the forefront of genealogy research, having compiled birth and death certificates, census records, obituaries, wills and deeds, and entered photocopies of the documents online. Then the records were indexed, Ballantyne said, allowing online access with a click.

Previously, genealogists had to travel to county courthouses to track down documents, spend hours at libraries spooling through reels of microfiche searching for obituaries, or drive back roads searching for family gravesites.

Mormons have an added incentive to find their roots. Like Catholics, who believe that prayers can speed the souls of the departed into the presence of God, Mormons can retroactively gather their ancestors into the fold by performing ordinances in the Temple, including baptism, confirmation and ordination.

"We believe that we are able to give them the chance to accept saving ordinances," Elder Ballantyne explained. "They can still make the choice to accept or reject them, still have the agency of free will."

The hope behind saying prayers, lighting candles or performing rites in the name of a departed family member is that all souls will be reunited in heaven — like at the Thanksgiving table, but without the fighting over who gets the last piece of pumpkin pie.

As Elder McCosh explains, "The highest degree of

heaven is being with our family."

That sentiment is something people may not appreciate until a generation of their family has shuffled off the mortal coil. Thanksgiving is a good time to ask older relatives the birth and death dates and places of parents and grandparents, and fill in the details of those war stories.

Another way to trace your family tree is to buy a white tablecloth and have everyone present at Thanksgiving dinner sign their name on the cloth with a laundry marker. You can use markers with different color ink, or if you're handy with a needle, embroider the signatures with different-colored thread, creating a family heirloom that can be added to, through the years.

The family-signature tablecloth Deb Mills of Clinton started creating in 2001 was featured on "Good Morning America" in 2016.

in France in World War I and received the Medal of Honor, the Croix de Guerre and other medals.

But unlike Sgt. York, considered the most decorated soldier of WWI, there is no movie about John Barkley.

Last Saturday, which was Veterans Day, Bill Simmons brought Barkley's story to the Windsor Historical Society meeting.

Simmons, who is from Windsor, said he has always been fascinated with Medal of Honor winners. When he read Barkley's combat memoir, he thought "Wow, this is better than Sgt. York."

York, who was 29, is known for leading an assault on a German machine nest, killing 25 enemy soldiers, collecting 35 machine guns and with seven other soldiers, bringing in 132 prisoners.

John Barkley, age 23, used his own initiative to single-handedly stop two advances of the German army, killing an estimated 200 enemy soldiers.

The story: John was acting as an observer a third of a mile from the German line. There was a lull in hostilities. His radio line being cut, John had no way to report, so had a choice of returning to his unit or taking the initiative.

Going to an abandoned German machine gun nest, John found a machine gun that the Germans had rendered useless by removing the breech block. Knowing that German soldiers did this, John always carried an extra breech block in his pocket, and repaired the machine gun. Then he noticed a disabled French tank nearby, with a hole where the tank's gun had been blown out, leaving an aperture. John snuck out to the tank, mounted the machine gun in the aperture and gathered up ammunition that had been left outside the tank, stacking it where he could reach it.

Then he sat in the tank and waited for the German soldiers to come out from the line of trees and into the open, like he had sat in a blind waiting for deer.

He held his fire until the enemy soldiers came level with the tank, then opened up, killing at least 200. They retreated, but advanced again. Figuring out where the machine gun fire was coming from, they started firing a 77-millimeter gun at the tank. A shell hit the tank's wheel drive, and the explosion knocked John unconscious.

When he came to, John thought he had been shot, but it was just blood from his nose and his jaw. He remained calm, cooling the overheated machine gun with oil, which created a terrible smell, and also using his canteen water.

Despite the acrid smoke, exhaustion, a broken nose, hunger and thirst, John stayed in the tank and kept firing, breaking up a second

attack. According to the Medal of Honor citation, John's efforts enabled U.S. forces to gain and hold Hill 25.

"When the Americans went out on the field, they found 4,000 shell casings around the tank," Bill said.

Pfc. John Barkley and Sgt. Alvin York both received their Medals of Honor from General John J. Pershing, plus medals from the French Republic, Italy and Montenegro. Both also received medals from Britain, but Barkley gave his away, Bill said, not having a very good opinion of the British or the French.

Before the United States entered the war and turned the tide, Simmons said, the British and French armies were retreating before the German army, which was heading towards Paris, Bill said.

"The Americans were not having that," he said.

After the explosion in the tank, John no longer had the stutter that he had been born with, and which originally prevented him from enlisting. The middle of eight children of Frank and Leona Barkley, John was 12 when his family moved from Blairstown to the Holden area in 1907. When the United States entered the war ten years later, John went to the Holden postmaster to enlist, but was told the Army didn't want men who couldn't talk.

So John went home, got his brother's draft notice and went to the Warrensburg recruitment office. Passing himself off as his brother, he kept this mouth shut or answered questions

in monosyllables, and was accepted. After training at Fort Funston and Fort Riley in Kansas, where he excelled as an observer, sniper and scout. He was shipped out to France in April of 1918, where the war was to last six more months.

"He was in a lot of battles," Bill said.

John Barkley returned to Missouri in 1919, joined the Army Reserves, and accepting a promotion, which he had avoided before, taught marksmanship at Tarleton University in Texas. During the last 30 years of his life, he lived in the Kansas City area. He died in 1966 at the age of 70, and was buried in Forest Hill Cemetery with full military honors.

The April 21, 1966 "Clinton Eye" reported that Mr. and Mrs. Paul Van Ormer of Clinton attended funeral services at Overland Park Presbyterian Church for Barkley, who was Mrs. Ormer's uncle.

Barkley was also survived by his wife and only child, Joan. At last Saturday's WHS meeting was Dan Henry of Calhoun, whose mother, nee Brooks, was John Barkley's first cousin. At one time, Dan said, he was related to everyone in Blairstown. A lot of his family served in the military, Dan said, and a Barkley had served in every American war.

Dan said he met the WWI hero several times, and remembers that Barkley once killed a large rattlesnake and made it into a belt.

Dan also recalled John Barkley wasn't a big man.

Unlike Alvin York, who was a heavy drinker before he found religion, John didn't drink, Bill said. Both Alvin and John liked a fight, how-

ever, and John was known as a person who never saw a rule he didn't break.

"He was always in trouble," Dan said, "and always had tall tales."

Dan said he used to correspond with Barkley's daughter, Joan, but doesn't know if she's still alive. Joan gave her father's medals to the National WWI Museum and Memorial in Kansas City, Dan said. Barkley's formal portrait is also at the National World War I Museum. It shows him in uniform, holding a ceremonial sword.

"It was the only weapon that Barkley never used," Bill said.

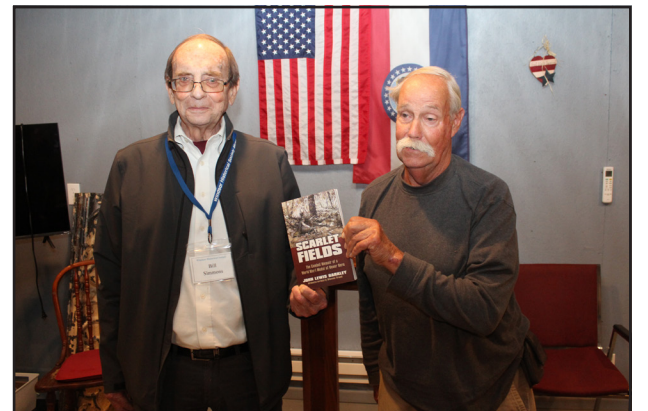
Bill Simmons has donated his copy of "Scarlet Fields" to the Windsor Historical Society, where it can be borrowed. Barkley wrote another book that was never published. The manuscript is at the Henry County Library, Bill said.

Barkley was a self-effacing man who didn't want to write his war memoirs, Bill said, but needed the money during the Depression. Royalty checks ranged from \$130 down to 37 cents, despite being considered America's response to "All Quiet on the Western Front." It is one of the best military books Bill said he has ever read.

Nov. 11 was originally called Armistice Day, the date when the ceasefire was declared that ended World War I. In 1954, it was changed to Veteran's Day to honor all veterans.

Bill said that when Barkley was told an armistice had been declared, he didn't know what the word meant.

"He didn't understand why he couldn't keep fighting," Bill said. "He loved combat."

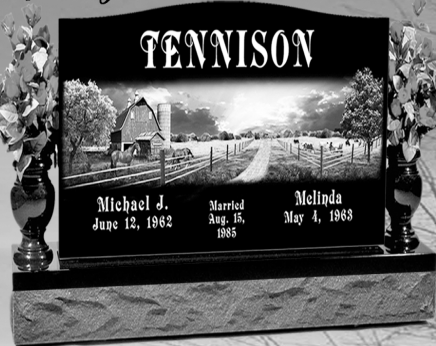

Anger is a universal emotion. Beneath anger is often fear or loss of control. We should try to think of our anger as a warning light.

3. Revenge Feels Right - Rather than pursuing justice, Gideon seeks revenge. The Bible calls us to forgiveness, not bitterness. We must remember to leave vengeance to the Lord.

Addressing our own warning lights may be tough, but necessary to avoid a breakdown. When we are struggling, we should H.A.L.T. and repent. We are most vulnerable to sin when we are Hungry, Angry, Lonely or Tired (H.A.L.T.). When we repent and confess, we can receive His forgiveness and purification. Are there warning lights in your life? Only He can fix our dashboard lights if we go to Him. Simply pause and ask God to examine your heart. Stay in the word and connected to other believers. 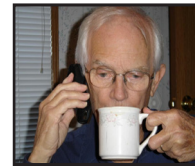

Please Drive Safely This Thanksgiving Holiday Weekend

Colonel Eric T. Olson, superintendent of the Missouri State Highway Patrol, reminds everyone there will be an increase in traffic over the Thanksgiving holiday. Drivers should remain alert to changes along their normal route. Regardless of traffic patterns, safety should remain a priority.

The counting period for the 2023 Thanksgiving holiday weekend is from 6 p.m. Wednesday, November 22, 2023, through 11:59 p.m. Sunday, November 26, 2023. Troopers will be participating in Operation C.A.R.E., enforcing all traffic laws, and available to assist the public. Over the 2022 Thanksgiving holiday counting period, nine people were killed and 482 injured in 1,355 traffic crashes.

Drivers should make sure their vehicles are in good condition and that they are well rested before they start driving. Remember: There is never a reason to speed, drive aggressively, or drive impaired.

If boating or fishing are part of your Thanksgiving holiday weekend plans, remember there is less daylight, which makes your vessel's navigation lights essential. Check your lights and have extra bulbs on board before you head out. This time of year, the water is becoming colder and hypothermia is a concern. The body loses heat 25 times faster in water than in the air of the same temperature. If you take an unexpected plunge in cold water, it's important to get out of the water and into dry clothes as soon as possible. Most boaters wear more clothing this time of year, so the proper wearing of life jackets and using caution to avoid falling overboard is even more important. Having a plan as to how you would exit the water if you inadvertently fell overboard is imperative. For example, does your boat have an exterior swim ladder to allow you to re-enter the vessel?

Watercraft operators must consider the effect their actions have on others: Share the waterway and use common sense, good judgment, and courtesy to ensure the safety of all. Life jackets save lives. Wear It!!

The public is encouraged to call the Patrol's Emergency Report Line (800) 525-5555 or *55 on your cellular phone if they witness criminal activity or experience an emergency. These phone numbers are operational for both highway and water emergencies. If your celebration includes alcohol, designate someone else to drive whether you are in your boat or your car. Please don't become a statistic.

State Fair Community College SFCC To Offer Dese-Approved Substitute Certification Training

State Fair Community College will offer a 12-week, hybrid format, Foundations of Education in a Diverse Society (EDUC 209) starting Jan. 30, 2024, for individuals seeking a substitute teacher certification from the Missouri Department of Elementary and Secondary Education (DESE).

The three-credit hour course will meet in person on Mondays and Wednesdays from 9-9:50 a.m. on the Sedalia campus, in addition to online class work. In-district tuition will be \$126 per credit hour, and tuition for Missouri residents will be \$191 per credit hour. The same course will also be offered in a fully online 16-week format beginning Jan. 16, 2024. Online courses, per credit hour is \$176.

Successful completion of English Composition I (ENGL 101) is a prerequisite to enroll in EDUC 209. Individuals who have not completed ENGL 101 may take a CLEP (college-level exam program) exam (fee applicable) to determine readiness for college-level courses. The CLEP exam is offered at the SFCC's Testing Center on the Sedalia campus.

SFCC students can take the course to become a substitute teacher regardless of their area of study. Those who are not currently enrolled at SFCC will need to apply by completing the free application at www.sfccmo.edu/apply. Applicants may choose to take the course for personal interest by checking the appropriate box on the application.

Report on the Audit of the Financial Statements

Opinions

comeback, ending second the period with a score of 10-10.

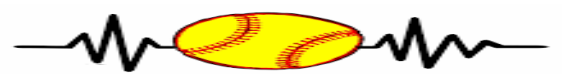
The freshmen players on the CHS squad truly made their mark during the Jamboree.
