Birds Of A Feather Rap Together: Chicken Festival Kicks Off In Clinton

The first flock of story-tellers arrived in Clinton Friday for the 31st annual RAP Story Weavers Chicken Festival.

RAP stands for River And Prairie, as the group is based in Kansas City, on the Missouri River, but draws members from the Kansas prairies. Every year the story weavers have a winter gathering, called the Chicken Festival, where they practice their art of spinning a yarn.

It is, as Linda Kuntz pointed out, the second largest chicken festival in the country.

"And the others involve live chickens," she said.

Linda, RAP event coordinator, arrived in Clinton with 10 other RAP members last Friday. Three of the story tellers entertained a small group who braved the cold temperatures to gather at the Clinton Senior Center. Ron Stewart of Liberty kicked off the session with a folksy tale about an older couple, Ollie and Marie,

and Marie's efforts to keep Ollie, a cobbler, active and engaged when all he wanted to do was sit in his chair and take afternoon nap.

Linda shared her husband's favorite story, about a road trip from Kansas City to Colorado that ended up with her being left behind at the gas station. Linda said the incident ended with the words no man wants to hear from his wife: "Give me the keys." Rich White had every-

body laughing at a tall tale told from the viewpoint of a 16-year-old boy who had to drive to southern Illinois and pick up his Aunt Edie and drive her back to Chicago. The trip along the IIlinois River Road involved the boy having to retrieve Aunt Edie's wooden leg, which she had propped on the dashboard, after they hit a pothole and the leg flew out of the car and ended up in an eagle's nest. He also retrieved her artificial arm, which his aunt took off and used to knock the leg out of the nest, where it was picked up by a squirrel, who used it to row across a stream to a beaver dam.

Rich, who is from Blue Springs, won the Kansas Storytelling Festival Tall Tales and the Missouri Liars Contest.



A survey of chicken festivals around the country reveal they are more focused on eating chickens rather than exhibiting fowl. The World Chicken Festival held in London, Kentucky, celebrates the life of Colonel Sanders. A National Fried Chicken Festival is held in New Orleans, and Knoxville holds the Big Kahuna Wing Festival. Poultry farmers in Lebanon, Missouri, attend an annual Cackle Hatchery Chicken Festival in October. The Cackle Hatchery Festival features show birds as well as poultry costume contests and egg-eating contests. Where do you get a chicken costume? The Henry County Museum recently received a costume with a checkered past, donated by Linda Lampkin, who restored the carousel in Appleton City. After Linda noticed an article about the Chicken Festival in the Clinton Daily Democrat, she got out the chicken costume she wore as an employee of Ralston Purina to give programs to school students about raising chicks, and donated it to the museum. Her program included taking live chicks to classrooms, as photos in the Kansas City Star attest. The prize for the weirdest chicken festival goes to a town in western Colorado, Fruita, which every spring, celebrates Mike the Headless Chicken. A symbol of survival, Mike was a rooster who lived 18 months —and toured the country on exhibit —after his head was cut off. The River and Prairie Storyweavers will return to Clinton Jan. 10, 11 and 12, 2025, and are already booked to perform a benefit concert for the Clinton Senior Center. RAP Storyweavers hold meetings in person on the third Thursday night of the month and the third Saturday of the month in Kansas City, and also on Zoom. Continued from page 1 the case on behalf of the State of Missouri. Brauer was represented by counsel.

The Prosecutor's Office filed charges based on a July 2022 incident that occurred at Artesian Park in Clinton. Two young men, Mason Roskop and Mitchell Andrew Raines, were shot by the defendant and died of multiple gunshot wounds. The defendant was charged for the death of Mitchell Andrew Raines. Brauer pled not guilty and requested a jury trial, which was conducted the week of January 8, 2024. More than one hundred Henry County citizens were summoned to appear for the jury selection process. The parties presented evidence to the jury for four days. After deliberating, the jury returned a verdict of guilty of voluntary manslaughter and armed criminal action. Voluntary manslaughter is a class B felony, which carries a range of punishment from five to fifteen years in prison. Sentencing is not yet set as a sentencing assessment report will need to be generated by Missouri Probation and Parole.

According to Prosecutor LaChrisha Gray, because Brauer was found guilty of armed criminal action, he will be required to serve at least three years in the Missouri Department of Corrections before being eligible for parole, but the total number of years will ultimately be determined by the court at sentencing.

Continued from page 1 It's an account of how, in September of 1861, 600 anti-slavery Jayhawkers, led by Capt. James Lane, came over Cemetery Ridge and looked down on Osceola. Suspecting the town was harboring Confederate sympathizers, they set up cannons and started shelling the town square, which was defended by 42 volunteers. As a result, every building except two were burned to the ground.

While the story is familiar to most people in mid-Mis-

cal paper and worked for a corporation in Utah for 42 years.

It was his newspaper editor that told Andy he should write a book. Andy's first book, "More Than a Job -An Adventure," won a Gold Quill Award for literature. A Vietnam veteran, he wrote about his experiences in the Navy.

"That was in 1986," Andy said, "and I have been writing ever since."

Linda's newest book is "From Pigtails to Turboprops," a memoir of her career as a pilot. Linda could be the poster child for STEM education for women — she was the director of flight operations for the third largest carrier of mail for the U.S. post office and UPS.

"When she retired, Linda was over 34 pilots who flew mail throughout the West and to Hawaii," Andy said.

Linda also wrote "The Osage of Missouri: People From the Stars," as well as several books about U.S. marshals and the lives of lawmen.

A fisherman and bow hunter, Andy also wrote "Andy's Fishing and Camping Guide to Utah." In 2007, he was the president of the League of Utah Writers.


In 2012, Andy and Linda moved back to the Osceola area, after a relative told them about a house and 10 acres going up for auction. It was niece Janie Horsman's Southern cooking that inspired Andy and Linda to write two volumes of "Ozarkia Cooking," he said. Andy still enjoys going out with his nephew Tim Horsman to set trot lines or snag spoonbills, he said, and he is thinking of taking up hunting again.

Ask him which side of the Civil War fence he favors, and Andy will tell you that his ancestors, like many families in Missouri, were a mixed lot.

"A lot of my friends are members of 'Sons of the Civil War," Andy said, "but I don't have a preference."

His indigenous heritage is also a source of stories. He has a Cherokee grandmother on one side, he said, and a Choctaw grandmother on the other. The Cherokee family, named Duke, homesteaded in the Osceola area in 1834. Andy attends Northern Cherokee Nation cultural gatherings and craft fairs, and is a familiar figure at Heritage Days in Warsaw and Rodeo Daze in Osceola.

Andy will not run out of conflicts to write about of the 10,000 military clashes that occurred during the

After the Civil War, riverboats continued to come up the Osage River to Osceola, Andy said, which served as a shipping point for nine counties. Was the bank money ever recovered that was buried before Lane's forces attacked on that September day?

"Yes," Andy said. "It was dug up and taken to Kansas City," so does not lie buried in the ashes of Osceola.

"Larry confessed his story about a Cat-a-Pult was not true, and no animals were harmed," Linda said.

That night, RAP members donated their talents to a fundraiser at the Delozier Theater for the historic Dorman House, which the Henry County Historical Society is restoring. The event, which started at 6 p.m, featured a chili and taco or chicken soup dinner, followed by live music by Larry Brown and stories by Denise Grow of Harrisonville, Alice Nathan of Blue Springs, Larry Brown, Ron Stewart, and Fran Stallings of Bartlesville, Okla.

Linda, who lives in Gladstone, said they expected about 40 more storytellers to arrive for the Chicken Festival on Saturday. Five members who planned to come had to stay home on water pipe-watch, she said, including a man who had to feed his wood stove, his only source of heat.

Saturday's schedule included a chicken-sock giveaway to those who had told stories Friday. A raucous auction was held, featuring hand-crafted items, during which "chicken stress balls" were tossed into the crowd. The storytellers adopted the festival name after a person noted that they had told stories about animals, but not chickens, Linda said. Storytellers walked to lunch and dinner on the Square, Linda said, and although looked for the Chick Capital of the World mural, did not find it.

RAP Storyweavers hold their winter festival in a different location every two souri, what you may not know is that until the Civil War, Osceola was the third largest town in the state. A prosperous port town on the Osage River. it went from 2,070 residents to a population of 187, he said. The loss included enslaved people who were working down at the harbor and fled to freedom, and nine local citizens who were executed when they refused to hand over the money in the bank to the Federal invaders.

"Jim Lane couldn't get the money because they buried it," Andy said.

To recompense his loss. Capt. Lane claimed kegs of Missouri sipping whiskey, two wagon loads of it, Andy said. In all, the raiders left towns with two hundred wagons of looted goods furniture, pianos and women's gowns.

"The chaplain went into one of our churches and stole the pews, pulpit and organ to take back to his new church in Lawrence," Andy said.

In 1948, when Andy was 4 years old, his family packed up and left Missouri, and moved to Utah. His father was a boomer, Andy said, meaning Jesse would go anywhere there were jobs, whether as a result of an oil boom or construction boom.

"He operated heavy equipment and drove trucks, and helped build the I-5 corridor," Andy said.

Andy started working as a chef's aide when he was 14 years old, he said, commandeered by his mother, who worked in a restaurant, to keep him off the street. He served four years in the U.S. Navy, attended Weber State College in Ogden, wrote an outdoor column for a lo-



an enormous impact on animal energy demands. Wet weather also results increased energy demands for livestock. To illustrate these points, I've formulated some beef cow diets for varying temperatures, hair coat conditions, and hay quality.

For these examples, I formulated diets for beef cows in late gestation with

Extreme cold weather has 2 pounds of corn and 1 pound of distiller's grains to meet energy and protein needs for a cow when it is 27 degrees and dry.

A wet cow will lose approximately 0.8 pounds per day at that temperature and supplement level. Eleven pounds of supplement, consisting of 9.5 pounds of corn and 1.5 pounds of distiller's grain is necessary to maintain

a body condition score of 5 designed to maintain body weight. Good hay (54% TDN, 8% CP) and bad hay (50% TDN, 7% CP) was used for the comparison. These are reasonable hay quality estimates based on results of hay samples I've received so far this year.

Let's consider the good hay first. If the temperature is 27 degrees and the animal has a dry hair coat, free choice hay plus 1 pound of corn will meet protein and energy demands. If the cow has a wet hair coat, this ration will only meet 69% of the energy requirement and 88% of the protein requirement resulting in an estimated loss of 0.75 pounds per day.

In order to meet energy requirements at 27 degrees with a wet hair coat, the supplement must be increased to 8 pounds of corn and 2 pounds of distiller's grains. If the temperature increases to 37 degrees, but the cow is still wet, a supplement consisting of 6 pounds of corn and 2 pounds of distiller's grains is needed to order to keep the cow from losing weight.

Bad quality hay increases the need for supplementation. Using the hay quality numbers above, it takes

cow body condition under these conditions. A wet cow at 37 degrees will need a supplement of 7.5 pounds of corn and 1.5 pounds of distiller's grains to meet energy and protein requirements.

I used corn and distiller's grains in these examples for ease of comparison. Other ingredients in different proportions can also be used to meet energy and protein requirements.

It is also important to note that cold and wet conditions result in large increases of supplement need. Increased supplementation at the rates in these examples is not practical nor recommended on a day-to-day basis. For this reason, it is important to have cows at an adequate body condition before extreme weather conditions exist. Then reasonable diet adjustments can be made when necessary and cows can used stored fat reserves to help make up for the energy deficits caused by cold, wet weather.



DISCERNING THE PROPHETS

In his gospel, Luke talks about the prophet Simeon and the prophetess Anna. (Luke, Chapter 2). They spent almost all their lives in the temple getting to know God. Each of them recognized the baby Jesus as the Messiah and believed. Upon seeing Jesus, they felt fulfilled and ready to depart this world.

Bruce Larson related the following story about three sisters in Lansing, Michigan. They had removed their clothes, smeared their bodies with mustard, and were riding around town in a stolen van. Apparently, they fancied themselves some sort of prophetesses. They told the police they were reading the Bible when the Holy Spirit spoke to them. Having read that Adam and Eve were naked in the garden of Eden, they discarded their clothes. Then they read the passage that likens faith to a grain of mustard seed and lathered their bodies with mustard. The stolen van seems to have had no biblical explanation. It would seem these three sisters were filled with something other than the Holy Spirit.

Obviously the three sisters were not prophetesses. A prophet may speak harsh words, truths painful to hear but sane. Sometimes the prophets accompanied their prophecies with physical demonstrations. However, they earned the right to speak for the Lord before their prophetic demonstrations. Such was the case for Simeon and Anna.

Sometimes prophets spoke futuristically, but their main purpose was to speak of man's sins, false values, and unloving behavior. They were not fortune tellers but forth tellers. When you understand the work of a prophet, you realize all Christians should be prophets. The authenticity of a prophet is determined by their relationship to God. The aged couple Zechariah and Elizabeth were reported as being "upright in the sight of God" (Luke 1:6), and God blessed them. in the Republican primary election


