Warsaw R-IX District Seeks Bond For Building Improvements

Lack Of Quorum Turns Warsaw Meeting Into Work Session On \$30M Improvement Plans

The need for improvements to the buildings of the Warsaw R-9 School District has prompted the Board of Education to ask voters to approve Proposition KIDS on April 2. The bond issue will *not* increase the tax rate but will give the district an \$18,000,000 general bond to construct, remodel, upgrade and repair existing buildings.

According to R-9 Superintendent Scott Gemes, the district is in need of additional rooms as well as much needed remodel and repair to existing buildings. One of the biggest projects on the list is the addition of a new fifth grade wing to John Boise Middle School to free up space for Pre-K in the two elementary schools.

"One of the projects is to construct a new fifth grade wing at John Boise Middle School that will be a storm shelter for all high school and JBMS students and staff," said Gemes. "The fifth graders will have their own wing and will have limited interaction with other middle school grade levels. We also plan to have a playground near their wing so the fifth graders will still have recess."

Moving the fifth grade to JBMS will allow for

PROPOSITION KIDS will be on the ballot when voters head to the polls on April 2. The R-IX District is seeking a multi-million dollar bond to make improvements to facilities. A meeting will be held on March 11 in the WHS gymnasium at 6:00 PM where voters will have the chance to learn more about the district's proposition plan. Superintendent Scott Gemes and Assistant Superintendent Shannon Deckard presented a rendering of proposed changes.

Pre-K/ECSE students to be located at both North and South Elementary Schools. Presently, all Pre-K/ECSE students are sent to the R-9 South Elementary School because of a lack of classrooms at the North school. The district leases one trailer using ECSE

funds to help pay for it for all the district Pre-K/ECSE students. All North students travel to South on a separate bus route from North. Parents with elementary students often have students in both elementary buildings. Another project is the

remodel of elementary restrooms at both North and South Elementary schools. There are also plans to include a corridor wall replacement for South Elementary School. Updates to playgrounds at both schools are also in the plans.

R-9 South Elementary School was constructed in 1953 and North Elementary was built in 1958. There are also plans for Warsaw High School to have an additional set of restrooms built. There are 400 students in WHS and

Lacking a quorum, Aldermen Adam Howe, Lou Breshears, Eric Flores, plus Mayor Eddie Simon and several City of Warsaw employees met on Monday eve, March 4 at 6:00 PM to hear Administrator Randy Pogue and City Engineer Charlie Page discuss a proposed \$30 million plan for Main Street improvements and several other additional upgrades in other areas of the city. City Clerk Jessica Kendall recorded the session. Aldermen absent were Rob Coskey and Reba Slavens.

Those improvements could include widening of Polk and Commercial Streets and construction of sidewalks, bike lanes and gutters there, improving exits and entrances to Walmart, widening the roadway to Northtown Casey's, improvements at Bothwell Clinic, and Drake Harbor renovations. The designs of those projects will be done by Engineer Page. "And the entire project will be subject to availability of funds," said Administrator Pogue.

The administrator furnished a tentative schedule for the several projects: Main Street CDBG and TAP - Advertise for bids mid-summer, construction starts in the

Milestone In Music: Local DJ Spins 10,000 Broadcasts

On-air radio personality Kenny Treece was a farm boy who loved listening to music and radio when he landed his first radio job in Warsaw at Ozark 98 in April of 1984. Although he produced radio programs at other stations in Clinton, Sedalia, Marshall and Lake of the Ozarks, he kept returning to Warsaw and returned here for good, the fifth time, nine years ago. He recently produced his 10,000th radio show that has been aired from a studio.

"I like to wake up in the morning and give listeners something to hear," said Treece. "Warsaw is home to me and when I worked

other places, I learned new things that I brought back to the local station. I plan to be here until I finish."

The Warsaw radio station first went on the air in 1980 (according to www.bing.com), and Treece said it has always done well. He said early on new country music

was played in the morning and midday, but in the evening hours he believes there was some pop music.

Treece said that when he worked at a Clinton radio station, rock music was played, and in Sedalia there was country music on the morning show and

the top 40 songs were played midday. Country music was played by other stations in the area.

"I have been in the business 40 years, and the biggest change I have seen is the rise of automation and computers," said Treece. "There used to be someone in the studio every hour. Now programs are automated, and it is not unusual for me to pre-record my programs early in the morning. That includes the Friday night program that includes a lot of music from the 1960's, 1970's, 1980's, and big bands. The Friday night program is about nine years old and popular."

Treece said in the past the radio station was on the air from 6:00 AM until 10:00 PM and later aired until midnight. He says now

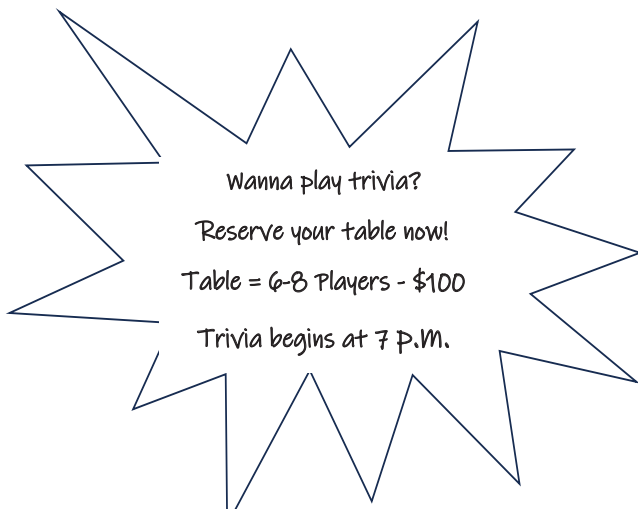

1 (7-ounce) can chopped green chilies
1 cup thick and chunky salsa
2 (15-ounce) cans seasoned chili bean with their sauce
1 cup shredded cheddar cheese

Preheat oven to 350 degrees.

(Continued from Page 1) only one girl's and one boy's restroom at the present time. "The additional restrooms will be near the present sophomore hallway," said Gemes. "We plan to enclose the area between the old art room building and the music room so students will not have to walk outside to get to class."

Gemes went on to explain that the present art department and science classes will be relocated to the area which is presently a walkway between buildings. The building located at the back of the school will be remodeled into an alternative school for students who are struggling academically, students who need credit recovery and students who need an alternative learning environment.

Another remodeling project for WHS includes the music department with plans for improvement to the WHS stage to improve sound quality for performances as well as a remodel of the band and vocal music rooms.

"We currently have two bonds," said Gemes. "One set is to be paid off in 2026 and the other bond will be paid off in 2039. This bond would be paid off in 2044," said Gemes.

The current Warsaw R-9 bond is \$3.55. This will not change if the bond is passed.

An informational meeting about the proposed bond will be held on Monday, March 11 in the WHS gym starting at 6:00 PM.

The University of Missouri Extension of Benton County will hold a Spring Lawn Maintenance Workshop from 10:00 AM-Noon on Tuesday, March 12.

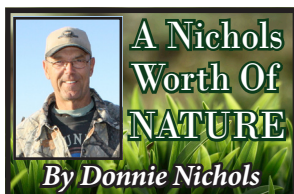

February 2024's average temperature was the second warmest since Missouri started keeping records in 1895. Each year I record in my journal the date I first hear spring peepers. They are the earliest species of Missouri frogs and toads to become vocal. Males begin calling to attract females. This year I heard them calling on February 2 which is the earliest I have ever heard them call. Within the past three weeks I have seen two species of butterflies, some moths, flies and bees fluttering around in sunny areas. In our woods, Pileated woodpeckers are drumming on trees establishing territories. Many bird species are becoming more vocal as they also declare territories. We have bluebirds building nests in some of our boxes and activity around others. Two weeks ago there were three woodcocks in the woods behind our house. On our glade area, and in our native plant flower gardens, many plants have emerged. It will soon be time to plant flowers and gardens.

The Journal of Biological Conservation suggests 40% of all insect species are in serious decline and some have diminished by as much as 75%. Almost all of our native bird species are also in decline, some perilously so. As sad as the situation is we can make a difference. I strongly recommend (implore you) to consider planting native plants around your house, gardens and property.

Insects are extremely important in all food webs. A mere 1% of insects react with humans in a negative way. The other 99% pollinate plants, return tied up nutrients in dead plants and animals to the soil, keep populations of insect herbivores in check, aerate the soil and provide food either directly or

indirectly for most other animals (including man). For example, 96% of all terrestrial bird species rely on insects to feed their young. Pound for pound insects provide more protein than beef.

You don't have to have good soil for native plants. Kim and I have established two native flower gardens by our house. One is 15'x24' and the other is 8'x10'. We also have native plants around our house. Our soil is so poor and rocky (we do live in Benton County!) we often have to use a crowbar to plant. The only time we water natives is when we first plant them. We never use fertilizer or chemicals and they thrive. Also, put native plants around your garden. They attract insects that pollinate your vegetables which increases production.

By using native plants you not only help sustain our native wildlife species, both flora and fauna, but plants native to where they evolved have morphological adaptations that make them much easier to grow.

You can find a native plant of almost any color or height requiring anywhere from

full sun to full shade that will not only look beautiful and enhance your property but will also benefit many other native species.

Wouldn't it be great to have native plantings up and down your street or in your neighborhood. Take a little spot (or more), get your kids or grandkids involved to plant some native plants that attract other native species. Help them learn about nature and sustainability. After all, it's their world we are supposed to be taking care of.

In previous years, this has been fairly simple and somewhat obvious in naming the best high school basketball players in Benton County. This season, not so much.

I asked eight people from Cole Camp to name their best three girls players and I received eight different lists with only Emma Thayer being an overwhelming choice. So this season was very difficult choosing players on the second team on both the girls and the boys side. I had to make tough choices.

With that being said, we want to thank all of the players for their dedication and hard work this season. Our apologies if we left out your favorite player.

Let's look at head-to-head team matchups before we begin with our selections.

On the girls' side, Warsaw ended up 9-18, beating Lincoln twice, 36-24 in the Warsaw tourney and then 41-22 at Lincoln. They defeated Cole Camp 50-35 in the second game of the season at Warsaw.

Lincoln finished 8-17, losing to Cole Camp at Cole Camp, 25-23 and as mentioned above lost twice to Warsaw.

Cole Camp ended up 6-20, beating Lincoln and losing to Warsaw twice as

previously mentioned. On the boys side, Cole Camp finished 21-7. They beat Lincoln in the conference tournament at State Fair, 43-32 and at Lincoln, 65-41 and beat Warsaw twice, 55-39 at Warsaw and at Stover in districts, 53-33. Lincoln ended 7-18 and Warsaw 5-19. Warsaw won the first game 60-59 in their own tournament and lost 59-34 at Lincoln.

Anyway, here's the selections for this year:

Boys First Team

Gentry Dieckman, senior, 6'6", Cole Camp - He was All-State last year. Had an awesome defensive game against Versailles in district play. Had 18 points and blocked numerous shots and caused havoc against their high powered offense.

He recorded 19.1 ppg, 60 assists, 226 rebounds and 69 blocks and had numerous dunks during the season in entertaining the fans.

He was the best player in Benton County, bar none. Besides dunking, his favorite move was to drive the paint and dish off to an open teammate for a layup.

Because of his slender frame, his speed, his quickness and being able to handle the ball in the open court, teams would play him very physically and sometimes even brutal. He took some hard hits but to his credit, he kept getting up.

Logan Gemes, junior, 6'1", Warsaw - It can be difficult

to find many bright spots on a 5-19 team, but Gemes was one for the Wildcats.

After being named to the second team last season, we said he'd be "fun to watch" and "should lead Warsaw's program". He was and did just that.

Gemes led the Wildcats with 15.3 ppg and also tied for the team lead for rpg with 6.4. He was on the leaderboard for about every major stat.

His biggest game this season came in a loss at Versailles where he dropped 44 on the Tigers.

Probably the best pure basketball player that Warsaw has seen on the floor since Matt Luebbert.

Reid Harrison, senior, 5'10", Cole Camp - Improved his shooting over last season. Was perhaps the best defensive player in the area. He was Cole Camp's best ball handler and he caused teams problems in applying a full court press. He could fly by defenders in the open court.

He averaged 15.1 ppg and shot 74 percent from the free throw line.

Harrison was a team player and, along with Dieckman, gave the Bluebirds a deadly one-two threat.

Cole Camp will have to wait awhile to have two athletes of their all-around caliber to grace their court again.

Injuries kept him from exceeding even greater expectations. Head football and basketball Coach Kevin Shearer called him the best

athlete he's coached in 33 years.

Ben Eckhoff, sophomore, 6'3", Lincoln - Opposing coaches dread the time when he matures as a player in the next two years. He has a great future as an inside force and rebounder. Had a couple of twenty point games. Saw defenses collapse on him. As he hits the weight room and learns more about scoring inside, none of that will even matter.

Just another good Lincoln kid that you want to see succeed. He comes from a basketball family and is well liked among his teammates.

Grady Strathman, senior, 5'10", Cole Camp - Tremendous outside shooter when he was on and could bust up a zone in a hurry. He averaged 9.3 ppg and had 47 assists. He was a good defender and capable ball handler. Had good basketball IQ which is missing among many players playing today.

Well mannered, unselfish on the court and the type of kid you want on your team.

Boys Second Team

Riley Sanders, sophomore, 6'0", Lincoln - Injuries kept him out of early season games. He never hit his stride. Can drive full court and shoot outside and he can light up a crowd with his athleticism.

Struggled with inexperience, bad passes and turnovers. Had to learn the point guard job on the run. Can play all five positions when needed and can be as

good as he wants to be. Lincoln needs a floor leader, a general to take charge and lead by example. Connor Lynde passed Sanders the torch. Stay tuned. The best is yet to come.

Matthew Bright, senior, 6'1", Cole Camp - Very underrated player. He guarded much bigger players underneath the basket. Made Cole Camp better when he was on the court. Took scoring load off of Dieckman by getting open underneath for a quick layup. He used the backboard well which is a lost art.

Just like he did at a tight end, he caught defenders off guard. Played bigger than he was.

Tyler Howard, senior, 6'0", Cole Camp - Howard improved as season went on. Gave Cole Camp another ball handler and a three point shooter.

Good defender and excellent team player. Fought for loose balls. Could get an occasional rebound. Under rated player as eyes were on the two big stars.

Xavier Smith, senior, 5'9", Lincoln - While other guards were injured, Xavier played in every game and started in most. He improved offensively, defensively and as a ball handler as the season wore on. He held his head up after missing a key late second shot in Warsaw game. That would have devastated a lot of players but he took it in stride and kept his poise. He hustled at every opportunity.

Looking at the stats, he was strong at the end as he made 8 points in their last game as their third leading scorer as Sanders had 12 and Eckhoff had 8 of their 36.

He had 10 as their second leading scorer as Eckhoff

had 13 in their 43-40 loss to Otterville in their last regular season game.

He provided senior leadership as one of only two seniors. Zaden Cole was the other.

Garrett Ferguson, junior, 5'9", Warsaw - Ferguson doesn't do a whole lot that is flashy, but he does the little things that should help lead to wins.

He is an above average ball handler but his ability to see the floor and distribute the ball is his biggest attribute.

A true floor general, if Ferguson can add to the 8.3 ppg that he averaged this year, he could be a first teamer when we announce this list next year.

Girls

First Team
Tanna Howe, sophomore, 5'5", Warsaw - Last year we called her the "best point guard in Benton County" and this year she didn't do anything to change our minds.

She improved her scoring average from 10.2 a year ago to 14.9 in 2023-24. Defenses planning for her opened opportunities for other players and that was a big factor in the Ladycats recording their highest win total since 2009-10.

She still showed up on about every statistical leaderboard and if others keep coming along with her, the Ladycats might just be finally turning things around.

Alyssa Mellen, junior, 5'8", Lincoln - Lincoln's leading scorer. Made first team last season. Outside shooter. Loved to drive to the basket. Needs to work on layups and shots close to basket for next year.

Scored in the twenties several times. Made huge free throws in close games. Good defender and rebounder. She carried the team offensively at times.

Keira Mostaffa, junior, 5'6", Warsaw - Mostaffa has proved herself as a deadly weapon from beyond the arc but don't take her for granted down low either because she can beat you there too.

She also led the team in steals and came in second in assists

Though the numbers don't necessarily jump off the page, Mostaffa has statistically improved her game every year for the Ladycats. If she does that next year, she and Howe could be a really nice 1-2 punch for the Warsaw offense.

Emma Thayer, junior, 5'4", Cole Camp - Their leading scorer at 5.2 ppg. At times, went on a tear shooting threes. Had two games of five each. Has good basketball IQ.

In a rebuilding year, Thayer showed leadership and was one of their best ball handlers. Will have even a bigger role next

Miss Louise Moore (Campbell) was their sponsor. Seniors playing on the 23-4 basketball team were Bob Miller, Stanley Intelmann, Don and Dean Bistline, and Robert Tolliver. They were coached by Harold Holley.

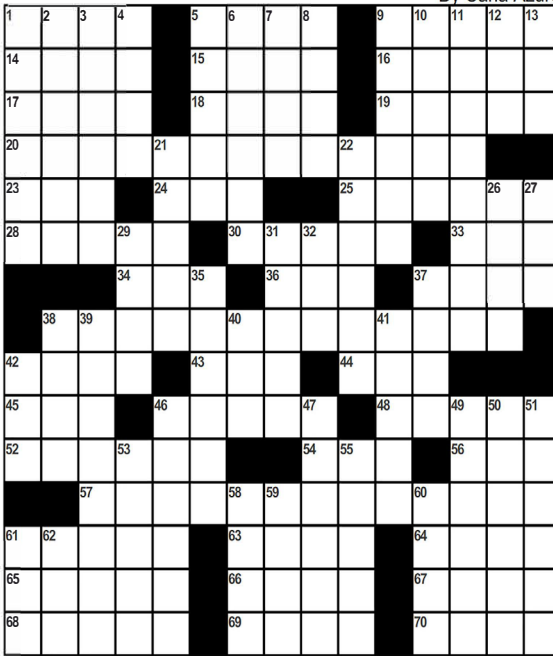

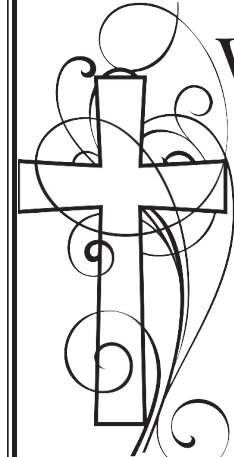

March 8 is International Women's Day, a day for celebrating all the accomplishments of women around the globe. But many women still need to make up ground in one key area: retirement security.

Women's challenges in achieving a secure retirement are due to several factors, including these:

- **Pay gap** – It's smaller than it once was, but a wage gap still exists between men and women. In fact, women earn, on average, about 82 cents for every dollar that men earn, according to the Census Bureau. And even though this gap narrows considerably at higher educational levels, it's still a source of concern. Women who earn less than men will likely contribute less to 401(k) plans and will ultimately see smaller Social Security checks.
- **Longer lives** – At age 65, women live, on average, about 20 more years, compared to almost 17 for men, according to the Social Security Administration. Those extra years mean extra expenses.

Caregiving responsibilities – Traditionally, women have done much of the caregiving for young children and older parents. And while this caregiving is done with love, it also comes with financial sacrifice. Consider this: The average employment-related costs for mothers providing unpaid care is nearly \$300,000 over a lifetime, according to the U.S. Department of Labor — which translates to a reduction of 15% of lifetime earnings. Furthermore, time away from the workforce results in fewer contributions to 401(k) and other employer-sponsored retirement plans.

Ultimately, these issues can leave women with a retirement security deficit. Here are some moves that can help close this gap:

- **Contribute as much as possible to retirement plans.** Try to contribute as much as you can afford to your 401(k) or similar employer-

sponsored retirement plan. Your earnings can grow tax deferred and your contributions can lower your taxable income. (With a Roth 401(k), contributions aren't deductible, but earnings and withdrawals are tax free, provided you meet certain conditions.) At a minimum, contribute enough to earn your employer's matching contribution, if one is offered, and try to boost your contributions whenever your salary goes up. If you don't have access to a 401(k), but you have earned income, you can contribute to an IRA. Even if you don't have earned income, but you have a spouse who does, you might be eligible to contribute to a spousal IRA.

- **Maximize Social Security benefits.** You can start taking Social Security at 62, but your monthly checks will be much bigger if you can afford to wait until your full retirement age, which will be around 66½. If you are married, you may want to coordinate your benefits with those of your spouse — in some cases, it makes sense for the spouse with the lower benefits to claim first, based on their earnings record, and apply for spousal benefits later, when the spouse with higher benefits begins to collect.
- **Build an emergency fund.** Try to build an emergency fund containing up to six months' worth of living expenses, with the money kept in a liquid account. Having this fund available will help protect you from having to dip into your retirement accounts for large, unexpected costs, such as a major home or car repair.

It's unfortunate, but women still must travel a more difficult road than men to reach retirement security. But making the right moves can help ease the journey.
