# One Of The Lucky Ones: Young **Author Tells His Story In Clinton**

When Wyatt Shield was 5 years old, he told his teacher, Mrs. Brun, that he would write a book that would be in the school library by the time he graduated from kindergarten.

Wyatt almost made that deadline, writing a book that was published the day before he entered first grade. Last Thursday, Wyatt, who is 8 years old, was in Clinton with his parents and his grandfather to read his book to the Sunrise Optimist Club at 7 a.m., at the Henry County Library at 10 a.m., and to the Clinton Rotary Club at noon.

What motivated him to write the book?

"I wanted people to know that God made us all different, and that it's okay to be different," Wyatt said. "Some people have green eyes, some people have blue eyes or brown eyes, and some of us have 12 fingers."

Wyatt considers himself one of the lucky ones. He was born with an extra digit on each hand. When he was a year old, he had surgery at Shriners Children's St. Louis to remove the extra digits, and when he was 5 years old, returned to correct the angles of the growth plates in his hands. It was when he was in

kindergarten that Wyatt told his mother, Amanda Shield, that he knew his story, and asked her if she should write it down. So she went and got a piece of paper and Wyatt dictated it to her straight through,

Aug.5, 2022. By Sept. 15, the story had gone global.

"We met with a reporter in Los Angeles, and the story got picked up on every continent except Antarctica," Amanda said. "We sold 1,500 to 2,000 books in a year and a half."

The readings in Clinton were arranged by Fred Bunch, a local attorney and a Shriner, who is a friend of Wyatt's grandfather, Kyle Rhorer, also a Shriner.

Wyatt is naturally outgoing, and is not fazed by speaking in public, his mother said, recalling the first presentation they were asked to make at a local Shriners club.

"I carefully prepared a talk with slides and timed it,"Amanda said. "I put Wyatt in a chair, and he pulled the microphone over and said, 'Hi, I'm Wyatt."

ton always knew she wanted to be an artist, even though art was not part of her life when she was growing up on a farm in Appleton City. One of her earliest memories was when she was 3 years old, and went with her parents to the home of Exie Mae Peeler to pay the rent on the property they farmed.

"I still remember being more excited about what was on the walls than the people in the room," Bonnie said. "I was drawn into the pictures."

"I learned later they were her artwork."

Even though there were no art classes in school, Bonnie went on to develop her talents as an artist after she graduated from Appleton City High School in 1965. And wherever she lived, Bonnie created art.

By 4th grade, other students were asking her to draw pictures for them. When she was 13, after begging and begging, her mother ordered her a set of oil paints, an easel and brushes from the Sears Catalogue.



pearances after learning that Wyatt and his parents and grandfather, who live in Wichita, were going to the 100th anniversary celebration of Shriners Children's St. Louis and Clinton would be a good halfway stop. Wyatt gives part of the sales of each book to the St. Louis hospital and to the Shriners' Plane of Mercy program, which pays for patients' airfare to the hos-

Wyatt also donated 375 books to the hospital to share with pediatric orthopedic patients, his mother said, and participated in a virtual fundraising walk for the hospital after his second surgery.

"The first year he raised more than \$2,500 and was the top fundraiser," Amanda said. "He walked nine miles in a week wearing a cast up to his shoulder."

The next year, Wyatt was again the top fundraiser, leading the walk and bringing in more than \$3,000. Between the walks and the books, Wyatt has given back \$10,000 to the hospital, Amanda said.

Wyatt has also made author appearances in Kansas, Oklahoma and Texas. The family went back to the first hand surgeon they had consulted after he was born, who had told them that Wyatt would need eight to 10 surgeries and not be able to write his name when he was in kindergarten.

Instead, Wyatt was a published author with a global following. He signed his name in cursive at the end of the book, which he read aloud to his first grade class.

"I wanted to prove that little kids can do big things," said Wyatt, who was inspired by his kindergarten teacher and the biblical story of David.

The book led to other big things. Wyatt has thrown the first pitch at a Kansas City Royals Game and was named the honorary team captain at a University of

Oklahoma baseball game. When he was 6 years old, he was one of the guest authors at the Kansas City Book Fair, participating in a panel of youth authors. Asked if he could read his book aloud, Wyatt replied, "Well, I read it last week to 250 women."

Last Thursday afternoon, after the three readings in Clinton, the Shield family drove to St. Louis. On Friday, Wyatt was scheduled to meet with the Shriners Children's board of directors, and on Saturday, to march in the procession at the hospital's 100th anniversary party at the Chase Park Plaza Hotel.

The party celebrated 100 years of hope and healing at Shriners Children's St. Louis, one of 22 hospitals the Shriners operate across the country. Six specialize Valley Shrine Club will have one of their mini-rods on display at their annual sale of Vidalia onions, a fundraiser scheduled at Westlake Hardware this spring.

some of those paintings." After high school, she worked as a window display and interiors designer for J.C.Penney, based at Blue Ridge Mall. Marrying Bill Shelton from Montrose took her to Saudi Arabia in 1975, where Bill, who had worked in a bank in Montrose and for TWA, set up an accounting system for an airline.

In Saudi Arabia, Bonnie started teaching art as well as selling her work. The Sheltons came back to the states four years later, and lived in Houston, where Bonnie also taught art, then moved to Jefferson City, which had a very large art community.

Moving back to West Central Missouri, she taught in Warrensburg, Kansas City, Warsaw and Clinton, and was part of the Creative Kids program at First Baptist Church in Clinton. She got a job offer from the North Kansas City school district to teach art classes in the community education program, and also taught classes near Whiteman Air Force base.

In 2019, Bonnie was the first person to win both first place in the professional painting category and Best of Show in the Ike Palmer Art Show during Olde Glory

Bonnie works in all mediums — oils, acrylics, pastels - and paints all subjects. But her favorite is animals poultry, sheep, cattle, and even camels when she lived in the Middle East. Every painting holds a memory. A winter landscape of a pasture captures a moment when she was a teenager, and she and her father had to go out in a blizzard to the back pasture, where the cows were calving. Another painting records a snowy road through the woods near Jefferson City.

Bonnie's parents eventually bought the 350 acre-farm in Appleton City from Exie Mae Peeler, Bonnie said. A 1917 graduate of Appleton

City High School, Exie Mae is remembered as the pansy lady for growing pansies and taking them around town, according to Linda Lampkin. Exie Mae passed away at the age of 94 in 1993, and in addition to inspiring Bonnie with her artwork, left a monetary legacy to Linda's church, First Christian in Appleton City, who used it to build a fellowship hall named in her honor.

According to the internet, the name Exie is a variant of the name Axel, a medieval form of the Hebrew name, Absalom, which means "my father is peace," and presages a child who will be blessed with a serene life.

Serenity is the feeling that comes through in many of Bonnie's paintings. Bonnie said she admires Edwin Landseer, an English artist known for his paintings of horses, dogs and stags. She also likes the work of French artists William Bouguereau, Jean-Leon Gerome and Rose Bonheur.

Bonnie said she was so busy filling commissions that she turned down the honor of being the featured artist in the Mid-MO art show the first time she was asked. One of Bonnie's largest commissions was painting a picture of a red farmhouse and outbuildings for a local farmer.

She will have many of her paintings for sale at the May 4 and 5 Fine Arts Show in Warrensburg. The Sunday Jammers will be playing music on Sunday afternoon at the show.

gunshot wounds. The defendant was charged for the death of Mitchell Andrew Raines and pled not guilty.

A jury trial was conducted on the week of January 8, 2024 and the jury heard evidence from the parties for four days. After deliberation, the jury returned a verdict of guilty for voluntary manslaughter, a class B felony with a maximum of fifteen years, and armed criminal action, an unclassified felony with a maximum of fifteen years.

On April 17th, 2024, a sentencing hearing was held. After hearing argument from both sides and statements from the Raines and Roskop families as well as the defendant himself, the court sentenced Brauer to ten years for voluntary manslaughter, and six years for armed criminal action. The sentences shall run consecutively to one another, for a total of sixteen years. Brauer must serve three years by law for the count of armed criminal action before being eligible for parole for the six-year sentence.


#### Daum Museum's Current Exhibitions

# Washburn University Debate **Team First in the Nation**



The Washburn University debate team has been crowned the national champions at the National Forensic Association (NFA) Debate Lincoln-Douglas Championships hosted by Central Michigan University in Mt. Pleasant, Michigan, April 18 – 22. Western Kentucky University earned second place, North Texas University third and the University of Nebraska at Lincoln took home fourth place honors.

Washburn's Cade Blenden (junior) is the tournament champion and has been named the top speaker of the championship. Also earning top honors are Jacob Bailes (junior) finishing in the top eight, Dan Archer (senior), Logan Michael (senior) and Andrew Rea (junior) finishing in the top 16, Maddox Misak (freshman) and Alfonso Rascon (freshman) advancing through to the top 32. Rea was also named the fourth top speaker overall.

Wendo Kimori (freshman), Braxton Kindel (sophomore), Hunter Squires (junior) and Jyaira Ware (freshman) also competed in this tournament. Kimori, Squires and Ware all went 3-3, narrowly missing advancing passed elimination rounds. Current graduate student in Washburn's master's communication and leadership program. The NFA Championship is the national championship for collegiate Lincoln-Douglas debate. Each debater receives four to five minutes of preparation time to use between speeches however they like.

**UCM Junior Receives Top Student Employee Award**

Donovan Hoyes, a junior accounting major from Sweet Springs, has received the top honor in an annual program that recognizes exemplary student employees at the University of Central Missouri. Hoyes received the Student Employee of the Year award in the ceremony conducted on April 8 by UCM's Office of Human Resources.

The event, which took place during National Student Employment Week, also recognized two other students as second- and third-place honorees in a field of 16 students who were nominated for awards. Joining Hoyes was the second-place award recipient, Kara Henderson, a senior fashion major from Raytown, Missouri, and the third-place honoree, McKenna Strodtman, a senior criminal justice major from Columbia, Missouri. They represent the top student employees at an institution that employs 945 part-time student workers.

UCM President Roger Best presented the student awards. Each of the top three honorees received a trophy, certificate, and a sponsored financial award. All other nominees received certificates.

In his remarks, Best praised the students for their role in doing "the great work we do every day in redefining what's possible for all of our students, and our faculty and staff."

Cory Wicker, associate vice president for human resources, said students being recognized "embody the spirit of excellence within our UCM community."

"In our role in higher education, this moment stands as a testament to the dedication and excellence that define our institution...without our dedicated staff and their tireless accomplishments and our students' accomplishments,our institution's vision would not thrive as it does," Wicker told the gathering during the award ceremony in the James C. Kirkpatrick Library.

The top selections for the Student Employee of the Year awards were based on nominations submitted by faculty and staff members who represent campus units in which each student was employed. In naming the

nonorees, committee members considered criteria related to community service, diversity and inclusion, leadership, technology, innovation, and critical thinking.

UCM's Office of Human

Resources coordinates the awards ceremony. Three organizations outside of campus provided financial support for monetary awards given to the first-, second-, and third-place honorees. As the first-place award recipient, Hoyes received a \$500 prize made possible by Associated Electric Cooperative, Inc.; Henderson received a \$250 award sponsored by McConnell & Associates; and Strodtman received a \$100 prize from Missouri Division of Social Services. Representatives of all of these organizations where there to help honor the award winners.

According to nomination documents submitted on behalf of the award winners, all three of them have had a positive impact on the offices that employee them. They exemplify characteristics of individuals for whom the awards are intended.

Hoyes has served as a student employee in the Office of Human Resources since July 2023. In this capacity, he is in a front-facing position that enables him to engage with many different individuals from diverse backgrounds, both inside and outside of the university. colleagues Professional who nominated Hoyes noted that "he is always very professional, kind, and understanding to anyone who enters our office for assistance" and "he creates a welcoming space for everyone on campus."

While exhibiting qualities of a strong business leader, Hoyes has demonstrated the ability to inspire and guide others toward common goals. He is a strong advocate for diversity and consistently seeks ways to promote understanding and unity among his peers. As an example, he works with many international students who experience issues ranging from finding student employment to obtaining required documentation for hire. His co-workers state that he listens to these stuto student worker for training other students, and he has had the opportunity to extend his support to professional workers, including helping two new hires in the office to learn about the filing and imaging process.

Outside the office, he has mentored incoming freshman students who have expressed an interest in accounting, in addition to serving as treasurer for the Student Government Association.

Henderson joined the Career and Life Design Center in October 2022, and her leadership skills led to her becoming the lead Professional Clothing Studio Assistant. In this capacity she is part of a free service to students that supports their efforts to prepare for professional endeavors. More than 1,400 students have utilized this service and more than 4.100 articles of clothing have been distributed to fulfill needs for professional attire, whether it is to dress for an interview or attend a special event.

"Kara's commitment to ensuring that every student feels valued and empowered through their experience at the Studio is why she is incredible in her role as the Lead Professional Clothing Studio Assistant," nominator stated. "By creating a welcoming and supportive environment, she has not only helped students acquire appropriate attire but also boosted their confidence and readiness for various opportunities such as interviews, internships, and next steps after UCM."

Henderson's colleagues note that during her first year as a student employee, she single-handedly managed the studio. She oversaw its operating hours, spearheaded marketing efforts that help reflect a welcoming atmosphere at the center for all students, and coordinated donations. As the demand for this service has grown, this fall, the Career and Life Design Center recruited an assistant whom mentored. Henderson trained, and collaborated with to develop a comprehensive strategy for the Studio's visibility at UCM. She has also leveraged technology to aid students through the browsing and selection process of clothing items, aid in accepting donations, and to monitor popular items.

Setting a great example as a student who helps other students while demonstrating leadership, McKenna Strodtman has served as a student employee at the Success Advising Center since January 2022. She is one of three Senior Academic Success Coaches who provides support for approximately 250 undergraduate students who are majoring in diverse disciplines. She also actively engages in the campus community through her role as mentor for the UNIV 1400 (University Foundations) and as a teaching assistant for UNIV 1410 (Exploring Majors and Careers) and UNIV 1620 (Reset for Success) courses. Students who have interacted with Strodtman have praised her "personable, kind and relatable" approach that has made them feel comfortable and university life much less intimidating, according to her nominators with the Succes Advising Center.

As a peer mentor and teaching assistant, Strodtman has considerable oneon-one interaction with students throughout the semester, which enables her to help them with goal setting, time management, organization, resource referral and success strategies. Caring about helping other students to stay on track for graduation, she works closely with new freshmen, transfer students and students in at-risk populations, and encourages them individually to visit with her.

A nominator in the Success Advising Center stated, McKenna's compassionate approach, coupled with her listening ear, empathy, and unwavering support, has earned her praise from the students she assists, who often return multiple time times to see her due to her helpfulness."

In addition to her work at the Success Advising Center, Strodtman is active in campus organizations such as areas around Pertle Springs.
