A team of firefighters from the Clinton Fire Department have been recognized for their exceptional heroism and life-saving efforts during a recent emergency in which a young man fell into a grain bin. The team's quick and skill-

ful response ensured the

young man's survival in a

dangerous situation.

Firefighters Bayley Heider & Ethan Houk, Engineer Jarrod Hix, Lieutenant Nathan Lochner & Lieutenant Jeremy Millam, were acknowledged for their teamwork and bravery in the rescue mission. The team demonstrated exceptional coordination and resourcefulness under pressure, a hallmark of their dedication to public safety.

Auxiliary Lieutenant Michael Morales and Captain Wade Glasscock received special commendations for their roles in the rescue. Both received a life-saving medal for their outstanding work and experience in rope rescue, holding level 3 certifications in the discipline.

Their expertise played a

crucial role in navigating the challenging and risky environment within the grain bin.

The incident occurred on April 29th when the young man fell into the grain bin and became trapped. Responding swiftly, the team assessed the situation and devised a plan to extract the individual. Lieutenant

# Do The Boomerang! Baby **Bottle Fundraiser Returns**

Throw an empty baby bottle out of the door and it won't come back to you. But fill a baby bottle with spare change, checks or dollar bills and take it to Door of Hope, and it will return tenfold in the form of hope and support for local mothers and children.

Last week, the Door of Hope, a pregnancy resource center on South celebrated Washington, the 15th anniversary of opening its doors. That's also how long it's been doing the "Baby Bottle Boomerang" to raise money to pay for diapers, wipes and formula for new babies. All are provided free of charge, along with classes for mothers and fathers on parenting, budgeting, special circumstances and a host of other topics.

The idea of BBB: to take a baby bottle and fill it with spare chain, checks of bills. In the past, it's been church congregations that have mainly participated, distributing bottles on Mother's Day and collecting

them on Father's Day. But Diane Kelce hopes to open it up so that more people will participate. You can pick up bottles during office hours at 205 S. Washington, Monday through Thursday, 9 a.m. to 5 p.m.

"If you donate \$100 or more, you get a Missouri tax credit of 70 percent of what you donate," Diane

Door of Hope's free services come with no strings attached, and serve people of all ages, Diane said. Joe Haskins and Bill Moose teach a fatherhood class for men. Bill is the former director of Door of Hope, which has three full-time employees, two part-time employees and six volunteers, plus more volunteers who help with the annual banquet in September

Diane, who is from Clinton, was hired as Door of Hope's executive director

in September of 2023. People may know her from when she was the city clerk in Deepwater.

"I thought I would retire there," she said, "but God had other plans." "He called me here."

Some of the people Door of Hope serves are referred by the Department of Health Services or the court system, Diane said. Others come through the Baby Bottles Page 3

door by themselves or with a friend. Services at Door of Hope include a medical-quality pregnancy test, and STI testing and treatment, and ultra-sounds for up to 14 weeks.

Dolores Tillman is one of three nurses who volunteer at Door of Hope, and has been for 13 years. The staff and volunteers work as a team to provide a caring support system for prospective parents who may not have one, Diane said.

"It's knowing we're here to walk through the process with them," she said. Door of Hope staff and volunteers do not judge anyone or their situation, Diane said, but provide services with care and compassion. They also don't ask anyone about their financial situation. All the information is kept confidential —all they need is a name, address and contact information, Diane said. The number of clients varies from month to month, she said, but they serve more than 1,000 clients a

The amount of money the Baby Bottle Boomerang brings in also varies, from a high of \$11,000 one year to \$6,000 last year. Diane hopes to get the word out about BBB and have the amount back up.

"We've had \$100 bills, checks and coins," Diane said of what people put in

Door of Hope is also a great referral resource for the community, she said.

"We are here to serve," she said. "We are going to give help to everyone who comes through the door. Our hearts are big."

Door of Hope is located at 205 S. Washington, just past the southwest corner of the Clinton Square. Call 660-890-7011.

Continued from page 1 stantial budget cuts passed

by the state's General Assembly. These cuts severely impact vital programs serving people with disabilities, including assistive technology, employment services, and in-home health care.

MOCIL, which serves over 100,000 Missourians annually, warns that these budget reductions may lead to staff reductions and hinder their ability to provide essential services. Moreover, with nearly one in three Missouri adults living with a disability, the implications of these cuts are profound. Missouri Centers for Independent Living (MOCIL) are deeply disappointed by the steep cuts to programs serving people with disabilities passed by Missouri's General Assembly Friday May 10, 2024. We have never seen a budget process like this one. No public testimony was taken, and duly elected representatives and senators from both sides of the aisle were not allowed to offer amendments and openly express the needs of their constituents.

A small number of senators controlled the daily schedule. Very little new legislation will be passed, including a much-needed update to the Circuit Breaker Property Tax Relief bill that enjoyed bi-partisan support and would have improved the household budgets of many seniors and people with disabili-

ties. MOCIL provided services to more than 100,000 Missourians last year - through vital programs like assistive technology, employment programs, and in-home health/ consumer-directed services. Assistance with bathing, cooking, housecleaning, and medications can protect health and prevent unnecessary and expensive hospitalizations and admittance to nursing homes.

Funding for Missouri Centers for Independent Living already lagged far behind national averages. With less state funding for Fiscal Year 2025, we may have to reduce staffing if we cannot locate other funding.

Those with disabilities should speak up as hardships are created by the budget cuts. Nearly one in three Missouri adults lives with a disability. We have not been speaking out in a loud, united way. This year's budget process demonstrates why we must do so.

the country setting up projects, but the majority of the time he will be in Clinton, where on May 24, he and spouse Jessica Hendershot are opening a bicycle shop and ice cream parlor on Main Street.

They have three reasons. The first, Ben said, is the popularity of the KATY Trail, the longest rails to trails bicycle path, which draws cyclists from all over the world. The second: Clinton didn't have a bicycle shop. And third: they want to provide local youth with a safe activity that's an alternative to team sports.

"We want to serve the community," Ben said.

Ben and Jessica were living in Peculiar, but two years ago, saw a house they liked in Clinton and moved. At the time, there was no ice cream shop, so they decided to combine the bike shop with a soda fountain to serve ice cream and milk shakes.

Jennifer Hinton and daughter Sarah Smidt, meanwhile, were remodeling an empty building on Main, planning to create three units of a Bed and Breakfast on the second floor for cyclists using the KATY Trail. They wanted to rent the street level to a bicycle shop and maybe a bakery, so when Mark Dawson, community development director for Clinton, connected the Hendershots to the Hintons, it was a good match.

The bike shop, called Cycles and Cream, will open on May 24. The bike side of the business will carry Specialized, Surly and State

brand bicycles, Jessica said. Ben is the cyclist in the family, she said, and has ridden the KATY Trail. They have two daughters, Mariah, 2, and Raina, 12, a cheerleader who is in the honor society and the band at Clinton Middle School.

The ice cream will be from the Tillamook Dairy on the Oregon coast, famous for its cheddar cheese and ice cream. Sodas and shakes will be served from the old-fashioned soda fountain in the back of the Clinton

Adding to the vintage vibe are the pink formica tables and blue booths, which Jennifer Hinton gave them. She found them at a vintage

store and was storing them at the old Clinton Daily Democrat Building.

The Hendershots have a map they are going to hang on the wall, so cyclists can mark where they are from. Jessica is from Ozarks, Mo., Ben said, so Clinton is halfway between there and Kansas City.

Ben said he lived a lot of different places when he was growing up in addition to the Kansas City area. In the Marine Corps, Ben served in the Third FAST (Fleet Anti-terrorism Team) platoon, an elite unit based in Norfolk, Virginia, and in California.

Like the winner of the Kentucky Derby, the second annual Mother's Day Brunch & Bubbly staged by the Clinton Mid-Day Optimist Club started out with long odds. Because of highschool graduation parties, all the venues in town were taken for the Saturday before Mother's Day, May 12.

So the Optimists booked the Clinton Country Club for May 4. But they were less than optimistic because tickets sales were slow out of the gate compared to the previous year, according to club member Kristi Kenney. In 2023, the brunch was held on Mother's Day weekend at the Delozier Building.





an increase in boating traffic on the state's lakes and rivers. Drivers and boat operators are reminded to follow all Missouri's laws and be courteous. Always wear a seat belt when traveling in a vehicle, and wear a life jacket when near, on, or in the water.

This year's Memorial Day holiday counting period begins at 6 p.m., Friday, May 24, and ends at 11:59 p.m., Monday, May 27, 2024. Every available trooper will be on the road or on the water, enforcing Missouri laws and assisting people. Troopers on our roadways will focus their attention on hazardous moving violations, speed violations, and impaired drivers. The Patrol will be participating in Operation C.A.R.E. (Crash Awareness Reduction Effort) during Memorial Day weekend.

Over the 2023 Memorial Day holiday weekend, 13 people died and 403 were injured in 990 traffic crashes. (Troopers worked 287 traffic crashes involving 12 fatalities and 117 injuries.) The Memorial Day weekend is also an unofficial start to the boating season. During the 2023 Memorial Day weekend, there were 10 boating crashes which included no fatalities and two injuries. No one drowned over last

end. Last year, troopers made 137 driving while intoxicated and eight boating while intoxicated arrests.

Always be courteous and pay attention, whether you're operating a vehicle or a vessel, and choose to be a sober driver on land and on the water. A safe, fun weekend is the result of planning and making good decisions.

Motorists or boaters in need of assistance or who want to report a crime should use the Highway Patrol's Emergency Assistance number 1-800-525-5555 (or \*55 on a cellular phone). For road condition reports, travelers can visit the Patrol's website at https://statepatrol.dps. mo.gov. Click on the Road Condition icon to view road construction areas as well as road conditions throughout the state or call 1-888-275-6636.

Motorists are encouraged to do their part to make Missouri's roadways safer. Speed, inattention, and impaired driving are leading causes of traffic crashes. Please obey all traffic laws and make sure everyone in the vehicle is properly restrained in a seat belt or child restraint.

When you're on the water, please be courteous to others enjoying Missouri's lakes and rivers, wear a life jacket, and obey the law regarding safe operation of a vessel. Always observe no

wake zones. Causing harm to another person or their property with an excessive boat wake may subject you to enforcement action or civil liability.

When you're traveling up Missouri's rivers in a jet boat, turn off the motor for a second and listen before navigating around that bend. River bends create blind spots. Listening for boats coming down the river allows you time to give way. Also, jet boats should stay closer to the center of the river to give floaters

When operating a power-driven vessel, it's important to understand the rules of navigation. Power-driven vessels must give way to anchored or disabled vessels, vessels restricted in their ability to maneuver, and commercial fishing vessels. Power-driven vessels also yield to a sailboat under sail unless it is overtaking. Observing right-of-way rules makes our waterways safer for everyone.

Always treat other boaters and property owners as you want to be treated. Never operate a boat while you are impaired; never ride with an impaired operator Remember: Life jackets save lives. Wear It!! Follow the Patrol on "X" for the most current news @MSHPTrooperGHQ




