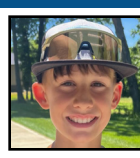

Flags Fly High For Warsaw Leathernecks Amid Ceremony

Incorporating this heartfelt addition, the narrative for the Warsaw Leathernecks MCL #1254 at 607 East Jefferson Street in Warsaw becomes even more personal and poignant.

"The flag, for me, is not just a symbol but a profound reminder of freedom, strength, and the sacrifices required to maintain these values," stated Eric Kirby, member.

"My decision to serve from August of '84 to August of '88, including over three years stationed overseas as an 0311 Infantry, was driven by the deep respect and honor I feel towards what our flag represents to the world. It's a privilege to have carried that flag on

foreign lands, a testament to the ideals we hold dear." What is a Leatherneck?

Leatherneck is a military slang term in the U.S. for a member of the United States Marine Corps. It is generally believed to originate in the

wearing of a "leather stock" that went around the neck.

The mission of the Marine Corps League Leatherneck community is to promote the interest and preserve traditions of the United States Marine Corps;

strengthen the fraternity of Marines and their families; serve Marines and FMF Navy Personnel who wear or who have worn the Eagle, Globe, and Anchor; and foster the ideals of Americanism.

The Marine Corps League offers funeral honors, scholarship, and award programs, assists transitioning Marines through the Marine for Life program, and resources for Marines and their dependents in communities across the country.

"With the new flagpole and flags, we, the Leathernecks Warsaw Leathernecks MCL #1254, aspire to signify our detachment's steadfast presence in our town—always ready to support our community and ensure our flag is revered," Kirby said.

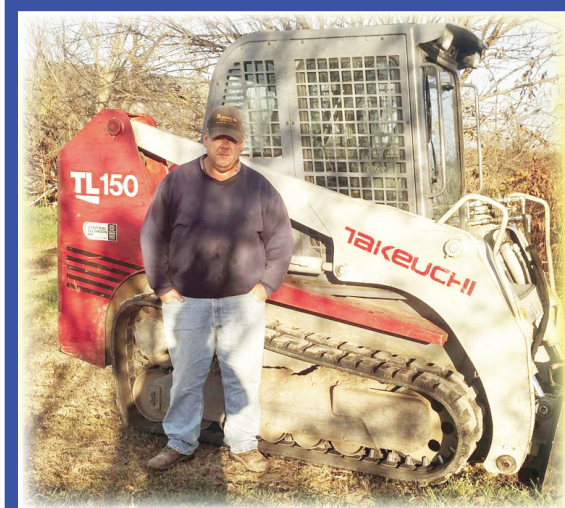

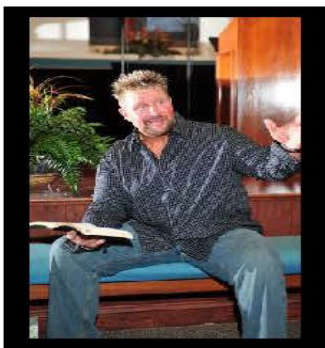

When tomatoes are in season, this is one of my favorite salads. I use red torpedo onions if they are available.

- 1 red onion, about 6 ounces, peeled
- 2 seedless oranges, 10-12 ounces each
- 6 ripe plum tomatoes, about 12 ounces
- ½ cup lightly packed flat leaf parsley leaves

Dressing:
2 tablespoons cider vinegar
3 tablespoons good olive oil
1 teaspoon Worcestershire sauce
Salt and pepper to taste
Mix together.

Cut the onion lengthwise into 1/8-inch-thick slices. Separate into rings and place in serving bowl. Peel oranges (removing all the white pith) cut crosswise into ¼ inch slices and put into serving bowl.

Cut the tomatoes in half, gently squeeze out seeds, cut into 1-inch pieces, add to onions and oranges, sprinkle parsley over top. Add dressing, toss and serve.

Today, as they roll into town, they bring with them a plethora of food trucks, games, fun entertainment, and rides, transforming each location into a bustling hub of joy and laughter. Their story is one of resilience, adaptability, and an unwavering commitment to bringing happiness to communities, with Warsaw emerging as a cherished stop, akin to a vacation, thanks to its welcoming community, picturesque lake views, and fishing stories of Fred (long-time crew member) bringing his 20 fishing rods and catching catfish that lasts for years in his freezer.

Life on the road has evolved significantly for the Jones. Gone are the days of cramped quarters in the back of a semi. Now, they travel in comfort, with a bunkhouse equipped with showers, satellite TV, laundry facilities, and a beautiful travel trailer, making the journey as enjoyable as the destination. Carl's dedication to driving for over 30 years and Darcy's meticulous management of everything from food to prizes have been the backbone of the carnival's seamless operation.

In an economy marked by instability, the carnival still thrives, offering families an affordable escape filled with joy and excitement.

Carl and Darcy were colleagues in the retail sector, where Carl served as Darcy's supervisor. Suddenly, they found themselves without employment when the business closed its doors. Their interest was captured by a shop specializing in hand-blown glass, where Darcy learned to create glass sculptures of elephants and roses.

The four-year collaboration with Toby's Amusement in Joplin laid the groundwork for their independent success and they ventured out on their own and fell in love.

The annual Carnival Convention-Missouri Association Fairs and Festivals in Osage Beach at Margaritaville play a crucial role in their continued journey, offering opportunities to discover new games, food stands, and rides, and to book future locations through committee connections and word of mouth. It was at one such convention that they were referred to Chuck Allcorn, who introduced them to the charm of Warsaw.

The carnival's lingo, "jump" means transporting the Carnival equipment from one spot to the next.

Every "spot" is where the Carnival operates and where they "play"

"Joint" refers to the game and the "ride jockey" is the crew working the ride adding to its unique culture. Carl emphasizes the importance of integrity in hiring, ensuring that each team member contributes to a safe and enjoyable experience for all. The Jones & Company Carnival prides itself on its selection of rides, including the rare ZIGZAG ride, one of two in the United States, and places community safety above all, with rigorous training for operators.

The testament of the longevity of their crew was witnessed with Evon "Vonny" Timblin embarked on her carnival journey at the tender age of 14, a voyage that began in Minnesota, weaved through Iowa, and culminated in Missouri. I had the pleasure of catching up with her as she was setting up her booth at the 57th Annual Jubilee Days Carnival in Drake Harbor. Vonny recounted how her adventure started when her parents sent her to watch over her older sister who had joined the carnival, a place she never managed to leave. She giggled and shared with me that her Sister only lasted two weeks. Amidst the whirlwind of carnival life, she raised four children. One of her fondest memories, she shared, involves the joy of watching fathers and their children at the Cork Hour booth, where kids shoot play guns with corks and their faces light up with excitement when winning the beloved prizes. "It gets in your blood," she said, "and you just can't leave."

Vonny has witnessed the joy of generations; seeing little ones play at her game booth, then watching those children grow up and bring their kids, and even their grandchildren, to share in the fun. It's a unique pleasure that has allowed her to see

Benton County Sheriff's Office Investigating Shooting Last Tuesday Night



On 06/04/24 at approximately 10:42 PM a 911 call came into the Benton County Central dispatch. The caller, Kathleen "Dawn" Burr 49, stated that her husband, Nicholas Burr Sr. 41 had been shot by their juvenile son (age 15) while she was being physically assaulted. Nicholas did not survive his wounds and was pronounced dead at the scene. This incident occurred in Arrowhead Estates in rural Edwards. This is an ongoing investigation with a massive amount of evidence to be processed. As of today's date, we have not had an opportunity to interview the juvenile due to the complexities of dealing with juvenile law. We do not have the most important perspective of this incident, the juvenile's point of view. Preliminary investigations based on the scene, the initial processing of evidence, Kathleen's interview and injuries are consistent with domestic violence. The preliminary investigation suggests "Self-defense or defense of another" under the Missouri Revised Statute 563.031, was warranted. Both Kathleen and her son were transported by ambulance for a medical evaluation for injuries received during the incident. Both were treated and released from a nearby hospital. The juvenile is not in custody. I will update you as we get further information.

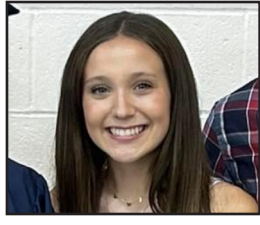

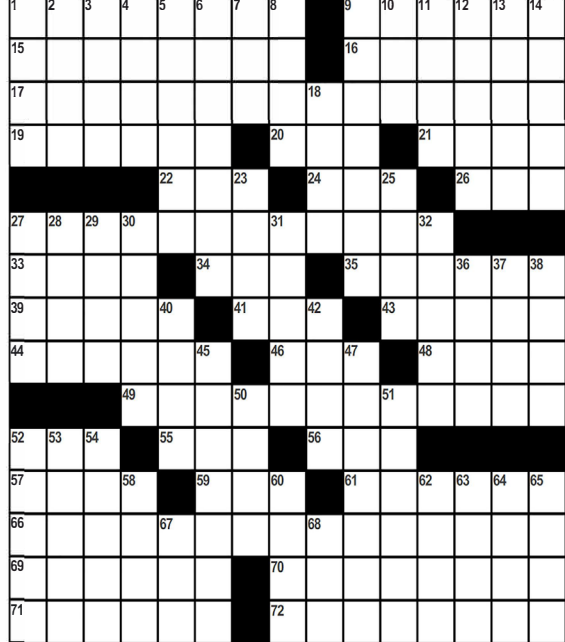

stuck with only Juneteenth as a new holiday.

The meeting opened at 6:00 PM on June 10, with Aldermen Barbara Hammond, Phil Fisher, Seth Casey and Lietzke present. Mayor Glen Nelson was absent, and Alderman Fisher served as Mayor Pro-Tem. Deputy City Clerk Kerrie Casey recorded the session in the absence of City Clerk Sabrina Brown.

First actions by the group were to approve the eve's amended agenda, minutes of it's May meeting, and authorize payment of bills presented.

Benton County Economic Director Jo Ann Lane then provided a followup on the "Safe Streets 4 All" program, to see if that board is interested in submitting an application for a planning grant. The group wished to do so. She also spoke about "Zone 31," a business that is expanding in Lincoln.

There was no old business. Police Chief Jason Wenberg then reported that his department made 20 traffic stops in May, issued three tickets, and experienced no accidents.

Public Works Director Josh Cole said his department has been doing "general stuff," also installed a culvert, and approved all work accomplished.

Clerk Casey had no report.

Also in new business, aldermen approved renewal of its Municipal Airport liability insurance with the same firm at, \$1,997, a \$182 increase over the previous year. Mayor Pro-Tem Fisher discussed whether to add an additional signor to the city's general operating and Capital Improvement bank accounts at Community National Bank. The group added Deputy Clerk Casey to presently authorized signors on those accounts. Lastly, Mayor Pro-Tem Fisher, noting that the Park Board's nine members are presently serving three year terms, suggested adding two new three year members: Amy Biggerstaff and Mikel Rehle. Aldermen agreed.

The group moved into closed session just after 6:20 PM.

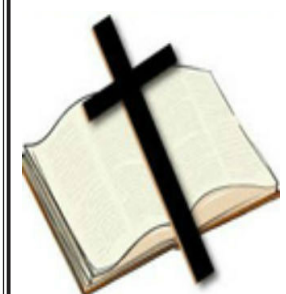

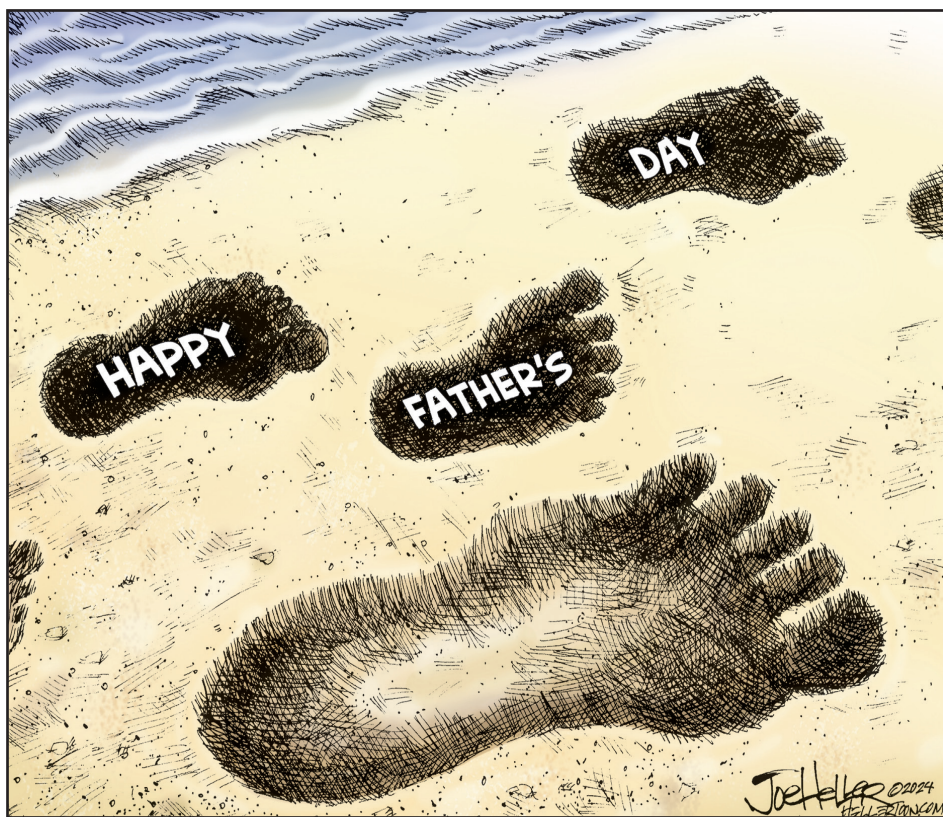

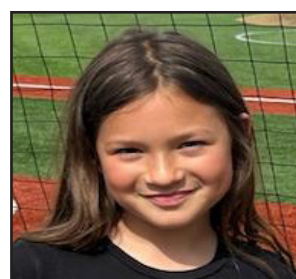

Benton County Commissioners Accept Bids For Water Heater, Chain Link Fence

The Commissioners voted to accept the bid from White Branch Handyman Service in the amount of \$13,500.

A Benton County citizen met with the Commissioners to discuss noxious weeds on Hanna Avenue.

Another Benton County citizen also met with the Commissioners to discuss issues pertaining to aggressive canines in his area. The Commissioners indicated that an ordinance has been adopted to address problems of this nature and that contact should be made with the sheriff's office and the prosecuting attorney's office.
