# VOL. 146 • NO. 29 Thursday • July 18, 2024 Warsaw's Transportation System Will See Stunning Transformation



Warsaw has been revitalizing its downtown and building up Drake Harbor's Recreation Area for many years resulting in parks, trails and other outdoor areas to walk, bicycle, and have events. There have also been improvements in infrastructure and other amenities. A key person enabling the city to receive many grants to help fund these projects is City Administrator Randy Pogue. One grant he has applied for since 2009, has been elusive until this year when the City of Warsaw became one of four Missouri cities to receive this year's Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant in the amount of \$24,997,004. Pogue says that the funds will be used to build on efforts to enhance mobility and community connectivity.

Pogue issued a statement outlining the RAISE Complete Street Project overview as follows.

"The \$25 million RAISE Complete Street project is moving into the final phases of completing necessary documents and contracts to be reviewed and approved by the Federal Highway

Administration (FWHA)," said Pogue.

He added, "This process has been a lengthy task requiring several meetings between the City of Warsaw and the FHWA. Part of this process is creating a fee proposal for the city to perform a design build construction project delivery. This type of project delivery requires the city to complete the first 30% of the design

engineer have completed the draft fee proposal and have submitted it to the FHWA for review. The city is hopeful that the draft fee proposal will be approved by the end of this year. Once approved, the city will be given notice to proceed with the 30% design documents. Eventually, the design documents will be provided documents. engineer team. The tasks within the 30% design documents are survey, environmental and cultural review, landscape review and various amenities like street lights. Using street lights as an

example, the 30% design documents will look at Main Street, Jackson Street, and Commercial Street to determine examples of street lights that can be provided

to a design team who will perform the final 70% of the design work. The lights will guide the design team in selecting an approved light that distinguishes each roadway with its own unique individual look.

In advance of the RAISE roadway improvements, a perfect example of a Complete Street will be Main Street in the Eastgate retail district. This project **RAISE Page 3** 

### **One Of FBI's Most Wanted** May Remain In **Stover Area**



The Stover Police Department says the FBI alerted their Department that Donald Eugene Fields II could be in the area. Fields was placed on the May 2023 most wanted list after allegedly sex trafficking a child in Missouri between 2013 and 2017.

He is wanted for the alleged sex trafficking of at least one child in Missouri. A federal arrest warrant was issued on December 8, 2022, in the U.S. District Court of the Eastern District of Missouri after he was charged with sex trafficking children.

According to the FBI, Fields has allegedly demonstrated a pattern of abusing minor females in his circle that are entrusted to his care, manipulating them to earn their trust quickly and using their own resources to take advantage of them.

The FBI is offering a reward of up to \$250,000 for information leading to Fields arrest. This amount reflects the FBI's decision in May of 2023 to increase the reward from \$100,000 to \$250,000 to aid in capturing individuals on the Ten Most Wanted List.

Fields is 58 years old and has brown hair and hazel eves. He is between 6'0" and 6'4" and weighs about 235 pounds. He is a white male FBI Page 3

### In Beautord Wilson Case



Morgan County Deputy arrested 50 year-Chad Armstrong old on Friday, July 12. Armstrong is now being held at the Morgan County Detention Center on a no bond warrant. Charges are First degree murder and armed criminal action. He is accused of killing Beauford Wilson of Hallsville MO, who was found dead by a Buffalo Creek neighbor on Sunday, June 30, after Wilson's truck was seen by the side of Beechnut Road, south of Stover.

The Morgan County Sheriff's office began investigating the case, and an autopsy confirmed it was intentional homicide



from multiple gunshot wounds. According to the probable cause statement, Wilson's wallet and its contents were not found with him at the scene. Investigators were told Wilson usually carried a large amount of money on his person. Deputies believed Wilson was killed at a different location and then moved to Beechnut Road in his own truck bed. One of my easy go-to recipes is sautéed bananas; I love them with vanilla ice cream. The best bananas for this recipe are just ripe, yellow with barely any brown spots. This is easy enough to double and terrific with just about any of your favorite toppings.

4 bananas, ripe but not too soft

3 tablespoons unsalted butter

Flour for dredging

2 tablespoons sugar, plus more to pass at the table Fresh lemon juice for the

table

Peel bananas; cut them in half crosswise, then lengthwise, so each banana has been made into four pieces. Place butter in large, deep skillet over medium high heat.

Dredge banana pieces lightly in the flour, shaking them to remove the excess. When the butter foam subsides, add the pieces to the skillet. Cook, turning frequently until they are golden and beginning to brown, about 10 minutes.

Sprinkle with two tablespoons of sugar, cook one minute more.

Serve, passing additional sugar, lemon juice, topping of your choice.

(Continued from Page 1) will soon advertise for bids that include unique lighting that has been selected specific for this area. The roadway reconstruction will be fully ADA-compliant and incorporate bike lanes, sidewalks, landscape and improved entrances to each business.

The RAISE transportation improvements that will occur are enhancements to our three primary roadways. This is Main, Jackson and Commercial Streets. Altogether, the project will add 5.8 miles of sidewalks, 5.3 miles of bike lanes, and 0.5 miles of multi-use trails, increasing affordable transportation choices and making it safer for our residents to choose active transportation, which in turn reduces vehicle dependency.

Today, Warsaw's transportation network accommodates vehicle travel only and fails to serve the large percent of the population who typically walk, bike, or use their wheelchair throughout the Enhancing community. mobility and community connectivity throughout Warsaw is a primary purpose of this project and has been a focus of improvement for the past two decades. Over the years we have completed multiple planning efforts that have guided our vision and implementation of capital projects. This RAISE Project will build on these past efforts to radically transform our transportation system into a multimodal network that will serve the entire community."

(Continued from Page 1) They have made their home in Benton County for over 25 years. Chanda is a teacher with the Warsaw R-9 School District. The Chiles are parents of two grown sons, Seth and Cade and the grandparents of a granddaughter.

Chiles said that his main job is overseeing the routine operation of Harry S. Truman Dam and Reservoir as well as managing the 50 employees who work maintenance, hydro power, water quality, safety, recreation and community relationships. Chiles commented that the staff at HSTD work together to manage the project in accordance with the purposes of flood control, hydroelectric power generation, fish and wildlife management and recreation. "We have to balance the need for electricity with the water conditions downstream as well as flooding conditions," said "It is really a Chiles. balancing of what is needed at the time." Presently the road across the dam is closed as the staff works on routine maintenance. The road should reopen sometime this winter. The U.S. Army Corps of Engineers built and manages the lake and dam. It is used primarily for flood control. Other uses include power generation, recreation, and wildlife management. named Originally Kaysinger Bluff Dam and Reservoir in 1954,

when construction was authorized. construction began in August 1964. It was renamed the Harry S Truman Dam and Reservoir, in honor of the former president from Missouri, by Congress in 1970. Construction was completed in 1979. The Kaysinger name refers to the bluff immediately north next to where the dam was eventually constructed. The bluff or cliff, a popular even landmark before the dam, overlooked the confluence of the South Grand River, Tebo Creek and the Osage River. The visitor center now sits on

the bluff. Completing the Truman Project took many years of planning, land acquisition, constructing new bridges and demolishing old Several roads, ones. towns, and cemeteries had to be relocated. The first construction project completed on the project was relocating Route 13 so it would be above maximum pool level.

The creation of the lake forced the closure of the Frisco Railroad's "Highline". Rising water levels severed the railroad tracks near Osceola and Deepwater and railroad officials declined to spend millions of dollars to reroute the lightly used tracks. The Missouri-Kansas-Texas Railroad, however, did relocate its main line between La Due and Clinton; the project included five miles of new track and a causeway/bridge combination over the lake. "My goal is to maintain

and preserve the area to pass on to future generations," said Chiles.

(Continued from Page 1) Cause statement, deputies found a bullet hole in the bed of Wilson's Ford F-150 as well as a 9mm shell casing. Dried blood was also visible on the inner tailgate. On July 3, Wilson's truck location data was examined. It reportedly said the vehicle was at Armstrong's residence on June 29 at 11:51 AM. Then there was a gap in the vehicle's GPS data. The next GPS data log was on June 30 at 8:40 AM, where Wilson's body was found.

According to the Missouri State Highway Patrol, the only way for the GPS to have a large gap in readings would be if the antenna is tampered with or the vehicle's battery is unhooked and then reattached at a different location.

A search warrant revealed that one of Wilson's last phone outgoing calls happened the morning of his death at 9:59 AM. He allegedly talked to Armstrong for less than a minute. A message from June 24 revealed that Wilson wanted to purchase Armstrong's property for \$200,000, according to the Probable Cause statement. The 71 year-old Wilson raised registered Highlander cattle and may have wanted to increase the size of his acreage to support the cattle herd. Data from Wilson's phone showed it was used at 11:52 AM on June 29, one minute after data from the truck indicated the vehicle was allegedly at Armstrong's residence.

During a July 4 interview, Armstrong allegedly told investigators the last time he saw Wilson was 10 days prior when Wilson offered to buy his land. Armstrong had security cameras but the only available footage was from 3:30 PM on June 29, moving forward. In other words, two or more hours after Wilson was killed, according to the autopsy conclusion.

Deputies executed a search warrant at Armstrong's residence on July 5. A 9mm shell casing was found in his Chevrolet truck, according to the Probable Cause statement. Armstrong as a convicted felon is not allowed to own firearms. Two security systems were seized. Authorities obtained



audio and video footage, revealed which two gunshots, clearly heard in rapid succession at 11:55 AM on June 29.

Armstrong was interviewed multiple times as the case evolved and continually made conflicting statements. It was learned on July 10 that the suspect was allegedly needing money and not happy with the possibility of being forced to sell his coin collection.

### Grants Available For Rural **Childcare Centers**

County Reporter So many times rural communities are like child care deserts, areas where the demand for licensed child care, exceeds the local capacity to provide it.

This lack can create a very limiting factor for working parents who work at businesses that keep community running а smoothly, such as health care, education, elder care, and local industry.

The Patterson Family Foundation of Kansas City is launching a grant program for child care centers run by public school districts and nonprofit community-based organizations. The funding will help organizations preparing to open new child care centers, as well as existing child care centers that would like to increase capacity, ages served or hours of operation. Organizations must be a licensed child care center or have a temporary operating permit to be eligible for this grant.

Public school districts and nonprofit communitybased organizations may request funds for short-term operational needs, training and certification needs, and/ or minor capital needs aimed at expanding or enhancing child care access. This programs goal is to increase the capacity and number of licensed child care centers in rural communities.

Applications opened on June 26 and must be registered by July 19 with the applications closing on July 30.



Last week, Missouri graduate, Jackson Beaman and former Lincoln MO. standout, announced his commitment to Iowa after entering the transfer portal. He will be a redshirt junior and will have two years of eligibility remaining.

Long remembered as an All- State Football player, Beaman quarterbacked Lincoln to two state championship appearances. However, his love and All-State honors with baseball ruled his heart upon graduation from LHS. Going to Missouri was his childhood dream. Now he is one step closer to the ultimate prize.

Beaman was a redshirt freshman and he missed the entire 2023 season at Missouri as a sophomore with a serious knee injury, he spent last summer playing with the Bismarck Larks in the Northwoods League. He batted .292, with nine doubles, ten home runs and 37 RBI's over 42 games.

After entering the portal back on May 25th, the Iowa baseball coaching staff reached out to Beaman on June 14th. Beaman traveled to Iowa City for a visit on Friday. It was a day he won't

soon forget. The transfer has given him new life to pursue his dream.

"It just felt right," Beaman told the *Hawkeye Report*. "The coaching staff, the city and the university made it seem like the right fit immediately. The development at Iowa is off the charts, the fit with Iowa's coaching staff, the culture, the conference and only being five hours from home was too good of an opportunity to turn down."

"I had a lot of offers and interests," said Beaman. "I chose Iowa over Jacksonville State, Baylor, Florida Gulf Coast, Austin Peay, Southern Illinois, Appalachian State and Kansas. That's who it came down to at the end."

This past season, Jackson, playing in the outfield, appeared in 34 games with 25 starts for the Tigers. He batted .247, with a .414 on-

base percentage, including four doubles, six home runs and 19 RBI's. He had a threehit, seven RBI game against Northern Kentucky on March 2nd, while he hit two home runs against Purdue Fort Wayne on March 9th. Beaman recorded six multihit games and three multi-RBI games.

Jackson just turned 22 so he be 23 at next year's draft. He will take nine hours in the fall and nine in the spring in going for a Master's degree .Hopefully, the extra playing time will better prepare him for the draft. Asked if he would come out, he replied, "I'll go whenever I get the call. We don't have to declare in baseball.\*

Asked about what he has learned over the past four years, Beaman told this reporter," I would say I learned that things don't always workout the way you have planned, but the way God has planned. I learned life is full of adversities and trials, and to mature and grow from those trials you have to lean on the Lord for strength."





A number of years ago a young couple resided in a large white farm house farther down the creek. They had five very adventuresome children, especially the middle daughter Bonnie and her younger brother Joe. Our Mother always gathered the eggs late each afternoon and would return from the hen house through the grape arbor and into the back of the house. We took the "fake snake' to the back steps and draped it as to appear it was crawling from beneath the porch. Then we went into the kitchen and took up our post beneath the table which gave us a clear view of the pending action. There was action aplenty

when Mother, carrying not only a fully rounded egg basket of hen fruit but also her apron was gathered full too, spotted the serpent and went into a frenzy. She screamed, dropped the wire egg bucket and most of the eggs in her apron spilled out upon the concrete sidewalk. She ran wildly to retrieve a garden hoe from wherever and we quickly grabbed the snake to hide our evil deed. We weren't fast enough and were caught red handed so to speak.

She notified Father and he sternly reprimanded us but I could detect a flicker of a smile and later that night after we were in bed I could hear him chuckling to Mother about the incident. That only incensed her more and my brother and I did not return to her good graces for several days. She could never find anything amusing that involved a snake, be it dead, alive or synthetic rubber.

My phobia isn't snakes, its mice, so I love having black rat snakes on the property because they're better mousers than any cat. I black snake inside my grain storage box at the horse pasture. She had been feeding on mice and I was careful not to disturb her meal time. About a week later I encountered her crossing the lawn. For some unknown reason I chose to follow where she was going. I was amazed as I watched her reach my tack shed outside the back yard. Then I overheard my neighbor tell another man that he had solved the rat problem in his barn. He said he had captured a very large black rat snake in front of my house and had installed it in his barn. From that day forward the rats and mice were on the run so to speak. Somehow I felt relieved to know she was safe. Summer ended, Autumn returned and Cleopatra in her wisdom wintered somewhere deep in the warmth of the earth. I've never seen her again and I'm OK with that. As my wise paternal grandfather taught me; attempting to own something wild is as foolish as wishing for a full moon every night.


Warsaw/Lincoln EMS, Benton County Missouri Sheriff's Department and the staff from Operation Barbecue Relief.

### BCHS Hears Program On History, Early Days Of Bagnell Dam



Leroy Whitaker, President of the Benton County Historical Society/Museum, welcomed 28 guests to the meeting room of the Boonslick Library on Thursday, July 11 at 6:30 PM. The evening program was looking back at the building of the Bagnell Dam to create the present day Lake of the Ozarks.

Whitaker introduced Larry and Lisa Peterson, former owners of a Camden County Land and Title Company. Larry's great-grandfather had founded the company in 1887 and it has always remained in the family until Larry and Lisa sold it to retire in 2019.

The Peterson's had brought several frames photos from the county prior to the Dam being built. Among those was a picture of the old Camden County Courthouse located at Linn Creek. The structure was lost to flood waters when the dam was completed as most of Linn Creek went under the lake.

Local Benton County recorder, Carla Brown, had heard Mr. Peterson present a program on this at another meeting and asked if he could do the program in Benton County. He had large Union Electric plat maps to display that had been in their Title Company since the 1930's. Included on the maps were locations in Benton County such as Duroc that was a flourishing town until most of it was also inundated by water. The maps also showed Highway 65 that had been constructed in 1927 and also the path taken by the "little railroad" that came from Sedalia daily and made its final run in August, 1946. Peterson also had a photo of the J.R. Wells Steamboat that had been in operation from Linn Creek to old Bagnell prior to the Dam's completion. The steamboat landing wasn't on the Osage but up in Linn Creek. In that era residents could take the steamboat from Linn Creek to Bagnell and then catch the train, if they desired to go to Eldon or on to Jefferson City. Mr. Peterson cited he had gleaned many facts from three books, Lake of the Ozarks, Before The Dam Waters and Dam Over Troubled Waters. "The He concluded, building of the dam caused a lot of heartache for some at the time but in the end it provided jobs and a more prosperous life." The construction began in August of 1929 and it was completed in 1931. It has 1,320 miles of shoreline located in four counties. Miller, Morgan, Camdenton and Benton, flooding over 20,000 acres and changing life forever in those old Ozark hills.



### **Emphasizing The** Importance Of **Skin Checks**

As a general dermatologist, I am formally trained to conduct skin checks, as well as to surgically remove skin cancers on the trunk, arms and sometimes legs. I can also identify, manage and treat various types of skin rashes.

A skin check is an inperson evaluation of the skin for any possible skin

cancers or skin damage

and generally takes 10 to

regular skin self-exams. A referral from a primary care provider may be needed to see a dermatologist depending on insurance coverage.

It is recommended to see a dermatologist if a mole or spot is changing in color, size or shape. Additionally, it's important to have a spot examined if it is tender, itchy or bleeding. Other common reasons to visit a dermatologist are for acne, any type of rash, including eczema and psoriasis, warts, skin irritation or any concern for skin cancer.

How frequently someone should see a dermatologist depends on a patient's risk of developing skin cancer and their medical history. Patients with a history of skin cancer are advised to follow up with a dermatologist at least once a year, although they could be seen more frequently depending on when the skin cancer was diagnosed and treated, as well as the type of skin cancer involved.

Individuals with an immediate family member - such as a parent, child or sibling - who has been diagnosed with melanoma, are recommended to have an annual skin check as they are considered higher risk because of their family history.

Skin checks are important because skin cancer is the most common cancer in the United States. According to the American Academy of Dermatology, 1 in 5 people will have skin cancer at some point in their life. Every day in the United States, about 9,500 people are diagnosed with skin cancer. The two most common skin cancers, squamous cell cancer and basal cell cancer, are very responsive to treatment when caught early and managed appropriately.

Although not as common, melanoma is more dangerous as it is responsible for most skin cancer-related deaths. Survival rates for melanoma have increased in recent years due to new treatments, but the importance of skin exams to detect melanoma early is also crucial.







### **Proposed Amendments to the Constitution of Missouri**

To be submitted to the qualified voters of the State of Missouri at the Special Election to be held on Tuesday, the 6th day of August, 2024.

### **CONSTITUTIONAL AMENDMENT NO. 1**

[Proposed by the 102nd General Assembly (First Regular Session) SJR 26]

### **OFFICIAL BALLOT TITLE:**

Shall the Missouri Constitution be amended to allow places where individuals, corporations, organizations, and associations provide childcare outside of the child's home to be exempt from property tax? This is intended to make childcare more available, which would support the well-being of children, families, the workforce, and society as a whole.

State governmental entities estimate the state's Blind Pension Fund could have annual lost revenue of up to \$400,000. Local governments expect an unknown fiscal impact.

Submitting to the qualified voters of Missouri, an amendment repealing section 6 of article X of the Constitution of Missouri, and adopting one new section in lieu thereof relating to a property tax exemption for certain child care facilities.

### Be it resolved by the Senate, the House of Representatives concurring therein:

That at the next general election to be held in the state of Missouri, on Tuesday next following the first Monday in November, 2024, or at a special election to be called by the governor for that purpose, there is hereby submitted to the qualified voters of this state, for adoption or rejection, the following amendment to article X of the Constitution of the state of Missouri:

Section A. Section 6, article X, Constitution of

each county. Each year after the first year the replacement tax is imposed, the amount distributed to each taxing authority in a county shall be increased or decreased by an amount equal to the amount resulting from the change in that district's total assessed value of property in subclass 3 of class 1 at the countywide replacement tax rate. In order to implement the provisions of this subsection, the limits set in section 11(b) of this article may be exceeded, without voter approval, if necessary to allow each county listed in section 11(b) to comply with this subsection.

3. Any increase in the tax rate imposed pursuant to subsection 2 of this section shall be decreased if such decrease is approved by a majority of the voters of the county voting on such decrease. A decrease in the increased tax rate imposed under subsection 2 of this section may be submitted to the voters of a county by the governing body thereof upon its own order, ordinance, or resolution and shall be submitted upon the petition of at least eight percent of the qualified voters who voted in the immediately preceding gubernatorial election.

4. As used in this section, the terms "revenues lost" and "lost revenues" shall mean that revenue which each taxing authority received from the imposition of a tangible personal property tax on all personal property held as industrial inventories, including raw materials, work in progress and finished work on hand, by manufacturers and refiners, and all personal property held as goods, wares, merchandise, stock in trade or inventory for resale by distributors, wholesalers, or retail merchants or establishments in the last full tax year immediately preceding the effective date of the exemption from taxation granted for such property under subsection 1 of this section, and which was no longer received after such exemption became effective. 5. Because the availability of childcare supports the well-being of children, families, the workforce, and society as a whole, all property, real and personal, used primarily for the care of a child outside of his or her home may be exempted from taxation by general law. If a portion of the property of an individual or a for profit or nonprofit corporation, organization, or association is used for such childcare, an assessing authority may be authorized by general law to exempt from the assessment, levy, and collection of taxes such portion of the property of such individual, corporation, organization, or association that is used primarily for such childcare. Section B. Pursuant to chapter 116, and other applicable constitutional provisions and laws of this state allowing the general assembly to adopt ballot language for the submission of this joint resolution to the voters of this state, the official summary statement of this resolution shall be as follows: "Shall the Missouri Constitution be amended to allow places where individuals, corporations, organizations, and associations provide childcare outside of the child's home to be exempt from property tax? This is intended to make childcare more available, which would support the well-being of children, families, the workforce, and society as a whole."

### **CONSTITUTIONAL AMENDMENT NO. 4**

[Proposed by the 101st General Assembly (Second Regular Session) SS 2 SJR 38]

#### **OFFICIAL BALLOT TITLE:**

Shall the Missouri Constitution be amended to authorize laws, passed before December 31st, 2026, that increase minimum funding for a police force established by a state board of police commissioners to ensure such police force has additional resources to serve its communities?

This would authorize a law passed in 2022 increasing required funding by the City of Kansas City for police department requests from 20% of general revenue to 25%, an increase of \$38,743,646, though the City previously provided that level of funding voluntarily. No other state or local governmental entities estimate costs or savings.

Submitting to the qualified voters of Missouri, an amendment repealing section 21 of article X of the Constitution of Missouri, and adopting one new section in lieu thereof relating to the funding of law enforcement agencies.

### *Be it resolved by the Senate, the House of Representatives concurring therein:*

That at the next general election to be held in the state of Missouri, on Tuesday next following the first Monday in November, 2022, or at a special election to be called by the governor for that purpose, there is hereby submitted to the qualified voters of this state, for adoption or rejection, the following amendment to article X of the Constitution of the state of Missouri:

Missouri, is repealed and one new section adopted in lieu thereof, to be known as section 6, to read as follows:

Section 6. 1. All property, real and personal, of the state, counties and other political subdivisions, and nonprofit cemeteries, and all real property used as a homestead as defined by law of any citizen of this state who is a former prisoner of war, as defined by law, and who has a total service-connected disability, shall be exempt from taxation; all personal property held as industrial inventories, including raw materials, work in progress and finished work on hand, by manufacturers and refiners, and all personal property held as goods, wares, merchandise, stock in trade or inventory for resale by distributors, wholesalers, or retail merchants or establishments shall be exempt from taxation; and all property, real and personal, not held for private or corporate profit and used exclusively for religious worship, for schools and colleges, for purposes purely charitable, for agricultural and horticultural societies, or for veterans' organizations may be exempted from taxation by general law. In addition to the above, household goods, furniture, wearing apparel and articles of personal use and adornment owned and used by a person in his home or dwelling place may be exempt from taxation by general law but any such law may provide for approximate restitution to the respective political subdivisions of revenues lost by reason of the exemption. All laws exempting from taxation property other than the property enumerated in this article, shall be void. The provisions of this section exempting certain personal property of manufacturers, refiners, distributors, wholesalers, and retail merchants and establishments from taxation shall become effective, unless otherwise provided by law, in each county on January 1 of the year in which that county completes its first general reassessment as defined by law.

2. All revenues lost because of the exemption of certain personal property of manufacturers, refiners, distributors, wholesalers, and retail merchants and establishments shall be replaced to each taxing authority within a county from a countywide tax hereby imposed on all property in subclass 3 of class 1 in each county. For the year in which the exemption becomes effective, the county clerk shall calculate the total revenue lost by all taxing authorities in the county and extend upon all property in subclass 3 of class 1 within the county, a tax at the rate necessary to produce that amount. The rate of tax levied in each county according to this subsection shall not be increased above the rate first imposed and will stand levied at that rate unless later reduced according to the provisions of subsection 3. The county collector shall disburse the proceeds according to the revenue lost by each taxing authority because of the exemption of such property in that county. Restitution of the revenues lost by any taxing district contained in more than one county shall be from the several counties according to the revenue lost because of the exemption of property in STATE OF MISSOURI ss ss Secretary of State

Section A. Section 21, article X, Constitution of Missouri, is repealed and one new section adopted in lieu thereof, to be known as section 21, to read as follows:

Section 21. 1. The state is hereby prohibited from reducing the state financed proportion of the costs of any existing activity or service required of counties and other political subdivisions. A new activity or service or an increase in the level of any activity or service beyond that required by existing law shall not be required by the general assembly or any state agency of counties or other political subdivisions, unless a state appropriation is made and disbursed to pay the county or other political subdivision for any increased costs.

2. Notwithstanding the foregoing prohibitions, before December 31, 2026, the general assembly may by law increase minimum funding for a police force established by a state board of police commissioners to ensure such police force has additional resources to serve its communities.

Section B. Pursuant to chapter 116, and other applicable constitutional provisions and laws of this state allowing the general assembly to adopt ballot language for the submission of this joint resolution to the voters of this state, the official summary statement of this resolution shall be as follows:

> "Shall the Missouri Constitution be amended to authorize laws, passed before December 31, 2026, that increase minimum funding for a police force established by a state board of police commissioners to ensure such police force has additional resources to serve its communities?"
