City Pool Improvements Hit A High Water Mark!

The state of the city outdoor pool, sewer plant and street projects were discussed, during the public works committee report at the city council meeting on July 2 at the municipal building in Clinton.

Ward 2 Councilman Roger House reported as committee chairman.

"The (new) outdoor swimming pool pumps are working the best they ever have," said House. "It opened for the summer on June 22."

Additional lighting was installed during the long over-running project.

"The new lights are all in," House said. "They really look nice."

Front desk manager for the outdoor pool Alex Crawford said some things about the renovation were great.

"Yes," said Crawford agreeing with Councilman House, "The pumps are working the best they ever have."

Not working at all, are the large slides for the pool.

"The controls were submerged during the large pump replacement," said

first year lifeguard Sam Baughman. "Neither slide is able to work at all."

Additional work and expense appears to be coming from the city sewer plant.

"The east digester may need replacing," House said. "We are waiting on word from Independent Electric."

City Administrator Christy Maggi brought information to the council about that.

"I will E-mail an update about that (digester) from Scott Fleming soon," said Maggi. "He will have some numbers for us this coming week."

A staircase access to the Deer Creek Waste Water Station took up part of the discussion.

"It is 32 feet down to the bottom," said House. "That is where workers will need access."

"I would like to see op-

tions," said 3rd Ward Councilman Cameron Jackson.

Maggi answered with some.

"We are looking at a spiral staircase," she said. "That would be in lieu of an elevator."

House spoke about ruled out options.

"That (32 feet) is to far for a ladder," he said. "It's not safe to have a ladder that tall."

On August 9, 2024, Smokey Bear officially turns 80 years old. The iconic image of a black bear in blue jeans and a forest ranger hat, familiar to generations of school children, was introduced in 1944 by the

U.S. Forest Service, the National Association of State Foresters and the Ad Council.

The image and his famous mantra, "Only You Can Prevent Forest Fires," which debuted in 1947, made Smokey the longest running

Commission Candidates Focus On Deputy Salaries

Keeping good law enforcement was a big topic for both incumbent Northside Commissioner Rick Fosnow, and challenger Mark Larson. Both candidates have ideas how to address that, and a recent effort that did address that. Incumbent Rick Fosnow stated what he has supported and accomplished for Henry County deputy retention. "We passed a \$1 an hour raise for our deputies," said Fosnow. "That has been several months ago." According to unopposed sheriff candidate Aaron Brown, that current salary is \$18-per-hour for most deputies. Brown and opposing candidate Mark Larson are not happy with that amount. "Guys (deputies) are not going to (risk) getting shot for \$18 bucks an hour," said Larson. "I pay my employees well, and as your commissioner I will work to do that same thing for Henry County." According to the city of Clinton Facebook site about their recently passed Public Safety Tax, the city

will make revisions to their current pay schedules, meaning significant raises for all policemen. The site also states that they will hire four additional town road officers. Fosnow says that tax is how the city is raising their police salary scales. "They (residents) passed a (public safety) tax to do that," he said. Fosnow declined to support a tax for the county to do the same thing. "We were able to come up with the \$1-per-hour amount," he said. "We were not able to come up with more." Larson did not support a tax increase either, but he did say the revenue the county

does bring in, has to be prioritized. "We need to take care of roads, bridges and law enforcement," he said. "Then we can distribute what is left." Larson further said that budgets can be trimmed, to come up with deputy salary money. "Lets get rid of the fluff money," he said. Fosnow disagreed. "Mr. Larson thinks that money can be taken from the budget," he said. No set amount of a new higher Clinton policeman salary has been set, according to Clinton City Clerk Wendee Seaton. "A city budget meeting on that was July 13," said Seaton. "We will also meet for that on Au-

gust 7." Both candidates strongly support Senate Bill 190 and the General Assembly's recent wording addition for senior property tax relief. Even with the potential effect on future county budgets. "I will (vote to) implement that bill and tax relief," Fosnow said. Larson insists the implementation, will still allow for deputy salary increases. "Our deputies are not going to lose (out) on their (needed) pay raise," Larson said, "Just because the county implements Senate Bill 190." The Republican Primary election will be on August 6, three weeks away.



bound the restless wave, oh hear us when we cry to thee, for those in peril on the sea."

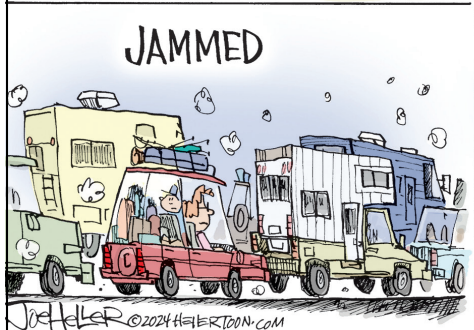
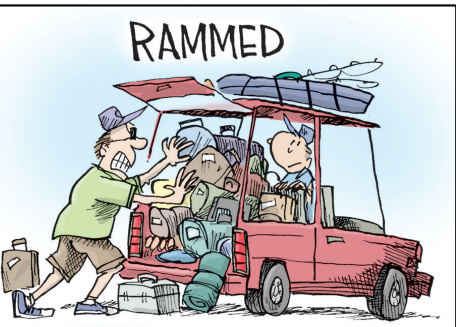
What in hell is happening to our country? We seem to be in peril on the sea.

Sheriff J. Kent Oberkrom Announces Retirement

When Kent Oberkrom first took office as Henry County sheriff in January 1997, deputies had to supply their own vehicles and pay for their own uniforms, weapons and protective gear. That was common in Missouri's third-class counties back then. Two years later, Oberkrom convinced the county commission to budget enough money for the county to pay for vehicles, uniforms and other gear that deputies needed for their jobs. That change is one of the accomplishments of which Oberkrom is most proud in his seven terms as sheriff.

Oberkrom - who didn't run for re-election this year to an eighth term -- resigned this month as sheriff, effective July 25, after being appointed by Gov. Mike Parson to a six-year term on the state Board of Probation and Parole. Oberkrom's 27.5 years in office make him the longest-serving sheriff in Henry County's history.

Oberkrom informed the Henry County Commission of his decision in a closed session early in July. The Commission will appoint a replacement for the rest of the unexpired term, which

The only candidate for sheriff in the August primary elections and November general election is Aaron Brown of Montrose, the Johnson County sheriff's chief deputy. "I didn't run for re-election because I decided it was time to let someone else do that," Oberkrom said. "My wife and I decided we wanted to do other stuff."

The possible position on the seven-member Board of Probation and Parole came on Oberkrom's radar a couple of months ago. "I knew another former sheriff was retiring from that board, so I put my name in the hat," he said. The board position in Jef-

erson City culminates a long career in the criminal justice system for Oberkrom. His career before being elected sheriff includes two years as a Henry County sheriff's deputy, five years as a Clinton police officer, and 12 years as a Juvenile Court officer for the Missouri courts' 27th District, which covers Bates, Henry and St. Clair counties.

"I've done every step (in criminal justice) except parole and probation," Oberkrom said. Many people think sheriffs focus on putting people in jail and prison, but Oberkrom doesn't think he'll have to change his attitude about offenders in his new job. "I've always thought the lion's share of folks, given the right opportunity, can be successful."

That attitude led to the creation of the Henry County pretrial release program six years ago, cutting down on what Oberkrom termed "paupers jail."

"Many people stayed in jail, awaiting trial, simply because they couldn't afford to post a bond. In this program, we ask them what they can afford to post, and petition the court to let them out for that amount. Then we help them get jobs to support their families and be productive citizens while their cases are pending. We monitor them, try to make sure they have transportation, and remind them about upcoming court dates so they don't go back to jail for missing an appearance," he said. This Henry County program, which had 32 people in it in early July, makes offenders have some "skin in the game," the sheriff said. "It's dependent on (the offender) having a good, solid home plan, such as a place to stay and support of a family."

He believes its success rate is about 90 percent, meaning the offenders showed up for court and completed their sentences, whether it's serving jail time, paying a fine, or doing community service. One success story of this

"What can we do to help people be successful?" attitude is a man named Anthony.

"I interviewed this young boy when he first got in trouble. He asked, 'Why do you care for me?' I told him, 'You don't have criminal thinking. You just did something stupid without thinking of the consequences. You acknowledge your mistake and take responsibility for it.' Anthony completed his punishment and I still communicate with him. I wrote him a letter of support for a job one time, and he got the job," Oberkrom said. "That's an example of someone who was given the right opportunity and made the most of it."

Oberkrom hopes he can bring this attitude to the Board of Probation and Parole. He said Missouri inmates have a recidivism rate of about 40 percent - meaning they commit another crime within three years of leaving prison. He knows of other states with much lower recidivism rates, which he credits to having more of a "helping" attitude.

"Instead of asking offenders, 'What's wrong with you?', we should be asking, 'What happened to you?' That's a big difference in thinking," he said.

Many law enforcement officers in Missouri are critical of the state Department of Corrections because it releases offenders well before they've served their full prison sentences because of various calculations for time already served, time off for good behavior, and allowances for crowded prisons.

"Some people think a prison sentence is 'automatic.' We need to know: what does a six-year sentence really mean. 'Truth in sentencing' is a real issue for law enforcement officers," he said.

Now, he'll be part of that system. The Board of Probation and Parole is a division of the Department of Corrections.

"Gov. Parson and Oberkrom share a similar philo-

The main subject of the program was where the backroads he travels have led him: To churches.

"My photographs always have a cross in them," he said.

Colvin, who is from Jefferson City, is an ecumenical church photographer, capturing images of country chapels. He uses a digital infrared camera, which takes black and white pictures that capture the texture of the buildings and the stone markers in the rural graveyards, and the contrasts in the cloud formations above.

Bob posts his photographs on Google Earth, and frequently gets requests from people who ask to use them on the church websites.

The best reward he ever received for letting someone use an image he took, he said, was a flag that was flown in his name over the U.S. Capital building, then sent to him.

Colvin said he likes wildlife photography best, and is getting a new lens for his next trip to Yellowstone. He gave the program in Windsor at the invitation of Walter Moser of Windsor, who met him at a photography club in Jefferson City.

Colvin included photographs of vintage cars and old buildings in Saturday's program, documenting the loss of businesses in small towns. Windsor is undergoing a renaissance as the junction of the KATY and Rock Island recreational trails, but has just lost its oldest continuous operating business, The Windsor

Review, started in 1876. WHS treasurer Martha Carter reported that the sign from the outside of the Windsor Review building has been donated to the historical society for the local museum, as well as the plate of the newspaper's 1966 masthead and other memorabilia.

Another former Windsor business will be celebrated at the August meeting of the Windsor Historical Society, which will hold the annual reunion of people who worked at the International Shoe Factory or had relatives who did. The meeting, on Saturday, August 10, starts with lunch at 12:15 p.m. at the fellowship hall of Windsor United Methodist Church, 216 S. Main. Fried chicken will be provided, with guests asked to bring a side dish. All are invited to share or listen to stories of working in the factory, which opened in 1932, and how life changed in Windsor when it closed in 1985. #

For Civil War buffs, Windsor Historical Museum curator Susan Luck is planning a new exhibit, featuring a cannon her husband built. Susan is asking museum visitors to "choose up sides" by having their photograph taken as either a Federal or Confederate soldier, posing behind the figures she created. The museum also has an extensive collection of military history books, donated by Randall Chapman, that are available to check out.

The museum, at 214 S. Benton, is open May through November on Sundays from 2 p.m. to 4 p.m. There is no admission charge.

ning and most successful advertising campaign in the country.

In Appleton City, children, parents, aunts, uncles and grandparents will be celebrating Smokey's 80th birthday at a party at the Summer Reading Hour at Trinity United Methodist Church on Monday, July 29. The Summer Reading Hour draws children ages 2 to 15, but all ages are invited to the party.

There will be cake, and Smokey himself, courtesy of the Missouri Conservation Department, will be there to blow out the candles — but not 80 of them.

"The candles will be numerals, and eight and a zero," said Karidi Hazell, who started the Summer Reading Hour. "I am going to do a big vanilla cake, and also make chocolate cupcakes."

The top of the cake will be decorated with bear figurines in a forest setting, she said, the decorations donated by True Value, she said, and the cupcakes will have a paw print on them.

Karidi said she chose the theme of the Summer Reading Hour after she heard about the Smokey Bear Reading Challenge

of the U.S. Forest Service and the U.S. Department of Agriculture. The program awards certificates for completing the challenge and taking the Smokey Bear Pledge, and badges for learning about campfire safety, science and nature related to forests, animals and fire prevention.

But Karidi said she had an ulterior motive. "The whole reason I'm doing this is that I've always wanted to meet Smokey," she joked.

The guest of honor in the Smokey suit will not be as large as a black bear, and much smaller than the 51-foot-tall Smokey Bear balloon that floated in the Macy's Thanksgiving Day parade last November. The Appleton City Summer Reading Hour also started celebrating the birthday early, with stories and activities related to forest ecosystems, plants and animals when the sessions started in July.

Last Monday, a program on fire safety was held by Appleton City Fire Chief Bryan Wade and Assistant Chief Brandon Snodgrass, who visited the church parking lot with the department's brush truck and the pumper truck. Chief Wade talked to the chil-

dren about the importance of changing smoke alarm batteries twice a year, having a designated safe spot outside if a fire breaks out in your houses, and that you should never, ever, go back into a burning house to retrieve items.

"They can be replaced," he said. "You can't."

Chief Wade also talked about how to prevent brush fires, explaining that the brush truck doesn't carry much water, but carries leaf blowers because they can be used to put out a grass fire by blowing the fire away from the fuel. Then Brandon hooked up the fire hose to the pumper truck, and the children took turns holding the nozzle and sending a spray of water into the street.

The July 29 birthday party starts at 11 a.m. and will include games, including musical chairs to the "Smokey the Bear" song, written in 1952 by Steve Nelson and Jack Rollins, who composed "Peter Cottontail" and "Frosty the Snowman." Rollins added "the" to Smokey's name to make a phrase that fit the chorus better.

Also in 1952, Congress passed the Smokey Bear Act, trademarking the character for the U.S. Department of Agriculture, which uses the proceeds from the sale of merchandise for fire prevention programs. The Summer Reading Program

birthday party for Smokey will have activity tables set up for children with related arts and crafts.

"We're also going to incorporate Woodsy Owl," Karidi said of the "Give a hoot, don't pollute" character.

The children might have been drawing pictures of Bambi, Flower and Thumper. Walt Disney loaned use of the cartoon characters from the movie for one year to the forest-fire prevention campaign, but campaign executives lobbied for their own animal symbol. Albert Staehle created the first image of a bear dressed like a forest ranger, pouring water on a campfire, and dubbed him Smokey.

The children in the Reading Program said they had heard of Smokey, who makes regular appearances at their schools for forest-fire prevention programs.

In honor of the milestone birthday, the Ozark Natural and Culture Resource Center in Salem, Mo., south of Rolla, hosted an exhibit of 19 reproductions of paintings created by illustrator Rudy Wendelin for the Smokey Bear advertising campaign between 1977 and 1995. "We feel it's so important to keep their interest in reading going," Karidi said.

ophy about people in custody.

"If we can get people out of institutions, we're better off," Oberkrom said. "Most people ought to have the opportunity to get out of custody, while keeping our communities safe."

In his seven terms as sheriff, Oberkrom is most proud of what he's been able to do to support his deputies. Besides not having to supply their own cars and equipment, deputies now have health insurance and other benefits, as well as a lot more training. He's also brought in technology and a better management system to the county jail. He's appreciative of the support of voters.

"The improvements came

with a price tag. We've been able to pass sales tax issues for a new jail and for improved public safety. We've also been aggressive about applying for grants."

In the last 20 years, Oberkrom is also proud that the Sheriff's Office has been able to take over the law enforcement duties for five of the six small towns in Henry County. The contracts save the towns money, and place deputies in the towns for a specified amount of hours each week.

The low points for the sheriff have been two deaths in the county jail in the past five years. One was for a woman who went into shock because of alcohol withdrawal symptoms. The other was a man who hanged himself.

"My goal always was to have no in-custody deaths," Oberkrom said. "We've had a lot of saves of inmates but these two got away from us."

Another jail incident was early in his tenure as sheriff. He fired — and asked the prosecutor to charge — a corrections officer who had sex with an inmate. He also fired another officer who knew something about it but didn't report it.

Oberkrom beat incumbent Sheriff Jack Reynolds in 1996. Several of his subsequent elections have been unopposed.

Oberkrom has lived in Henry County since he was 2 years old. He grew up on a cattle farm west of Clinton. In addition to being sheriff, Oberkrom also served nine years on the Clinton School Board, including two years as board president. He and his wife, Diane, his high school sweetheart, have three daughters, eight grandchildren, and one great grandchild.

His community service includes being a leader in Boy Scout Troop 430, where he earned Eagle in 1972 under longtime Scoutmaster J.C. Smith. Smith later managed some of his campaigns for sheriff. He has never seen a conflict between the values of Scouting and his role as a law enforcement officer.

"I've tried to live by the Scout Oath and Scout Law. My philosophy in life has been to care about other human beings. That's also been my attitude in law enforcement."

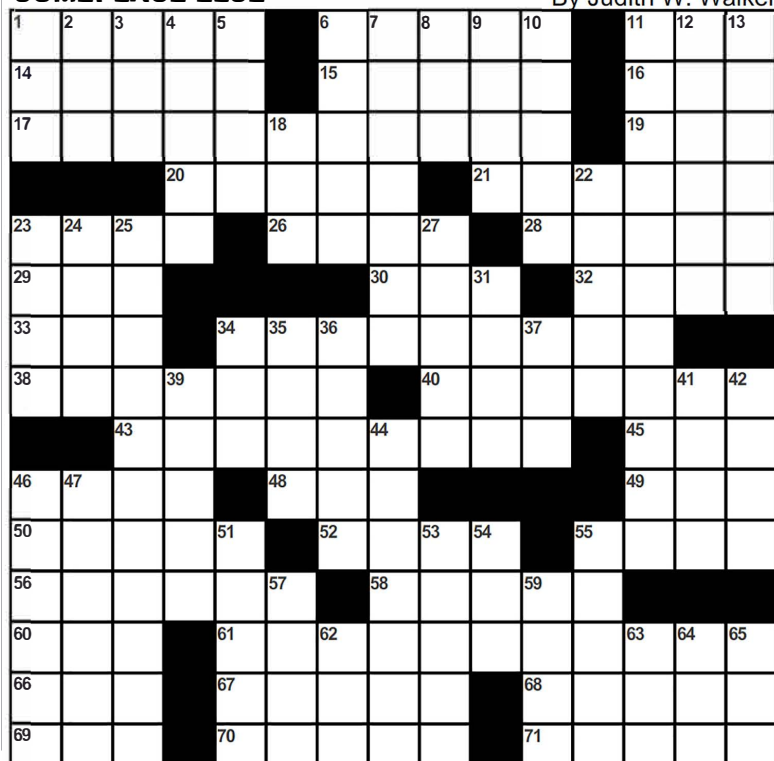

Evegy Limits Industrial Development Power

Competing for new industrial development is a hard enough job for municipalities already.

Now there is a limit on available electric power.

Mark Dawson, economic development director spoke to the city council about the challenge on July 2 during the regular council meeting at the municipal building in Clinton.

Going over the latest directive from Evegy Power Company, Dawson told the council the news straight up.

"Right now we cannot provide more than 10 megawatts (MW)," said Dawson. "That is not enough for our potential industry Project DODGER."

According to Business Energy Advisor, manufacturing plants on average require 95.1 kilowatt hours per square foot. That limits how far 10 MG can power up.

"A 10 MG capability is not enough for most industrial loads we are competing for right now," Dawson said. "Project DODGER would bring 75-100 high paying jobs and a very large capital expenditure (CAPEX) in physical assets."

Another utility is capable of supplying more power, but there is a big catch.

"Osage Valley Electric Coop can give more than 10 MG at our airport industrial location," Dawson said. "But there is no sewer capability."

All of the current challenges will change with the coming year.

"In 2025 Evegy will have more power generation coming online," Dawson said. "Their limit for new industry will go to 25 MW."

Dawson reported on two additional development projects that he is competing for.

"Project PROP is possible for the industrial develop-

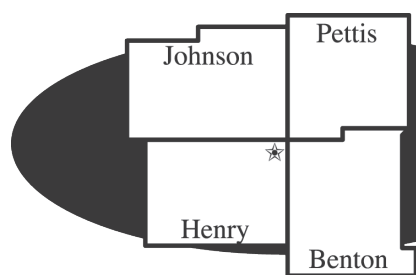

Editorial

Sickening event

No one who has paid even the tiniest amount of attention to the political discourse going on in the U.S. should be surprised a gunman tried to murder Donald Trump at a rally Saturday.

Saddened, angry, sickened, a whole lot of reactions should be in play, but surprise shouldn't be one of them.

It's been easy to see that we've been headed down this path for years.

Only providence or luck, in the form of Mr. Trump turning his head at the right moment, prevented this from being a successful attempt.

For years, both political parties have pushed the anger, promoting the idea

that the other gaining power will be disastrous for our country.

Republicans blast the Democratic party as a whole, saying their agenda seeks to fundamentally change our nation in ways never before imagined.

For their part, Democrats' talking points have focused on Mr. Trump and what they see as a cult formed around a megalomaniac. Comparisons of Mr. Trump to Adolf Hitler are fairly common. The left wing magazine, New Republic, featured a cover merging the faces of the two men into one image just days before the shooting.

The Democrats' entire campaign has centered around the idea that the former president represents a threat to democracy. Their allies in the media have taken it further with dire warnings about endless diabolical happenings should he be re-elected.

The conservative satirical fake news website The Babylon Bee summed it up humorously just hours before the attempted assassination, "Democrats Warn That Democracy Will Cease If One Of The Two Major Political Parties That Have Existed For 170 Years Wins In November."

The shooting didn't end this dialogue. Some held course, like the Atlantic which the following morning ran an article, "The Gunman and the Would-be Dictator." The subhead was "Violence stalks the president who has rejoiced in violence to others."

A few even kicked it up a notch. Like the field director for a Mississippi congressman who posted, "I don't condone violence but please get you some shooting lessons so you don't miss next time..."

It's doubtful she anticipated the level of condemnation that headed her way. Her sentiment hasn't been out of bounds for many on the left; it was her timing that was poor.

No matter how over-the-top the political talk gets, it can only be given a small share of blame. The responsibility here lies solely with the shooter.

Many millions of Americans have absorbed and believe the Democratic talking points about the danger Mr. Trump poses, but they haven't taken up arms to attempt his murder.

At the time of this writing, little is known about

the shooter. He has been identified as a 20-year old from Pennsylvania. Initial reports say he was registered as a Republican, but made a small donation to ActBlue, a liberal political action committee.

For all we know right now, he could have been just an attention-seeking opportunist who saw a chance for sick infamy in a convenient location.

Sometimes, a precise motive can be given to assassins, but often the reasons are just twisted.

Most infamously, John Hinckley Jr. shot President Ronald Reagan just to impress actress Jodie Foster.

Applying reason to mad men isn't always a winning proposition.

Both condemnation and praise has been leveled at the security for Mr. Trump's rally. It's hard to understand how a shooter with a rifle could climb onto the roof of a building less than 150 yards from the speaker's podium. That seems like a terrible lapse and should be investigated to prevent it from happening in the future.

Conversely, we must recognize the bravery and selflessness of the agents who covered Mr. Trump with their bodies and then formed a human shield around him to whisk him away.

Experts have said the Secret Service has done an outstanding job with a very difficult task. An gunman willing to give up their life in an assassination attempt has a distinct advantage over the protectors. The agents have to be perfect every time; the assassin only has to get lucky once.

Mr. Trump's immediate reaction was certainly in character. As the Secret Service hustled him out of harm's way with blood running down his face, he raised his fist in defiance and shouted, "Fight."

Not since Theodore Roosevelt opted to go forward with an address after being shot in the chest has such defiance to an assassination attempt been shown.

The same goes for the crowd amazingly calm. One would have expected something closer to sheer panic.

Later Mr. Trump addressed the attack, "Thank you to everyone for your thoughts and prayers yesterday, as it was God alone who prevented the unthinkable from happening."

"In this moment, it is more important than ever that

we stand united, and show our true character as Americans, remaining strong and determined, and not allowing evil to win," he added.

Thankfully, most of the reaction from both sides of the aisle is a call to narrow the divide which separates the country and turn down the heat.

For his part, President Joe Biden struck the right note. "There's no place in America for this kind of violence. It's sick. It's sick."

Former First Lady Melania Trump said it best Sunday. "Let us reunite."

Now. This morning, ascend above the hate, the vitriol, and the simple-minded ideas that ignite violence."

Sadly, getting little attention in the coverage so far is the man in attendance killed, and two others who were grievously wounded. Going to cheer for your favored presidential candidate should not have such consequences.

This event must be a wake-up call for all of us. Tone it down and be rational. Keep in mind, politics isn't everything. If you were to suddenly be isolated from the political fray, your life would go on, perhaps even better than before.

Clinton, Missouri Man Arrested For Possesioen Of Child Pornography

The Missouri State Highway Patrol's Division of Drug and Crime Control announces the arrest of Aaron M. Mays, 40, of Clinton, Missouri. Mays was arrested on July 10, 2024, for possession of child pornography, following an investigation by the Special Victims Unit of the Missouri State Highway Patrol's Division of Drug and Crime Control. The Clinton (Missouri) Police Department,

Henry County Sheriff's Office, and Homeland Security Investigations, Kansas City, assisted in the investigation.

In November of 2023, investigators were notified that digital files of suspected child pornography had been uploaded by a social media account, later found to be associated with Aaron M. Mays, of Clinton, Missouri. On July 10, 2024, investigators contacted Mays and during a consensual search of his cellular telephone, located digital files suspected of being child pornography. Mays was arrested and transported to the Henry County Jail, where he was held, pending the filing of formal charges. On July 11, 2024, the Henry County Prosecuting Attorney formally charged Mays with three (3) counts of possession of child pornography. Mays is currently being held in the Henry County Jail, with a \$1,000,000.00 cash only bond.

The above charges are mere accusations and are not evidence of guilt. Evidence in support of these charges must be presented before a court of competent jurisdiction whose duty is to determine guilt or innocence.

The Division of Drug and Crime Control encourages internet users to promptly report to the Patrol or local law enforcement anyone who attempts to engage in unwanted, inappropriate, or sexualized communications with children.

Proposed Amendments to the Constitution of Missouri

To be submitted to the qualified voters of the State of Missouri at the Special Election to be held on Tuesday, the 6th day of August, 2024.

CONSTITUTIONAL AMENDMENT NO. 1

[Proposed by the 102nd General Assembly (First Regular Session) SJR 26]

OFFICIAL BALLOT TITLE:

Shall the Missouri Constitution be amended to allow places where individuals, corporations, organizations, and associations provide childcare outside of the child's home to be exempt from property tax? This is intended to make childcare more available, which would support the well-being of children, families, the workforce, and society as a whole.

State governmental entities estimate the state's Blind Pension Fund could have annual lost revenue of up to \$400,000. Local governments expect an unknown fiscal impact.

Submitting to the qualified voters of Missouri, an amendment repealing section 6 of article X of the Constitution of Missouri, and adopting one new section in lieu thereof relating to a property tax exemption for certain child care facilities.

Be it resolved by the Senate, the House of Representatives concurring therein:

That at the next general election to be held in the state of Missouri, on Tuesday next following the first Monday in November, 2024, or at a special election to be called by the governor for that purpose, there is hereby submitted to the qualified voters of this state, for adoption or rejection, the following amendment to article X of the Constitution of the state of Missouri:

Section A. Section 6, article X, Constitution of Missouri, is repealed and one new section adopted in lieu thereof, to be known as section 6, to read as follows:

Section 6. 1. All property, real and personal, of the state, counties and other political subdivisions, and nonprofit cemeteries, and all real property used as a homestead as defined by law of any citizen of this state who is a former prisoner of war, as defined by law, and who has a total service-connected disability, shall be exempt from taxation; all personal property held as industrial inventories, including raw materials, work in progress and finished work on hand, by manufacturers and refiners, and all personal property held as goods, wares, merchandise, stock in trade or inventory for resale by distributors, wholesalers, or retail merchants or establishments shall be exempt from taxation; and all property, real and personal, not held for private or corporate profit and used exclusively for religious worship, for schools and colleges, for purposes purely charitable, for agricultural and horticultural societies, or for veterans' organizations may be exempted from taxation by general law. In addition to the above, household goods, furniture, wearing apparel and articles of personal use and adornment owned and used by a person in his home or dwelling place may be exempt from taxation by general law but any such law may provide for approximate restitution to the respective political subdivisions of revenues lost by reason of the exemption. All laws exempting from taxation property other than the property enumerated in this article, shall be void. The provisions of this section exempting certain personal property of manufacturers, refiners, distributors, wholesalers, and retail merchants and establishments from taxation shall become effective, unless otherwise provided by law, in each county on January 1 of the year in which that county completes its first general reassessment as defined by law.

2. All revenues lost because of the exemption of certain personal property of manufacturers, refiners, distributors, wholesalers, and retail merchants and establishments shall be replaced to each taxing authority within a county from a countywide tax hereby imposed on all property in subclass 3 of class 1 in each county. For the year in which the exemption becomes effective, the county clerk shall calculate the total revenue lost by all taxing authorities in the county and extend upon all property in subclass 3 of class 1 within the county, a tax at the rate necessary to produce that amount. The rate of tax levied in each county according to this subsection shall not be increased above the rate first imposed and will stand levied at that rate unless later reduced according to the provisions of subsection 3. The county collector shall disburse the proceeds according to the revenue lost by each taxing authority because of the exemption of such property in that county. Restitution of the revenues lost by any taxing district contained in more than one county shall be from the several counties according to the revenue lost because of the exemption of property in

each county. Each year after the first year the replacement tax is imposed, the amount distributed to each taxing authority in a county shall be increased or decreased by an amount equal to the amount resulting from the change in that district's total assessed value of property in subclass 3 of class 1 at the countywide replacement tax rate. In order to implement the provisions of this subsection, the limits set in section 11(b) of this article may be exceeded, without voter approval, if necessary to allow each county listed in section 11(b) to comply with this subsection.

3. Any increase in the tax rate imposed pursuant to subsection 2 of this section shall be decreased if such decrease is approved by a majority of the voters of the county voting on such decrease. A decrease in the increased tax rate imposed under subsection 2 of this section may be submitted to the voters of a county by the governing body thereof upon its own order, ordinance, or resolution and shall be submitted upon the petition of at least eight percent of the qualified voters who voted in the immediately preceding gubernatorial election.

4. As used in this section, the terms "revenues lost" and "lost revenues" shall mean that revenue which each taxing authority received from the imposition of a tangible personal property tax on all personal property held as industrial inventories, including raw materials, work in progress and finished work on hand, by manufacturers and refiners, and all personal property held as goods, wares, merchandise, stock in trade or inventory for resale by distributors, wholesalers, or retail merchants or establishments in the last full tax year immediately preceding the effective date of the exemption from taxation granted for such property under subsection 1 of this section, and which was no longer received after such exemption became effective.

5. Because the availability of childcare supports the well-being of children, families, the workforce, and society as a whole, all property, real and personal, used primarily for the care of a child outside of his or her home may be exempted from taxation by general law. If a portion of the property of an individual or a for profit or nonprofit corporation, organization, or association is used for such childcare, an assessing authority may be authorized by general law to exempt from the assessment, levy, and collection of taxes such portion of the property of such individual, corporation, organization, or association that is used primarily for such childcare.

Section B. Pursuant to chapter 116, and other applicable constitutional provisions and laws of this state allowing the general assembly to adopt ballot language for the submission of this joint resolution to the voters of this state, the official summary statement of this resolution shall be as follows:

"Shall the Missouri Constitution be amended to allow places where individuals, corporations, organizations, and associations provide childcare outside of the child's home to be exempt from property tax? This is intended to make childcare more available, which would support the well-being of children, families, the workforce, and society as a whole."

CONSTITUTIONAL AMENDMENT NO. 4

[Proposed by the 101st General Assembly (Second Regular Session) SS 2 SJR 38]

OFFICIAL BALLOT TITLE:

Shall the Missouri Constitution be amended to authorize laws, passed before December 31st, 2026, that increase minimum funding for a police force established by a state board of police commissioners to ensure such police force has additional resources to serve its communities?

This would authorize a law passed in 2022 increasing required funding by the City of Kansas City for police department requests from 20% of general revenue to 25%, an increase of \$38,743,646, though the City previously provided that level of funding voluntarily. No other state or local governmental entities estimate costs or savings.

Submitting to the qualified voters of Missouri, an amendment repealing section 21 of article X of the Constitution of Missouri, and adopting one new section in lieu thereof relating to the funding of law enforcement agencies.

Be it resolved by the Senate, the House of Representatives concurring therein:

That at the next general election to be held in the state of Missouri, on Tuesday next following the first Monday in November, 2022, or at a special election to be called by the governor for that purpose, there is hereby submitted to the qualified voters of this state, for adoption or rejection, the following amendment to article X of the Constitution of the state of Missouri:

Section A. Section 21, article X, Constitution of Missouri, is repealed and one new section adopted in lieu thereof, to be known as section 21, to read as follows:

Section 21. 1. The state is hereby prohibited from reducing the state financed proportion of the costs of any existing activity or service required of counties and other political subdivisions. A new activity or service or an increase in the level of any activity or service beyond that required by existing law shall not be required by the general assembly or any state agency of counties or other political subdivisions, unless a state appropriation is made and disbursed to pay the county or other political subdivision for any increased costs.

2. Notwithstanding the foregoing prohibitions, before December 31, 2026, the general assembly may by law increase minimum funding for a police force established by a state board of police commissioners to ensure such police force has additional resources to serve its communities.

Section B. Pursuant to chapter 116, and other applicable constitutional provisions and laws of this state allowing the general assembly to adopt ballot language for the submission of this joint resolution to the voters of this state, the official summary statement of this resolution shall be as follows:

"Shall the Missouri Constitution be amended to authorize laws, passed before December 31, 2026, that increase minimum funding for a police force established by a state board of police commissioners to ensure such police force has additional resources to serve its communities?"
