

Overdose Awareness Vigil 'A Time For Healing' In Clinton

On April 16, 2021, Karl Krupp, age 38, died of fentanyl poisoning in Amarillo, Texas. His body was found on a bus, which he was taking from Phoenix to his hometown in Owensville, Missouri.

"He was on his way home," Jeannette Krupp said. "He didn't make it."

Interviewed by phone, Jeannette, Karl's older sister, is leaving the Amarillo bus station on Thursday, August 29, on her bicycle and riding 700 miles across three states in nine days. Her destination: Owensville. Her goal: To complete "Karl's Last Ride" and bring awareness to the high risk of addiction and overdose death of fentanyl, a powerful painkiller.

Jeannette's ride won't take her through Clinton, Mo., but the dates of her ride overlap with National Overdose Awareness Day on Saturday, August 31, which will be observed at a candlelight vigil at 7 p.m. on the Clinton Square. It is the third year that the vigil has been held on the Square by Celebrate Recovery, and has the same purpose as Jeannette's ride: to alert people to the danger of drug addiction and overdose.

Clinton's Drug Overdose Awareness Candlelight Vigil started three years ago when one of the Celebrate Recovery members, Stephanie Hernandez, suggested it, Darren Huey, Celebrate Recovering director, said.

"The first year we had about 50 people," Darren said. "Last year we had 125."

This year's vigil, which starts at 7 p.m., will feature music by Kingdom Fighters and testimonies by a person who lost someone to a drug overdose and a person who survived a drug overdose. Prayer and poetry round out the vigil, with candles lit as the names of loved ones who died of drug overdoses are read.

Each flame represents a person whose life, like Karl's, was snuffed out prematurely, leaving a dark hole in the hearts of his parents, his siblings and his children. In 2022, more than 100,000 people died from drug-related overdoses in the United States.

Jeannette, who is in her early 40s, said she is planning to ride her Salsa touring bicycle on Route 66 to Owensville, which is northeast of Interstate 44, halfway between St. James and Herman. She will have a sag wagon (support vehicle) with a sign on it following her, and has sent press releases about the ride to towns along the route — Clinton, Okla., Oklahoma City, Tulsa, Joplin, Springfield, Lebannon, Rolla and St. James. Last week, she was sched-

uled to do an interview for a newspaper in Denton, Texas, she said, and to appear on Channel 7 News in Amarillo.

Keeping Landmarks Alive! Fundraiser Steps In To Help

Last week, members of Appleton City Landmarks and Restoration held their annual Taco Bar lunch at the MK & T Railroad Depot. They started serving at 11 a.m., and by noon, 130 people had come and paid \$10 each to pick up lunch or eat in the historic depot, treasurer Dorothy Holt said.

The organizers also take phone orders from businesses, who come and pick up lunch for their entire staff. The money goes to cover utility costs and maintenance for the buildings in the Appleton City group has restored and maintained — the depot plus the original town library, the Moore Schoolhouse and the house museum, the latter on the grounds of the Appleton City History Center, 503 S. Maple.

The next event at the depot is a Baked Potato Bar in October. ACLR members also decorate the depot for Christmas and host Christmas in the Country with local persons selling ground beef, with shredded cheddar cheese, salsa, lettuce, tomatoes, onions, jalapeños, black olives and sour cream. Dessert was choice of a homemade brownie, pineapple cake, chocolate cake or peanut butter cake with peanut butter frosting, plus coffee, tea or lemonade.

Many people came and got their lunch in takeout boxes, while others sat and enjoyed the ambiance of the depot. Built in 1870, the MK&T depot served Appleton City until the 1950s.

"People would take the train that came through in the morning down to Nevada to shop, and come home at night," Linda Lampkin, ADLR president, said.

The depot sat vacant for many years, then was acquired by the The Missouri Pacific Railroad, and about to be torn down until the ACLR stepped in. Twelve years later, in 1998, the ACLR also restored Railroad Park, put up a wrought-iron fence similar to the original, and added an MK&T caboose and a gazebo, making a green space in the center of town. Many of the old depots are gone, Linda said. The AC depot used to be on the other side of the tracks, she said, and when it was moved, was flipped end to end. The rails are still in

off service on Saturdays. Trash is off-loaded to the transfer station and further transferred to a landfill in Warrensburg. People without a trash pickup service can also take their waste to the transfer station, as well as contractors. For a list of materials not accepted go to www.gvdisposal.com.


The busiest time for trash pickup according to a Golden Valley Disposal representative is in the spring and summer when there is a lot of construction work resulting in extra waste. Holidays observed by the disposal business include New Year's Day, Memorial Day, 4th of July, Labor Day, Thanksgiving and Christmas.

Henry County Industries at 516 Price Lane in Clinton, provides recycling community bins at its facility. They provide pick-up for businesses which usually recycle paper, cardboard and sometimes cans and plastic. It does not take shredded **Trash Page 3**

To The Editor,

Although our world seems to become more complicated with each passing day, I find myself feeling truly thankful that I still have the basic freedoms everyone should have: freedom of speech and freedom of belief.

Living without those freedoms, I think, would be like living in a prison. The sad truth is that many people are living in a place like that—in China.

Twenty-five years ago, a gentle, meditative practice called Falun Dafa (aka Falun Gong) was outlawed by the Chinese Communist Party (CCP), because those who practice it believe in something those in power find dangerous—the Divine.

Although it was banned, many people had found something in Falun Dafa they were unwilling to give up—a simple practice based on the principles of Truthfulness, Compassion, and Forbearance, which basically taught them how to be good people.

Starting in 1999, practitioners were harassed, arrested, imprisoned, sent to labor camps, and tortured. They were told to give up their beliefs, but they refused. There were so many of them that the detention centers, prisons, labor camps, and jails were full. In the early 2000's, human rights groups began to see an alarming trend: an inexplicable amount of organ transplants were being

Continued from page 1 will be met by her parents, who are raising Karl's two younger daughters, Emily and Aspen, ages 5 and 4. Karl's older daughter Clarice,15, Emily and Aspen will ride their bicycles with their aunt to the finish line at the high school.

Karl was first prescribed fentanyl after he was in a serious car accident, Jeannette said, from which he was airlifted to the hospital after being trapped under the steering wheel with multiple broken bones. A synthetic opioid drug, fentanyl is 100 times more potent than morphine as a pain reliever. Available by prescription under the brand names Duragesic, Actiq, Abstral, Sublimaze, Subsys and Ionsys, fentanyl is approved by the Food and Drug Administration to treat severe pain, but has a high risk of addiction and dependence.

After pharmacy laws changed, Karl's prescription was cancelled and he started obtaining fentanyl on the street, Jeannette said. She remembers

"He was in so much pain," she said. "He said if he didn't use it, he felt like he was dying."

Made in labs and sold illegally, fentanyl can be in powder form, dropped onto blotter paper, put in eye droppers and nasal sprays, and made into pills. Karl apparently picked up fentanyl in New Mexico, Jeannette said. Fentanyl slows breathing and retards brain function, causing confusion and drowsiness. Karl fell asleep on the bus, and had stopped breathing by the time the bus reached Amarillo.

"They said he had enough fentanyl in his body to kill 20 people," Jeannette said. "If they'd had Narcan on the bus, it would have saved him."

Narcan is the brand name of naloxone, which can be used to successfully reverse an overdose. It can be administered as a spray to reverse restricted breathing, or injected.

Karl had struggled with fentanyl addiction for ten vears. Jeannette said. five

izes all the names on the ribbons at the finish — so far there are 150, she said. She invites people to send names of family or friends lost to SUD (substance use disorder) or suicide, to her website, www.Stay-StrongKrupp.com.

At the Candlelight Vigil in Clinton, Save a Life Bags will be distributed. Darren said, which contain Narcan, plus test strips to detect the presence of fentanyl in drugs, and information about drug abuse. Compass Health, Hope Project, Forged by Christ and Narcotics Anonymous will be at the vigil, Darren said, along with Celebrate Recovery.

People who have lost a family member or friend can go to the Celebrate Recovery Clinton MO Facebook page, and put the name and date of the loss on the list, which will be read as the candles are lit at the vigil.

The vigil is a place where people who have lost family and friends to a drug overdose can remember them and mourn their loss. Given the connotations of substance abuse, it is one people are sometimes reluctant to share, Jeannette said.

"Not talking about it doesn't make it go away," she said, "so I'm talking about it."

She also invites cyclists to ride part of Karl's Last Ride with her (email JFKfitness@gmail.com).

Funeral services for Karl Clarence Krupp IV, born Nov. 7, 1982, took place on Friday, April 23, 2021, in Owensville, Mo., with burial at Resurrection Cemetery in St. Louis. He was survived by his father and mother, three daughters and his partner's son, his two older sisters, two nieces and a nephew. Memorials went to StayStrongKrupp.com, Jeannette's nonprofit organization to prevent drug overdoses and promote mental health.

Jeannette said after Karl died, she received hundreds of condolence messages, including from people he was in rehab with. One resident remembered Karl going up and down the hall, handing out the purple "StayStrong" bracelets Jeannette had sent him. Jeannette also campaigns to have Narcan on every public transport, and is raising money for college scholarships for women athletes who have lost a parent, and who will never see them on the podium being awarded a medal for their efforts.

Awareness Day, August 31, is a worldwide campaign that started in 2001. The candlelight vigil in Clinton is held around the band pavilion on the northwest corner of the Square, West Franklin and Washington, starting at 7 p.m. Bring a lawn chair or blanket. Candles are provided.

paper and books but will accept clothing during business hours.

"We have a broker out of Joplin who takes our goods and distributes them to different recycling mills," said Director Carley Ross. "Some of these mills are in Arkansas and a lot of paper is sent to Boonville. A few years ago, recycling had a decline (apparently when China banned the import of most plastics and other materials headed for that nation's recycling processors.)" But now it is improving. Businesses can receive recycling pickup by purchasing a membership for \$25 a month to help cover the cost of fuel. We pick up some recycling in Benton County including schools."

The City of Clinton's Wastewater Department is located at 1102 S. Vansant (south of the big cemetery). Residents can take their yard trash there for disposal.

According to www.statista. com, the U.S. recycling system faces many challenges. There is no federal law that mandates recycling in the country, so there is only localized legislation through city or state governments. Almost 10 percent of the population lacks access to recycling services, and we have some of the lowest municipal waste recycling rates worldwide. However, the rate of waste being recycled has increased every year since 1960 reaching nearly 68 million tons.

Recycling rates in Missouri were reported to be at 43 percent of materials available, according https://recyclingpartnership.org. The top two recycling states are Main with 67 percent and Oregon with 60 percent, and the lowest three are Kentucky with 23 percent and Alabama and Tennessee at 22 percent.

Continued from page 1 to Clinton once a week still comes through Appleton City.

To raise funds to keep the depot and other historic buildings open, the ACLR group used to do home tours, Linda said. The group also owned the three-story building across the street from the depot, which was the Durly Hotel. It also served as Ellett Hospital, the name still inscribed in stone across the facade.

"The rumor is that Grover Cleveland stayed at the hotel," Linda said. Cleveland, from New York, was the first Democratic president elected after the Civil War. To learn more about Ap-

pleton City history, visit the Appleton City History Center and Museum, which is open on Fridays from 1:30 to 4:30 p.m. Donations are accepted.

Also open on Friday, from 4 p.m. to 7 p.m. plus those hours Saturday and Sunday through Sept. 2, is another piece of local history, the Appleton City Carousel. The carousel came to town as part of the carnival for the city fair, but after the carnival closed, Linda bought the carousel, purchased two lots on the main street, spent a year having the lots cleared and an octagonal pavilion built. then moved it in.

Named 2024's Best Children's Attraction in Missouri by Rural Missouri magazine in April, the carousel has drawn people from more than a dozen states and several foreign countries. The most recent riders from a foreign country were from Belize, two children who were visiting their grandparents. Linda has regulars, she said, whose grandparents or parents bring them once a week to ride the carrousel. She also had a former police chief from Belton ride the carousel, and a 80-year-old woman came from Climax Springs with relatives to ride one of the horses. Riders must weigh under 160 pounds, the weight limit of each carousel horse or other animal.

Linda also has rules about attire for safety reasonsno wet swimsuits, no flipflops or flimsy footwear. To cover the cost of electricity, she asks for whatever U.S. bill people want to pay, as long as they don't want change.

Linda said she expects even more carousel riders in town in the last two weeks of August. 



Former Employees Told About Life After International Shoe Factory Closing

The International Shoe Factory closed its doors in Windsor on July 31, 1985. The Windsor Historical Society program, "Life After the Shoe Factory Closed in Windsor," was held on Saturday, August 10, at the Windsor United Methodist Church following a luncheon at 12:15 p.m.

In the 1980s, U.S. shoe companies were reporting decreased sales caused by stiff competition from cheap foreign imports. Many employees of the International Shoe Company plant in Windsor were laid off and were never called back. Windsor employees received official notice on May 9, 1985 that the shoe factory would cease production by July 1, 1985. The doors closed on July 31, 1985. Dorothy Warren led the discussion of former employees and Windsor business people about the effects of the closing for their lives and businesses. Many employees sought other employment, but several reported that not a lot of jobs were available in the four-county area in 1985. Helen Sell stated it was a blessing for her. Her father was ill, and she was free to help care for him. She later found employment later.

Butterflies have time enough..

When I lived away from the creek I somehow became accustomed to not seeing butterflies. There weren't any in town and even after I moved out a short distance, I never saw them. There were pastures, a creek and even crops, but no butterflies. In reflection I wonder if it was the pesticides that made the area bereft of their beauty. Perhaps butterflies are so fragile that their numbers and their health might be a barometer for us. An alert to environmental change or pollution.

Then I and some friends began bringing our horses to the creek to ride on the week-ends and I once again was reminded of their rare beauty as we would spot them along a trail. I recall one particular afternoon along a high ridge in late August when the numbers of colorful kaleidoscopes took to the wing and fluttered magically about us. Their presence seemed to be a blessing on what had already been a wonderful day. A few years ago I was shucking corn down by the lower garden and suddenly this small Copper, an orange butterfly, alighted on my arm. Gently I shooed it away but it immediately returned to land in my hair, on my face and on my leg. Even when it flew a short distance it would soon return and remained with me all that morning. Then there was what I referred to as the year of the butterfly as the air was full of them in all different sizes and color. Driving along the country road here, you could see the mangled bodies of the dead that had been finished off by cars as they flitted wantonly from wildflower to wildflower.

memorial services for loved ones. There are actually companies that sell them in either individual boxes or one giant release container.. But the true obsession are the few that have spent their lives tracing the Monarch. One such man, Dr Fred Urquhart had been trying to discover where the "Royals" spent their winter months since 1937, as it had long been known they fly the length of North America twice in their short lifetimes. In a book by Bianca Lavies, published in the early nineties, Bianca tells of the discovery of the winter home in the Sierra Madre Mountains in Mexico.

It was hoped that the sites would be kept secluded but thousands of tourists flocked to see Monarch butterflies so thick they blanketed the ground, hung from branches and the tree trunks. Bianca described when the sun hit them how they fluttered into the sky, "rising above the trees like puffs of orange and black smoke."

Another condition that endangers the Monarch, beside humans, is the herbicides that kill the milkweed plants where the monarchs feed and lay their eggs. Milkweed has a chemical that creates a bitter taste to birds and can actually be poisonous to them, thus birds soon learn that orange and black butterflies are not good food. Monarchs that emerge in late summer and fall will not mate as the cool weather postpones the development of their reproductive organs. But those from spring and summer will mate within four days and live only about a month. They weren't Monarchs but I had a pair of honeymooners in my backyard last week. They were two very large satiny black creatures with bright yellow insignia which reminded me of oriental marks. The lovers perched on the welcome spelled out on my back walk and then spent time on the stepping stones. They languished atop a picnic table and surveyed the world from the chiminea. Finally late in the afternoon they were gone. Seeing butterflies here has become so common that there are times I barely notice them. But every now and again the Great Spirit takes a hand and makes you aware there are still miracles. The miracle I speak of took place a few years ago, just outside my back door. At that time I had bluegrass sod in the back yard. To insure that it survived during intense heat, I watered it about every other day. I soaked it heavily one evening and then went to bed. The following morning, after coffee, I opened the back door to step out. What happened next is almost beyond description and no words on paper can ever completely describe the vast beauty my eyes were about to behold. The opening of the door ignited a bomb of butterflies in my back landscape. A fluttering of wings arose from the damp grass as hundreds and hundreds of the winged creatures surged upwards. Not one species but many comprised the volcano of color. The easy explanation is that they

were seeking the moisture of the grass. But sometimes

we try too hard to explain away the simple everyday miracles and messages sent to us. Frankly I think I was being reminded that we humans are like butterflies flitting about for a day, thinking it will last forever. But as one great man said: "The butterfly counts not months but moments, and has time enough."

Sharon (Howery) Scott stated she remembered the closing as she was expecting her son, and she said she worked up to closing and later found other employment.

Larry Kreisel said that there were not a lot of jobs available in the area in 1985, so he took a full-time job at the Bormann Conoco Service Station where he worked for many years.

Knowing the factory was closing, some employees left ahead of closing. Gwen Hix said she left her factory job before closing for a job in Warrensburg.

Dorothy Warrens said her husband, Roy Warren's department was the first to go around June 1, 1985. and Roy worked for a contractor at Whiteman AFB painting carports. Dorothy said she and her husband found new opportunities after the shoe factory closed. After Dorothy's position ended on July 31, 1985, Roy and Dorothy were offered employment at a subdivision/resort at working in maintenance and Dorothy in the office. Dorothy later earned her Salesperson and Broker's license and had her own office, D Warren Realty, in which her daughter, Sandy, joined her in the office.

The International Shoe Factory had been Windsor's largest employer for much of the previous 53 years. Dorothy Warren asked how business owners were affected by the shoe factory closing.

Rodney Wesner saw a big difference with the loss of regular shoe factory income for employees. As the third generation of the Wesner Drug Store, Rodney remembered that there were more "lows" than "highs" in 1985. Shortly after the shoe factory closed, the Windsor Community Hospital closed its doors in November, 1985.

Walt Moser stated that his parents' Windsor Furniture Store sold a lot to shoe factory employees on a payment plan as they knew the workers would get a pay check.

Bill Simmons was not living in Windsor at the time, but his parents felt a difference in the Citizens Bank as employees always came into the bank to cash their checks, most of which were under \$100.

Lynn Wilson said his parents' Dairy Queen business noticed some difference after the shoe factory closing as they had always had a noon rush from shoe factory workers.

Brian Vincent's parents ran the Vincent Shoe Store in Windsor, and he said their store was less affected by the shoe factory closing than other Windsor businesses because their Butterflies are insects and come into the yard and garden looking for nectar from the flowers. Their early days are spent as wingless caterpillars and then they change into

glorious creatures flitting in the wind. As a caterpillar they live in grass, on the underside of leaves or they are hidden under a silken web on the leaves they eat. Butterflies use a garden as a restaurant and usually have to leave your garden to lay their eggs. Unfortunately this does not hold true about Cabbage White butterflies. Cabbage Whites lay their eggs on the vegetable and causes severe damage to the crop.

The beauty of the butterfly has brought about some strange behavior from humans. One being that butterflies are popular tattoos. My thought on that would be, don't! The butterfly that looks so great on your breast when you are twenty will stretch into a buzzard when you turn sixty-five.

Then there is the practice of releasing large numbers of butterflies at ceremonies such as weddings and

Jim Nelson---one of our current Outbackers---tells of the Home's earliest days. There were times when having enough food for the residents was in doubt. Food was garnered from donors and arrived in baskets and barrels on trains and wagons. In 1935, the Home was sold in forfeiture. Robert Barger, an Episcopalian, bought the Home with its 175 acres including its \$200,000 facilities at a sheriff's auction for \$131. Subsequently, Mr. Barger sold the Home, for the price of \$1 to a new board that was to continue its ministry.

I first learned of the Home and its ministry when we moved to Sikeston in 1967. Observing the ministry of the Home for these 57 years and comparing it to its earliest days, I conclude I have witnessed the Home's golden years.

Recently, however, the Home has encountered new, complicated, and expensive snares. In II Corinthians 12:9, God tells us, "My power is made perfect in weakness." Commenting on that scripture, Andrew Murray wrote, "There is no truth more generally misunderstood and abused. God's thoughts are heaven-high above man's thoughts."

The Liberty Grove Baptist Church in Jackson, Tennessee was voting on the construction of a new building. Their present facilities had long been inadequate and by some calculations unsafe. A lady who apparently assumed they were the best givers in church said, "We cannot do this. We will never be able to pay for it." Another lady said, "I'll tell you what we can do; we do what we want to do." With a standing vote, the church voted to move forward. The following week a deacon and I demolished the front section of the sanctuary so we could not go back.

Fast forward a couple of years---we learned that a widow in our church who passed away had left her home and farm to the church. At the time the church voted to build, no one in the congregation knew of this bequest; but God knew it. The church was built, completed, and paid for in less than five years.

Remember the scripture above, "God's power is made perfect in weakness." Then, do not be afraid. God is in charge.




