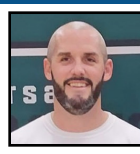

authorizing the Mayor to enter into a supplemental agreement to complete, extend or continue the original agreement between the City of Warsaw and

Burns and McDonnell Engineering Company, Inc. for professional services for MODOT Project 22-023-2, Apron Expansion to the north at the Warsaw Municipal Airport. The vote was councilmen James White, aye, Eric Flores, aye, Rob Coskey, aye and Adam Howe, aye. Councilwomen Reba Slavens and Lou Breshears were absent.

The council also approved Ordinance Number 558 authorizing the Mayor to execute Amendment #1 to bill #2023-14, Ordinance # 507 to State Block Grant Agreement by and between the City of Warsaw and Missouri Highways and Transportation Commission. Reference also was made to the Federal Aviation Administration and the Federal Airport Improvement program. The vote was councilmen James White, aye, Eric Flores, aye, Rob Coskey, aye and Adam Howe, aye. Councilwomen Reba Slavens and Lou Breshears were absent.

The council also accepted a bid from Lane's Quality Service for \$5,200 to replace the heating and air conditioning unit in the mobile home at the airport.

City Administrator Randy Pogue updated the council on a tentative schedule for upcoming projects.

Main Street north side improvements from Hackberry to U.S.65 will be advertised for bids at the end of September 2024 and open bids at the end of October 2024. Construction will be from January until October 2025.

Drake Harbor restroom and parking lot improvements will be advertised for bids in October 2024 with bid opening in November 2024. Construction will be from January until April 2025.

North Town, Commercial and Pol Street improvements will advertise for bids November 2024 and bids will be opened December 2024. Construction is set for February to June 2025.

Main Street south side improvements from hackberry to U.S. 65 TAP -Phase II projects will advertise for bids July 2025, open bids, August 2025 with construction October 2025 until August 2026.

Main Street improvements from Illinois to Hackberry TAP/GAP-Phase III projects will start design in November 2025. Right of Way Plans to MoDOT will be in February 2025 with final plans to MoDOT in July 2025. Advertise for bids in October 2025 with opening of bids in November 2025. Construction will be from January to November 2026.

scheduled for 1:00 PM that day. Apparently, some juvenile friends were engaged in a group chat that began during the night of September 15 while playing Fantasy Football. During their messaging back-and-

forth, one juvenile made statements that were implied to mean that such a shooting might occur. The parent of a member of the group found out about the statements and contacted the Sheriff's Office the morning of the 16th. This led to deputies going into the field to interview parents and kids before the juvenile responsible for the statements was taken into custody at 8:50 A.M.

"We launched a thorough investigation and established a probable cause of terrorist threat, getting authority to arrest this juvenile," said Lieutenant Kelly Lowe of the Sheriff's Office. "We informed School Resource Officers, the Juvenile Office and Chief of Police making them aware of the situation and turned the 14-year-old over to the Deputy Juvenile Officer."

Deputy Juvenile Officer Jesse Wood operates out of the Missouri Judiciary through county circuit courts. He said that after a referral to his office a case will be assessed to determine whether to handle it formally (in front of the court), or informally, which is out of court and is treatment based. If handled out of court the juvenile would be informed that his or her actions have consequences such as treatment."

Lieutenant Lowe made a statement on the Sheriff's Office Facebook page after the arrest Monday morning. He emphasized the importance of the swift actions taken by other juveniles who were witnesses to the situation and promptly alerted their parents. He said they were to be commended for quick thinking and willingness to "See Something, Say Something," helping prevent a potentially dangerous situation.

"The Benton County Sheriff's Office always takes threats of a shooting with the utmost seriousness due to the immediate danger they pose to public safety and the potential for devastating harm," said Lowe. "Every threat, whether direct or implied, carries with it the possibility of significant violence and loss of life and as such, law enforcement's duty is to act swiftly and decisively...."

He also said that the Sheriff's Office doesn't

believe that people in our county wish such harm to others, but that possible threats need their response to protect the public.

www.news.vcu.edu reports that guns are now the leading cause of death among children and adolescents in the U.S. according to the Centers for Disease Control and Prevention. The site gave

possible explanations for why this is happening. First, the U. S. has the highest civilian gun ownership in the world by a huge margin. Second, school safety is not as high as it should be. Third is social media, a component that revolves around how people make it OK on social media to act on violence.

This recipe was published years ago, but it is such a great recipe, I think it needs a repeat. It comes from the now defunct old grand department store Jordan Marsh.

I'm not a huge fan of many types of muffins (bran muffins, soggy muffins, cakey muffins, etc.) But these muffins are top drawer. The batter will seem really thick, that's ok. And you do need to let them cool since all that fruit will stick when still hot. The recipe calls for mashing a half cup of berries and adding them to the batter. This produces a very moist muffin, one that will stay fresh longer. The muffins will have a purple tinge.

The sugar sprinkled on the top produces a really wonderful crunchy top crust. Just don't add lemon in any form! I like the lemon and blueberry taste combination but this muffin is all about the blueberries.

Jordan Marsh's Blueberry Muffins

- 1/2 cup softened unsalted butter
- 1 1/4 cups sugar
- 2 eggs
- 1 teaspoon vanilla extract
- 2 cups flour
- 1/2 teaspoon salt
- 2 teaspoons baking powder
- 1/2 cup milk
- 2 cups blueberries, washed, drained
- Frozen berries work, if really soft you may not need to mash up as many
- 3 teaspoons sugar

Preparation

1. Preheat the oven to 375.
2. Cream the butter and 1 1/4 cups sugar until light.
3. Add the eggs, one at a time, beating well after each addition. Add vanilla.
4. Sift together the flour, salt and baking powder, and add to the creamed mixture alternately with the milk.
5. Crush 1/2 cup blueberries with a fork, and mix into the batter. Fold in the remaining whole berries.
6. Line a 12 cup standard muffin tin with cupcake liners, and fill with batter. Sprinkle the 3 teaspoons sugar over the tops of the muffins, and bake for about 30-35 minutes.
7. Remove muffins from tin and cool at least 30 minutes. Store, uncovered, or the muffins will be too moist the second day, if they last that long.

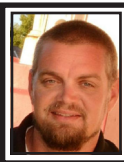

After losing to Lafayette County (Higginsville) for three straight years, one of those coming in the state tournament (2021), the #9 Wildcats staged a second half rally and avenged those prior losses with a 21-16 come-from-behind win over the (then) #4 ranked Huskers on Friday night in front of a large and raucous crowd in the team's home opener at Randy Morrow Field.

With the undefeated

Wildcats welcoming the unbeaten Huskers to town, the stage was set for a showdown of two top-10 teams and the anticipation throughout the week assisted in drawing Warsaw football fans out to see the legitimacy of Coach Ryan Boyer's 2024 squad.

And if they hung around until the final horn, those fans got everything they asked for.

Lafayette County won the coin toss and chose to receive the opening kickoff and quickly got on the board after handing the ball to Carter Wallpe on a series of runs to get them across midfield. A defensive pass

interference call put the ball on the Wildcats 22 yard line and that drive ended when Wallpe scored on a 1-yard touchdown run. Cody Gast hit the PAT and the visitors took a 7-0 lead with 5:59 left in the first.

There wasn't much running room for Warsaw against the big front line of the Huskers and on a big fourth down early in the game from the 29 yard line of Lafayette County, 'Cats quarterback Garrett Ferguson was stuffed behind the line of scrimmage and the Huskers took over on downs at their own 35 yard line.

Another heavy dose of Wallpe on the Huskers' next drive opened the second quarter but the Wildcats defense came through to force a punt to put the offense back on the field.

The run game moved the ball out towards midfield but that Warsaw drive was halted when a fumble was recovered by the Huskers

and the defense of the Wildcats was tested again.

After moving the ball to the 10 yard line of Warsaw, a couple of costly penalties moved them back and the Huskers settled for a 35-yard field goal by Gast to take a 10-0 lead with just 3:18 to go in the opening half.

With another Wildcats drive stalled and forced to punt, the Huskers would take possession. However, it was the Wildcats defense once again that came through when Sean Reinertsen picked off a pass from Page, the Huskers signal caller and set-up shop for Warsaw at the 37 yard line. It took just one play for the Wildcats to take advantage when Ferguson spotted a wide-open Jase Hubert on the left side of the field to put Warsaw on the board. Logan Gemes came in to nail the PAT and the Wildcats trailed just 10-7 at the half.

With the opening possession of the second half, Warsaw had a touchdown erased after an offensive pass interference call but the 'Cats rebounded and took their first lead of the game midway through the third period on a 2-yard touchdown run by Josh Harvath. Gemes was good for the PAT once again and the 'Cats had their first lead at 14-10 to close out the third, much to the delight of a packed stadium.

The Warsaw defense was turned up in the final frame and continued to keep the Huskers offense in check. A big turnover on downs early in the quarter put the offense back on the field and later, Harvath scored again on a 9-yard TD run to extend the Wildcats lead. Gemes' PAT was successful and Warsaw led 21-10.

Lafayette County tacked on a late score on a 46-yard touchdown reception from Page to Mariano Rodriguez, but the Wildcats defense held tough late to help the Wildcats pickup one of their biggest wins in recent

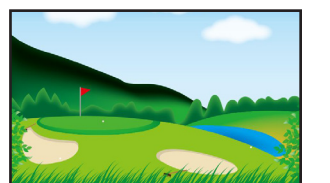

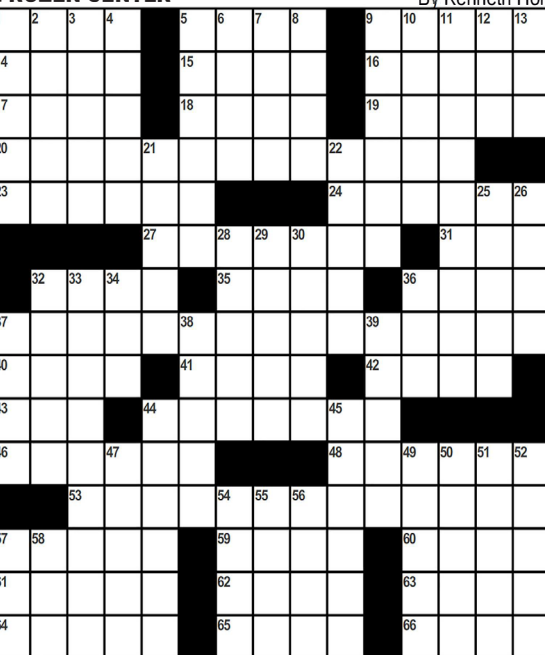

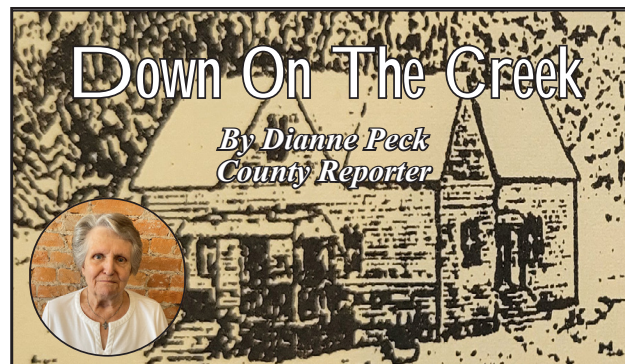

Down On The Creek

A Poor Man's Dollar

Few people, I being one, realized that sleepers or wooden railroad ties were once a substitute material for stone blocks. In the 1830's a railroad ran out of stone blocks on which to mount the rails, it was then decided to try hewing a substitute material from logs out of the nearby forests. It was soon noticed the wooden sleepers or ties provided a much smoother ride. Stone blocks were abandoned and the wooden railroad tie became a permanent fixture.

As the west was expanded and the railroads followed, a continuous supply of sleepers were needed to not only build new tracks but to repair the existing ones. Missouri forest land was a virtual gold mine creating a whole new industry. In the earliest times of the 1800's great stands of timber enabled a man to easily "hack" out a living for his family on the hillside close to his cabin. In the Benton County area and any county skirting along the Osage River, the ties were generally taken to the closest tie slide and shoved into the water to be "herded" down stream to old Bagnell. Men, referred to as "river hogs" balanced on the logs and floated with them. It was a dangerous occupation. Many drowned and being permanently wet in all seasons often brought about early deaths from a variety of diseases.

My father and his brothers worked in the ancient tie trade in the late 20's and early 30's. Their father had been a champion tie hacker in his earlier days and often won contests for making the most ties in one day. His biggest competition was always his cousin, Jim Taylor.

My Dad and his brothers, like their father before them, had a special set of tools for their work. It included a cross cut saw that required two men to operate. A double-bit axe, a broad axe, a measuring device called a tie scantling, a horse or preferably a mule for skidding logs and a small quantity of coal oil for removing sticky resin and gum residues from the saw blade. A side note, the coal oil was often used to doctor bites or small cuts incurred on the job.

The noon day meal was packed along in a lard bucket or sometimes a large galvanized milk bucket. Sometimes they would bring a mason jar with buttermilk to soak up leftover pieces of cornbread or biscuits. The noon meal could consist of beans, fried pork or fried squirrel and along with the bread might have an onion or a small jar of molasses to be spread on the now stale bread. Large stone water jugs were filled at the spring on the way to the woods and wrapped in burlap bags to keep them as cool as possible.

Keeping anything cool in 1934 was totally impossible in what is still remembered for having record breaking heat. Dad said they never wore socks because they only became drenched in sweat and they often paused to actually pour water from their shoes. When the horse was not available they would often carry the heavy ties out of the distant hollers on their shoulders to be placed on a wagon to be taken to either Cole Camp or Stover. The tie slides had become a part of history when they closed the gates on Bagnell Dam in February 1931, making the Osage River no longer free flowing.

Now the ties were hauled with great difficulty to town and the railroad depots. There were long steep hills to be traversed and at one time there was a route that skirted the base of the steep hill just NE of Boylers Mill on F hwy. Dad said it was known as the "tie trail" because it was chiefly used by the tie hauler wagons.

Railroad ties were eight feet, six inches long while switch ties would range from nine to sixteen feet long. Those were usually cut on special orders. By the time my father and his siblings were struggling to "make a buck" the quality trees were hard to find. Dad told me that trees had to be free of rot and holes. Holes in a tie resulted in deceit by

some tie hackers. The tie yards would not buy them so a limb from the same tree was used to create a plug which was driven into the hole. The plug would be hewed off and sometimes have a large amount of dirt rubbed into the area, disguising the flaw.

The hand hewing of ties was doomed to become a lost art as a small, efficient sawmill was being developed. That meant the loss of jobs on a nation wide scale. The numbers were estimated in the early 1900's at 60,000 to 70,000 men hewing ties. Not all of them were full time timber workers but some often supplemented their Ozark farm incomes with marketing ties. It was

estimated that an additional 50,000 men worked at collecting, drying, stacking along with distribution and sales. Nevertheless the small affordable sawmills were developed and soon ended the hand hewing of wooden sleepers.

My dad and his contemporaries were the last of a breed here in the Ozarks. Their ancestors had migrated across the country from Virginia and the Carolinas. The expertise in hewing logs for a cabin and out buildings was turned to a salable skill in producing ties for the railroad industry. Thus, enabling my father and his kin to make a poor man's dollar.

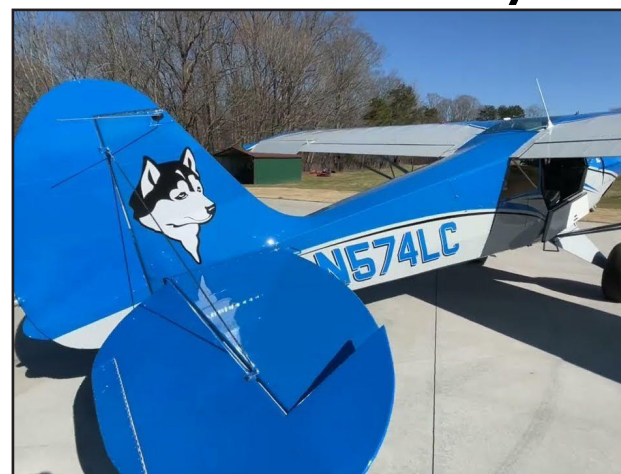
Husky Demonstrates Abilities At Well-Attended Annual Lincoln Fly-In

The pilots land their aircraft and park them in organized rows to allow the attendees to walk among them and hear about each plane and how the owner acquired it. This year a Cole Camp man, Jim Stoppel, brought his Husky "tail dragger" (I'm told that is what they are called) and he put on great demonstrations of the aircraft's abilities as he would rev up and in no time was aloft and leaving the ground like an eager puppy jumping up for its owner. The Husky "tail dragger" was created in 1985 at Aviat Aircraft in Afton, Wyoming by Frank Christensen. He had tried, without success, to acquire rights to the Piper Super Cub but was turned down. So Christensen took the idea of the Piper, applied computer-aided design principles and



simply "supered" the Super Cub. The result was what we all delightedly enjoyed Saturday morning as Stoppel put his Husky through its paces.

According to data the Husky can enjoy the heights of 10,000 feet but when it flies low its owners can enjoy postcard panoramas rarely seen by the majority of people. The plane is generally owned by people who are the happiest with the stick in their right hand, throttle in the left and the sweet satisfaction of a grass landing. It is definitely an airplane for adventures. It gave me vintage vibes just to look at it.

There were, according to the organizers, fewer aircraft this year but it had nothing to do with the popularity of the event. There were lots of areas surrounding Lincoln with weather unsuitable to flight, despite the great atmospheric conditions in Benton County.

Early morning attendees enjoyed a breakfast of biscuits and sausage gravy and when noon approached the pulled pork, smoked by Tom Miller, was served to hungry guests. Miller was awarded recognition for his cooking for the group and Jim Bentsch was given a plaque for his many years of dedication to making the annual fly-in a reality. This was followed by the drawing for prizes provided by Lincoln Merchants.

As afternoon became a reality the planes reluctantly began to depart with the majority making one more pass over the small rural farm community that still has barns at the edge of town. Barns that no longer house draft horses to work the fields but now sport Barn quilt squares to attract the sightseers that come for a few peaceful hours in the quiet country town of Lincoln, Missouri.

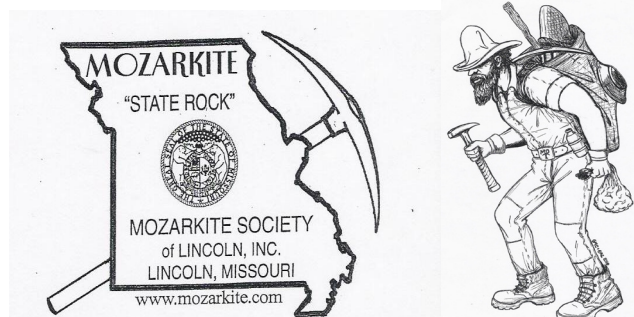

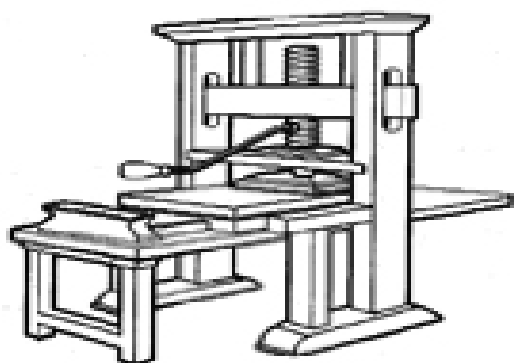

Benton County Historical Society Hears Of Resistance To Truman From USACE's Chiles

Rich Chiles, who is currently the "big dog" at the Truman Dam operated by the Corp of Engineers spoke at the quarterly meeting of the Benton County Historical Society. The program was held in the meeting Room of the Boonslick Library and area residents gleaned a personal glimpse of Rick Chiles and his connection to the area.

Chiles stated he had grown up in the Henry and St Clair Counties and how the coming of the proposed Dam was resisted by his own family. He heard more times than he could count about how the awful "thing" would forever change their day to day lives and nothing would ever be the same again. They were dreading they have to face what countless numbers had already faced in the late 20's and early 30's when the Bagnell Dam was built and displaced so many when it created the Lake of the Ozarks.

It did impact his family's life, so when he first went to work as a Park Ranger for the Corp it wasn't a popular career choice with his relatives, especially his grandfather. His grandfather was still very much alive and so Rick slowly began talking about the duties of his occupation and different things he did on the job and over time his grandparent became proud



of his grandson and his position with the Corp.

He wore different hats in his employment over the years. In 2017 he worked in the Power Plant, has done a stint at Stockton until he came back to Truman and actually became Project Manager. It's a big task as the project covers 150,000 acres and 55,600 acres of water and 200,00 during flood stage.

He shared the Corp has flowage easements. He said, "We don't own the land, but we have the right to flood it. It can be farmed or used as wet lands or hunting grounds too."

He showed a couple of huge record books that are kept in the office and said the one contains Parcel numbers when the Corp bought the land for the Project. The other book contains records about the Parcel number and what transpired as each piece was purchased. He remarked that the landowners that took the money offered and moved on came out ok financially. The ones that fought in court didn't.

Because when they lost they had to pay all the court costs, not the Corp of Engineers.

He explained the extreme bitterness by so many residents, telling about the huge billboards between Warsaw and Clinton and down highway 13 proclaiming in large lettering, "DAM THE DAM!" Many in the audience, new to the area, were shocked to learn there had been so much resistance.

One person questioned where the power goes that is generated by Truman and Chiles stated, "It goes to the Springfield and Tulsa areas. It doesn't stay here."

Chiles continued, "Warsaw has done a fantastic job managing Corp land with the Harbor and all the trails they have created." He concluded that now people see the Dam has created

Let’s start with the risks associated with investing. There’s not a single investment risk because different types of investments carry different types of risk. Here’s a look at three investment categories and some of the risks connected with them:

To help protect against this risk, you could own CDs of varying maturities. Now, let’s turn to a

completely different type of risk — the risk of not investing.
