Shootout At The Homestead! Event To Showcase Lawmen, Outlaws & Author

Laura Ingalls Wilder, who turned her family's forays in homesteading into the "Little House" books, wrote the series after she and her husband moved to a farm outside of Mansfield, Missouri, east of Springfield.

The historic farmhouse has been preserved as it was when the author lived there, from 1896 until her death in 1957. Mansfield holds a Wilder weekend at the end of September, but you don't have to travel there to see the author.

On October 5, Laura Ingalls Wilder is coming to Clinton.

Nancy Kathleen Boswell portrays the author in her later years looking back to her childhood in a program called "Sincerely Yours, Laura Ingalls Wilder." The program will take place at noon in the Highland School, a circa 1890 one-room schoolhouse on the Homestead grounds of the Henry County Museum.

Boswell's presentation will be part of "1800s Lawmen and Outlaws," a fun, free, family event

with a hint of history at the Henry County Museum Homestead on Saturday, Oct. 5, from 10 a.m. to 2 p.m.

Among the highlights: "Shootout at the Homestead," two re-enactments of western gunfights by the South Fork Regulators. The Old West re-enactment group, founded in 2002, is dedicated to preserving Western Frontier heritage and celebrating the legends of the frontier from the end of the Civil War to 1900.

Shootouts will take place at 11 a.m. and 1 p.m. According to Robin "Lucky" Lightfoot, the Regulators do historically accurate gunfights, and are asked to stage famous movie gunfights. In Martinsville, they staged a 1868 shootout, he said, but Lucky is not sure what the shootouts in Clinton will involve.

"We may do something

that is comedic and funny," Lucky said.

A dozen of the Regulators, who live all over Missouri, will be coming to Clinton, he said. The group started staging gunfights 25 years ago, and each chooses a personality to depict. Characters in the Regulators include both men and women, including Louisiana Lilly, Mrs. Lefty and Miss Bee, who happens

Lunch Hour Shifts Into High Gear With Stories

When she was 2 years old, Susan Luck boarded a jet in Spain, where she was born, with her father, a widower, had been stationed at an Air Force base. The plane rose up through the clouds and flew over the Atlantic Ocean to the east coast of the United States, where Susan spent several weeks with her maternal grandmother in Connecticut. The result is "The Lunch Bunch Gang,"a series of adventures that connect to each other, keeping the

book, which incorporates children flying off to new places, like she did when she was young. The children in the book start out in a stagecoach in the desert, then encounter exotic wildlife in the air and in the

Susan has already sold more than 75 copies of "The Lunch Bunch Gang." She will be signing copies of the book on Oct. 5 at The Pour Poet, a coffee-

Susan has always been involved in creative endeavors. As a teenager, she worked at Knott's Berry Farm, portraying a school marm or saloon girl. She also volunteered to be Gracie the Clown for a church event, she said, and soon became in demand at parties. She also took a stunt class for rodeo clowns.

Teaching preschool and Sunday School for 30 years also prepared her to write a children's book. In addition to encouraging good eating habits, the book incorporates appreciation for all the good things God has provided and weaves a few Bible stories into the narrative. The 56-page book, which has 7 chapters, is suitable for early readers or to be read to preschoolers by an adult. Luncheon Highlights Housing, Childcare As BIG Pieces To Clinton's Economic Development Puzzle BY DEANNA HENDRICH

Affordable housing and adequate child care are two pieces of the economic development puzzle that help draw new employers to a community.

Clinton needs more of both, according to presenters at a recent meeting sponsored by the Clinton Area Chamber of Commerce. The luncheon, held September 18 at the Clinton Elks Lodge, highlighted how growth in each area could support new jobs.

Dozens of local leaders, business owners and service agency staff members heard from two presenters: Mark Dawson, Economic Development Director for Clinton, and Robin Phillips, CEO of Child Care Aware of Missouri.

Dawson shared the results of a housing study completed by Next Move Group, a consulting firm that works with small to mid-sized communities. The findings show that 163 additional housing units, both homes and apartments, are needed locally in the next five years to keep up with job growth. Two-thirds of the housing units are needed for those in the \$50,000 to \$75,000 income bracket, and the

rest are needed for the \$100,000 to \$150,000 income bracket.

The study results were based in part on how many Henry County residents own their homes vs. renting, how much rent or mortgage residents can afford based on their other expenses, and how many homes and rental properties currently are available in the area.

Dawson said that when selecting a site, companies that once focused on "location, location, location"


now look at labor. He said that firms want as many as 10 applicants for each open position to find employees.

"We have to look at those projects that we can make work here," Dawson said. The largest available tract at Gerhart Industrial Park is 20 acres, and the average request by developers is 30-plus acres, which means many projects are out of reach.

In addition, 11 percent of companies require rail, which also is not available. Dawson also said the average request he receives requires available labor of 3,500. Within a 25-mile radius of Clinton the number of unemployed is 2,200.

Despite the challenges, Dawson said he remains positive. He said a handful of current projects are "viable," and he pointed to an expansion at Cloy Estates, a senior housing development, that will add another 38 units with a \$10 million investment.

Lot's going on as we get closer to Election Day. A union affiliated with the





to be the sheriff.

A retired human resources manager from Kansas City, Lucky usually plays a chuckwagon cook, he said, but next time might play a lawman or an out-

"We all take turns doing that, based on our ages," he said of playing the gunfighters. "It depends on who can fall down and get back up."

The re-enactors put together authentic costumes for their characters, he said, and carry weapons for the historic period they depict, post-Civil War to 1900. That's when Westerners toted single-action revolvers, like the Colt Peacemaker, or lever-action rifles.

Safety is a top priority – the South Fork re-enactors shoot blanks and create a safety barrier by roping off where the gunfight takes place and guarding it. The gunfighters shoot only from a safe distance, as blanks are actually projectiles that can kill when fired at close range. They also never leave their firearms unattended, and do not aim firearms directly at each other, he said.

Like Laura's story, the South Fork Regulators bring frontier history to life, and teach children what life was like in the mid-19th century Midwest, when people had to make it, grow it themselves or do without, Lucky said.

Lucky said he has been a fan of Western history since he was a little kid, but now, instead of putting on his cap pistol and straw cowboy hat, he puts on his leather holsters and real six shooters.

The Regulators warn people with small children or dogs that the gunfire may be loud, he said. At noon, go to the whiteframe Highland Schoolhouse on the Homestead grounds to see Kathleen Boswell portray Laura Ingalls Wilder, whose family moved west by covered wagon. Born in a log cabin in western Wisconsin, Laura wrote her first book, "Little House in the Big Woods," describing how her family tapped trees for maple syrup, raised pigs, and smoked and stored the hams in a tree stump.

But when Laura's Pa, a free spirit, felt that Western Wisconsin had become too populated, he packed up his rifle, rolled up blankets for bedding, tied a cooking pot and a tin pail to fetch water in onto the side, and packed Ma, Laura and sister Carrie into a covered wagon and headed across the frozen Mississippi River in January (!) in search of a place to homestead. "Little House on the Prairie" recounts the family's experiences through Laura's eyes building a log cabin on land in the Midwest and how the family survived a prairie fire, floods and other challenges.

Other "Little House" books describe the family living in a dugout in the banks of Plum Creek. The Ingalls eventually moved

out to the Dakotas where they faced blizzards that shut off train shipments of food and fuel, and plagues of grasshoppers, which descended and devoured the crops in the field and anything

that was green, includ-

ing dresses and aprons

pinned on the clothes

line. Laura married Almanzo Wilder, and the couple homesteaded, then moved to the Ozarks, where they bought Rocky Ridge Farm, built a house and planted apple trees.

The Oct. 5 "Lawmen and Outlaws" event will also feature farm animals shown by the Clinton High School FFA students on the Homestead grounds. Children interested in the FFA program and the educational farm at the high school will want to talk to the students and learn about the program.

As well as the one-room Highland School, which was originally a rural schoolhouse west of Calhoun before it was moved to the Homestead, visitors can tour the interior rooms of an original dog-trot log cabin. The cabin was moved to the Homestead after it was discovered inside a farmhouse that had been built around the log walls in rural south Henry County, north of Appleton City.

A dog-trot cabin consisted of a kitchen on one side and a sleeping room on the other, separated by a covered outdoor passage called the dog trot. It offered shelter from the weather for household animals, and a place where family members could sit and get away from each other.

There is also a mule barn, a corn crib and a smokehouse on the Homestead. Adding a smoky taste to the Oct. 5 event will be Brandon Howard, who is bringing his chuckwagon. Brandon will give demonstrations of traditional Dutch-oven cooking and hand out samples. The Homestead is a recreation of a mid-1800s Missouri farm, across from the museum, 203 Franklin, Clinton, Mo. 64735, in the block just off the northwest corner of the Square.

"1800s Lawmen and Outlaws" is Henry Coun-Museum's annual fall family living-history event, presented by the HCM's Children's Program Committee, headed by Connie Grisier. The event is a free, fun event for western history fans of all ages. Western or frontier wear is encouraged —add a red bandana around your neck or layer a calico apron over your clothes, and spend a day immersed in the interactive history of frontier days.

The Regulators were the name for a deputized posse who "regularized" a situation in a frontier area. The most famous were the Lincoln County Regulators, who fought a long-running, deadly feud against a competing cattle and dry goods interest in New Mexico Territory in 1878. Both sides recruited lawmen and criminals, including Billy the Kid, who fought in what became known as the Lincoln County War. It ended in 1881in a three-day occupation of Lincoln, during which the sides exchanged gunfire.

The shooting ended when U.S. Army troops arrived and set up cannons, with Billy the Kid and another Regulator surviving a gunfight and escaping under cover of pistol fire.

size, that opens houses up for others, he said.

Phillips, who is from Henry County originally, said the lack of child care locally is also a challenge across the state and the country. She said inadequate child care affects recruitment, productivity, attendance and retention, adding that the Missouri economy loses \$1.35 billion annually due to childcare issues.

She said 80 percent of working parents say that child care benefits impact their decision to stay at a company, and 69 percent of women with young children said they would be more likely to choose an employer that assisted with child care access.

Phillips said 435 slots exist at seven licensed facilities locally for children from birth through 6 years, but more than 1,200 could be needed based on current population numbers. The result for the community is that young parents and grandparents or others raising young children are missing work, distracted, disengaged and frustrated.

"Child care is a community wraparound issue," she said, and requires an investment "if you want people back to work."

A variety of options can help, she said, including communicating with workers, offering and educating employees about Flexible Spending Accounts (FSAs), offering flexible work arrangements and contributing to child care costs as a benefit.

Following the presenta-

tion, participants asked several questions.

Kathy Wilson with the Clinton Senior Center said she sees many older adults with inadequate or no housing. She questioned whether the Cloy Estates expansion would be enough to make a difference.

Dawson said builders who are interested in housing projects have to weigh construction costs against the income generated from a project.

"How do you produce it?" he said. "I don't know. I really don't have an answer ready."

Clinton Mayor Carla Moberly said the cost of goods to build or rehabilitate a property combined with interest and insurance rates can stop developers.

"When you put those three together, it doesn't pencil out," she said.

Steve Lebofsky of Moreland Day Care asked for examples of how a community could close the gap in child care, in Missouri in particular.

Phillips said she has seen initiatives in other states, one in which a payroll tax paid for child care and another in which the public and private sectors worked together with 80 percent of the funding coming from private sources.

"It's a very layered, complex thing to fix," Phillips said. "It takes strategic doing, not strategic planning. It takes the whole community."

Dawson closed the event with the announcement that the Docking Institute from Fort Hayes State University would complete a six-county labor study in the spring in that involves polling 2,000 residents to provide additional data.

where the cows give strawberry and chocolate flavored milk, meet a talking Big Blue Whale, take naps in nests on Talking Bird Island, before making a last stop at the Village of Desserts.

Susan had always wanted to write a book, she said, and after she heard Brenda Black of The Word's Out speak at a Christian Women's Club lunch in Clinton, contacted her about helping her get it published.

At the back of the book, Susan encourages young readers to use their imaginations and create their own tall tales by assembling the components of a story — characters, setting, dialogue and action. Susan also offers story 'starters,' such as imagining what Stagecoach Sally, one of the characters, pulls out of her big pockets. Sally is perhaps reminiscent of a stewardess on one of Susan's plane trips, pulling items to entertain a small child out of her pockets. Susan also explains the cowboy terminology that Big Dusty uses.

Two Hundred Five Years Ago The Steamboat "Independence" Reaches Frankin, Missouri

By Glynna Elliott Morse Two hundred and five years ago, the "Independence" was the first steamboat to ascend the Missouri River, arriving at Franklin, Missouri on May 28, 1819.[1]

Floyd C. Shoemaker, Secretary of the State Historical Society of Missouri, began writing historical columns, This Week in Missouri History," Shoemaker's columns began appearing in newspapers throughout the state in January, 1926, and continued through December, 1950. THE May 27, 1926 issue of the WIND-SOR REVIEW published his column about the first trip of steamboat "Independence"up the Mis-

souri River to Franklin.[1] Shoemaker quoted the news published in the Franklin newspaper, THE MISSOURI INTELLIGENC-ER, "...we announce the arrival, this morning, of this place of the elegant STEAM BOAT 'Independence,'Captain Nelson, in seven sailing days...from St. Louis, with passengers, and a cargo of flour, whiskey, sugar, iron, castings, etc. being the FIRST steamboat that has ever attempted ascending the Missouri. She was joyfully met by the inhabitants of Franklin, and saluted by the firing cannon, which was returned by

the Independence."[2] The MISSOURI INTELLI-GENCER predicted, "Missourians may hail this era, from which to date the growing importance of this section of the country, when they view with what facility, (by the aid of steam) boats may ascend the turbulent waaters of the Missouri to bring to this country the articles requisite to its supply and return laden with the various products of this fertile region."[21

The "Independence" departed from Franklin on June 3, reaching St. Louis three days later. Following the successful trip of the "Independence," the "Expedition" and the "Johnson" were headed for the Yellow Stone on July 2, 1819. Eleven days later, Major Stephen H. Long commanded the "Western Engineer," which was the first steam boat to go beyond Franklin, reaching Council Bluffs.[1]

Shoemaker pointed out that "from this time there was an ever increasing number of boats plying between Franklin and St. Louis... Gradually the shipping lines were extended to Gasgow, Lexington, Westport Landing, Weston, and St. Joseph and steamboat navigation finally reached the forts and posts on the upper Missouri."[1]

The first river traffic helped in the growth and settlement of the Western Frontier. The river became a "mighty highway" used by settlers, many of whom were immigrants. The river trade grew rapidly between 1850 to 1860; however, trains had

begun in Missouri in the

early 1850s. After the

Civil War, railroads began

to replace boats for trans-

portation. Last week, this column reported Part I of Harry P. "Punk" Barber's interview giving his account of his Prisoner of War experience during World War II. Part II will be continued next week with information about Punk's plane being shot down, his captivity, the 600-mile "Death March," and his liberation.





They also requested that those attending the funeral wear casual dress because this foundryman, cattleman and shade tree mechanic wouldn't want anyone to go out of their way to dress up. It just wouldn't seem right.

Jim was born August 3, 1939 to Albin L. Fonke and Louise Clara (Tophinke) Fonke. He and his little sister, Connie, lost their mom in 1942.

He grew up on a farm near Montrose, MO. He was working in the fields at a very young age. The neighbors thought the tractor was running itself through the fields, but it was a very young Jimmy Joe, barely able to see over the steering wheel.

Jim graduated from Montrose High School and had several jobs before being employed at Gold Foundry for over 40 years. He was a foundry foreman until the business shut down after the death of it's owner, Milton Gold. He then worked at the Clinton Daily Democrat with his daughter until his retirement.

He met Judy Ann Batschelet during a double date when his friend was with Judy and Jim was with Judy's friend. Jim informed his buddy that the next week he was dating Judy and so began a lifelong

partnership. He knew he had found the right girl when she would help him round up sheep before every Saturday night date. And they were a sight to see, Jim being 6'4" tall and Judy a little of 5' tall.

Jim and Judy married on January 5, 1962 at the old Catholic Church on Second Street in Clinton. Their daughter, Denise Ann, was born September 2, 1962, and son, James Michael "Mike", joined the family on December 12, 1964.

Judy died August 8, 2006 of brain cancer, and Jim never dated or remarried. She was the one for him. Although they could fight with the best of them, they hung together for over 44 years.

Jim loved to watch "Jeopardy" every week night with Denise. He loved the Samaritan Center and had belts, shoes, blue jeans and so much more to last him a lifetime. He couldn't resist a bargain or as he would say, "I couldn't pass up a deal like that". He could never pass a "gimme" hat either. He knew where everything on his farm was, even until his dying day. His directions were, for example, "You will find it on the back porch in the north closet on the second shelf behind the paper towels". It was always where he said it was.

He was very independent after Judy's death by cooking meals for Denise when she came over to watch "Jeopardy" after work, taking care of his cattle, dogs. cats and chickens, enjoying daily rides with his Italian Greyhound PeeWee (who died St. Patrick's Day at the age of 18), Saturday trips to town with his daughter and attending church on Sunday, always sitting in the same pew every week, and then visiting Mike and the grandkids afterwards. He was a man with a set schedule and if that schedule was messed up in any way, well, the whole day was a mess. His kids are the same way. He was also a proud member of the Bear Creek Cemetery Association with his daughter.

His independence ended on May 11th, when he was unloading feed sacks and fell over a wheelbarrow after the last sack was emptied, breaking his right leg. After surgery, one nursing home, six weeks at home with Denise as his caregiver, then another stay at the hospital fighting sepsis and staph, he was able to come home with the help of Golden Valley Hospice on September 12th. spending his remaining days with his kids, his dog and his cats.

Jim is survived by his

daughter, Denise Smith and husband, Doug, Clinton. MO: his son. Mike and his wife, Tracy, Clinton, MO: grandchildren, who made him so proud, Sara Strough and husband, Shawn, Clinton, MO, Coley Fonke and wife, Brittany, South Carolina; Emma Fonke and her partner, Dillon, Arkansas, and Noah Fonke of Kansas; great-grandson, Donavon Strough, Clinton, MO; sister, Connie Gustafson, Indiana; nephew, Tory Gustafson and wife, Jackie, and their daughters; niece Holly Gustafson; and his dog Cody; and cats, Beeb, Dink and Tux.

In addition to his wife, Judy, and his mother, he was preceded in death by his father, his step-mother, Oleta Fonke, and an infant sister, Mary Louise in 1938.




