One of my favorite things about fall is apple cakes and the following is one I have made for decades.

- 8 ounces (2 sticks) unsalted butter, more for greasing pan
- 1 1/2 cups plus 1 tablespoon sugar
- 1/8 teaspoon salt
- 2 large eggs
- 2 cups all-purpose flour
- 2 teaspoons baking powder
- 4 Gala or other flavorful apples, peeled, cored and each cut into 8 slices
- 1/2 teaspoon Calvados or apple brandy
- 1 teaspoon freshly grated ginger
- 1/2 teaspoon ground cinnamon

Preheat oven to 350 degrees. Butter a 9-inch spring form pan, and set aside.

In bowl of an electric

mixer fitted with a whisk attachment, combine remaining 8 ounces butter, 1 1/3 cups sugar and the salt. Mix until blended. Add eggs and whisk until smooth. Using a rubber spatula, gently fold in the flour and baking powder until thoroughly mixed. Fold in a few of the apples, and spread batter evenly in pan.

In large bowl, toss remaining apples with Calvados, ginger and cinnamon. Arrange apple slices in closely fitting concentric circles on top of dough; all the slices may not be needed. Sprinkle remaining 1 tablespoon sugar over apples. Bake until a toothpick inserted into center of cake dough comes out clean and apples are golden and tender, about 50 minutes. Serve warm or at room temperature.

## Constitutional Amendment No. 2

Do you want to amend the Missouri Constitution to:  
-allow the Missouri Gaming Commission to regulate licensed sports wagering including online sports betting, gambling boats, professional sports betting districts and mobile licenses to sports betting operators;  
-restrict sports betting to individuals physically located in the state and over the age of 21;  
-allow license fees prescribed by the Commission and a 10% wagering tax on revenues received to be appropriated for education after expenses incurred by the Commission and required funding of the Compulsive Gambling Prevention Fund; and  
-allow for the general assembly to enact laws consistent with this amendment? State governmental entities estimate onetime costs of \$660,000, ongoing annual costs of at least \$5.2 million, and initial license fee revenue of \$11.75 million. Because the proposal allows for deductions against sports gaming revenues, they estimate unknown tax revenue ranging from \$0 to \$28.9 million annually. Local governments estimate unknown revenue.

## Constitutional Amendment No. 3

Do you want to amend the Missouri Constitution to:  
-establish a right to make decisions about reproductive health care, including abortion and contraceptives, with any governmental interference of that right presumed invalid;  
-remove Missouri's ban on abortion;  
-allow regulation of reproductive health care to improve or maintain the health of the patient;  
-require the government not to discriminate, in government programs, funding, and other activities, against persons providing or obtaining reproductive health care; and  
-allow abortion to be restricted or banned after Fetal Viability except to protect the life or health of the woman?  
State governmental entities estimate costs of at least \$51,000 annually in reduced tax revenues. Opponents estimate a potentially significant loss to state revenue.

## Constitutional Amendment No. 5

Do you want to amend the Missouri Constitution to:  
-allow the Missouri Gaming Commission to issue one additional gambling boat license to operate on the portion of the Osage River from the Bagnell Dam;  
-require the prescribed location shall include artificial spaces that contain water and are within 500 feet of the 100-year base flood elevation as established by the Federal Emergency Management Agency; and  
-require all state revenues derived from the issuance of the gambling boat license shall be appropriated to early-childhood literacy programs in public institutions of elementary education?  
State governmental entities estimate one time costs of

\$763,000, ongoing costs of \$2.2 million annually, initial fee revenue of \$271,000, ongoing admission and other fee revenue of \$2.1 million annually, and annual gaming tax revenue of \$14.3 million. Local governments estimate unknown revenue.

## Constitutional Amendment No. 6

Shall the Missouri Constitution be amended to provide that the administration of justice shall include the levying of costs and fees to support salaries and benefits for certain current and former law enforcement personnel?  
State and local governmental entities estimate an unknown fiscal impact.  
Yes, 4,607; No, 5,513.

## Constitutional Amendment No. 7

Shall the Missouri Constitution be amended to:  
-Make the Constitution consistent with state law by only allowing citizens of the United States to vote;  
•Prohibit the ranking of candidates by limiting voters to a single vote per candidate or issue; and  
•Require the plurality winner of a political party primary to be the single candidate at a general election?  
State and local governmental entities estimate no costs or savings.  
Yes, 8,267; No, 2,147.

## Proposition A

Do you want to amend Missouri law to:  
-increase minimum wage January 1, 2025 to \$13.75 per hour, increasing \$1.25 per hour each year until 2026, when the minimum wage would be \$15.00 per hour;  
•adjust minimum wage based on changes in the Consumer Price Index each January beginning in 2027;  
•require all employers to provide one hour of paid sick leave for every thirty hours worked;  
•allow the Department of Labor and Industrial Relations to provide oversight and enforcement; and  
•exempt governmental entities, political subdivisions, school districts and education institutions?  
State governmental entities estimate one-time costs ranging from \$0 to \$53,000, and ongoing costs ranging from \$0 to at least \$256,000 per year by 2027. State and local government tax revenue could change by an unknown annual amount depending on business decisions.

(Continued from Page 1) encourage participation in drug prevention activities.  
Warsaw R-9 School Superintendent Scott Gemes said that the district is very serious about working with students who struggle with mental health issues.  
Bruce Miller who is a certified school-based counselor with Katy Trails, has an office in Warsaw High School and works with students referred to him by faculty or parents.  
"He works one on one with referred students in the middle school and high school and also travels to both elementaries to work with students," said Gemes.  
Gemes mentioned that both elementary schools have counselors to work with students who may be dealing with anxiety issues or other mental health concerns.  
North School instructor Amanda Payne works with students in a special behavioral room to help them deal with issues.  
Tyler Richardson is the WHS counselor. Kelsi Brosnahan is the JBMS counselor and Laura Sons is the South School counselor. Students and parents are encouraged to contact on of these counselors to help with any issue a student may have.  
When teenagers are struggling with emotional problems, they often turn to alcohol or drug use to help them manage painful or difficult feelings. In this, they are not different from adults. But because adolescent brains are still developing, the results of teenage "self-medication" can be more immediately problematic.  
In the short term, substance use can help alleviate unwanted mental health symptoms like hopelessness, anxiety, irritability, and negative thoughts. But in the longer term, it exacerbates them and often ends in abuse or dependence. Substance use escalates from experimentation to a serious disorder much faster in adolescents than it does in adults, and that progression is more likely to happen in kids with mental health disorders than in other kids.  
Treatment varies among different mental disorders and by age. Based on US data from 2023.  
Among children ages 3-17 with a current mental health condition, just over half (53%) received treatment or counseling from a mental health professional in the past year, and 43% took medication for an emotional, concentration, or behavioral condition.  
Among children with depression, 79% received treatment or counseling, compared with 59% of children with anxiety and 52% of children with behavior disorders.  
Receipt of treatment or counseling increased with age, from 36% of children ages 3-5 to 60% of children ages 12-17.

Members of the band include Perryman who sings and plays rhythm guitar, Doug Cole who sings and plays bass guitar, Rick Weaver on drums and Terry Wood on steel guitar. Wood has also written books about the steel guitar and been in steel guitar contests. The group has played in many venues in Missouri, Oklahoma, Kansas and Texas and hope to get established in the local area.  
"In the 1970's, when I was a lot younger, I worked for different radio stations opening for shows that the stations were involved in," said Perryman. "I did this for 10 years until I found that I was going to be a father, and I left show business, moved to a family farm, raising cattle and kids for 35 years. Then about seven years ago, Terry Wood asked me to sing on his steel guitar show. I didn't think I had it in me after all those years, but I tried it and got along good. We booked a couple of dances and put together a band and have been playing ever since."  
Perryman said that although the band also does some old-time rock 'n roll from the 50's and 60's, they mostly perform tribute songs of old-time country classics with some occasional songs of George Strait. Some of the stars Perryman opened for back

in the 1970's included Mel Tillis, Freddie Hart, Billy Crash Craddock, Margo Smith and T.G. Shepard. He has also opened for Mickey Gilley, Johnny Lee, George Jones, Jean Shepard and Earnest Tubb. He has worked with Conway Twitty, Jr. and other Nashville acts. He worked for KAYQ Country Plus Radio in Kansas City, MO; KTOW Country Radio in Tulsa, OK; and KBIL in Liberty, MO. He has played at the Worlds of Fun in Kansas City, Cains Ball Room in Tulsa, and Will Rogers Roundup Club, Claremore, OK.  
Tammy McCaslin, a Benton County resident, has been friends with members of the band who are from Conway, Missouri, for 50 years. She said that Perryman's and her kids used to play together. She told Perryman that she would take care of publicity for the show on November 9.  
The Warsaw performance will run from 7 to 9 P.M. Admission is \$10, but senior citizen tickets are \$5, and kids 12 and under are free. Some of the show sponsors are giving out a few free tickets to the show. Sponsors include Jessica's Fish Camp, Deer Rest Campground, Beth's Osage Mini Mart, Pitts Houses Inc., Maples Ford, T&K Automotive, All American Heating & Cooling, PDR Paintless Dent Repair, G&W Country Mart, Main Street Spirits, Benton County Tire, and The Train Station.

Smelling victory, Cole Camp scored again as Rodriguez became a one man wrecking crew rumbling in from 21 yards out. The two pointer failed but that made the scoreboard read 22-8, in favor of the visitors.

The Indians score from the 21 but failed on the 2-point conversion as it was 22-14 after three.

In the fourth, Russellville tied the game at 22 on a 9-yard run and the two pointer with two minutes and change to go.

Cardinals junior quarterback Riley Sanders put on a show in front of a nice post-season home crowd with school records of 476 yards passing and completions going 26 for 33 in a wild 56-34 Class 1 District 3 victory over (10) Skyline. He also tied former Cardinals Jackson Beaman for a school record with 7 passing touchdowns for Lincoln.

The No. 7 district ranked host school led 28-14 at the half.

Sanders had a lot of help as his receivers, Chase Young, Braeden Benham and Dawson Parrott added to the passing totals with great runs after catches. Young reached the milestone of 1,000 yards in nine games with 288 yards on 10 catches with 4 touchdowns. He missed a game earlier in the season with an injury.

Lincoln scored at the 3:24 mark on a Sanders pass to Young and the two pointer also found Young for the 8-0 lead.

The quarter change moved the ball from the 1 yard line to the other end of the field. Skyline sophomore quarterback Carter King plowed in for the score. The 2-point pass attempt was no good and it 8-6 at 11:58.

Another Sanders pass play to Benham ended in the endzone after a 52-yard romp and made it 14-6 at the 7:06 mark following a failed point-after-try.

King would not be denied as he raced 24 yards for

another TD at the 4:09 mark and with the two pointer it was tied at 14-14.

A 10-yard pass in the flat to Young turned into a 45-yard TD, the duo's second of the night. The PAT pass was incomplete making the score 20-14.

At the 1:17 tick, Cam Everhart romped in from 6 yards out to make it 26-14. Sanders found Benham in the endzone for the 2-point conversion and it was 28-14 at the half.

It didn't take long for Lincoln to put Skyline on notice as they scored on a 35-yard pass to Young at the 10 minute mark to make it 34-14. The two pointer failed.

Skyline answered as King scored from the 1 and then swept across the field for the two pointer to make it 34-22 at the 3:20 mark.

A healthy Dawson Parrott raced down the left sidelines from the 37 on a nice toss from Sanders to make it 40-22 at 2:44 point. The 2-point

pass attempt failed.

In the fourth, King scored again at the 11:22 tick. It was a tough night for PAT's but it was now 40-28 and the fat lady was tuning up.

On a beautiful 10-yard pass from Sanders to tight end Ben Eckhoff over the middle in the end zone, the score made it 46-28 and Everhart tacked on the 2-point conversion to lead 48-28.

Skyline scored again at 7:49.

Sanders threw a bomb to Young for the final TD from the 30. He would leave the game with cramps but appeared okay after the game. Parrott came in and hit Benham for the two pointer for the 56-34 final score.

Parrott also had a 45-yard return and a 44-yard punt.

Lincoln, now 5-5, will need him at 100 percent as they travel to face 8-1 Adrian this Friday. An old fashioned shoot out would give Lincoln a chance at the upset.

Coach Brad Drehle commented on the win.

"It was a big win, good win for us," the coach said. "We needed it. We struggled last week but we bounced back tonight. Next week will be a big challenge against Adrian. No one stops their run."

Statistically, Ashton Wolfe led the defense with 9 tackles. Everhart ran 16 times for 39 rushing yards and Sanders finished with 6 rushes for 30 yards.

Benham hauled in 6 passes for 94 yards with a TD and was also good for 2 PAT's.

As mentioned, Lincoln will travel to (2) Adrian this Friday for district action. The Blackhawks received a first round by after their 8-1 record landed them one of the top two seeds in the district. The winner of that contest will face the winner of Ash Grove/Midway on November 15.

## CORNER

The conclusion of the Wildcats football team's undefeated regular season spurred me to do some digging into the entire history of the program; coaches, records, and more. After a few hours and quite a bit of help from Cindy, Nicole and others at WHS, here's what I found.

When making the decision to add football, then superintendent John Boise said, "University High School in Warrensburg was shutting down, so I went up there and bought all of their equipment; pads, helmets, blocking dummies, tackling dummies, everything for \$200."

He went on to say, "We also knew that we needed a scoreboard, and Eldorado Springs was getting a new one, so I drove down to Eldo and bought their old one for \$50."

With everything they needed, the high school program played a junior varsity schedule in 1977 and finished undefeated at 6-0 under the 'Cats first head coach Alan Meyer.

In 1978, the program made their move to varsity and struggled right away, going just 1-8. In Meyer's 9 year tenure, Warsaw posted just one winning season, going

6-4 in 1980. He finished his career for the Wildcats with a record of 26-50, a winning percentage of .342, and never appeared in the post-season, prompting the district and the powers-that-be to make a move.

Meyer is now retired and resides in Lexington, Missouri.

Enter a young Randy Morrow, who at the tender of age of 36, took on a "project" program, to say the least.

We're all well aware of Morrow's success and that it was so much so that he is now a member of the Missouri Sports Hall of Fame and has a field with his name on it, but let us not forget that in his first season at Warsaw, the Wildcats posted a record of just 1-9. In 1988, the 'Cats were just 3-7 and, at the time, both Morrow and the district may have questioned their decisions.

But in 1988, Warsaw shocked the community, district, state and maybe even themselves by going 9-1 in the regular season and played in the state semifinals, only losing to private school powerhouse John Burroughs (St. Louis).

The taste of success had set in though and the

Wildcats went 10-0 in 1989 with another semifinals appearance and in 1990, the 'Cats won their first state championship with a 42-7 win over South Shelby after finally upsetting John Burroughs in another semifinal showdown. That team finished 13-1 with their lone loss coming to Eldon in week 2.

Another post-season run to sectionals in 1991 preceded 3 straight undefeated regular seasons.

The 1992 squad's season ended in a quarterfinals loss but in 1993, the 'Cats completed the program's first-ever perfect season, going 14-0 with the second state title in school history after a 13-12 victory over Lutheran North (St. Louis).

In 1994, Warsaw rattled off 13 straight wins and made their second consecutive appearance in the state title game, only this time coming up just short in an 18-13 loss to Monroe City.

Morrow made one more appearance in the state championship game in 2001, coming up just short to John Burroughs (St. Louis) in what some sportswriters still call "one of the greatest championship games ever". That team finished 12-2.

Following that season, and after 16 years at the helm, Morrow made the decision to retire and the Wildcats turned the program over to longtime Morrow assistant, Tony Berry.

Berry went 10-3 with a state semifinals appearance in 2002 and then made a trip

to the quarterfinals in 2003 with an 8-4 team. He went 5-5 in 2004 and a dismal 3-7 in 2005 before returning to the post-season in 2006, going 6-5 and ending that season in the sectional round.

Berry's tenure at Warsaw ended after a 5 year run. The third-ever coach in program history completed his career with the Wildcats going 32-24 with a winning percentage of .571.

He has since retired from education and is enjoying his time with his wife, Betsy in the Bolivar area.

So where did the Wildcats turn next? Now a local businessman, the district went back to Morrow to lure him out of coaching retirement.

In 2007, in Morrow's first year of his second stint with the 'Cats, they went 8-2 and matched the sectional appearance that they had made just 1 year prior.

In 2008, the Wildcats' season ended in the quarterfinals and with an 8-5 record. In 2009, the magic made it's way back and Warsaw posted their fifth-ever undefeated regular season at 10-0. However, with the team poised to make another deep run, a key injury late in the season forced a Wildcats star to sit out in a sectional contest at home with Pierce City. The Wildcats were upset in that game, ending their season at a "disappointing" 10-1.

A 7-5 season in 2010 with another quarterfinals showing officially put a cap

on Morrow's career with the Wildcats.

The much admired and now local icon posted an overall record of 183-56 with the Wildcats with a winning percentage of .766.

His team's made 4 state championship appearances, won 2 titles and completed 5 of the program's 6 undefeated regular seasons.

Morrow now enjoys retirement in Arizona with his wife, Debby, but still returns to Warsaw on occasion and usually makes time to catch a football game during his visits.

Following a legend is not an easy task as Kevin Gundy learned in 2011.

Gundy's tenure at Warsaw rightfully ended after a 1-9 campaign and possibly the most embarrassing moment in the program's history when that team forfeited in a post-season blowout loss at Lamar.

Gundy had stops in Waynesville and Gallatin before a brief retirement. He returned to coaching in 2020 when he was named the coach for Keytesville/Northwestern's new 8-man football team. He now resides in Brunswick, Missouri with his wife.

In 2012, the Wildcats turned to another young coach in Blake Markway.

Markway, a prior assistant under Morrow and then Gundy, was a "football guy". However, his first season did not go as planned, ending with a 2-8 record. A 4-6 record in 2013 prompted his exit and since,

the former 'Cats coach has found success with the Crusaders at Class 6 St. Dominic (St. Louis).

Upon Markway's departure, Paul Thomas made his way to Warsaw after already having a successful career at Marceline. With numbers down, much ado to the lack of recent success, Thomas' team's struggled.

In 2014, the 'Cats went just 2-8 and then two winless seasons in 2015 and 2016 (thankfully the only one's in the program's now storied history) sent Thomas on his way with a 2-28 overall record.

Thomas is now retired in Missouri, but coaches middle school football in Texas.

With nowhere to go but up, that's when Warsaw turned to an old friend. After quarterbacking for Morrow's state championship runner-up team in 2001, the time was right for Ryan Boyer to come back "home".

In Boyer's first season, the 'Cats went 4-5 and after a 2-7 season in 2018, Warsaw has now posted 6 straight winning seasons with their most recent being the sixth undefeated regular season in Warsaw's history.

Boyer knows that he is chasing greatness, but he already holds the second highest winning percentage at the school at .654 with a record of 51-27 and still counting.

We'll update the "board" soon, but hopefully not for another few games.







Nominations are being accepted for the January 2025 election of the University of Missouri Extension Council in Benton County.



### A Mighty Sick Hog

Despite the Missouri Conservation's request to all hunters who encounter a feral hog to shoot it on sight, the animals are proving themselves survivors. The hog, tame or the wild variety, has been very important to the Ozarkers over the years. In fact, the razorback has been to our region what the longhorn was to Texas.

About sixty years ago a gentleman from down on Hogles Creek took a visiting trip out to California to some of his kin that had migrated out that way a number of years before. The 78 year-old man was questioned upon his return of what all he had seen in the thirty days he had been gone. To which he replied: "I certainly am glad to get back to Benton County. I was all over the state of California and never saw a single hog. That's enough to make anyone homesick."

One of the most important outbuildings to the early pioneers was the smokehouse. They smoked bear, turkey, venison but the chief source of meat was the hog. The stock all ran loose and foraged on acorns and roots. For two dollars they could buy into a hog claim and that gave you the right

to equal shares of meat when they had a butchering.

Down late in the fall the hogs couldn't get as much food as they needed and one man would be designated to take corn to a big spring or a free flowing branch and throw it out on the ground. That would get the hogs coming there daily in search of food. The reason for doing this next to water was so they would have plenty for scalding the hogs and cleaning the meat on hog killing day.

All the men, on the big day would circle around the area with guns. They would shoot as many as they thought they could dress out that day. Then they would equally divide the meat for their own tables at home.

If an area was sparsely settled and had enough room for each farmer's hogs, they would just roam on the "range" and would be earmarked or branded. This identified ownership and sometimes they had the brands registered in the courthouse.

Prior to the 1920's stock laws were written and all people were supposed to fence their animals into confinement. For the most part everyone complied. The year of 1934 was not only difficult because of

the depression but it was a terrible drought year in this area. Winter was approaching and the gardens had failed and people wondered what they would eat in the coming months.

My paternal grandparents, with their usual Ozark ingenuity, turned their hogs loose to range on the large acorn crop and that was sufficient to fatten them enough to be their meat supply for the coming winter.

Many wild tales have been told about the razorback hogs of Arkansas. They are supposed to be descendants of hogs that were brought here by DeSoto and they escaped into the woods to become the gaunt animals that have been described as to thin to cast a shadow. It was said they had ridges on their backs so sharp that they could be used as a razor. Everyone always agreed that the most dangerous animal in the woods was an old range sow with a litter of pigs.

Hog meat is not the only thing the Ozarkers are noted for. They have always been known for the humor of the backwoods. The ruse most used in backwoods humor for its impact is exaggeration. Exaggeration is used with telling effect because it is used to distort some distinctive trait of their subject. A prime example is an age old story about the toughness of range hogs. They may not have the fighting equipment of a wildcat or the strength of a bear but when it comes to absorbing punishment and coming back for more, none can match them.

The old story is told about the farmer that was clearing ground, grubbing out the stumps by hand, which is the worst backbreaking work imaginable. A County Agent came by and showed the farmer how easily and cheaply the stumps could be removed with the use of dynamite. The farmer was grateful to find such a wonderful solution. He went to the store and purchase dynamite, fuse and caps. Coming home, he dug a hole by a big black oak stump, set a charge of dynamite under it, lighted the fuse and went to his cabin for supper. The fuse went out and by that time the farmer was clean up to the house so he decided to

wait until morning before re-lighting it.

Early the next morning the farmer's big old range sow got up and went foraging. She found the stick of dynamite and ate it. She rooted around for bugs, roots and acorns for awhile and then she saw the farmer feeding the other stock in the barn lot. She hustled up there to see if she could steal some of the mule's corn. She ran into the mule's stall and headed for the feed trough. The mule quite naturally kicked

at her and for the last time in its life, made contact. The dynamite went off!

Neighbors heard the explosion and hurried over. They found the farmer leaning on what was left of his rail fence, viewing the ruins. One of the neighbors commented that it looked pretty bad. "Yes" said the poor farmer, "it is bad. It killed my mule, wrecked my barn, broke every window in the cabin and brother I am here to tell you that I've got a mighty sick hog."

## Perception Study Highlights Areas Of Improvement For County

Concerned citizens from all around Benton County came to Lincoln's City Hall to learn the results from a perception study done on the county this past year. Earlier in 2024, Jo Ann Lane from Benton County Economic Development and Lynette Stokes from Benton County Tourism worked together with MU Trulaske School of Business to facilitate a tourism and economic development study.

The study surveyed people from Benton County and beyond to find out what is needed in our area and what is working in the locale regarding tourism and investors to invest in Benton County. The research team gathered the data by compiling feedback from a detailed survey, going out to residents and visitors to the county.

Some of the key takeaways from the study included, the area is known for its beauty and outdoor offerings. The proximity to lakes, outdoor recreation and the affordability, plus safe environment.

Some weaknesses of the county was listed as lack of indoor activities, new


experiences every time I visit, variety for each member of the family, clean hotels and convenient locations and the lack of a variety of restaurants. Benton County did out Truman Lake and Pomme De Terre but trailed Lake of the Ozarks and Table Rock.

Other findings concluded that Benton County has less family households per capita than the national average. Families that do live here are mostly lower middle class and the county needs to find ways to attract upper middle class. 30% of the residents are aged 65 and older, which is much higher than the national average.

The study suggested that the county needs the establishment of more homeowners associations to attract both families and seniors. Most of the current Benton County associations cover seasonal lakeside properties and campgrounds but the county needs more full-time residential associations.

The reports on the study done were lengthy and covered many aspects of need in-depth. The goal of the project was to find ways to attract more visitors and residents alike to Benton County. The members of Benton County Tourism and Recreation understand the county's potential and want to make sure they are maximizing its current offerings while finding ways for more opportunities to attract more people. It is crucial to research new potential endeavors as a stagnation of offerings could lead to tourism decline over periods of time.

By the end of the evening it was concluded that meetings need to be held similar to those that brought about the forming of a Benton County Economic Development group and the hiring of Jo Ann Lane to spearhead the group. The meeting should be residents from all over the county gathered in groups to kick around ideas and solutions to arrive at what forward path the county could/should take to improve housing, job opportunities and what will enhance the overall image to bring more tourism dollars to the Benton County area.

Mr. Smith stated there are 720 farms in Benton County with 72,600 acres of pasture. 98% are family farms that care for 42,000 head of cattle in the county. 24,000 are beef cattle that accounts for 30 million in sales annually. He shared the average age of a Benton County farmer is 68.

He went on to say anyone that has beef herds should belong to the Benton County Cattlemen's Association and shared that any business supported by beef producers can also belong and should. Smith closed with a Thomas Jefferson quote on Agriculture. Jefferson said, "Agriculture is our wisest pursuit, because it will in the end contribute real wealth, good morals and happiness."

President Smith announced it was time for dinner and wanted everyone to know the Sonic Corporation was furnishing the drink cups for the evening and will for all events throughout the year.



Then he added, "By the way, Sonic serves 100 million pounds of beef annually."

Vice-President Mike Dieckman offered the prayer and then attendees were treated to a great meal of delicious roast beef, Caesar salad, hot rolls, Cheesy potato casserole, accompanied by Balsamic green beans. All topped off with a choice of Chocolate cake with cream cheese icing or Ooey-goey pumpkin cake with whipped cream. The food was prepared by Taste Buds catering from Lebanon, Missouri.

Following the meal the speaker was an Agriculture student from MU, Colton Whitney. Colton grew up and graduated from Skyline School and walked everyone through his days in high school Ag, sharing how many projects he didn't want to do but how much he gained from participating in them by being an FFA member. Now majoring in

Agriculture at the University he is discovering many avenues for his future and how much he is enjoying working in his chosen profession.

First responders from Warsaw/Lincoln EMS and two Officers from the Lincoln Police Department were on hand for the event and the Lincoln High School FFA members donated their labor for the evening to assist with serving food and also selling raffle tickets throughout the evening. Final tabulation is not in but it is believed that close to \$10,000 was raised for the Scholarship program that benefits seniors from Cole Camp, Lincoln and Warsaw.

Ideally, you might want to use a credit card strictly for items such as car rentals or hotel reservations, and you should pay off the bill each month to avoid interest charges. Sometimes, though, you may need to use your card for other purposes, and it may not always be possible to pay your bill in full. That's why you'll want to review credit cards periodically to find one with lower interest rates, a favorable balance transfer offer and a better rewards program.

It's not always easy to cut down on your spending, but when you do, it can provide more peace of mind — and an opportunity to boost your savings for what could be a long and active retirement.



Compared to last week, steers and heifers sold uneven with the majority of steers selling steady to 5.00 lower but the calves weighing 500-600 lbs. sold 5.00-15.00 lower with few weaned longer than 30 days. Heifer calves that were weaned saw just the opposite with better demand than their brothers and sold 5.00-10.00 higher with spots up to 15.00 higher while the yearlings sold steady. The un-weaned or shorter weaned calves and those carrying flesh saw sharp discounts when compared to the long weaned calves and yearlings. Demand was moderate to good, but the un-weaned calves saw light to moderate demand with a big cold front coming through with some moisture the middle part of the week to create a pretty good recipe for a sick calf. Supply was moderate. Slaughter cows & bulls sold \$3-\$5 lower.

found in a life full of faith. First, we must establish that every human relationship is shaped by faith or the lack of faith in each other, yet is seldom spoken when we address friendships, marriage, and work. The pain in broken relationships is not the lack of love (Romans 8:39) but from shattered trust (faith) in the other person. Maybe this is the main reason people have not returned to worship with other believers since CoVID. Maybe, this is why the younger generations are walking away or seldom attend worship with other believers. They do not know how to really walk in faith. Why am I opening this door? The global church in our country has a virus— instant Christianity—that needs addressed.

In the beginning God created the heavens and the earth - Genesis 1:1 How many believers in God, the Father, fully believe these words? Is it true? Of course, humans were not there to record with their senses what God did for us in love, so it requires faith to trust in scripture. (Hebrews 11:1) Maybe you believe today, did you always place your faith fully in those words? Consider Peter's situation in the New Testament. He knew Jesus was the Messiah and our Lord confirmed the faith Peter was exercising by telling Peter that only His Father in heaven could reveal this to Peter (Matthew 16:17), yet in his faith walk Peter denies His Savior at the trial of Jesus—three times. While our faith will be tested, we must remember Jesus words "I am the true vine, and My Father is the vinedresser. 2 Every branch in Me that does not bear fruit, He takes away; and every branch that

bears fruit, He prunes it so that it may bear more fruit. 3 You are already clean because of the word which I have spoken to you. 4 Remain in Me, and I in you. --John 15:1-4 (NASB)

You must... remain true to the source to remain clean—not perfect. You must trust the Holy Spirit's guidance in your sanctification. After all, it is your choice. The greatest tragedy spinning out of instant Christianity, as defined by A.W. Tozer in his essay of the same title, is the desire for instant fruit. How many years does it take before a vine produces fruit desired by the master? We must remain in Him by renewing our minds daily. While you were made clean the instant you received Jesus in your heart, you must NOT let one faith experience in Jesus determine your value in the family of God. Ask the saints in your church body to testify about their faith forming experiences. I have no doubt there are many such experiences that they have built their house on over the years.
