## **Cole Camp Council Studies** Impact Of **Increased Water** & Sewer Rates

Cole Camp's City Council held their regular monthly meeting on Thursday, November 21 with a full council present. Following the routine approval of minutes, bills and financials, Public Works Director Heath Roark presented the council with three rough quotes for the construction of a storage building for his department. It was decided to pursue this further when the council begins holding budget meetings for the various departments.

LAGERS was tabled until a representative is on hand to explain the details of the program.

The council held a first and second reading by title only of Bill No. 2024-13 to extend the current street tax which will be on the April 2025 ballot. This will extend the tax at the current rate. It passed to become Ordinance 569.

Updates on grants: Nothing new or changed on Butterfield Park equipment, the cultural study is back but nothing more. It is believed construction is to begin on the North Maple Street sidewalks in April or May 2025, with assurances they will be completed by the Cole Camp Fair in

In my early catering days, so many decades ago, my

sobriquet among my foodie friends was "the queen of cream cheese". And why not? Having a couple of blocks of cream cheese in the fridge is insurance. Dozens of recipes abound which feature it and this is one of my favorites. No exact recipe, just use softened cream cheese.

Chop up some green olives with pimentos, mix, add a splash of Worcestershire and you are done. The amounts are up to you, I usually use about 1/3 to 1/2 cup olives to each block. Getting fancier, you can add pecans, minced onion and

Spreading pepper jelly on

top of a block is an instant entertaining help.

Pour some soy sauce in a shallow pan, add a block of cream cheese turning it over to stain the block, then roll in toasted sesame seeds. Easy enough.

Roll ups are always popular. This one was a favorite.

Mix together 3/4 cup spreadable cream cheese and 1/2 cup crumbled cheese of choice. Pat dry 12 slices lean deli pastrami and 12 dill pickle spears.

Spread about 1 tablespoon cheese mixture over each pastrami slice; top with a pickle spear. Roll up tightly. Cut each roll into 4 slices.

(Continued from Page 1) the 2023 audit back. It is a clear, clean audit. Some minor issues were addressed but nothing different than from before.

There was a first and second reading by title only of Bill No. 2024-12 for zoning changes for James and Nancy Theisen property. It was changed from R-1 to A-1 and became Ordinance 568. The property is on Cash Lane behind Oak Street.

Bill No. 2024-14 had a first and second reading by title only to become Ordinance 570 and establishes the city hall office will no longer be open on Saturday mornings.

The council is studying what the rate increase will be on the water and sewer. It has been twelve years since it has been adjusted. It is strongly suggested by state agencies they be adjusted every six years.

Planning and Zoning will hold meetings on November 26 and again in December. They are considering a complete overhaul of the ordinances

Dave Locke brought subject of the Comprehensive Steering Committee to the floor. City attorney, Nathan Nicholaus stated, "This is the Planning side of Planning and Zoning. It will show how Cole Camp should look sometime in the future. It includes infrastructure of sidewalks

and streets." He concluded, "State statues say we need a Comprehensive Steering Committee."

Public Works Heath Roark said the City Hall window project is completed. Councilman Locke asked, "When are you finally finishing the Spring Street sidewalks?" Heath responded, "Hopefully next week. I've been called off to prepare for Christbaumfest." The Police Chief "The temporary Stop signs have

been blowing over at North Maple and Junge Street. They have been removed for safety's sake. "

The City Clerk announced the city's Christmas dinner will be on December 2. Dawn reported she had looked up about the library fund. The library fund is in the Community Foundation of the Ozarks and the money can be paid out for roof repairs. The funds are designated for the library. City Clerk, Dawn and Linda Allcorn with Boonslick Library would need to sign off on it.

**Bees or Butterflies?** 

Down here on the creek, I was taught American History in a little one-room school house. As I have aged I have discovered that so much of it was a fallacy. Discovering George Washington didn't chop down the cherry tree was a little like realizing there wasn't a Santa Claus. In the past few years I have been wised up to the real truth behind the first Thanksgiving celebrated in

In the Edmonson School Thanksgiving myth unfolded yearly, complete with stereotyped Indians and stereotyped whites. No where in our textbooks did it tell us that Squanto had traveled to England in 1605 with an English explorer named John Weymuth. During this time he mastered the English language and returned to New England with Weymuth. Later he was captured by a British slaver who sold Squanto to the Spanish in the Carribean. A Priest befriended the Indian and assisted him in reaching Spain and then put him aboard a ship to England. Squanto located Captain Weymuth who arranged to

get him back to America. Not all the whites were as benevolent as John Weymuth. The truth of the next few months, teaching them to cultivate corn and vegetables and how to build an Indian style home. He taught them the

difference between poisonous plants which plants to harvest for medicine. He taught them to dig and cook clams and how to obtain the sap from the maple trees and many other skills required for their survival. Because there was enough food to last the winter and they had adequate shelter they decided to have a harvest feast to celebrate their good fortune. It would be reminiscent of the Thanksgiving feasts they had observed in England before coming to the New

Captain Miles Standish, the leader of the Pilgrims, invited Squanto, Samoset and Massasoit the leader of the Wampanoags, along with their families to join them in the feast. The Pilgrims had no idea how large Indian families could be and were overwhelmed at the large turnout of ninety people. Thanksgiving festivals were very familiar to the Indians as they held five a year to honor various gifts from the Great Spirit. They turned out in force and there would not be nearly enough food. Chief Massasoit sized up the situation and ordered some of his men to go home and bring more food. The Indians themselves furnished five deer, several wild turkey, fish, beans, squash, corn soup and cornbread, topped off with

Captain Standish sat at one end of the long table and Chief Massasoit at the other end. It was the first time the Indians had ever eaten at a table and the Indian women

sat with their men to eat. The Pilgrim women stood behind their men and waited until they had finished before they themselves partook of the meal. During the three day feast an agreement was made between Standish and Massasoit, giving the Pilgrims the clearing in the forest, for the new town of Plymouth.

In an ideal world they would all have lived happily ever after but alas just two years later Elder Mather delivered a Thanksgiving sermon in which he stated: "We should give special thanks to God for the devastating plague of small pox which wiped out the majority of the Wampanoag Indians. Chiefly young men and children, the very seeds of increase." He continued on, "this has cleared the forest to make way for a better growth."

How could a people who fled to America seeking freedom and justice be so callous toward their Indian benefactors and particularly Squanto who was their very angel of survival that first year? The Pilgrims and the Indians are a parallel to the bee and the butterfly. A bee sips his honey and hums his thanks to the flowers as he leaves. The gaudy butterfly is cock sure that the flowers should be thanking him. We are preparing to celebrate Thanksgiving and now I ask,



SUNSHINE LAW IN A NUTSHELL

We have been receiving multiple requests documents, mostly the same ones, from citizens. I am happy to see that the people of Cole Camp are taking an active interest in of their city government. Every citizen should be informed about what is happening in Board of Aldermen meetings and in committee meetings. I'm writing this to clear up common misconceptions about the Sunshine Law and to help citizens to receive the information they need to stay informed.

The Sunshine Law is found in Chapter 610, RSMo. It can be found on line or you may call the Attorney General's Office at 573-751-3321 to request a paper copy of the complete law. I am highlighting specific areas in this message.

Sunshine Law allows 72 hr. (three business days) for the city to respond to a request. This means that someone from the city will contact you about your request. It does not mean that you will have what you requested within three business days. The City Clerk is the keeper of records and is responsible for responding to these

requests. She may not have the requested information and need to obtain it from a committee chairman. It may require research into past files and that can take a while. Please don't wait until the day of a meeting to request information about that meeting.

Sunshine Law allows the city to charge for making copies and for the clerk's salary for the time required to process the request. There is no specific information that I have found regarding charge for digital information. The city is allowed to recoup the cost for responding to the request and the information is not provided either electronically or on paper until the fees are paid. The clerk has not been charging a fee for digital transfer of information up to this time. However, I plan to discuss this with the Board of Aldermen soon because it takes the clerk away from her other responsibilities. The number of requests we have been receiving recently are taking a significant amount of time.

Closed records are not available to the public. There is a list of 25 items that are considered closed information that are listed in the Sunshine Law. Minutes of closed sessions are generally available 72 hours (three business days) after the meeting unless they contain information listed in those 25 items.

I hope that this will clear up some of the questions about the Sunshine Law. This is in no way a complete summary of the law. It is meant to answer some of the most common questions I have heard from others.



The individual retirement account (IRA) is celebrating its golden anniversary. Created in 1974, this savings vehicle has helped millions of people build resources for retirement. And in 1997, the Roth IRA was introduced. But which IRA is right for you?

Let's look at the basic differences between the two IRAs. With a traditional IRA, you generally invest pretax dollars, so the more you put in, the lower your taxable income. earnings grow tax deferred, meaning you pay no taxes on them until you start taking withdrawals. (If you take withdrawals before you reach 59½, you'll be subject to ordinary income tax and a 10% IRA penalty.)

When you invest in a Roth IRA, your contributions aren't deductible, but they can be withdrawn at any time, tax- and penaltyfree. And you can typically withdraw your earnings on these contributions tax free once you're 591/2 and you've had your account at least five years. (If you don't meet these conditions, withdrawals of earnings are subject to income taxes and the 10% penalty.)

So, are you better off by taking the immediate tax break offered by a traditional IRA or the longterm benefits of tax-free withdrawals available with a Roth IRA? If you think you'll be in

a higher tax bracket when you retire, you might want to consider a Roth IRA, especially if you have a long time until retirement. This will give you more opportunities to put away funds that can be withdrawn tax free. Conversely, if you think you might be in a lower tax bracket upon retirement, you might lean toward a traditional IRA, as you'd get the tax benefits now, when you're in a higher bracket, and can eventually make your taxable withdrawals when you're in a lower one.

Here's something else to keep in mind: Once you

turn 73 (or 75 if you were born in 1960 or later), you must start taking taxable withdrawals — technically called required minimum distributions, or RMDs — from your traditional IRA. But if you have a Roth IRA, you won't face RMDs and can essentially keep the money in your account indefinitely. If you don't need all the funds in your Roth IRA for your retirement, you can pass them on to your heirs.

Ultimately, though, your income may determine which IRA is right for you. You can earn any amount and contribute to a traditional IRA, though if you exceed certain income limits, your contributions may no longer be tax deductible. If you and your spouse don't have a 401(k) or other retirement plan through your employers, you can make a full, deductible contribution to a traditional IRA regardless of your income.


But you may not be able to contribute to a Roth IRA, or at least not make the full maximum annual contributions, if your income is above certain levels. Your tax advisor can explain these levels, which often increase from year to year. (In 2024, the most you can contribute to either IRA, depending on your income, is \$7,000 per year, or \$8,000 if you're 50 or older.)

Under some circumstances, you can convert a traditional IRA to a Roth IRA, though you'll need to pay taxes on the conversion. In any case, think carefully about your options and make the choices that are appropriate for your needs.







### **Cattle Windbreaks**

Winter cold and wind are soon going to be upon us. Wind chill values are a usual part of any winter weather forecast. Wind chill also impacts livestock, so developing some type of wind protection is beneficial to the performance and well-being of the animals we care for.

Research has shown that below 30 degrees Fahrenheit, energy requirements of beef cattle increase about 13% for every 10-degree drop in windchill. Providing wind protection is therefore reducing beneficial in the amount of extra feed or supplement needed to overcome the impact of windchill.

Windbreaks or wind protection comes in a variety of forms. If natural windbreaks are unavailable, man-made structures can be constructed. There are a few guidelines to follow, however, in order to make these structures more effective.

Solid windbreaks are not recommended. Wind protection is lessened downwind of the structure compared to windbreaks that provide some porosity. Also, drifting snow due to down drafting is an additional problem close to the structure and can reduce the benefit of the windbreak. Recommendations for cattle windbreaks suggest a minimum height of 10 feet with 25 to 33 percent

cattle windbreaks suggest a minimum height of 10 feet with 25 to 33 percent porosity. This allows some air movement close to the structure and reduces the amount of snow deposited close to the downwind side of the windbreak. Leeward wind and drift protection is provided 8 to 10 times the height of the structure with this amount of porosity. For example, a 10-foottall structure with 25% porosity would provide wind and drift protection approximately 80 to 100 feet downwind of the windbreak.

If constructing a structure with 6-inch-wide lumber, a spacing of 1.5 to 2 inches

between boards will provide the recommended amount of porosity. Also be sure to leave some space at the bottom of the windbreak for a bit of air flow and to allow the area to dry out. Four to six inches are recommended. If necessary, some straw or hay could be placed at the bottom of the windbreak during extreme weather events. Provide about 25 square feet of protection per cow or 1 foot of length per cow. A width to height ratio of 10:1 is also recommended, so the length of a 10-foot-tall structure should be 100 feet for maximum wind protection.

Windbreaks should be oriented perpendicular to wind direction, but V-shaped or L-shaped structures can also be effective. Windspeed will increase around the edges of windbreaks, so keep edges away from waterers, feed bunks, and resting areas. Also pay attention to windbreak placement due to the potential for drifting snow.

Wind protection is beneficial to livestock but be sure if constructing windbreaks that you also consider drifting snow so a solution to one problem doesn't cause another one. Farm site planning, building placement, and potential for vegetative windbreaks are other considerations to keep in mind.

There are a variety of resources available for planning both constructed wind breaks as well as planting, placement, and species selection for vegetative windbreaks. Many different materials can be used for this purpose but keeping in mind a few general guidelines will make wind protection for farmsteads and livestock more effective.

I've been getting lots of mail lately and not the kind I like, which is generally gifts or Amazon packages I've ordered. For months, letters and postcards have been arriving in my mailbox reminding me to sign up for Medicare and extolling the virtues of Medicare Advantage plans. The trick with having an upcoming "big" birthday is that sometimes the wrong people


know about it. Medicare is federal health insurance for anyone age 65 and older, and some people under 65 with certain disabilities or conditions. For most people, the initial

Medicare enrollment period begins three months before turning 65 and ends three months after.

It's just coincidental that the window for me to sign up for Medicare is near the annual Medicare open enrollment period, which began on Oct. 15 and ends Dec. 7. During this time, Medicare members can review their options and make changes to their coverage, which will take effect on Jan. 1, 2025.

Medicare coverage has several "parts." Original Medicare has two parts - Part A (hospital insurance) and Part B (medical insurance), and people typically pay a portion of the costs for covered services as they get

Part Dhelps cover the cost of prescription drugs (including many recommended shots or vaccines). People can join a Medicare drug plan run by private insurance companies that follow rules set by Medicare. Medicare

Advantage plans, also known as Part C, are alternatives to original Medicare and are administered by private insurance companies. These "bundled" plans include Part A, Part B and usually Part D. In the U.S., Medicare Advantage enrollment in 2024 now totals 33 million, or 54% of all eligible beneficiaries. Two years ago, 34% of our patients eligible for Medicare chose a Medicare Advantage plan. Today, that number is 48%.

Enrollment in Medicare Advantage plans has grown rapidly partly because most plans charge no premium (other than the Part B premium) and offer extra benefits not available in original Medicare such as out-of-pocket maximums, dental, vision or hearing coverage and fitness benefits. In recent years, there have been growing concerns and inquiries into Medicare Advantage plans and their pitfalls for patients, providers health systems. and So much so that some hospitals, health systems, and skilled nursing homes have ended their contracts with Medicare Advantage plans or are considering it. Out of necessity, Bothwell Regional Health Center is exploring our continued relationship with some Medicare Advantage plans. Among the most commonly

cited reasons for consideration are needing approval from the plan before receiving a service (prior authorization), which can delay care for up to two weeks. Additionally, more requests for services are denied upfront. As a result, you may end up paying for services out of pocket or worse, decide to go without care. Medicare Advantage plan insurers reimburse at a lower rate than Medicare and are slow to send payments. This is especially troubling since Medicare rates only cover 79 percent of the cost of providing services.

Medicare Advantage plans were originally designed to offer patients more choice and flexibility, yet from a provider's perspective, they have evolved into a system rife with inefficiencies and inequities. The plans prioritize profit over patient care, leaving hospitals like ours to shoulder the consequences. Denied claims and delayed payments we're spending mean more time and resources on bureaucracy instead of patient care. This is a fundamental misalignment of priorities.

It's time for policymakers to take a hard look at the impact of Medicare Advantage plans on rural hospitals and the communities we serve. We need reforms that ensure these plans pay providers fairly, reduce administrative burdens, and prioritize timely payments.

As you can probably surmise, I will not be signing up for a Medicare Advantage plan when my birthday rolls around. I want the decisions about my health care to stay between me and my physician.


