# Tourism Director Sees Stellar Season On The Horizon For Twin-Lakes Area

Benton County residents and tourists alike have much to look forward to in the way of events, particularly those sponsored by Benton County Tourism. The Benton County ArtsFest takes place on Saturday, June 7, Whiteman Day is June 17 (this is an event to invite the sister squadron at Whiteman Air Force Base 509th to enjoy our area) and the Smokin' HOT Harborfest is scheduled for August 2.

The Benton County ArtsFest will be held at Sawdust Alley, 303 Seminary Street, and in the parking lot across the space from 9:00 AM to 4:00 PM. Included will be the Artisan Vendor Marketplace, Chalk Walk, Live Demonstrations, Live Performances and Open Mic at The Locker Room (from 12:00 PM to 3:00 PM). Also, part of the ArtsFest will be Competition and Exhibition in the Warsaw Community Building, lower level. This event is being held the same day as Jubilee Days this year.

Whiteman Day plans are coming together to allow Whiteman Air Force Base 509th airmen and their families the opportunity to spend the day utilizing our attractions in Warsaw at no cost to them (sponsored by

community businesses). The first annual meeting took place in 2023 when a day of jam-packed activities took place.

Smokin' HOT Harborfest will provide live music, beer garden, food trucks, a Kid's Zone, and more. Follow Facebook for more information as the August 2 date draws closer.

These events are not only

enjoyable for residents but also attract tourism, enhancing our local economy. Lynette Stokes, Executive Director of Benton County Tourism, says that several initiatives are underway to leverage existing assets and attract visitors to the area.

"One significant project is the Benton County Barn Quilt Trail, launched

in 2022 by a dedicated committee of local residents passionate about showcasing the region's cultural heritage," said Stokes. "This year, the committee is proud to work on its 22nd barn quilt, funded by Benton County Tourism through a grant from the Missouri Humanities Council. Visitors can expect an updated website soon, which

will feature expansions to the trail."

Stokes also revealed that a recent Brand Perception and Brand Awareness Study conducted by a marketing firm in Springfield has provided important insights into how tourists discover Benton County and their perceptions of our offerings. This study, supported by a Missouri

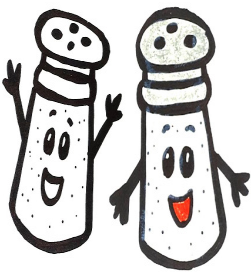
My late husband used to refer to me as the Queen of

Condiments; the refrigerator was usually packed with many assorted mustards, relishes, sauces and so on. But the one I often reach for to liven up a recipe is chili crisp, which is now readily available. Mixing a little with mayonnaise is a simple, quite tasty sauce. Division of Tourism grant and in collaboration with Benton County Economic Development, has revealed opportunities for attracting more visitors by identifying gaps in local attractions and businesses.

As a result of these findings, Benton County has initiated monthly committee meetings where stakeholders gather to transform innovative ideas into tangible projects. These projects include a unique dining experience, a conference center, a family recreation center, and a theater venue. The meetings are open to the public, and interested individuals are encouraged to participate. For further information, please contact Lynette Stokes at (660) 438-2090.

Stokes also said that the Benton County Arts Council is another exciting development in our community backed by tourism and local partners. The Council is in the process of obtaining 501(c)3 non-profit status, which will enable it to better support the arts in Benton County. Monthly meetings are held for individuals interested in getting involved, with President Dina Kowal available at bentoncountyarts@gmail.com for inquiries.

Furthermore, Benton County Tourism and the Benton County Tourism Board of Directors have established a partnership with the three local chambers of commerce to promote community events extensively. This collaboration focuses on maximizing visibility through social media, print, and digital advertising, as well as a county-wide event card.

To ensure the effective promotion of local events, our marketing strategy, developed by Stokes and the board, includes a mix of print, digital and social media outreach. Stokes was appointed Executive Director of Benton County Tourism in June 2017 after serving as Assistant Director. She has been instrumental in guiding initiatives alongside a ten-member board representing diverse community interests. Bi-monthly meetings enable ongoing collaboration.

Stokes and the board are actively seeking sponsors to support the summer festivals and enhance promotional opportunities for local businesses. She says that “Together, with robust community support, we can continue to offer unique experiences and foster economic growth in Benton County.”

does a great job working with our teachers in both ECSE programs and Pre-K program. When she came to Warsaw, she brought a lot of knowledge from other districts. I am excited for her in her retirement, but she will be missed at Warsaw South.”

Bell’s pre-school teacher partner Kristy Henderson was also sorry to hear of Bell’s retirement. “Mrs.

Bell has been a passionate and resourceful teacher for some of Warsaw’s youngest students. She has an immense knowledge of child development and helps students gain knowledge and social-emotional skills every day. She and her husband, Pastor Loren Whetsell, have also made it possible for students in our youngest grades to receive monthly books for several years now. She has been a wealth of knowledge and I wish them tons of luck in their new adventure in the UK,” said Henderson.

The youngest of six children, Bell grew up in Steelville, Missouri and graduated from SHS in 1986. She graduated from the University of Missouri at Rolla in 1990 then received her Master’s degree in 1996 from the University of Missouri in Columbia. Bell went on to earn an Education Specialists degree from William Woods in 2008.

Psychology was her first major as she knew she wanted to work with people to help them.

“I really didn’t consider becoming a teacher at first because I always felt my teachers put me down, but I found my calling in working with the little people and raising them up,” said Bell. “I felt the need to be an advocate for my students. I want all my students to be the best people they can be so I push for what they need.”

While finishing up her student teaching, Bell was offered a job in Moberly teaching special education. This assignment would lead to her appointment to Early Childhood Special Education where she was in charge of 12 school districts. Her next move was to Hallsville where she spent 12 years teaching Early Childhood Education. During her time in Hallsville, she was in charge of special education, the gifted program, all federal programs section 504 and worked as the Assistant Superintendent.

Bell next worked for the Alton/Thayer School District as a math, FACS, English and journalism teacher. She next went to St. Charles where she was employed by the Francis Howell School District as a Parents As Teachers instructor.

“I wanted to teach because it was a chance to touch the future,” said Bell. “I became interested in child development when I was pregnant with our first child. By working with the little people, I was able to shape the future one child at a time. I wanted to build people up to discover the tremendous skills within them.”

When her husband Loren accepted the position of minister of the First United Methodist Church in Warsaw, Bell accepted a teaching position with Warsaw R-9 as a pre-school teacher.

“I thought I was marrying a college professor and then after seven years of marriage and two children, Loren spent two months in England working on his dissertation and came home and announced he had received the call to go into the ministry,” said Bell. “We will be married 35 years this summer and he has been a minister for 23 years.”

Now, Rev. Whetsell’s calling will take Lucy to England as the United Methodist Conference is loaning his services to British Methodist Church where he will rotate between four churches every Sunday. “We both always loved British history and we look forward to this adventure,” said Bell. “We will be in England for at least five years and after that it depends on God’s calling.”

Bell and Whetsell are the parents of two children. Their daughter Lindsay Brennan, 32, and her husband Jordan live in St. Louis with their son Leander, 6. Their son Torsten Whetsell, 25, is a software engineer for GM in Southfield, Michigan.

Both Lindsay and Torsten plan to visit their parents in England and Leander will spend a month during the summer with them.

“The church is supplying us with a four-bedroom house so all of our family plans to visit,” said Bell. “God has a plan for us and we will go where God is calling us. I am sure I will always be working with children as I have felt that was my calling.”

ran unopposed for his west ward seat.

Police Chief Andrew Breshears reported that on March 14 officers took a report of an attempted child abduction in the area of the city park. Officers reviewed several cameras throughout the city. The vehicle was identified as a black Ford Escape with silver trim. Officers have been unable to locate a clear enough photograph to determine the plate number of the vehicle. The case remains under investigation.

Officers made three warrant arrests in connection with traffic stops this month. Traffic stops are

vital in their efforts to deter criminal and drug activity within the city. The Lincoln Police K-9 has been active over the last month and has been deployed twice at the Lincoln school. The department is happy to work alongside the school to make a safe learning environment for the students.

An update on grants: the Alco system has been purchased and should be sent soon. New firearms have arrived and are being outfitted and completed this week. The Lincoln Police Department continues to look for ways to improve safety efforts. In doing so, officers have been working overtime hours on traffic grants. These grants will continue through the summer and the busy season.

City Clerk Sabrina Brown, said she had nothing to report but did thank the council for taking the step to purchase new software. The Park Board Liaison, Seth Casey, reported the ball field is being worked on.

Public Works Josh Cole reported outside of normal maintenance they had trimmed trees in roadways, installed a power pack for the solar panel, dug out ditches for better drainage, reset a culvert on Lamine Street and patched roads. They also removed brush and small trees growing in the lagoon fence and cleaned out a plugged pivot sprayer nozzle,

Mayor Nelson stated he is applying for a grant for an additional lift station to serve lots behind the new Dollar General and Vera Cruz. He explained until that is done no contractor is interested in building homes. The city has to do this if they wish to grow.

The city received three bids to have a Generac generator system installed in City Hall. This would provide a warming center, or even headquarters in case of a major disaster in the area as the generator would provide the power to keep everything running there. The winning bid was from Gyer Power Systems for \$15,326.75. It is completely turn-key with a good warranty.

With no further business to discuss, the meeting was adjourned.

LAKEVIEW HEIGHTS FIRE DEPT NEWS

The Volunteer Fire fighters of LVHFD were called out Sunday, April 13 to Eagle Bay Development to fight a cover fire. Despite the recent rains the terrain is still vulnerable to fire, especially in windy conditions.

The Department wants to thank the residents of the Lakeview Heights Fire District for their overwhelming support on April 8th in passing the tax levy to provide the equipment for the volunteers keeping the community safe. Equipment such as turnout gear, breathing equipment and assuring there are reliable fire trucks to cover whatever emergency they are called to.

The Lakeview Heights Fire Department was founded in 1973. It was a “membership” protection plan in its early days and covered a six-mile radius of Lakeview Heights. It was formed by Thomas Slaughter, Ben Ferguson and W.T. Brinkley. It prospered and grew offering membership protection. The community raised funds and built a concrete block firehouse in Lakeview. Businessmen from Lincoln and Cole Camp helped as well as individual contributors. The new fire house held two trucks secured from the Forestry Division of the Missouri Conservation Department.

Over the years things evolved and now the main firehouse location is at W and B highways with Firehouse # 2 on Sagrada Beach Road. The original location, which had been known as Station # 1, has been sold.

In what could (or should) be the toughest stretch of their 2025 schedule, the Ladycats softball team ripped off wins over #9 Lone Jack last Tuesday and then, as part of the Mount Vernon Tournament on Friday and Saturday, notched wins over then #1 Diamond, #5 East Newton, #8 Houston and #2 Mount Vernon. Sandwiched in between ranked opponents was a shellacking of Versailles at home on Thursday night. The wins propelled Warsaw to a record of 10-1, with their lone loss coming to Bentonville (AR) at the Ozarks Softball Classic. Bentonville currently sits at #24 in the entire country in the latest rankings released by *The Sporting News*.

Last Tuesday, Warsaw took a 3-1 lead over #9 Lone Jack into the fifth inning when they rallied for 4 runs to extend their lead to 7-1.

After drawing three straight walks to start the inning, Brylee Brewster forced in 1 run after being hit by a pitch. With 2 outs, Haylee Cobb scored on a passed ball and Brewster scored on a wild pitch before Elizabeth Winters scored Emmersyn Miskell on a RBI single to right field.

That cushion was more than enough for Brewster, who took over from there. The senior lefty K'd 6 of the last 9 outs with no real threat in between.

Warsaw added 2 more runs in the top of the sixth for the 9-1 final.

Adison Sherrill, Winters and Maylee Slavens all tallied 2 hits for the Ladycats.

Brewster struck out a total of 14 to get the win in the circle.

On Thursday, Brewster made quick work of the Versailles Lady Tigers by tossing her second no-hitter of the year in a 15-0 rout of their OHC visitors.

Warsaw scored 1 in the first and then whipped up 5 and 6 runs in each of the second and third innings before capping their scoring in the fourth with 3 more runs to mercy rule their guests, 15-0.

Brewster went all 4 innings and struck out 12. Besides allowing 0 hits in the contest, she also surrendered 0 free passes.

Cobb paced the Ladycats offense with 3 hits, including her first homerun of the season, while 2 each were added by Sherrill, Sara Miller and Brewster.

At the Mount Vernon Tournament that started on Friday, the task was tall for the Ladycats as they faced the defending state champion and undefeated #1 ranked team in the Diamond Wildcats, but Warsaw got on the board with 2 runs in the top of the first and never looked back in an 11-0 shutout win behind another no-hit performance by Brewster.

After jumping out to a 2-0 lead in the first, Brewster fanned the first 6 batters she faced. The Ladycats tallied 2 more runs in the third on a triple by Miskell and 1 more when she scored on a sacrifice by Mady Reimund to extend the Warsaw lead to 5-0.

One more run in the fourth made it 6-0 and then 2 in the fifth and 3 more in the seventh made it all Warsaw in an 11-0 upset as they handed Diamond just their second loss in two seasons.

Brewster finished with 15 strikeouts and walked just 1 in another dazzling outing.

Cobb had 3 hits for Warsaw while 2 each were contributed by Miller, Brewster, Miskell and Winters. One of Miskell's was a 2-run homerun, the first of her career for the Ladycats.

Against #5 East Newton, Brewster was dominant in the circle as she rung up 18 strikeouts to lead Warsaw to a 5-0 win over the Lady Patriots.

Brewster gave up 0 runs on just 2 hits over seven innings and walked none.

With the game scoreless, Warsaw jumped on top in the fourth inning on a Winters single. Sherrill reached on an error that scored a run, Miller scored another run with a sacrifice bunt and then Brewster aided her own cause with a 2-run triple to claim a 5-0 lead. The Ladycats hung on from there with that score also being the final.

Brewster went 2 for 4 in the win while 1 hit each came from Warsaw's 7-8-9 batters; Winters, Slavens and Braylee Cunningham.

On Saturday, the Ladycats started a little slow, but rallied to win big over #8 Houston, 12-4.

A sacrifice fly by Cobb put Warsaw on the board in

the bottom of the first, 1-0. A single by Sherrill in the second also drove in a run for a 2-0 Warsaw lead.

The Ladycats added more in the third after Winters singled and Slavens hit a sacrifice fly that both scored runs to make it 4-0.

After scoring 3 in the fourth, Warsaw exploded for 5 runs in the sixth to extend their lead on a RBI groundout by Winters, a Slavens double that scored 2, a Reimund triple that scored one and another run scored on a ball hit by Sherrill and misplayed by the Tigers defense.

Brewster was a perfect 4 for 4 at the plate while 2 hits apiece were added by Sherrill, Cobb and Reimund.

Bri Fellers led things off in the circle for Warsaw. She surrendered 4 runs on 4 hits over 4.2 innings. She struck out 6 and walked just 1 to get the win. Brewster threw the final 2.1 innings and struck out 7.

Against the #2 ranked Mountaineers of Mount Vernon in their tournament finale on Saturday, Warsaw got another prime-time performance from Brewster as she rung up 14 strikeouts in the Ladycats 2-0 win.

She allowed just 1 hit over 7 innings and gave up 0 walks.

In what ended up being a defensive battle, Warsaw got on the board in the first inning on a fielder's choice by Brewster that scored Miller to put the Ladycats in front 1-0.

The only other run scored in the game came in the top of the fifth after Sherrill drew a walk after seeing 6 pitches and then later scored on a single by Cobb. With the ball miscued by the Mountaineer's center fielder, Cobb rounded third but was punched out at the plate on a more-than-close (and one could say "controversial") call. Nevertheless, the Ladycats pushed ahead 2-0 and that would be the final.

Winters led Warsaw with 2 hits in three trips to the plate. Cobb tallied 1 for the Ladycats.

With many starters getting some much deserved rest, Warsaw still destroyed Lakeland on Monday, 18-3.

Bri Fellers got the win in the circle for the Ladycats.

Braylee Cunningham led the team with 3 hits.

Warsaw (11-1) will be back at home on Thursday to welcome Crest Ridge to town.

The Ghost Chicken

Humans are an odd bunch, we love scary stories and some of us will pay hard earned money to be frightened out of our wits. The popularity of haunted hay rides and house tours proves that fact. And we all love a good ghost story.

Why does the subject of life after death create so much curiosity? Does the loss of a loved one create that in us or is it the nagging question of what will happen to us after death? Then there are those that ask: “Why should humans be the only ones entitled to an afterlife, what about the animals?

Aside from the common Christian beliefs of the soul going to either heaven or hell there is the persuasion of reincarnation and transmigration. The consensus concerns the passing of the soul at death into a new body or a new form of being. In Hinduism, the state of the soul being reborn is determined by good or bad deeds. 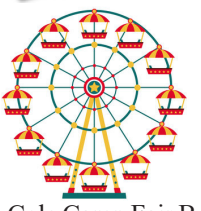

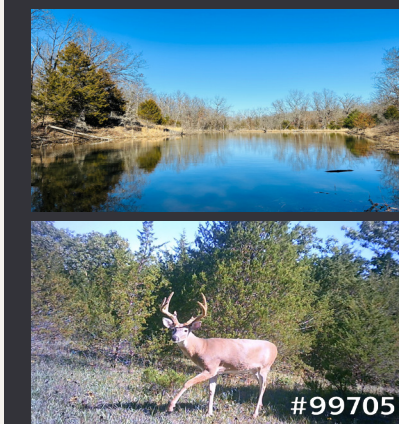

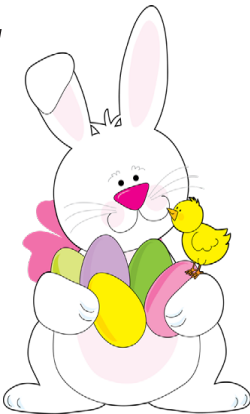

Good Morning from Warsaw Church of the Nazarene. Most of you will be reading this article the week after Palm Sunday’s service. Did you wave the palm branches in service? Did you hear a sermon on the Triumphant entry of Christ into Jerusalem? All I can say is “What a crowd” but stop just for a moment and analyze who may have been in that crowd. People from the local region were there with the growing number of travelers from the outreaches of the Israel and parts of the Roman kingdom. When you read about this event in one of the Gospels, what do you see?

The crowd watched Jesus make his grand entrance is no difference than your gathering of people on Palm Sunday’s service. Most attend because they are believers, some attend just to appease a close friend or relative, and others attend just in case something amazing happens. Children feed off the excitement of the crowd in participation of the family gathering that will follow. Foreigners, family, friends, and faith all colliding in one of the most impactful events in human history! They were there to discover their identity—both Jews and gentiles. However, we must ask, what did they identify with? Was it a god, a man, the crowd, or tradition?

Identity? Pharisees and Sadducees milling among the people claiming to know what is best for all those in attendance. Funny, the best thing for the people was on a colt in front of the entire world to see and they did not have a clue. Why? Their hearts were not ready for a Jesus encounter. They believed they had it all figured out because of their education.

How many people in your Palm Sunday’s worship identified with Jesus? How many were like those people in the crowd just going with the flow, hoping they stumble onto something wonderful, and life changing? Again, I ask. How do you identify with Jesus? Consider the scripture, Matthew 21:6-9, for your answer: “The disciples went and did just as Jesus had instructed them, 7 and brought the donkey and the colt, and laid their cloaks on them; and He sat on the cloaks. 8 Most of the crowd spread their cloaks on the road, and others were cutting branches from the trees and spreading them on the road. 9 Now the crowds going ahead of Him, and those who followed, were shouting...”

Are you one of the obedient disciples identifying with “...Jesus Christ our Lord, 5 through whom we have received grace and apostleship to bring about the obedience of faith among all the Gentiles on behalf of His name, 6 among whom you also are the called of Jesus Christ” (Romans 1:4-6). Or, are you one of the people in the crowd? There for the entertainment created by the event of a king entering the city—just going with the flow of the

current culture because it is easier than seeking a high standard of living.

Wait, there were others in the growing throngs of people watching to see what this new king would do. Matthew 21: 15-16 reveals: “But when the chief priests and the scribes saw the wonderful things that He had done, and the children who were shouting in the temple area, “ Hosanna to the Son of David,” they became indignant...” Are you an indignant priest or a scribe because of the ‘wonderful things’ Jesus is doing? Or, are you a child shouting praise to Hosanna, who has been set free from sin and free to receive the perfect love of Jesus. Is there a better day than today to receive this freedom provided by the grace of our Savior so many years ago? 
