Young actors enliven a classic play

"OKLAHOMA!" is one of the most recognizable and celebrated musicals of all time and the Murray County Theatre Department rendered a lively version of it for local audiences during three shows on Friday, Saturday, and Sunday.

Riley Morrison and Sarah Ridley played the lead roles of Curly and Laurey, a couple falling in love as a new future of statehood awaited for Oklahomans at the dawn of the Twentieth Century. The musical was the first collaboration of the famed duo of Rodgers and Hammerstein. It features rival factions of cowboys and farmers making their way in a changing world. Though largely satirical, the musical offers perspective on life in what had been Indian Territory.

Musicals are difficult, but the Murray cast shined in their final performance of the year.

"They're getting tired but keeping the energy up as best as possible," said Murray drama teacher Keith Rollins. "I'm proud of them. They have worked really hard. This is an old musical and it's not exactly for 21st century viewers in the sense that they can get bogged down because there's a lot of stuff that needs to be tightened up. They have done a great job in making it interesting the entire time."

Auditions began at Christmas and rehearsals got underway in January.

"That's typical for a school musical," Rollins said. "We tried to keep weekends out, but we had a lot of after school rehearsals and we got to do a couple of matinees for the middle school so that was nice."

The cast and crew were made up of students from the drama classes and those who were members of the International Thespian Society, though the two are not necessarily one

Mayelli Diaz Meza and graphic artist and banjo player extraordinaire, Jim Pankey have volunteered to judge the exhibit. Prizes will include 1st Place - \$50; 2nd Place - \$30; 3rd Place - \$20; and three Judge's Choice Awards at \$15 each. These awards will be presented on Sat., April 9 at 3 p.m.

"Murray Arts Council is so happy to be presenting another Student Art Show," said Julie Sane, MAC Vice President and Art Committee co-chair. "Visitors are always so stunned at how much talent is represented, and it is always such a varied and fun show."

North Murray art teacher, Kristi Sitton, and Murray County High art teacher, Ashli Sollinger, worked with the MAC Art Committee to organize the show. Some of their students, Alex Lynch from Murray High and Rebecca Hines from NMHS, were recently



Grant covers tuition in high demand fields

Students who wish to pursue one of Georgia's high demand careers may be eligible for a grant to pay 100% of tuition costs for select in-demand technical certificate and diploma programs at Georgia Northwestern Technical College (GNTC).

HOPE Career Grant programs of study fall in the aviation, business, health, public service and industrial categories.

Criminal Justice and Basic Law Enforcement will soon be added to the list of high demand careers eligible for the grant.

To be eligible for the HOPE Career Grant, students must first qualify for and be receiving the HOPE Grant. The two grants together will cover tuition.

Eight hundred thirty-nine students have taken advantage of the grant program in spring 2022, and 1,334 have done so this academic year, Phillips said.

In the previous three years, 4,718 students utilized the program to cover their tuition costs: 1,789 students in academic year 2021; 1,665 students in academic year 2020; and 1,264 students in academic year 2019.

Students must meet HOPE Career Grant eligibility requirements and pay the remaining costs of college fees, books and materials each semester.



The king of the box scores

As of this week, The New York Times no longer publishes sports agate.

Agate, often generically labeled "the box scores," is the portion of the newspaper sports section containing the statistical minutiae of sporting events. How many yards receiving did Ladd McConkey have? Who pitched middle relief for the Braves? What line produced the winning goal?

The baseball box score is the Cadillac of sports agate. A seasoned baseball agate reader can pretty much tell you what happened in a game played 10 years ago with one quick, close look at the box score. Mastering agate was akin to learning a new language or working as a code breaker.

Agate was once the cornerstone of a great sports section. Every good sports staff had someone assigned to "do the agate." But all those combinations of numbers could be quite cranky when you tried to organize them for the printed page. One problem was the length of people's names. Ideally, every athlete would have a name like Mel Ott -- easy to fit in a narrow newspaper column. But for every Mel Ott, there was also a column-buster like Giannis Antetokounmpo, which would throw off your nice neat rows of numbers.

Sports agate for sure took extra work, but it was a crucial part of the sports section -- at least it was until the Internet came along and made box scores and other results available within minutes

of the competition ending.

Today, instead of grabbing a sports page early in the morning and scouring the box scores, most fans go to bed knowing what they want to know.

Logically, these advances in technology have made things better for fans -- yet --- have they?

I check the box scores about every night during baseball season and appreciate the speed and convenience that technology provides. But I do miss setting aside a portion of my days to wander through that numeric dumping ground in search of sports greatness.

And now to the greater point, part of the reason I am so respectful of "the agate age" is that it was pounded into my head by my first boss in the newspaper industry, Doug Hawley.

Doug was the sports editor of The Daily Citizen in 1986 when I came to Dalton. I was hired by managing editor Louise Hackney but worked directly for Doug.

Doug was an eccentric fellow. He was a trained public speaker but actually rather shy. He was a single man in his mid 40s and I think he was terrified that people would think he was gay; that led him to making the occasional unnecessary, unacceptable but often hilarious comment.

For many years I denigrated

Doug's abilities as a sports editor.

Truth be told, he had an out-of-date writing style and page design skills best suited for 1957. Doug knew a lot of verbs, but when it came to writing headlines, he only used about three of them. He'd utilize some variation of spark -- spark, sparks, sparked, sparkling, sparkler -- every single day. Drove me nuts.

Doug loved agate. That same 1950s mentality that stamped his writing and layout, also demanded a healthy agate section ... including our local games.

I would be pounding the keyboard like a madman trying to finish a football game story on Friday night deadline and Doug would inevitably sing out -- "Don't forget the agate."


As much as I loved reading agate, doing all the work to get it in a story on deadline was maddening. But Doug demanded it. That's why today if you dug up a game story from that era, you can find out how many yards the Murray County backup fullback had in a game against Dalton.

In the last few years I have come to much more deeply appreciate Doug's editorship of The Daily Citizen. His flaws were real, as I knew back then, but what stands out to me today -- 30-plus years later -- are the things Doug did well.

He knew every coach in the community and had phone numbers for about all of them.

He got out to all kinds of games

It was right out of a Jerry Springer show. Come to think of it, the past few years in America have been Springer-ized. Everybody is screaming, cursing, and acting out. From the executive branch, to the legislative, and now even the wife of a Supreme Court justice, so I suppose the circle is complete.

will begin work on the projects this summer.

"They will probably start with the softball field and hopefully they will be done by the time softball begins in the spring," Loughridge said.

AND MORE LIGHTS

The board OK'd paying the City of Chatsworth \$39,000 to help pay the cost of additional lighting at the crosswalks near Chatsworth High School. Earlier this year a student was struck while crossing the road to get the school campus.

The new lighting will add about \$282 a month in energy costs, according to Georgia Power estimates.

NEW FURNITURE

Board members voted 5-0 to approve spending more than \$834,000 on new furniture (desks, chairs, lockers, etc.) for Northwest Elementary (\$328,000) and Gladden Middle (\$506,000).

Gladden underwent major renovations before the 2021 school year. Northwest Elementary suffered heavy damage inside the school facilities after being struck by a tornado in 2020.

Last week Loughridge told board members that initial cost estimates for replacing the furniture at the two schools came in at more than \$1.3 million. Central office officials then met with the two principals, Daphne Winkler and Roger Rainey, to pare costs.

"They cut the items that didn't impact teaching in the classroom," Loughridge said.

The vendor is Virco, a California-based supplier of school equipment and furniture.

LET THERE BE LIGHT

The board unanimously OK'd spending approximately \$345,700 on new lights for the softball field at Murray County High School and the tennis courts at North Murray High School.

Loughridge said the wooden poles have been damaged over the years by woodpeckers.

Doug had an understanding with every coach in the area -- get us the information and we'll get it in the newspaper. That determination to do incredibly thorough coverage would get Doug in trouble. More than once I saw Doug take a chewing out from an irate publisher because he held the sports section a little too long trying to get one last story on the page.

Under Doug's leadership the sports pages we produced were flawed; but they were also the best thing about

The Daily-Citizen at that time. We did a lot of good.

Doug and I didn't always get along when I worked for him but I was happy that when I came back to Dalton in 2000 as managing editor that Doug worked for us as a stringer. He and I had some good conversations.

Yet I never told him how much I appreciated what I learned from him.

Doug died recently at age 82. I'll always regret not seeking him out for one last talk, most of which would have consisted of apologies for my youthful bull-headedness.

Doug was a kind soul and a good man and I am proud to say he was my boss.

Doug Hawley sparkled.

in cattle. Any cattle that survive the parasite would then be carriers for life. Infected dairy cattle will also experience a decrease in milk production. Often stress episodes such as calving and weaning could worsen the appearance of signs in cattle.

Prevention is key through both integrated pest management and visual inspection of your animals. If you see significant scratching and irritated skin or large infestations of ticks on your animals, take immediate action. Permethrin is an effective repellent against the Asian long-horned tick. Also keep pastures and other grazing areas short; clear wooded areas when possible, especially around pastures, barns & lots to reduce tick habitat.

The Asian longhorned tick is light brown and less than 5 mm in size when unfed. Once a female has fed, she'd be about the sizes of a pea; nymphs (immature ticks) are about the size of a poppy seed. This particular tick can actually reproduce sexually and asexually. What does this mean? A single female can produce fertilized eggs and offspring without mating with a male. It only takes one female to establish a population! They prefer to live in tall grass and weeds but will attach to livestock, wildlife, pets and humans.

Why are we worried about it? Since a single female can lay up to 2,000 eggs in a 2-3 week period after a blood meal, there is the potential of hundreds of ticks attaching to a single animal.

Extreme blood loss (anemia) in an animal will result in an unthrifty appearance, decreased milk production, and possibly death.


In addition, these ticks can carry a parasite that infects red and white blood cells in cattle. The parasite itself also causes anemia by destroying red blood cells, leading to weakness, lethargy, jaundice and abortions.

However, it may run in families.

I disagree with nortriptyline in most people. Not only is it not a good treatment for anxiety, it may have excess sweating as a side effect, but the very low dose makes that unlikely. Doses for depression are often 300 mg.

Lack of sweating concerns reader

DEAR DR. ROACH: I have had excessive sweating for the past few years. I don't mean underarms; I mean head and face. In warmer weather, my hair will be soaking wet in no time. My doctor thinks it's related to the anxiety syndrome I have had since

I was a small child, and prescribed nortriptyline 10 mg once daily. When I looked it up, I thought it might be a little dangerous for me. I am 79 years old.

I am very healthy otherwise. I hope you can help. It's a horrible problem, and it ruins my summers. -- J.H.

ANSWER: We use the Greek terminology to define this problem: primary focal hyperhidrosis, specifically craniofacial hyperhidrosis. "Primary" because it isn't associated with any other known problem; "focal" because it is in one area; "craniofacial" meaning "head and face"; and "hyperhidrosis" just means "too much sweat." The underlying cause is unknown, but your doctor might be right that anxiety is playing a role.





Murray is at LFO on Thursday and North Murray hosts Coahulla Thursday. Both are region contests. The regular season ends week after next for both teams.



Murray County catcher Landon Bennett applies a tag to North Murray's leaping Logan Malchesky in a game eventually won by the Indians.






"In my classroom it doesn't function well





Lawmakers OK tax cut

ATLANTA - Georgia lawmakers approved a tax cut Monday night during the final hour of this year's General Assembly session.

After the state House of Representatives voted 167-2 to support a compromise version of the legislation reached by a joint conference committee, the state Senate followed by a margin of 41-13.

The bill includes a phased-in rollback of Georgia's income tax rate from 5.49% to 4.99% over six years, starting with the 2024 tax year. The current tax rate is 5.75%.

Democrats had blasted the original version of the bill proposed by the legislature's Republican majority, which would have dropped the tax rate to a flat 5.25% immediately upon taking effect, arguing some Georgians actually would end up paying higher state taxes.

"We haven't been able to find anyone who pays more," House Ways and Means Committee Chairman Shaw Blackmon, R-Bonaire, said of the compromise bill. "Everybody pays

zero [more in taxes] or less under this plan."

The bill also includes a trigger mechanism to make sure tax cuts don't continue if the economy falters. Taxes would not be reduced in any year where state revenues don't grow by at least 3% or the year's net revenue collections are not higher than those of each of the previous five fiscal years.

"If the triggers aren't met, it will pause a year," said Senate Finance Committee Chairman Chuck Hufstetler, R-Rome.

The legislation also increases taxpayers' personal exemptions. Single filers will get an exemption of \$12,000. Exemptions for married couples filing jointly will increase every two years, from \$18,500 in 2024 to \$24,000 in 2030.

Hufstetler said the tax cut will cost the state \$455 million during its first year and \$1 billion during the second year.

Danny Kanso, senior tax analyst with the Georgia Budget and Policy Institute, said it will end up costing more than either version of the bill the House and Senate passed earlier in the session.

Budget includes pay raises

ATLANTA - The General Assembly gave final passage Monday night to a \$30.2 billion state budget that provides pay raises to state employees and Georgia teachers.

During the final hour of this year's legislative session, the Georgia House of Representative passed the fiscal 2023 spending plan 160-5. The state Senate had passed the budget unanimously earlier in the day.

The budget, which takes effect July 1, will increase salaries for most state employees by \$5,000 and gives state retirees their first cost-of-living adjustment in 14 years. Targeted raises will go to correctional officers in the adult and juveniles prison systems to try to stem huge turnover rates.

Teachers, who saw a \$3,000 raise in 2019, will get another \$2,000, fulfilling a pledge Gov. Brian Kemp made on the campaign trail four years ago to raise teacher pay by \$5,000.

With state coffers flush with robust tax revenues coming out of the pandemic, the budget increases spending by 10.8% over the budget the General Assembly adopted last spring. It includes an \$11.8 billion investment in K-12 education, the largest in the state's history.

The spending plan also eliminates the institutional fees the University System of Georgia began charging students during the Great Recession and increases Medicaid coverage for low-income mothers in Georgia to a full year following the birth of their children, up from the current six months.
