Open burning season runs from January 15 to May 1, and residents must obtain a permit from the fire department before engaging in this activity.

anchester Essex football coach Joe Grimes was pleased with almost everything about his team's Thanksgiving Day game against Essex North Shore Agricultural and Technical: The Hornets pulled out a 22-14 win in their final contest of 2024. The seniors on his team ended their high school football careers on a high note and Manchester Essex broke a three-game losing streak.

Add in the fact that the game itself recreated a rivalry that extends back more than 100 years, a prospect that both schools were excited to revive, and this was a Thanksgiving that was almost perfect for Grimes and his team. There was one thing that the coach would change in future years, but it's one that's pretty much out of anyone's hands at any level.

"Overall, I think it was a great success," explains Grimes. "If I could change one thing for next year in Manchester it would be: 50 degrees and sunny."

The coach was obviously referencing the windy, rainy weather that afflicted both teams and their fans on November 28. While the weather may not have been optimal, the Hornets didn't let it rain on their parade, overcoming some turnovers and jumping out to a 14-0 lead before halftime and staving off a comeback attempt by the 2-8 Hawks in the fourth quarter.

"We were able to weather the storm, both literally and figuratively," says Grimes. "It was raining most of the game, but Essex Tech also came out fast and tough on defense and took away the ball three times (two interceptions and a fumble). Those guys are well-coached and were fired up in their throwbacks and played a lot tougher than their record. They seemed ready to go for the new tradition and will be

ready for next Thanksgiving, I'm sure."

The win was a big one for the Hornets after Manchester Essex suffered a string of three close losses from the end of the regular season into the postseason. The victory helped to ensure that the Hornets would finish 2024 with a winning record (6-5 overall) and that the team's seniors would finish their high school football careers on a high note.

"You don't want to end your high school career on a sour note especially when it's been four years on the squad," explains Grimes. "A lot of growth happens in those years and it's really nice to see it end with a 'W.'"

Those seniors were instrumental in helping Manchester Essex get that "W." Senior tight end Jarrett Croft threw a touchdown pass to twin brother Carson for the first score of the game during the

Lorraine Auwaerter fortunately, at the Olympic Bullock



August 30, 1930 -November 27, 2024 Lorraine Auwaerter Bullock, 94, beloved wife of Anthony N. Bullock III died, Wednesday, November 27th, 2024 at home surrounded by her family. Born in Philadelphia, PA, she was the daughter of Mary (Niznik) and Jacob F. Auwaerter.

She graduated from Philadelphia High School for Girls at top of her class, where she also excelled at gymnastics. She went on to graduate from West Chester Teacher's College (West Chester University) in 1952 with a major in Health and Physical Education. From 1948-1952 she was a member of the Philadelphia Turnverein Gymnastic Club where she won many titles and was the leading candidate for the US Olympic team. UnTrials she learned she was disqualified because she was considered a professional for being a Tumbling and Dance Instructor at Camp Canadensis for two summers. She continued her education with postgraduate studies at Temple University.

While at West Chester she met the love of her life, Anthony. The two were married January 10th, 1953. Their courtship blossomed into a marriage of 71 years with six children and moves from Cheyney, PA, to Philadelphia, PA, Fairfield, CT, Newburgh, NY, Dallas, TX, Lakewood, OH, Marblehead, MA, and finally settling in Manchester-by-the-Sea in 1968. With every move she immersed herself in the local community. While raising her children, she taught, she coached, she refereed, she volunteered and served on many civic boards, there was no "idol time" in Lorraine's life.

In 1975, she revived her teaching and coaching career in the Beverly School system. A dream opportunity became true when she was named head coach for the Varsity Girls Gymnastic team. In her second year at the helm, she helped lead the team from last to first place winning the Northeastern Conference Gymnastic

Unfortunately, due Title. to budget cuts in the school system, forced upon it, by the City of Beverly and a national recession, many teaching and coaching positions were eliminated, hers included.

The following year she joined the staff at Manchester Jr./Sr. High School. She became known as the "Super-Sub" (the students knew that when Mrs. "B" was the sub it was an actual class of learning). Her focus evolved into the Special Needs Education Program. The following are reflections from fellow teachers: "She was an island of calm and composure in our ocean of student chaos!"; "We were always astounded by her strength and fortitude. A wonderful role model for us all."; "She was considered a kind and caring teacher who always had a pleasant smile and caring tone."; "I have such fond memories of your mom being in my biology classroom, helping kids and taking notes for them. The kids would cluster around her. She could be counted on to remember exactly where we "ended up" last class and kept me on track!"; "Lorraine was truly respected and appreciated by her students and peers."

Lorraine was a talented seamstress making her own clothes, from dress suits to ball gowns. Making Halloween costumes for her children and grandchildren and with five daughters, was also the go-to-person for prom and bridal party dresses. Lorraine was active in many community associations and

clubs; Manchester Women's Club, PTA, Sacred Heart Church, Girl Scouts, Meals on Wheels and many more. She also was a force on the tennis court well into her seventies. And you could always find Lorraine with her beloved Tony watching school and sporting events of their children, grandchildren, and great grandchildren. She continued to be the Hornet's #1 fan even when her immediately family wasn't on the

Senior Citizen Lock Box **Program Launched**

he Essex and Manchester Fire Departments are pleased to announce the launch of a residential lockbox program. This initiative aims to provide firefighters with quicker access to seniors and disabled residents during emergencies when they may be unable to reach the door. By utilizing these lockboxes, we can minimize property damage that may occur if responders need to force open doors. More critically, this program saves valuable time in emergency situations by allowing swift access to individuals who may be incapacitated within their homes.

What is a lockbox? Α lockbox is a compact, secure metal container that is installed on or near a resident's door and holds a key to the home. This box is secured with a unique key that only authorized fire department personnel possess. The lockboxes are designed to be safe and durable and will only be accessed in emergencies; at no time will they be available to anyone other than emergency responders.

New Town Administrator Search Begins

ith my retirement coming up next summer, efforts to hire a new Town Administrator are getting underway. It will be 12 years since I came to Manchester, and the time has come for me to hand the position to someone new. I admit I am both excited and panicked about the prospect of retiring after working a 40+ hour a week job for over 40 years.

The Select Board is responsible for hiring Manchester's Town Administrator. The Board has contracted Community Paradigm Associates to help with the recruitment process. Paradigm is a leading recruitment firm working for Massachusetts communities to fill key leadership positions.

In this early stage, Paradigm staff are meeting with Select Board members and department leaders to gain insights into what qualities are needed in a new administrator. A profile of the position, the Town and its challenges will be crafted to be used as part of the recruitment process. Interested candidates will be sought in earnest during the month of Ianuary.

A Preliminary Screening Committee will be formed to conduct the initial screening of candidates. The committee, to be appointed by the Select Board, will consist of

the chairpersons of the Finance Committee, the Planning Board and the School Committee, two former Select Board members and two citizens at large. Former Select Board members and residents interested in serving should submit letters of interest to the Select Board's Office over the next couple of weeks.

The initial phase of candidate screening is done confidentially by the screening committee. This maximizes the number of potential candidates by allowing candidates to step forward to see if Manchester is a good fit for them and vice-versa while still comfortably maintaining their current position. The consultants will assist the screening committee in narrowing the list of candidates to three finalists. Once the finalists are identified, the Select Board will conduct public interviews and make a final decision. This is a similar process that was used in my hiring.

The screening committee will be active mostly during February and into March. Final interviews by the Select Board are likely to take place in March or April. The goal is to have a new Town Administrator under contract come May with a probable start date later in the summer as it often takes a few months before a new person can start. A review of operations and our structure also is taking place over the next few months. The Select Board chose Capital Strategic Solutions, a municipal consulting firm, to conduct an operations audit to see what improvements might be possible in the delivery of town services and in the organizational structure we have. As part of this review, the consultants will be looking at the use of technology to see if there are new tools that could improve services and efficiencies.

In addition to hearing from department leaders and the Select Board, the consultants would be interested in hearing from residents as well. Feel free to send to the Select Board Office suggestions for service improvements and insights you might have regarding how the Town can operate more efficiently and we will be sure to pass along your thoughts.

This grant-funded effort should identify changes that we can make both in the short-term (through the upcoming FY26 budget process) as well as longer-term by providing an assessment of current operations and a solid roadmap for a new Town Administrator to follow. I am not done yet! I will continue to work to serve the Town's best interests as we prepare for several transitions that are coming during the new year.



Forty acres of quarried and stripped land will be restored and developed in an environmentally sensitive manner by Cell Signaling Technology, thanks to several years of hard work and thoughtful consideration by the Town's Planning Board, Zoning Board, Conservation Commission, Finance Committee, Department of Public Works, Town Administrator and numerous other Town employees and representatives. The project will yield years of positive returns for Cell Signaling and the Town. I am proud to have been part of the Cell Signaling team and most appreciative of the fair hearing we have received. It should also be acknowledged that throughout the process, the thorough coverage of the Cell Signaling project by The Cricket was invaluable in keeping the Manchester community involved and supportive of our efforts. "We were able to jump out to a lead early and a couple stalled drives hurt

their momentum early," explains Grimes. "They battled back in the 4th and I'm



proud of my guys to keep their focus and finish the game. Hard-fought, physical game all morning and really what you love to see on Thanksgiving."

Both schools seem to be keen on seeing this kind of performance between the two football teams on Thanksgiving in the future. The Hornets had traditionally played Georgetown on Thanksgiving since the 1990's, but had to scramble to find a replacement in 2023 when the Royals didn't have the numbers to field a varsity squad. North Middlesex was a lastminute add to give the Hornets a game on Thanksgiving Day, but too much distance and too little history existed between both schools to continue that as a new tradition.

The opportunity to pit Essex Tech and Manchester Essex football against one another was far more appealing after the schools returned to the Cape Ann League recently and were in need of a rival located nearby. Both schools have a history that goes back to at least 1918 when Essex Agricultural School and Story High School (the previous monikers for the now regional schools) - giving the matchup some precedence as well.

"I hope this is the start of a long, long rivalry," says Grimes. "We've got tons of respect for Coach Connors and the whole Essex Tech Athletics organization starting with TJ and Tara who help us set up the successful pre-game breakfast."

Should the matchup repeat itself, many of the same Hornet players will be back to compete in it for a second year in a row. Manchester Essex will lose only five seniors as Magee, the Croft brothers, Satchel Rubin and standout lineman Cian Brennock will graduate in the spring.

"We're only losing five to graduation this year." They are a bunch of great kids. Cian Brennock (Sr. OL/DL) was a four-year varsity player and a three-year starter on both lines. His leadership as a captain has been wonderful and he's made an impact that will be felt for years to come."

The seniors and the returning underclassmen will have a lot to remember and learn

from now that 2024 is in the books.

"We had some great wins and some tough losses, but we had a very resilient group that always stuck together," says Grimes. "They were very calm and focused in the meeting room, weight room and practice field regardless of the situation, week to week."

He adds: "I'll remember the photos on Thanksgiving and the bus rides and the long days and all the help we get to put on a football season.

At the school, in the press box, on the field or at home there are so many people who make it happen. I appreciate all of them. It's a huge effort and I'm so grateful for all of them."



The Town Administrator (TA) has placed the order for the necessary equipment and will work on deployment after it is received.

Next Safety Committee Meeting


The Safety Committee will next meet on December 19, 2024 at 8 a.m. in Town Hall. Chairman Pereen is usually able to attend remotely.

Update on Visit from Crew of USS Essex

The TA learned that the crew visit that the Board is interested in hosting will likely occur in late-April or early-May of 2025. The visit's organizer, Lt. Matthew Coffin, will be in touch with the Board this winter to provide highlights on what is being planned. I have provided Lt. Coffin with contacts for a variety of groups and organizations that the Navy contingent plans to visit while here.

Scope of Services and Contract for Municipal Fuel Depot Design

After the Fall Town Meeting appropriated funding for the design of a municipal fuel depot, the TA contacted four design firms that have experience in this area. One firm's pricing was exorbitantly high, one firm's response required two redrafts after we discovered errors, another firm did not provide a proposal after the TA made initial contact, and the firm of Fuss & O'Neill agreed to provide a detailed scope of services within the available

Annual Request for Operating and Capital Budget Proposals

The Finance Committee will soon request fiscal year 2026 operating and capital budget proposals through the Town Accountant from all departments. Proposals are usually due by January 10, 2025 and the Board will have two meetings for proposal review between now and the submission deadline.

Planning for MPO Public Forum Concerning Essex Causeway

The TA participated in the subject meeting along with Selectman Phippen on November 26, 2024. The Boston Region Metropolitan Planning Organization (MPO) is currently assisting the Town with a preliminary study of possible future solutions for increased flooding of the Essex causeway on Route 133. MPO will host a public forum as part of the study (which was to be held on December 4, 2024. However, MPO needs more time to research the issue and possibly discuss with various stakeholders prior to the forum (which will now be held sometime in January). The insights gained from the MPO study will be very important to include in MassDOT's application for Federal PROTECT funding to evaluate the issue in much more depth (see item K1).


Application for PROTECT Grant to Study Essex Causeway Flooding

As discussed at the last meeting, the Massachusetts Department of Transportation (DOT) is interested in collaborating with both the Town and with the Boston Region Metropolitan Planning Organization (MPO) on a PRO-TECT Grant application for a study of possible future solutions for the expected more frequent flooding of the Essex causeway. This application will follow on the heels of a preliminary study that is being performed by MPO presently, which will begin the formulation of some general recommendations (also see item H2). The Federal PROTECT grant (Promoting Resilient Operations for Transformative, Efficient, and Cost-saving Transportation) will delve into the issue project is to better align future projects with roadway resilience planning by the Massachusetts Department of Transportation (DOT). The TA participated in a webinar on November 21, 2024 offered by the National Oceanic and Atmospheric Administration (NOAA) with respect to best practices for BIL applicants. The webinar covered details concerning the application platform and important information about the application process.

Gloucester Coal Tar Settlement Project Ideas Update

As the Board may recall, Selectman Phippen and the TA have been working on some ideas for environmental restoration projects that could be funded in Essex from the Gloucester Coal Tar Settlement. To that end, we met with Gloucester's Community Development Director and Gloucester's Planning Director on November 25, 2024 to determine if there are project ideas that are possibly of interest to both Essex and Gloucester. City personnel are going to discuss the ideas internally and provide Essex with feedback. However, a number of possible projects initially resonated with them including: shellfish seeding, green crab drying for fertilizer, a thin-layer sediment placement pilot project, and additional alewife habitat restoration with respect to the Alewife Brook and Chebacco Lake. We expect to hear back from Gloucester soon and will approach the submission of project ideas accordingly.

Canine Life Stages



By Lawrence Lamb, DVM

Every dog owner thinks that their dog is special. Guess what? We're all right.

ach dog is special and should be treated as an individual. Not only is your dog special to you, but she is special to your veterinarian as well. Every year improvements are made to the quality of the care provided.

This year, The Manchester Animal Hospital will introduce a test that just became available that has the capacity to detect cancer. A veterinary team considers your dog's life stage, breed, and various lifestyle factors so they can create a healthcare plan customized to meet your dog's unique needs, and the American Animal Hospital Association's Canine

covered in every wellness visit with your veterinarian,

Fact #2: Visiting the veterinarian every 6-12 months is key to your dog's health, regardless of age.

Puppies will visit the veterinarian more often than their adult counterparts, as the veterinary team completes personalized vaccine protocols, prepares them to be spayed or neutered, sets a foundation for appropriate behavior and exercise, and monitors for congenital health problems.

Young adults should receive continuing preventive care, including appropriate protection against fleas, ticks, heartworms, and intestinal parasites. The veterinary team will address any behavior concerns and monitor their growth and development, including setting an appropriate body condition score (BCS) to help you keep your canine pal at a healthy weight so she will be less likely to develop osteoarthritis, breathing problems, and other future health problems exacerbated by increased body weight. Veterinary visits for mature adult dogs will focus on maintaining good health through regular screening and testing, as well as monitoring weight, muscle condition, and mobility. When a dog enters her senior years, the veterinary team will work to identify any issues that may contribute to a decline in her health or quality of life through regular blood work and other health screenings, and they'll recommend adjustments in activity level and nutrition as needed.

Emerging data suggests that pet owners and veterinarians should weigh the risks and benefits of spaying or neutering a dog between five and six months for smallbreed female dogs, before six months for small male dogs, or after growth stops (9 - 15 months) for largebreed male and female dogs.

Fact #4: Your dog's surroundings may need to be altered as she ages.

rambunctious Ensure young dogs don't have access to potentially toxic items (and your favorite pair of shoes) and provide a crate with comfortable bedding and a favorite toy. Use pet gates and other items to keep puppies in the areas of your home where you know they're safe.

Senior dogs may struggle with mobility, so be sure to provide ramps or pet stairs when your dog struggles jumping to his favorite sleeping spots or getting into the car, add carpeting or another form of traction to slick hardwood or tile floors, and put a dog bed on the main floor of your home if your pet struggles to take the stairs to your bedroom.

Fact #6: Behavior problems lead to relinquishment and euthanasia of dogs.

One of the top reasons dogs are relinquished to shelters is behavior problems. Stay in close communication with your veterinarian during all life stages if you notice problem behaviors, like aggression or fear, in your dog.

Fact #7: Dogs should be vaccinated based on lifestyle.

While there are some core vaccines that every dog should receive, like rabies and distemper, others are given based on a dog's lifestyle. Your veterinarian will discuss your dog's risk factors to determine if she should receive noncore vaccines against canine influenza, Bordetella, leptospirosis, or Lyme disease.






