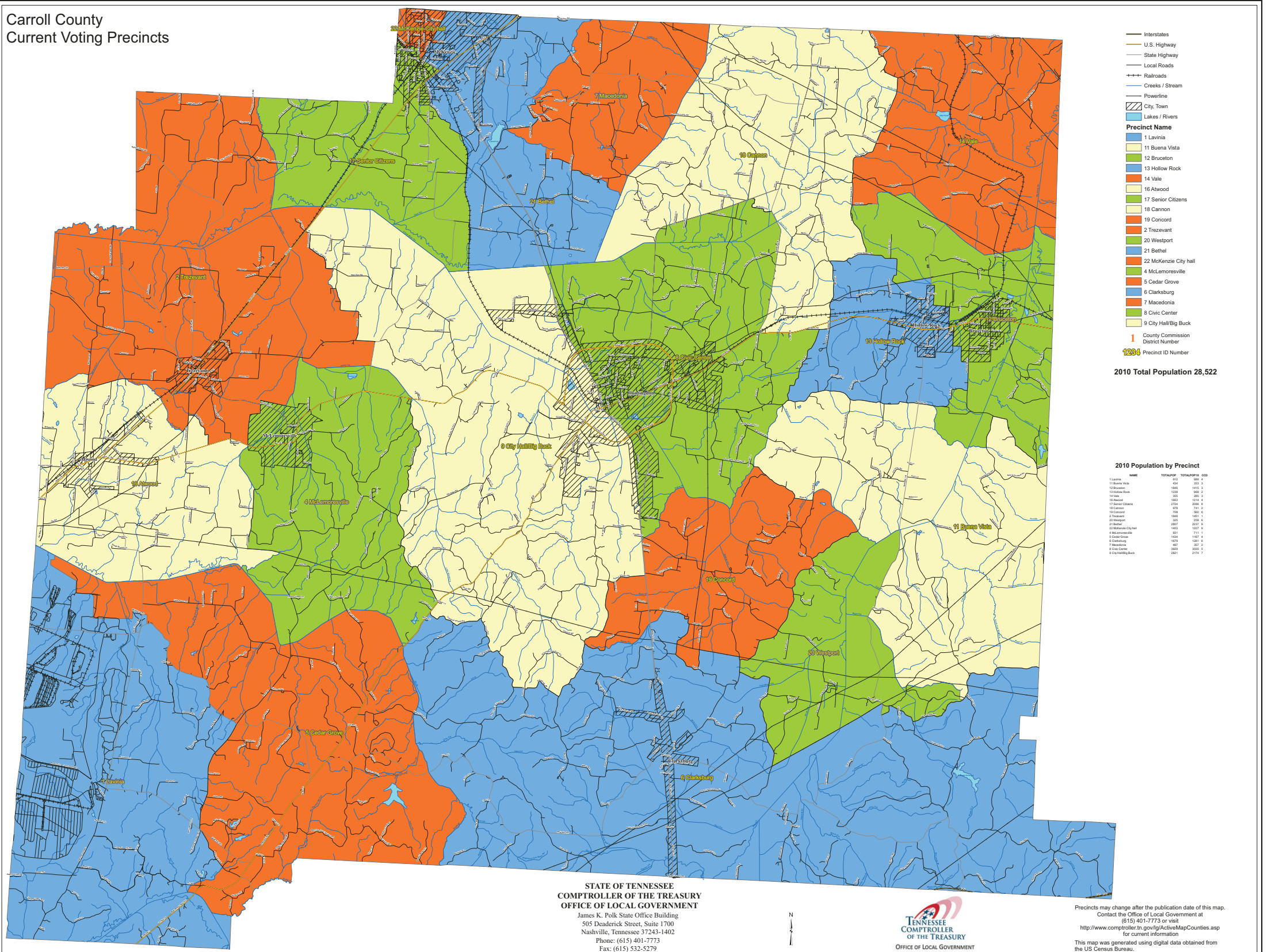

NOTICE OF EARLY VOTING

FEDERAL/STATE PRIMARY, CARROLL COUNTY GENERAL, CARROLL COUNTY SPECIAL SCHOOL DISTRICTS AND THE CITY OF CLARKSBURG ELECTION

The Carroll County Election Commission announces Early Voting Requirements for the **August 2, 2018** Federal/State Primary, Carroll County General, Carroll County Special School Districts, & City of Clarksburg Election. Any properly registered voter may cast a ballot by personal appearance at the Election Commission Office located, 625 High Street, Suite 113, Huntingdon TN, beginning on Friday, July 13, 2018, and ending on Saturday, July 28, 2018.

State law requires voters to have Federal or State gov-

ernment issued photo ID to vote, unless an exception applies. College student IDs will not be accepted. The voters must have photo identification when they present themselves to vote. This includes early voting at the election office and voting on Election Day at your assigned polling place. To learn more about the new law and its exceptions, please call Carroll County Election Commission office or visit www.GoVoteTN.com.

***CHANGE OF ADDRESS DEADLINE:** 4 P.M. July 28, 2018. Pursuant to T.C.A. 2-2-109 (a), the last time to change your address inside your county of registration is the close of business on the 5th day before Election Day. Voters who have moved within Carroll County may change their address at the Early Voting site or by sending a change of address in writing to the Carroll County Election Commission Office, 625 High Street, Suite 113, Huntingdon, TN. **QUESTIONS?** If you have

questions regarding the above procedures or about the election process in general, call the Carroll County Election Office.

Voter Qualifications

- You must be a citizen of the United States, (18) years of age or older on or before the date of the next election.

- You must be a resident of Tennessee.
- Special Considerations for Homeless Persons Residency and Non-resident Property Owners

- You must not have been convicted of a felony, or if you have, your full rights of citizenship must have been restored (or you must have received a pardon).

- In order to participate in an election, a qualified voter must be properly registered no later than thirty (30) days before the election. The election commission office will process any by-mail voter registration form that has been postmarked at least thirty (30) days before the election. T.C.A. 2-2-109.

Need to Know Before You Go

Voter Identification Requirements

All voters must present an ID containing the voter's name and photograph when voting at the polls, whether voting early or on Election Day. This information is provided to ensure that all Tennessee voters have access to information about the new law. If you have further questions, call 1-877-850-4959.

FAQ

When will I need to bring a photo ID? You will need a photo ID to vote at a polling place, whether you vote early or on Election Day.

What if I don't bring a photo ID to the polling place? If you don't bring a photo ID, you will vote a provisional ballot. You will then have two (2) business days after Election Day to return to the election commission office to show a valid photo ID. Upon returning to the election commission office, the voter will sign an affidavit and a copy of the voter's photo ID will be made to be reviewed by the counting board.

What IDs are acceptable? Any of the following IDs may be used, even if expired: Tennessee driver license with your photo, United States Passport, Photo ID issued by the Tennessee Department of Safety and Homeland Security, Photo ID issued by the federal or Tennessee state government, United States Military photo ID, Tennessee handgun carry permit with your photo

What IDs are not acceptable? College student IDs and photo IDs not issued by the federal or Tennessee state government are NOT acceptable. This includes county or city issued photo IDs, such as library cards, and photo IDs issued by other states.

Who is exempt? Voters who vote absentee by mail, Voters who are residents of a licensed nursing home or assisted living center and who vote at the facility, Voters who are hospitalized, Voters with a religious objection to being photographed, Voters who are indigent and unable to obtain a photo ID without paying a fee.

What if I registered by mail and am voting in my first election? Federal law requires first time voters who register by mail to present one of the following: A current photo identification with voter's name and photo OR If the photo identification is expired, the voter must also present one of the following: a copy of a current utility bill, bank statement, government check, paycheck or other government document that shows the voter's name and address.

What if I don't have a photo ID? You may obtain a free photo ID to vote from the Department of Safety and Homeland Security at any participating driver service center across the state. You may use the "express service" line at the driver service center to obtain your photo ID to minimize wait times. Visit the Department of Safety and Homeland Security web site for more information, <http://www.tn.gov/safety/photoids.shtml>.

What if I need to get a free photo ID from the Department of Safety and Homeland Security? You will need: Proof of citizenship (such as a birth certificate), and Two proofs of Tennessee residency (such as a voter registration card, a utility bill, vehicle registration or title, or bank statement). If your name differs from that on your primary ID, proof of the changed name (such as a certified marriage certificate, divorce decree, court order, etc.) Learn more about the required documents at <http://www.tn.gov/safety/photoids.shtml>.

I have a driver license, but it doesn't have a photo. Can I use it to vote? No, but if you do not have another form of valid photo ID, the Department of Safety and Homeland Security will reissue your license with your photo for free upon request.

I can't afford a copy of my birth certificate, so I can't get a photo ID. Can I still vote? Yes. If you cannot afford a copy of the documents required to obtain a free photo ID, you may sign a form stating under oath that you are indigent and have been unable to obtain an acceptable photo ID for voting without paying a fee.

DID YOU KNOW?

Wyoming First State to Elect Female Governor

Wyoming was not only the first state to grant women the right to vote, but it also was the first state to elect a female governor, electing Nellie Tayloe Ross to that post in 1924. Ross was elected after being nominated for governor in a special election following the sudden death of her husband, William Ross, who died from complications of an appendectomy less than two years into his term.

Wyoming granted full voting rights to women in 1869, 21 years before it was even granted statehood. The year 1869 proved to be a groundbreaking year with regard to voting rights, as it was in February of 1869 that Congress proposed an amendment that would ban voting restrictions on the basis of race, color or previous servitude. That amendment would not be ratified for nearly 12 months,

but it would still precede the 19th Amendment, which granted American women the right to vote, by half a century. Among those credited with fighting hard for women's suffrage in the United States are Elizabeth Cady Stanton, Lucretia Mott and Susan B. Anthony, none of whom would ultimately live long enough to see the 19th Amendment passed.

The Second of July, Not the Fourth

While July 4th is synonymous with American independence, one of the United States' founding fathers felt that July 2nd was a more appropriate date to celebrate the colonies' declaration of independence from Great Britain. John Adams, who would serve as the second President of the United States, felt July 2nd was the correct date to celebrate the colonies' independence and even protested July 4th by refusing invitations to appear at events on that day

during his lifetime. Adams' contention dates back to June 7, 1776, when Richard Henry Lee, the Virginia delegate of the Continental Congress, first introduced a motion calling for the colonies to declare their independence. Voting on Lee's motion was postponed, though a five-man committee consisting of Adams, Benjamin Franklin, Thomas Jefferson, Robert R. Livingston, and Roger Sherman was appointed to draft a statement justifying independence

from Great Britain. Lee's motion was approved on July 2nd, and Adams even wrote his wife, Abigail, that the day would be celebrated as the anniversary of the colonies' independence for many years to come. But that was not to be, as American independence is instead celebrated on July 4th, the day when the Continental Congress formally adopted the Declaration of Independence.

Research Candidates, Upcoming Elections

Cast your vote for the right candidate this election season.

Presidential elections may grab the national headlines, but local elections also have a big impact on voters' daily lives.

Locally elected officials are typically much more accessible to voters, whose participation in local elections can bring about real change. With that in mind, here are some tips to prepare for Election Day, whether you are selecting state, county, town, provincial, labor union, or school officials.

Solidify your stance. The first step to casting your vote is deciding how you feel about key issues and candidates. Some voters back a particular political party, while others spend more time moving across party lines and standing with politicians who have like-minded goals and ideas. Make a list of the issues that you find most important and want addressed

in this election. Then research the stance each candidate takes on the issues that most resonate with you.

Research the candidates. Conduct some preliminary research into each candidate running for office. Chances are their websites provide background information regarding their qualifications as well as their stances on certain issues. Many times newspapers will offer their own round-up on local candidates so you can get to know them further. Such information can save you the time and effort of looking into candidates on your own. Delve further when needed to see if the facts are correct. Examine public records for policies candidates supported to confirm if their ideals are similar to your own.

Ignore the polls. If you strongly support a candidate and his or her agenda, then stick with your preferences rather than relying

on the polls. Polls may be used to sway indecisive voters. However, even though the polls may be indicating one thing, the real test of a candidate's mettle is the end result come Election Day.

Attend a town hall meeting. Many local candidates interact with voters at informal town hall meetings. This is a great chance to assess a candidate, and provides voters the opportunity to have their voices heard and ask questions about the issues that concern them. You also may be able to watch candidate forums on television or online.

Stick to the issues. The best candidate is not necessarily the one with the biggest campaign war chest. Resist the temptation to be swayed by the flashiest signs or the best slogan. Pay more attention to the candidates' answers on tough questions.

Prepare Now for Election Day

Elections decide the leadership that guides legislation and enforcement of regulations. The right to vote is something many people take for granted, but elsewhere in the world many people have no say with regard to their political leaders, which only emphasizes the importance of participating in the election process whenever you're afforded the opportunity to do so.

The first step to prepare for Election Day is to confirm your eligibility. Age, legal residency and citizenship status are just a few of the factors that may affect your eligibility to vote. County clerks, municipal offices as well as the Division of Motor Vehicles should have voter registration forms, and additional information is available online.

Voter registration may have to be filed several weeks to a month in advance of Election Day in order for you to be eligible. In the United States, when voter eligibility is in question at the time of an election, a person typically may cast a provisional

vote, which will then be considered after other ballots are counted.

Once your eligibility has been verified, it is important to know the dates of key elections. Local newspapers often print schedules and this information can be found online as well. Various local and federal elections occur each year, and November is when national elections take place in the United States.

Before voting, voters should research the respective candidates for each election. To better understand candidates' platforms, visit their websites as well as those of nonpartisan political organizations, such as The League of Women Voters. Deciding who to vote for requires more than just siding with a particular political party. Read as much as you can on the candidates' beliefs, concerns and voter history. This will help you make the best decision possible.

In the days leading up to Election Day, confirm your polling location and voting options. USA

gov advises that if you need special assistance, contact your local elections office for information, advice, and educational materials about voting equipment and details on access to the polling place, including designated parking.

Understand that voter intimidation is illegal. Never feel obligated to vote for one candidate because you felt bullied into doing so. Your vote should remain private unless you want to share your choice with others.

Keep in mind that, in addition to voting for candidates, you may be asked to answer additional questions about issues impacting your local community. These are called ballot measures. A voter guide also may include information about certain issues that will require your vote.

Elections are on the horizon and preparing now can help voters make educated and sound choices at the polls.

American Flag Etiquette

The American flag symbolizes many things to many people. While the American flag is proudly displayed in millions of buildings and homes across the United States year-round, it tends to draw special attention each summer, when Americans celebrate their independence on July 4.

The Flag Code formalizes and unifies the standards of respect that must be given to the flag, even containing specific instructions regarding how the flag should not be used. The following are some of the rules that govern how to display the American flag.

Raising and lowering the flag

According to USFlag.org, the American flag should be raised quickly and lowered slowly and ceremoniously. While the Flag Code suggests the flag should be displayed only between sunrise and sunset, if it is displayed at night, it should be illuminated. The flag should be saluted as it is hoisted, and when lowered that salute should be held until the flag is snapped from the halyard or through the final note of music, whichever is the longest.

When displayed indoors, the

flag should be displayed to the right of the speaker, staging area or sanctuary. Any additional flags hanging in the room should always hang to the left of the American flag. When flags are grouped for display, the American flag should be in the center and at the highest point of any flag.

In mourning

The American flag is often displayed in mourning. When placing the flag at half staff, first hoist it to the peak for an instant before lowering it to a position halfway between the top and bottom of the staff. During mourning, when the time comes to lower the flag, it should once again be momentarily raised to the peak before it

is lowered.

The American flag is flown at half-staff when mourning designated, principal government leaders. It also must be flown at half-staff upon presidential or gubernatorial order.

When covering a casket, the American flag should be placed with the union at the head and over the left shoulder. The flag should never be lowered into the grave.

Parading the flag

When the American flag is carried in a procession, such as in a parade, the flag should always be to the right of the marchers when it is the lone flag being represented. When other flags are carried, the American flag may

be centered in front of the others or carried to their right. Parade audiences should salute the flag as it passes in the procession.

Flag restrictions

There are many conditions under which the American flag is not to be used. These include:

The flag should never be used as a decoration. Use bunting to decorate with the colors of the American flag, always ensuring the blue stripe of the bunting is on top.

The flag should not be used as part of advertising. The flag also should not be embroidered, printed or impressed on articles such as cushions, napkins, boxes or anything considered temporary

that is likely to be discarded after use.

The flag should not be used as part of a costume. The uniforms of military personnel, firemen, policemen and members of patriotic organizations are permitted to wear American flag insignias on their uniforms.

The flag is not to be used as a receptacle to carry, deliver, hold, or receive anything.

The American flag is an enduring symbol of freedom and sacrifice to millions of people across the globe. The flag should always be displayed with the utmost respect and in adherence to the guidelines set forth by the Flag Code

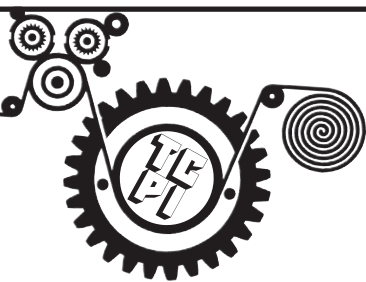

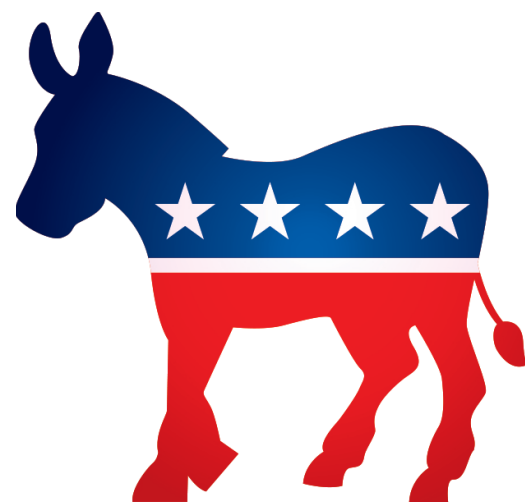

Make Election Day Go By Smoothly

Election Day gives voters throughout the United States a chance to participate in their government. The right to vote is something to cherish, as many people across the globe do not get a chance to elect the officials who govern their countries. While Election Day is an exciting time, voters may find it frustrating if they do not take steps to ensure things go smoothly when they head to the polls. The following tips can help voters prepare for Election Day.

Confirm your polling location. Polling locations may have changed since last year, and voters who have moved in the past 12 months may now have to vote in a new location. Voters can contact their local board of elections or visit www.Vote411.org to confirm the correct polling locations. Voters should also learn the hours when the polls are open so they do not arrive too early or too late to vote.

Bring photo identification.

Voter identification laws vary by state, but voters who want to avoid hassles or holdups may be able to do so by bringing current photo identification with them to the polling place. While such identification is not necessarily a requirement, voters who bring along a driver's license or state identification card may get in and out of the polling place more quickly than those who do not. Confirm registration. Voters can confirm that they have registered to vote by contacting their local board of elections in advance of Election Day. Sometimes voters' names may not appear on the registration list when they arrive to vote, even if they previously registered. Poll workers can help voters who find themselves in such situations. But voters who want to avoid such hassles on Election Day can confirm their registration beforehand.

Be familiar with the candidates and issues on the ballot. Voting



is a privilege and a responsibility, so voters should familiarize themselves with the candidates and issues on the ballot in the weeks leading up to Election Day. In addition to national or statewide candidates and issues, voters should learn about local issues that may have a more direct impact on their daily lives. The more

voters learn about the candidates and issues in advance, the more quickly they can cast their votes and get to work or return home. Voting on Election Day is a privilege that voters should not take lightly. Taking certain steps in the weeks ahead of Election Day can make it easier for voters to cast their ballots.

I am the Democratic Party candidate for the District 76 seat in the Tennessee House of Representatives. I already have listed some of the details of my background elsewhere in this issue, so here I will add a little more.

My wife, Susan, and I met in college in April, 1962. On September 1 of this year we will celebrate our 56th wedding anniversary. Susan majored in Home Economics Education. She has worked as a teacher and as a secretary. A talented artist and seamstress, over the years Susan made most of her own clothes and those of our sons when they were young. We also have combined my skills in mathematics and computing with her skills in art to give joint talks at mathematics conferences. Our two sons are both college graduates – Nathan, from Centenary U. and Andrew from Gonzaga U. Nathan is a materials engineer at Washington State University, while Andrew an insurance executive in Spokane. We also have 3 grandchildren and a great-grandson.

I spent my career as a university mathematics professor, all the while continuing a vigorous program of self-study to broaden my knowledge in both mathematics and computer science. In the

United States for 30 years I taught at Iowa State U., Whitworth U., and UTM. Overseas, for 15 years I taught at the U. of Papua New Guinea, Bendigo College of Advanced Education (Australia), the University of Vienna, KAIST – the Korean Advanced Institute of Science and Technology, and Divine Word University (Madang, PNG).

After gaining tenure at Iowa State in 1974, I made what turned out to be a life-changing decision. I took a leave to go to the University of Papua New Guinea in Port Moresby. There I realized how much Susan and I could contribute to the people of a developing nation, witness to our faith, and grow significantly in the process. Our sons attended multi-racial schools, and I was elected as Secretary of the Waigani Primary School Board of Management. This gave me insights into the vital issues of a developing nation, the opportunity to interact with government leaders, and to get to know both national and expatriate parents and teachers.

The experience led us in later years to take up positions in Australia, South Korea, Austria, and many times, in Papua New Guinea. In more recent years at UPNG I taught Introduction to Comput-

ing to hundreds of students each term, including many everyday poorly-educated but intelligent workers who otherwise would have had no opportunity to attend a university. Each of these opportunities enabled us to be able to relate to people of different races, cultures, and religions. In the process, many of those whom we met have become lifelong friends.

The idea of being able to take on new challenges arose again when I took a position at Whitworth College (now University) in Spokane. This highly respected liberal arts university is affiliated with the Presbyterian Church. Life there is firmly based on the faith of its community. Moreover, the university is committed to reaching out to assist the people around the world in matters of faith, well-being, and justice.

While at Whitworth I became a pioneer in the use of spreadsheets for mathematics, and in the process became an internationally recognized expert in this area, publishing articles, books, and serving as an invited speaker in over 25 countries. I also took on another task, serving at the Chair of the Faculty Economic Welfare Committee. I negotiated for improved faculty salaries and working conditions. However,

because the other staff had no such committee, their concerns became mine, too.

Finally, in coming to Martin in 2000 to become Chair of the UTM Mathematics Department, Susan and I found that this was not only the home a wonderful university (with another, Bethel, nearby, too), but that the area abounds in wonderful, welcoming people. We are active in Trinity Presbyterian Church where I am a ruling elder, I am Chair of the Weakley County Democratic Party, and Susan is active in several civic groups.

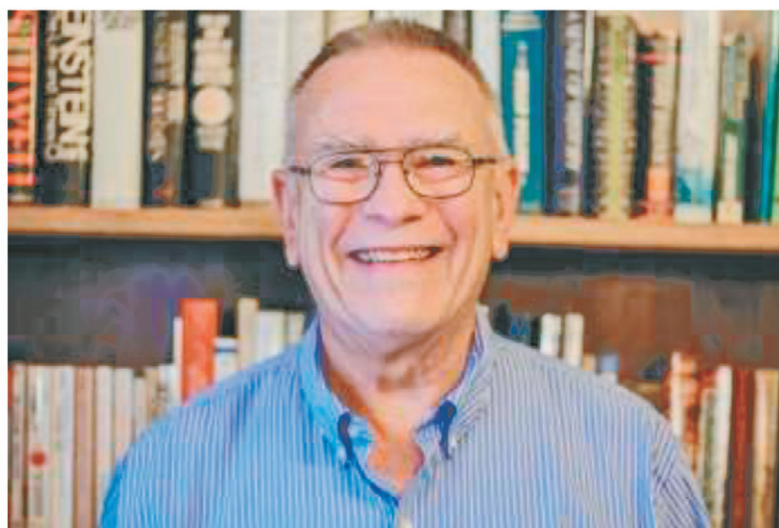
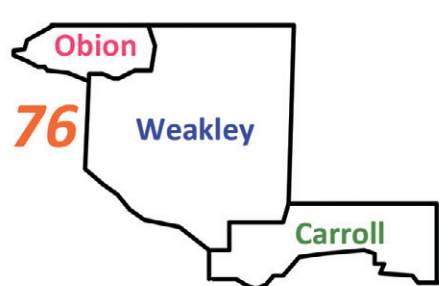
