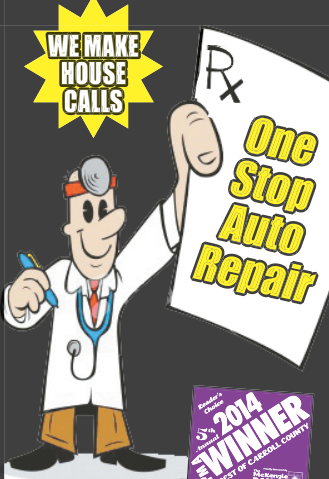

## One Fired After Use of Force in Jail

HUNTINGDON – One county corrections officer's employment has been terminated and another is under investigation following a Sunday morning, March 22 incident at the Carroll County Jail.

Sheriff Andy Dickson confirmed late

Monday afternoon (4-6-15) that the two were involved in an incident concerning the use of force on an inmate at the jail. Dickson declined to identify the two corrections officers or their gender. He said the Tennessee Bureau of Investigation (TBI) and the Federal Bureau of Investigation (FBI) are both reviewing the matter. The incident was brought to the sheriff's

attention on March 23. After reviewing footage from surveillance video, the sheriff requested the involvement of the District Attorney's Office, which requested involvement of the TBI. Agents with the TBI also asked the FBI to be involved.

## Jobless Rate Declines In Carroll County

NASHVILLE – Unemployment in Carroll County declined in February as compared to the January reporting period.

The percentage dropped 1.7 percent to a new rate of 9.6 percent as compared to 11.3 in January, according to the Tennessee Department of Labor and Workforce Development.

In February, 1,200 persons were unemployed from a labor force of 12,520. That compares with 1,400 unemployed in January from a labor force of 12,410.

Carroll County remains one of ten with the highest rate of unemployment in the state. Of 95 counties, Carroll is ranked 87th, and joins Clay, Scott, Cocke, Houston, Van Buren, Sevier, Decatur, Pickett, and Lauderdale in the top 10.

Henry County recorded a rate of 7.9 percent in February compared to 9.3 percent in January. From a labor force of 13,830, 1,100 were listed as unemployed.

Weakley County recorded a

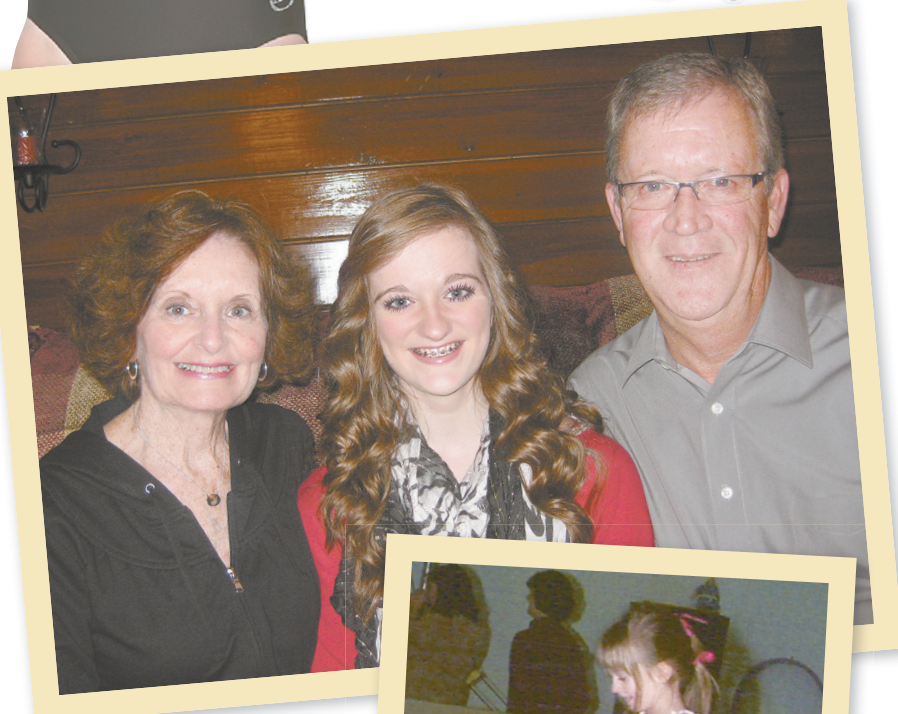

McKenzie High School senior Madison Graves is a natural gymnast, taking to the balance beam like a fish to water from an early age. Her skills, along with hard work and a strong support system, have yielded an abundance of rewards, including nine state championship gold medals in seven different years.

But when a devastating injury stifled her natural gifts and she suffered the tragic loss of her father, an irreplaceable pillar of support, Madison had to rely on her strength of will, her faith, and her patience to find her way back to the top.

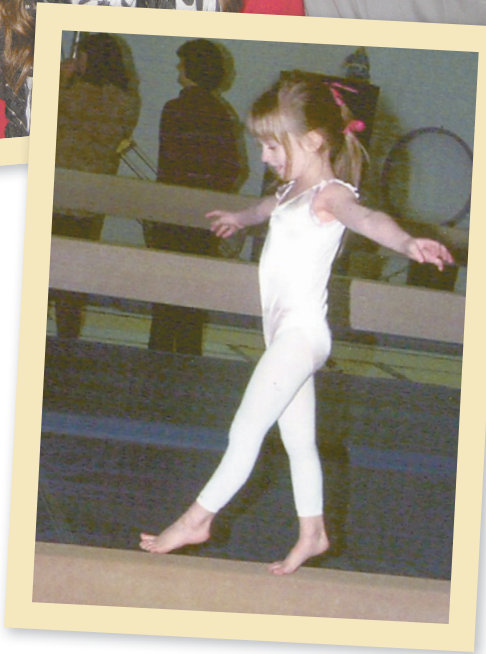
A lifelong McKenzie native, Madison began gymnastics at age six at Lakewood Gymnastics in Martin. She began her competitive career the next year as a Level 4 (out of the ten levels recognized by USA Gymnastics, the official governing body of gymnastics in the U.S.) In 2006, she won her first state championship, on the vault. The next year, she won on the balance beam, a feat she would repeat in 2008, 2009, 2012, and 2013. In 2008, she also won the floor routine and was the all-around champion, a composite of scores in all four events: vault, uneven bars, balance beam, and floor routine.

## Stevens' Bill Removes Ban on Handguns in Parks



State Senator John Stevens (R-Huntingdon) has introduced legislation that eliminates cities and counties from prohibiting firearms on the grounds of public parks, playgrounds, civic centers, or other building facility areas, or property owned, used or operated by any municipal, county, or state government for recreational purposes.

The bill is moving forward despite an amendment, added in the Senate, that also nixes the prohibition of handguns at the State Capitol. However, on Monday, the House passed the bill 72-14 without the provision to allow guns at the State Capitol.

Governor Bill Haslam has flagged the bill indicating he is opposed to it. The former Knox-

ville mayor said that it takes away local control of the municipalities and counties.

This bill removes the present law provision whereby local governments may prohibit a handgun carry permit holder from carrying a handgun in a public park that is owned or operated by the local

## Carroll Property Owners Receive Reappraisal Notices

CARROLL COUNTY (April 6) Some 18,507 parcels of real estate were reappraised in Carroll County and the notices of new appraisals were mailed last week to property owners.

Rita Jones, Assessor of Property for the County of Carroll, said property owners should have received and will receive their notices soon. The new appraisal represents the current value of real estate in the county.

The appraised value of some properties increased while others decreased.

Real estate values on farm and agricultural land increased the highest percentage. In the year 2014 (the final year of a four-year appraisal), farm land was valued at \$28,171,825, for 1,261 parcels, compared to \$33,977,950 for 1,289 parcels in 2015. That represents a \$5,806,125 increase in total value or about 20.61 percent.

Agricultural land experienced an increase from \$63,966,800 for 2,882 parcels in 2014 to \$72,951,525 for 2,871 in 2015. That represents an increase of \$8,984,725, or 14.05 percent increase.

Residential property in the county increased slightly at 2.52 percent or a total of \$4,429,300.

**STANDING RIB ROAST**  
1 (6 pound) fully trimmed 3-rib roast  
1 ½ to 2 tablespoons coarse sea salt  
1 ½ teaspoons coarsely ground pepper or cracked pepper  
Garnish: fresh herbs  
Place roast, rib side down, in a lightly greased shallow roasting pan. Rub salt and pepper into fat across entire top of roast, covering completely. Insert a meat thermometer into roast, making sure it does not touch bone or fat.  
Roast, uncovered, at 450 degrees for 10 minutes; reduce oven temperature to 325 degrees, and roast 2 ½ hours or until thermometer registers 145 degrees (medium rare). Remove from oven; cover roast with aluminum foil, and let stand 20 minutes. (This allows juices to retreat into the meat; the temperature of roast will rise slightly.) Garnish, if desired. Serve with new potatoes, and carrots. Yield 10 servings

**BEEF TENDERLOIN**  
1 tablespoon salt  
1 ½ teaspoons onion powder  
1 ½ teaspoons garlic powder  
1 ½ teaspoons black pepper  
1 teaspoon ground red pepper  
½ teaspoon ground cumin  
½ teaspoon ground nutmeg  
1 (5-pound) beef tenderloin, trimmed  
¼ cup olive oil  
Garnish: fresh herbs  
Combine first 7 ingredients  
Rub tenderloin with oil; coat with spice mixture. Place in a roasting pan; cover and chill 8 hours. Bake at 500 degrees for 15 minutes or until lightly browned. Lower temperature to 375 degrees; bake 20 more minutes or to desired degree of doneness. Let stand 10 minutes. Slice and serve with Spicy Horseradish Sauce (below), if desired. Garnish, if desired. Yield 8 servings

**SPICY HORSE RADISH SAUCE**  
2/3 cup reduced fat sour cream  
3 tablespoons prepared horseradish  
2 tablespoons light mayonnaise

1 tablespoon white wine vinegar  
1 teaspoon dry mustard  
¼ teaspoon salt  
¼ teaspoon ground red pepper  
Stir together all ingredients. Cover and chill for 1 hour. Serve with beef, pork, steamed shrimp, as a sandwich spread, on baked potatoes, or as a dip. Yield 1 cup.

**MOLASSES GRILLED RIB EYE STEAKS**  
½ cup molasses  
¼ cup coarse-grain Dijon mustard  
1 tablespoon olive oil  
4 (10 ounce) boneless rib-eye steaks  
¼ teaspoon salt  
¼ teaspoon pepper  
Combine ½ cup molasses, ¼ cup mustard, and 1 tablespoon olive oil in a shallow dish or large zip-top freezer bag. Add steaks; cover or seal, and chill for at least 2 hours, turning occasionally. Remove steaks from marinade, discarding marinade. Sprinkle steaks with salt and pepper. Grill steaks, covered with grill lid, over medium-high heat (350 to 400 degrees) 5 to 7 minutes on each side or to desired degree of doneness. Yield 4 servings.

**LIVER AND CARAMELIZED ONIONS**  
2 onions, thinly sliced  
3 tablespoons butter or margarine, melted  
3 tablespoons olive oil  
1 teaspoon salt  
½ teaspoon pepper  
1 pound thinly sliced calf's liver  
¼ cup all-purpose flour  
Saute onion in butter in a large skillet over medium heat 20 minutes or until tender and golden, stirring occasionally. Remove onion; add olive oil to skillet. Sprinkle salt and pepper on both sides of liver; dredge in flour. Shake off excess flour. Add liver to skillet, and cook over medium-high heat 3 minutes on each side or until browned. Transfer liver and onion slices to a warm serving platter; serve immediately. Yield 4 servings

Then, on August 26, 2013, while training to move from Level 8 to 9, Madison dismounted from the uneven bars and “the landing just went wrong.” She had torn the ACL in her left knee.  
After waiting an excruciating month for the swelling to reduce, she underwent surgery on September 26.  
In an interview with The Banner, Madison explained her mindset going into the procedure. “Part of me knew that I was going to be able to come back from it, but part of me wondered if I’d be able to walk.” She was able to (under her doctor’s guidelines) put weight on her left leg right out of surgery. Her parents, Marian and Kenny, asked her what she was going to expect of herself. She replied, “I just want to see what I can do.” She immediately began working on her upper body strength.  
Six days later, on October 2, while recovering at home with her mother, the two were preparing to eat lunch when a police car pulled up in the driveway. Kenny, the maintenance supervisor for the school system, was working on the roof of McKenzie Elementary and had what doctors call a “widowmaker,” a massive heart attack that killed him instantly. Madison, who was already



under the effects of pain medication for her very recent surgery, says, “I don’t remember much.”  
“We were in shock,” Marian added. “We helped each other go through the motions, but our world stopped.”  
Marian went on to say, “You talk about community support, this is an amazing community. They did everything. Physically helped with everyday things, brought food, collected money. We received enough cards to fill a room.”  
She continued, “You could be angry, you could be bitter. But I’ve been blessed. The years I got with Kenny and the daughter we had together... I’ve been blessed.”  
Madison had to now heal from another wound alongside the physical one. She poured herself into her recovery, rehabbing her knee three days a week for six months. She did extra work at home (within the recommendations of her doctors and therapists, of course.)  
By the time the 2015 season began, she was stronger than before the injury. Unfortunately, after missing the rest of 2013 and all of 2014, she had run out of time to reach Level 10 during her senior year, and wouldn’t be scouted by colleges. This effectively meant that her senior year would mark the end of her competitive career.  
Rather than be discouraged by that finality, Madison went full force into her remaining opportunities, determined to leave everything on the gym-

nasium floor.  
After two shaky preseason meets in late 2014, she won the beam at a January regular season meet. “I knew I was back,” she said.  
It all came down to the State Championship at the Knoxville Convention Center on March 28. Competing against Level 8 gymnasts from across Tennessee, Madison began with the floor routine. She performed well, earning a score of 9.375 and a fourth place medal. The next two events, the vault and the uneven bars, were her weaker events, but “I knew all I could do was my best,” she said, “and afterward, I shook it off.”  
Left for last was her specialty, the balance beam. She indeed put everything she had into it, and upon sticking the landing, “I was just happy. When I saluted the judges, I couldn’t even see them through the tears in my eyes.” Her three coaches from her gym of four years, Glory Gymnastics Center in Jackson, embraced her as she left the floor.  
When final placings were announced, her elation multiplied as she learned that she had won the gold medal in beam, with a score of 9.35, well above the next-highest score. She also placed fourth all-around to earn another medal.  
Marian said of the win, “I was really excited knowing it was her last competition. Everything she had been through, this was her reward for coming back so strong.”  
Madison says that gymnastics

has taught her more than just athletics, and her mother agrees. Between the two, they listed discipline, concentration, determination, patience, teamwork, work ethic, and the ability to prioritize. The sport has also given her the opportunity to travel all over the country and meet Olympic gymnasts such as John Roethlisberger, Shawn Johnson (Madison’s favorite), Shannon Miller, and Jordyn Wieber, to name a few.  
She now plans to attend the University of Tennessee at Martin and will major in exercise science, hoping to become a physical therapist. She plans to stay involved in gymnastics in one way or another, beginning by learning Level 9 skill and then coaching at Glory over the summer. She’ll also coach at G-Force in Martin, formerly Lakewood, her original gym.  
Aside from hard work, she credits her accomplishments to her parents, her sister, Kaci Mebane Bond, and her husband Scott Bond, her friends and family, coaches, teachers and community, and she “definitely couldn’t have done any of it without the Lord.”  
Aside from gymnastics, Madison is involved in numerous school activities and clubs, is a distinguished scholar, and has a vast community service record.  
Most indicative of Madison’s nature, though, is her response when asked, “Was there a point at which you thought about giving up?”  
“Never.”

Commission to Amend Budget To Accept Funds for Radios

CARROLL COUNTY – Commissioners will amend the County of Carroll’s budget on Monday to accept \$487,501.20 from the county’s E911 Board for the purpose of purchasing two-way radios for the county’s Sheriff’s Department and Rural Fire Department. Commissioners meet April 13, 7:00 p.m. at the Carroll County Office Complex.  
The new digital radios will be supported by a new system of repeaters throughout the county to assure two-way communication with the dispatcher and between mobile units.  
The Impact Funds from the E911 Board will provide the lion’s share of the cost of the new communication system.

Mayor Kenny McBride said the funds have already been received and the Commission has approved the purchase of the radios, this is the final step to reflect the transfer of funds in the budget.  
In other business, commissioners will consider the following resolutions:  
To appoint Don Reed of McLeomoresville to the Board of Equalization to fill the vacancy of Larry Fisher.  
To appoint Carl Byars to the Carroll County Library Board to fill the vacancy of Nancy Rush.  
To reappoint Billy J. Smith the Carroll County Zoning Appeals and Carroll County (Lake) Regional Planning Commission.  
To approve a five-year reappraisal cycle for all real estate in the county. The State is requiring the change from four years to five years.

United States military or any member of the Tennessee national guard when in discharge of their official duties and acting under orders requiring them to carry arms or weapons;  
(2) A civil officer of the United States in the discharge of official duties;  
(3) An officer or soldier of the militia and the national guard when called into actual service;  
(4) A law enforcement officer when in the discharge of official duties;  
(5) A student in the ROTC or enrolled in a course of instruction, or who is a member of a club or team, that requires the student to carry arms or weapons in the discharge of official class or team duties;  
(6) A private police employed by the administration or board of trustees of any public or private institution of higher education in the discharge of duties;  
(7) A registered security guard discharging official duties; or

(8) Carrying a machete while employed in a profession where a machete is customarily utilized.  
This amendment also prohibits a department of state government from changing, removing, or replacing signs as a result of the bill until the time the signs are regularly scheduled to be changed, replaced, or removed. However, the amendment authorizes the general assembly to appropriate funds for this purpose. This amendment also specifies that permit holders may carry a handgun in any building located on the areas described above in the bill summary.  
This amendment changes the effective date from "April 6, 2015" to "upon becoming law."  
AMENDMENT #2 adds that handgun carry permit holders may not be prohibited from carrying a handgun on the grounds of the state capitol or the surrounding capitol complex.

J. C. taught us how to fish. He'd bring Uncle Clifford's old International truck to a screeching halt in the middle of the small bridge spanning Sugar Creek, leap out and fire his big 30-06 down in amongst the brim and shell cracker. He didn't hit anything mind you, but the concussion would stun the fish and they'd momentarily turn bottom side upwards and float to the top.

Me and J. C.'s little brother would be waist deep, downstream, throwing the “sleeping” fish up on the bank. The ones that got passed us would shake a bit, spin right side up and go on about their merry way seemingly unconcerned over the mid stream nap.

We were fourteen or fifteen that summer and providing food for the family was only a small by-product of the fun we shared in those “days we thought would never end”. We rambled from the Steadman Ridge Road all the way down to Bonnertown exercising our constitutional rights as teenagers almost old enough to be driving that truck.

Life interrupted our fishing. David and J. C. went off to Viet Nam on their senior trip. Joe followed Uncle Clifford down to the bicycle plant. I was captured and sent to Florida.

J.C. and David, like cousins are wont to do, have been swapping guns and stories about “running the ridges” for years. David brought “C” by the house. He took

a liking to an antique advertiser clock hanging on the wall in my Stan Musial room. He wouldn't let me give it to him. As he was putting it into his truck he said, “You come up home and pick out any gun you like.”

It took me two months to “get up home”. It didn't take me but one minute to select the Harrington and Richardson remake of their famous 1871 Buffalo Rifle. This gun had a beautiful black walnut stock, crescent steel buttplate and a Lyman front sight with eight aperture inserts. It shot a 45/70 shell that I'm telling you would take care of any buffalo roaming down Garrison Avenue!

We haggled over how much ammo he was going to include as I experimented with the chocolate gravy up at Anne's Diner. As you well know you can't just trade outright. No self respecting horse trader is going to do that! The breakfast eatery was in downtown Leoma, Tennessee. I was kin to near 'bout everybody in the place. I got so overcome by the Hershey flavored gravy and the nostalgia running knee deep to a giraffe's hind leg I let J. C. slide with only one box of shells.

The rifle had never been fired. I had five hundred bucks in that old clock but I figured I'd “come out all right” in this deal. You can't stop a charging buffalo by throwing a wall clock advertising Bull Durham Smoking Tobacco at him!

Dave and I drove up to Nashville to visit our sister-in-law. We hadn't been there an hour before J. C. called. He'd found his old Seiko watch he purchased in 1969 as his tour of duty wound down in Viet Nam. Son of a gun! Now, I'd never seen the watch. But a Viet Nam era Seiko is a prized possession.

We met him at Preston's Restaurant,

which is right next door to Anne's. Over a catfish dinner that would melt in your mouth we got serious about that watch. I knew it didn't run unless J. C. shook it pretty hard. “C”, did you throw this watch into the fire before or after the Mack truck ran over it?”

He'd owned that watch for a long time. He didn't say nothing. “I'll tell you what, I'll give you cash for it or I will get it fixed and bring it back to you.” He just picked up another piece of catfish. “Or,” I swallowed hard but tried to keep my poker face, “I'll trade you my prized Harrington and Richardson genuine Buffalo Rifle for it. This gun has been in my family for years. My great granddaddy got it off of William Cody himself. I've personally shot down seven buffalo with it. I stopped one dead in his tracks just last week charging across the little league field. I'll even throw in a case of shells.....and pay for dinner.”

Whew! That J. C. drives a hard bargain! I figure in its present condition that watch wasn't worth fifty cents. But I can get if running like a sewing machine for only two hundred and fifty, maybe three hundred dollars at the most.

I proudly pulled it out to show Cathy when I got home. She peered down at it in disbelief. And I've got to admit, it looked a little rough under a good light, with the crystal broken and the dial burned off and the stem hanging a little loose. But it is a genuine Viet Nam era Seiko.....

Cathy finally managed to tear her self away from it. She turned and gave me her sweet smile, “Honey, you need to find a new line of work.”

More Than Just a Drink By Clayburn Peeples

I've gotten several comments about a column I wrote a couple of weeks ago about the 1924 murder trial of Lem Motlow. Motlow, of course, was the Tennessee distiller who shepherded his famous Jack Daniel's Tennessee Whiskey to national prominence.

That brand, along with Tennessee's other famous whiskey, George Dickel, has made Tennessee one of the best-known whiskey-producing areas on earth. That's odd, given that up until a few years ago, they were the only two legal distilleries in the state.

Which is also strange, because distilling was once the leading industry in the state; no product has been more intertwined with the history of Tennessee.

Beginning in 1771, whiskey has been produced throughout the state, in amounts that stagger the imagination. As early as 1799, for example, Davidson County counted fewer than 4,000 inhabitants, but had 61 operating stills.

Tennessee was a natural for whiskey-making in the early days. There was a seemingly inexhaustible amount of good soil for growing corn, an abundance of white oak for making barrels, and a good network of rivers on which to ship the whiskey to distant markets. Also, stills could be set up cheaply and easily with almost no capital, and the leftover mash could be fed to hogs and cattle.

And Tennessee distillers couldn't make enough of it back then. It was used on the frontier for all sorts of things; it was for drinking, of course, but it was much more than a drink. It was used as a medicine, a disinfectant, and as both stimulant and tranquilizer, depending on the need.

By 1820, Tennessee was one of the four top states in the nation in whiskey production, and the industry grew steadily up to the Civil War. But during that unpleasantness, occupying Union

armies banned the production of whiskey in order to conserve grain to feed their soldiers and livestock. Immediately after the war, however, Tennessee distillers cranked up their stills again. By 1874, 45,000 barrels of whiskey were being produced annually in Robertson County alone. Tennessee distillers began to use so much corn that Tennessee farmers couldn't grow enough of it, and had to import it from other states.

By 1896, distilling of spirits was the largest industry in the state, using 750,000 bushels of corn a year and 500,000 bushels of apples and peaches, which Tennessee farmers were delighted to produce.

But there was a cloud on the horizon. The Women's Christian Temperance Union had organized in 1874, followed a few years later by the Anti-Saloon League. Their anti-alcohol crusade was joined by churches throughout the state, and by 1887 their coalition had become strong enough to pass a law that forbade the sale of alcohol within 4 miles of chartered schools, except in incorporated towns.

Then, in 1899, the Legislature passed an act which gave towns of up to 2,000 citizens the right to also prohibit the sale of liquor, and in 1903 they included towns of up to 5,000 people. In 1907, they authorized every town in the state to do so, if they wished, and every town did except for four, Memphis, Nashville, Chattanooga and LaFollette.

Two years later, they ended it all, and forbade the manufacture of whiskey in the entire state, as of January 1, 1910, instituting Prohibition in Tennessee a decade before it spread to the rest of the nation.

As a result, Tennessee's vast and powerful liquor industry was banished from the state. Most distillers simply went out of business, but a few attempted to move to other states and conduct busi-

ness there.

Almost all of them failed. Only two of the famous pre-Prohibition whiskeys would survive. Jack Daniel's, of course, and Coffee County's Cascade whiskey, the flagship brand of the George Dickel Distributing Company.

Lem Motlow, owner of Jack Daniel's distillery, persuaded the legislature, in 1937, to allow the resumption of distilling in Lynchburg, and Cascade whiskey, produced in Kentucky for many years after Prohibition, moved back to Tennessee in 1958, when they too got permission to fire up their stills again, marketing their once famous Cascade whiskey under the name, “George Dickel Tennessee Whisky.”

For half a century these two historic companies were all that remained of the once vast and powerful Tennessee whiskey industry, but in recent years the legislature has authorized the manufacture of whiskey in other Tennessee counties, and several boutique brands have been distilled and introduced.

Still, when people think of Tennessee whiskey, they usually mean either George Dickel or Jack Daniel's, both of which, ironically, are owned by out-of-state business conglomerates.

As for Prohibition, people still argue over whether it was a good or a bad thing. For certain it destroyed the state's most important industry at the time, but it did something else as well. It all but erased our collective memory that such an industry even existed in Tennessee, let alone prospered and drove the state's economy for much of our history.

But it did, and the story of whiskey in Tennessee is part of how we evolved as a people and who we are today. It's a story all Tennesseans ought to know.

And now you do.

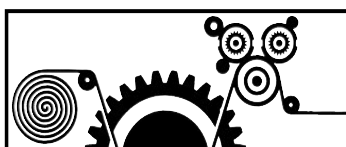

McKenzie Police Reports

Gas Prices to be \$2 this Summer

TAMPA, Fla. (April 5, 2015) — Lower gas prices may be on the way for U.S. consumers by this summer if refinery maintenance ends smoothly and crude oil remains relatively cheap. It is even possible that gas prices will return to near \$2 per gallon in some areas, as long as there are no unexpected problems in the meantime. AAA does not expect the national average to rise above \$3 per gallon this year.

“There is a real hope that gas prices could drop significantly in time for the busy summer driving season,” said Mark Jenkins, spokesman, AAA - The Auto Club Group. “The overall outlook looks good for drivers, and with any luck we will avoid the types of problems that often lead to higher gas prices at this time of year.”

Many refineries have completed seasonal maintenance, though unexpected problems could still occur. Many refineries and wholesalers will switch to more expensive summer-blend gasoline by May 1 to meet EPA clean air regulations.

The cost of crude oil is likely to be the most important factor influencing gas prices over the next few months. At the close ofFriday's formal trading on the NYMEX, WTI settled at \$49.55 per barrel - 68 cents higher than the week before. Many experts

believe that crude oil prices may drop further due to abundant supplies, but international conflict, declining production or other issues could result in higher prices.

The framework nuclear deal, reached with Iran last week, could have an enormous impact on oil and gas prices. While it could ultimately take 6-12 months, the agreement would bring an estimated 500,000 barrels per day of additional oil to the global market, which would add more supply to an already well-supplied market and exert further downward pressure on crude prices, which have a major influence on the price of gasoline.

Sunday's national average price for regular unleaded gasoline is \$2.39 per gallon. Consumers are paying 3 cents less than last week, 7 cents less than a month ago, and \$1.18 less than the same date last year. The national average has now fallen 23 of the past 30 days. Many drivers are saving \$15-\$30 on every trip to the gas station due to lower prices. AAA estimates that American households are saving a total of \$400 million per day on gasoline compared to a year ago, which works out to average savings of more than \$100 per household per month.
