

## **Carroll County Returns to Top 10** In Unemployment

NASHVILLE — Carroll County is back in the unenviable position of the top seven in unemployment percentages in the State of Tennessee, according to the October 2018 labor force estimates released by the Tennessee Department of Labor and Workforce Development.

Carroll County joins seven other counties in West Tennessee to be listed among the top 10 in unemployment. Those include neighboring Benton, along with Obion, Lake, Lauderdale, Haywood, Hardeman, and McNairy.

From a labor force of 12,080, 11,430 were employed and 650 were unemployed. The percentage of unemployment increased to 5.4 from 5.1 one month earlier, and 4.6 one year earlier.

Henry County's unemployment rate was listed as 4.7 percent in October, up from 4.3 in September, and up from the 4.1 percentage rate one year earlier. The

### **Weakley County Ambulance Service Awarded Three-Year Franchise Agreement**

DRESDEN (November 19) -After months of discussions and public hearings, the much-anticipated vote on the ambulance service franchise agreement was finally held during Monday night's meeting of the Weakley County Commission. The two main competitors for the three-vear contract were Weakley County Ambulance Service, Inc., which is the county's current ambulance service provider that has served the citizens of the county for 35 years, and Medical Center EMS (West Tennessee Healthcare), which recently purchased Volunteer Hospital in Martin. Both

Following a motion by Commissioner James Roy Pope of Greenfield to re-hire Weakley County Ambulance Service and a second by Commissioner Dennis Doster, the Commission approved the motion by a vote of 10 to eight.

Commissioners voting in favor of the motion were: Dennis Doster, Bobby Dunlap, Eric Owen, Larry Hudson, James Roy Pope, Greg Ursery, Gary Eddings, Scott Fortner, Donnie Essary and James Westbrook. Seven of the eight "no" votes

## AAA: Tennessee Gas Prices Challenge 2018 Lows

NASHVILLE (November 26, 2018) — Tennessee gas prices are approaching the lowest levels of the year, and motorists should see additional discounts this week. Just as retailers cut prices on Black Friday, the price of crude also dropped by more than 10 percent - for concerns that strong global oil production will overpower demand.

Gas prices in Tennessee averaged \$2.34 per gallon on Sunday, after dropping 8 cents in the past week. The average price in Tennessee has declined the past 45 consecutive days for a total discount of 35 cents. The lowest average price so far this year was \$2.26/g, on January 1.

Average prices are at or near 2018-lows in metro areas like Chattanooga, Cleveland, Jackson, Knoxville, and Memphis. Click here and scroll down to find daily metro average gas

Most expensive gas price averages: Johnson City (\$2.43), Nashville (\$2.43), and Jackson (\$2.36).

Least expensive gas price averages: Cleveland (\$2.17), Chattanooga (\$2.22), and Knoxville (\$2.27).

The national average price of \$2.56 per gallon is 7 cents less than last week, nearly 30 cents less than last month, and the lowest daily average since March. Sunday's U.S. average price was 7 cents more than this year's low, of \$2.49 set in January. However, the national average should drop below that point within the next week.

"Last week's crude price plunge adds even more weight to what was already strong downward pressure on prices at the pump," said Mark Jenkins, spokesman, AAA - The Auto Club Group. "Tennessee motorists should see gas prices drop another 5-15 cents as a result. The state average will likely log a new 2018-low within the next 10 days. These falling prices are mostly due to record crude production rates from the U.S., Russia and Saudi Arabia. Unless the oil market quickly recovers, these low gas prices should

hang around through the end of the year."

#### **Fuel Fundamentals**

Crude oil prices plunged another \$6 per barrel last week - the equivalent of about 15 cents at the pump.

Friday's daily settlement of \$50.42/b is the lowest since October 2017.

Domestic crude production holds steady at 11.7 million barrels per day (record high) The U.S., Russia, and Saudi Arabia are all producing crude at record levels.

Crude oil supplies increased again, by 1.1 percent (9th consecutive weekly gain).

Gasoline dropped another 19 cents on the futures market Wholesale gasoline dropped another 5 cents last week. Gasoline demand is also rel-

atively steady. Gasoline production was slightly lower than the week

Gasoline supply remains strong for the fall, 10 percent better than this time last year.

Pearson was a former teacher at McKenzie Middle School and a softball coach for MHS. She resided in Huntingdon and was very active in the church. As she battled cancer, Pearson signed her documents with 'Never Quit."

Never Quit's goal is to help as many families in the Carroll County area and surrounding county as possible. However, the organization needs support from the community to accomplish this.

loss, change in household compositions, etc.





labor force today is 14.160, with 13,500 employed and 670 unemployed.

Weakley County's unemployment rate was listed as 4.3 percent. That matches the September rate and a decline from the 4.7 one year earlier.

Northwest Tennessee has the highest unemployment rate among all districts statewide. The average rate is 4.8 percent.

The rate decreased in 26 counties, increased in 33, and remained the same in 36. The rate is less than 5.0 percent in 81 counties, and 5.0 percent or greater, but less than 10 percent in 14 counties. No counties were higher than 10 percent.

McKENZIE — University Drive in McKenzie is providing a much smoother ride for vehicles. Leveling and an estimated 2,600 tons of asphalt for a twoinch thick surface layer made the one-time rough and ragged 7,900-foot long roadway sleek and pristine.

Arrow Paving Company, Inc. of Lexington, Tenn. was awarded the contract following a bid of \$94.80 a ton for the asphalt. Public Works Director Johnny Mercer requested bids to be by the ton, not the completed job. Any asphalt remaining after the completion of the

project will be applied to city

streets in need of repairs and

The council authorized the issuance of an interest bearing general obligation capital outlay note of \$350,000 for the paving project and other street repairs within the city limits. The authorization was for a five-year 3.875 percent bond through the Tennessee Municipal Bond Fund. The bond would cost the city \$40,480.20 in interest totaling the expense to \$380,480.20 over the five-year

## **McKenzie Industrial Board Hears Retail Development Consultant**

McKENZIE (November 20) McKenzie Industrial Board heard a presentation by Casey Kidd, chief executive officer, of NaviRetail concerning a proposal to implement a retail development strategy for McKenzie.

Speaking to the board, Kidd said his company provides detailed information about traffic patterns and shopping habits of the local residents and transients passing through the local retail market.

Kidd said the company analyzes credit card data of regional retailers and online companies to determine where people are shopping. The information can help local retailers better understand their customers and also determines what gaps exist in services people are purchasing elsewhere.

The company estimates McKenzie has a loss of \$3,657,999 in tax revenues on sales going outside the city and an unmet demand of \$133,017,945 in goods and services purchased else-

People don't mind driving

to meet their needs, said Kidd. McKenzie can increase its quality of living for its residents by identifying and fulfilling their needs.

Kidd said his company offers anayltics and retail development consultants to assist the local community.

The board also heard a report on Pottery Direct's plans to locate in McKenzie in the year 2019 and an update on Campbell Arms Manufacturing.

Due to a tie vote in a previous

Public Safety Committee meeting, the matter was deferred to the full County Commission. The ambulance franchise

agreement is in force from January 1, 2019 through De-

cember 31, 2022. During discussion of the resolution granting an exclusive franchise for the operation of ambulance service within the boundaries of Weakley County, Commissioner Hawks was the only commissioner speaking in opposition to awarding the contract to Weakley County

Ambulance Service. Other commissioners had nothing to say about the issue, having already discussed the matter at length in prior meetings, and after hearing arguments for and against one ambulance service or the other. They have also heard from their constituents, which was evident by the split vote, with those in the Martin area voting against Weakley County Ambulance Service, having expressed support for West Tennessee Healthcare, the new owner of Volunteer Hospital in Martin.

We're going to work on strengthening our staff with more paramedics. It's a nationwide problem. It's not just in Weakley County." He added this would be the number one focus.

"The second thing we're going to work on is building a stronger first responder network throughout Weakley

County in every community," Washburn continued. "I've already talked with some of the fire chiefs about that, and how we can integrate our first responder network across Weakley County.

"The third thing we're going to do is sit down with Volunteer Community Hospital and the fire department and see what we can do to resolve any differences and difficulties that we

## **Social Security Matters**

Ask Rusty — U.K. Pension Affects Social Security Benefits

Dear Rusty: Today I had my interview for Social Security and was told that because I receive a government retirement pension from the United Kingdom, my Social Security check will be reduced by up to 55%. My question is, how can this be so? My U. K. pension was not a voluntary contribution but a mandatory deduction withheld from my paycheck just like for my U.S. Social Security. Is there any way to get around this drawback? Any information you can give me will be greatly appreciated as I am not financially well off and was depending on both checks and not still having to work after retirement. Signed: Perturbed

Dear Perturbed: If you worked and earned enough separately in both countries to be independently eligible for benefits from each, your U.S. Social Security benefit will be reduced by Social Security's Windfall Elimination Provision (WEP).

WEP was enacted by Congress in 1983 to equalize benefits between those who collect only Social Security, and dually entitled workers who collect both Social Security and a pension from an employer which did not participate in or contribute to Social Security. The United States has Social Security 'totalization agreements' with many other countries, and here is an excerpt from the Agreement between the US and the UK:

"A U.K. pension may affect your U.S. benefit. If you qualify for Social Security benefits from both the United States and the United Kingdom and did not need the agreement to qualify for either benefit, the amount of your U.S. benefit may be reduced. This is a result of a provision in U.S. law that can affect the way your benefit is figured if you also receive a pension based on work that was not covered

by U.S. Social Security."
The "agreement" referred to is the "totalization" agreement between the United States and United Kingdom which provides for coordination of benefits

between the countries The bilateral agreement is helpful when someone join-amac.

has some time working in both countries but not enough in either to qualify for full benefits. In that case the agreement allows for totaling credits earned in both so that a person has enough total credits to be eligible for benefits. But when someone is independently eligible for full benefits in both countries, the Windfall Elimination Provision applies and will reduce Social Security benefits by up to 50% of your U.K. pension amount, or up to the maximum reduction for the year you became eligible for U.S.

benefits. I'm afraid there is no way around this, unless you have more than 20 years of U.S. employment, which contributed to the U.S. Social Security system. The WEP reduction to your U.S. Social Security is less if you have more than 20 years of SScovered "substantial earnings" and WEP goes away if you have more than 30 years of SS-covered employment with substantial earnings.

But if you have less than 30 years of SS-covered substantial earnings, WEP will reduce your U.S. Social Security benefit. For additional information, here is a link to an article I previously published on how WEP works: https://socialsecurityreport.org/ask-rusty-wep-windfall-eliminationprovision/

## **West Texas Ranchers Set New Trend**

Our extra nice postmaster answered politely my query concerning the mail business as we approach the holiday season. He mentioned the uptick in online shopping really kept them busy. And added almost as an afterthought, "You wouldn't believe the amount of groceries we handle each day."

I went silent. For some time. How do you shake a coconut to see if it's the one you want via this absentee, long distance purchase technique? How do you know for sure you picked the freshest lettuce in the bin if you're seeing it for the first time at the mailbox? How do you buy grapes, apples and peaches without checking for bruised spots? And I don't even want to think about

Mother wouldn't dare purchase a watermelon, cantaloupe or grapefruit without thumping, smelling or squeezing it first!

I'm certainly not anti-online shopping. For the right product! There are distinct advantages in not circling the block searching for a parking space, avoiding the long lines and not sifting through endless racks hoping to find a size that fits. AND, you don't have to shave! In lots of ways this phone-in purchasing gig is better than a double bowl full of Neapolitan ice cream.

But it seems to me the American consumer has got to recognize that mile wide chasm between product and produce! We tell those rotten tomatoes jokes...but nobody actually wants them over-ripe and smelling when they show up at the front

door. And there is at least one other serious flaw in this online buying thing. You see the product—you buy the product. To me that eliminates any possibility of accidental shopping. That's how I pick up my best stuff. Cathy sends me to the grocery to fetch a can of mushroom soup and a box of Ritz Crackers. I "accidentally" see the bread and butter pickles, the Planters mixed nuts, the mustard sardines...and if you take the long way back to the checkout counter you can stumble across the Chips Ahoy cookie section.

I'm not calling this impulse buying. You don't have a real meatloaf sandwich if it's not adorned with bread and butter pickles. You can never have too many Planters nuts. And the mustard sardines and Chips Ahoy speak for themselves...

It would probably shock some millennials to know online shopping wasn't invented by that Amazon fellow. Mr. Sears and Mr. Roebuck beat him to it by a hundred years and more. And I'm not for dead certain positive those two were the first either. It is fairly well documented that a few lonesome West Texas ranchers in the post-Civil War days shopped on line for what was then called Mail Order Brides. It usually worked out well for both parties in most instances, but the return policy was near bout nonexistent!

And if you think Walmart or Amazon will deliver about anything to your door, you ain't heard nothing yet. Sears and Roebuck sold houses online. I kid you not! They had five, six...up to 10 room models. The two-story styles were particularly popular. Every house came precut with everything you needed, including detailed

blueprints, to set it up on the lot of your choosing. Most of the houses cost between \$700 to \$1200. And as an extra courtesy, each set of plans came with an estimate of what it would cost to "put together" the house. And the loan department at Sears, for a mere six per cent interest, would gleefully finance your home.

These house sales went the way of the dodo bird by 1940. I'm sure curtailed by the Great Depression and the uncertainty of an impending war. But I'm telling you, was for many years online shopping on its grandest scale!

We were introduced to the mail order phenomenon by the Sears and Roebuck Company catalogue in the early 1950's. It had hundreds of pages, many in living color, with everything in the world in there but we mostly concentrated on toy trucks, Lincoln Logs, bicycles and Red Ryder BB Guns. We spent hours, lying on that old braided living room rug, picking out the best item tailored just to our particular taste. Of course, I'm not exactly sure we were online shopping. It was more like online looking. We didn't have the money to actually order anything. We were just wishing and hoping. It was kinda like buying coconuts or fresh lettuce online today. And—regardless of the crowds, long lines and parking nightmares—we might ought to hustle downtown and browse through a few of the different stores...before they







## Did You Know?

Dreidels are especially popular during the eight-day Jewish festival of Chanukah. Even though they may seem like novelty items for children, dreidels have a rich and interesting history. In ancient times, Greek Syrians infiltrated areas where many practicing Jews resided. Over time, the Greek Syrians became more oppressive and tried to convert the Jewish people to their pagan beliefs. However, their efforts were not

very successful. As a result, the Greek Syrians established laws that outlawed ritual commandments and the study of the Torah. It is widely believed that Jewish people used dreidels to fool the Greeks into thinking they were just playing a game. Instead, rolls of the dreidel corresponded to numerical equivalents that could represent elements of the Jewish faith, according to My Jewish Learning. Others say the dreidel

Israel would learn the Torah in outlying areas and forests. When Greek patrols were nearby, the children would hide their texts and take out dreidels instead, says Chabad.org. Today the dreidel is a token of the Chanukah miracle. In Israel, the letters upon the dreidel are Nun, Gimel, Hay, and Pay, which stand for the Hebrew equivalent of "a great miracle happened here." Outside of israel, the last letter is Shin, which transforms the phrase into "a great miracle happened there."



## Wildcats Dominate All Mid-South Conference Bluegrass Football Team

All Mid-South Conference Bluegrass Division teams and individual award winners were announced by conference officials on Thursday.

Bethel's (Tenn.) Sam Castronova is the Craig Mullins MSC Bluegrass Offensive Player of the Year, while Lindsey Wilson's (Ky.) Trent Mueller is the MSC Bluegrass Defensive Player of the Year.

The individual awards and all-conference teams are selected by a vote of the Bluegrass Division's coaches. Coaches are not allowed to vote for their

own players

In addition to the players of the year, Bethel's Davius Prather is the Bluegrass Offensive Freshman of the Year and his teammate David Miller is the Bluegrass Defensive Freshman of the Year. Bethel's Brent Dearmon is the 2018 Ron Finley Bluegrass Division Coach of the Year.

Castronova leads the Mid-South with 244 yards of total offense per game as the signal caller for the top scoring offense in the country. He threw for 2.177 vards and added 263 more on the ground to amass 2,444 yards this year. Castronova completed 62.4 percent of his passes while breaking the single-season touchdown record at Bethel with 27. He also leads the MSC and is third nationally in passing efficiency (184.5).

Mueller registered 93 tackles from his linebacker position to collect his second-straight MSC Defensive Player of the Year honors. He is fourth in the MSC with 9.3 tackles per game and led the Blue Raiders in total tackles. Mueller was the anchor of a defense that allowed only 18.1 points per game, which ranked fourth in the conference

and 16th in the NAIA Prather hauled in 20 receptions for 610 yards and five touchdowns in his freshman campaign. His 67.8 receiving yards per game was sixth best in the Mid-South and best on the team. Prather was a big-play threat for the Wildcats and averaged 30.5 yards per reception.

Miller made 53 tackles from his defensive back position for the Wildcats. He registered 3.5 tackles for loss and added a fumble recovery in his first year. He is part of a secondary that is eighth in the NAIA in passing defense efficiency (96.8).

Dearmon led Bethel to a 10-0 regular season during his first vear at the helm of the Wildcats. Bethel claimed the MSC Bluegrass Divisional title and is currently ranked No. 3 in the NAIA. Dearmon helped the Wildcats beat four ranked teams this season and reach the postseason for the first time since

Thirty-one players earned first team all-conference honors and 29 were selected second team all-conference as voted on by the coaches. Ties for all-con-

ference teams were not broken. Bethel had ten players named to the 1st team and nine players named to the 2nd team.
