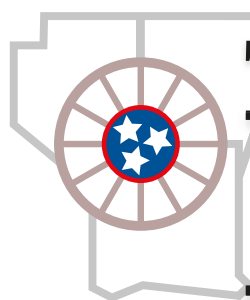

Ice-Laden Trees Cause Power Outages

The tri-county area suffered electrical power outages, mainly from ice-laden trees that fell across and severed power lines.

Andrea Harrington, an engineer with Weakley County Municipal Electric, said the system had approximately 8,500 customers out of service during various times of the day Sunday. Outages were not all

simultaneous.

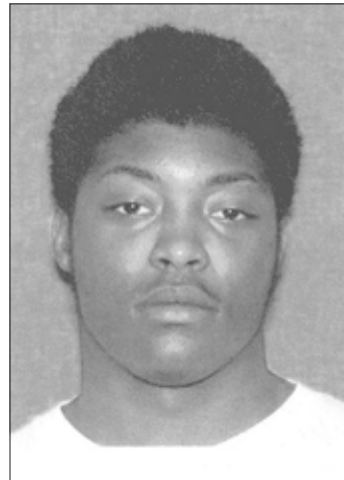
Customers starting notifying WCMES between midnight Saturday and 2 a.m. of outages. Harrington said the outages were scattered throughout the county — from the Kentucky line to Skullbone. Crewmen worked the pre-dawn hours of Sunday through the evening. Linemen were not

given any new assignments after 9:30 p.m.

Customers were notified to make other arrangements if their power was not restored by 8:30 p.m. Sunday.

The crews reported to work Monday at 6:30 a.m. to continue making repairs and

Bethel University Confers Degrees During Saturday's Commencement

McKENZIE — Despite the threat of wintry weather, hundreds of excited students, family and friends made their way to Bethel's Rosemary and Harry Crisp II Arena to cheer on the university's newest group of graduates this weekend. In his welcoming remarks, Bethel University President Walter Butler noted that 1,108 Bethel University students graduated during the 2018 calendar year. A total of 374 students from the colleges of Arts and Sciences, Professional Studies, and Health Sciences matriculated during the December commencement.

West Carroll Grants Tenure, Honors Retirees

ATWOOD (December 6) — West Carroll's Board of Education met last Thursday for their monthly session with a number of items on the agenda.

School Director Dexter Williams honored three retirees from the school system with a combined total of 114 years of education. Molly Vann taught 44 years, Betty Welch 41 years, and Wendy Wilson 29 years. Welch and Wilson were not able to attend due to other commitments. Vann was present to receive her award.

Action on purchasing a new student information system has been postponed until after the first of the year. The board approved letting bids on renovating the restrooms at the Junior High/High School building. They also approved some of the additional upgrades being proposed. S&S Alarm Systems turned in a bid totaling approximately \$20,000. A motion

to approve the bid died for lack of a second motion, however a motion to do a portion of it now and the remainder later passed. The bid was broken down into upgrading the schools alarm systems and replacing cameras. The board opted to approve replacing the cameras and do the remainder in the near future.

During the spotlight portion of the meeting, Pam Bryant was spotlighted at the Primary School for coming out of retirement on a 100-day contract and helping operate the library. West Carroll Elementary and Junior High Beta Clubs were spotlighted. These programs have existed for several years but some years they weren't very active. Several teachers stepped up wanting to revive the programs. 41 students are now members of the Beta Clubs and have recently earned 2018-2019 National Beta Club School of Distinction. Several students recently

McKenzie Rite Aid Converts to Walgreens

McKENZIE — Rite Aid in McKenzie converted to a Walgreens, following the purchase of 1,900 Rite Aid stores by Walgreens. The new signage was unveiled last Friday when the rebranded store opened after being closed approximately one week.

Roadside signage indicates the new Walgreens store, located at 14860 Highland Drive. The pharmacy portion of the store converted to Walgreens several months ago.

A letter was mailed to current customers of the Rite Aid pharmacy advising them of the

recent changes. All prescriptions are part of the Walgreens network, allowing customers to pick up their medicines at any of the 8,000-plus Walgreens across the country. Walgreens did not purchase the entire Rite Aid chain of stores.

Huntingdon School Board Visits Schools for Improvement Plan

HUNTINGDON (December 4) — School improvement and evaluation of the programs and facilities of the three school sites were part of the annual Joint Venture of the Huntingdon Special School District Board of Education on December 4.

Board members started at 7 a.m. For the regular monthly meeting at the Board office, heard from Tracy Connell, who is participating in the inaugural class of WestTeach, a program created by WestStar, based at the University of Tennessee at Martin. She thanked the board for allowing her to learn what other West Tennessee communities are doing in their schools, cities, and counties as the group tours the West Tennessee area. The resignations of Emily Smith and Lisa Todd were acknowledged. The board was acknowledged the transfer of Christy Carey to HPS principal from the assistant principal; Alan Eubanks as the supervisor in the Central Office, moving from the HPS principal position; and Nikki Fronabarger employed as the Food Service supervisor. Jennifer Briscoe was employed as HMS cafeteria manager, Victoria Dye was HPS cafeteria assistant manager, and Amanda Stockdale as a first-grade teacher. The board acknowledged the resignation of Emily Smith, assistant cafeteria manager at the primary school and Lisa Todd, a first-grade teacher.

The board also gave the statutory notice to discuss the contract of Pat Dillahunt, director of schools, during the January 17 meeting. The board also approved to allow a board member to participate in the board members via electronic communication. A quorum must be physically present and the off-site board member must be able to be heard by everyone, including the audience.

The board heard from Dr. Jonathan Kee, principal of Huntingdon High School, Scott Carter, principal of Huntingdon Middle School, and Christy Carey, principal of Huntingdon Primary School. Each of the site administrators spoke about the progress in academic achievement at the schools, the use of new technology, including the Promethean flat panel big-screen monitors in each classroom, and the newly added academic coaches to assist members of the faculty.

Dr. Kee said the entire school system was rated as an Exemplary School, one of 14 in the state. He said the high school is offering dual enrollment, dual credits with colleges, and the ability for students to earn vocational training at the TCATs in McKenzie and Paris and the Carroll County Vocational School. The school will partner with local businesses and industries to strengthen opportunities to learn vocations while still in school.

Kee said the new artificial turf on the football field is being used extensively by several of the sports teams, including track and baseball. Members of the community are also using the field for various activities. He also noted the new Band Room is under construction and will provide a large rehearsal room, an instrument room, and private rehearsal rooms.

Scott Carter said HMS was honored to be designated as a Reward School because of the across-the-board growth of achievement by the students. The school's area of focus has been in scheduling adjustments, new English Language Arts curriculum, an updated math curriculum, and lots of new technology. He noted that four of five math teachers left after last year. Curriculum coaches helped the new teachers interface quickly in their new roles.

Carey said HPS has a new phone system and a new surveillance camera system to monitor the campus. She noted the school needs about 120 iPads for K-2 grades and a larger cafeteria because each grade has approximately 107 students.

In recent years, the school system has made significant improvements to the physical plants at HHS and HPS. A new playground/gym and library was added at HPS and new classrooms and a more secure front entrance were added at HHS. Air conditioning and new seating were added at the HHS gymnasium. The 2017 season was the first for the new artificial turf and running track at HHS. A new band room is under construction. The city donated Filies Field to the school and major improvements were made to the complex.

Student Resource Officers, SROs, law enforcement safety officers, were added at each of the school sites this year, said Kee. Dr. Lee Carter, chairman of the board, said the list of the wants and needs of the school system has greatly diminished from years ago. He praised school officials from the continued progress.

In other business, the board the school calendar for the 2019-2020 year: Classes begin August 5, fall break is October 14 to 18, Thanksgiving holiday is November 27-29, and Christmas holiday is December 20 through January 3. For the second semester, students start Tuesday, January 7. Spring Break is April 6 to 10, and the last day of school is May 20.

Holidays include Labor Day, Thanksgiving, Christmas, New Year's, Martin Luther King Day, President's Day, and Good Friday, which is included in Spring Break. There are six days included for inclement weather.

After visiting all the schools, the board determined their areas of concentration will be on upgrades to the cafeterias at HPS and HHS, and upgrades to the HHS baseball press box and concession stand.




attended the Tennessee State Beta Convention and competed in a number of categories placing in the top three in several of them. 11 of these kids have qualified for the National Beta Convention in Oklahoma City. One of these is Macy Mitchell, a junior high student who placed third out of 74 entries in a singing competition.

After the spotlight portion, Mr. Blake Kee was recommended for tenure by school director Williams and unanimously approved by the board. Boardmembers then approved the first reading of a school board policy update regarding maintaining test and data security. They also approved the 2019-2020 school year calendar proposed by the Carroll County School System.

In other action, the board voted to explore using plexiglass on the baseball and softball backstops as a cheaper option to using netting or additional fencing. They approved the second reading of a proposed overnight softball trip to Columbia for a tournament the end of March 2019. They also approved the first reading of a proposed overnight trip to Chattanooga for the FBIA conference next March.

During his remarks near the end of the meeting, Director Williams brought out the banner sent to the West Carroll School System signifying they were a Reward School for the 2017-2018 school year. West Carroll was one of 11 schools who earned that distinction across the state. Williams announced the school system will receive a Read To Be Ready Grant for next summer. West Carroll's portion of

In a unanimous decision, the board voted to extension the contract to June 30, 2021. Watkins is a McKenzie native, graduate of McKenzie High School, where he played sports, and served as a teacher, assistant principal, and principal in the school system.

Five teachers were granted tenure after at least five years in the system and earning qualifying performance reviews.

Mary Spivey and Chris Wall at McKenzie Elementary School, Joseph Baumgartel at McKenzie Middle School, and Kelly Spivey and Zach Tippitt at McKenzie High School were granted tenure.

Student enrollment continues to decline. Watkins reported the current average daily membership (enrollment) is 1,230, down from the current Basic En-

rollment Plan funding of 1,298, based on last year's enrollment. Watkins said that represents a loss of 68 students. The 2019 graduating class is one of the largest in enrollment. So next year, the total overall enrollment can be down even more.

The school calendar was approved for the 2019-2020 year. Classes begin August 5, fall break is October 14 to 18, Thanksgiving holiday is November 27-29, and Christmas holiday is December 20 through January 3. For the second semester, students start Tuesday, January 7. Spring Break is April 6 to 10, and the last day of school is May 20.

were expected to have everyone's service restored by the end of the workday Monday.

Sunday morning, Henry County reported scattered outages affecting approximately 450 customers, according to updates on the Facebook page. Power was restored to customers by mid-afternoon Sunday.

# AAA: Gasoline Prices Fall

NASHVILLE (December 10, 2018) — Gas prices in Tennessee continue falling like autumn leaves. The state average has declined the past 59 consecutive days for a total of 52 cents.

Sunday's state average of \$2.17 per gallon is 7 cents less than last week, 34 cents less than last month, and 9 cents less than this time last year.

"Gas prices in Tennessee could drop another 5-8 cents this week, but should level off soon," said Mark Jenkins, spokesman, AAA - The Auto Club Group. "Pump prices are close to catching up with the recent crude price plunge. However, oil prices are beginning to increase, after OPEC announced a production cut agreement on Friday. Regardless, drivers should continue to enjoy low gas prices through the end of the year, unless oil prices suddenly spike."

Most expensive gas price averages: Nashville (\$2.28), John-

son City (\$2.28), and Clarks-ville-Hopkinsville (\$2.22).

Least expensive gas price averages: Cleveland (\$2.01), Chattanooga (\$2.01), and Knoxville (\$2.10).

During the past month and a half, the national average has declined 1-2 cents a day. Over the weekend, the national average declined fractions of a penny. Sunday's national average price of \$2.42 per gallon is 5 cents less than a week ago, almost 30 cents less than last month, and 4 cents less than this time last year. The national average has declined 60 consecutive days for a total discount of 49 cents.

Oil Prices Edge Higher on OPEC Production Cut Agreement

At the close of Friday's formal trading session on the NYMEX, WTI increased \$1.12 to settle at \$52.61 per barrel. Oil prices rallied Friday after the Organization for Petroleum Exporting Countries (OPEC) announced that beginning in January 2019, the cartel - alongside non-OPEC members,

including Russia - will reduce combined crude oil production by 1.2 million b/d. The cut will be in place for six months and will use October 2018 as a baseline, a time when OPEC and Russia had less crude output than in November. With the announcement, crude prices will likely increase in 2019 ahead of the higher demand driving season next summer. Increased crude prices will likely lead to higher gas prices, given that approximately 50 percent of the cost motorists pay at the pump is based on the cost of crude used to make gasoline.

In related news, EIA's report for the week ending on November 30 revealed that crude inventories decreased by 7.3 million bbl after 10 weeks of consecutive growth. Total domestic crude inventories now sit at 443.2 million bbl, which is approximately 5 million bbl less than their level at this time last year. Declining inventories contributed to the increase in crude prices this week, and if the trend continues, prices could climb further.

They were polite, seemed sympathetic to our plight but you couldn't dynamite them away from their "catastrophic weather" excuse.

It must be tough being a major category hurricane. There are new insurance rules, costs and requirements, stricter building codes and more government planning oversight today.....all still being blamed on Hurricane Andrew...which blew ashore in the last century for goodness sakes!

The TV hasn't been a big loss...except for missing the SEC championship game. But the DVD player works, and I've got the complete "Rawhide" series and the Burt Lancaster movie, "Valdez Is Coming".

No phone has actually been a bit of a blessing. I haven't been asked to give a talk or explain to Judy from Time-Life why I'm not interested in Rock and Roll's Golden Hits from the 1950's. She doesn't remember one song from the whole packet—and I can't get them to stop bouncing around in my head.

Up to date information is another matter. We've grown accustomed to instant news via the various internet feeds. MSN, Facebook, instant messages, etc., keep us in the loop as to births, deaths, ball scores, shoot outs, Mexican border crossings, Thanksgiving Day parades, congressional boondoggling and the most up to date pictures of Traci Gaddis's

grandchildren.

This cable loss reminds me of the old days when the morning newspaper was everyone's window to the world. It wasn't instant. It was always one day behind but it was the best we had growing up in the decade that Judy from Time-Life has only read about in history books.

My first ever "remembrance" of a newspaper was courtesy of the Commercial Appeal out of Memphis. Mom laid the front section on the kitchen table as she prepared breakfast. In the largest bold-est print you could imagine, the headlines declared "Eisenhower!" It was the first Wednesday after the first Monday in November, 1952. I would have been five years old. And I couldn't have actually read the story underneath if I had been a mind to, which I wasn't.

Politics were not my thing, then—or now. But let me tell you, they had comics in the Commercial Appeal! We called it the "funny papers." By the time Miss Belle promoted me to the Blue Bird reading class I was keeping up with Dick Tracy, Little Orphan Annie, Mary Worth, Mark Trail, Beetle Bailey and I was comparing Leon to Dennis the Menace.

It wasn't required reading...which made it the best of all.

We'd pour over the sports pages, reading every article. Its how I learned about Roger Bannister running a four minute mile; and the perfect game Don Larsen pitched in the 1956 World Series. I remember a grainy, black and white picture of Arnold Palmer hitting out of a bunker in the 1958 Masters like it was yesterday. And this was years before I ever held a golf club in my hand.

We got the Nashville Banner in the afternoon. They had a great sports editor named Fred Russell. He'd write on the comings and goings of the major sports figures of the era. He knew them all, from Babe Ruth to the Say Hey Kid! I read his every byline religiously. It was a loyalty that is near 'bout non-existent in today's instant media whirl.

And that is kinda sad. We get bombarded from so many directions with so much stuff...that we don't slow down enough to appreciate what anyone is saying, or trying to say, to anyone else.

It may not be as much about miss communication as it is about mass communication.

I fear print newspapers are going the way of the dinosaur, jukeboxes and telephone booths. That too, is sad. They bespeak of a slower time, maybe a gentler time...a less hectic time for sure. Folks would read a story and chew on it, digest it, ponder its relevance and discuss it with a neighbor. News wasn't so polarized or sensationalized and you weren't considered "unhip" if you paused to let a moment sink in before hitting the refresh button.

Surely, a little slower pace and a more reflective attitude couldn't be all that bad. But I don't have time to dwell on it this morning. I'm calling my cable company again! I'm demanding they fix this problem and get me back "on line." Right now! This instance!

# Easy as Pie

I was driving along the other day listening to a compilation of 1940s hits when the smooth, slightly Southern sound of Tennessee's own Dinah Shore came charmingly out of the speakers:

Shoofly pie and apple pandowdy  
Make your eyes light up,  
Your tummy say howdy.  
Hard to believe that a song about a dessert, actually two of them, could ever even get recorded, let alone become a hit record, but "Shoofly Pie" did, in spite of the fact that not a lot of people knew exactly what either one of those desserts was.

Today they sure don't know, although the Internet has recipes galore for each. There are also thousands of recipes for all sorts of other esoteric baked desserts - sweet treats like cobblers and crisps and crumbles. And grunts and slumps and brown Bettys.

Oh, and buckles. I forgot about buckles.

The pastry driven dessert list goes on and on and on, with many of the entries regional and sometimes even local, and for most of them there is no consensus whatsoever as to the proper recipe, and in some cases, not even the proper name of the dessert.

But whatever they call them, Americans have been eating sweet fruit pastries ever since the first settlers discovered how well sweet English apple varieties they brought with them thrived in the New World.

Think about cobblers, for example. Is that a cherry cobbler or cherry pie? Everybody pretty much agrees that a cobbler is a dish of sweet baked fruit, but what about the topping? Food historians and sticklers for accuracy say

cobblers are baked fruit desserts covered with a biscuit topping dropped onto the fruit in small mounds, giving the finished product the appearance of a cobbled road, hence the name.

So some people say. They say that if the baked fruit dessert is topped with a pastry crust, regardless of the shape of its pan, then technically it isn't a cobbler, it's a pie.

Which, by the way, is usually how cobblers are made in the South, with a pastry, rather than a biscuit top. Our Northern cousins make their cobblers with small biscuit like dumplings tucked into the fruit, and I hate to say it, but they may have something on us there. But cobblers are just one of many variations of fruit desserts that are famous somewhere in America. What about Miss Dinah's pandowdy? It is a dessert, usually, but not always, made of apples sweetened with brown sugar and molasses, and it seems to be a cousin to a cobbler. With a pandowdy you start with a topping of rolled piecrust, but during baking you break it apart and push it down into the fruit so the juices rise through it. This process of breaking up the piecrust to let the fruit bubble up through it is called dowsing. There you go.

Which brings us to crisps and crumbles. Apple crisp anyone? Maybe, but what is it?

Both crisps and crumbles are fruit-based desserts with a crumbly streusel topping of flour, butter and sugar, baked until crisp. The difference in the two, if there is one, is that crisps have oats in their toppings as well. Crumbles do not.

An apple brown Betty, one of Ronald Reagan's favorite desserts, is similar to a crisp, but with a Betty the fruit is layered with bread crumbs, or even cubes, making it denser than crumbles and crisps.

Not all fruit desserts are baked in ovens. Some are covered and cooked on top of the stove. Grunts and slumps fall into this category.

Not such great names, huh? That may be why they are almost totally forgotten. Sort of Americanized British steamed puddings, consisting of fruits stewed on top of the stove then topped with biscuit dough or batter and covered until the dough is steamed into dumplings which "slump" into the fruit filling as it cooks. As the fruit bubbles through the top, some people think it makes a grunting noise. The only difference in the two seems to be that slumps are inverted before serving. The final result of either looks sort of like a cobbler's down and out cousin.

Now if none of these charmingly named offerings entice you, perhaps you'd be tempted by a buckle. A buckle has a layer of cakey batter underneath the fruit, with a crumb topping as well. As it bakes the cake rises around the fruit which causes the whole desert to buckle inward. Once there were only blueberry buckles, but now there are all kinds. And finally, "shoofly pie." It's a Pennsylvania Dutch creation that is similar to a pecan pie without pecans. Sort of a crumb topped molasses pudding in a crust. Not a fruit pie at all.

All of these desserts are children of both necessity and invention, and sometimes, just opportunity. Mostly they aren't too pretty, but usually taste delicious and often have the added cachet of being part of our American pioneer heritage. But such creations can also be brand-new. Just last week I visited the dessert table at a restaurant buffet and spied some sort of cobbler-like concoction covered with miniature honey buns submerged halfway into the filling.

"That looks horrible," I said to myself, "but I bet it tastes great." Alas, it did. Both helpings.

Carroll County Solid Waste Committee Approves Alternate Payment Method

HUNTINGDON (December 6) — Residents of Carroll County might soon have the convenience of paying for their solid waste collection billing via credit card and bank draft. The county's Solid Waste Committee voted to send the proposal to the full Carroll County Commission for consideration. If approved, customers of the curbside solid waste collection can pay their monthly invoice by cash, check, bank draft or credit card, the latter would incur

a convenience fee of approximately 2.75 percent. Presently, customers only have the options of cash or check. Jeff Heyduck, director of Solid Waste and Recycling, said it would take several months to implement after final approval. He suggested a July 1, 2019 start date. In other business, the committee heard Republic Services, the current vendor, will provide a price quote to provide curbside collection services for a five- and seven-year period. Heyduck said he met with Chad Brown of McKenzie, who represents Republic Services. The quote is expect-

ed in the coming weeks from Brown. Heyduck said if the price comes in much higher, then the county might seek additional quotes from other vendors. Carroll County has mandatory rural curbside residential solid waste collection. Collection trucks serve each household weekly and the company provides a rolling cart to each residence for their convenience. For seven years, the monthly charge to customers has been \$18. The Committee will convene again in early 2019 to review the quote from Republic Services.






