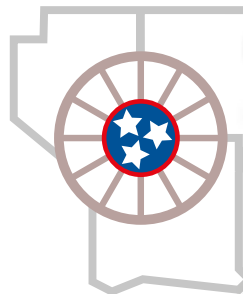

Local Man Murdered in Gallatin

GALLATIN (December 16) — Gallatin police have arrested three people in connection with a deadly shooting that took place on the night of December 15 on South Maple St. in Gallatin. Police say they suspect the incident was a drug deal that turned into a robbery, according to the newspaper Gallatin News.

Kevin Ronald Green, 21, a 2016 graduate of McKenzie High

School, was killed in the incident. He played football at MHS and was the son of Tawanna Green. Funeral services were Saturday, December 22 at New Reedy creek Baptist Church in McLemoresville.

Andre D. Gillespie has been charged with criminal homicide, possession of a firearm by a convicted felon, tampering with evidence, possession of

schedule VI drug for resale and possession of drug paraphernalia.

Two additional suspects, Nakhia Rogan and Paris Kesinger, have both been charged with accessory after the fact (homicide), tampering with evidence, possession of schedule VI drug for resale and possession of drug paraphernalia.

Year in Review 2018

The year of 2018 was an eventful year for the area. Listed below are a few of the stories The Banner chose to highlight. The stories are not necessarily in order.

McKenzie Regional Hospital Closes

McKenzie Regional Hospital (MRH) closed September 15, 2018. The 45-bed hospital. Baptist purchased the ambulance services and will operate as Carroll County Ambulance, which will be managed by Priority Ambulance. An ambulance base and helipad will remain in McKenzie. The closure displaced 200 employees.

Huntingdon Approves Retail Package Liquor

Huntingdon's retail package store referendum passed by a vote of 863 – 546. That's

a margin of 61 percent for to nearly 39 percent against the referendum.

New Carroll County Mayor

Joseph Butler, 32, of Huntingdon was elected mayor of Carroll County during the August general election. He became the youngest serving mayor in Tennessee with his election. Butler unseated Kenny McBride, who served 20 years. The new mayor is the son of former county mayor Walter Butler.

ZLINE Kitchen and Bath To Locate in Bruceton

The kitchen range and hood manufacturer and distributor will create 74 new jobs and invest \$3 million in Carroll County in

Carroll County Electric Employees Receive Pay Raise

HUNTINGDON (December 27) — Beginning in January, employees of the Carroll County Electric Department will receive a 2.2 percent increase in their work pay. The cost of living adjustment was approved by the department's board of directors.

Danny Brawner, department manager, said cost of living increase was calculated at 2.2 percent during 2018.

In reports, Brawner said the department now has a work crew and the necessary equipment to make splices to the system's fiber optic cables. The machine is a state-of-the-art in splicing fiber, said Brawner. The crew has been practicing making repairs and recently made a live repair on fiber damaged by a contracting crew.

Equipment is now arriving for the installation of all new smart electric meters at every customers' location in the county. The AMI project will begin in early 2019 with an estimated completion date of August or September. Once complete, the meters will report electrical consumption via electronic means, eliminating the need for monthly readings by human meter readers. The department accrued the funds for the multi-million dollar project after retiring all of its long-term debt.

The next meeting of the board is January 31, 2:30 p.m. in the board office in Huntingdon.

Carroll County's Unemployment Rate Drops

NASHVILLE — Each of Tennessee's 95 counties experienced lower unemployment in November 2018 according to newly released data from the Tennessee Department of Labor and Workforce Development (TDLWD).

Ninety-one counties had an unemployment rate of 5 percent or lower during the month and only four counties had a rate higher than 5 percent.

Carroll County reported a labor force of 12,030 with 11,480 employed and 550 unemployed. The November 2018 rate was 4.6 percent, down from 5.4 percent one month earlier and higher than 4.3 percent one year earlier.

The December 2008 statistics – amid the latest recession, the November 2018 county statistics indicate there are 2,000 fewer persons in the county's labor force and 900 fewer jobs today than in 2008.

With the November 2018 rate of 4.6 percent, Carroll moves out of the 10 counties with the highest unemployment rate.

Henry County reported 14,170 in the labor force in November with 13,610 employed and 560 unemployed. The unemployment rate is 3.9 percent, down from 4.7 one month earlier and equal to one year earlier.

Weakley County reported a labor force of 16,230 in November with 15,600 employed and 630

Budget Committee Approves Security Updates for Circuit Court Office

HUNTINGDON (December 28) — New bulletproof glass and door will be installed at the Carroll County Circuit Court office following budgetary approval by the county's Budget Committee.

Sarah Bradberry, Circuit Court Clerk, requested a local match of \$3,200 for the \$32,000 security enhancement project, which includes a camera to monitor the hallway

and bulletproof glass and door for inside the office to protect the personnel. A state grant of \$28,800 was awarded to the county for the project. Bradberry said she requested the grant funding within days of taking office in September.

The county will pay the entire \$32,000 and be reimbursed \$28,800 upon completion.

County Mayor Joseph Butler said the county received a state grant of \$35,000 to fund the entire cost of the a person to oversee the Prevention Coalition. The purpose of the program is to help those people in need

and to prevent residents from using addictive substances. If the funding ceases, the program does as well, said Butler. The Committee approved establishing the program. The director will be housed at the Carroll County Technical School to eliminate any cost of office space.

Sheriff Andy Dickson, Chief Deputy David Bunn, Butler, and Lisa Norris serve on the Prevention Coalition.

Tennessee Releases New State Report Card

NASHVILLE (December 4) — Education Commissioner Candice McQueen recently released the new, redesigned state report card for 2017-18. This tool was developed over the past year with educators, parents and community organizations and includes a number of new features based on that feedback, including school ratings, a Spanish translation of the site and additional new data about the performance of different student groups.

The new report card is intended to help families better understand school performance and support student success. The updated design of the report card and information that is included in the tool,

including the new rating system, is based on input the department received as it developed a plan to transition to the new federal K-12 education law, the Every Student Succeeds Act, and has several components that are unique to Tennessee.

“We want families to have easy access to information about their school’s performance and how it is meeting the needs of all students, and we want them to have that context on a variety of metrics that encompass success,” Commissioner McQueen said. “The report card provides parents and community members with an additional snapshot of information to understand how their school

is performing, see successes, and know where to ask questions and get engaged.”

While the department has published a state report card for a number of years, the redesigned version includes a number of updates. For the first time, the report card provides schools with ratings on up to six indicators designated in Tennessee Succeeds, the state’s ESSA plan. These indicators capture different aspects of school performance and include academic achievement, academic growth, chronic absenteeism, progress on English language proficiency and graduation rate. The report card also includes a new measure called the Ready

Graduate indicator that that looks for students’ readiness for college and career to let families know how students are being prepared for life after graduation.

The rating system provides a score of 0.0 to 4.0 on each indicator, similar to a GPA, with 4.0 being the highest. Parents can click through to see more information behind each rating, including how both the full student population and different student groups are performing. Ratings are based either on how well the school is doing overall or how much it improved over the last year; the school receives the higher of the two. The department has shared more information about the rating system and indicators, as well as context on how schools were rated in 2017-18, at [tn.gov/content/dam/tn/education/rpt-crd/](http://tn.gov/content/dam/tn/education/rpt-crd/report_card_ratings.pdf)

Additional new features include a new full Spanish translation of the website, an opportunity for principals and superintendents to share messages about their schools, and a wealth of new metrics, including new details on the performance of different student groups and new data in areas like discipline and attendance. The department will continue to update and improve this tool in future years as it receives additional feedback, which families can share via the report card home page. 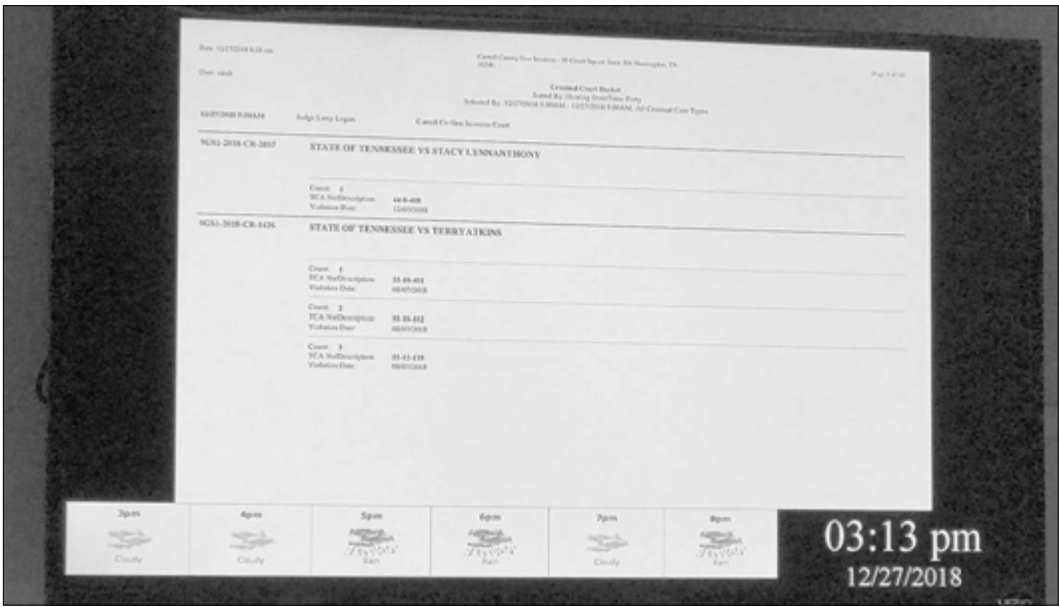

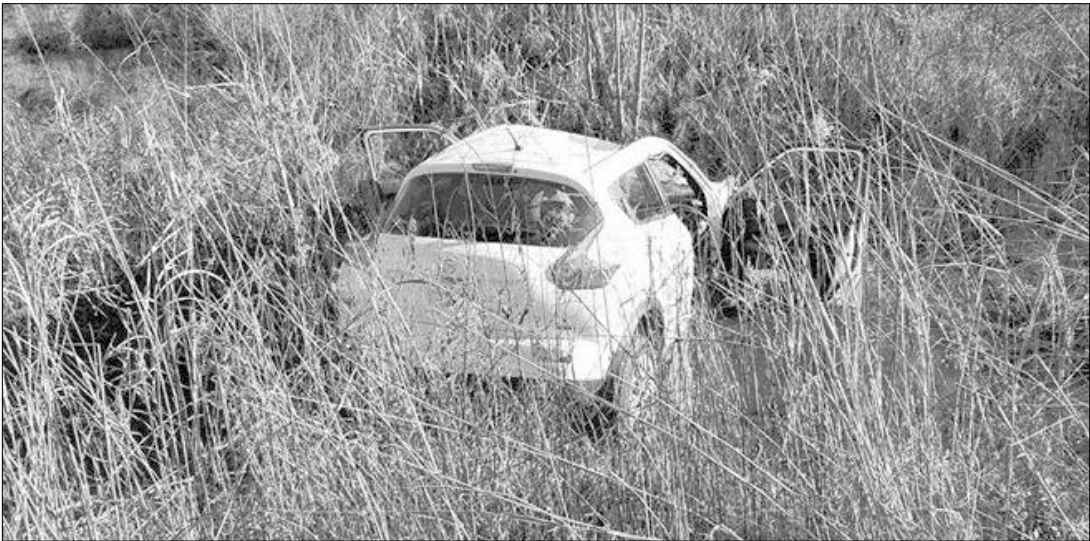
Hallway Video Monitor Informs Court Visitors

Paris Landing Inn Being Razed

BUCHANAN — Workers have made significant progress in the demolition of the Paris Landing Inn since work began in mid-November. The main lobby area is now down and the frame of the portion that contained the hotel rooms is

still standing, but much of the interior and windows has been removed and/or salvaged from that section. Workers began dismantling the building beginning at the back of the building. New Park Manager Zach Tinkle said all the furniture and other

items were removed from the facility before demolition began and have been given to other parks in the state. The Inn will be replaced by a more modern, but smaller facility. State officials estimate the new Inn will be completed in 2020.

McKenzie Walkers Report 65,670 Miles

This is the end of the fifth year of the “McKenzie Walks” program, and it continues to be successful in terms of the health benefits derived from regular walking. Forty-eight persons are registered walkers in addition to over 250 school walkers, group walkers, bikers, treadmill walkers and gym exercisers. The program finished 2018 by recording 65,670 miles as McKenzie walkers continue to set a good example for its neighbors in other cities within Carroll County.

Some individual performances include two walkers who actually walked 1295 miles, 1 over 1000 miles, 16 over 500 miles, 7 over 300 miles, and 15 over 100 miles.

There is no deadline for joining and “Mileage Recording Forms” are available at the drop-off box located in the lobby of city hall, if you choose to report your mileage in that manner. The main purpose is to get moving so we can get in shape. We have had several success stories reported by our walkers who are enjoying the benefits of a higher level of fitness.

Since this program is a friendly competition with the other cities and based on the honor system, we will honor your pledged mileage. All you have to do is give us an estimate of how many miles you think you will walk per day, week or month and we will record it for

you. By simply reporting your mileage, you can get involved and help us in the friendly competition with the other cities in Carroll County.

The program is still looking for additional walkers. Anyone interested simply has to report his or her miles to Garlon Prewitt at his new e-mail (garlonprewitt@gmail.com) or drop off a note in the box located on the table in the lobby of City Hall. It is never too late to start walking.

County Mayor Butler is not accepting the \$15,000 annual appropriation budgeted to the Purchasing Agent position. In the recent past, the county mayor has accepted his salary plus the \$15,000. Butler said he did not feel it is appropriate to take the \$15,000 in addition to his salary. He floated the idea of possibly equally splitting the funds to two employees who work in budgeting and accounting in the Mayor's Office. After significant discussion, Budget Committee members chose to not act on the matter. They expressed concerns

of a backlash from other county employees.

Commissioner Joel Washburn, who does not sit on the Budget Committee, addressed committee members and asked for quarterly updates on the budget instead of one-time, year-end massive adjustments. Washburn also requested committee members to require periodic updates from the county's economic development board, including specific actions and budgetary expenditures. The county appropriates the funds to the Carroll County Chamber of Commerce to administer economic development projects. No action was taken on the matter since the board had already adjourned.

Shooting Leaves One Dead

WEAKLEY COUNTY — A McKenzie man is dead after he was shot breaking into an apartment near the Carroll-Weakley County line on Thursday, March 15. The incident occurred on State Highway 124, just outside of McKenzie.

Weakley Co. Sheriff's Captain Randall McGowan said Terry Lee Haynes of McKenzie was shot after he broke into an apartment by kicking in a sliding glass door and confronting the resident in the bedroom of the apartment. Haynes died at the scene.

McGowan said the sheriff's office was called to the scene around 11:15 p.m. by dispatch, which had received several 911 calls about shots fired.

The resident, Reggie Milam, age 27, and a woman in the apartment, April Garner, age 37, were both questioned by sheriff's investigators, McGowan said. Milam was cleared of any wrongdoing in the incident.

HUNTINGDON (February 15) — Huntingdon seniors in the Class of 2019 and later can choose whether they graduate in

McKENZIE (March 5) — Students arrived Monday morning to McKenzie High School to beeped up security after a week-end threat on Facebook.

Lynn Watkins, director of schools, said one person posted that another student was bringing a weapon to school on Monday. Watkins said school officials decided to scan every student entering the building with a handheld metal detector wand. Two extra deputies- one at each the front and rear of the school added an extra level of security. Nothing was found, said Watkins. The student, who was a minor, was questioned. Watkins said the school conducts periodic, unannounced check.

Autopsy Reveals Buena Vista Man Died From Blood Loss

BUENA VISTA — A Buena Vista man died from the loss of blood, according to an autopsy report. Carroll County Sheriff Andy Dickson said Steven Hampton, 38, of 1845 Ball Creek Road, Buena Vista probably fell through a plate glass window at his rural residence, where he had no phone, no vehicle, and no running water because of a plumbing issue.

Hampton's mom and brother appeared at the Sheriff's Department on March 23, 12:38 p.m. to report they went to Steven's house, where they found the front rooms of the house strewn and blood in a few back rooms.

Officers of the Carroll County Sheriff's Department and the Tennessee Bureau of Investigation investigated. Hampton's body was found behind the house near a shallow ditch. He had sustained some lacerations and a deep cut to his calf area, where a vein was severed.

The last time he was seen was about six days earlier when a handyman friend dropped some plumbing supplies at his home and gave him a ride and then returned him to his home.

Captain Phillip Kemper of the Jackson Police Department and Investigator Brad Oliver of the Gibson County Sheriff's Department led the seminar and provided information to better protect against armed or other intruders.

150 Animals Removed From Atwood House After Warrant Served

ATWOOD — Animal Rescue Corps (ARC) assisted the Carroll County Sheriff's Office in April in the rescue of approximately 150 animals of various species, found living in extremely neglectful conditions on a property in Atwood, Tenn. All of the animals were seized by the Carroll County Sheriff's Office.

Scotlund Haisley, president and founder of Animal Rescue Corps, said all of the seized animals were either dead or in various stages of dying. ARC, Carroll County Sheriff's Department, and the Redemption Road Rescue

worked to assess the status of each animal, and transport the living animals to rescue centers.

Approximately 43 large and medium breed dogs, including puppies, 37 cats, including litters of newborn kittens, 17 rabbits, 10 geese, eight chickens, six ducks, six goats, five sheep, five chinchillas, four ferrets, and two alpacas were found without adequate food or water. Several dead animals were found around the property including a zebra, a cat, a duck, and the remains of rabbits. There were live animals and dead animals in the same cage. Animals were found running loose and in cages around the property, inside a barn, and in the property owner's house and garage. The animals were all extremely dirty and suffering from heavy infestations of internal and external parasites, broken bones, extreme matting, eye and ear infections, and respiratory issues caused by the extremely high ammonia levels inside the house and garage which was among the highest ARC has ever recorded, according to a news release from ARC. Many of the animals were suffering from malnutrition and no food for the animals was found on the property.



AAA: Most of Tennessee's Gas Stations are Below \$2 a Gallon

New Year's Day Gas Prices to Hit 3-Year Low

NASHVILLE (December 28, 2018) — The plunge at the pump continues this week, and now gas prices are poised to have their lowest start to the New Year since January 1, 2016.

Americans are finding gas prices below \$2 a gallon at 31 percent of filling stations in the United States. Since mid-October, the national average has plummeted a total of 61 cents. Thursday's average price of \$2.29 per gallon is the lowest since July 2017.

"Falling gas prices continue to be 'the gift that keeps giving' this holiday season," said Mark Jenkins, spokesman, AAA - The Auto Club Group. "Prices at the pump declined as AAA projected last week, largely due to weakness in the stock market and concerns about global crude oversupply. Although oil and gasoline futures have been on a rollercoaster ride this week, wholesale gas prices have held steady. Unless oil prices suddenly spike, prices at the pump should remain low through the end of the year."

Drivers in Tennessee can now find gas prices below \$2 a gallon at about 63 percent of gas stations throughout

the state. Gas prices in Tennessee averaged \$2.03 per gallon on Thursday, after declining 6 cents in the past week. Since mid-October, the state average has declined a total of 65 cents. Tennessee motorists are now paying about 70 cents per gallon less than they did in May, and 22 cents per gallon less than this time last year.

Thursday's state average price of \$2.03 is the lowest daily average price since July 2017. It's possible the state average could dip below \$2 a gallon before the new year. The last time Tennessee gas prices averaged below \$2 per gallon was on July 6, 2017. During that time, crude oil was trading at around the same price as it is right now (\$45 per barrel).

Of course, the very next night, you stand on a moon lit front porch in the unimaginable embarrassing "silence of eternity" as Billie Jean Barham answered with a semi-polite "no" to your sincerest request to take her to the prom — it's a memory that won't let go no matter how earnestly one tries to erase it!

As you grow older you realize every year counts. And sometimes the memories now... are better than when you made them.

And the best ones are very personal. Mr. Ed Wiley was our city clerk. He was quiet, unpretentious, honest to a fault, taught my Sunday School Class for years and reminded me of Jimmy Stewart in "It's a Wonderful Life." He was simply the best person I knew growing up.

And that's a memory Time Magazine, in all its glory, could never capture.

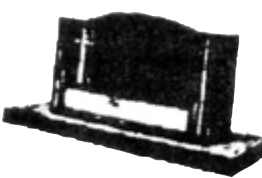

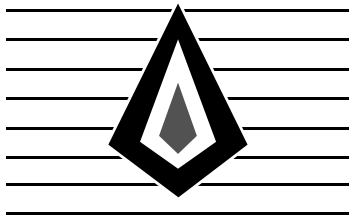

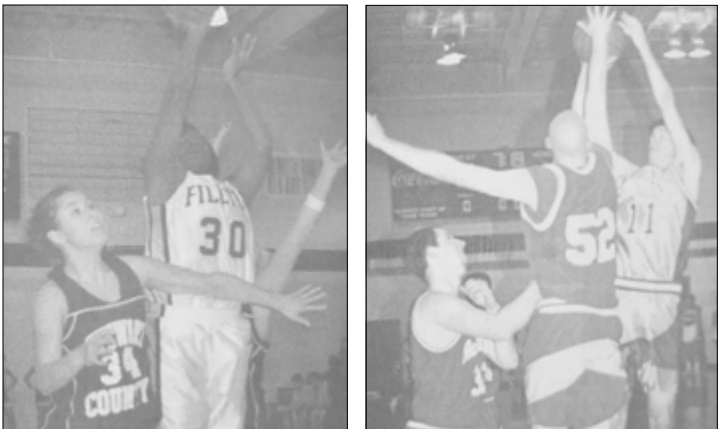

McKenzie Police Reports

Aggravated Assault/Domestic Assault — McKenzie Police received a call Friday evening, December 21, from Jessica R. Curtis, of McKenzie, who told police she had just been assaulted by Terrance Roy, also of McKenzie, at her Walnut Circle residence.

As officers responded to the call, Curtis notified police that he had left in a white Nissan pickup truck likely headed for his Park Cove residence. Officers did locate Roy in his truck in front of his residence and asked him what happened. He responded that he went over to Ms. Curtis's residence to get some "groceries" and she got ill about it. Roy was told to stay at his home while they questioned Curtis.

Curtis told police that Mr. Roy was sitting in her driveway when she came home and was wanting "groceries" from her. She stated that she went inside and got him something to eat and brought it back out at which time Roy said it wasn't enough and became ill with her. They started arguing and he grabbed her throat and slapped her and hit her in the head with his cane.

According to the report filed by Officer Mark Boaz, Ms. Curtis had a busted lip and scratch marks under her chin and on her throat as well as a knot on her forehead. She also had injuries on two fingers and her thumb.

Officers returned to Roy's residence and arrested him on charges of aggravated assault and domestic assault and was transported to Carroll County Jail under \$5,000 bond.

Criminal Simulation — On December 24, Officer Billy King responded to McDonald's and recovered a counterfeit \$10 bill. Jessica Watne, an employee, stated that the bill was passed the previous evening and they have no knowledge of who passed it.

Drug Paraphernalia — On Thursday, December 20, Officer Jeff Winberry and Officer Billy King responded to a possible domestic assault call at a residence on Hwy 22 South. According to Winberry's report they smelled what they believed to be marijuana in the residence and conducted a search. The search turned up several grinders and a digital scale. The resident, Jarrett Houston of McKenzie admitted to smoking what marijuana he had before the officers arrived. Houston was cited in to Carroll County General Sessions Court for possession of drug paraphernalia.

Domestic Assault — A juvenile contacted police and reported that he had been assaulted by his uncle shortly after midnight on

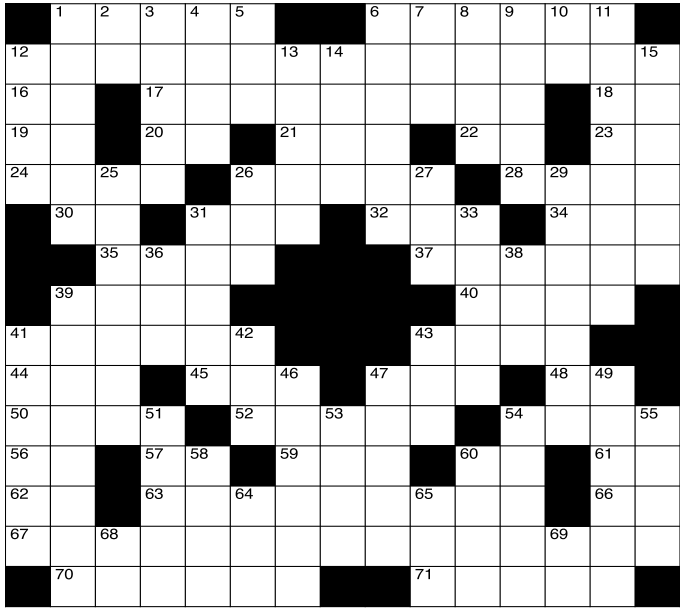
