Kapeller's Tae Kwon Do/MMA

Over the last two decades, hundreds of children and adults have acquired valuable life skills, including discipline and self-defense, at Kapeller's Tae Kwon Do in McKenzie.

Arthur Kapeller first opened the studio in October 1998 in the McKenzie Shopping Plaza before purchasing the current location on Cedar Street from businessman Earl Pace.

Kapeller was born in New York and raised in west Texas. His family moved to Carroll County when he was 13, and he graduated from Trezevant High School in 1981. His wife, Lisa, is a Trezevant native. They have two adult sons and one granddaughter.

The Army veteran has practiced martial arts since childhood, and as an adult, his family trained together in Milan and earned their black belts.

Kapellers offers several

wide-ranging programs. The After-School Program runs from 3-5 p.m. weekdays. Pupils from Kindergarten through eighth grade gather at the studio for training and to do homework. They also play games and are provided snacks. Karate Kids meets at 5:30 p.m. on Monday, Tuesday, Thursday and Friday for 45 minutes and is open to kids ages five through 12. The Young Adult class serves ages 13-29 from 6:15-7 p.m. on Monday, Tuesday and Thursday and is a more aggressive, physical program.

The Adult 30+ class meets from 7-7:45 p.m. on Monday, Tuesday and Thursday. Kapeller describes this program as more of a workout than martial arts. In total, the four classes currently have approximately 50 students.

Kapeller's teaching includes a plethora of elements. He utilizes all traditional weapons, including those originating from Korea, the Philippines, Thailand, Japan and China.

Styles of ground fighting include Brazilian Jiu-jitsu, Rus-

sian Sambo, Gene LeBell-style wrestling, old-style wrestling and kickboxing.

Kapeller's had an MMA team from 2006 to 2009, earning numerous wins and accolades around West Tennessee and beyond. In fact, Kapeller's was the first MMA school in northwest Tennessee.

A member of the Elite Martial Arts Coalition, Kapeller is a Level I MMA instructor and a sixth-degree black belt in Tae Kwon Do. He was the 1997 World Champion in Tae Kwon Do.

Kapeller is assisted by one other certified instructor, Jacob Cruse, a fourth-degree black belt. Another student is currently in the process of earning instructor certification.

Kapeller's demo team will perform at the Park Theatre on Wednesday, March 20 at 6 p.m. at the Park Theatre. There will be skits on self-defense and bullying as well as board-breaking and weapons forms demonstration.

Preparedness is Key in Severe Weather Awareness Week

NASHVILLE — Tennessee's Severe Weather Awareness Week is Feb. 25 to Mar. 3, 2018, and the Tennessee Emergency Management Agency (TEMA) and Tennessee's National Weather Service (NWS) offices are using this week to promote preparedness to Tennesseans.

"Severe weather can occur at any time in Tennessee," said TEMA Director Patrick Sheehan. "TEMA wants Tennesseans and our state's visitors to understand severe weather hazards, and prepare themselves and their loved ones to receive and understand warnings, and get to safety, when

severe weather threatens."

"Now is the time to think about what your actions will be in the event severe weather including tornadoes and floods impacts you," said Krissy Hurley, warning coordination meteorologist at NWS Nashville. "Our last few severe weather seasons have been relatively quiet, so we definitely don't want Tennesseans to become complacent thinking that severe weather won't happen to them. It's not if severe weather will strike; it's merely a matter of when."

A highlight of the week was a statewide tornado drill NWS

conducted at 9:30 a.m., Central, on Wed., Feb. 28, 2018. The drill will also include a statewide test of NOAA weather radios.

Be Ready, Make a Plan, Have a Kit A key message of Severe Weather Awareness Week is to help Tennesseans understand the importance of having emergency plans in place before a flood, tornado, or other threat is imminent.

"The most important preparedness tip is to stay informed to its potential," Sheehan said. "At home, at work, or in your vehicle, have multiple ways to receive weather information and

warnings: keep a battery-operated NOAA Weather Radio at home; watch TV and listen to the radio for weather updates; and download applications that push weather information to mobile devices."

Other severe weather awareness tips and resources include: Never venture into high water, either on foot or in a vehicle. If you're outside and hear thunder, go indoors immediately.

Go to a basement or an innermost, first floor room in your home if you're told to take shelter during a tornado warning. Know the location of and route

to your office or building's tornado shelter.

Never try to outrun a tornado. Have an emergency plan ready at places where your family spends time – work, school, daycare, commuting and outdoor events.

Emergency plans should include where to meet, and who family members should check in with, if you are separated from family members during a severe weather emergency.

At a minimum, emergency preparedness kits should include one gallon of water per day, per-person, and per-pet, for

three to five days. The kit should also have enough non-perishable food for each family member, and pets, for three to five days.

Other items that every kit should include: flashlight, battery-powered radio, extra batteries, first aid kit, personal hygiene items, cell phone charger or solar charger, and copies of important family documents.

It is also very important that emergency kits contain extra supplies of medications, especially for those in the household with chronic health conditions.

Those events included the tragic fire that took the lives of three recent West Carroll alumni and a wreck in McLemoresville that left five Carroll County teens injured. It was noted West Carroll graduates worked the fire that took the lives of Ashley Barlow, Dakota Cook, and Caitlin Cook earlier this month.

So last Monday night, a dinner themed "West Carroll Gives Back" was held at West Carroll Jr./Sr. High School Cafeteria with approximately 125-150 attending. Several first responder groups were represented including the Carroll County Sheriff's Department. Sheriff Andy Dickson with several deputies attended, members of different Carroll County

Fire Departments attended, Atwood Fire Department, Baptist Hospital EMS, Carroll County Rescue Squad, Carroll County Emergency Management Agency, Vanderbilt Life Flight and Air Evac helicopters literally dropped in for dinner, and members of the Tennessee Highway Patrol.

Principal Tim Stratton welcomed everyone to the dinner that was catered by Hot Daddy's Barbeque and Cajun Bistro. Stratton said, "This is a meal to honor those who give their lives, their time and sacrifice to others. We hope to make this an annual event."

West Carroll School Board Chairman William Robinson also spoke and told the first responders, "We really appreciate what you do for our community." Approximately 30 West Carroll students from several of the school groups and clubs came and assisted as servers for the event.

As people were finishing their dinners, McLemoresville Mayor

Phil Williams spoke to the crowd, "I always enjoy seeing our three communities come together like this for a good cause." He read "The Fireman's Prayer" and told first responders it applied to all of them.

homes. She said there might be damage that is unreported. She said the county was spared as compared to some area counties. She noted February 25 was the beginning of Severe Weather Awareness Week.

Carroll County road supervisors were pleased the county was mostly spared from significant damage to the rural roads. Ricky Scott said Sykes Road, Dollar Road, and Pond Branch were still closed Monday. Other roads that had shoulder damage were Terry, Cedar Grove, Buena Vista, and roads in Clarksburg and Westport.

Road Supervisor Scotty Bailey said several roads were under water for a period but were reopened. Those were Fire Tower,

Cotton Creek, Old Rice, Ephesus Church, Briar Creek, and Paris Road. Cotton Creek and Old Bruceton roads were still closed Monday.

Three west Tennessee counties were declared in a state of emergency on Saturday. Those were: Decatur, Hardin, and McNairy. Decaturville and Savannah reported extreme high waters inside homes as the Tennessee River flooded. In Middle Tennessee, the counties included: VanBuren, Maury, Marshall, Cheatham, Lincoln, Moore, Overton, and Warren. In east Tennessee, Claiborne, Sevier, and Scott counties were under a state of emergency. In Waverly, the water entered the middle school and flooded several retail businesses.

There are 40 State roads damaged or washed out in Tennessee. Several hundred, perhaps as many as 500+, county roads are damaged or washed out.

The Tennessee Department of Transportation (TDOT) expects

I-24 eastbound at mile-marker 42, north of Nashville, to be closed for a week from a rock slide. TDOT is re-routing drivers onto Old Hickory Boulevard then to I-65 to get into Nashville. State Highway and Interstate impacts available on TDOT Smartway, https://smartway.tn.gov

No significant damage reported in Carroll, Henry and Weakley counties, according to TEMA.

Flooding is trending toward moderate and major stages on five (5) Tennessee rivers:

Tennessee River – Moderate Flood Stage

Cumberland River – Moderate Flood Stage, higher at localize locations

Duck River – Major Flood Stage

Buffalo River – Moderate Flood Stage

Harpeth River – Moderate Flood Stage in Kingston Springs

The Ohio River in Kentucky is in Major Flood Stage.

primary of their choice without having any prior declared party affiliation.

This bill would add a statewide political party affiliation question to the voter registration form, which would allow voters to declare a statewide political party affiliation or declare to be unaffiliated. This bill would change the affirmation on the voter registration form by adding language acknowledging that a person who selects "unaffiliated" is not eligible to vote in a primary without changing their affiliation before the end of the registration period for the applicable primary election, a person who declares an affiliation is a party member of intends to affiliate with that party, and that voting in an election in which the person is not entitled to vote is a Class D felony offense.

This bill requires each voter registration card include a statement indicating which statewide political party's primaries the voter is entitled to vote in based on the voter's declaration, if any. This bill does not require the administrator of elections to re-issue registration cards for voters who were registered prior to July 1, 2019, solely for the purposes of indicating that a voter has not yet registered their party affiliation or for modifying the content of the registration cards pursuant to this bill.

Under present law, if a primary election is being held, the application for ballot form must include a place for the voter to indicate the voter's party. This bill instead requires that, if a primary election is being held, the application for ballot form must include a place for the administrator of elections to indicate the voter's statewide political party affiliation as recorded on the voter's per-



manent registration record as of the registration deadline for the primary election.

Under present law, a registered voter is entitled to vote in a primary election for offices for which the voter is qualified to vote at the polling place where the voter is registered if:

(1) The voter is a bonafide member of and affiliated with the political party in whose primary the voter seeks to vote; or

(2) At the time the voter seeks to vote, the voter declares allegiance to the political party in whose primary the voter seeks to vote and states that the voter intends to affiliate with that party.

This bill instead provides that a registered voter is entitled to vote in a primary election for offices for which the voter is qualified to vote at the polling place where the voter is registered under the following conditions:

(1) If the voter is registered before the registration deadline of that primary election as being affiliated with that state-

wide political party in whose primary they seek to vote; or (2) If the voter was registered prior to July 1, 2019, and:

*The primary election is the first primary election the voter has participated in following July 1, 2019; *The voter has not changed his or her voter registration or selected a statewide political party affiliation since July 1, 2019; *The voter at the polling station during the primary election period completes a valid statewide political party affiliation form; and *The voter selects on the registration form the statewide political party of the primary election in which the voter wishes to vote, in which case the declaration of party affiliation must be added to the voter's permanent registration record.

For primary elections, this bill requires the state election commission to provide and the coordinator of elections to post a sign as practicable to the location where ballots are posted stating persons who were registered to vote prior to July 1, 2019, and who have not yet voted in a primary election after July 1, 2019, and who have not changed their voter registration nor selected a statewide political party affiliation since July 1, 2019, may register your party affiliation today by completing a statewide political party affiliation form. The sign must also advise voters that it is a Class D felony offense to vote in an election that they are not entitled to vote in.

How Did We Get Here? Part I

One of the most interesting details of history is learning how the early settlements emerged, developed and transpired into the current cities and towns. Maya Angelou said it best, “You can’t really know where you are going until you know where you have been.”

To begin the story of McKenzie, one must travel back to the time when the Chickasaw controlled West Tennessee. What would later become McKenzie was named the “Barren Lands” because few trees occupied the landscape; the terrain was covered by “barren grass that grew so high riders on horseback could be seen only from the shoulders up.”

Dating back to the 16th Century, Spaniards were the first Europeans to step foot onto West Tennessee soil. Hernando De Soto brought his conquistadors across the Tennessee border and died near Memphis; with his body being tossed into the Mississippi River to conceal his mortality. Next were French fur traders of the 17th Century who worked their way down the Mississippi River claiming the Mississippi River valley in the name of Louis XIV. With the close of the Revolutionary War, expansion brought settlers closer to West Tennessee and into contact with the Chickasaw Nation.

The Chickasaw were friendly with the white expansionists who brought various treaties for the indigenous tribesmen to sign. The documents were obtained with the sole purpose of building settlements. Jackson Purchase in 1818 was the final treaty turning West Tennessee over to the United States. The treaty was brokered by Andrew Jackson and Isaac Shelby. Through the negotiations, West Tennessee and southwestern Kentucky between the Tennessee and Mississippi Rivers were purchased for \$300,000. At the time of settlement, one trail or trace, the West Tennessee Chickasaw Trail, ran through what would become McKenzie. The trail was an offshoot of the Natchez Trace.

In 1785, Henry Rutherford, the first surveyor in this area, discovered Clear Lake which was originally named Boyd’s Lake named for Reverend Adam Boyd, a Revolutionary War chaplain in North Carolina. Boyd held large land grants in this area.

By 1819, R.E.C. Dougherty was appointed land entry taker in what is present day McMormorsville. The first county court sessions took place there while the county seat would end up being located near Beaver Creek in nearby Huntsville.

On November 7, 1821, the Tennessee State Legislature passed an act creating Carroll County in honor of Governor William Carroll. In December of 1823, the county seat Huntsville changed its name to Huntingdon.

Historical celebrities like Daniel Boone and Davy Crockett passed through the area.

Crockett settled near the Obion River in Gibson County and made numerous visits to the community of Caledonia, four miles north of McKenzie in Henry County. He was known to attend Shiloh Church when he was in this portion of his congressional district.

Stephen Pate is theorized as the first settler with his home west of McKenzie, with several hundred acres towards Greenfield. Other settlers include, John M. Gilbert in the North, Colonel John D. McKenzie and R.S. Cole the central portion, Garland Snead in the South, and men named Harris and Collier to the East. The Sneads and Gilberts took the lead in building up the area with the construction of two trading posts.

Gardner Gilbert and his son John M. Gilbert were the leaders of an area they called Marrieta. Centered near the intersection of Magnolia and Stonewall, the settlement included a business office, a log schoolhouse and a few other small buildings. The large rock found on the corner of Magnolia and Stonewall was used as a step to the old schoolhouse.

The Snead family claimed founding the Dundas settlement. Lasting only five years, the trading center consisted of a trading store, a post office, a saloon, blacksmith, and a hotel “The Carroll House.”

In 1859, James Monroe McKenzie built The McKenzie Hotel. The McKenzie family prevailed at the close of the Civil War with the crossing of railroad lines on the family property. George McKenzie became the station manager at the behest of his father, James Monroe. The first time-tables printed bore the name “McKenzie, Tennessee.”

In the next edition, we will go deeper into surrounding communities that were absorbed by the City of McKenzie, the Civil War in this area and some early government leaders.



I’ve loved three women in my life: Mother, of course, my first wife.....and Loretta Lynn.

Thank goodness I wasn’t alone. Buddy, Ricky and Yogi were having the same contemplations. We wanted to be “acknowledged” as maturing, growing, contributing....but we didn’t have a clue about life past the city limits sign.

We discussed our plight during breaks in the backyard baseball games and determined it was going to take some outside help.

Television was just making its way into our homes. And it had an immediate impact. We watched spellbound as Walter Cronkite on CBS took us to places in the world that had buildings taller than trees. We listened as he interviewed folks that didn’t have the country twang that permeated our everyday conversation. We had never thought of ourselves as “backwards” or “country” but then, we’d never been anywhere else.

We didn’t see hog farmers on TV. Or guys still using crosscut saws. People weren’t even wearing overalls for goodness sakes. And if you listened to Mr.

Cronkite everyday, you’d-a-thought “ain’t” wasn’t even a word!

It’s not much fun thinking “here we are, just spreading our wings” and discovering the world has left you way behind.

Jackie Burns was giving us a ride out to Frank’s Dairy Bar in his 1956 Ford. We were half listening to a country station out of Lexington when I heard her voice for the first time.

It was like the whole world stopped, “Ever since you left me I’ve done nothing but wrong, Many nights I’ve laid awake and cried.....”

Buddy was first to speak, “Well, there’s one thing for dead certain positive, we’re not as country as that girl!”

No, we weren’t. Her voice was from someplace way out further back than we’d ever been. You could hear it in every word. But it was also so pure. Bare. Straight forward. I’m thirteen years old, I’d heard one verse and I KNEW this lady was the real deal!

“So turn that jukebox way up high, And fill my glass up while I cry, I’ve lost everything in this world, And now I’m a Honky Tonk girl.”

And that was just her first song! She’d mesmerize you singing “Blue Kentucky Girl”, “Dear Uncle Sam” and “If I Could Hear My Mother Pray Again.”

She felt like one of us from the very beginning. And she never apologized or took a back seat for being from Butcher Holler. You can’t believe how proud that has made us over the years of her, and for her.

When her husband flirted around a bit, she wrote a number one hit, “You

Ain’t (she’s more cultured than Walter Cronkite) Woman Enough to Take My Man.” When he had one too many, she sang, “Don’t Come Home A’Drinking with Loving on Your Mind.” You see, real country folks don’t take nothin’ off of nobody!

Every single time she sings “Coal Miner’s Daughter” we all receive a free trip back home.

I took a job at the Grand Ole Opry in 1968 just hoping to catch a glimpse of her. I was standing backstage listening to a couple of country music Hall of Famers talking about how many folks they played “in front of” at the Iowa State Fair or the Pontiac Silver Dome.

Loretta Lynn walked in talking about how many jars of tomatoes she’d “put up” the past week.

She turned to me and gave me a great big country, “Howdy.”

The truth slipped out of me without any thought or foreknowledge, “Miss Lynn, I fell in love with you in the back seat of Jackie Burns’ Ford in 1960 listening to “Honky Tonk Girl.”

She smiled and said, “I appreciate that son.”

“You really look nice tonight.” It was all I could think of.

She backed up just a mite, looked me up and down from head to toe a couple of times....and declared, “You ain’t looking too bad your ownself!”

Now, won’t that knock your hat in the creek.....

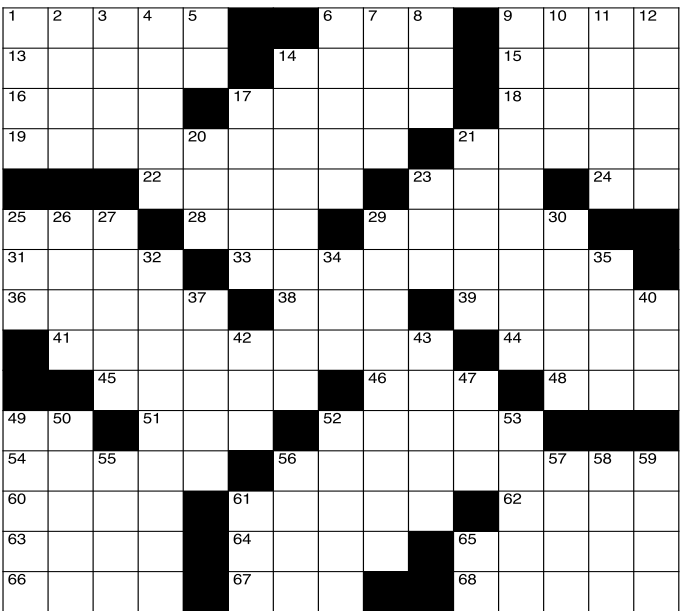

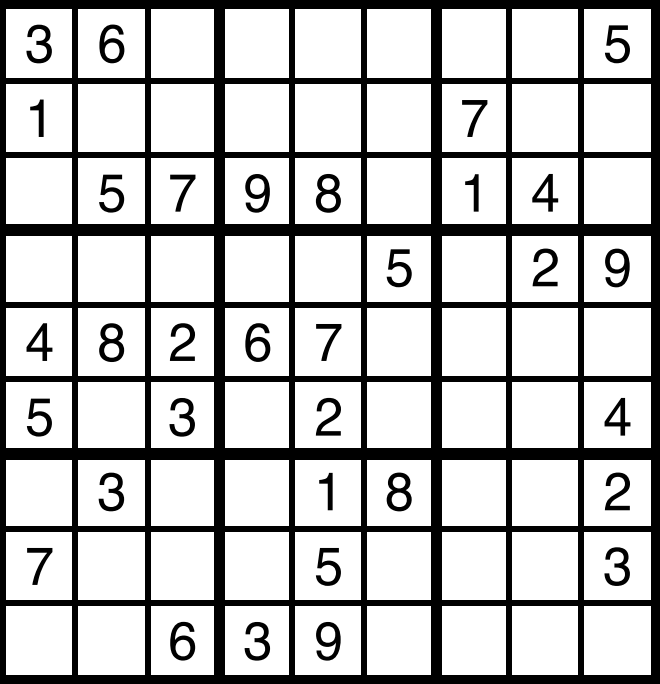

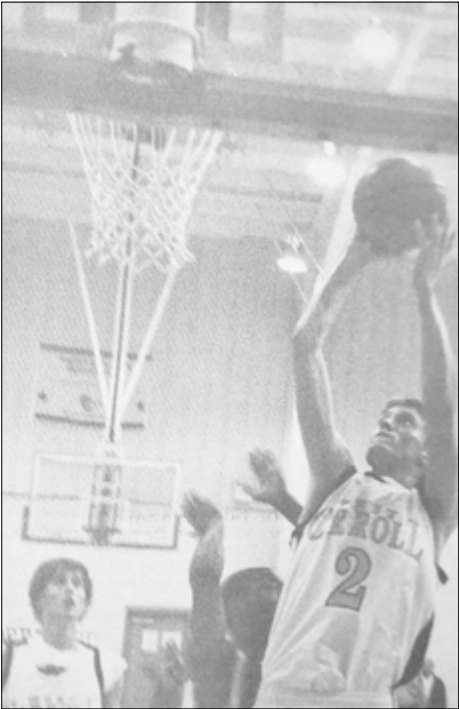

McKenzie Police Reports

Aggravated Kidnapping/Domestic Assault — Last Wednesday night, February 20, a caller contacted the McKenzie Police Department to report that Kevin Burnine of McKenzie had taken a truck to a gas station and not returned. The caller stated that Burnine was drunk and had kicked his girlfriend out of the truck.

According to a report filed by Mark Boaz, he and Sgt. Jeff Winberry met with Amanda Farlow of McKenzie and got her side of the story. Farlow told the officers she had been with Burnine for the past few hours and had been kidnapped. She stated he picked her up wanting to talk and held her hostage and repeatedly hit her on the head and threatened to kill her. She also stated she escaped the truck at a stop sign on Oak Manor Road and ran and walked to the Walnut Avenue residence where the officers found her. She

told officers she felt as if she had a concussion from the multiple blows to the head. EMS was called and an exam did confirm she had contusions on her head and was transported to Baptist Hospital in Huntingdon.

Burnine was charged with aggravated kidnapping and domestic assault.

Aggravated Assault/Domestic Assault — Ms. Athena Stafford of McKenzie called 911 from Little General last Monday Feb. 18 stating that Charles Dunning of McKenzie had held her hostage in her Locust Avenue residence and would not let her leave. She told dispatch that she had gotten free and ran to Little General and locked herself in the restroom. Officer Cody Coleman found her there while Officer Trey Boucher went to her residence and found Dunning walking from the back yard stating he was looking for

Stafford. He was detained while the officers got a statement from Stafford.

According to the report filed by Boucher, Stafford reported she and Dunning had gotten into an argument at her house during which Dunning threw her down and punched her in the forehead and choked her. Stafford also reported Dunning pulled her around her residence by the hair. She also stated that Dunning assaulted her again about an hour after the first time breaking into the bathroom door where she had locked herself and shoved her in the bathtub. Officers observed a knot on Stafford's forehead and damage to the bathroom door and bathtub.

Dunning was arrested and charged with two counts of aggravated assault, two counts of domestic assault, and two counts of vandalism. Bond was set at \$7,500. The kidnapping allegations are still under investigation.

Domestic Assault — Last Saturday, Feb. 23, a Little General em-

ployee contacted McKenzie Police reporting a couple was arguing both inside and outside the store. Two officers responded and spoke with Jeremy Russell of McKenzie and Tabitha Humfress of Gleason. She stated she went to Little General to get away from him but he followed her and continued to be aggressive towards her.

Russell was arrested for domestic assault and transported to Carroll County jail. Humfress was later found to have an active warrant out of Weakley County and was taken to Weakley County Jail.

Prescription Fraud/Shoplifting — Ms. Erin Simpson, A Walgreen's pharmacist, notified McKenzie Police last Tuesday evening, Feb. 19 that Ms. Janell Glenn of Memphis came into the pharmacy and gave them a fraud-

ulent prescription script. Simpson stated the fraudulent script was from a place that did not exist.

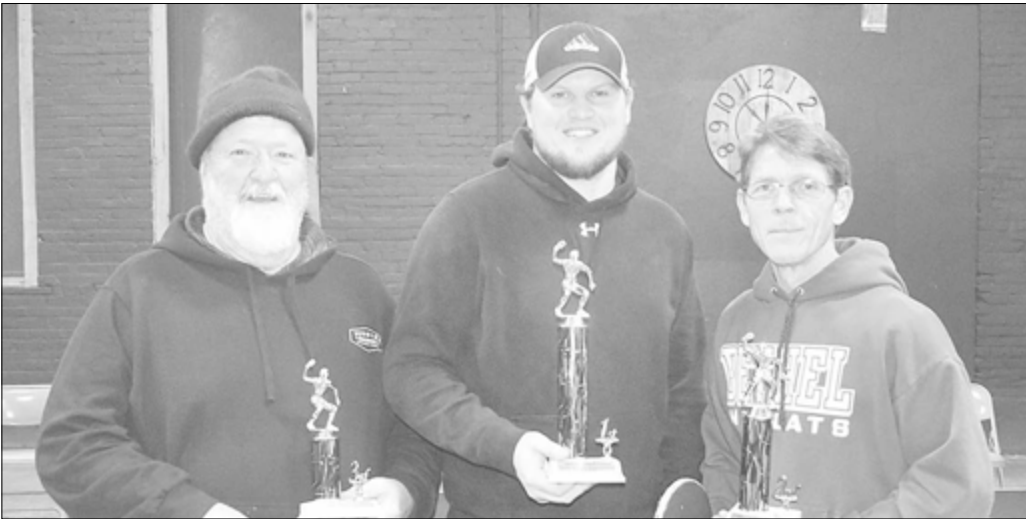
