Huntingdon Man Arrested In Homicide in Buena Vista

BUENA VISTA — A 20-year-old Huntingdon man is charged with Reckless Homicide in relation to a fatal shooting of a Buena Vista man on Friday afternoon in Buena Vista.

Arrested Sunday was Corey Leavitt, Jr., 20, of Huntingdon. He is incarcerated at Carroll County Jail without bond. An arraignment hearing is scheduled Wednesday at the Carroll County Courthouse.

Carroll County Sheriff Andy Dickson said a 911 call came in at 5:59 p.m. Friday, March 29 indicating a man had been shot in the non-incorporated area of Buena

Water Main Break Leaves Residents with No Service

McKENZIE (March 31) — For some McKenzie residents Sunday started with-

out running water in their homes after a

six-inch water main broke. Water Superintendent Billy Wood said he was notified of the problem at approximately 2 a.m. Once the problem was located, the water service on that line was terminated and Anderson Construction Company's trackhoe was

enlisted to excavate the broken line at the intersection of Hamilton Street and U.S. 79. The break left some residents with limit-

ed water pressure and others without any

Gleason Senior Earns Full Scholarship to Bethel

GLEASON (April 1) — Edward Wayne Castleman, Jr., a senior at Gleason High School is the 2019 Hendrix Scholar and has earned a full-ride, four-year scholarship to Bethel University in McKenzie.

Established in 1988, the Hendrix Scholarship Competition was the brainchild of late Nashville businessman Willard R. Hendrix, who dreamed of connecting qualified and dedicated faculty with outstanding and deserving students. As the grandson of former Bethel University President W.W. Hendrix, the younger Hendrix also wanted to pay tribute to his grandfather, an outstanding educator who reopened the school on a new McKenzie campus after the Civil War. Willard Hendrix established the trust just two months before his death in August 1988. Worthy students have competed for - and benefited from - the prestigious award ever since.

The competition was a twoday event in which students' academic abilities will be tested with a written exam, an academic exam, and an interview. Butler said the award is not based on popularity, but rather scholastic ability and an inter-

Bethel President Walter Butler made the presentation in the Dudley Sanders Memorial Gym at Gleason School on Monday as middle and high school students looked on. Butler said students from many states competed for the award. The last Gleason recipient was Amy Lawrence, the librarian at Gleason School. It is valued at over \$100,000, said the president.

Castleman said he is honored to receive the scholarship and to be able to experience college as a student-resident. He said of the university, he enjoyed meeting the faculty, who were very easy to communicate with. He said he also knows several students at the local university. He plans to earn his bachelor's degree and advance to a Ph.D. and teach.

Castleman was honored by Bethel and by his family, who attended the announcement.

Carroll County to Vote on New Solid Waste Contractor

Carroll County commissioners will vote on a resolution to award a five-year contract to Red River Waste Solutions of Union City to provide weekly curbside weekly solid waste collection for approximately 6,000 households in rural Carroll County. Commissioners convene Monday, April 8, at 7 p.m. at the Carroll County Office Complex.

The resolution was on the February agenda, however, commissioners delayed for one month to investigate the viability and service record of Red River. Republic Services, the current provider, has had the contract for approximately 25 years and

Watershed Authority Seeks New Financing Bond Issuance

HUNTINGDON (March 26) The Carroll County Watershed Authority's Board of Directors voted to issue new interest-bearing bonds in the amount of \$340,000 at an interest rate of 3.5 percent. It will replace a 2016 series in the original principal amount of \$340,000, at an interest rate of 2.0 percent.

Board members also approved the 2017-2018 audit, which indicates a net change in balance of negative \$312,760, which included the cost of constructing the new RV park, which was funded from the funds set aside in the previous fiscal year. No grant funds were received during the 2017-18 FY.

The Authority presently has

Huntingdon **Approves Audit**

HUNTINGDON (March 26) The Huntingdon Town Council approved the 2017-2018 financial audit and a new intercom system for The Dixie during the March 26 meeting.

In the audit, the town's financial position had the noted changes as announced by Mayor Dale Kelley. The General Fund had a net increase by \$108,501, the Dixie Performing Arts Center had a fund balance increase of \$20,372, supported by a budgetary transfer from the General Fund of \$358,000 to generate a positive increase, the Public Improvement Fund increased by \$3,444, the Drug Fund increased by \$24,477, the Utility Fund had an increase of \$747,266, and the Industrial Fund increased by

Also on the town's audit is the financial activity of the Carroll County Watershed Authority. The Town of Huntingdon provides the fiscal accounting services for the Authority and also has a financial responsibility in case of default by the Carroll County Watershed Authority.



McKENZIE (March 30) — As part of McKenzie's sesquicentennial celebration, McKenzie Banking Company hosted a free movie Saturday afternoon at the Park Theatre. McTyeire School was McKenzie's first educational institution, coming to McKenzie from Caledonia in 1867 before there was a public school and before Bethel College moved from

McTyeire School

McKenzie's First Educational Institution

Bethel University, I felt it only right to build further on the educational institutions of McKenzie. So this week it's the story of McTyeire School.

The story of McTyeire School dates back to 1858 in the Caledonia Community of Henry County. Started by Edwin H. Randal, it began as a boarding school and later chartered in 1860 as Caledonia College. The first and only graduates were G.W. Nowlin, J.R. Wilkins, Mattie Miller and Adelia Wall.

The onset of the Civil War closed the doors to Caledonia College. The building burned before the war ended and relocated to McKenzie in 1867. The new facility was known as the McKenzie Male and Female Institute

The move to McKenzie left the school with limited funds forcing the school to open on the ground floor of the Masonic

Caledonia. By 1871, Captain H.C. Irby purchased land on present-day McTyiere Street. Two buildings were constructed and chartered as McKenzie College. It became McKenzie's first educational facility beating out the relocation of Bethel College from McLemoresville in 1872.

Irby resigned in 1874, and the property was purchased by Dr. A.P. Waterfield with Professor Randal taking over as president of the school. It was during this time, two interesting stories attached themselves to McKenzie

The first story is about a Scotsman known as Dr. Mundie. Hired to teach chemistry and Greek, Dr. Mundie claimed noble birth and to be the last surviving member of the distinguished family. Falling ill and near death. Mundie made out his will leaving the college 400,000 English pounds. The

Scotsman failed to sign the will before his death, and Professor Randal could never locate the

Another story is that of painter and wanderer Ernest Schwarzwald. Arriving in McKenzie in the late 1870s, Schwarzwald lived above the Cannon Drug Store and was hired by Dr. Waterfield to paint the school. After being stabbed by a drunk and near death, from the recommendation of Waterfield, Schwarzwald left his money to the Methodist Church.

The church paid for his burial expense and remaining debts. He was buried in Mt. Olivet Cemetery with a modest headstone with the area enclosed by an iron fence. At the time of his death in 1878, Schwarzwald's estate was valued at \$4,000 (equivalent to \$101,000 in today's terms).

With the influx of capital, the Methodist Church looked to purchase the school and property from Waterfield. Believing the price was too high for the property, the church purchased a different lot further from town and constructed their own campus through the Schwarzwald Fund.

On April 10, 1882 McKenzie College changed its name to McTyeire Institute in honor of Holland Nimmons McTyeire, an American Bishop of the Methodist Episcopal Church. Bishop McTyeire was responsible for co-founding of Vanderbilt University in 1873.

McTyeire initially granted degrees, but in 1879, the school became a preparatory school. Under the leadership of A. Grier Peoples, the name changed

to the McTyeire School in 1899. McTyeire School curriculum followed the custom of the time, focusing on classics, English, math and history, aimed at the Vanderbilt entrance exams.

When Vanderbilt was established, there were few schools in Tennessee designed to prepare students for college. Only three preparatory schools were established before 1873. Montgomery Bell Academy (Nashville) and the McTyeire School (McKenzie) were founded in 1867, followed by the Webb School (Culleoka/Bell Buckle) in 1870. These three schools set the standard for preparatory schools in the State of Tennessee.

Other principals of the school included Dr. Edwin B. Chappell (1879-1883), Granville Goodloe (1883-1886), Raleigh Williams (1883-1887), Joshua H. Harrison (1886-1898), Reverend Clough A. Waterfield (1898-1899), R. Grier Peoples (1899-1902), and James A. Robins (1899-1931).

By the arrival of James Robins, the McTyeire Institute was going by the McTyeire School and was accredited by the Southern Association of Secondary Schools. Serving as a four year preparatory school for colleges. Its students were allowed to enter any of the college and universities of the Southern Association. At the conclusion of Professor Harrison's tenure, the McTyeire School housed 75 teenage boarding students (male and female) developing them academically and spiritually.

James Robins held the longest tenure at McTyeire with 32 years of service. In his own

words Robins stated he regarded education, "not as a pouring in process, but rather as a drawing out, training, and developing of the highest impulses that come to boys and girls during a period when their standards and ideals are becoming fixed."

One of the key principles of the McTyeire School during Robins' time came from author John Phillips, "Goodness without knowledge is weak and feeble, yet knowledge without goodness is dangerous, and both united form the noblest character and lay the surest foundation of usefulness to mankind."

The school was operated as if the facility, staff, students were all part of "Mr. Jim and Mrs. Jim" Robin's family. Informal morning chapel talks and Sunday afternoon walks through through the woods were key for Robins to develop life philosophies for his teenage students.

hold in 1929, McTyeire School was greatly effected by the economic crisis. Limited funds prevented families from sending their children to the preparatory school. The end of 1931 academic year saw the closure of the once great school.

In 1936, Professor J.L. Seets and McKenzie Mayor Glen A. King worked to purchase the 30 acres and five buildings of the abandoned McTyeire School. The once great school for white students became the great school for African-Americans, Webb School.

Much of the research of this edition comes from McKenzie's History (1869-1969), the papers of Mrs. Parnell, Vanderbilt University and the Gordon Browning Museum and Genealogical Library.

uman beings know how to help each other. We rise to the occasion after natural disasters, for instance, and demonstrate that we are at our best when our fellow humans need us most. But why can't we do this all the time? What keeps us from reaching out and helping others in the mundane give and take of our everyday lives? Or why do we sometimes fail to rise to the occasion in certain crises, such as helping refugees from war-torn regions. The fact that we sometimes help and other times look away or just plain refuse to help is perhaps an indictment of our moral sentiments, the feelings of empathy and sympathy which move us to help. Sometimes our heartstrings are pulled and we rise to the occasion and other times we fail to do so. Social Psychology offers some clues to this puzzle. It turns out that what is referred to as bystander apathy (not helping when you see someone in need) can be overcome by 1) noticing that someone needs help; 2) interpreting the situation as one where you could be helpful; 3) taking responsibility for helping; 4) developing a plan (or deciding what should be done); and 5)

implementing the plan. It's not terribly

complicated. Most of us could be doing

more to help our sisters and brothers in

need. – Christopher Simon


Day lilies originated in eastern Asia and were introduced to the U.S. in the 1920s. The most common lilies were those referred to as "ditch lilies," but growers began to cultivate other colors.



There are now over 80,000 cultivars, but no one has cultivated a blue lily. Day lilies grow in clumps, and the best way to plant them is to create a mound of soil, spread the tubers out over the mound, cover with soil and keep them moist. It is best to divide clumps every three years-lilies can die from lack of space. Tennessee Magazine suggests dividing them in September. Keep the new divisions watered well. Some will stay green over the winter.

Although toxic to cats, lilies are edible for humans and are ingredients in many Asian dishes such as Mushu Pork. Ms. Traut ended her program by showing pictures of some of her lilies, as well as her azaleas and peonies, and answered various questions posed by the club members.

The meeting then closed with the reading of the collect.






