Four Arrested in Atwood After Entering Home

Four men were arrested April 23 for allegedly trespassing on private property in Atwood.

Antonio Germaine Walker, 20, of McMoresville; Isaac S. Bobbitt, 22, of Atwood; Al-Kareem Williamson, 19, of Milan, and Anthony Thomas of Milan were all charged with aggravated criminal trespassing and resisting stop/frisk/

halt by the Carroll County Sheriff's Department.

Williamson was also charged with possession of marijuana. According to the report by Deputy Jason Walker, Orlando Ross called the Sheriff's Department at around 9:20 p.m., saying that a neighbor had called him and told him that several people were in his house at 240 Bryant

Road while he was away from home. Deputy Walker reported that when he pulled into the driveway, he saw four black males run out of a shed beside the house. Deputies caught and arrested Williamson, Thomas, and Walker that night, and Bobbitt was arrested later. Officers from the CCSO and the THP were on the scene searching for the suspect.

Tri-Counties Show Mixed Unemployment Rates

NASHVILLE (April 25) — The percentage of persons unemployed in February decreased from the February rate in the tri-counties of Carroll, Henry and Weakley.

Carroll County remained steady with a unemployment percentage of 4.6 in March compared to 4.6 in February and down from the 4.8 March 2018 rate. Of the 12,180 in the labor force, 11,620 were employed and 560 were unemployed.

Henry County had slightly more unemployed at 590 persons.

In March, the number of people in the labor force was 14,510 with 13,920 employed for a rate of 4.1 percent, down from the 4.2 rate one month earlier and 4.3 one year earlier.

Weakley County posted an unemployment rate of 3.6 percent in March, up slightly from February's 3.4 and down from last year's 3.9. Of 16,580 in the labor force, 15,980 were employed and 600 were unemployed.

Four counties in West Tennessee are in the top ten in unemployment including Lauderdale,

McNairy, Lake and Hardeman counties. The Northwest Tennessee region of Benton, Carroll, Crockett, Dyer, Gibson, Henry, Lake, Obion and Weakley counties continues to have the overall highest average unemployment at 4.2 percent across Tennessee.

Tennessee has a 3.2 percent rate of unemployment and the United States has 3.8.

Williamson County has the lowest rate at 2.4 percent, followed by Davidson at 2.5.

Huntingdon Council Authorizes Emergency Repairs

HUNTINGDON (April 23) — Huntingdon's Town Council met in its second session of the month with a brief agenda of activity.

The only action taken during the meeting was board members unanimously authorizing Mayor Dale Kelley to award the Jordan Avenue Gravity Sewer Rehabilitation Contract to the lowest and best bidder for the emergency repair of 273 linear feet of existing gravity sewer from Sewer System Manhole A015 to Manhole A565 and report to the council at the next regular meeting.

Mayor Kelley advised council members, "Due to the emergency nature of the repair, the engineer has contacted several local contractors to provide bids this week."

The board heard a grievance from Ryan Forbess, a Forney Road resident, regarding vehicles parking on the street. Forbess indicated this issue had been occurring for some time and was creating a traffic hazard on the road due to Forney Road only being 17 feet wide by his measurement. Forbess

offered solutions acknowledging that widening it would be too expensive but banning street parking could be done with the only expense being providing signage to be placed on the street. Mayor Kelley thanked Forbess for bringing the issue to their attention and assured him that some action would be taken. Smothers commented, "There are tow trucks that can resolve the problem!"

Vice-Mayor Tim Tucker summarized the recent meeting of the town's public safety committee meeting held on April 9. The agenda was a discussion of providing pay raises to the police department due to McKenzie recently approving a \$3.00 per hour raise to its police department.

Tucker, committee chairman, reviewed the benefit package provided to department members and acknowledged the employees mainly look at take-home pay. He provided information on the use of part-time officers and overtime pay for full-time officers covering shifts during the first fiscal quarter of this year. Also discussed was the expense involved when hiring non-certified officers. Tucker advised the committee that the town has sent 20 officers to

the academy in recent years and would like to think of a strategy to retain the employees. The committee did not refer any recommendations to the town council.

Public Safety Director Walter Smothers updated the board on renovations being done to the old courtroom which includes pulling up the rug and generally sprucing up the room. He advised one future project involves him talking to the HHS art teacher about having her students paint a mural of the three separate 9/11 sites and placing the number of first responders who lost their lives with the mural. One council member asked if there was a target date for completion of the renovations. Smothers laughed and said "No set target date at this time, most likely when it's done!"

Mayor Kelley announced Huntingdon will be receiving \$26,565 in dividends from Public Entity Partners. This is approximately \$4,683 increase over last year's dividend. He also announced the Huntingdon Ruritan Club made a recent donation of \$272.32 to the Huntingdon Fire Department. With no other business to be discussed, the board adjourned.

Clarksburg to Improve School Traffic Safety

CLARKSBURG (April 22) — During their regular meeting Monday, Clarksburg's Mayor and Aldermen gave final approval to a much-needed safety improvement for the traffic areas around Clarksburg School. The Safe Route to Schools grant, a joint project by the City and the Tennessee Department of Transportation (TDOT) will provide new solar-powered caution lights and signage at two locations on Clarksburg Road which will be activated during morning arrivals and afternoon departures. A low bid of \$19,967 by Nsite, Inc. of Milan was accepted. Once TDOT receives formal notification of the City's approval, work on the project should begin.

Mayor Howell Wayne Todd said "Clarksburg Road is rather congested as students are arriving and departing school,

and we need all the reminders we can muster to ensure the traffic adheres to school zone speed limits. These new signals are designed to be much more visible to drivers."

In other business, bids were accepted from Josh Todd Mowing Service to mow/trim the City Park, from Mark Simpson to install appropriate electrical connections for the City's new Christmas Lighting Project, and from Axon Enterprise, Inc. to replace the Tasers used by the City's police. Maintenance is no longer available on the currently used Tasers. The financial reports for March were also approved.

Mayor Todd distributed to the aldermen a draft of a lengthy questionnaire required by the State Water and Wastewater Financing Board as a result of last year's deficit in sewer

operations. State law requires municipal sewer operations to be funded solely by payments from customers, and rates must be set accordingly.

"Take a look at what has been prepared with Leigh's help in pulling historical data together. We won't know whether I will have to go to Nashville and meet with the Board until they have an opportunity to review the responses to the questionnaire. I sincerely hope that our action in February raising the rates will satisfy the Board and that they will not see a need to intervene. Send me any suggestions for improvement by the end of the week," said Todd.

Finally, Todd noted a meeting of the City Beer Board at 5:30 p.m. on Monday night, April 29 to consider two applications. The Mayor and Aldermen also serve as the City Beer Board.

Huntingdon School Board Hears Personnel Changes

HUNTINGDON — The Huntingdon Board of Education met in an early-morning session Thursday, April 25 with a brief but busy session.

After approving the March meeting minutes and budget amendments, board members approved the adoption of textbooks for 2019-2020 along with a procurement plan for the Child Nutrition Plan. An easement agreement between the Board of Education and Huntingdon was approved regarding a sidewalk at the Middle School. The board

also approved an amendment to the Tobacco Free Schools policy.

Huntingdon SCOPE Conference attendees Katie Chase, Aden Hutcherson, Leigh Sanders, and Merritt Willis, made a presentation to the board about what they learned at the conference. HMS principal, Scott Carter, updated the board on one-to-one leasing while HHS Principal Jonathan Kee presented the board with the 2019-2020 dual enrollment options.

Several new employees were announced for the coming year

including Misty Gray, Alicia Hansen-HMS Softball Head Coach and HHS Assistant Softball coach, Porsche McClerking-HHS Head Boys' Basketball coach and will teach high school Biology, David Wilkins-HHS Head Girls' Basketball coach, and Jade Wilkins. The full roster of each school's staff will be announced during the summer.

Board members were reminded of the next meeting, Thursday, May 16 at 7 p.m. before adjourning.

Commissioner David Salyers is the commencement speaker. David Salyers became commissioner of the Tennessee Department of Environment and Conservation in January 2019 after serving as executive director of the West Tennessee River Basin Authority since 1997.

A native of rural western Kentucky and resident of Madison County, Tennessee, Salyers led the West Tennessee River Basin Authority as an agency that sets the standard for water resource management in West Tennessee. Salyers introduced stream management techniques that led to improved efficiency and preservation of natural resources.

Under Salyers' leadership, the Basin Authority was recognized by state and local leaders as innovative and cost-effective.

The agency successfully built partnerships with state departments, federal agencies, nonprofits, local chambers of commerce, businesses, private landowners and agricultural producers. Such partnerships led to large collaborative grant awards for projects to reduce flooding, protect infrastructure, improve water quality and restore ecosystems. The agency provided solutions to issues related to public safety, agriculture, transportation, recruitment of industry, watershed stabilization, water quality and natural resource enhancement. He received the 2016 Land Conservationist of the Year Award from the Tennessee Wildlife Federation for his wetlands restoration work and effective promotion of soil conservation practices with local farmers that improved the health of target watersheds.

Salyers worked for 11 years in the private sector in the Southeast as an engineer and manager before taking the reins of the

Basin Authority. He maintains registrations as a professional engineer and geologist, as well as being a certified hydrologic professional. He received a bachelor's degree in geology from Murray State University and a bachelor's degree and master's degree in geological engineering from Missouri University of Science and Technology. Additionally, he has served as a Bethel University faculty member.

Inglennook Book Club April News

The Inglennook Book Club met in April at Lakeside Assisted Living Center with Suzanne Russell as hostess, assisted by Jean McKinnie.

After refreshments and a business meeting, Sandi McMahon presented her program featuring two protagonists created by the thriller novelist team of Douglas Preston and Lincoln Child. Preston and Child each have several novels to his credit, Preston with his Wyman Ford series and a novel entitled Jennie, which was made into a movie by Disney. Lincoln Child's novels include the Jeremy Logan series, and most of his solo novels have become New York Times best-sellers.

Aloysius Pendergast first appears as a supporting character in the first Preston and Child novel, Relic, and in its sequel, Reliquary, before assuming the protagonist role in The Cabinet of Curiosities. Pendergast is a special agent with the FBI and works out of the New Orleans branch, but frequently travels out of state to investigate cases which interest him, often those appearing to be the work of serial killers.

Pendergast appreciates the finer things in life, including expensive cuisine and wines. He has a great distaste for opera. He spent a year in Tibet studying deep meditative art. His interests encompass a wide variety of differing walks of life, yet all focus on the enlightenment of the human mind, body and soul. He is always described as being tall and slender, fit and graceful in movement and physically powerful despite his slight frame. His very pale skin causes people to refer to him as "corpse-like" or as an "albino." He has platinum blond hair and ice-blue eyes. He religiously dresses in a black,

hand-tailored suit and thus is often described as looking like an undertaker. In many cases, Pendergast's normal appearance is irrelevant. A master of disguises, he has fooled even close acquaintances on several occasions.

Pendergast maintains an apartment at The Dakota in New York City and later inherits a renovated Beaux Arts mansion near Harlem. In his apartment, there is a fully furnished Zen garden where he likes to take time to meditate before a new challenge.

The second protagonist in the Preston and Child novels is Dr. Gideon Crew, a field operative for the New York-based corporation Effective Engineering Solutions and a nuclear physicist currently on indefinite medical leave from Los Alamos National Laboratory. He is also a jazz enthusiast, avid fisherman and gourmet chef.

Crew is described as tall and lanky with long, floppy jet-black hair, blue eyes and also missing the top joint of his right ring finger. He is a master of disguise and social engineering.

Gideon's father, Melvin Crew, was a civilian cryptologist with the U.S. Army Intelligence and Security Command (INSCOM) at the height of the Cold War. After a flawed encryption system resulted in one of the worst intelligence disasters of the Cold War, the blame fell to Melvin, who cracked under the pressure of accusations, took a hostage, and was shot and killed by FBI snipers after surrendering, as twelve-year-old Gideon looked on.

Years later, Gideon learned from his mother on her deathbed that his father was a scapegoat for the INSCOM disaster. Knowing the encryption standard, code-named "Thresher" was flawed, Melvin wrote a

memo warning his superiors. These warnings went unheeded and "Thresher" was implemented, resulting in the deaths of 26 American operatives. The group leader of the Thresher project, Lt. Gen. Chambliss Tucker, destroyed the evidence and ordered Melvin Crew killed to silence him. Doris Crew's dying message to her son was to "even the score" with Tucker, making sure he knew why and by whom.

The revelation gave Gideon renewed purpose and he returned to college, earning a doctorate in physics from MIT and going to work at Los Alamos National Labs in New Mexico. After several years of searching and planning, Crew found the evidence to clear his father's name and took his revenge on the general.

While in the hospital being

treated for injuries following his encounter with General Tucker, tests revealed the presence of an abnormal congenital tangle of arteries and veins deep in the brain. The condition was inoperable, untreatable, and invariably fatal: Crew was told he had approximately one year to live.

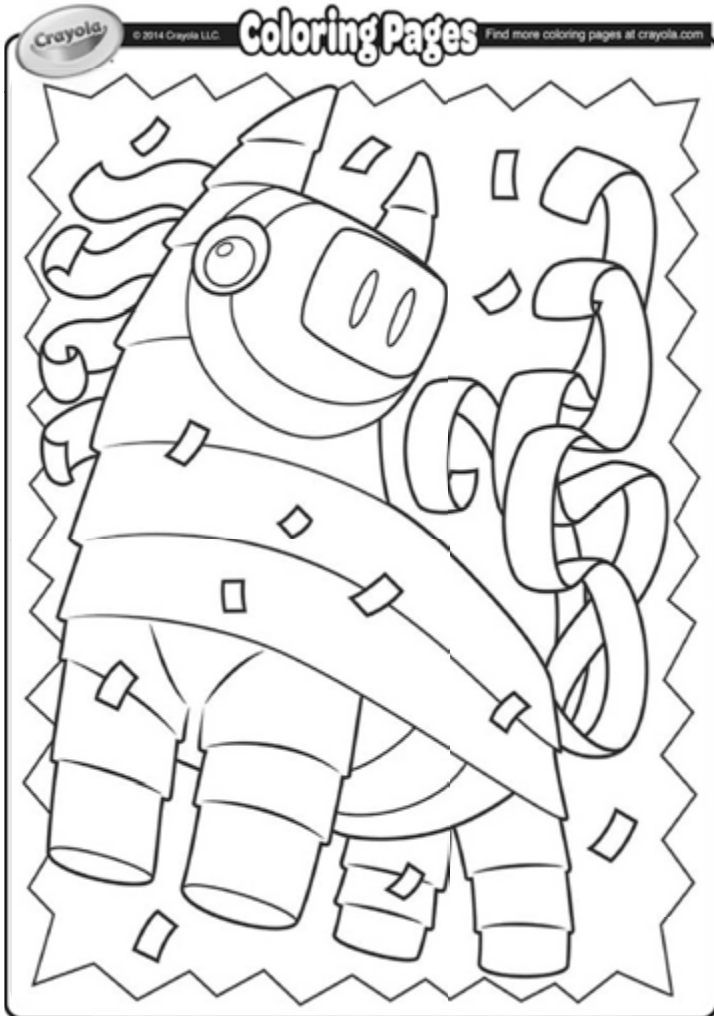

Bethel’s Stacie Freeman to Participate in Think Tank at Harvard

Harvard’s Think Tank on Global Education has invited Stacie Freeman, Bethel University professor and co-executive director of Bright Light Volunteers, to be at the forefront of testing and developing cutting-edge curriculum to advance competence in global studies, in classrooms, schools and school districts via participation in Harvard’s Graduate School of Education program.

Freeman states, “Participants in Harvard’s Think Tank will be sharing and learning ways to foster global competence in our schools by co-constructing curriculum, developing educa-

tors and devising a strategy for systemic change in global education.”

As a participant in the upcoming institute, Freeman will take part in “a dynamic, large-scale collaboration to create and adapt lesson plans and scale global education” for students in the rural, Southern, Title I schools where she teaches.

Freeman has led students from Bethel University and high schools, both local and national, to destinations such as Cuba, Vietnam, Costa Rica, and Colombia.

Historically, Title I students in the rural south have had

limited access to global citizenship education and to the multiple intellectual and social benefits of participation. Bethel University and Bright Light Volunteers initially partnered to support the U.S. Department of Education’s Purpose for Title 1 schools: “improving the academic achievement of the disadvantaged,” by “closing the achievement gap between minority and non-minority students and between disadvantaged children and their more advantaged peers.” (2004)

Although Freeman has already devised and implemented a curriculum which capitalizes

on the United Nation’s 17 Sustainable Development Goals, she is eager to learn more and to use that knowledge to help “level out the playing field” when it comes to access to global education.

Catherine Greenberg, founder & co-executive of Bright Light Volunteers is excited about how Freeman’s participation in the institute will strengthen the educational aspect of the Dallas-based nonprofit’s student global service learning programs.

Greenberg offers, “Being able to improve how we implement our signature pedagogy in global education and pro-

vide teachers with the tools to design global service learning experiences is an enterprise that will change lives.”

Freeman resides in Dresden, Tenn. with her husband, Mike, and twin daughters, Lillie and Katie.

Bright Light Volunteers is a 501(c)(3), a non-profit organization, designed to empower program participants and community partners through education and service.
