Aggravated Vehicular Homicide, Aggravated Kidnapping Indictments Handed Down

HUNTINGDON (May 6) — Fifty-one indictments were handed down during the May term of the Carroll County Grand

Jury last week. The charges include Aggravated Vehicular Homicide, Child Rape, and numerous drug-related offenses.

Creighton Lyle Cockrill, 24, of McMoresville, was indicted on multiple charges including Aggravated Vehicu-

lar Homicide and Vehicular Homicide stemming from a fatal accident on Hwy 70A between McMoresville and Atwood in July 2018 that took the life of

Two graduations will be later this week and four area high schools graduated last week.

Gleason High School graduates Friday, May 17, 7 p.m. in the school gymnasium. Thirty students are expected to graduate.

McKenzie High School graduates Sunday, May 19, 3 p.m. in the school gymnasium. One hundred-nine students are expected to graduate.

Last week, graduations in Carroll County began in Atwood at West Carroll High School. Sixty-four graduated during the Thursday evening ceremony.

Hollow Rock-Bruceton graduated 43 students on Friday evening in the school's gymnasium.

Clarksburg High School graduated 17 students on Friday, May 10, 7 p.m. in the school gymnasium.

Huntingdon High School graduated Sunday, May 12, 2 p.m. in the school's gymnasium. Seventy-eight students graduated.

Election Commission, Sheriff Requests Increases to Budget

HUNTINGDON (May 10) — Carroll County Election Commission needs new voting machines and the Sheriff's Department is seeking significant pay raises for personnel in the Sheriff's and Jail depart-

ments. Carroll County's Budget Committee members met with elected officials and department directors on Friday to learn of the budgetary needs for the 2019-2020 fiscal year budget beginning in July.

Most department directors presented budgets with most increases, which include the two-percent increase in employee pay.

NASHVILLE — A McKenzie teacher is among thirty-one educators selected for the 2019-20 class of the Tennessee Educator Fellowship through a competitive admissions process, the State Collaborative on Reforming Education (SCORE) announced.

Carol Nanney, McKenzie Elementary School librarian is among the honorees. Nanney was the West Tennessee Teacher of the Year in 2017 and a finalist for Teacher of the Year for the state of Tennessee.

Nanney graduated from McKenzie High School in 1989. She completed her Bachelor of Science in Elementary Education in 1993 and her Master's Degree in

Carroll County Approves Industrial Access Road

HUNTINGDON — Carroll County commissioners approved a contract with the Tennessee Department of Transportation to construct an industrial access road for Pottery Direct in the industrial park at the Carroll County Airport. The proposed work is along Rochelle Store Road.

Last year, the county budgeted \$25,000 during this fiscal year to construct a road, however, after Mayor Joseph Butler worked with the Tennessee Department of Transportation, the department has agreed to participate and construct an industrial-grade access road to

Ambushed City Marshal A.D. Bryant Memorialized

McKENZIE/WASHINGTON DC — A McKenzie city marshal, who was slain during an ambush on December 7, 1898 in McKenzie, Tennessee, was memorialized in two ceremonies on Monday, May 13.

McKenzie Police Department memorialize Bryant at Mount Olivet Cemetery at his grave site at 11 a.m. A second ceremony included the name of A.D. Bryant in the National Law Enforcement Officer Memorial on Monday evening in Washington, D.C.

Police Chief Craig Moates and Mayor Jill Holland led a memorial at Mt. Olivet, the headstone of Bryant. Police officers heard the story of A.D. Bryant and how he met his demise. A wreath was situated adjacent to the headstone.

Moates first learned of the tragic death when a retired capitol policeman in Wyoming discovered the information. Jere Cox at the Gordon Browning Museum in downtown McKenzie helped in the

research of the event.

Chief Moates said City Marshal A.D. Bryant was killed in the line of duty while eating supper. He was ambushed and shot in the head twice. The perpetrator was previously arrested by Bryant, incarcerated, and released on bond. When he was released, he found Bryant in the telegraph office at the railroad depot and shot him. The perpetrator escaped and drank poison to commit suicide.

Mayor Jill Holland read a script that indicated Bryant was born September 15, 1842, served in the Civil War, 22nd Tennessee Confederate Infantry, and married Aletha M. Quinn in 1866. She and he owned the Quinn House. He served as the city marshal five to six times in his career.

According to excerpts from the Carroll County Democrat in 1933, up until City Marshal Dorsey Bryant's death, 29 lives within 30 years were snuffed out during drunken brawls or

men crazed by liquor.

The newspaper stated the citizens were more or less indifferent to the true conditions until the climax came with Marshal Bryant was shot down in cold-blooded murder while on duty at his station (railroad depot-ticket/telegraph office) by a whiskey-crazed man.

His death stirred the townspeople as they had not been before and the following night, a group of Christian men, led by ministers, met at the Cumberland Presbyterian Church and organized a law and order league.

In 1899, legislation was introduced to prohibit liquor in the City of McKenzie. Victory was won and McKenzie was the first town in Tennessee to abolish the open saloon.

Moates said Bryant's death was not in vain because the citizens took action to remedy the problem of drunkenness in the city.



Sergeant Andy Weaver Surprises Daughter on Return from Deployment

McKENZIE (May 10) — Sergeant Andy Weaver returned home Friday from a 10-month deployment to Poland with the 278th Armor Calvary of the U.S. Army. His specialty is a gunner on a M1A1 Abrams tank.

He and his wife, Callan (Hayes) Weaver made a visit to McKenzie Elementary School to

surprise their daughter, Rena, age 6.

As Rena's class entered the playground, she spotted her dad sitting at the foot of some play equipment. Pausing momentarily to evaluate who she just saw for the first time in 10 months, she quickened her step toward her father, leaped into his arms

and gave him a hug. Her shirt read "Daddy is my hero."

Soon, other children were gathering around, some even giving Sergeant Weaver a hug.

Weaver has been in the Army-National Guard for nine years. He is also a sergeant with the McKenzie Police Department.

serve Pottery Direct, which will start construction later this year. The industrial road will serve

one industrial site and provide access for future development. The total project is expected to cost over \$1 million, with the county's outlay under \$25,000.

In other business, the commission applied for a litter and trash grant from TDOT, appointed Johnny Blount to the Audit

Committee, and approved a budgetary transfer of \$13,435.75 for proceeds from the insurance company to cover vehicle damage in the Sheriff's Department.

Commissioners convene the second Monday night of each month, except July, December, and February.

Peg Hamlett, administration of elections, said the county is

needing new voting machines to replace the 13-year old machines at the end of their life cycle. She also said the commission needs new computer systems because the present aged machines cannot be upgraded to meet new cybersecurity standards. New machines will cost the county \$99,000 after a \$210,000 Help America Vote Act. The new machines will be touchscreen and print a matching paper ballot to review before finally being placed in an optical scanner to record the vote. The machines need to be purchased and available by the fall of 2019, said Hamlett.

She said three voting precincts are being closed and merged with other precincts. Macedonia will now vote at the former Cannon School, and Buena Vista and Vale will vote at Hollow Rock. The reason for the consolidation is the lack of poll workers on election day. She noted the office's computer must all be replaced with newer models to meet state cybersecurity standards.

Sheriff Andy Dickson requested significant pay increases to more closely match the \$3 per hour McKenzie City Council recently granted its officers as part of an effort to retain certified officers. The raise was granted, in part, because certified officers were leaving MPD for the CCSO and other departments, where pay was better. Dickson requested pay raises totaling \$125,000 for deputies, investigators, and salary supplements for the Sheriff's Department. Dickson additionally requested a raise of \$1 per hour, or a total of \$118,000 in raises for dispatchers, correctional officers, clerical, cafeteria, maintenance, part-time personnel, and overtime for the Jail. Dickson referred to the successful lawsuit former Sheriff Bendell Bartholomew filed against the county to receive pay increases and additional law enforcement personnel.

Overall, Dickson's requests increase the budget by \$163,872 in the Sheriff's Department for a total budget of \$2,310,873. The

proposed Jail and dispatch budget increases \$195,349 for a total budget of \$2,719,611. Dickson also mentioned the possibility of adding longevity pay to help in retention. He noted two recent employees who left law enforcement for other lines of work.

He requested an increase in the water/sewer budget because of the greater number of inmates and the cost-rate increase by the Town of Huntingdon.

Carroll County Jail provides two hot meals daily to prisoners, said Dickson, at a cost of approximately \$4 daily. He also noted the Sheriff's Department has 11 vehicles in its fleet that were purchased by the Drug Task Force, saving the local taxpayers the cost of those vehicles.

In the Solid Waste/Recycling Department, director Jeff Heyduck said the overall cost of collection and disposal of solid waste by new contractor Red River will save the county \$71,577 annually. He noted the new company will distribute its rolling waste carts to each rural residence in June and Republic Services, the current contract, will pick up its rolling carts on the last collection of solid waste in June.

Rural customers can pay the \$18 monthly charge with an automatic bank draft or credit card later in the year. A convenience fee will be applied for the use of a credit card.

Carroll County implemented mandatory solid waste collection for rural residences in 1984.

The General Sessions and Circuit Court clerks' offices will require new computers, said Sarah Bradberry, Circuit Court Clerk. The new current computers are using Window 7 operating system, which is no longer supported. She noted seven computers will need to be replaced along with the software. She also requested funding for a wireless network in the courtrooms to support lawyers and prosecutors, who retrieve documents or videos over the Internet for use during hearings.

Clerk and Master Kenneth Todd said the Chancery Court offices must also have new computers to run the new software. He noted the court presently does not have a chancellor since Carma McGee was appointed to the Court of Appeals. Circuit

court judges Donald Parish and

Creed McGinley along with senior judges are serving the docket. Todd said he hopes Governor Lee soon appoints someone to fill the vacancy.

County Fire Chief Terry Bradshaw said he needs a new passenger vehicle since his has high mileage and prone to disrepair. It has been towed twice recently, said Bradshaw. He said the department operates 12 rural stations with 150 volunteer firefighters. The department will need new turnout gear for some firefighters and the self-contained air bottles for their breathing apparatus.

John McAdams, director of Carroll County School, said the department does not need any additional funding. It closed its Special Learning Center during the current fiscal year at the mandate by the state. The school previously contracted with the county's five special school district to transport and teach many of the county's special needs/special education students in one location. The state declared the students must return to their home school district and be educated. The school district operates the county's student transportation system and the centralized high school vocational school. Overall, the school district has \$8 million in reserve funds.

Former Carroll County Librarian Nikki Cunningham spoke on behalf of a pay raise for the librarian. She noted the Carroll County Library is ranked 50th of 52 in pay for public libraries the size of Carroll County. Previously, the Budget Committee committed to raise the pay to \$30,000 annually beginning July 1.

In miscellaneous budgets, the Parks and Fair Board will hire a new director of the Carroll County Civic Center with the retirement of Mike Tolley. Mayor Joseph Butler said the director will receive a salary increase.

Also in the miscellaneous category, the county will spend \$115,000 to erect a antenna tower in the Westport area to install antennas for the sheriff's department and fire department. Radio communication in the area is not possible after an area elevated tower was razed. It was owned by Charter and also had the county's antenna on it.

Curriculum and Instruction in 1996, both from Bethel College. She continued with her Masters in Education at Cumberland University, then achieved her Librarian’s Certification from Union University in 2003.

She taught second grade at McKenzie Elementary for 12 years, and has been the librarian for another 14. She has accepted the position of librarian at McKenzie High School beginning in the 2019-2020 school year.

She lives in McKenzie with her husband, Tim Nanney. They have two children, Braden, a 2019 graduate at Bethel University, and Nathan, a student at McKenzie High School.

She is an active member of the First Cumberland Presbyterian Church, where she leads the Children’s Service.

“The Tennessee Educator Fellowship convenes talented and driven educators who are relentless advocates for improving student achievement through student-focused policies and practices,” SCORE President and CEO David Mansouri said. “The fellows bring unique and diverse perspectives and experiences that are invaluable as they participate in local and state-level conversations about preparing all students for success in college, career and life.”

The Tennessee Educator Fellowship is a year-long program that equips teachers, school counselors, interventionists and librarians to learn about education policy and advocate for their students and their profession. The educators chosen this year work in a variety of settings: traditional public schools, public magnet schools and public charter schools.

Since 2014, the fellowship has supported more than 180 educators to engage in critical discussions about education policy by speaking at public events, inviting policymakers into their classrooms, writing about their experiences in state and national publications, creating regional professional networks and serving on state-level policy committees.

“The 31 fellows – from different backgrounds, grade levels, subjects and regions of the state – bring diverse perspectives to policy and practice conversations with a clear focus on greater academic growth and opportunities for all Tennessee students,” SCORE Educator Engagement Associate Leigh Cooksey said.

This is the sixth year of the Tennessee Educator Fellowship. The fellows chosen for the 2019-20 cohort have a combined teaching experience of 358 years and represent elementary, middle and high schools in 26 districts across East, Middle and West Tennessee. The members of this cohort teach English language arts, math, science, social studies, STEM, construction trades and special education in urban, suburban and rural schools. The cohort also includes educators who serve as school counselors, a librarian and an educator who teaches English language learners.

The local 2019-20 Tennessee Educator Fellows are:

Linda Biggers teaches eighth-grade English language arts at Milan Middle School in Milan Special School District. Biggers has been teaching for 15 years.

Crystal Brooks teaches second-grade English language arts and math at Thelma Barker Elementary School in Jackson-Madison County Schools. Brooks has been teaching for three years.

John Graham teaches high school construction and wellness at Union City High School in Union City Schools. Graham has been teaching for seven years.

Ashley James teaches kindergarten at WG Rhea Elementary School in Paris Special School District. James has been teaching for 13 years.

Carol Nanney is a librarian at McKenzie High School in the McKenzie Special School District. Nanney has been in education for 26 years.

Kenya Turner is a school counselor at Humboldt Junior and Senior High School in Humboldt City Schools. Turner has been in education for 15 years.

Past fellows have led new education initiatives and worked to improve outcomes for all students. Their work has included advocating for the use of high-quality instructional materials; starting a leadership academy for students to explore a career in teaching; bringing community leaders into classrooms to discuss the importance of literacy in their careers; expanding access to early postsecondary opportunities for students; amplifying the voice, presence and support for educators of color; and much more. Fellows also have engaged in education conversations at the local, state and national levels and written op-eds and blog posts for news and education outlets, including The Tennessean, Education Post and Hechinger Report.

Throughout the upcoming year, the fellows will learn through in-person and online convenings and will serve as liaisons between their colleagues, their communities and policymakers as Tennessee continues the work of improving academic achievement for all students.

The State Collaborative on Reforming Education (SCORE) works with state, local and national partners to advance policies and practices for greater student success across Tennessee. 64-year old Sara (Sally) Aylor also of McLemoresville. The accident also left Aylor’s husband George injured. Cockrill’s indictment also included Vehicular Assault, Aggravated Vehicular Assault, and DUI-First Offense.

Cassius Sinclair Jordan of McKenzie was indicted for Especially Aggravated Kidnapping and 3 counts of Aggravated Assault following a disturbance in August 2018. A 911 call sent McKenzie Police to a Kay Street residence where officers located, Jessica Rhoades, the 911 caller, who stated that Jordan told her if she didn’t help him rob the homeowner, he would kill him and knock out the other female visitor in the house.

The Grocery Chain that Changed The Face of McKenzie – Part II

The following is a continuation from the previous edition. The information was written by Mary Lou Carlisle for The McKenzie Banner in May 1956.

Growth of the U-Tote-'Em Chain Stores

In 1935 an experimental corn processing plant was installed to convert locally grown corn into finished products. This provided a cash market for the farmer's grain and in turn provided the community with corn meal and other finished products at 25 percent less cost.

The experiment not only proved worthwhile for the farmers, but it turned out to be a paying proposition for the company. At that time, they felt justified in installing a larger corn processing plant and grain elevator. A few years later the plant built in 1935 could not longer meet the demand.

Therefore, they began the process of enlarging the storage and shipping capacity, which is still continuing. The present milling plant is one of the largest and most modern all-electric plant of its kind in West Tennessee.

The Keco Milling Company,

whose title is derived from the initials of its marker partners (Glen A. King and Ben T. Everett), receives grain from several states. It ships finished products to ten states – Arkansas, Alabama, Mississippi, Missouri, Kentucky, Tennessee, Iowa, Illinois, Louisiana, and North Carolina. This is a reverse situation which existed in the previous years.

The milling company blends the U-Tote-'Em brands of flour, corn meal, a new product – hush puppy mix, and all kinds of poultry and livestock feed. In recent years pellet machines have been installed.

When the trend for self-service super markets swept the country, U-Tote-'Em began the task of converting the old-time cracker barrel stores into modern super markets. The first was installed in Paris, Tennessee, in 1947. From then until the present time, practically all of the stores have been changed over into modern super markets with a larger variety of merchandise. The majority have been moved to the suburban areas of town with plenty of parking space provided. The stores have all the convenience and comforts which make customer's shopping a pleasure instead of a task.

The operation of a few of the smaller old-time stores has been discontinued. At present U-Tote-'Em is operating 29



stores in West Kentucky and West Tennessee.

U-Tote-'Em selects the managers of its stores from among the employees. Several hundred men and women are employed for the stores, warehouse, and the milling company. The owners instituted a profit-sharing plan for the workers.

In 1954, the King and Everett partnership which had persisted since 1918 was dissolved. The Kings bought the Everetts' share of the business. The two partners had worked long and hard, and had shared the many difficulties of the earlier development of the company.

Although Mr. King has no intention of retiring very soon from the management of U-Tote-'Em affairs, he brought his children into the firm as junior partners. He expects them some day to continue the family-owned, family-operated tradition. Chandler King, the eldest son, is the buyer for the firm. Jerry, the second son, is the general manager of the Keco Milling Company. Glen Jr., the youngest son, is the advertising manager for the firm.

The stores, the Cash Economy Wholesale Grocery Company (the wholesale buying and warehousing department), and the Keco Milling Company are highly organized and to a considerable extent self-sufficient. The U-Tote-'Em tradition is persistent and profitable. They

believe in the simple formula "Make your customer your friends."

The U-Tote-'Em grocery chain continued on a few years past 1956. The chain was eventually sold to another chain and is no longer in existence.

In 1961, the warehouse became Southern Biological Supply Company, owned by Chandler and Sybil King; which was torn down in 1918. The Keco Milling Company lasted several years and under various handlers. The building is now occupied by Dale's Recycling.

When We Got to Be We

The first time I consciously appreciated summer was after I had been captured and held against my will in the first grade for nine months. I was a bit "shaken" by the daunts of adding and subtracting whole numbers, spelling bees and Suzie Cozart sitting two inches behind me. The walls crept closer with each passing reading class. We threw rocks at Pet Milk Cans perched high on fence posts.

It wasn't that we were against school in the summer of 1954. It was just that the alternative was so much better!

Every day was bright and sunny. And we met it with equal hope and anticipation. We didn't invent the term "living large" but we took it to new heights!

The lesson was obvious, noteworthy, and eternal: We didn't

want to be someone else. Or anywhere else. We didn't want to be 16 and driving. We were not interested in dating. Marriage and children were for our parents for goodness sakes! We didn't dwell on having to get a job one day.

Here and now for us was... here and now!

You'd a'thought we had life by the tail. Forever!

The line at the water fountain and the smell of chalk dust jolted us back to reality. And again, we were not anti-second grade; we were pro freedom. Plus, you could almost see the baseball field in Paul David Campbell's backyard from the school house window.

The second grade ending May never captured the old magic. Maybe the moment had passed. We were eight that summer and we didn't have time for high fly-

ing birds or Mr. Archie's cattle. We had Little League tryouts. And that was too big a deal for idyllic lollygagging...

Maybe we spent the rest of our summers looking too far forward!

By the end of the sixth grade we had junior high to worry about. Our lockers would be out in the hall. We had to change classes for goodness sakes. By the end of the next year Suzie Cozart was sitting too far away from me!

The day after graduating from high school didn't find me out by the mimosa tree. I was too busy looking for a college that might take me. And the summer after that I was so busy working to pay for my next tuition I missed the roses again.

And then I married. Got a job. Had children...

I understand that life changes

us. That we have to shift to be what we need to be...or should be... And, believe me, life is great even when it's not about running barefooted down the Como Road.

But I believe with all my heart everyone needs a summer of 1954 in their life. For perspective maybe. To smile about in dark times perhaps. To pass on to young loved ones. To look back at with the sheer laughter and joy... that made it so special in the first place!

I wouldn't bemoan and kick the dog that life maybe kept you from ever getting back to such a place... I'd thank the mimosa tree, Tarzan, Miss Brooks and God for the special memory that time, space and happenstance can never take away.

One Ring Phone Scam Could be Costly

Consumers Should Not Call Back Unknown Late-Night Callers Using the '222' West African Country Code

WASHINGTON (May 3) — The Federal Communications Commission is alerting consumers to reported waves of "One Ring" or "Wangiri" scam robocalls targeting specific area codes in bursts, often calling multiple times in the middle of the night. These calls are likely trying to prompt consumers to call the number back, often resulting in per minute toll charges similar to a 900 number. Consumers should not call these numbers back.

Recent reports indicate these calls are using the "222" country code of the West African nation of Mauritania. News reports have indicated widespread overnight calling in New York State and Arizona.

Generally, the One Ring scam takes place when a robocaller calls a number and hangs up after a ring or two. They may call repeatedly, hoping the consumer calls back and runs up a toll that is largely paid to the scammer.

Consumer Tips:

Do not call back numbers you do not recognize, especially those appearing to originate overseas.

• File a complaint with the FCC if you received these calls: www.fcc.gov/complaints

• If you never make international calls, consider talking to your phone company about blocking outbound international calls to prevent accidental toll calls.

• Check your phone bill for charges you don't recognize.

Advances in technology allow massive amounts of calls to be made cheaply and easily. In addition, spoofing tools make it easy for scammers to mask their identity. The FCC is working to combat scam calls with enforcement actions, a strong push for caller ID au-

thentication, and support for call blocking tools. Another key tool is consumer education like this alert and the FCC's One Ring scam consumer guide: <https://t.co/pROJ0ldMXv>



Then develop a plan to become the person you long to be. And finally, put the plan into action. As a good friend of mine likes to say, “Plan the work and work the plan.” Remember also to make adjustments to the plan if it isn't going perfectly. Some adjustments or corrections are needed in even the best plans.

McKenzie City Council
Approves Bids for
Sewer Rehabilitation

The McKenzie City Council unanimously approved a pair of bids for the upcoming sewer and wastewater treatment plant improvements. Bids were accepted on two separate contracts with Contract A focusing on Sanitary Sewer Improvements and Contract B focusing on Wastewater Treatment Plant Improvements. Encsor, LLC won the bid for Contract A-Sanitary Sewer Improvements bidding \$889,640 on the work. Miller Contractors, Inc. won the bid for Contract B-Wastewater Treatment Plant Improvements totaling \$667,634. These bids are tentatively subject to approval from U.S. Rural Development.

After hearing the City Park was having issues with dogs and young children being left unattended during park activities, the Council approved a Park & Recreation Ordinance that 'put teeth' in rules that already existed for conduct at the park. The Ordinance allows fines to be levied at a maximum of \$50 per day for violations of park rules. These rules include children age 14 and under being accompanied by adults, no pets, except service animals and those must be appropriately restrained, smoking or tobacco products of any kind outside of designated areas, no alcoholic beverages or illegal substances of any kind, and fighting or any aggressive behavior.

Mayor Jill Holland announced bids would be opened for solid waste disposal at 2 p.m. May 20 with a called council meeting on May 23 at 5:30 p.m. to discuss and approve the winning bid.

Council members approved a recommendation from Mayor Holland to include Bethel University's 1842 Society to the City's annual donation list and tabled a proposal for advance notice of citizen's input. Several council members were not in favor of the idea but no action was taken other than tabling the matter until June's meeting.

McKenzie School Board Honors Two Retirees

McKenzie’s School Board met in their final session prior to the school’s summer vacation. They opened the meeting recognizing retiring High School Librarian Mona Batchelor and Education Assistant Renee Brown. Batchelor spent the last 10 years as MHS’s librarian while Brown spent 23 years in the school system spending time in each of the three schools.

School Director Lynn Watkins thanked both of them for their service and gave them gifts from the board and school system. The two will be honored May 20 at a retirement luncheon given by the McKenzie Education Association.

Coordinated School Health Supervisor Mandy Drewery, along with her assistant Jennifer Medford, gave a presentation covering what the program had done in the school system during the year.

Wellness screenings were done in grades K, 2, 4, 6, 8 and High school focusing on basic health such as height, weight, body mass, etc. Coordinated health sponsored a “Walk To School Day” which had 212 students participate along with family members.

McKenzie’s freshman class participated in a county-wide Teen Summit that focused on bullying.

Coordinated School Health made contributions to the McKenzie School System totaling \$5017.41 for a variety of different things related to the school health program.

A new program will be coming to Coordinated Health next school year called “Be In The Zone” It is a teen driving program sponsored by Vanderbilt Hospital through Coordinated School Health. It is only being done in 11-12 schools in the Nashville area because of the proximity to Vandy.

Jennifer Medford told the board and audience that she learned of the program while visiting Vanderbilt and was able to get access to the program due to the traffic accident involving multiple teens of which one was airlifted to Vanderbilt earlier this year.

Following the presentation, Director Watkins introduced Drew Beeler as the new student representative to the school board for the next school year. Later in the meeting, he recognized outgoing student representative Isabella Colotta for her efforts during the school year.

Colotta received compliments from board members for her consistent attendance and participation in the school board’s work during the year. She was presented with a gift from the board.

The school board approved high school instructional fees for the upcoming school year. These include fees for all science classes being \$15, Art-\$15, Biology II Lab Manual-\$17.50, Driver Education-\$45, Computer-\$5, Accounting materials-\$27, Health Science-\$15, Health Science Scrubs-\$40, TN Ready Test Prep-\$5, Diploma/Diploma Cover-\$26, Cap and Gown-\$44, and Student Professional Health Liability Insurance-\$15.

The board also approved the lone middle school instructional fee of \$10 for all science lab classes and \$20 to be the instructional fee for all elementary school grades K-4.

During the director’s report, Watkins advised the board they needed to schedule a workshop date to work on next year’s school budget and update the school system’s 5-year strategic plan.

The board agreed on June 11 at 5:30 p.m. for the workshop at which time a called school board meeting will be scheduled to approve the school budget prior to the new fiscal year beginning July 1.

The Director’s Report also included four teachers who have tendered their resignations including Anna Trull, Renee Hob-

son, Misty Logan, and Donna Simmons. It was also learned prior to the board meeting that elementary school principal Tim Barker has also tendered his resignation.

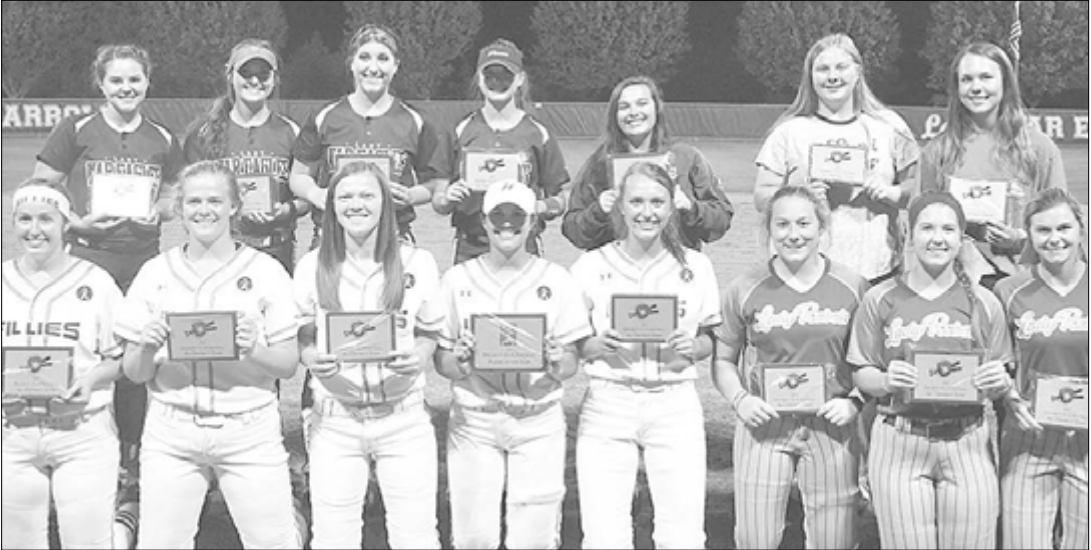

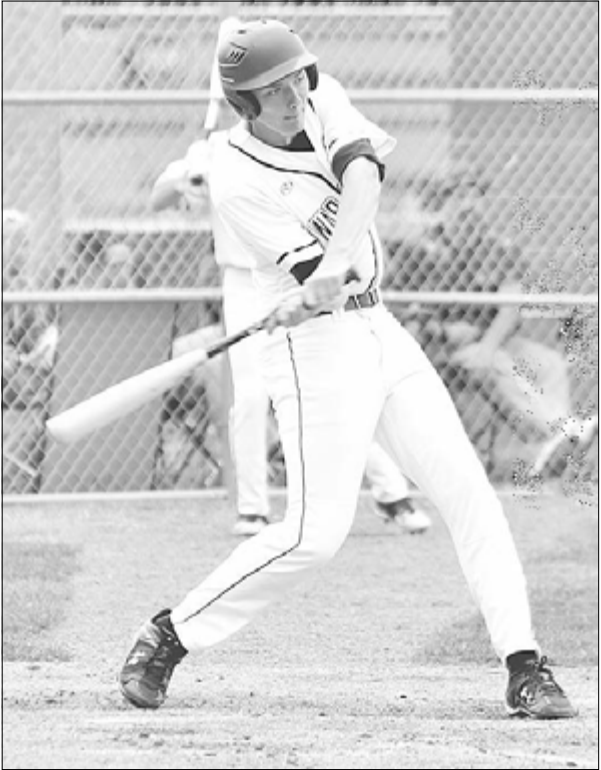

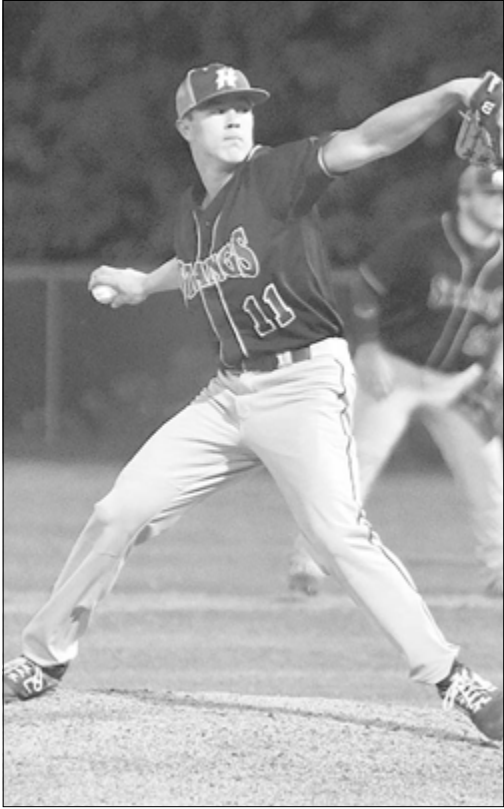
