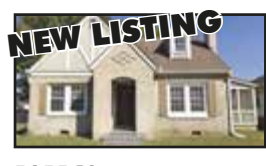

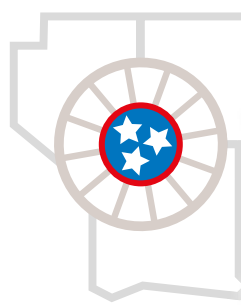

McKenzie Trooper Arrested for DUI, Resigns

PARIS (October 14) — An off-duty Tennessee Highway Patrol trooper was arrested Monday morning on charges of DUI first offense, violation of implied consent and possession of a weapon while intoxicated.

Trooper Daryl Veliz, 36, of McKenzie, was reportedly placed on discretionary leave with pay pending an internal investigation by the

THP, but Lt. Brad Wilbanks has confirmed Veliz resigned Wednesday.

According to the police report, a Paris Police officer observed a Ford pickup truck running off the roadway around 5 a.m. Monday. The officer saw Veliz slumped over in the seat. The officer also saw open containers of alcohol in plain view inside the truck, and officers recovered a loaded Smith & Wesson .380 handgun inside the vehicle.

Veliz performed poorly in the field sobriety test, according to the report.

Huntingdon School Board To Visit Schools In December

HUNTINGDON (October 17) — Members of the Huntingdon School Board plan their annual visit to each of the three school sites in December to visit with administrators and teachers to learn about their wants and needs for their students.

Called the "joint venture," the process starts at 7 a.m. with a school board meeting listening to the school principals and hearing progress reports and then moving to the primary, middle, and high school buildings.

Last year, Chairman Lee Carter said the "needs" list of items is shrinking at each of the schools.

Huntingdon is the lone school district in the county conducting such a listening tour.

2019 Youth Achievement Award

The Youth Achievement Award is not an annual award, it is awarded to young people for outstanding achievements beyond the state level. Tonight we have chosen to present it to someone who has brought recognition to his school and his hometown and who has distinguished himself on the local, state, and national levels. Keller Smith is a freshman at Huntingdon High School. Last May, as an eighth-grader at Huntingdon Middle School, he competed in the Scripps National Spelling Bee in Washington, D.C. Keller is the 21st recipient of the Youth Achievement Award and the fourth National Spelling Bee participant to be honored with this award.

On his way to the national bee, Keller won his fourth consecutive spelling bee at his school in Huntingdon in December. He then advanced to compete in the regional competition in Nashville in February at the Tennessee Titans Regional Spelling Bee. Out of 48 contestants, Keller correctly spelled his way into the top two and earned a berth in the Scripps National Spelling Bee in May to represent the State of Tennessee. And—just to point out the toughness of the national spelling bee competition—eight spellers all tied for first place when the announcer ran out of

Palestine Church Vandalized

The Carroll County Sheriff's Department received a call on Wednesday, October 16, that the Palestine Church on Highway 424 in Cedar Grove was vandalized. According to the report filed by Deputy Michael Seavans, all of the storm windows of the church were broken including some metal frames. The lectern was thrown from the pulpit and broken apart. The piano was moved from the back wall and flipped over on the front side. The back door

was found shattered. Two holes in the floor were created by large rocks. The floor boards were ripped off the floor and thrown into the hole. Four of the church pews were thrown through the windows and left dangling. The front double door windows were broken out of the door. No suspects were identified at the time of the report. The incident remains under investigation.

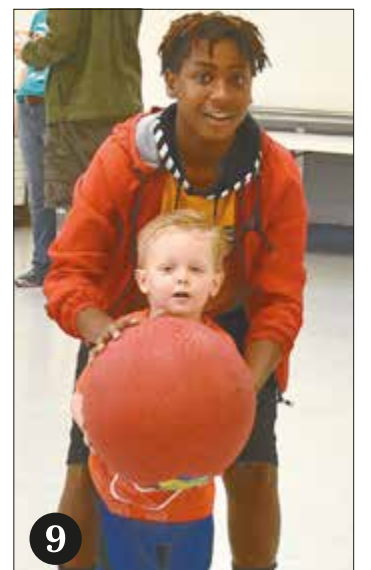

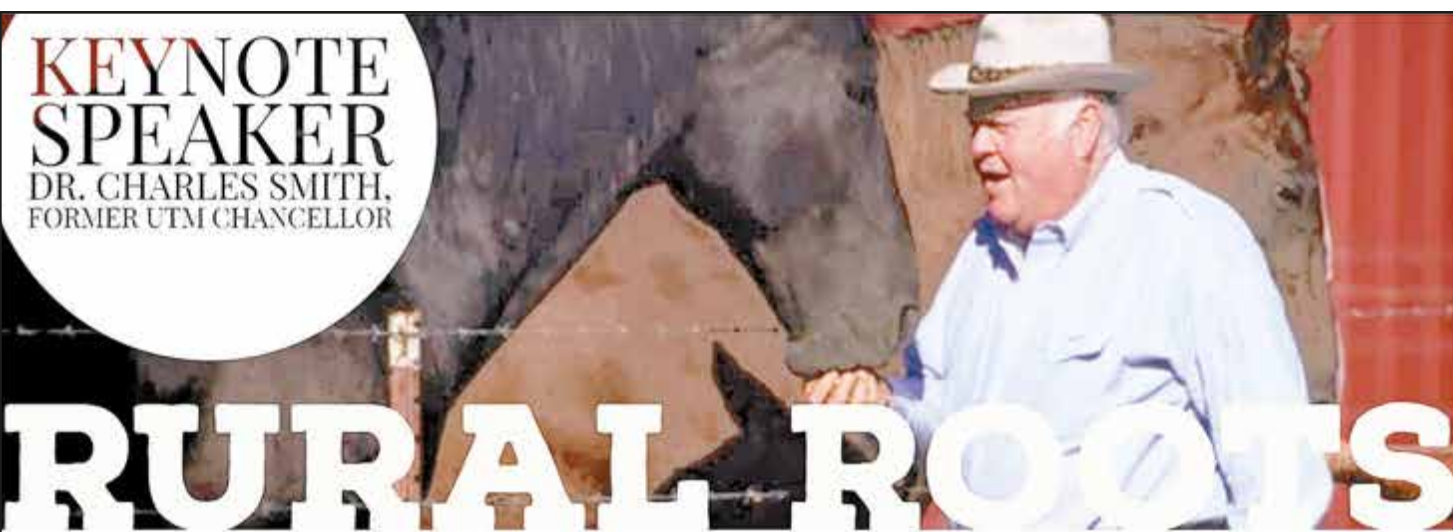

McKenzie Middle Holds Third Annual Service Day

McKENZIE (October 11) — McKenzie Middle School continued a new tradition by giving back to the community with a Service Day on the Friday before Fall Break.

The third-annual event saw some of its activities hindered by rain, but that didn't dampen the spirit of giving and cooperation that the students and staff spread throughout the city.

In the first two years, students were split up by grade level, but this time, they did things a little differently. At the beginning of the school year, a new initiative was enacted, spearheaded by seventh grade math teacher Beth Mathis, based on the "house" system from Harry Potter. Some went to the elementary school to read with students and assist in the school's workroom. Others went to Head Start/Early Head Start to play with the young children there and do some chores.

Groups went to Lakeside Senior Living, McKenzie Healthcare and Christian Care Center to spend time with residents. A group did a variety of chores at the local VFW.

Others went downtown to help clean up the public areas and help the city prepare for upcoming activities such as the Boo Bash and Hometown Christmas. Some helped wash emergency vehicles at the firehouse.

Groups traveled to Bethel's Wildcat Stadium and the City Park to do some clean-up.

After the kids had worked hard for several hours, everyone returned to the school and met with their respective houses. The houses discussed the "Essential 55 Rules" listed by Ron Clark, the award-winning educator and best-selling author who created the house system. Members of each house selected the five rules which they believe in the most.

Students and staff alike made a difference in their community once again before a well-deserved Fall Break.

sion on Thursday, October 17 at 7 a.m., approved school policies on testing and fundraising activities.

ThReady and End of Course scores shall be included in the

students' final grades as follows: Grades 3-12, 15 percent.

Students in seventh grade will have interest inventories to determine their personal interest in careers. Eighth graders will be administered a career aptitude assessment to help determine the high school plan of study.

On fundraising, with the approval of the principal, an employee may be authorized to

raise and use funds for the following non-educational purposes" bereavement support, award recognition, employee morale, banquets, or other situations at the principal's discretion. The director of schools will develop administrative processes regarding the receipt, disbursement, accounting, and auditing of these noneducational funds.

Youth Deer Hunts Start This Weekend

NASHVILLE — The first of two Tennessee young sportsman deer hunts for the 2019-20 season is the weekend of October 26-27.

Youth ages 6-16 years of age may participate. Participating youth can use gun, muzzleloader, and archery equipment.

Young sportsmen must be accompanied by a non-hunting adult, 21 or older who must remain in position to take immediate control of the hunting device. The adult must also comply with the fluorescent orange

regulations as specified for legal hunters. Multiple youth may be accompanied by a single qualifying adult.

Archery season began in the state on September 28 and the first segment ends October 25, the day prior to the opening of the young sportsman hunt. The second segment of archery only season is Monday, October 28 through Friday, November 8. Muzzleloader/archery season starts November 9.

The TWRA makes the recom-

mendation that all hunters obtain a 2019-20 Tennessee Hunting and Trapping Guide. The guide lists license requirements, the counties and bag limits for each of the different deer management units. The guide is available on the TWRA website. www.tnwildlife.org, the TWRA App, and where hunting and fishing licenses are sold.

In 2018, youth hunters harvested a total 5,379 deer during the first weekend. The total included 2,700 bucks.

Smith Farms was started in the late 1970s when brothers Bobby and Donnie Smith joined together in a part-time farming operation on the family farm located in Westport Tennessee. Starting with a couple of old tractors, a planter, and a pull-type combine, they farmed in the evenings and weekends while holding down full-time jobs.

By 1985, the brothers had purchased land in Buena Vista, which became the center of operations. In 1993, Bobby's son, Brad Smith, joined the family business, and the business expanded. Brad serves the agricultural community as President of Carroll Farmers Co-op Board of Directors, serves on the Board of Directors of the Carroll County Farm Bureau, and is a past Zone Director of the Farm Service Agency.

Smith Farms farms 2,800 acres of corn and soybeans, which are located in the communities of Buena Vista, Westport, Hollow Rock, Bruceton, and Huntingdon. In addition to their row crop production, they have a cow/calf operation. Daniel Hilliard, who was hired in 2014, is the only full-time employee.

Bobby lives in Huntingdon, Donnie in Buena Vista, and Brad in Yuma. The family knows farming takes a lot of faith and trust in the Lord from the time the seeds are planted until time for harvest.

John D'Adamio's hard work and dedication, Wendy's of Huntingdon is better here.

John D'Adamio has been with Wendy's organization for twenty-eight years. He pinpoints the use of technology, healthier food choices, and more competition as the biggest changes he has seen in the food industry. John oversees fifty employees at Wendy's in Huntingdon.

John and his wife Susan will celebrate twenty-five years of marriage this year. The couple has a son, Jacob Smith; a daughter and son-in-law, Kimberly and Andrew Foster; and three grandchildren—Natalie, Lauren, and John David. John's mother is Adriana D'Adamio.

John stays active and supports his community as a member of the Carroll County Chamber of Commerce. He also is an ardent supporter of various sports teams and an avid golfer.

For the past several years, Judge Williams has served as chairman of the Tennessee Lawyers Assistance Program (TLAP). During his leadership, TLAP was recognized as one of the nation's leading programs helping law students, lawyers, and judges in coping with alcoholism, drug addiction, depression, suicide, and other mental health-related problems unique in the legal profession.

Judge Williams has authored and participated in thousands of cases in Tennessee. In the 2014 statewide judicial retention election, Judge John Everett Williams' name appeared as the last name on the ballot in the state. He received the highest vote total for retention of any member of his court. He received over 510,000 votes to retain.

Judge Williams has lived a very entertaining and full life. He is a member of the International Brotherhood of Magicians since 1998. You may have often seen him perform on the square, at birthday parties, or various events around the county. He is somewhat of a thespian, performing in various plays, including his portrayals of Mark Twain and Attorney Clarence Darrow.

He loves hunting and fishing.

He has two granddaughters, Emory and Everly, who are the light of his life. His family includes his son and daughter-in-law, J and Devon, and his brother and sister-in-law, Bob and Donna Williams.

2019 Carroll Countian of the Year

John Everett Williams is the 34th individual to be recognized as Carroll Countian of the Year by the Carroll County Chamber of Commerce.

John Everett Williams is a life-long resident of Carroll County. Born on Veterans Day, November 11, 1953, he will be 66 years old next month. He graduated from Huntingdon High School in 1971 and the University of Tennessee at Martin in 1977. Judge Williams had so much fun in college that he jokes he crammed four years of college into six.

The University of Tennessee at Martin called Judge Williams back in October 2015 and presented him with the first-ever Distinguished Criminal Justice Alumni Award.

Judge Williams attended law school in Birmingham, Alabama, at Cumberland School of Law, his father's alma mater. He was co-chairman of the Cordell Hull's Speakers Forum, which was named by the American Bar Association as being the Most Outstanding Student Bar Association project in the nation that year.

Upon graduating law school, Judge Williams was offered jobs in 25 states and two foreign countries. He is very happy and has never regretted that he chose to return to Huntingdon in Carroll County to establish his practice of law. Judge Williams and his father practiced law as Williams and Williams Attorneys at Law in Huntingdon for almost 20 years.

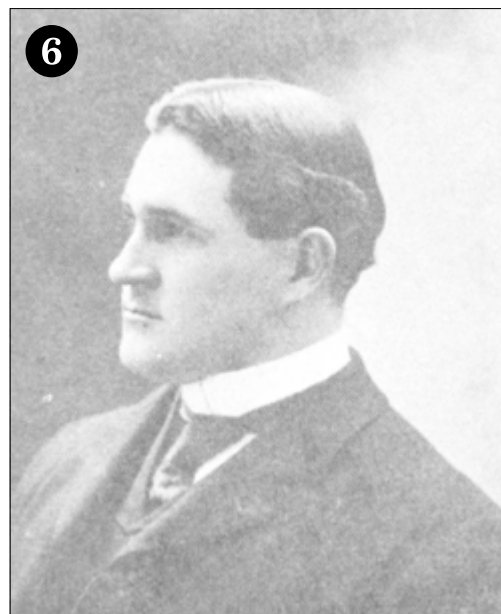
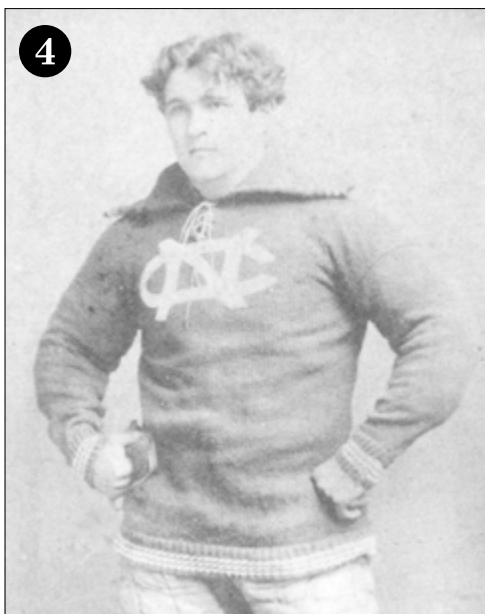
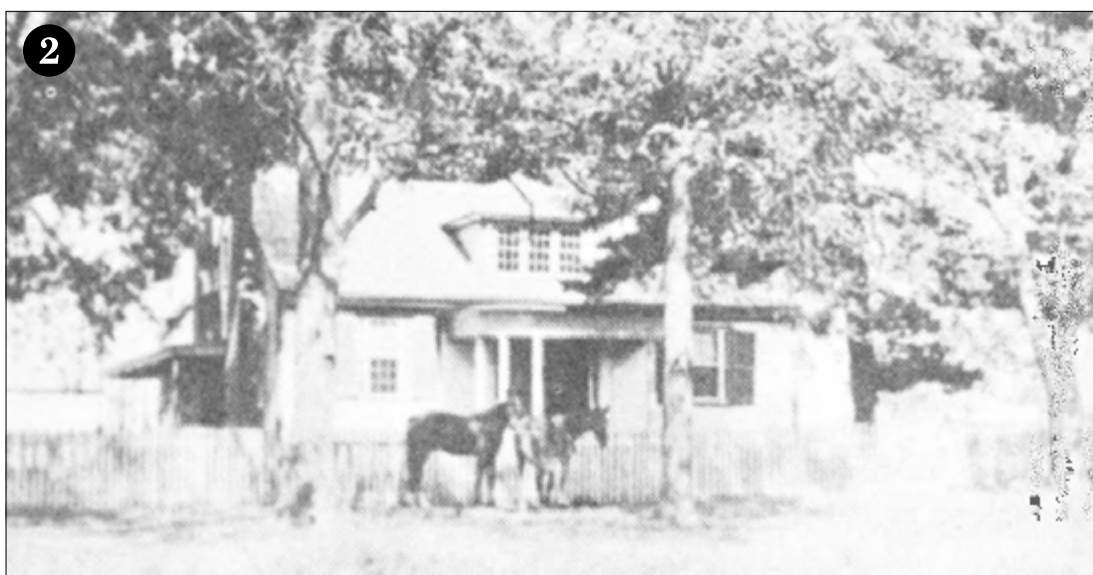

The Harris-Collier Family (Part I)

Doctor Harris T. Collier Who?

Recently I wanted to do a little research on families in McKenzie, and yes I have a list about as long as my leg. As I flipped through a book of McKenzie families, I came across the name Harris which to my knowledge isn't too common in the area. Against my better judgment I decided to take a gander on what was before me, and it was pretty interesting. So as always, I've decided to share the information with the public.

In 1854, Albert Gallatin and Pernecia Gilbert Harris built a home in Carroll County to raise a family. One of the children, Ada, was educated in Paris and at Professor Randal's Boarding School (McTyre School) in Caledonia. At the age of 20, Ada married Zachary Taylor Collier of Cottage Grove, Tenn. Zachary worked as a salesman

for a firm out of Louisville, Ky. During the 1880's they moved from Louisville and purchased Ada's homeplace from her parents. The young couple had two children, a son, Harris Taylor, and a daughter, Mary Ada. The family was very close-knit even with the father on the road. The following is a letter from Zachary to his 11-year-old son: *Cincinnati, February 14, 1886 My Dear Son,*

Your two letters were received last week. I am glad you captured the prize in writing. You will soon learn to write better than Papa if you will only take the pains to practice. I notice you make little I's this way -- i. You should make capital ones and always spell correctly. After you write your letters, get Mama to look over them and correct your errors then copy and you will

have it all right. I am glad your colt rides nicely, but I am afraid you will let her hurt you. You must let them go to the pasture everyday and get all the grass they can. I thought about my horse yesterday when the streetcar men struck and all the cars stopped. They settled everything satisfactorily, however, and they were all running again last night. Tell sister that I shall expect a letter from her next week.

*Affectionately,
Your Father,
Z.T. Collier*

Tragedy entered into the family's lives in 1895. While the family was living in Memphis, Mary died of pneumonia. She was only 18 years old and an accomplished pianist. It was rumored Ada never fully recovered from the loss of her daughter. Then in 1906, only eleven years later, Zachary died. The year prior they had moved back to country home in McKenzie.

Mary along with Harris, who at that point was a physician, lived on the family farm until 1918. It was at that point the home and farm were sold to Hayes Holland, father of Kermit Holland. Ada then purchased her uncle Gardner Gilbert's home at the corner of

Magnolia and Stonewall. In 1935, tragedy struck Ada again, this time it was the death of her son, Dr. Harris Collier. Four years later, Ada died at the age of 85.

Records note, Dr. Harris Collier was an outstanding athlete in his younger days. In an obituary story by Null Adams for the Memphis Press-Scimitar: *Altho Dr. Collier weighed 225 pounds, he was a 10-second tract man at Virginia. He was a great football player just as good at baseball. He was playing with Virginia against Yat at New Haven one year and hit the longest baseball ever hit. Boston tried to get him and so did the Giants. He played on that old Memphis Chickasaw team, one of the best Memphis ever saw. (Collier played for Memphis in 1900 as a pitcher).*

Dr. Collier graduated from the University of Virginia and from Tulane. He served his internship at New Orleans. He practiced medicine in Memphis and Osceola, Ark. before moving to McKenzie in 1906 to establish practice there. He was a surgeon in McKenzie for the L & N and NC & St. Louis Railroads.

At the time of his death, found amongst his possessions were two trophies with the fol-

lowing inscriptions: "1897. H.T. Collier, Throwing Hammer 81 ft. 9 in. University of Virginia" and "1897. H.T. Collier, 100 Yard Dash 10 4/5 Seconds. University of Virginia." He was offered several positions by professional baseball teams and there was a letter offering him the head football coaching position at the University of Ole Miss.

Doctor Collier along with wife, Mary Lewis Fields Collier, are buried in Mt. Olivet Cemetery. Their only child, Harris F., was a U.S. Army Air Corps captain. In 1943, he was killed when his bomber crashed and disintegrated two miles west of Donnelsville, Ohio.

After reading through all the content, I decided to use my favorite tool and "Googled" Harris Taylor Collier. Much to my surprise was even more content available about a man I have never heard of until today. He served as the head coach for Tulane in 1899 and Georgia Tech in 1900. His coaching record was nothing to brag about 0-10-1, but those are more college games than I've coached.

He began his college career at the University of North Carolina at Chapel Hill. He played on the football team in 1895 as a guard. According to a fraternity newsletter at Virginia, he

was considered "one of the best tackles Virginia has ever had," holding the position of football team captain in 1898. The yearbook, Corks and Curls ranked him as the best "all-around athlete."

So I guess the moral of the story is, if you don't know who they are, and you don't want to read about them, read it anyway. You might just learn something.

I accidentally ran into Graylene on the way home. She offered me a ride in the back of her Aunt Opal's pickup the eleven miles over to the fair in Huntingdon. It just so happened that Mr. Brooks had accidentally left my check for picking cotton back at his house when he paid off Friday. I did have some money!

And I'm telling you it was the accident of all accidents running into Mary Hadley in the line at the Ferris wheel. I couldn't tell if it was an accident or just plain old bad luck that Millicent walked by just as we were getting off the ride together!

I figure that was three and a half Carroll County accidents that Porter had not sung about. I don't think the fact that Millicent Blackburn never spoke to

me again, ever...was an accident at all!

The fire in the attic was certainly an accident. And it was all Leon's fault. He brought the matches home. Left them right on the table. In plain sight. Anybody could walk by and pick'em up.

I didn't dare strike one in the bedroom. Mom could smell that from the kitchen. I sneaked a couple upstairs and wondered if a baseball card would flame up or just kind of melt if you stuck a match to it. I had an extra 1959 Jerry Lumpe card. And I didn't like the Yankees much anyway.

The answer is...it will flame up. Quicker than you think! I realized as the card blazed in my hand I didn't have a "put it out" plan. The bathroom and kitchen sink were downstairs where Mom was keeping vigilance. Waving it real fast in hope the air would put it out only made things worse.

I was trying to get the window over the porch open with one hand when the fire lit the curtain. Good gosh, curtains burn faster than baseball cards!

I was face down in the gravel when Jim Dick Crews drove up in his patrol car. I remember thinking, "How did he get here so fast, this accident just happened." He got us all separated (thank goodness) and was reading us the riot act...in his friendly kind of way.

He finally asked the Atwood mob if they had actually seen any of our hometown girls in the daylight. It was my first inkling that he wasn't sending anyone to jail over this altercation...uh, er...accident.

I'm not sure to this day how the goldfish accidentally jumped out of the fishpond up on the town square. And Leon running those cows into the high school auditorium turned out to be a bigger accident than I think even he intended...

Someone might need to update Porter's song.

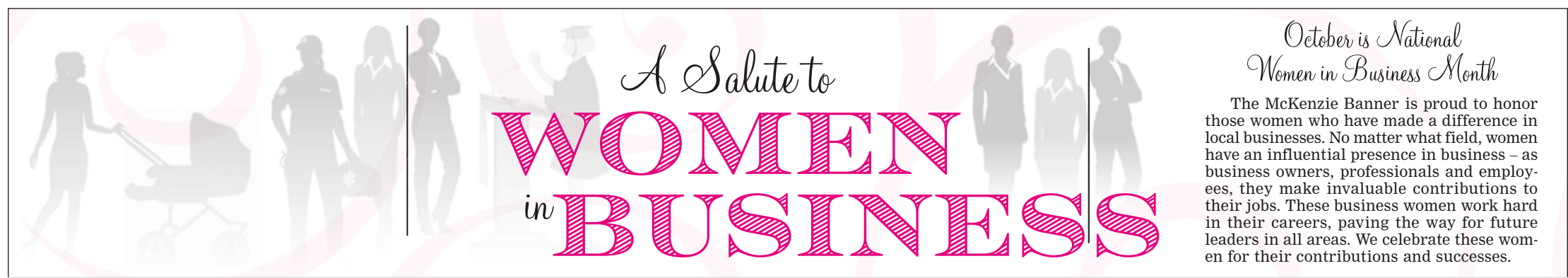

October is National Women in Business Month

Résumé Writing Rules to Follow

When professionals are ready to take a new step in their careers, it's wise to revisit their old résumés and see what can be done to update them for the current day and age. This is especially true for people who may have been out of the job-seeking arena for some time.

Writing a résumé can be complicated. The rules for finding a new job are continually evolving, and résumés remain a big component of that process. The following are some current résumé trends that will help professionals stand out from the masses.

Consider Design — Design your résumé so it will look good whether it's viewed on a screen or a mobile phone or printed on paper. Classic serif style fonts can make a résumé seem dated, so select modern fonts that are crisp. The idea is for the résumé to look balanced and clear, without being overdone with modifications, like italics and bold lettering. However, a spot of color could provide much-needed attention.

Be Brief Yet Effective — A concise design is key. Many recruiters spend little to no time reviewing the hordes of résumés they receive. In fact, automated résumé bots may initially screen the documents to thin the crowd. According to data from the 12th annual Mystery Job Candidate survey by CareerXroads, the average recruiter spends six seconds looking at a résumé. If a résumé is lengthy or

doesn't attract attention, it will likely be ignored. Stick to a single-page and make sure wording is brief but meaty.

Keep Juicy Details Up Top — Format the résumé so the most pertinent information is within the top one-third of the document. Beef up a summary statement and use it in lieu of an objective. Make sure that summary includes keywords that promote your skills and experience to potentially lure the recruiter into reading more.

Tweak Job Titles — Mimic phrasing from the job listing to beat the bots and get résumés flagged for review. Slightly change job position titles so they mirror the wording used. For example, if a recruiter is looking for a "financial account manager," and you have the experience, list your title as something like "Senior manager of new financial accounts."

Who You Know — Landing a new job is often about what you know, but getting a foot in the door is also largely influenced by who you know. Include any professional groups to which you belong or alumni associations. Who knows? The recruiter may have the same alma mater, and you can bond over your shared mascot.

Keywords, phrasing, formatting, and having the right skills for the job can ensure a résumé is seen by a recruiter, and perhaps even lead to a new career.

Stay Mentally Fresh During the Workday

Energy levels tend to ebb and flow throughout a typical workday. A cup of coffee may provide some caffeine-infused spark in the morning, but a big lunch can squash energy later in the afternoon.

Waning mental sharpness as the workday progresses can compromise productivity, making it more difficult for workers to complete projects on time. That, in turn, can contribute to stress. In fact, in its "2017 Stress in America" survey, the American Psychological Association found that 58 percent of Americans say work is a significant source of stress.

Staying mentally fresh during a workday can pay a host of benefits, and the following are just a few ways to maintain mental focus until quitting time.

Exercise regularly. The physical benefits of routine exercise are well documented. But even the most ardent

fitness enthusiasts may not realize just how big an impact physical activity is having on their brains. The Harvard Medical School notes that exercise stimulates regions of the brain that release a chemical called brain-derived neurotrophic factor, or BDNF, which rewires memory circuits so they can function better. A stronger memory can help workers recall project details and deadlines more easily, even as the workday draws to a close.

Avoid the "quick fix." Relying on a beverage or snack to provide a quick mental boost may end up compromising your mental sharpness. Foods and beverages that are high in sugar may provide an immediate energy boost, but that spike is almost instantly followed by a crash that can adversely affect your mental sharpness. Stick to healthy snacks, such as fruits and vegetables, and avoid

late afternoon cups of coffee, which studies have shown make it harder to fall asleep at night, thereby compromising your energy levels the next day.

Take a walk outdoors. Spending some time outdoors during a lunch break, or even a quick, post-lunch stroll around the office grounds, can provide a break for the brain. That break can help the brain refocus, improving productivity as a result. One great way to get outdoors during busy workdays is to conduct meetings outside when the weather permits. This gives everyone a chance to recharge their brains in the great outdoors, and few people would prefer a dusty conference room to a nearby park or picnic area outdoors.

Various strategies can help working professionals maintain their mental sharpness throughout the workday.

Did You Know?

According to estimates from the U.S. Department of Education, women have earned a disproportionate share of college degrees compared to men over the last 12 years. In 2018, women were on target to earn 141 college degrees at every level for every 100 degrees earned by men.

That trend isn't all that recent, as women have earned the majority of degrees at every level of higher education for years and, in many cases, several decades.

For example, DOE statistics indicate that women have earned the majority of associate's degrees every year since 1978 and the majority of bachelor's degrees every year since 1982.

That trend also is reflected in post-

graduate degrees, as women have earned the majority of master's degrees every year since 1987. The female majority in regard to doctoral degrees earned is a relatively recent yet still impressive trend that dates back to 2007.

Estimates suggest these trends will continue, as DOE forecasts suggest that, by 2027, women will earn 151 college degrees for every 100 degrees earned by men.

High-Paying Professions

Much of the talk centered on women in the workforce concerns the disparity between earnings when compared against men in the same positions. The U.S. Bureau of Labor Statistics indicates that the earnings difference between women and men varies with age, with younger women in the country more closely approaching pay equity than older women. Still, Pew Research Center says the female median annual earnings is around 83 percent of what men earn in the United States.

The gender pay gap exists to some extent in every country in the world.

Statistics Canada points out that women between the ages of 25 and 54 earned 87 cents an hour for every dollar made by men in 2015.

Business Insider UK says Iceland, Finland and Norway boast relatively small pay gaps between the genders.

Even though a gender wage gap may exist, women can still pursue careers that are known to be well-paying. The following are some of the top-earning positions women (and men) can consider, courtesy of Forbes, Monster.com and the U.S. Bureau of Labor Statistics.

Obstetrician/Gynecologist: Many women feel more comfortable being examined or discussing female issues with female doctors.



Women who want to earn top salaries can consider employment in various lucrative fields.

This may account for the higher percentage of female OB/GYNs in practice. The job can be very rewarding because it enables one to care for women at various stages in life. The median annual salary for OB/GYNs is \$207,000.

Chief executive: It's a large responsibility overseeing an entire company or division, but that's what chief executives do on a daily basis. Approximate median annual earnings are \$97,552.

Pharmacist: Pharmacists manage the distribution of medications, but they also consult patients on medication use and

administer some immunizations.

Some pharmacists work in drug or grocery stores, while others are employed in clinical settings. The median annual salary for pharmacists is \$95,628.

Optometrist: Responsible for the examination and care of their patients' eyes, optometrists also determine prescriptions for glasses and contacts. Optometrists earn a median annual salary of \$102,000.


Attorney: Lawyers are consumers' advocate and help explain the often confusing nuances of the law.

Attorneys may specialize in

different areas, such as corporate law or family law. Attorney salaries vary depending on the specialty lawyers choose, but law can be a very lucrative field.


Computer and Information System Manager: These workers are also known as Information Technology (IT) Managers. They coordinate and implement company-wide IT efforts, including networking, database development and trouble-shooting. IT managers earn median annual salaries of \$87,400.

While gender pay gaps may still exist, women can earn high salaries in an array of professions.

Tracy, from Shelbyville, serves the entire state of Tennessee. He said USDA works with small cities and counties with grants and low-interest loans for infrastructure projects.

Recently, the federal agency helped the city of McKenzie with its wastewater system improvement project, helped McKenzie Industrial Board

with a marketing grant, the McKenzie Fire Department with a \$9,500 grant to purchase a rescue truck, \$40,000 to the local Tennessee College of Applied Technology, provided \$28,000 to the Bruceton community to purchase computers.

Carroll County is one of 16 economically struggling counties in Tennessee, said Tracy.

Tennessee's USDA Rural Development is rated as one of the top four or five USDA agencies in the U.S.

Miss UT Martin/Miss Tennessee Soybean Pageants October 26

MARTIN — The annual Miss University of Tennessee at Martin/Miss Tennessee Soybean Festival Scholarship Pageant is 7 p.m., October 26, in the Boling University Center's Duncan Ballroom on the campus of UT-Martin. The deadline to apply for the competition is Oct. 14.

The Miss UT Martin Scholarship Pageant is celebrating its 57th year, and this is the 21st year for the Miss Tennessee Soybean Festival title.

Both titles are chosen the same night. Students enrolled full-time at UT Martin through the spring 2020 semester are eligible for either crown.

Beginning this year, a UT Martin graduate currently working toward an additional degree at another Tennessee institution, is also eligible to compete for the Miss UT Martin title.

All women participating as residents of Tennessee or full-time students in Tennessee are eligible for the Miss Tennessee Soybean Festival title.

Potential candidates for both titles should consult the contestant packet for full eligibility requirements.

The pageant is divided into five phases of competition, including private interview, swimsuit, talent, evening wear and on-stage questions.

Each contestant is scored individually from one to 10 in each category. Interviews will take place on the morning of the pageant and mandatory practice will occur in the afternoon.

The contestant crowned Miss UT Martin will receive \$1,500 in scholarship money, and Miss Tennessee Soybean Festival will receive \$1,500 if she is a UT Martin student or \$500 if not.

The first runner-up for Miss UT Martin will receive \$500 and the second runner-up will receive \$200. There is no financial award for runners-up in the Miss Tennessee Soybean Festival title.

Both titleholders will compete in the statewide Miss Tennessee Volunteer Scholarship Pageant in Jackson next summer, and the winner of that crown will serve as the governor's spokesperson for character education across the state and receive \$25,000 in scholarship money.

Tickets are available now at the Boling University Center Welcome Desk outside Watkins Auditorium.

A limited number of tickets can also be purchased at the door beginning at 5 p.m. the night of the competition. Advance ticket purchase is recommended.

The admission charge is \$15 for the general public and \$10 for UT Martin students with their university ID. Only one ticket can be purchased with each student ID.

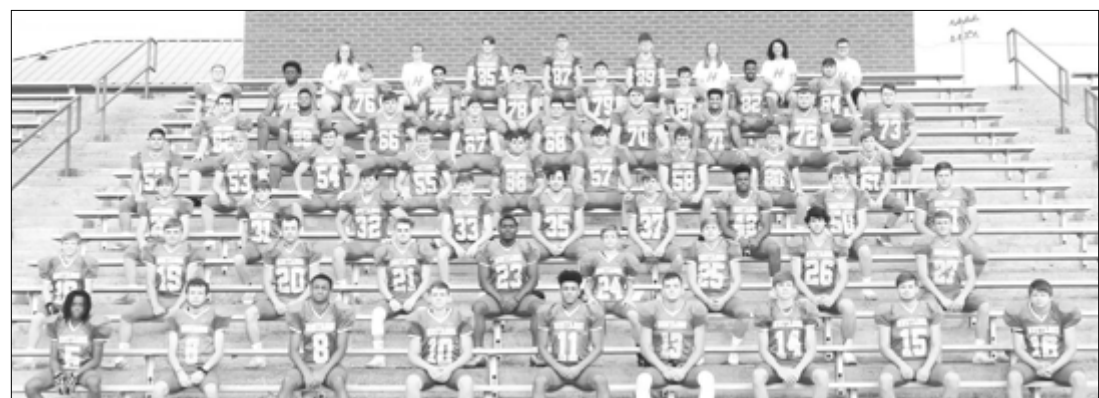

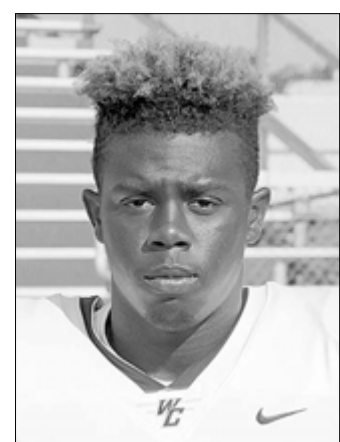

Ricketts tossed to Will Harris for a two-point conversion, and Greenfield led 27-0 with nine

and a half minutes to play in the first half.

The Bulldogs were forced to punt from deep in their own territory, giving the Yellowjackets the ball near midfield. After an incomplete pass, Isbell ran 25 for a first down, then Thomas took it 27 for a touchdown. Featherston's kick split the uprights, and Greenfield's lead was up to 34-0 halfway through the second frame.

Yellowjacket Trevon Watkins returned the next Gleason punt to the 44, and an eight-yard, 56-yard drive ended with Isbell diving for a one-yard touchdown. The PAT was good, and the new score was 41-0 just under a minute until intermission.

The Bulldogs ran two plays before time expired.

Greenfield received the second-half kickoff, but a fumble on second down was recovered by Bulldog Hagen Hodges.

Taking over at the Yellowjacket 39, Gleason mounted a ten-play scoring drive, including three first downs, to get on the board. Isaac Denton made the final, four-yard carry into the end zone, and after a failed two-point attempt, the Bulldog deficit was cut to 41-6 with three and a half minutes to play in the third.

Greenfield started the ensuing drive at the far 33 with Watkins taking over under center. A high snap on second down resulted in Bulldog Elijah Young taking Watkins down at the 12. Watkins kept the next snap for an 88-yard touchdown. After a failed two-point attempt,

the Yellowjackets led 47-6 with under a minute remaining in the third quarter.

The Bulldogs began at their own 33 with a 22-yard run by Denton across midfield as the third ended. The drive continued into the final frame with six plays capped by a 16-yard touchdown run by Denton. A two-point try came up short, but the Greenfield lead was cut to 47-12.

Craig Ross took over at quarterback for Greenfield and fielded a high snap on first down, recovering to make a throw to Featherston for a 62-yard touchdown. The score was negated by a Yellowjacket penalty, and, two plays later, a pass by Ross was tipped and then intercepted by Bulldog Kursor Gustafson and run back to the 26.

Gleason couldn't capitalize on the takeaway, losing yards on three plays before turning the ball over on downs with an incomplete pass on fourth down.

Greenfield took over at the far 37, moving across midfield on two plays. Chandler Finch had the ball stripped by Crochet, but the Yellowjackets forced him to fumble during the return, and Hunter Drinkard dove on it at the Gleason 43. Luke Stone took the snap and kept for 38 yards to the 5. He repeated and was stopped at the 1 as time expired for a 47-12 Yellowjacket win.

The Bulldogs (1-7, 0-4) hosts Dresden for a region contest Friday; Greenfield (7-1, 4-0) will host region foe Lake County. Kickoff for both games is 7 p.m.

The Wildcats mounted a late drive but Christian Arrambide had a pass picked off on a Wildcat fourth and goal from the UC six yard line. The Patriots promptly moved down the field and scored with just over a minute left to add to their lead at 49-21.

UC had a 528-396 advantage in total yards. Bethel had 292 yards in passing but just 104 yards in rushing. UC had 171 yards in the air and 357 on the ground. Dieuly Aristilde led the Wildcats with eight receptions. Bethel's Marcello Walton had 51 yards in rushing. Josiah Robbins had 188 yards in rushing and threw for three touchdowns for the Patriots. Weston Hayes caught two passes for touchdowns and had two rushing scores for the home team.

Jakobe Griffin led Bethel with 15 total tackles while Jeremy Johnson followed with 10 total stops.

Bethel returns home Saturday to host the Georgetown Tigers. Kick-off is slated for 1:30 CST. It will be the seventh meeting between the two programs with Georgetown holding a 4-2 advantage in the series. The Tigers are 2-0 in McKenzie. Both Bethel wins have been in Georgetown including last year's dramatic 50-49 overtime thriller. One of the biggest recognized wins in Wildcat history was Bethel's 45-44 win in the first round of the NIAA Championships.

It will be Pink Out Day with activities in support of it being Breast Cancer Awareness Month.

This season's Wildcat team will again have a bevy of experience to return. This group will feature eleven returning players, with six of those being seniors. This cast of players will be looking to make it back-to-back NIAA National Tournament appearances and the third since 2015. Four of the top six scorers return, but will need to have several players step up to replace the scoring presence of Third-Team All American Isaac Edmondson. Bethel will look to build on the 25-9 record, which will require this team to play to their capabilities and reach their ceiling.

The Wildcats' returning cast will have six seniors on the roster: Cayden Edmondson (6'8, 14.3 points per game, 7.3 rebounds per game, 1.5 assists per game), Noah Chatman (6'6, 8.7 ppg, 8.5 rpg, 1.0 apg), Foday Sankaray (6'5, 7.8 ppg, 3.1 rpg, 1.2 apg), Charles Cobb (6'1, 7.2 ppg, 1.6 rpg, 1.3 apg), Javonte Ellis (6'6, redshirted 2018-19) and Cameron Ricks (6'1, redshirted 2018-19).

The underclassmen returnees are: Jarred Walker (5'9, junior, 4.1 ppg, 1.8 rpg, 1.9 apg), Tyrus Robinson (6'0, junior, 2.5 ppg), Ja-

cob Rose (6'5, sophomore, 1.7 ppg, 1.1 rpg), Jamarius Mayberry (6'4, junior, 2.3 ppg, 1.5 rpg) and Terrell Brown (6'4, junior, 1.0 point).

Bethel has brought in two transfers and five freshman to this year's team: Chandler Clements (6'6, freshman, 25 ppg, 11 rpg, Monroe County (Ky.) High School), Connor Guthrie (6'2, freshman, 15.7 ppg, 4.1 rpg, Mayfield (Ky.) High School), Myron McKinney (6'6, junior, 14.5 ppg, 6.6 rpg, 3.1 apg, Dyersburg State Community College), Kamron Rose (6'8, junior, 12 ppg, 8 rpg, Arkansas State University-Mid South), Kylan Cunningham (6'0, freshman, 20 ppg, 10 rpg, 3 apg, Munford High School), Kyree Cunningham (6'0, freshman, 19pts, 10 rpg, Munford High School) and Connor Diecker (6'5, freshman, 12.5 ppg, 7.5 rpg, Freeburg (Ill.) High School).

The 2019-2020 non-conference will again be tough as the Wildcats will have 12 games against some talented teams. The Wildcats will again put on the Chick Fil-A Classic, where Bethel will face Southeastern Florida University and University of Science and Arts of Oklahoma. Bethel will host another Classic in December

and will face Lindenwood University-Belleville and Philander Smith College. The other home games will be with Freed Harde-man University, Fisk University, Crowley's Ridge College and Oakwood College.

The road games this season will see the Wildcats travel to Brescia University and Lindenwood University-Belleville. The Wildcats will play exhibition games with Delta State University, a NCAA Division II school which plays out of the Gulf South Conference, and Lane College, a NCAA Division II opponent who plays out of the Southern Intercollegiate Athletic Conference.

Coach Jeff Britt states that, "I like the team that we have put together, and we really look forward to getting things going. Our schedule will be a tough one, and we will have to be ready to go out and compete each and every night as we have no games that we can just show up and win."

The Wildcats begin the season Friday, November 1 at the Appalachian Wireless Classic in Pikeville, Kentucky against Alice Lloyd College. Tip-off is 5 p.m.



2019-2020 Bethel Lady Wildcats Basketball Preview

Throughout the successful 2018-19 campaign for Bethel basketball, many of the storylines centered around sharpshooter and Conference Player of the Year Myah Taylor. But in many ways, what made the Lady Wildcats go was Tasia Jones and Tyasia Willis off the bench who step into starting roles this year. "Tasia and Ty are both great leaders," said Head Coach Chris Nelson. "Ty is not only one of our returning leading rebounders, but she is also very vocal on and off the court. Tasia dictates the tempo and controls the game and our team. She sees the floor as good as any point guard that has played in our program."

As the Lady Wildcats prepare for the 2019-20 season, returning leadership from the two lone starters, Morgan Martin and Milie Bryant, give the experience needed in the back court for the challenging schedule. "These two are what our program is all about," said Coach Nelson. "They bring stability and toughness. Not only do they lead in the locker room, but in the classroom as well."

The most notable new faces to the team are redshirt transfers Ge'Naisha Robinson and Mickey Head. Robinson and Head allow the Lady Wildcats to play different styles than past seasons. Although Bethel led the nation in three point makes last year, this team is looking for more of a post presence and scoring off of their defense and transition. "It is comforting to know they have been with us all last season, so chemistry should not be an issue with them fitting right into the puzzle," states Coach Nelson.

Jani Crawford and Ashton Hulme are two players to keep an eye on as they both played significant roles at different times last season. Crawford certainly has a lot of promise after finishing strong her sophomore season and being named to the SSAC All-Tournament Team. She could very well be one of the main scoring options for the Lady Wildcats this season. "She can really shoot it and spends more time in the gym than any player we have ever had," said Coach Nelson. Another local native, Ashton, could take a leap in playing time after having

up-and-down minutes her freshman season. Hulme will bring three-point shooting, rebounding and depth at the forward position.

"We are excited about this season, and the expectations are the same. It is our goal to win the conference again and go as far in the postseason as possible and be the last team playing in March," said Coach Nelson. "Our preseason should have us prepared as we will have to be resilient with the schedule we have ahead of us. Obviously, we are a year older with this team, so chemistry and experience will be the major ingredients for our success."
