## MARCH

### Region 6A Boys Championship-McKenzie's Comeback Kids Strike Again to Claim Title

MCKENZIE (February 28) — Two weeks ago, the McKenzie Rebels trailed the Huntingdon Mustangs by seven points entering the fourth quarter of the District 11A Championship Game at Bethel University's Crisp Arena, and the Rebels mounted a 20-4 comeback to claim the title.

Fast forward to last Thursday, when the Rebels again trailed the Mustangs entering the fourth quarter of a title game. The venue was the same, but this time, it was the Mustangs of Loretto who had an edge-point advantage over the Rebels, and it was the Region 6A Championship game. With hosting rights to a Monday win-or-go-home Sectional game on the line, McKenzie's boys once again delivered when the pressure was the greatest.

Trailing 44-36, the Rebels started the quarter on a 7-0 run to pull within a point. Soon after, they would take a 47-46 lead. Loretto scored to regain the lead, then Rebel Nate Whitsell hit a three to go up by two. McKenzie got a stop and scored again to go up four, but Mustang Jacob James hit a three to get back within a point with two minutes to play. Defense prevailed until only ten seconds remained, and James drove to the basket. Rebel Ben Austin stopped him from scoring, but was called for his fourth foul. James went to the line with four seconds to play to shoot a one-and-one. The first bounced off the rim, and Austin came down with the rebound, also drawing a foul. Austin converted on his one-and-one to give the Rebels a 54-51 lead. A last-second desperation three by Loretto missed wide, and the Rebel bench and student section rushed the court

in jubilation.

### STATEBOUND! McKenzie Rebels Earn State Tournament Berth with Sectional Win

MCKENZIE (March 5) — The McKenzie High School Rebels will travel to Murfreesboro next week as one of the "Elite Eight" teams in the 2019 TSSAA Class A State Boys' Basketball Tournament at the Murphy Center on the campus of Middle Tennessee State University.

The Rebels punched their tickets Monday with a 69-57 Sectional win over a tough East Robertson team before a raucous crowd at Bethel University's Crisp Arena.

The win gives the Rebels a season record of 28-3 entering the state tournament.

It is just the second trip the Rebels have made to the state tournament in the history of the program, the first coming 21 years ago.

### BlueCross Basketball Championships-Rebels Make History with First State Tournament Win

MURFREESBORO (March 14) — The McKenzie High School Rebels earned the first state tournament win in program history Thursday with a 68-49 victory over the University School-Johnson City Buccaneers in the quarterfinal round of the TSSAA Class A Boys' Basketball Championships.

The Rebels led from the opening tip, jumping out to a double-digit lead in the first three minutes. The Buccaneers would make several brief runs to cut into the deficit, including an impressive burst in the third quarter to cut the gap to six, but overall, the Rebels outscored USJC in each period.

### BlueCross Basketball Championships-Rebels End Historic Season with Semifinal Loss

MURFREESBORO (March 15) — The McKenzie Rebels saw a historic season come to an end

Friday as they fell 66-55 to the Humboldt Vikings in the semifinals of the TSSAA Class A State Boys Basketball Tournament at Middle Tennessee State University's Murphy Center.

The Rebels never had a lead in the contest. The Vikings led by a dozen at the half, but McKenzie came out strong from the break with a 16-6 run to pull within two points. Humboldt stifled the rally and built the lead back to double digits with two minutes left to play. The Vikings hit their free throws late to hold off the Rebels and claim the win.

The loss ends the high school basketball careers of seniors Ben Austin, Tyler Spivey, Brandon Hobson and manager Stephone Haynes.

### BlueCross Basketball Championships-Austin, King Named to All-State Tournament Team

MURFREESBORO — Following the TSSAA Class A Boys Basketball Championship Game, players from participating teams were named to the All-State Tournament Team. Two McKenzie High School players, senior Ben Austin and junior Lucas King, were among those honored.

In McKenzie's two state tournament games, Austin scored a total of 37 points and had 28 rebounds, eleven blocks and two assists. King totaled 31 points, six rebounds, ten assists, a block and a steal.

### Wildcats Win First NAIA Tournament Victory

KANSAS CITY, Mo. — The Bethel Wildcats and the John Brown Golden Eagles tipped off the 82nd NAIA Division I Men's Basketball National Championship last Wednesday morning at the historic Municipal Arena in downtown Kansas City. The No. 5 seeded Wildcats used a late surge in the first half to run out to a 34-24 lead at halftime. That lead held up as the Wildcats pulled off the slight upset knocking off the No. 4 seeded Golden Eagles 77-57.

The Liston Bracket victory was the first ever for the Wildcats in the championship. They had lost to Pikeville in 2015. It was only the second meeting ever between the two programs which is now tied at one each. JBU beat Bethel 73-71 in McKenzie in 1977. The 18th ranked Wildcats moved to 25-8 while John Brown finished their season at 23-11.

### High School Baseball-Ensley Hits for Cycle as Mustangs Trample Cardinals, 9-1

HUNTINGDON (April 5) — The Huntingdon High School Mustangs hosted Adamsville Friday for a non-district baseball contest. A 9-1 Mustang win featured a rare accomplishment as Hunter Ensley hit for the cycle (a single, a double, a triple and a home run).

### Patrick Willis To Be Inducted in Tennessee Sports Hall of Fame

NASHVILLE — The Tennessee Sports Hall of Fame announced its nine-member 2019 class last Thursday, April 11, and it includes Bruceton native and former San Francisco 49er linebacker Patrick Willis. Willis was an outstanding offensive and defensive player for the Bruce-ton-Hollow Rock Central Tigers where he became the first player in Tennessee history to be nominated for both the Mr. Football Award for best lineman and Mr. Football Award for best back in the same season. He earned a scholarship to Ole Miss where he was coached by fellow inductee David Cutcliffe. He became an All-SEC performer and two-time SEC Conference Defensive Player of the Year along with being named South Team Defensive MVP at the 2007 Senior Bowl. In 2006, Willis won the Butkus Award and Lambert Award, both given to the top linebacker in college football. He was a first-team All-American in 2005 and 2006.

Willis was drafted in the first round by the 49ers where he played for eight seasons before retiring. He was the AP NFL

Defensive Rookie of the Year in 2007, leading the league in tackles as a rookie.

### Bethel University Wins First Major League Fishing College Championship

DAYTON, Tenn. — Eight boats/16 anglers from Bethel University competed in a head to head match up against the same amount of boats from in-state rival Bryan College from Dayton, Tennessee recently. The format of the Major League Fishing saw the top five boats from each school getting points based upon the combined weight of each boat's total catch of fish weighing over one pound. The Bethel team had a staggering 294 pounds of largemouth bass with a total of one hundred fifty six fish caught for the combined top five Bethel boats.

### Middle School Soccer-Rebels End Stellar Season as West Tennessee Runner-Up

MCKENZIE (April 26) — The McKenzie Middle School soccer team saw a phenomenal season come to a bittersweet end Friday in a 1-0 loss to the St. Mary's Angels in the championship game of the West Tennessee Regional Soccer Conference at Bethel University's Wildcat Stadium.

The Rebels were previously unbeaten on the season with a 10-0 record including two tournament wins to reach the title match. Overall, they outscored their opponents 48-5 on the year.

Following the championship, players were named to the All-Conference Team. McKenzie was represented by defender Rashad McCreary.

### District 11A Baseball Championship-Mustangs Clinch Title with 8-4 Win over Rebels

ATWOOD (May 8) — The Huntingdon Mustangs claimed the District 11A Championship Wednesday with an 8-4 victory over the McKenzie Rebels. It was the Mustangs' second win in three games against the Rebels during the tournament. McKenzie struck first with a

pair of runs in the top of the first inning. Huntingdon cut the lead in half with a run in the home half, took the lead with three in the third and pulled away with two runs each in the fourth and fifth. The Rebels rallied for a pair in the top of the seventh.

### District 11A Softball Championship-Fillies Claim Title with Win over West Carroll

ATWOOD (May 7) — The Huntingdon Fillies clinched the District 11A Softball Championship Tuesday with a 9-4 win over the West Carroll Lady War Eagles.

With the win, the Fillies would host Loretto Monday for a Region 6A semifinal. As the runner-up, the Lady War Eagles would travel to Summertown.

West Carroll struck first with a pair in the top of the first, and Huntingdon answered with one in the home half, then took a big lead with six in the second. After three scoreless frames, the Lady War Eagles rallied for a pair in the top of the sixth, but the Fillies matched that in the bottom half.

### High School Soccer-Rebels Earn District 13A Championship, Advance to Region Championship

DYER (May 6-8) — The McKenzie High School Rebels are the District 13A Soccer champions following a two-game sweep of the district tournament, held at Gibson County High School. They will host the Region 7A Championship game Thursday at Bethel University's Wildcat Stadium at 6 p.m.

Monday, the Rebels played Westview in a semifinal contest and won 1-0. Diego Calderon scored the lone goal with an assist from Zack Flippin. Goalkeeper Will Essary recorded seven saves.

In Wednesday's title game, McKenzie faced Gibson County and earned a 3-1 victory. Diego Calderon scored a pair of goals, and Francisco Padilla scored the other. Goalkeeper Will Essary again had seven saves.

McKenzie Council Approves Zoning Map, Residential Zoning Ordinance

MCKENZIE (January 9) — During its regular monthly meeting, the McKenzie Board of Mayor and Council approved the city’s zoning map and amendments to Ordinance 529. The zoning map and ordinance were approved by the McKenzie Regional Planning Commission in November 2019. According to Mayor Jill Holland and Councilman Jason Martin, both are ex officio members of the commission, stated the zoning changes focused around the former Gaines Manufacturing building and a portion of Kencindot Street. The area in question was changed from heavy industrial to light industrial allowing for greater opportunity for commercial usage of the properties. On its first reading, amendments to Ordinance 529 were approved. The amendments are in Chapter 4, Sections 11-403, 11-601 and 11-602 concerning the construction of more than one principal structure on a lot. Section 11-403 states only one principal structure shall be erected or situated housing a permitted or permissible principal use may be erected. Section 11-601 and 11-602 amended the language of the provisions governing residential districts concerning the R-1 (low density) and R-2 (medium density) districts. Both ordinances prevent further construction of duplex and apartment housing in the aforementioned districts. During the meeting a public hearing was held for the adoption of the ADA transition plan proposed by Jim Pillow. After Pillow’s work with city officials, the following were

items were found to be out of ADA compliance on city-owned property and will be addressed by the City of McKenzie: city hall parking lot handicapped parking has no signage, some lines are not drawn for van parking; not enough adequate space to maneuver around the council seating area; no accessible route to second floor of fire department; no braille signage except on the outside of the lobby restrooms (signs are on the doors instead of on the walls); many of the restrooms routes have obstructions leading into them; no grab bars in most of the restrooms; several toilet levers on wall side instead of open side in restrooms; pipes not insulated under sinks; many sinks are not conducive to being approached straight to the front because of obstacles like trash cans, etc., and most of the door knobs require tight grasping and twisting (need to replace with lever). In other business the council approved the Local Parks and Recreation Fund (LPRF) Grant budget. The grant total is \$60,000 with a dollar and in-kind match of \$60,000 from the City of McKenzie. The \$120,000 project is for the construction of Harmony Park to be located adjacent to the Splash Pad. The council approved the nomination of Jennifer Fontana to the Library Board. Bids were opened concerning the demolition of multiple condemned properties. The following properties were initially included in the requested bid notice 276 Elm Street, 44 Linden Street, 80 Paris Street, and Hays Trailer Park, 924 Magnolia

Avenue. The properties located on Paris Street and Magnolia agreed to remove the structures without the city’s involvement. Following the opening of bids, City Attorney Laura Keeton said the council needed to allow two of the bidding parties a chance to amend their bids due to change the quantity of properties. Joseph Foster and Anderson Construction bid on the Linden and Elm properties while Peed Family Associates (Clarksville) and DR&M Demolition (Hermitage) on all four. The council recommended a special committee consisting of Public Works Supervisor Johnny Mercer, Codes Officer Phillip Morrisett, Councilman Martin and Mayor Holland will convene on Monday, January 27 at 4 p.m. to accept the bid between the four companies. Under department reports, Water Supervisor Billy Wood informed the council of the nearing completion of the sewer rehabilitation project and only a few water meters are waiting to be installed. The public works department made a \$3,500 repair to the leaf machine and had work with the parks department to remove Christmas decorations. Mike Beasley of the parks department informed the council baseball practice will commence on January 13. Fire Chief Brian Tucker reported 24 incidents for the month of December including six residential fires. The next regular meeting of the Board of Mayor and Council is 6 p.m., February 13 at McKenzie City Hall.

was south of Dresden in the south end of Weakley County.” He said, “In Dresden, high winds damaged properties along Oak Grove Road, including missing shingles from roofs. “In the Greenfield area, portions of roofs were missing,” Wiggington said. “Outbuildings were blown out into the fields in some cases. The same is true in the Sharon area.” Wiggington stated, “We’re

still waiting to hear from the National Weather Service (NWS) in Memphis, which will be surveying storm damage in Weakley County this week, to determine if it was a tornado, or just straight-line winds.” Approximately 600 customers were without electrical power due to fallen trees and limbs knocking down utility poles and snapping electrical lines. According to Weakley County Municipal Electric System Director Faron Collins, “We had quite a bit of wind damage caused by the storm system, which broke 1-15 poles. “The damage was confined

to a narrow strip located just east of Greenfield and across the Gleason area. We did have a little damage in other parts of the County, but it was not nearly as severe. “We had everybody we had out working Saturday and we finished up about 10 o’clock Saturday night. “We still have a few poles that are broken that we have temporarily repaired, just to keep the lights on. Later on this week, when it dries out, we’ll have some poles to change out and some maintenance to do to get things back to normal.

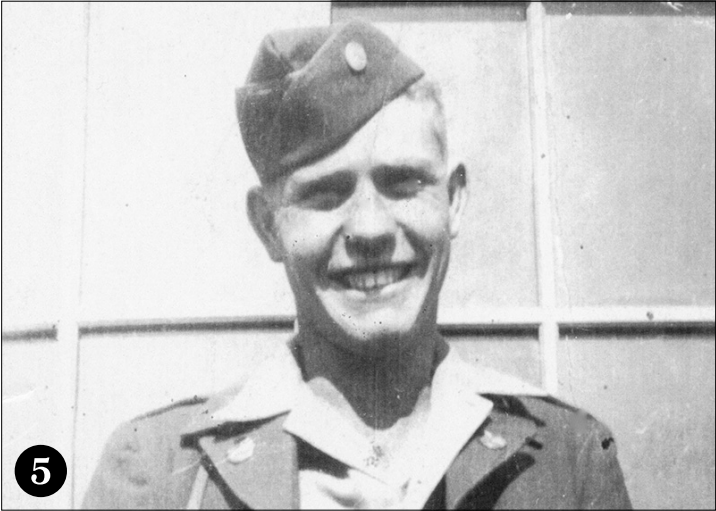
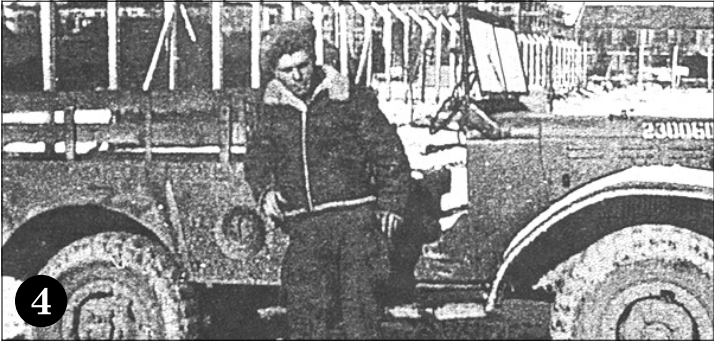
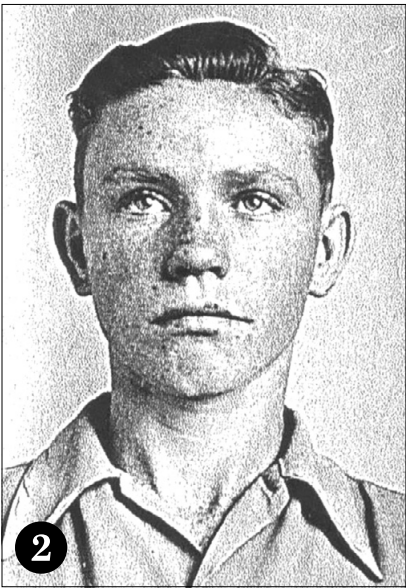

# The Washburns (Part I)

## From Connecticut to McKenzie

The next chapter in The McKenzie Banner history brings us to the Washburn family. James L. Washburn began working for J. Frank Barlow in 1948. From that point onward, the Washburn's evolved into the heart and soul of the Banner and became civic leaders in the community. For over half a century a Washburn has owned The McKenzie Banner with three generations working for the company in some capacity.

The story of the Washburn family dates centuries back to England when the name was spelled Washbourne. To save eight-plus centuries of history for another time, let's pick up with Eli Washburn.

Eli was born on December 8, 1796, in Canterbury, Connecticut. He was the first Washburn to migrate to West Tennessee. At a young age, Eli moved from Connecticut to Virginia, where he married Jane Mackey.

Around 1840, Eli and his wife

moved to Perry County, Tennessee. While in Perry County, Eli was ordained as a Baptist preacher. Sometime between 1840 and 1850, the Washburns settled in the area of Jack's Creek near the Reagan community.

Eli and Jane Washburn had six children, one daughter and five sons; Mary Ellen, Robert, Augustus and Edgar, all born in Virginia; and John and Reuben Hale were born in Tennessee. They also raised their grandson, William (Billy) Daniel, the son of Augustus. His wife, Mary Daniels, died shortly after giving birth to Billy in 1859.

Four sons fought for the Confederacy during the Civil War. Reuben was the only son of Eli and Jane to come back from the Civil War. Robert, a member of the 10th Regiment, Tennessee Cavalry (DeMoss), was reported killed at Knoxville. Augustus died as a prisoner at Camp Douglas, a Union civil war prison in Chicago, Illinois. John, a member of the 27th Regiment, Tennessee Infantry, was killed at Meridian, Missis-

siippi. Reuben was a private in "I" Company of the 1st Confederate Infantry. Edgar Washburn, died of typhoid fever on July 24, 1857, before the start of the Civil War.

Eli died on October 13, 1875, at his residence near Jack's Creek at 78 years of age. He and his wife, Jane, are buried at Union Hill Missionary Baptist Church located in proximity to the intersection of Highways 22 and 100 in Henderson County.

Our portion of the Washburn story picks up with Augustus who enlisted as a member of Cox's Tennessee Cavalry Battalion. He was 30 years old at the time of his enlistment. When General Nathan Bedford Forrest organized his first raid into West Tennessee in December 1862, Cox's Battalion was mustered into his service and ordered to cross the Tennessee River. On December 20, General Forrest, with his escort and Cox's Battalion, charged into Trenton, Tennessee, and captured the town and some 800 Federal prisoners.

After the raid on Trenton, Forrest accompanied by Cox's Cavalry moved on toward Union City and were involved in a skirmish there on December 21, where the Union Captain surrendered his garrison.

The battalion found themselves near Dresden and Gleason where they destroyed a railroad trestle on Christmas Day 1862. The troops used axes scavenged from local farms to cut the timbers of the trestle. Forrest's cavalry soldiers camped in Dresden near the trestle on Christmas Day night and moved out toward McKenzie on December 26, 1862. From there to

the Battle of Parker's on December 31, 1862. It was at the New Year's Eve battle Augustus was captured with 300 other Confederate soldiers.

With the death of both parents, William "Billy" Washburn was raised by his grandparents. He married twice and fathered 16 children. His first marriage was to Nancy Cornelia Bailey, with whom he had six children. His second marriage was to Mary Helen Linton and they had ten children together; eight daughters and two sons.

Children with Nancy: Mary Lee 1879; Hubert Adkins 1880; Elector Ardel 1883; Arby Cleveland 1886; Lucy Tennessee 1888; James Edward 1893.

Children with Mary: Maggie Correlia 1895, Hattie Ethel 1897, Nancy Lillian 1898, Willie Lerah 1900, Vester Arden 1/13/1902, Edner Mae 1903, Otis A. 1905, Hessie Edith 1909, Dessie Ethel 1909, Ruby Mackey Jane 1911.

William's 11th child, Vester, brings us one generation closer to James. Vester was born and raised in Jack's Creek community. At 20 years of age, Vester married Dovie Ardell Ross, who in 1922 was only 15 years of age. They had seven children; Fred Arden 1923, Wayford Otis Washburn 1925, James Loyd 1927, Leo Franklin 1930, Arlene 1933, Billy Junior 1935, and Helen Louise 1938.

No longer interested in farming the "Hill Country" of Henderson County, Vester and Ardell moved to Carroll County. In October 1938, the family loaded up in an old truck and settled near the south side of Carroll Lake, near pres-

ent-day Lakeside Senior Living Community.

Vester worked as a sharecropper, and the entire family was required to be involved in the farming operations. He later moved the family to a house and farm known as the Bateman farm located near the present-day McKenzie Elementary School. In January 1947, the family moved to a farm near the McKenzie-Como Road known as the Eulas Pickler place. Vester and Ardell purchased the farm where they were residing, which was approximately 145 acres.

Ardell died of cancer at the hospital in McKenzie on July 24, 1982. Vester died at the family home on December 17, 1984. Both are buried in the Caledonia Missionary Baptist Church Cemetery on the McKenzie-Como Road near McKenzie and their farm.

James Loyd Washburn was born on September 5, 1927, in Henderson County, the third son of Vester and Ardell Ross Washburn. He assisted in the family's farming operations until joining the military in 1945. James attended the McKenzie school and graduated from the eighth grade. He dropped out of school after the ninth grade to help the family farm, a common practice in those days.

On November 29, 1945, he was inducted into military service at Fort McPherson, Georgia. Following basic training, he served with the 40th TC Squadron, 317th Transportation Corp. Group. After being stationed in Yamato, Japan with the American Occupational Forces after the end of World War II, he was transferred to E Squad-

ron of the 1377th Army Air Force Base Unit and was stationed at Westover Field in Massachusetts.

He was honorably discharged from the Army at Camp Stoneman, California, on June 29, 1947. During his enlistment in the U.S. Army, he was awarded the World War II Victory Medal, Army of Occupation, Japan. After being discharged from the Army, he returned to McKenzie, where he joined Company G, 117th Infantry Regiment of the Tennessee National Guard. James was discharged from the National Guard on January 19, 1951.

Next week's article will pick with James joining the staff at The McKenzie Banner.

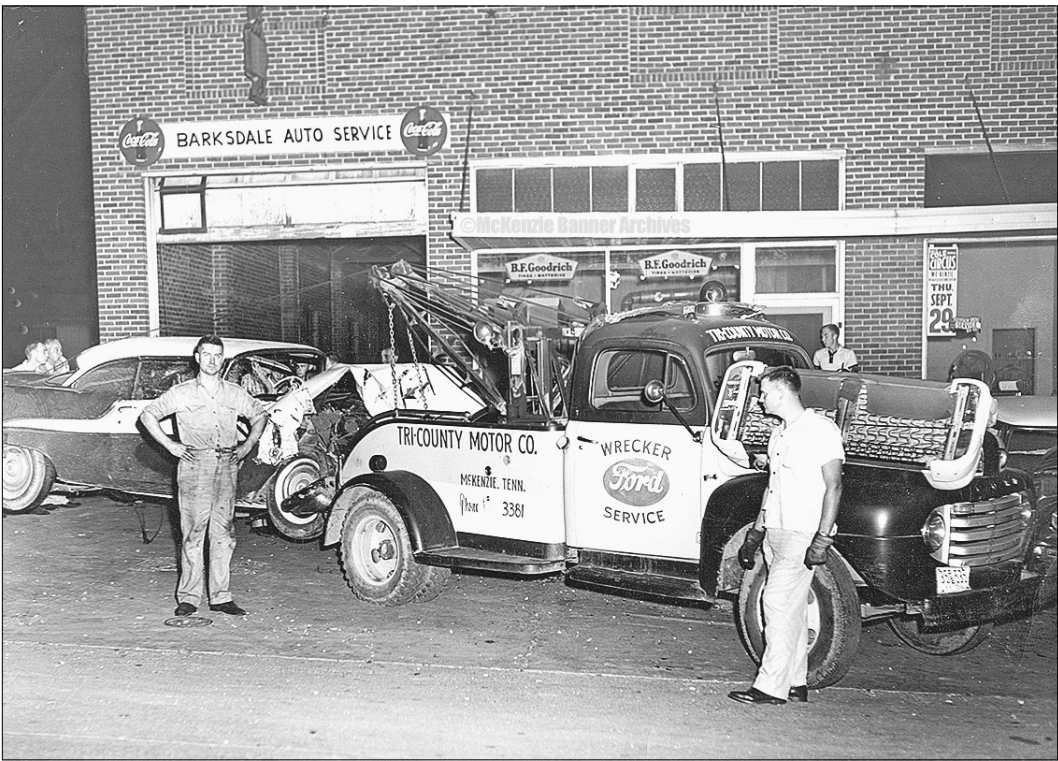

## McKenzie Police Reports

## School Bus Drivers Needed

The school bus driver shortage across the state has meant some city routes have been combined or cancelled. In more rural areas, some administrators have turned to different school start times to maximize their limited personnel. Such drastic measures have not yet been necessary in Weakley County. And transportation director Ron Byington is working overtime to ensure the county's 41 routes stay fully served.

He is already aware that he'll be losing a driver soon and he's in need of a stronger roster of substitutes. "We are blessed to

be where we are and have the people we have," noted Byington. "We are in good shape, but not great shape."

Adding to the concern is an upcoming deadline of Feb. 7, when more extensive training for new drivers will be mandatory. The training could require up to two weeks to cover the 96 different topics that's included in the materials.

"Ideally, before that first week in February, I'd like to have all our positions filled and a substantial number of substitutes ready to finish out

our school year," explained Byington. "Filling spots after that date would put a strain on our limited personnel."

Daily wages of from \$60 to \$66 can even be combined with those from other positions within the school system like cafeteria workers and educational assistants to carve together a fulltime position, he noted. Benefits for drivers include retirement.

Byington stated, "Drivers must be self-motivated and safe-minded. And they are a huge part of the academic success of our children."

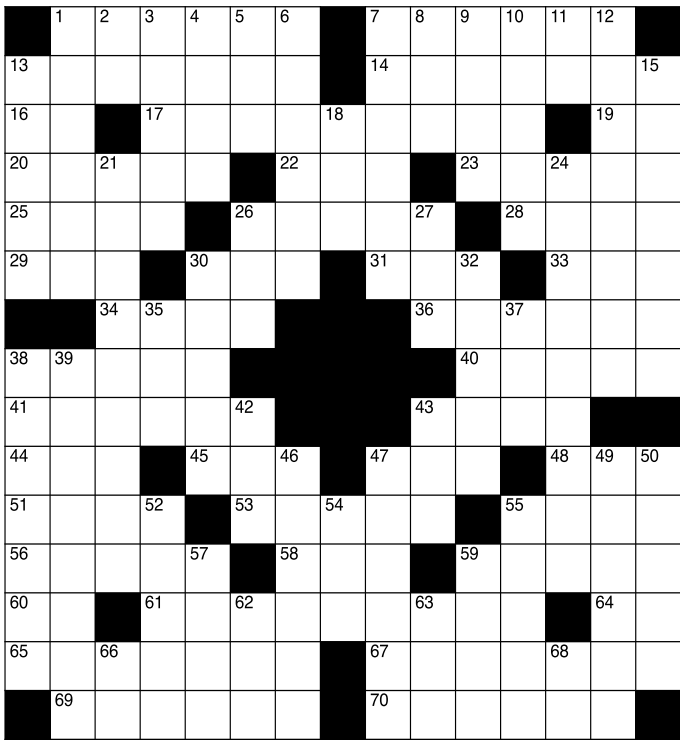


