Gasoline Prices Rise

(March 15, 2021) — Tennessee gas prices rose 9.3 cents per gallon in the past week, averaging \$2.65/g today, according to GasBuddy's daily survey of 3,821 stations in Tennessee. Gas prices in Tennessee are 39.9 cents per gallon higher than a month ago and stand 65.2 cents per gallon higher

than a year ago.

According to GasBuddy price reports, the cheapest station in Tennessee is priced at \$2.09/gallon today while the most expensive is \$2.99/gallon, a difference of 90.0 cents per gallon. The lowest price in the state today is \$2.09/gallon while the highest is \$2.99/gallon, a

difference of 90.0 cents per gallon.

The national average price of gasoline has risen 5.9 cents per gallon in the last week, averaging \$2.86/gallon today. The national average is up 33.2 cents per gallon from a month ago and stands 64.0 cents per gallon higher than a year ago.

Representative Darby Speaks at Chamber Forum

HUNTINGDON (March 12) — State Representative Tandy Darby (R-Greenfield) was the featured speaker at the Carroll County Chamber of Commerce's Legislative Briefing. Chamber President Brad Hurley introduced Tandy, saying the freshman legislator was in his 60th day of service as a legislator.

Darby is employed with Akin Porter in Greenfield and operates Darby Brothers Farms. He and wife, Kaci, have three children.

Darby said it is good to be in front of an audience, especially after a year of pandemic.

He spoke about his career, saying he is not a politician,

has attended no rallies, and will help west Tennessee forward.

He his revelation to enter public service came when his daughter, Tess, visited Texas Tech. The school's representative was a 70-year-old man who indicated his regret for not providing more public service during his life. Tess, a freshman at the University of Tennessee at Knoxville, is a member of the Lady Vols basketball team. Representative Darby said he is happy Tess chose UT.

He said the Tennessee government is in good hands of conservative leadership. He said he gets to work early to better learn his new job and works to better serve his constituents. He said his staff is very experienced and

a great asset.

Darby said he is the lone freshman on the Calendar and Rules Committee and has the opportunity to see each bill before it moves forward.

When asked about the Constitutional Carry Bill, the representative said he supports Governor Bill Lee's bill.

McKenzie Mayor Jill Holland said the Tennessee Legislature reduced revenues for local governments in the year 2002 by taking away part of the local option sales tax. Cities really hurt from that move, said the mayor.

Darby said Governor Lee understands rural areas and is working to assist them through rural initiatives.

as director of schools for the West Carroll Special School District for the past four years. It has been an honor to serve in this capacity at the place I call 'home.'

"We have made progress, but I know there is still much work to be done. However, I no longer believe that I am the best person to lead WCSSD. There are discrepancies between what I see as my role as superintendent and what others believe it to be. Without the freedom to lead, a leader's purpose is lost. For this reason and others, I am stepping aside. My last day as director of schools will be June 30, 2021.

"Although I am stepping down as director of schools, I will always be a supporter of the students, faculty and staff in the West Carroll Special School District. My sincere hope is that I have done something to better the school district during my tenure here."

Williams is a 1995 alumnus of West Carroll, where he played on the 1995 men's basketball team that advanced to the semi-finals in the state Class 1A tournaments in Murfreesboro.

He is a 2000 graduate of Union University, where he played basketball for four years and served as the student assistant coach in his fifth year as the obtained a double major in Sports Medicine and Athletic Training and earned an education degree in Physical Education and Health.

He earned a master's in Educational Leadership-Administrative Supervision from Trevecca in 2003. He taught at Northeast Middle School in Jackson (2000-2003), Liberty (2003-2010), where he coached men's basketball and taught physical education. In the two season of 2006 and 2007, Williams' team earned state championships in the Class 2A. He served as assistant principal at Liberty 2009-2010.

In 2010 to 2013, he served as principal of Tigrett Middle School in Jackson.

In 2013 to 2015, he served as men's basketball coach at Milan High School and director of human resources and bus transportation for Milan Special School District.

In 2015 to 2017, Williams served as the principal at West Carroll Junior High/High School and was selected as the director of schools for the years 2017-2021.

Williams said West Carroll has made advance-

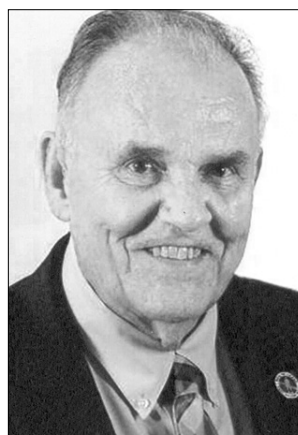
ments in several years during his tenure as director and during the time he served as principal. The school has retained and recruited excellent teachers, achieved a system-wide safety initiative, hired two certified law enforcement officers to serve as student resource officers in the schools, hosted an annual junior high all-star football contest, added a junior high baseball team, high school golf team, and girls' volleyball, improved the sports programs, and added LED lighting throughout the school system to save money.

"I will always consider West Carroll as my home," said Williams. "I wish them the best and hope they find the right person to lead the school."

Dexter and wife, Amber have three children, Kaleigh, 16, Kaleb, 14, and Karcyn, 12. Kaleigh and Kaleb will both transfer to Trinity, where their father is employed. Karcyn with remain at South Gibson in Medina, where her mother is a Special Education teacher.

Our program was given by Linda Edge whose subject was Memphis writer Nick Nixon, who has four books in publication with a fifth in progress. This was a first for our programs, since Linda is personally acquainted with Nick Nixon. They attended Hollywood Junior High School together in Memphis through the ninth grade, but went separate ways in high school. The two became reacquainted through Facebook years later and continue to Message each other.

After college at Memphis State (now University of Memphis), Nixon began

making a living as a graphic artist and ended up owning and operating an advertising and marketing firm for 35 years. His company serviced local, national, and international clients. After retiring, he wrote humorous articles for various publications and did cartoons to go along with them. At the time he also wrote and illustrated children's books.

When asked once if he ever wrote a novel what kind it would be, he jokingly replied it would probably be a parody of The Maltese Falcon and title it "The Maltese Chicken." That led to his first novel, The Frame, the first book in the Peter English, PI mystery series. That was followed by Murder on the 13th Green, then The Main Street Murders. The Chicago Connection is his latest, all set in the late 1940s right after World War II. He is currently working on the fifth in the series, Process of Elimination.

The Frame introduces Peter English, a private investigator who has a law degree but enjoyed being an MP during the war so much that he joined the Memphis Police Department after the war. He was an outstanding police officer and was eventually promoted to detective. Being an honest cop in those days was not popular among his fellow officers, the brass, many at City Hall, and some in the underworld. When they could not buy him off, they framed him for something he did not do. His wife died and he lost his job about the same time. He no longer carried a badge but still carried a gun, and he was still a detective. He swore to get even and bring down those who had framed him.

In Murder on the 13th Green English, English,

along with his father and two other golfers discover four bodies on the Riverview Country Club golf course who have been shot execution-style. Peter is called on to help the police find out who did it and why.

The Main Street Murders is book three in the series. Bodies start turning up on Main Street in Memphis in broad daylight and shot execution-style. A hit list is discovered in the bloody pocket of one of the victims, and Peter's name is on the list. Could an old nemesis be behind this? And who or what is the Main Street killer?

The Chicago Connection takes Peter and his partner to uncharted territory. Peter decides to go to Chicago and hopefully turn the tables on Louie Galloway, his old nemesis, and maybe even the mob, while working with a Chicago private investigator and the Chicago Police Department.

Nixon has five children and 15 grandchildren. He and his first wife, now deceased, had two sons. He and his second wife, Debbie McCaskill Nixon, have three children—twin boys and a daughter. Debbie is a Realtor in the Memphis area, and they live in Cordova, Tennessee. They are members of Bellevue Baptist Church.

of the cities that constructed dog parks, thanks to funding by the foundation.

In other business, the Council, with Vice-Mayor Nina Smothers serving as chairman, voted to change the frequency and meeting times of the council.

Of the seven-member

board, Councilman Tim Tucker was the lone dissenting vote on changing the meetings from the second and fourth Tuesday each month to a single meeting on the fourth Tuesday. The change in meeting time to 5:15 p.m. was approved unanimously. Tucker said the members were elected to meet twice monthly. He questioned if the pay for the board members would reflect the adjusted frequency.

The votes were the first of two readings on the proposal. Huntingdon is the lone municipal board in the county that meets twice monthly. All others municipal boards meet once with occasional additional meetings as needed.

Mid-year budget adjustments were approved as well as a PILOT - payment in lieu of taxes to Dynamix Casting, located in the South Huntingdon Industrial Park.

The airport budget was amended to reflect the service of three part-time staff members instead of a full-time manager. A resolution amended the budget of \$30,000 for the manager and reallocated it to part-time personnel.

The Veterans Service Office budget was amended by \$315.00 to allocate

additional funds for training during the former and new director transition.

One item that drew some negative votes was the resolution to amend the Election Commission supplies and travel budget by \$25,000 and shifting it to salaries for part-time and election workers.

A budget item approved for the Sheriff's Department in the amount of \$4,000 was for funds received for insurance recovery on a damaged patrol vehicle.

The Circuit Court budget's line item Jury and Witness fees was reduced by \$4,000 since the court has been in limited operation during the pandemic.

With two new recently appointed commissioners - Lana Suite and Jay Phipps, the county's list of committee assignments was realigned to include the new representatives. Commissioners convene at 7 p.m., Monday, March 8 at the Carroll County Civic Center. The public is invited to attend.

Carroll has sustained 3,505 cases of COVID-19 in the one-year-long pandemic. Eighty-one died, and 3,410 recovered.

Henry has administered 11,986 vaccines, or 21.89 percent of the population

with at least one vaccine and 15.22 percent with two doses or the one-dose J&J vaccine. Vaccines are available at Henry County Health Department, Henry County Medical Center, and Walmart.

In Henry, the population sustained 3,034 cases over the one-year period, 75 deaths, and 2,917 recovered.

In Weakley County, 8,622 have been vaccinat-

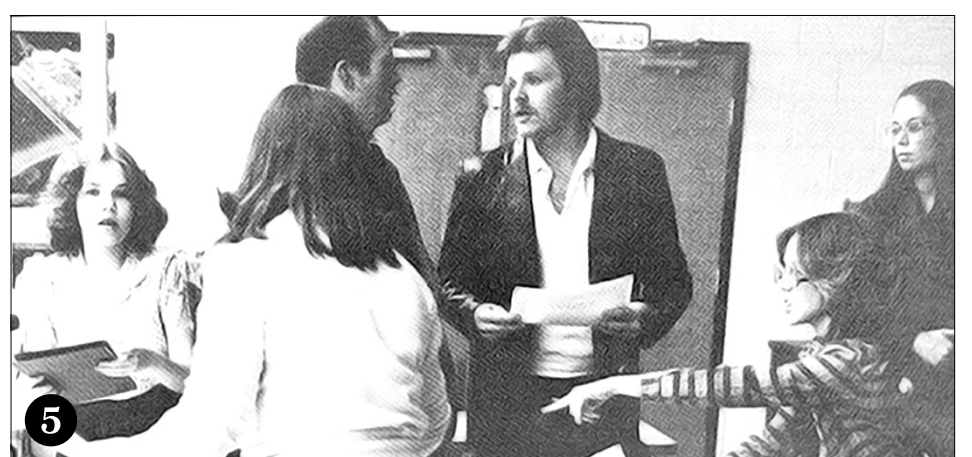
ed, which is 15.35 percent with at least one dose and 10.43 with both vaccines or the one-dose J&J.

In Weakley, 3,826 cases of COVID-19 were reported over the year, with 60 deaths and 3,738 recovered.

Coach Randy Thomas The Model for Coaches

When I decided to go into education as a career, there were many teachers and coaches at McKenzie I modeled myself after. In pedagogy courses, you regularly hear the quote from William Arthur Ward, "The mediocre teacher tells. The good teacher explains. The superior teacher demonstrates. The great teacher inspires." In my mind's eye, when looking at that quote, the terms teacher and coach are interchangeable. If you look at McKenzie High School football over the last 40 years, there has been one fairly consistent face on the sidelines, Randy Thomas. He stands out as

a superior and great teacher/coach. The 2020 football season marked his swan song in athletics, and at the end of the 2020-2021 school season, he will officially retire from education. Beginning in the fall of 1979, Randy Thomas played an integral part in the McKenzie School System. His first assignment was as assistant football coach at the junior high, teaching Tennessee History and World Geography. "I helped with the high school team as much as I possibly could. In the fall, I'd go out the first week or so with the high school and work with them until our junior high started." For six years, Coach Thomas molded his craft at the old two-story building before moving up to the high

school level. In 1985, Thomas joined Coach Richard Chappell's staff. Three short years later, he was no longer the assistant. Coach Thomas was at the helm of Rebel Football. As the steward for the program, Thomas led his teams to key victories with bowl appearances and playoff berths. From 1988-1996, Coach Thomas compiled 45 wins, making him the winningest coach at the time. His record was later broken by a former assistant, Wade Comer, whom he hired in his last year as head coach. Thomas's coaching career took a brief two-year hiatus. He returned to coaching as an assistant softball coach helping the late Lori Pearson. After Bill Koen's retirement in 1999, Wade Comer was named football head coach. Thomas was asked to rejoin the staff helping with the offensive line. "I had hired Coach Comer as my assistant his first year. He came back to me and wanted me to come in and help him coach. All he wanted me to do was coach the offensive line. Of course, I was a little apprehensive about it at

the time because I was concerned some people might think I wanted to take the limelight away from him and his accomplishments. I still had a desire to coach but being head coach was never too overly important to me." Being around the kids has kept him in the game. Thomas enjoyed coming to school every day and seeing the students. Having a positive impact on students and players is the most important part of his career. "Probably the things that stick out in your mind more than anything are the mistakes you make as coaches more so than the accomplishments. As a coach, having the opportunity with McKenzie to play for the state championship was a great joy." With a lifetime of achievements on and off the field, Coach Thomas was awarded one of the greatest honors a coach can

receive. On August 5, 2016, the hallowed ground known as Rebel Field underwent a name change. The Friday evening pre-season event was scheduled as an event for fans to meet the year's current team. As coaches and school board members gathered at centerfield, the longtime coach and beloved mentor, Randy Thomas was recognized for his dedication to McKenzie athletics as the football field was named in his honor. The honor came as a surprise to Thomas. "I looked up and saw the blue cover, but I had no idea it was concerning me. Then when I looked and saw my family coming out on the field, especially my parents, and I knew something was going on. I still didn't know what it was, so it was a total surprise." The career of Coach Thomas cannot be summed up in wins and losses or

even through game strategy. Thomas's greatest achievement through his forty-plus-year career is the countless number of students and athletes he has helped. The four-year transition through high school to graduation is an arduous task, but Coach Thomas was always there to help guide the way.

Sue-Cat stretched out on the steps one morning and couldn't, or wouldn't, get up. She was in pain. Cathy told me in no uncertain terms to

fix this. Josh and Jess cried in unison, "Daddy, do something!" I loaded up the cat in a cardboard box and took it to Dr. Nelson. Kidney failure! The cat got an IV. And boatloads of medicine. And boarded three days with the vet. We went to visit every afternoon! I ended up spending EIGHTY-FIVE DOLLARS on a cat I didn't even know was mine! You'd better believe I got a story out of it! And I let the cat in the house. Did you know Tender Vittles come in seven delicious flavors? Sue-Cat ate them standing, propped up in my lap or laying on the couch. It, she, he took to sleeping in our bed. The boys piled in there with us to "be with the cat."

I half slept for four years with Josh on my chest, Jesse hanging off the bed in the crook of my arm and Sue-Cat curled up on my feet. I declared thirteen years later, when Sue-Cat passed away, "No more cats!" Sue-Cat Two showed up like three days later, on the back steps. There has to be some kind of catology underground "jungle drums" system that alerts a homeless cat to where there is an opening! She moved in within the week. Katze adopted us when Sue-Cat Two left. I'm pretty sure Katze was a girl.....she had a litter of kittens in my closet not long after making herself at home. The boys grew up and we got out of the cat business for good. I thought. Our sweet, innocent neighbors who are as nice and kind as they can be got displaced by hurricane Michael. They took Cooney with them. Apparently that cat didn't

like the temporary arrangement. It, her, him would fairly quickly wind its way back to the old house, which was under some serious repair work. Our neighbors would pick Cooney up and take it, him, her back, but in a day or two the cat "came home" again.....and again..... Cathy was giving me the daily cat report, "Cooney is back. And I think she's hungry. And lonely....." Oh, merciful Heavens! I didn't want to be a party to this. But I did say, "Don't get that expensive Purina Cat Chow." It was a bit of a process. Cathy would go over and talk to Cooney. Well, you know cats; it didn't take long for him, it, her to reciprocate. Cooney took to hanging out in our driveway, chatting with Cathy. The cat got to coming over every day. It wasn't long before Cooney was sleeping on our deck.....close to the bowl

filled to the brim with Purina Cat Chow. Of course, we had one of those cold February nights. The expensive food and the cat both moved inside. I'm embarrassed to speak to Steve and Kim. I'm guilty by association. But I have been tempted to ask if Cooney is a girl. I may need to put a lock on my closet door! I reckon by mutual consent we have come to a joint custody arrangement. But if that cat lies down on the back steps, won't get up and starts moaning.....I'm taking Cooney next door in a cardboard box and telling my neighbors they need to do something about THEIR cat! And it appears, after thirty-seven years, I've come full circle in this writing business.....

Cats Undefeated After Home Opener

MCKENZIE (March 12) — The Bethel Wildcats captured their third straight win of the season beating No. 17 the University of the Cumberland's 38-14 Friday night at Wildcat Stadium. Bethel moved to 3-0 overall and 3-0 in the MSC. The Patriots dropped to 1-3 and 1-3.

The match-up was the third of a seven-game season, with all the games being MSC Bluegrass Division affairs.

The Cats took the opening kick-off and drove 83 yards for their first score. Anthony Hughes capped off the 14-play drive with a two-yard run for the score. Rodrigo Campos hit the point after to give Bethel a 7-0 lead at the 10:45 mark. Jacob Murphree hit De'Ontay Tate on a 50-yard strike to make it 13-0 at 6:40 of the quarter, and after a Campos kick, it was 14-0.

Murphree threw a deep ball that J'Kobi Reddick gathered in and, with his brilliant speed, ran in from 69 yards and the Wildcats took a 21-0 lead with 5:41 left in the quarter. Martize Smith scored from one yard out, capping a 13-play 71-yard drive for UC 30 seconds into the second quarter.

Tripp Holloway hit the point-after and Bethel's lead was shaved to 21-7. Campos closed out the first-half scoring with a 24-yard field goal to give the Cats a 24-7 lead at the half.

After a scoreless third quarter, Tate literally hurdled a tackler and ran for a 69-yard touchdown, right in front of the home crowd to give Bethel breathing room at 31-7 with 10:59 left in the game. Smith capped off a 23-yard rushing night with a 41-yard run to cut the UC deficit to 31-14.

Murphree hit Caleb Roebuck, who made a spectacular catch and after a Campos PAT, Bethel would go on

to win 38-14.

Coach Michael Jasper spoke about Bethel's balance on offense. "We were pleased with our balance as we had 207 yards rushing and 285 in passing. Jacob threw the ball well and our receivers ran good patterns and got open. Our running backs did a good job behind our offensive line, which is one of our strengths."

Murphree was 17-of-25 on the night for 85 yards. Tate had 129 yards rushing on 20 carries. Roebuck had five catches for 83 yards. Smith led the Patriots with 234 yards on the ground. Bethel outgained UC 492-279 in total yards.

Coach Jasper summed up his thoughts about his defense. "Our kids really flew to the ball and played well. Credit Smith, who had a really good game for them. He runs low and is hard to tackle but for the most part we are happy as we made several big stops when we really needed them."

UC was just 2-of-14 in third-down conversions. Jakobe Griffin led the Wildcats on defense with 13 total tackles. Jerwin Young had 10 total stops. Vonte Bates had a big interception. The Wildcats had 6.5 tackles for losses in the game.

Coach Jasper summed up his thoughts about the game and next week's opponent. "All in all, we are happy with the game. Our kids are going to play hard and get after it. We have some things to clean up and get ready for a tough and well-coached Georgetown squad. I have great respect for Coach Cronin and always look forward to coaching against him. We will need to play well and be ready for the challenge."

The Wildcats head the road again next Friday traveling to No. 19 Georgetown to face the Tigers at 2:30 p.m.

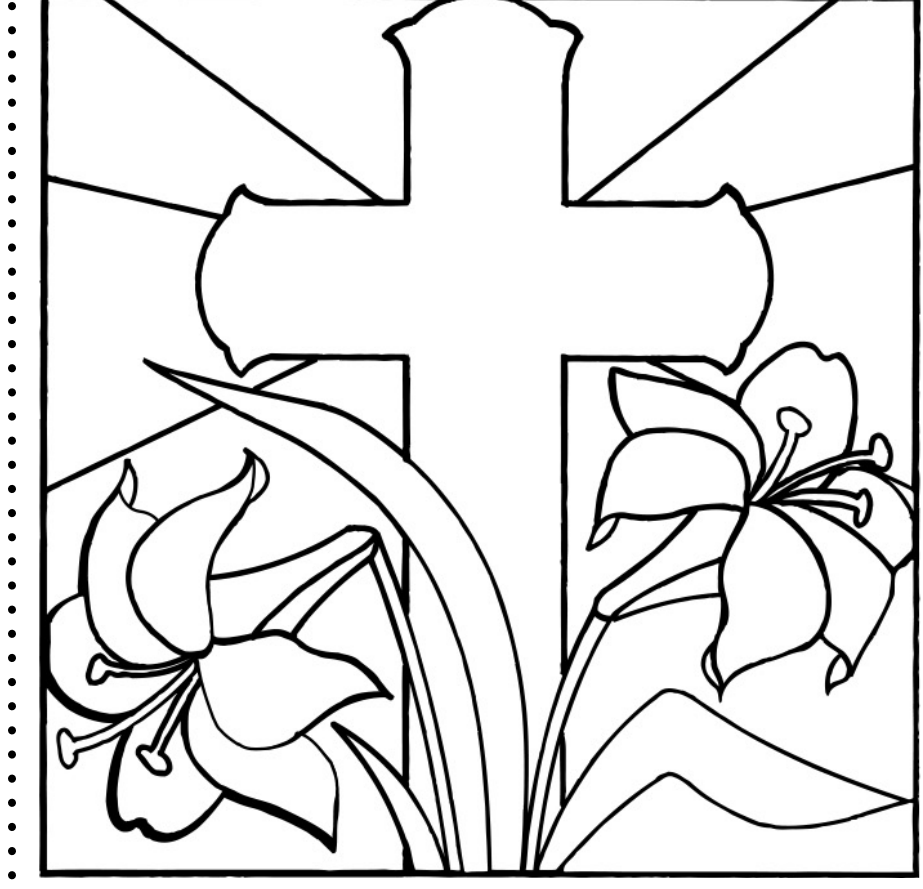

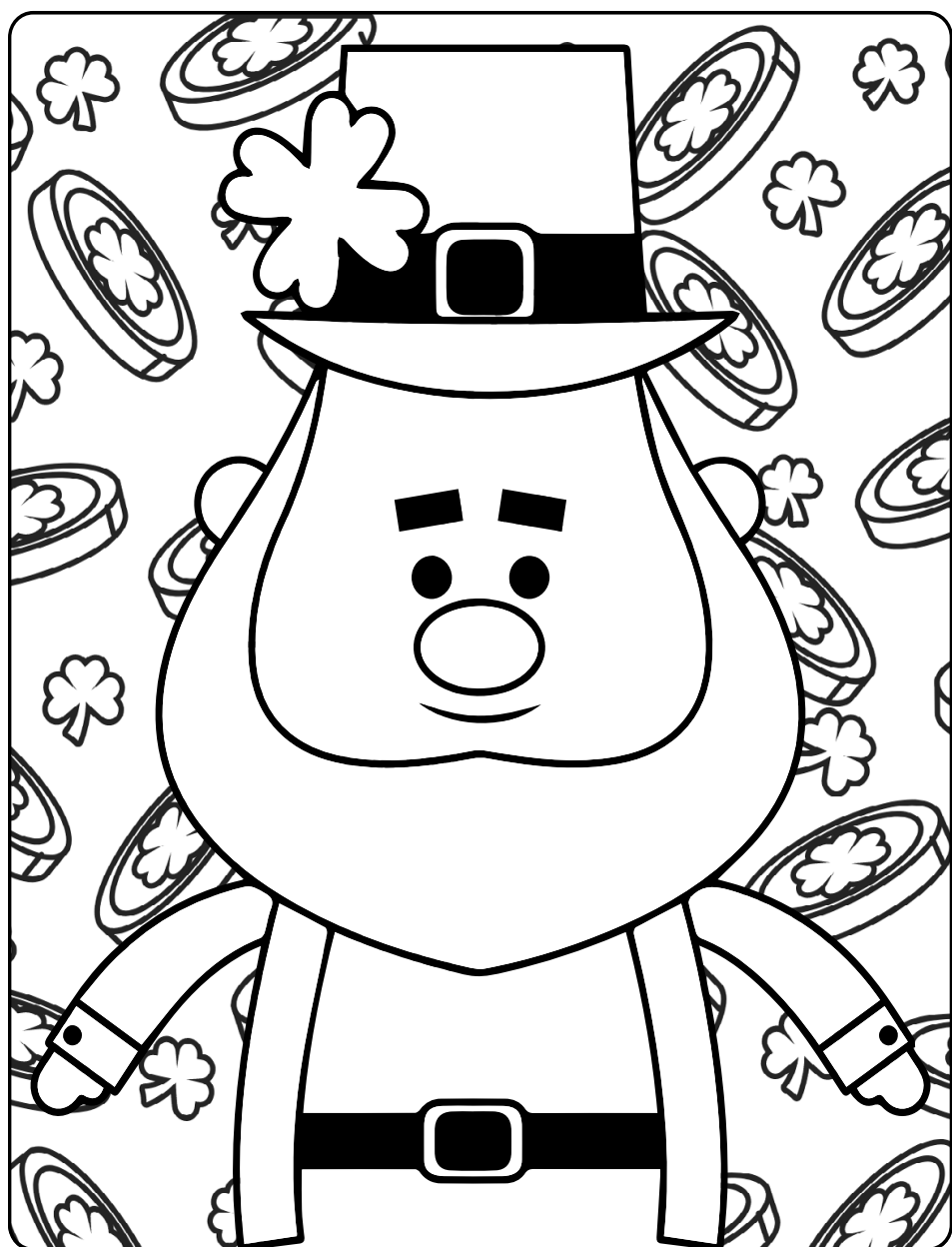

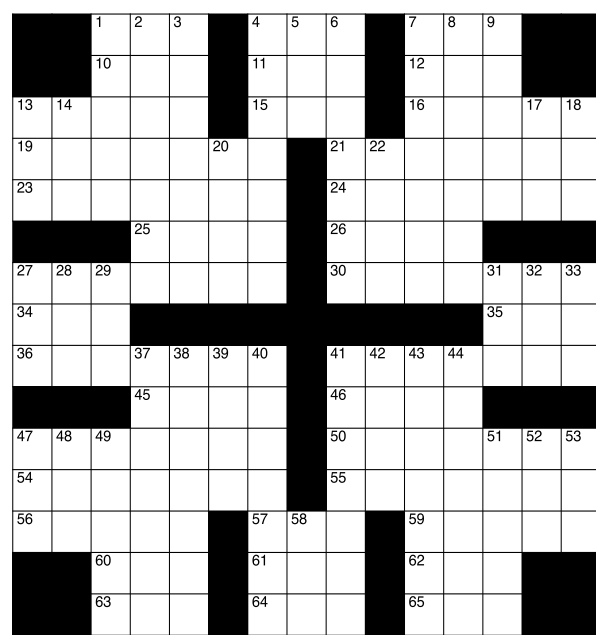

TSSAA 2021 BASKETBALL CHAMPIONSHIP State Tournament Guidelines

In accordance with CDC guidelines, the TSSAA has issued the following guidelines for the state basketball championships.

Tickets and Capacity Limits — General admission tickets are \$12 per session. Due to COVID-19 capacity limits, tickets will be limited and Championship Event cards and TACA cards will not be accepted. Each participating school will receive a link for their allotment of tickets to be purchased through the GoFan online platform. No tickets will be sold on site. Schools should make plans for how to prioritize the distribution of the link to players' families and other members of your school community.

Media — All media requesting credentials should complete the online media request form. A live telecast/videostream or tape delay broadcast of any state tournament game is NOT permitted. Live video coverage of every state tournament game will be provided by the NFHS Network.

Parking — All parking for the DI Basketball State Championships, including team buses, must be contained within the Greenland Drive parking lot at the northeast corner of Murphy Center. Each participating school will receive three parking passes for this lot. All other vehicles will be charged \$5 per vehicle per day.

Complimentary Tickets — Each school will receive admittance for 15 people to each tournament session in which they are participating. The list will be available at the Pass Gate located at Gate N-4. All teams who win their first game will use the same list of 15 names at the pass gate for their subsequent games.

Game Administrator's Meeting, National Anthem, Starting Line-Ups — Prior to the starting time, there will be a game administrator's meeting at the mid-court area with both head coaches, referee, head of security, and the game administrator. The game administrator will be responsible for the meeting. At 0:00 on the clock, the teams will go to the bench area and there will be the National Anthem and introduction of starting line-ups. The National Anthem will be sung or played prior to the beginning of each day. In all quarterfinal games,

all players will be introduced. Substitutes will be introduced first and they are asked to go to the free throw line. Following the introduction of the substitutes from both teams, the starters will be introduced on an alternating basis. Each starter is asked to go to the free throw line. Following the introduction of starters, the head coaches will be introduced.

Cheering Sections and Cheerleaders — The arena is open to general admission seating with appropriate social distancing, but it will be divided into quadrants to create a designated cheering section for each school. Signage will be posted informing spectators of which quadrant they should sit in. For the first game of each session, the home team fans should sit in sections P, R, S, and T and the visiting team fans should sit in sections F, G, H, and J (as well as the corresponding upper levels behind those sections). For the second game of each session, the home team fans should sit in sections A, B, C, and D and the visiting team fans should sit in sections K, L, M, and N (as well as the corresponding upper levels behind those sections).

Cheerleaders will not be allowed on the floor but will be granted access to the first few rows of section T for the home team and section J for the visiting team during the first game of the session, and the first few rows of section A for the home team and section K for the visiting team during the second game of the session.

In the cheering sections there can be no large handheld signs or large flags, no confetti, no miniature basketballs to be thrown out, and no noisemakers.

Pep Bands — In accordance with our COVID-19 Sports Regulations, pep bands will not be permitted to attend.

Videotaping — Each school will be allowed to have one representative tape during their game only. Video cameras on tripods may be set up in designated areas only. No tripods will be allowed in the stands or on the playing floor. Championship games will be broadcast on live television. No video recording will be allowed during the championship games.

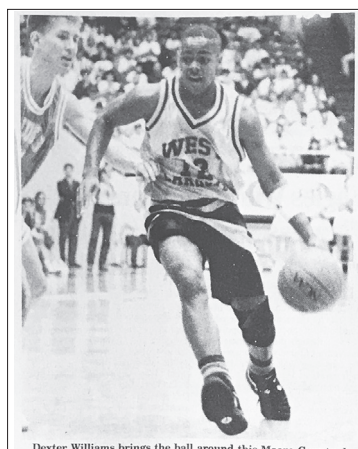

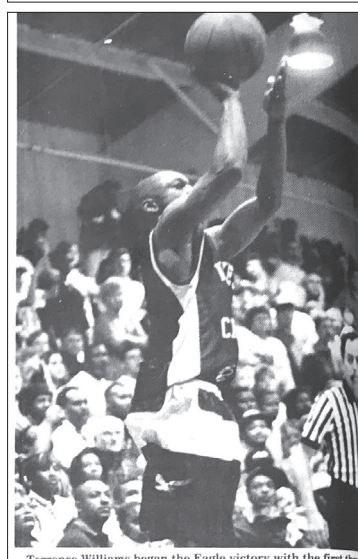
