

# Plant Increases Manufacturing Capacity

McKENZIE (July 16) — There are new manufacturing jobs headed to McKenzie, thanks to a recent expansion at Profile, Inc. in the Henry County portion of McKenzie.

Gary Weirs, general manager, said the company is installing a 1000-ton press to expand its stamping oper: tions for the automotive industry. The Canadian-made press was ordered last fall and arrived last week at the McKenzie location at 370 Republic Drive. A large crane lowered support columns through the roof as one of the final steps of the installation. Weirs said the machine, which will be operational in August, was installed in the new 7,500 square-foot addition. The company provides manufactured parts to domestic and foreign markets, including South Africa, South Carolina, Michigan, Alabama, and Kentucky.

UNION CITY (July 13) -Federal, state, and West Tennessee officials met in Union City on Tuesday, April 13 at the intersection of U.S. 51 and the future Interstate 69.

Congressman David Kustoff, State Transportation Commissioner Clay Bright, State Senator John Stevens, State Representative Tandy Darby and others gathered

on the bridge - future overpass of I-69 to announce the commencement of paving of I-69.

Bright said Tennessee is a pay-as-you-go state as it concerns its transportation system. The roadway is now funded for paving, which marks one of the final steps to open the region. I-69 will connect with State Route 22 (US-51) in Union City. Carroll Countians will have four-lane access to I-69 along State Route 22.

I-69 is an integral part of High Priority Corridor 18 across mid-America. Corridor 18 originated with the Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA), where the U.S. Congress designated certain highway corridors of national significance to be included in the National Highway System. I-69 currently exists from the Michigan/Canada border to the northeast side of Indianapolis, Indiana. Congress passed legislation to extend the corridor from Indianapolis to the Lower Rio Grande Valley.

Development of the proposed I-69 corridor would provide a continuous

dards, from the Mexican border to the Canadian border, a route length of approximately 1,650 miles. The extension of the corridor incorporates several elements, including a new interstate route (I-69) that will serve Memphis, Tennessee. The proposed route has been divided into multiple segments, three of which impact the state of Tennessee.

The three Tennessee sections include: Segment 7 (Fulton, Kentucky to Dyersburg, Tenn.), Segment 8 (Dyersburg to Millington), Segment 9 (Millington to Hernando, Miss.)

Purpose and Need - There is no existing interstate facility with Corridor 18 for the full distance from Indianapolis to the Texas/ Mexico border. This missing interstate link is in a corridor that has a high demand for formerly known North American Free Trade Agreement (NAFTA)-associated goods movements. Short- to medium-length trips, however, far outnumber international traffic along the corridor. There will be local and regional trips that will take advantage of an improved facility designed to Interstate highway standards. By diverting these local trips to the I-69 Corridor, the adjacent state and federal highways will likely see a drop in overall traffic levels with attendant increases in travel efficiency and motorist safety.

Throughout its length, I-69 would connect 16 existing Interstate highways crossing Corridor 18 (10 east-west routes and 6 north-south routes). It would link 10 urban areas of more than 50,000 population along the corridor. Within urban areas, development of I-69 could provide the means to upgrade existing Interstate routes, connect major transportation corridors and radial freeways with a new facility, and connect modal and multi-modal terminals to the Interstate highway network.

The overall goals for this Interstate facility are defined as follows:

- To improve international and interstate movement of freight and people by ensuring a safe transportation system that is accessible, integrated, and efficient while offering flexibility of transportation choices in mid-America.
- To enhance the regional and local transportation

systems by providing transportation capacity to meet current and future needs.

- To facilitate economic development and enhance economic growth opportunities domestically and internationally through efficient and flexible transportation with particular emphasis being given to economic growth in the Lower Mississippi Delta Region. To facilitate connections
- to intermodal facilities and major ports along the corridor.
- To facilitate the safe and efficient movement of persons and goods by fostering a reduction in incident risk.
- To upgrade existing facilities to be utilized as I-69 within the corridor to design standards suitable for an Interstate highway and commensurate with the projected demand.
- To directly connect the urban areas named by Congress (the "named cities" of Indianapolis, Evansville, Memphis, Shreveport/Bossier City, and Houston and the Lower Rio Grande Valley) with an Interstate highway connection.

# **Charley Pride's Secret Son Comes Forward**



marketing efforts intended for parents," said Tennessee Department of Health commissioner Lisa Piercey, MD, MBA, FAAP. "The Tennessee Department of Health not only supports immunizations but continues to provide valuable information and access to parents who are seeking vaccinations for their children. We are proud of the efforts of our staff across the state and will continue to promote vaccination and the vaccination work of our partners."

While health departments administer routine childhood vaccinations,

they continue to give COVID-19 vaccines. As of July 18, 2,625,316, or 38.4%, Tennesseans are fully vaccinated against COVID-19. 42.9% of Tennesseans have received at least one dose.

Of the fully vaccinated Tennesseans, 2.2% are 12-15, 4.5% are 16-20, 11.1% are 21-30, 12.7% are 31-40, 13.9% are 41-50, 17.2% are 51-60, 19.1% are 61-70, 13.5% are 71-80 and 5.8% are 81 or older.

A June 11 article from the American Medical Association reported over 96% of practicing physicians in America are fully vaccinated against COVID-19. Of the remaining physicians, 45% plan to get vaccinated. In the week of July 10

through July 16, the Tennessee Department of Health reported an average

# **H. Gordon Stoker** Gleason and The Jordanaires

en talking about Mike Snider and his music career, it is a must to bring up Gordon Stoker as both men hail from Gleason. I didn't realize until the other day, it was Stoker who arranged for Snider to appear on the Opry.

As fate would have it, I was listening to a Podcast about the Nashville Sound and much to my surprise the host kept mentioning the Jordanaires. Now, I knew Stoker was part of the Jordanaires and they did a tremendous amount of backup vocals for Elvis Presley. Yet, I was floored to learn that they were the background vocal for countless other recording artists in the late 50s and 60s on into the more modern era of country music.

So it would be remiss if I didn't include the story of Gordon Stoker. a Grammy winner and a member of the Country Music Hall of Fame, to the list of those included in the Weekly 150.

Hugh Gordon Stoker was born on August 3, 1924, to Ambus Hugh Stoker (1891– 1963) and Willie Lee Bevill Stoker (1894-1984) in Gleason, Tennessee. Blessed with the gift of music, he began playing piano publicly at the age of eight for West Tennessee's Tumbling Creek Baptist Church.

By age 12, going by the name Hugh Gordon, Stoker was well-known, playing in and around Weakley County and performing with the Clement Trio on WTJS in Jackson, Tennessee. He had caught the ear of John Daniel at McKenzie's Snead Picnic; after graduating nign school at 15 joinea Nashville's John Daniel Quartet. Performing with them on WSM's Grand Ole Opry, he became one of the

Opry's youngest performers at age 15.

As World War II rolled around, Stoker's music career took a brief interlude as he was drafted into the Air Force in 1943. He served as a teletype operator for three years. After his service concluded, he decided to move to Shawnee, Oklahoma to attend Oklahoma Baptist University. He studied psychology, music and voice, and sang in the Bison Glee Club.

Stoker missed the bright lights of Nashville; he enrolled at George Peabody College (now part of Vanderbilt University) in 1948. The move allowed him to rejoin the Daniel Quartet. A year later, he met and later married (1951) Jean Wilkerson of the local east Nashville family singing group, the Wilkerson Trio.

Meanwhile, in Springfield Missouri, a new quartet, The Jordanaires, was formed in 1948 by Bill and Monty Matthews along with bass singer Culley Holt and second tenor Bob Hubbard.

In 1950, he auditioned for and won the piano-playing job for the popular vocal quartet, the Jordanaires. He started singing first tenor with them in late 1951. Stoker assumed the additional roles of group leader/manager. The Jordanaires recorded for Capitol Records in the early 1950s and soon started providing background vocals on recordings for solo performers.

In 1955, The Jordanaires traveled to Memphis to sing with Eddie Arnold at Ellis Auditorium. When the show was over, a young musician, Elvis Presley, made his way backstage to meet the quartet. He explained that if he ever got a major recording contract he wanted them to sing with him.



thing that made the young man memorable at the time was his long sideburns. He added, "Boys didn't have long sideburns back then,' he explains, "But the main thing was that he had on a pink shirt. Boys just did not wear pink shirts in 1955.

Elvis called the group in January 1956 after signing with RČA Records. This began a 15-year relationship and friendship. Stoker sang duets with Elvis on hit records like "All Shook Up", "Good Luck Charm", and "Easy Come Easy Go" while the full quartet sang back up on most of Elvis' songs.


The Jordanaires' background vocals were recorded on 28 of Elvis's 30-plus number one songs. Their success was not limited to just Presley's records, it's estimated they can be heard on over eight billion records sold, including Grammy-winning recordings in six consecutive decades, starting in 1959 with Johnny Horton's "Battle of New Orleans" to "Lost Highway" by Willie Nelson and Ray Price in 2007.

During the 1960s and beyond, the Jordanaires ofFerlin Husky's "Gone", Jim Reeves' "Four Walls", and Patsy Cline's "Crazy", Don Gibson's "Oh Lonesome Me," Tammy Wynette's "Stand by Your Man," Conway Twitty's "Hello, Darlin'," Kenny Rog-ers's "Lucille," and George Jones's "He Stopped Loving Her Todav"

According to Stoker's son. Alan, a curator at the Country Music Hall of Fame and Museum. The Jordanaires helped with the origination and methodology of the "Nashville Number System" of musical notation, now standard in Music City recording studios. They were instrumental in establishing Nashville offices for performers' unions.

The Jordanaires were not only backup singers but had an impressive discography reflecting continuous releases from 1950 to the 2000s. Their honors include:

1998: Gospel Music Hall of Fame; 1999: North America **Country Music Associations** International Hall of Fame; 2000: Rockabilly Hall of Fame; 2001: Country Music Hall of Fame; 2002: Golden Voice Awards Vocal Group

"I always thought two shows a night is what took his life," Gordon said sadly, "It's just hard... They pushed him. he wasn't well: he was taking uppers and downers all the time. He was never on hardcore drugs - he didn't even smoke marijuana - but that eventually took his life."

While the Stokers called Brentwood home for most of his recording career, he, like Mike Snider never forgot

their roots in Gleason. "He was so famous," said Stoker's niece, Jenna Wright. "But to me, he was just Uncle Gordon. He was an extremely unassuming person."

Wright recalled how her uncle attended her graduations from Gleason and UT Martin. She added the family was extremely close. She even recalled how her father, Wayne Stoker (1915-2010), and Gordon were together at Thanksgiving when Mike Snider dropped by the house.

"When my dad got real sick a couple of years ago, Uncle Gordon would call him every day, no matter where he was," Wright said of her late uncle.

a lengthy illness. Stoker died. His obituary stated of him, "He found much happiness working outside, digging and planting in his garden and taking care of his goldfish pond. His sense of humor, laugh, tenderheartedness and love of family will always be remembered."

The Stokers have two sons, Alan and Brent, and a daughter, Venita, plus five grandchildren.

Gordon is interred at Woodlawn Memorial Park and Mausoleum in Davidson County, Tennessee.



Stuart Woods was born in Manchester, Georgia, attended local public schools, then graduated from the University of Georgia with a Bachelor of Arts in Sociology. After college he moved to New York in search of a writing job. The magazines and newspapers were not hiring, so he got a job in a training program earning \$70 a week. "It is a measure of my value to the company, he says, "that my secretary earned \$80 a week.' He spent the whole of the sixties in New York, with the exception of two months of basic training for what he calls "the draft-dodger program" of the Air National Guard. With the guard, he spent ten months in Mannheim, Germany, according to him, "driving a two-anda-half-ton truck up and down the autobahn." He notes the truck was all he ever flew in the Air Force.

At the end of the sixties, he moved to London working for various advertising agencies. In early 1973 he decided the time had come to write the novel he had wanted to write since the age of ten. He moved to Ireland and worked two days a week for a Dublin ad agency while working on the novel. Then he discovered sailing and about a hundred pages into the book, all he wanted to do was sail, and the book fell by the wayside. During this time he participated in several races, one of which was a trans-Atlantic race from Plymouth, England, to Newport, Rhode Island. in 45 days.

per based on his sailing experiences, and the second called A Romantic's Guide to the Country Inns of Britain and Ireland, a travel book he wrote on a whim. In the meantime, a New York publishing house, W. W. Norton, offered an advance of \$7,500 to publish his novel called Chiefs. This is the first book in his Will Lee series.

Though only twenty thousand copies were printed in hardback, the book achieved a large paperback sale and was made into a six-hour television drama for CBS-TV starring Charlton Heston at the head of an all-star cast including Danny Glover, Billy Dee Williams, and John Goodman. Chiefs established Woods as a novelist, winning an Edgar Allan Poe prize from the Mystery Writers of America. Woods has since been prolific, having published more than sixty novels with more than fiftv best sellers.

His Stone Barrington novels seem to be the most popular, and Woods writes about three books per year. Barrington cruises the world of the rich and famous. One of the latest takes us to Florida where Barrington's vacation is interrupted when something falls from the sky.

He teams up with a detective to investigate the issue when the evidence seems to disappear.

Before he knows it, Stone is drawn into a web of deceit and crime that follows him wherever he goes—along with old and new enemies who just can't leave him be.

Woods married for the first time in 1984, but the marriage ended in 1990. He said, "I married too young-I was only 47.3 After 15 years in Atlanta, he moved to Santa Fe, New Mexico, where he met his second wife, Chris, who was working in a bookstore while trying to write her own novel. He now divides his time between Florida and Connecticut and travels widely with no plans to retire.






