REPUBLICAN AND DEMOCRATIC PRIMARY ELECTIONS

The Carroll County Election Commission announces VOTING for the Republican and Democratic Primary Elections on Election Day, May 3, 2022. Any registered voter, in Carroll County, may cast a ballot on Election Day by personal appearance at his/her designated Polling.

State law requires voters to have Federal or State government issued photo ID to vote, unless an exception applies. College student IDs will not be accepted. The voters must have photo identification when they present themselves to vote. This includes Early Voting, which is ONLY at the election office, and Election Day at your assigned polling place.

EARLY VOTING FOR THE MAY 3, 2022, ELECTIONS is in progress now through Thursday, April 28. Weekday voting will be 8:30 a.m.-4 p.m. Saturday voting, April 23, will be 9 a.m.-NOON.
