Huntingdon Man Dies in Bicycle Accident

HUNTINGDON — A 47-year-old Huntingdon man died Wednesday, April 27 in an accident involving the bicycle he was riding and a semi-truck.

Keith Henry Gazley, a warehouse worker at VP Racing Fuels in Huntingdon, leaves a wife and two young children.

According to a report by Walter Smothers, director of Public Safety at Huntingdon, the accident occurred at 7:30 a.m. at the intersection of Highway 22 and Veterans Drive.

At approximately 7:30 a.m. Wednes-

day, April 27, Huntingdon Police Department was notified by the 911 call center that there was a traffic accident involving a bicycle and a semi-truck at the intersection of Highway 22 south and Veterans Drive. Police officers, firefighters, and EMS responded to the scene to find a male subject that had been riding his bicycle on the shoulder of the road had run under the

HUNTINGDON (May 2) - A new rate for the collection of solid waste and appointments are on the May 9 agenda of the Carroll County Commission.

Beginning July 1, the solid waste collection fees are expected to increase to \$25 monthly from the current rate of \$18, if commissioners approve the rate during the May 9 meeting. If approved, the county hopes to hold the rate steady for five years

Last fall, after Red River Waste Solutions, the county's solid waste disposal company in rural areas, filed for bankruptcy, the county agreed for Republic Services, with a base in McKenzie, to return as the solid waste collection and disposal company for the once weekly, curbside residential collection in rural areas of the county.

Red River was in its second of a five-year contract when it suddenly ceased

HUNTINGDON (April 26) — The \$10 annual wheel tax on each motorized vehicle registered in Carroll County should end on December 31. That's if the Carroll County 1000-Acre Lake is purchased by the State of Tennessee, said Carroll County Mayor Joseph Butler.

Carroll County Watershed Authority, a governmental entity with its members appointed by the Governor, has not voted to sell the lake nor have they even discussed selling the lake in any open meeting. During the April 26 meeting of the six-member board, the sale seemed all but fait

accompli as members of the board answered questions from the audience about the future of the lake. The Tennessee General Assembly

voted (SB2402) to purchase the lake

Construction Underway on Atwood Highway Bypass

Construction work is well underway on the new Atwood/ Trezevant bypass starting at the Gibson/Carroll County line and stretching over 12 miles to McKenzie.

The path of the highway (U.S. 79/State Route 76) has been cleared with the razing of structures and removal of trees from the Gibson Carroll County line past Atwood, with workers making daily progress northward towards Trezevant.

A contract was awarded to Delta Contractors at a cost of \$29,734,482.50 to perform grading, drainage, construction of a concrete box bridge and noise wall along a new route from Cades-Atwood Road in Gibson County to east of State Route 77 in Carroll County. The estimated

HUNTINGDON (April 28) - Nine persons applied for the position of general manager of the Carroll County Electric Department. That the information from Terry Howell, chairman of the Board of Directors. Two are employees of the Carroll **County Electric Department** and seven are not.

Danny Brawner, general manager of Carroll County Electric, is retiring on June 2. Brawner announced his plans to the Board of Directors on March 24.

He started with the local department on July 31, 1979 as chief engineer following a six-year stint at Bolivar Electric Department. The Board of Directors selected Brawner to serve as general manager with a start date of July 1, 2014.

Howell said some of the candidate wish their names to not be disclosed unless they are selected for the position of manager. One is from East Tennessee and one is from Missouri.

All the names of the applicants are public record since they are seeking the position of general manager of a public entity.

The Board tentatively agreed to interview candidates in one-hour intervals, beginning Tuesday, May 3, 9 a.m. in the Board Room at CCED.





Ford to Support Agriculture, STEM Education in West Tennessee

MEMPHIS — At the 2022 Memphis International Auto Show, Ford Motor Company and the University of Tennessee Institute of Agriculture announced a historic agreement that will propel economic development, education, and conservation throughout the mid-south.

The two signed a stream mitigation and restoration agreement to restore the stream waters flowing through the University's Lone Oaks Farm. UT Extension is developing Lone Oaks, a 1,200-acre facility, into a world-class 4-H and STEM (science, technology, education and math) Education Center in Middleton. Lone Oaks is located just 45 minutes east of Memphis and in close proximity to Ford's BlueOval City. Both properties are under development, and earlier this month UT Extension celebrated laying the top beam of the first of many overnight camping facilities at the 4-H Center. Education programs at Lone Oaks already serve about 5.000 K-12 students each year, but the new facility will allow the program to continue growing and offer overnight STEM programs and camps. Knowing the workforce needs in STEM fields are growing across the region, the timing couldn't be better.

"Every year, UTIA provides valuable life skills as well as STEM education opportunities to nearly 112,000 students across Tennessee,' said UT President Randy Boyd. "Ford's investment in Lone Oaks will ensure our 4-H programs will be able to expand STEM education to Tennessee students for years to come."

Linda C. Martin, UTIA interim senior vice chancellor and senior vice president, savs Tennessee has 7.216 4-H clubs, which is the most of any state in the nation. "The ability to offer overnight educational programs and daily STEM activities at Lone Oaks in West Tennessee is a tremendous enhancement to the region's educational

opportunities," she adds. The Clean Water Act of 1972 requires that any impact on streams and wetlands from development projects, such as buildings and roads, be offset by restoring and permanently protecting an equivalent amount of habitat elsewhere. The size of the Blue-Oval City project required Ford to invest in a significant stream restoration project, and the UT Institute of Agriculture was prepared to meet this need through a restoration project at Lone Oaks Farm. This unique agreement allows Ford to meet its regulatory requirements while also benefiting the entire region through funding STEM education and 4-H Youth Development at Lone Oaks. The agreement totals \$16.5 million, which covers the construction cost of restoring some 20,000 feet of streams on the Lone Oaks property while also providing long-term financial sustainability for Lone Oaks' educational programs. The residual funds from the project will be invested by the UT Foundation to support education programs at Lone Oaks Farm in perpetuity.

"At Ford, our goal is to create a positive impact on people and the planet. We're proud to enter into this innovative partnership with the University of Tennessee that will help restore and protect the streams and wetlands at the Lone Oaks Farm and create educational opportunities that will inspire and benefit future generations,' said Bob Holycross, vice president of sustainability. environment and safety engineering at Ford. "This is just one way we can fulfill our purpose to help build a better world."

The project involves many other partners, including The Tennessee Wildlife Federation and the West Tennessee River Basin Authority (WTRBA). The Tennessee Wildlife Federation is a nonprofit that advances conservation in Tennessee through advocacy, education and on-the-ground conservation projects, including stream and wetland restoration. WTRBA, an independent unit of the Tennessee Department of Environment and Conservation. is charged with managing rivers, streams, lakes and other water issues in West Tennessee. WTRBA is responsible for the design, engineering, construction and monitoring for the stream restoration. "In addition to restoring

the stream, this partnership will create additional opportunities for our UT Extension professionals to develop STEM programs with an emphasis on workforce skills and preparation for higher education. As the needs of employers in the region and state change, we are tailoring our educational programs to match those needs," says UT Extension Dean Ashley Stokes.

"The vision for Lone Oaks Farm includes introducing young people to agriculture and conservation through STEM education programs. We are extremely excited to partner with Ford and support both their sustainability goals and the University's and community's education goals," says Ben West, director of strategic partnerships with UTIA. This investment will provide quality, hands-on education programs for students throughout the region for decades to come.'

for \$11 million, an amount equal to the outstanding debt on the lake. The legislation was laying of Governor Bill Lee's desk at the time of the Watershed Authority meeting. The Governor had recommended the state purchase the lake and had placed the \$11 million in his budget.

Natalie Porter, chairman, fielded the questions from the audience and could not answer specifics about how the Tennessee Wildlife Resources Agency would manage the lake nor about regulations on the lake. Other members of the board also did not offer any responses.

Walter Reister, a lake front resident, encouraged board members to meet with TWRA prior to the transition of ownership, which could occur possibly as early as July. TWRA-developed lakes generally do not allow private boat docks. The agency is assuming a lake with multiple private boat docks. The construction of seven new docks were approved during the March and April meetings of the Watershed Authority.

Questions were also asked about the future operations of the food concession area, marina, and fuel station.

In other business, the Board approved ATA accounting firm to audit the 2021-22 fiscal year finances of the Watershed Authority.

operations in the county. As trash piled in roadside containers, the county issued an emergency contract with Republic Services to collect the waste. After months of trying to catch up, Republic Services is prepared to enter into a five-year contract.

In other business, the county will vote to give bonuses to county employees in the amount of \$2,000 for fulltime and \$1,000 for part-time. The estimated \$430,000 will come from federal American Rescue Plan (ARP) funds. The families of three county employees, who died from COVID, will receive the funds.

A one-time donation of \$60,000 to the Carroll County Rescue Squad is also on the agenda. The funds are needed to help build a new bay on their Chickasaw Drive. Huntingdon headquarters to house a truck too large for the current structure. The funds will come from ARP.

completion date is May 31, 2025


The project involves widening and realignment of the existing roadway for approximately 12.6 miles. Due to the size of the project, the proposed improvements have been divided into three smaller sections. TDOT recently sought bids to demolish houses on

the right-of-way of the new highway. Those included certain structures on Oasis Road, Milan; and Jax Road, Barker Road, Church Street, and Norris Robinson Loop all in Atwood.

A second section from east of State Route 77 to West of Cutlip Lane. That section is a candidate for letting on January 10, 2024 or possibly earlier if stimulus money is available. That section will bypass Trezevant.

The third phase — from west of Cutlip Lane in Trezevant to west of Sydnor Rd./Winston Rd. in McKenzie - the right of way purchase phase is expected to begin in the fall of 2022.

The completed project will create a four- or fivelane highway from McKenzie to Milan.

quors. Harris fled to Mexico, where he and several other ex-Confederates attempted to rally with Emperor Maximilian. After Maximilian's fall in 1867 however Iar. ris was again forced to flee, this time to England. Later that year, after learning Brownlow would rescind the warrant, Harris returned to Tennessee. Passing through Nashville, he called on Brownlow, who is said to have greeted him with the statement. "While the lamp holds out to burn, the vilest sinner may return." Afterward, he returned to Memphis to practice law. By 1877, the Tennessee state legislature, which was once again controlled by Democrats, elected Harris to one of the state's U.S. Senate seats. One of his earliest assignments, in the 46th Congress (1879-81), was the District of Columbia Committee. Subsequent assignments included the Committee on Epidemic Diseases in the 49th Congress through the 52nd Congress (1885–93) and the Committee on Private Land Claims in the 54th Congress (1895-97). During his first term in the Senate, Harris became the leader of Tennessee's Bourbon Democrats, a wing

of the Democratic Party that generally supported laissez-faire capitalism and the gold standard. As such, Harris spent his early Senate career advocating strict constructionism and limited government, states' rights, and low tariffs. In 1884, he was interviewed by President-elect Grover Cleveland for a cabinet position. In 1887, he gave an impassioned speech in favor of the repeal of the Tenure of Office Act. In 1890. Harris denounced the Lodge Bill, which would have protected voting rights for African-Americans in the South, arguing that it violated states' rights.

Senate in October, Harris, as president pro tempore, launched a filibuster in hopes of preventing the act's repeal, but was unsuccessful. Disgruntled over the repeal of the Sherman Act, Harris campaigned for an unsuccessful presidential candidate and gold standard opponent William Jennings Bryan in 1896. Harris died in office on July 8, 1897. His funeral was held in the Senate chamber of the United States Capitol. Congressman Walter P. Brownlow, a nephew of Harris' old rival Parson Brownlow, was among those who delivered a memorial address in his honor. He is interred at Elmwood Cemeterv in Memphis.

At the Battle of Shiloh on April 6, Harris found Johnston slumping in his saddle and asked if he was wounded. to which Johnston replied "Yes, and I fear seriously." Harris and other staff officers moved the general to a small ravine and attempted to render aid. but Johnston died within a few minutes. Harris and the others secretly moved his body to Shiloh Church so as not to dampen the morale of Confederate troops

ris and the state legislature

moved to Memphis, but af-

ter that city fell, Harris

joined the staff of General

Albert Sidney Johnston.

Harris spent the remainder of the war as an aidede-camp on the staffs of various Confederate generals, among them Joseph E. Johnston, Braxton Bragg, John B. Hood, and P. G. T. Beauregard. Andrew Johnson was appointed military governor by President Lincoln in March 1862, though Harris was still recognized as governor by the Confederacy. In 1863, Tennessee's Confederates elected Robert L. Caruthers as a successor to Harris, but Caruthers never took office. Harris was still issuing edicts as governor as late as November 1864.

Though a Bourbon Democrat, Harris, representing


an agrarian state, was also a "Silver Democrat," believing pro-silver policies protected farmers. He supported the Bland-Allison Act of 1878, which authorized the federal government to purchase silver to prevent deflation in crop prices. He also supported the act's replacement, the Sherman Silver Purchase Act of 1890. In 1893, President Cleveland, concerned that the Sherman Act was depleting the U.S. gold supply, sought its repeal. When the vote came up in the


