

# NOTICE OF EARLY VOTING

## STATE PRIMARY AND COUNTY GENERAL ELECTION WITH CITY OF CLARKSBURG — AUGUST 4, 2022

The Carroll County Election Commission announces Early Voting for the State Primary and County General with the City of Clarksburg Election. Any registered voter, in Carroll County, may cast a ballot during Early Voting by personal appearance at the Election Commission office, 625 High Street, Suite 113, Huntingdon, TN.

State law requires voters to have Federal or State government issued photo ID to vote, unless an exception applies. College student IDs will not be accepted. The voters must have photo identification when they present themselves to vote. This includes Early Voting, which is ONLY at the election office, and Election Day at your assigned polling place.

EARLY VOTING SCHEDULE FOR THE AUGUST 4, 2022, ELECTION is Friday, July 15 through Saturday, July 30. Weekday voting will be 8:30 a.m.-4 p.m. Saturday voting, July 16, 23 and 30 will be 9 a.m.-NOON.
